### DESCRIPTION

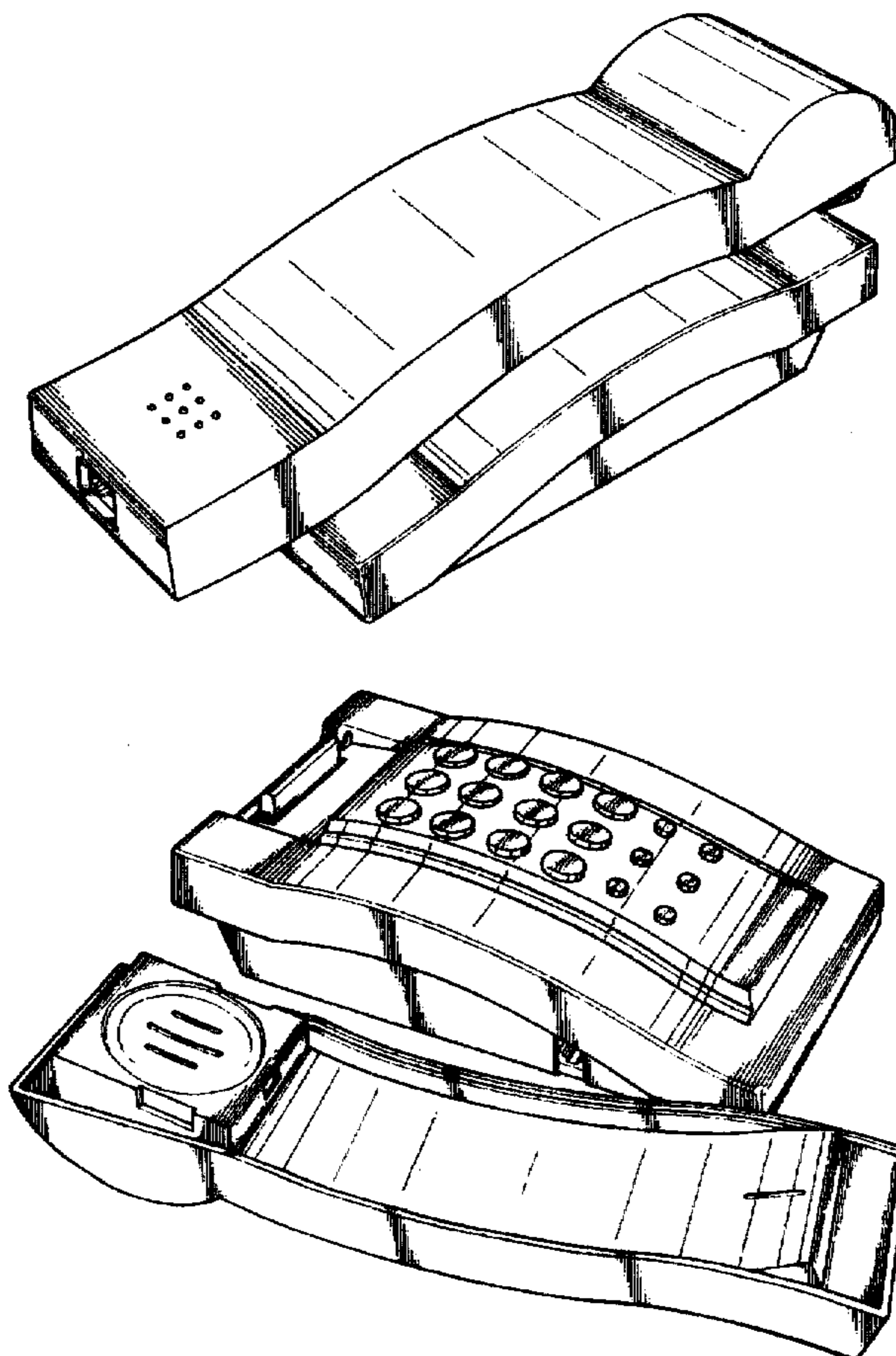
FIG. 1 is a perspective view of a telephone set showing my new design;

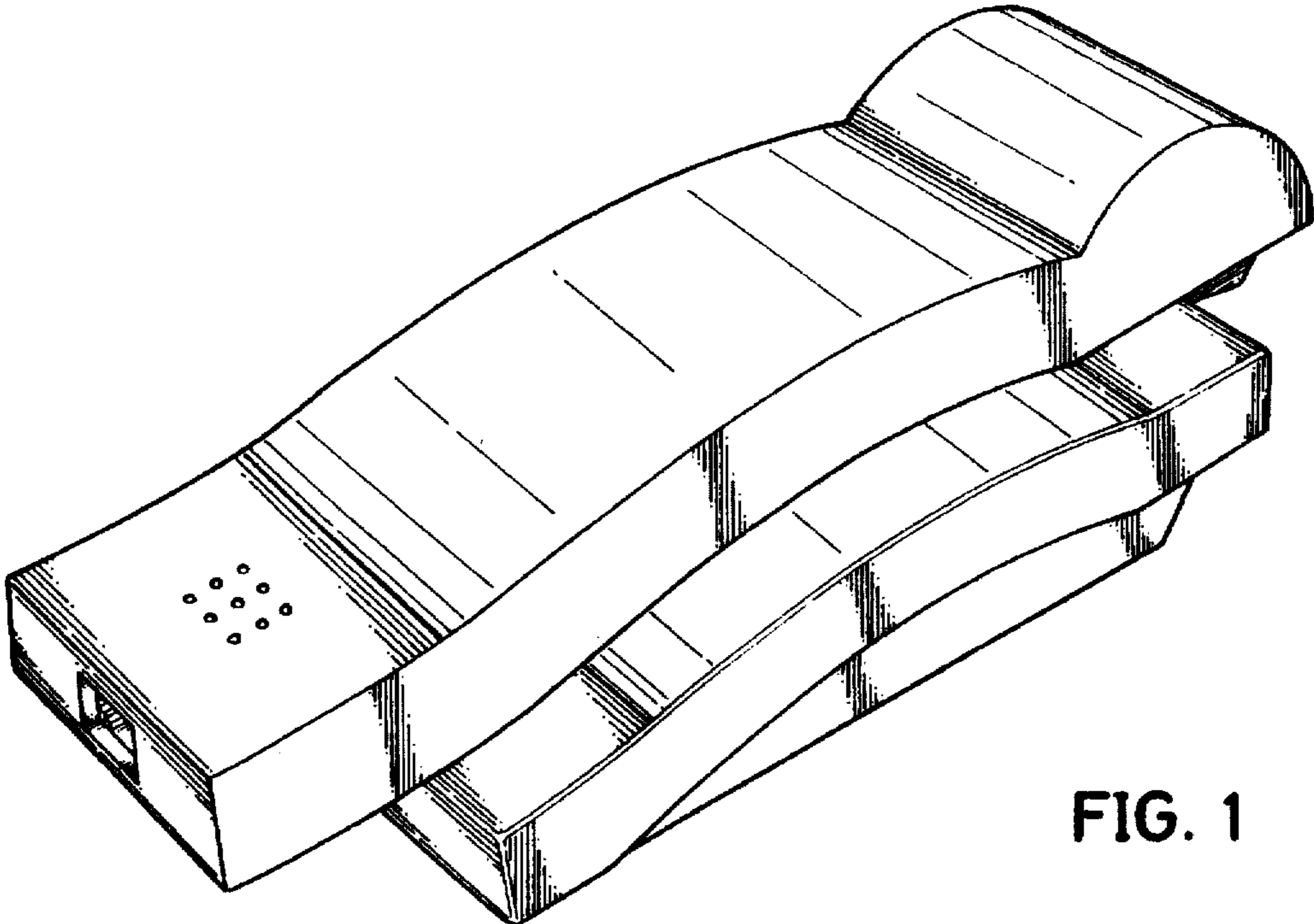

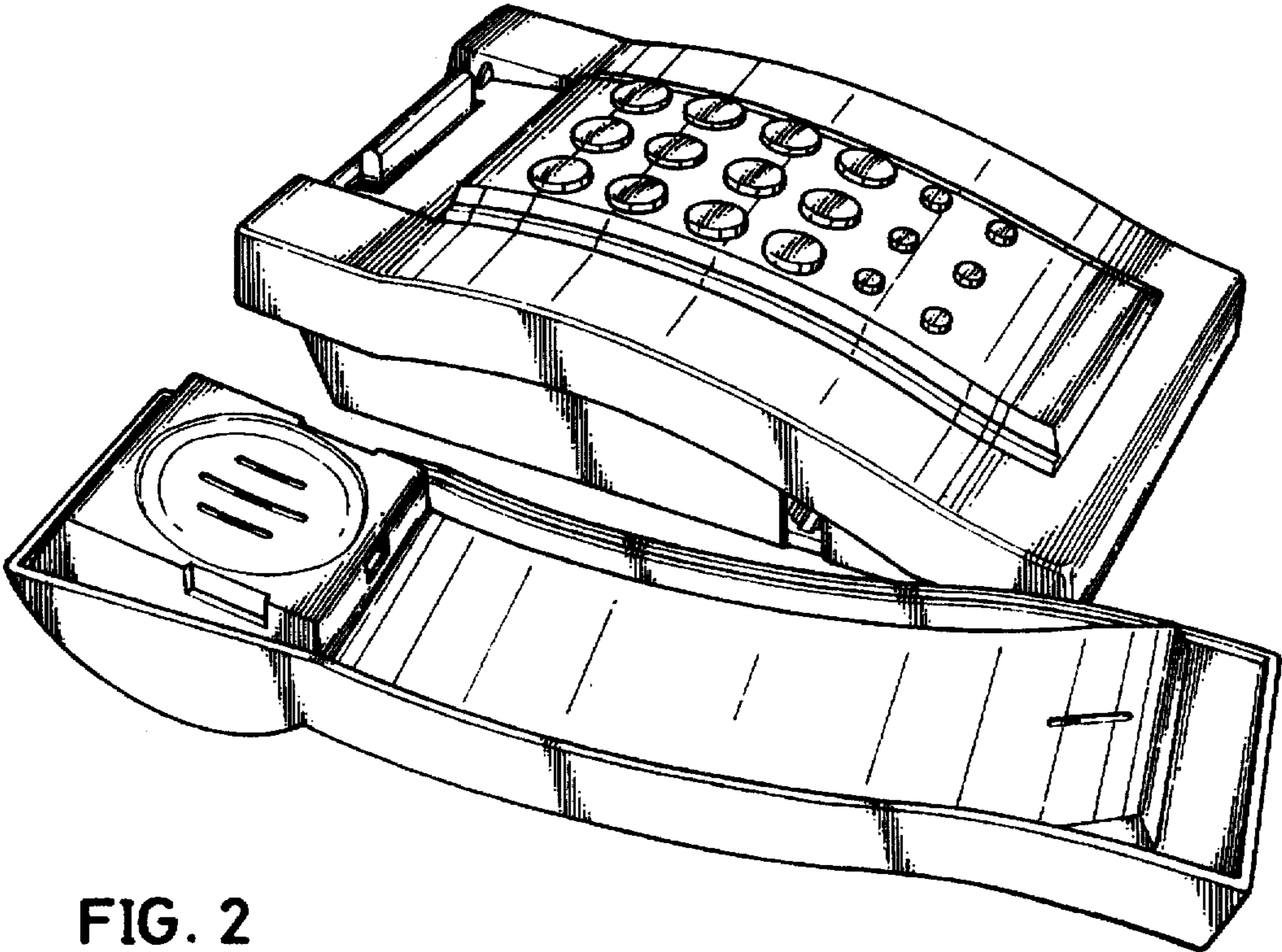

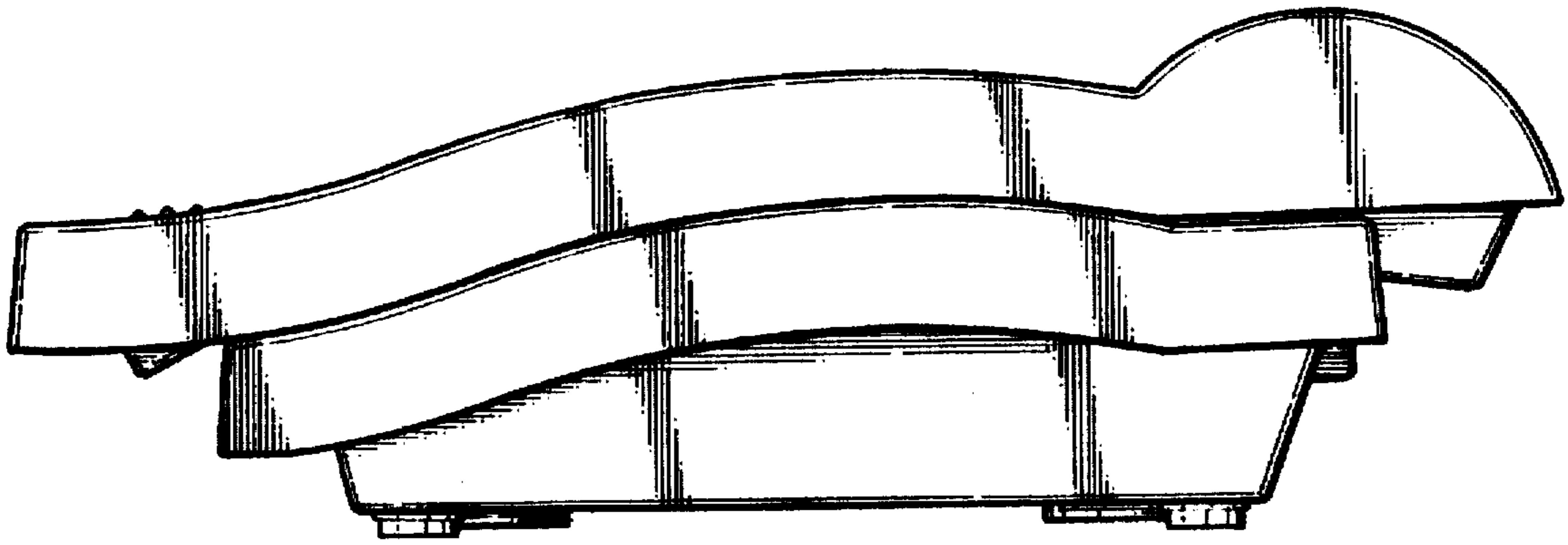

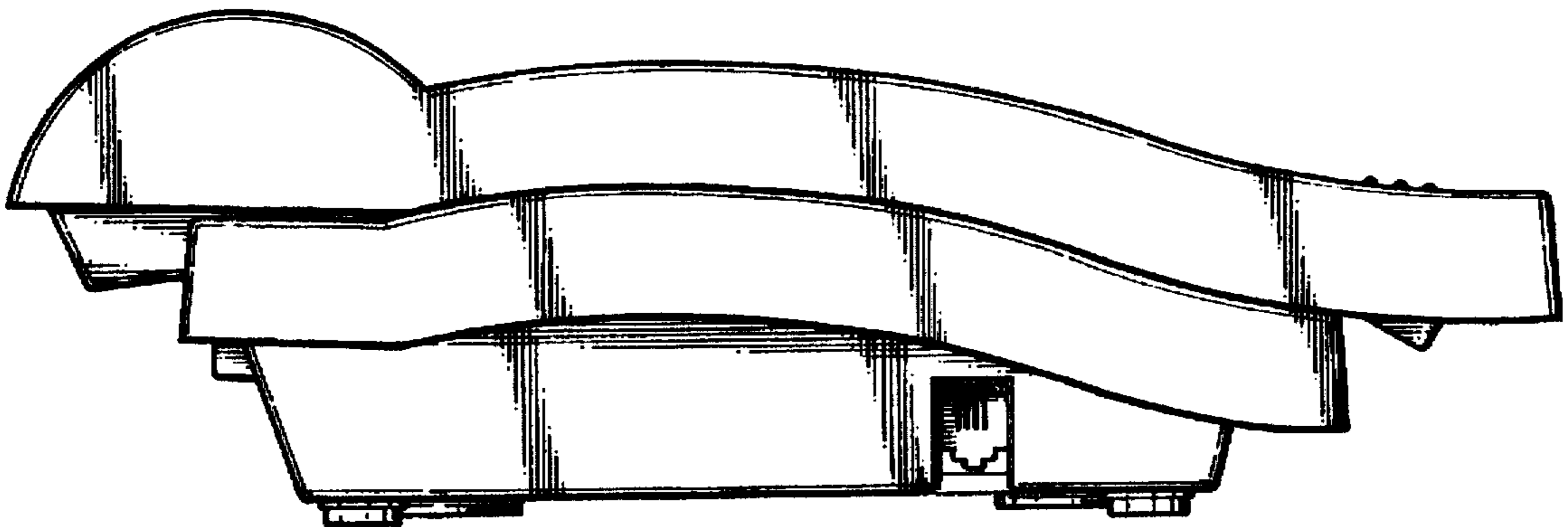

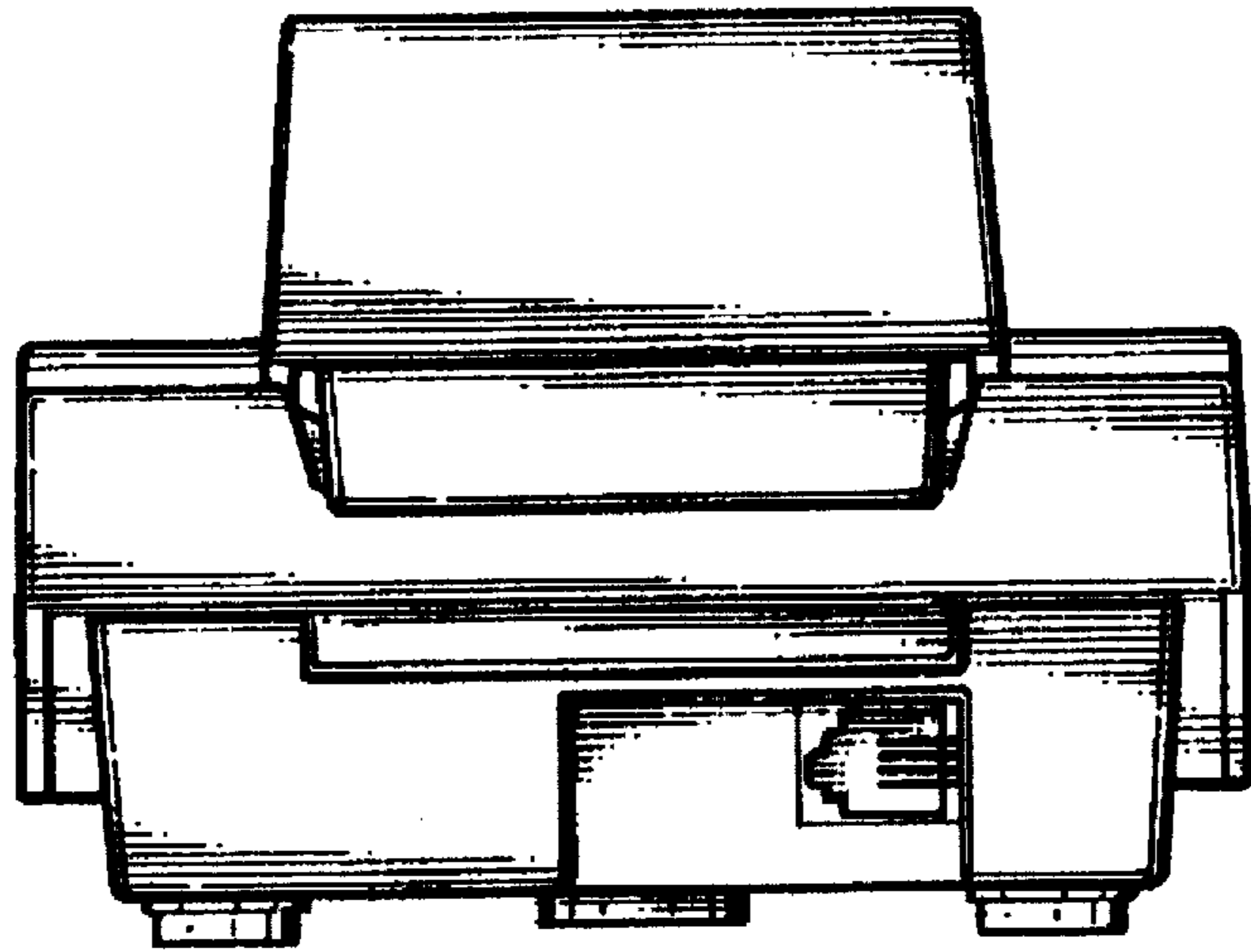

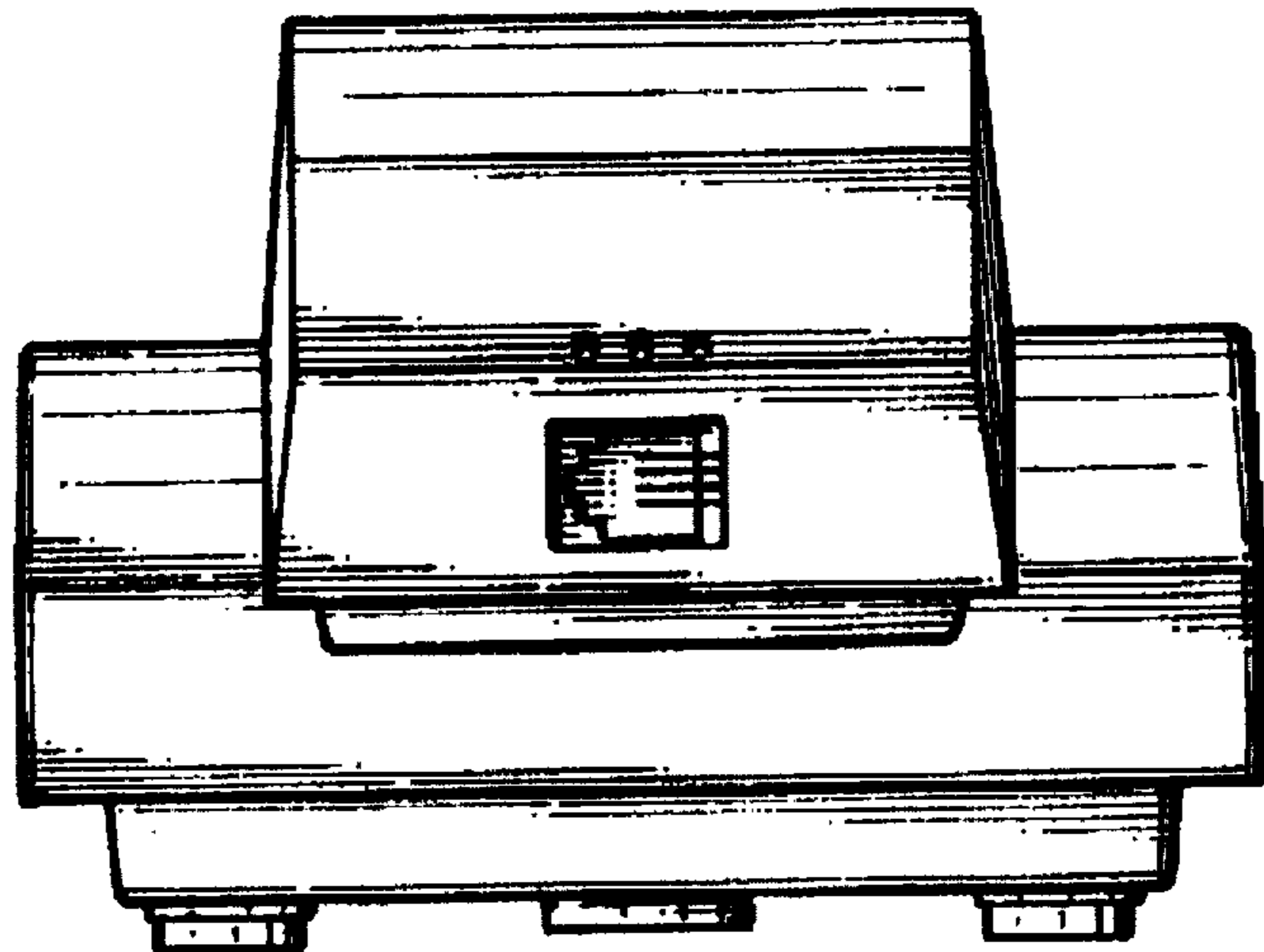

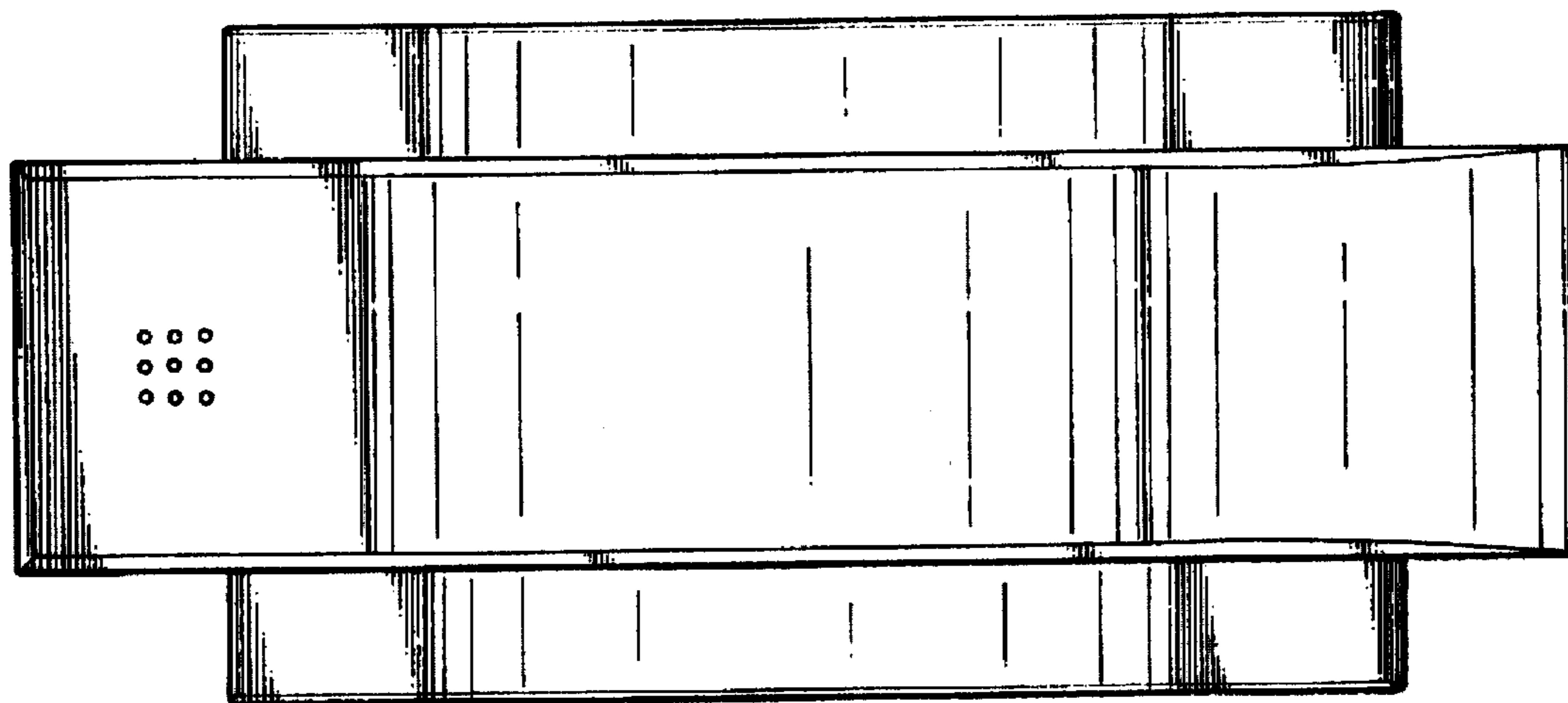

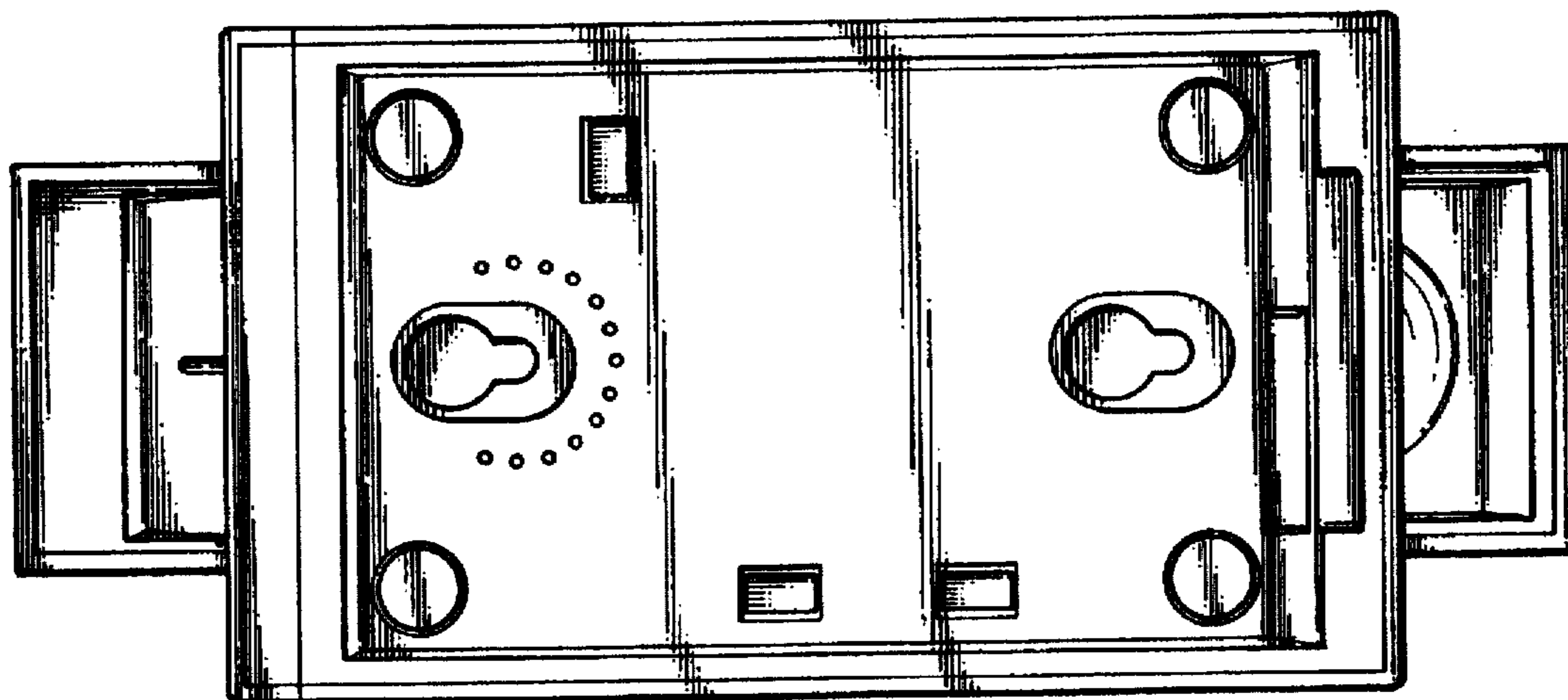
