[57] **CLAIM**

The ornamental design for a wall mounted luminaire, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a wall mounted luminaire showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a side elevational view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a top plan view of a second embodiment of the design;
FIG. 7 is a side elevational view thereof;
FIG. 8 is a bottom plan view thereof;
FIG. 9 is a top plan view of a third embodiment of the design;
FIG. 10 is a side elevational view thereof;
FIG. 11 is a bottom plan view thereof; and,
FIG. 12 is a rear elevational view.
The front and rear configurations shown in FIGS. 2 and 12 are common to the first, second, and third embodiments.

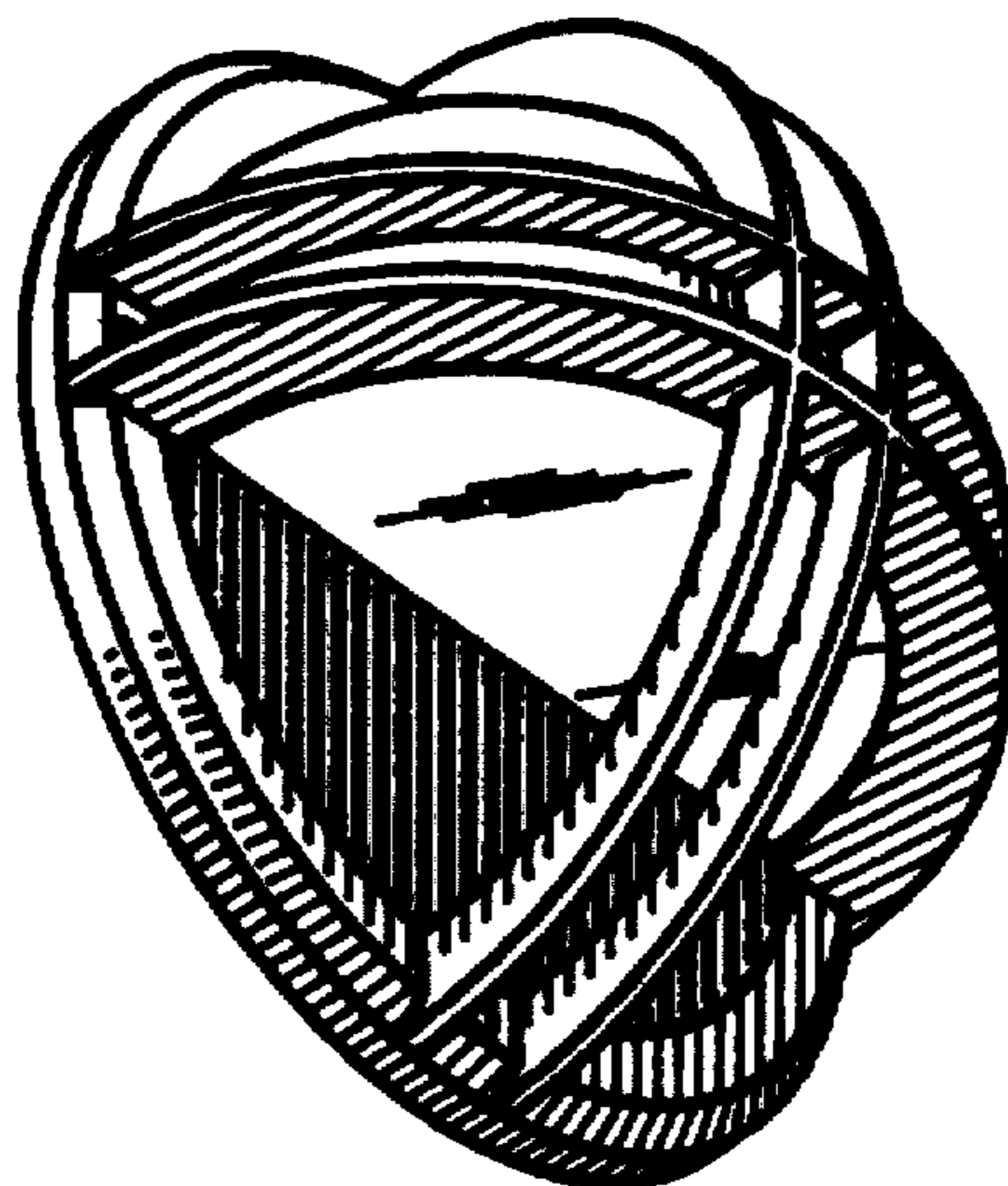

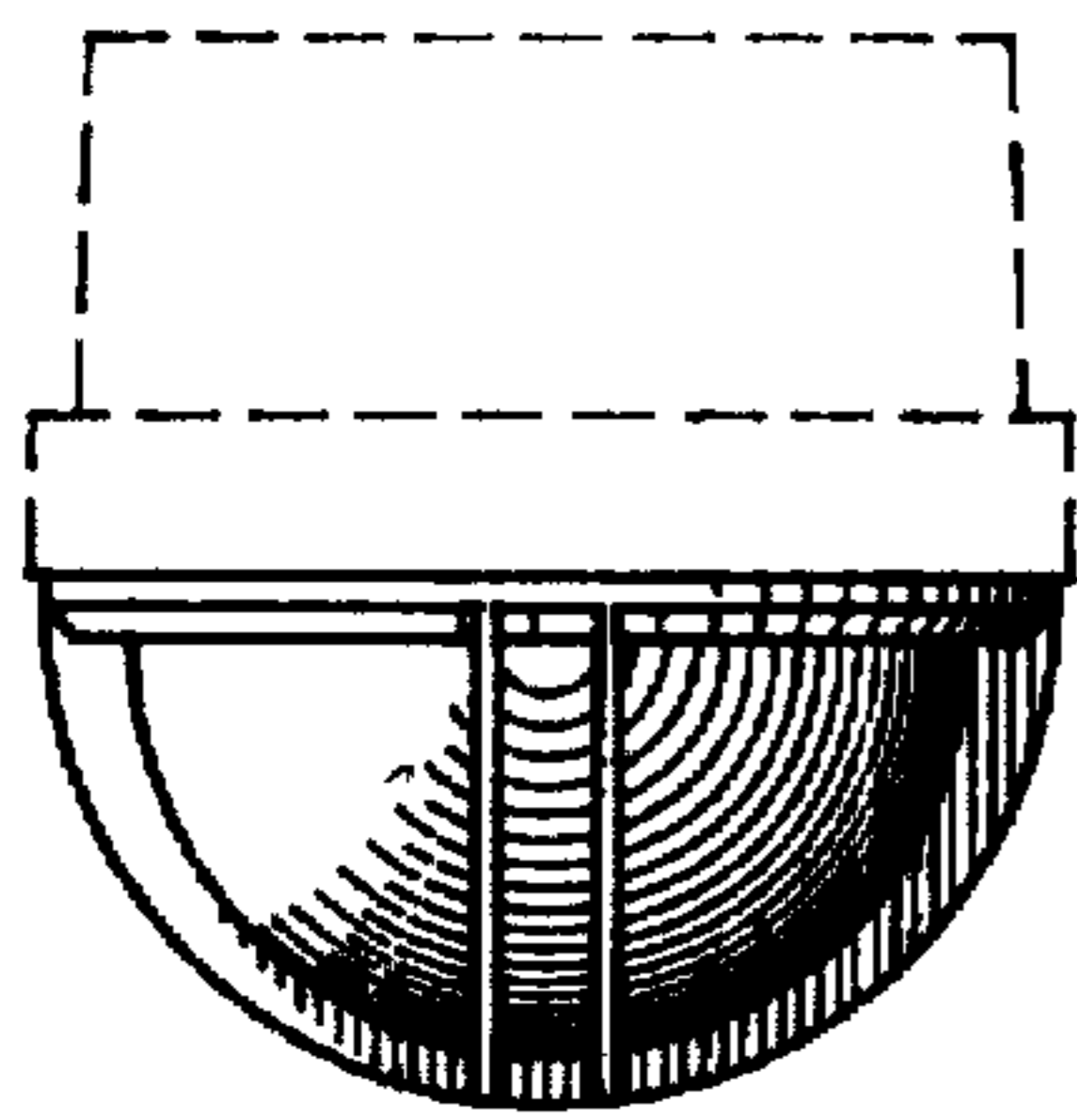

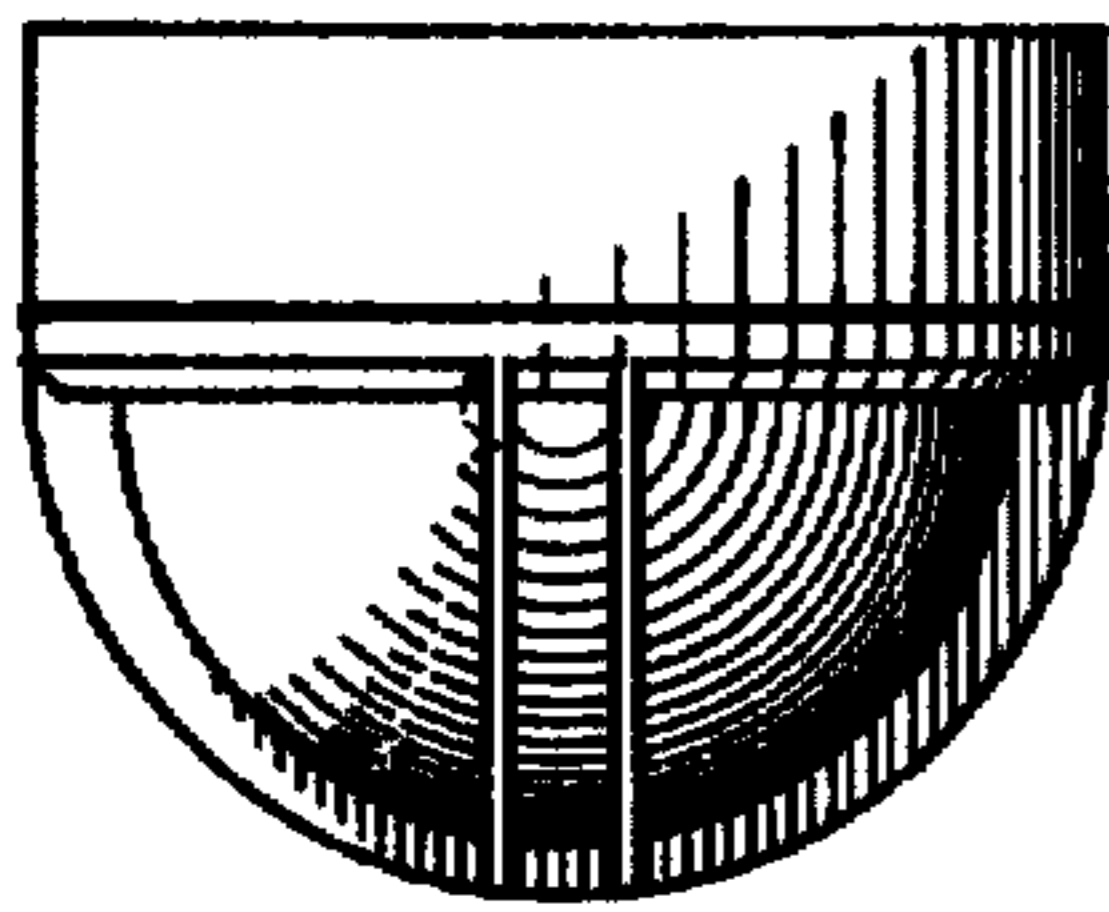

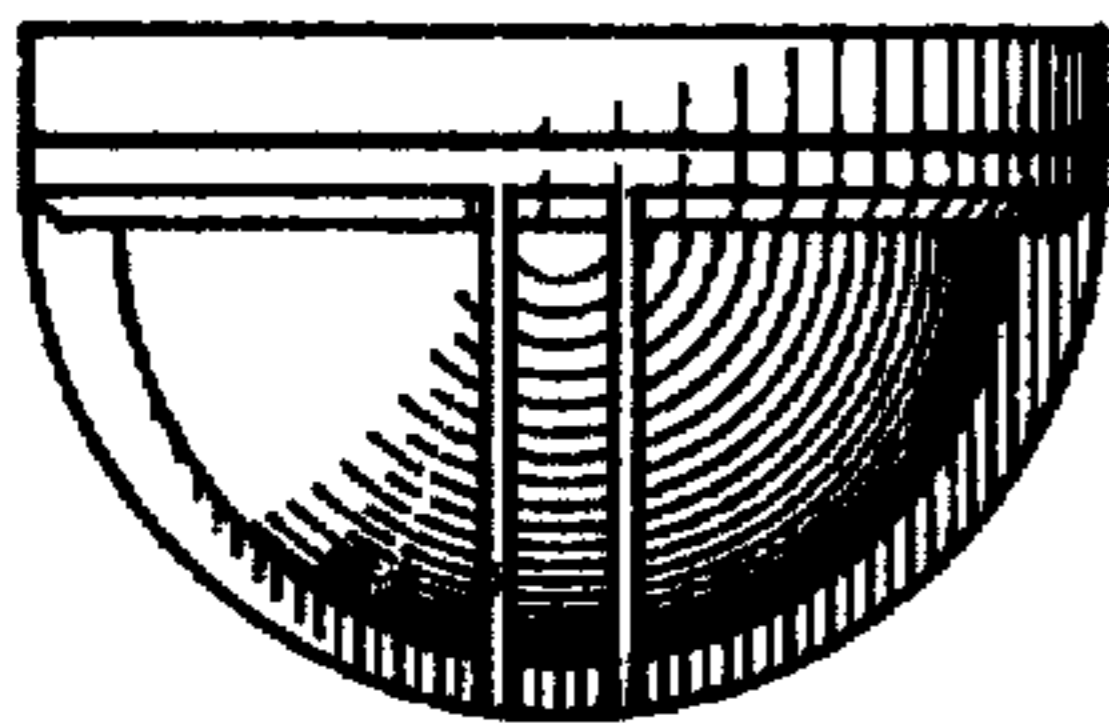

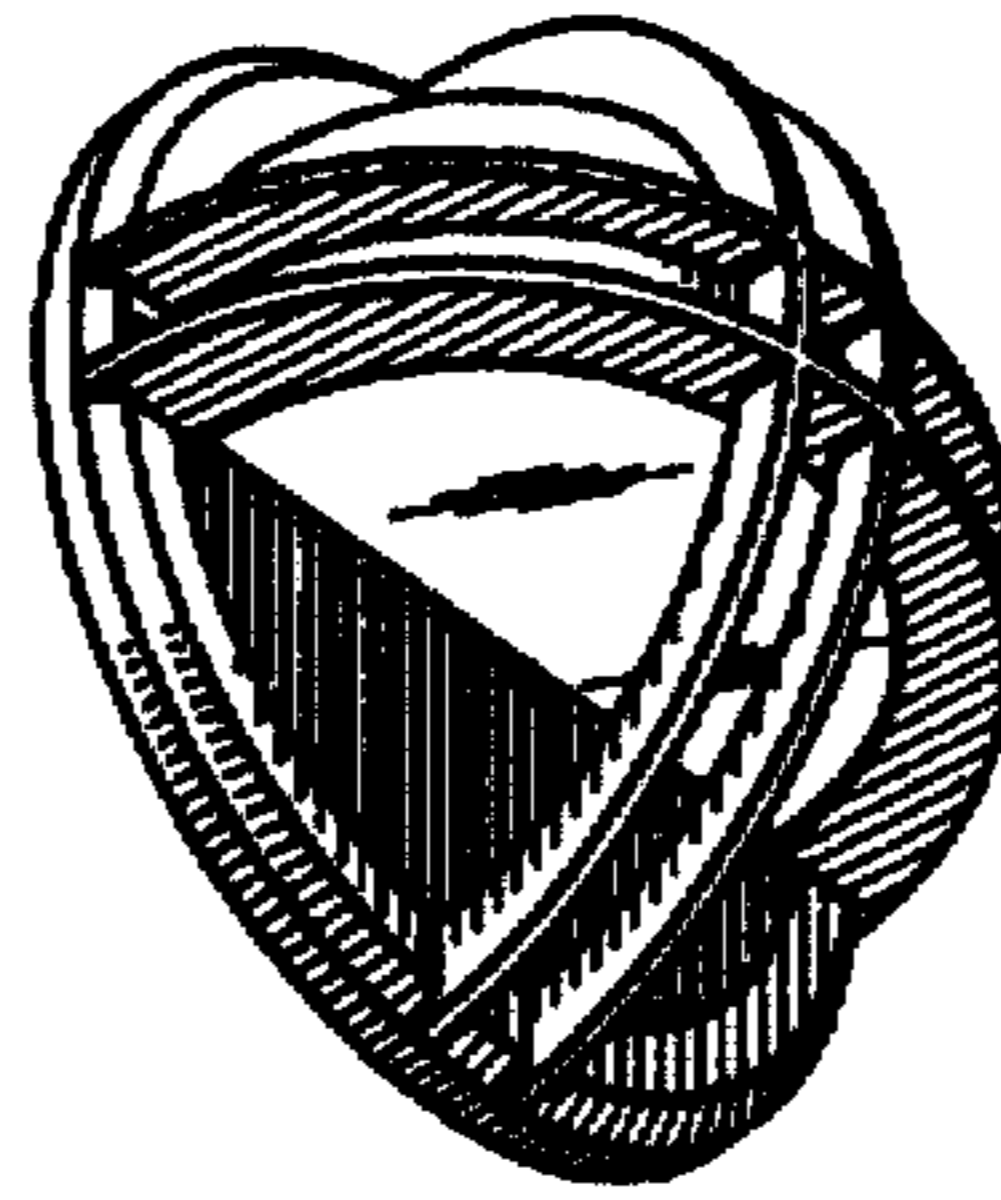

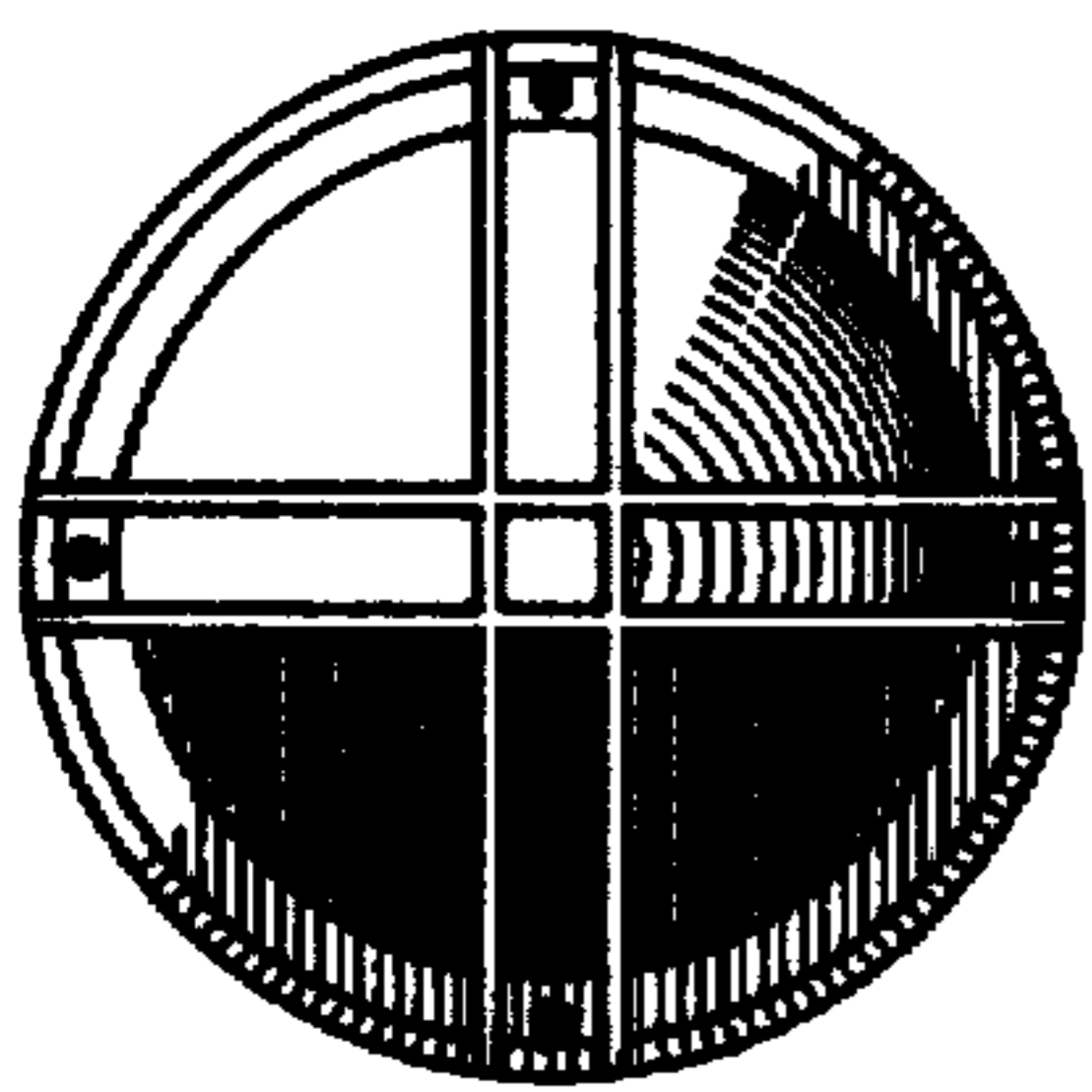

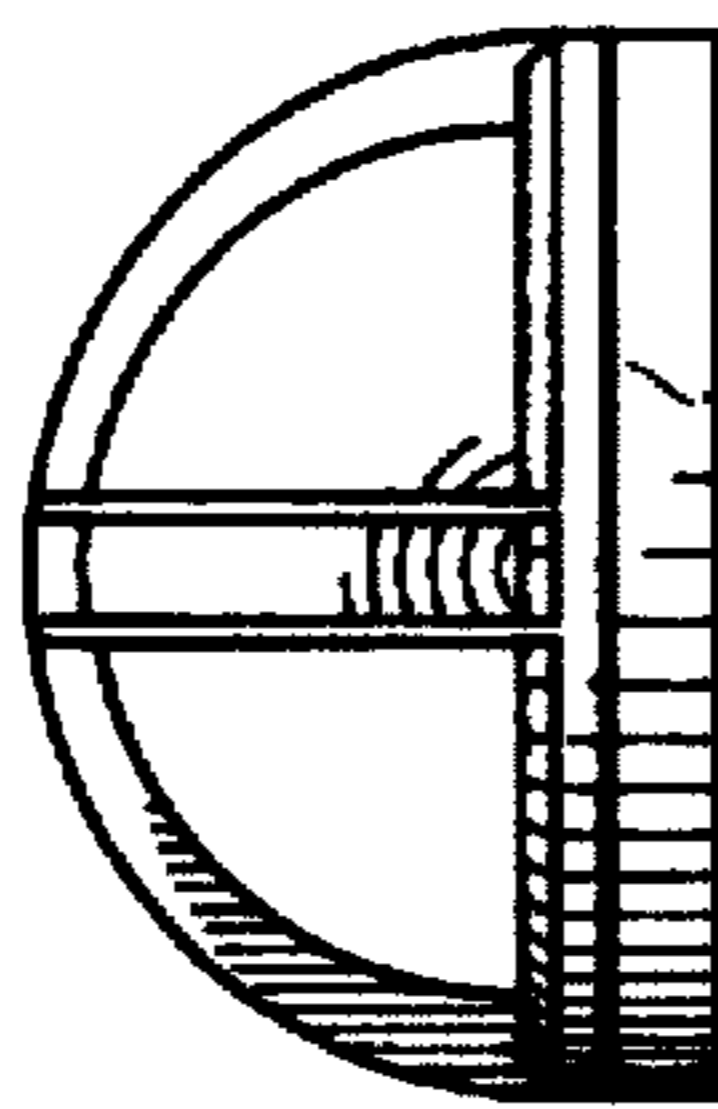

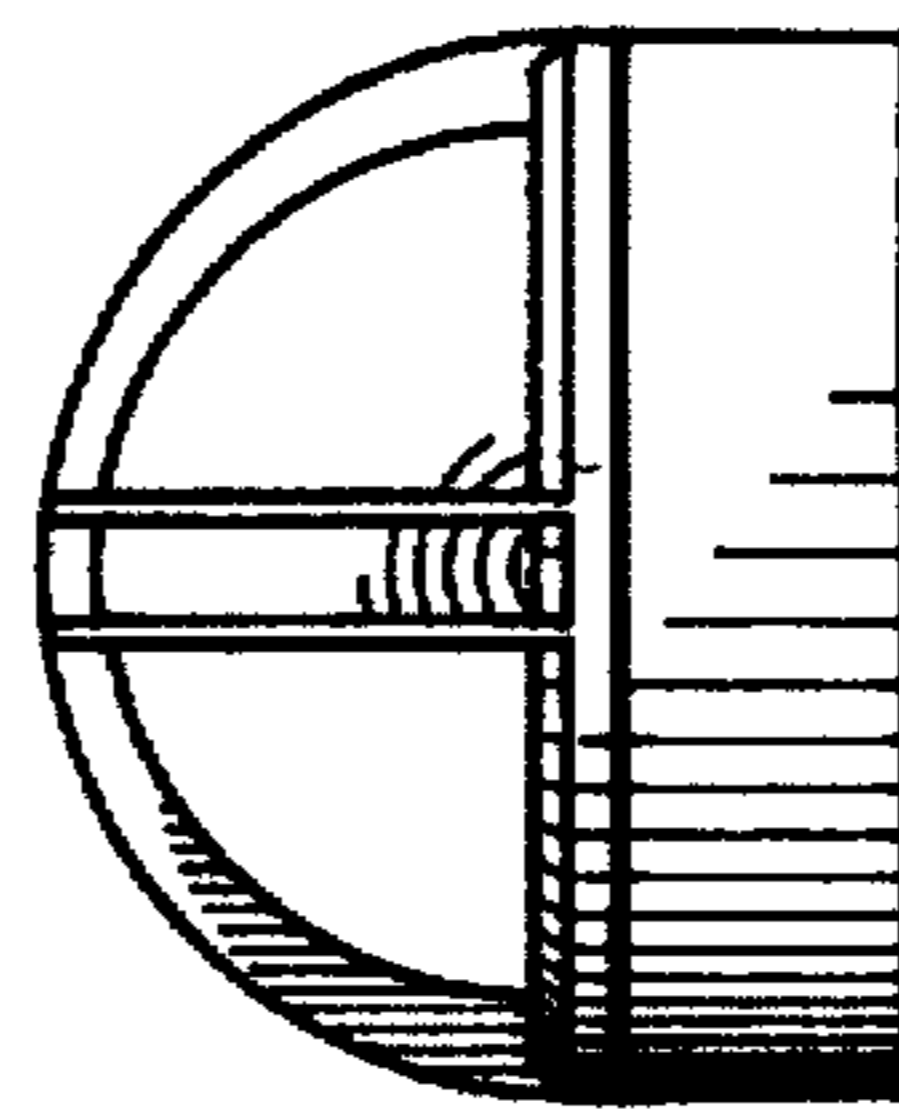

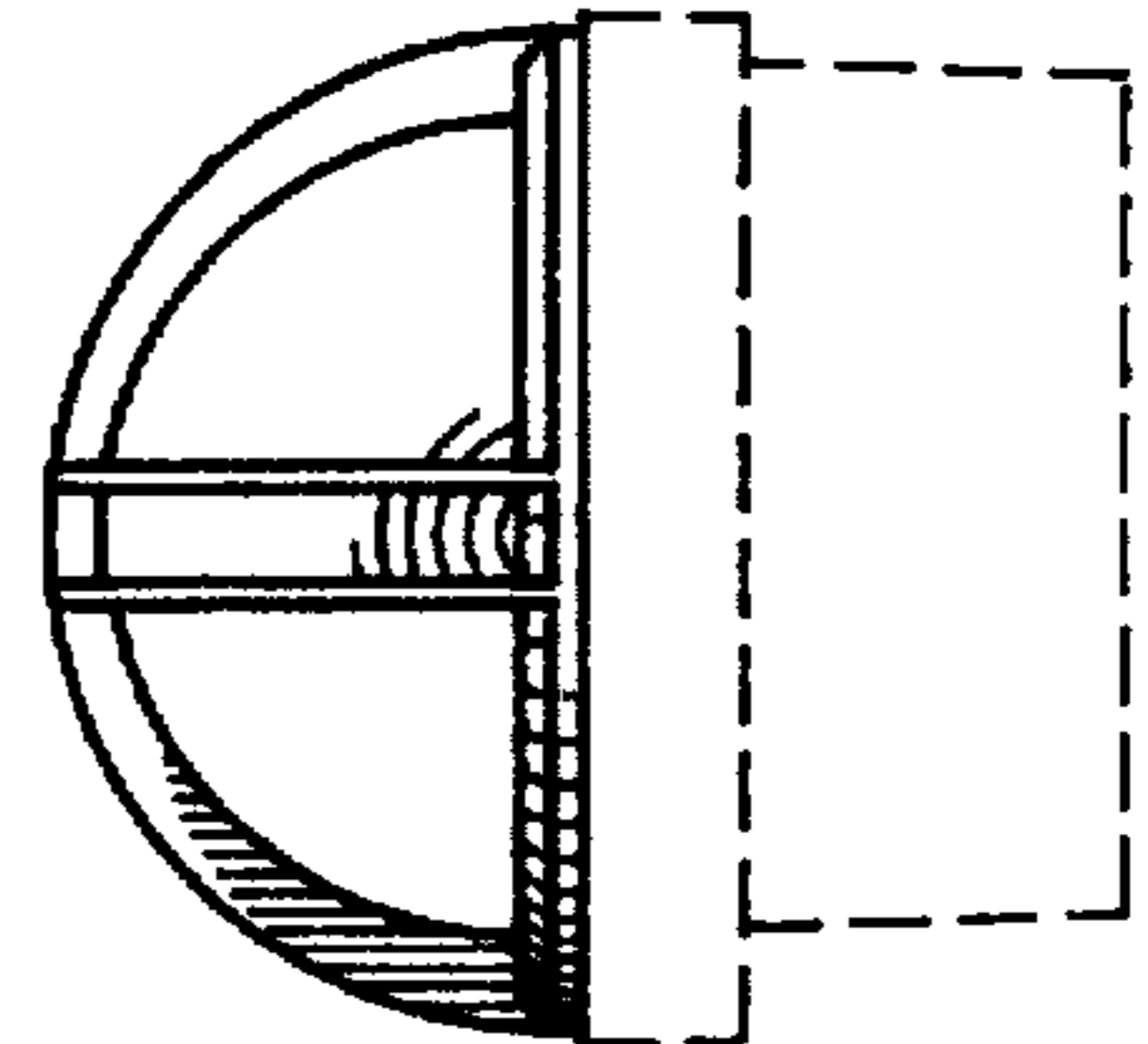

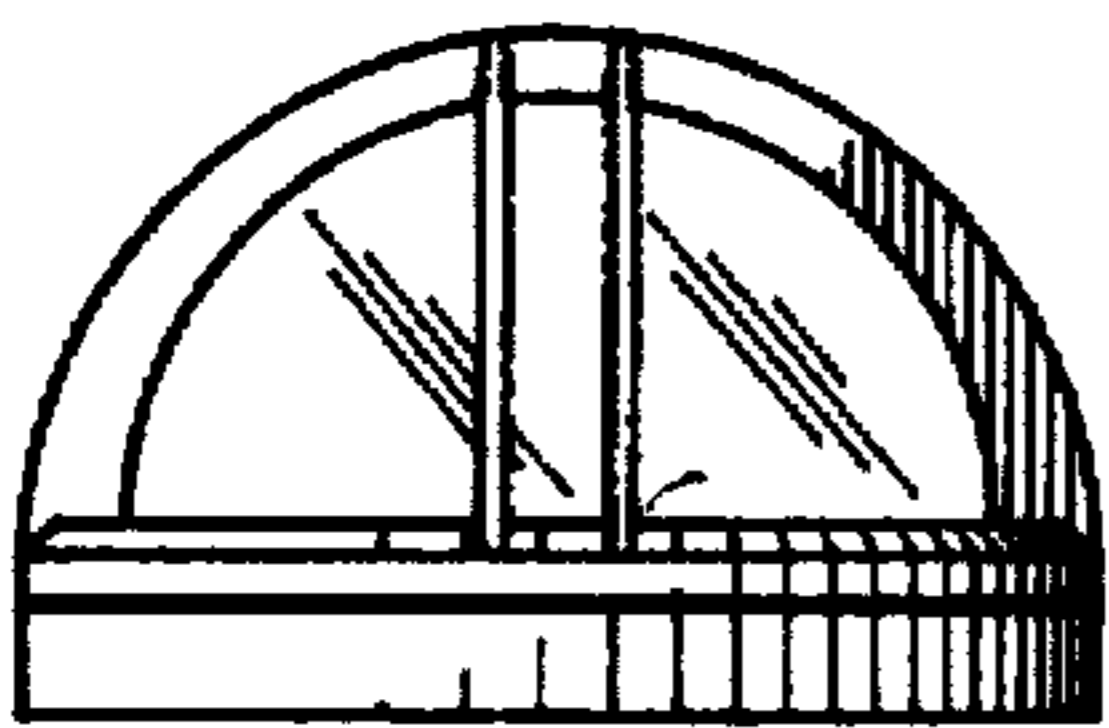

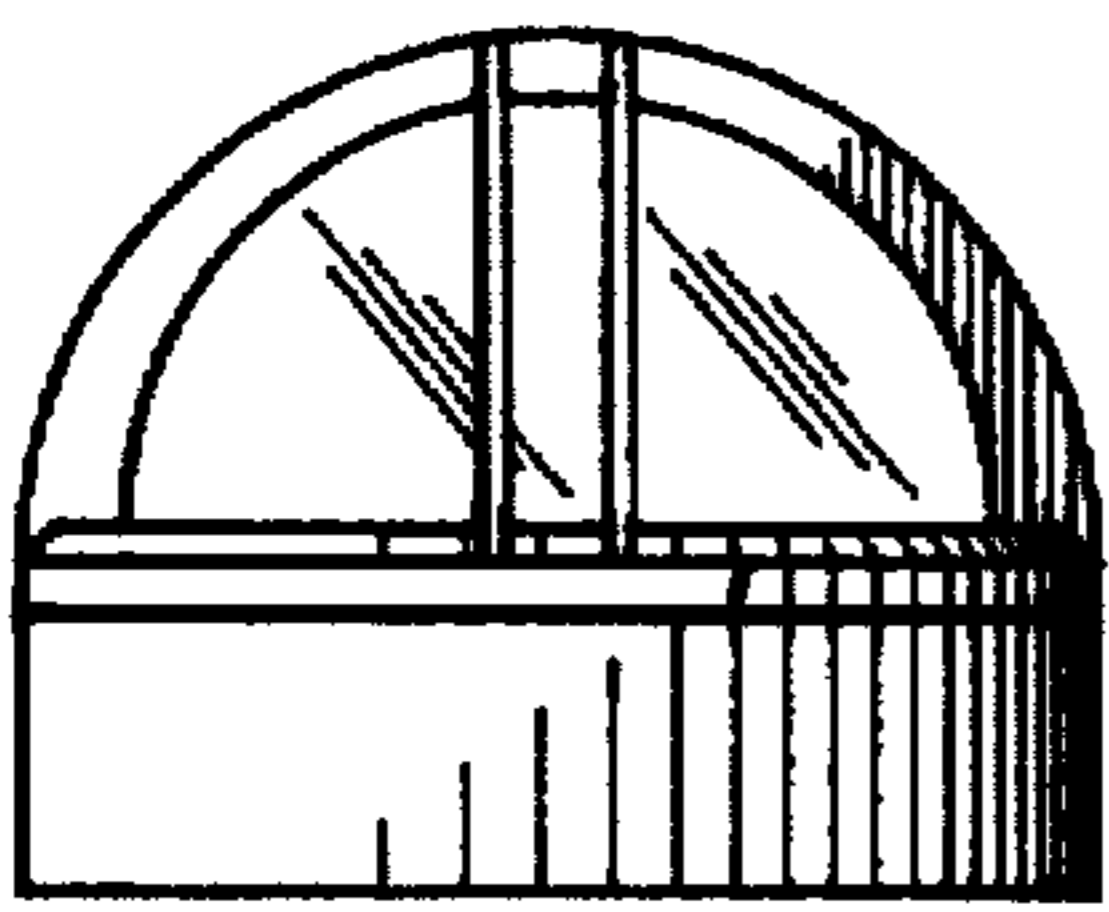

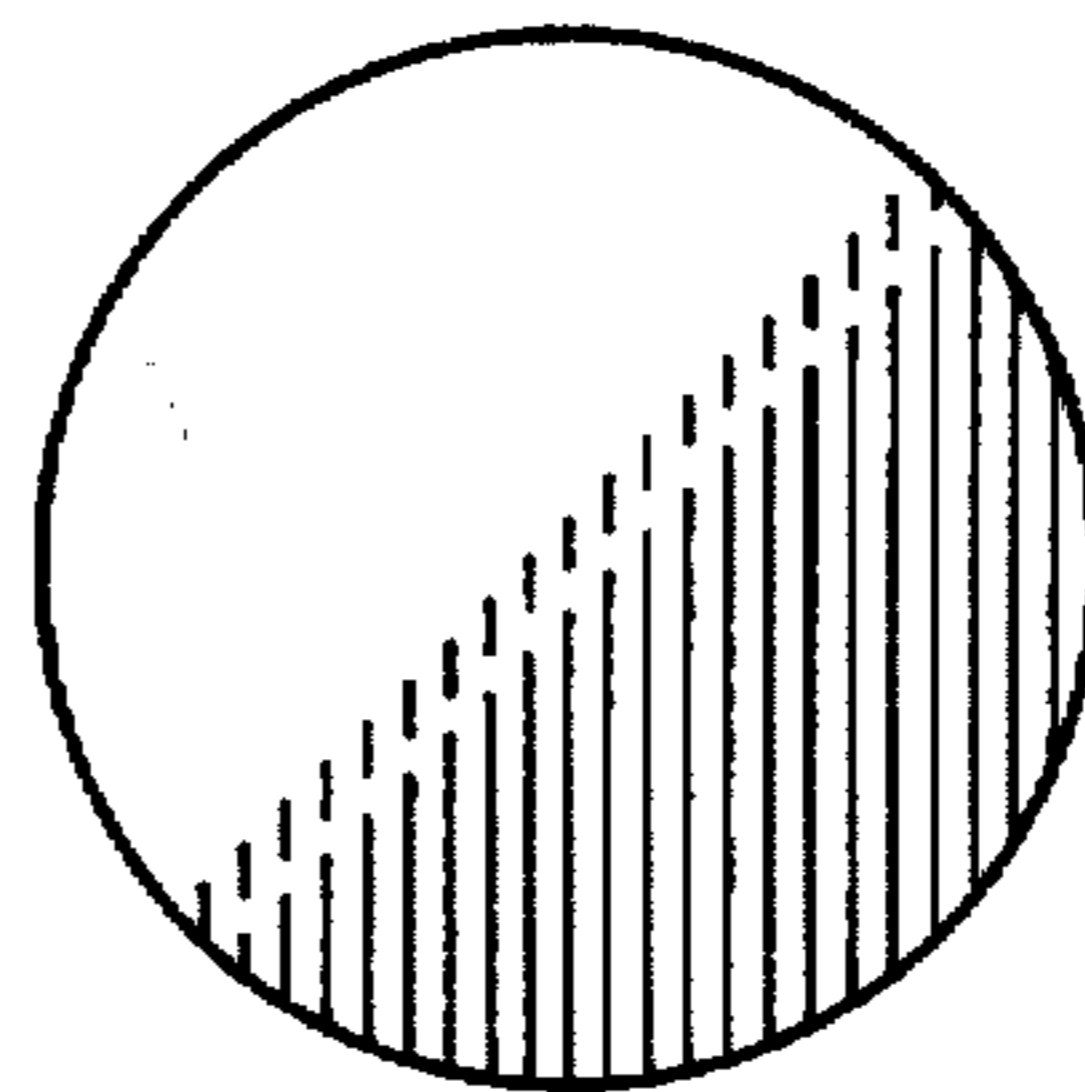

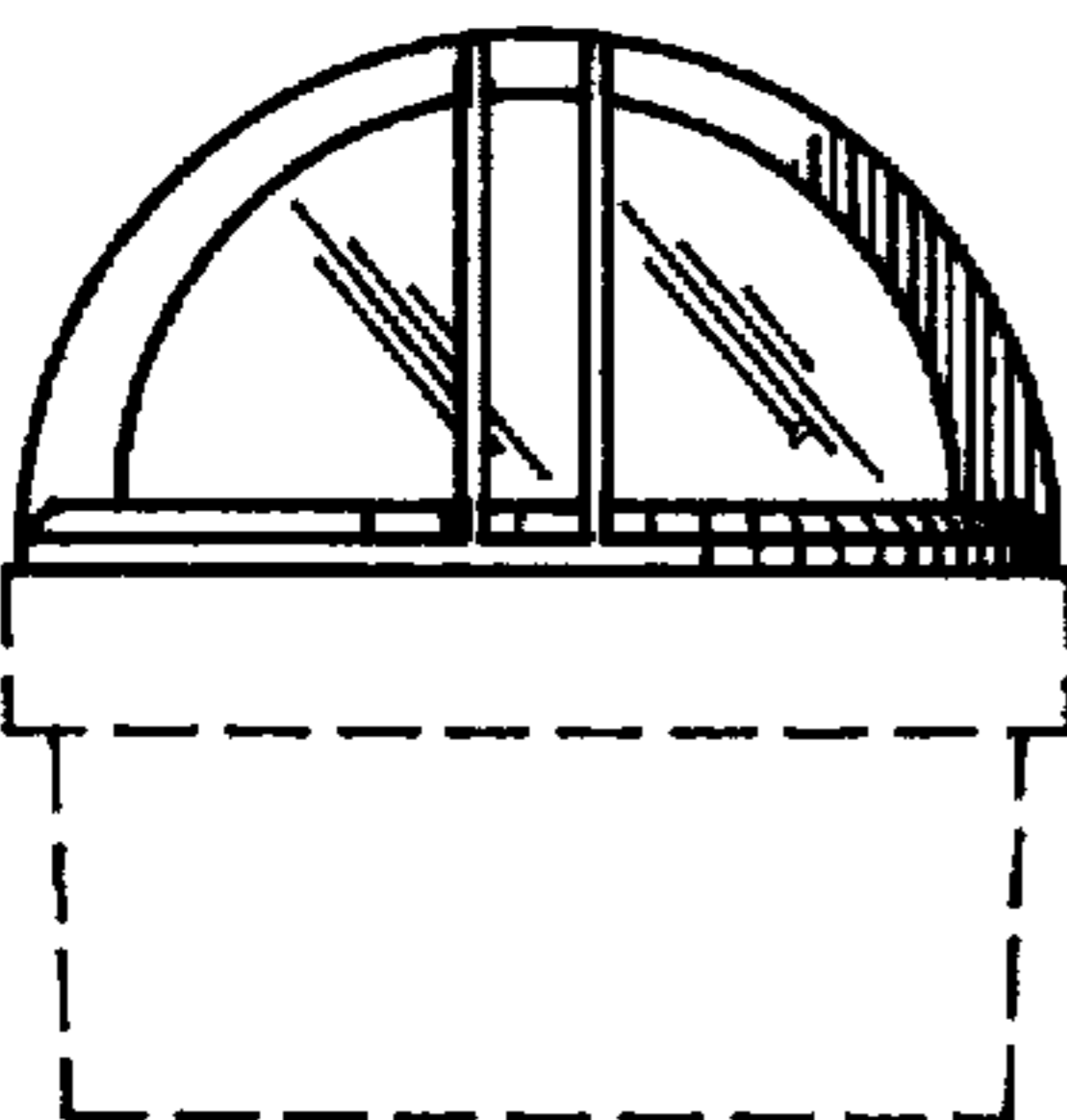
