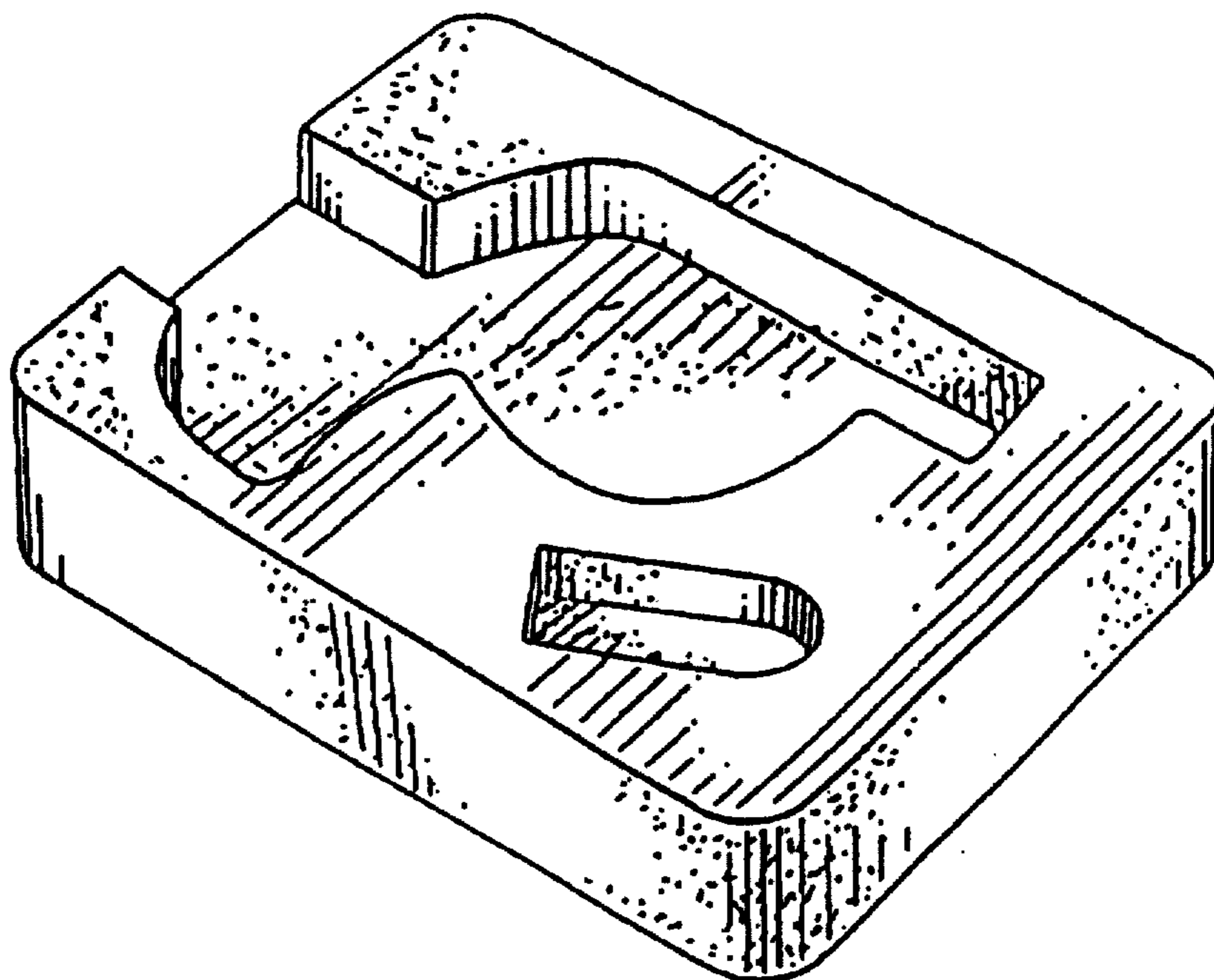
[57] **CLAIM**

The ornamental design for a gun carrying case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the gun carrying case showing my new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a front elevational view, the rear being a mirror image thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 5A is a left side elevational view thereof;  
FIG. 6 is a perspective view of the second embodiment;  
FIG. 7 is a top view thereof;  
FIG. 8 is a front elevational view, the rear being a mirror image thereof;  
FIG. 9 is a bottom view thereof;  
FIG. 10 is a right side elevational view thereof; and,  
FIG. 10A is a left side elevational view thereof.

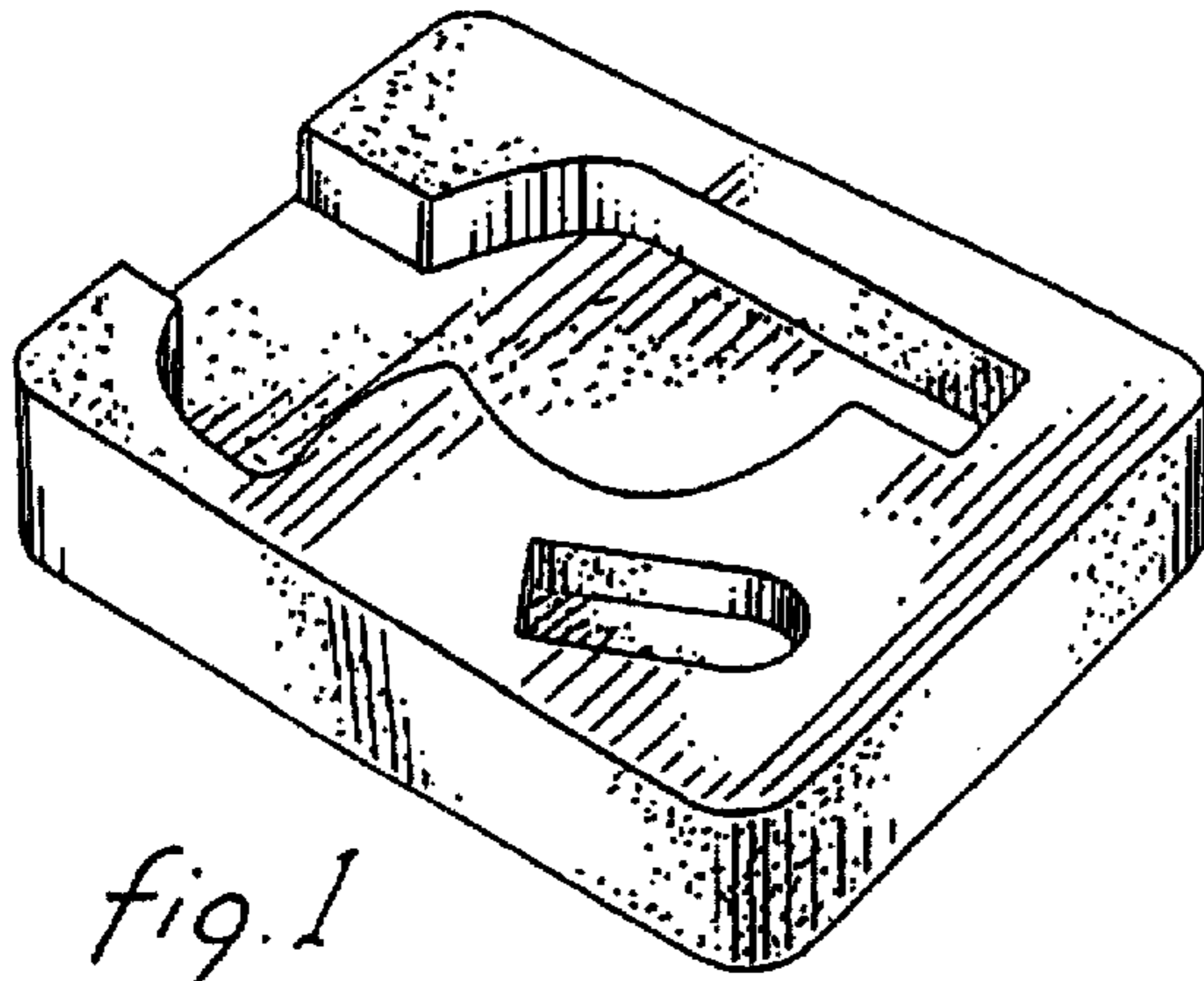

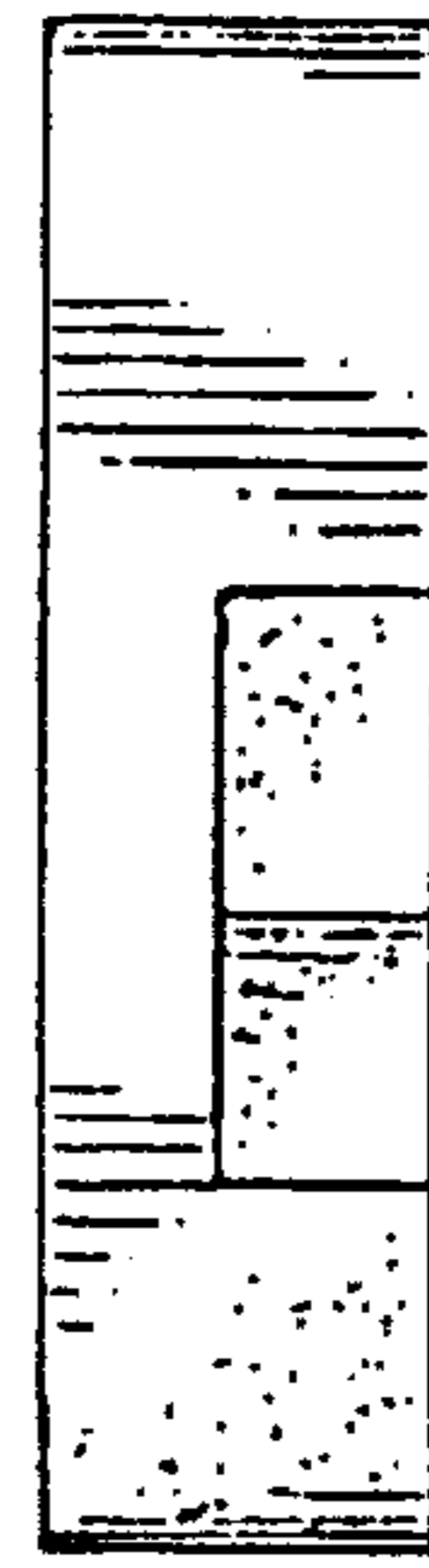

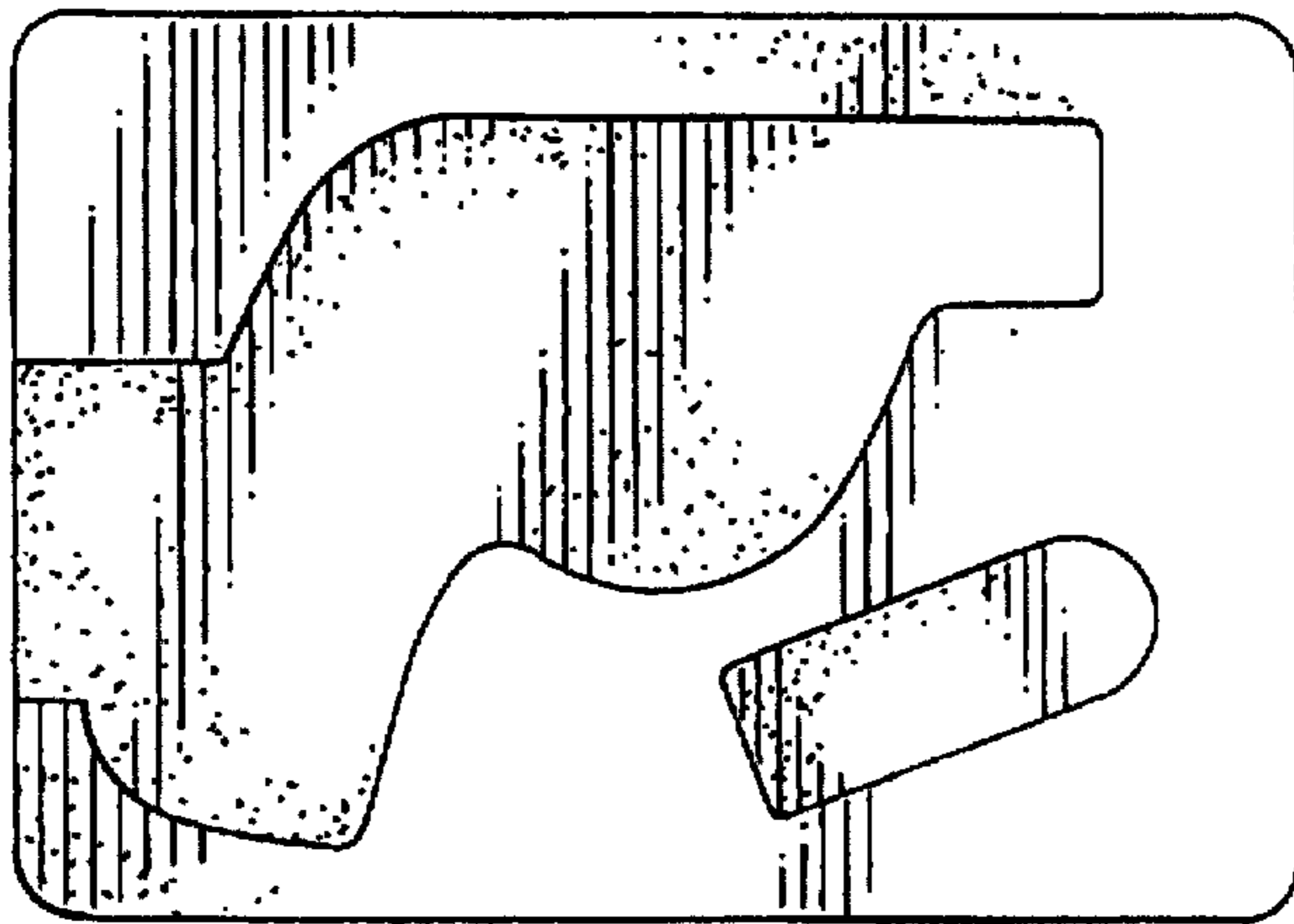

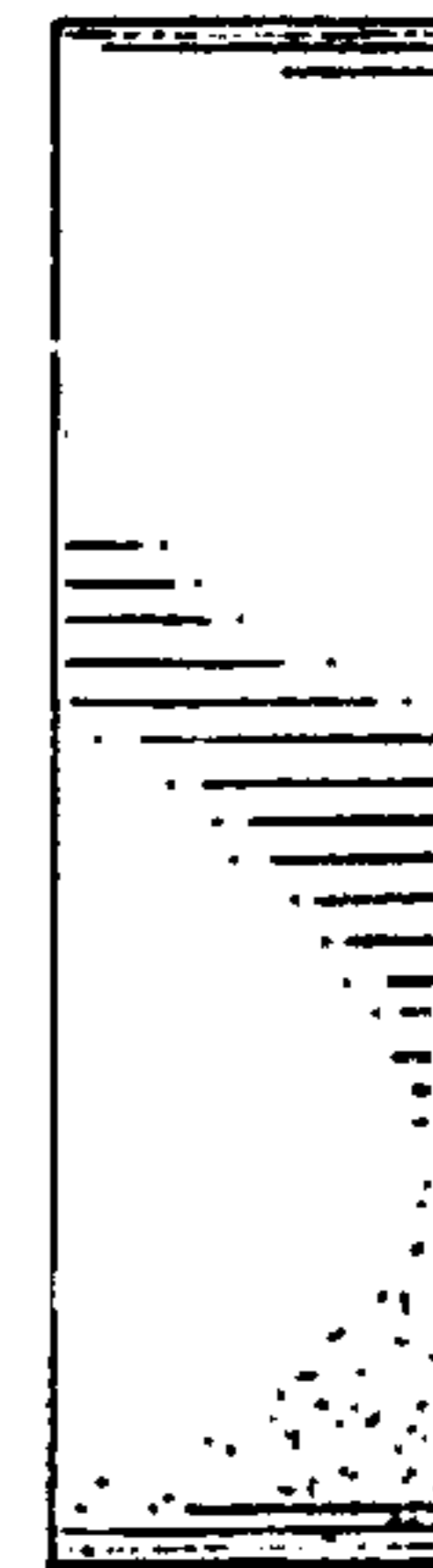

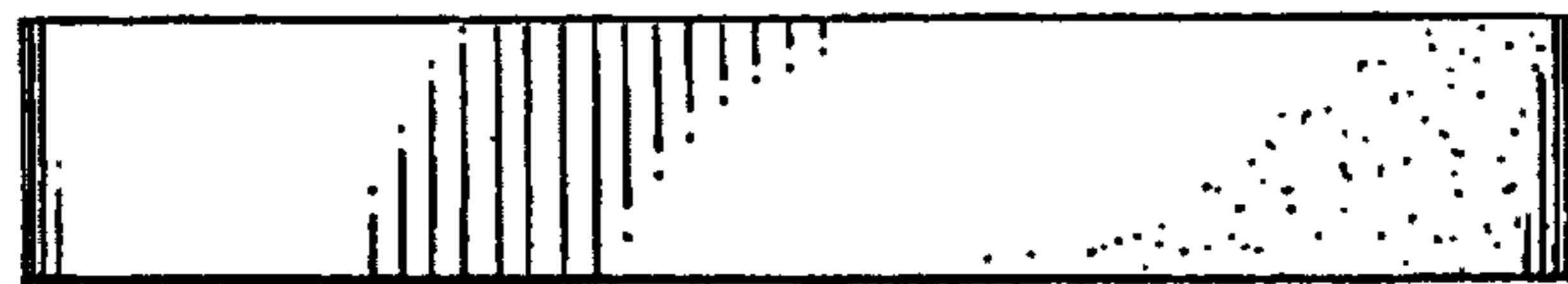

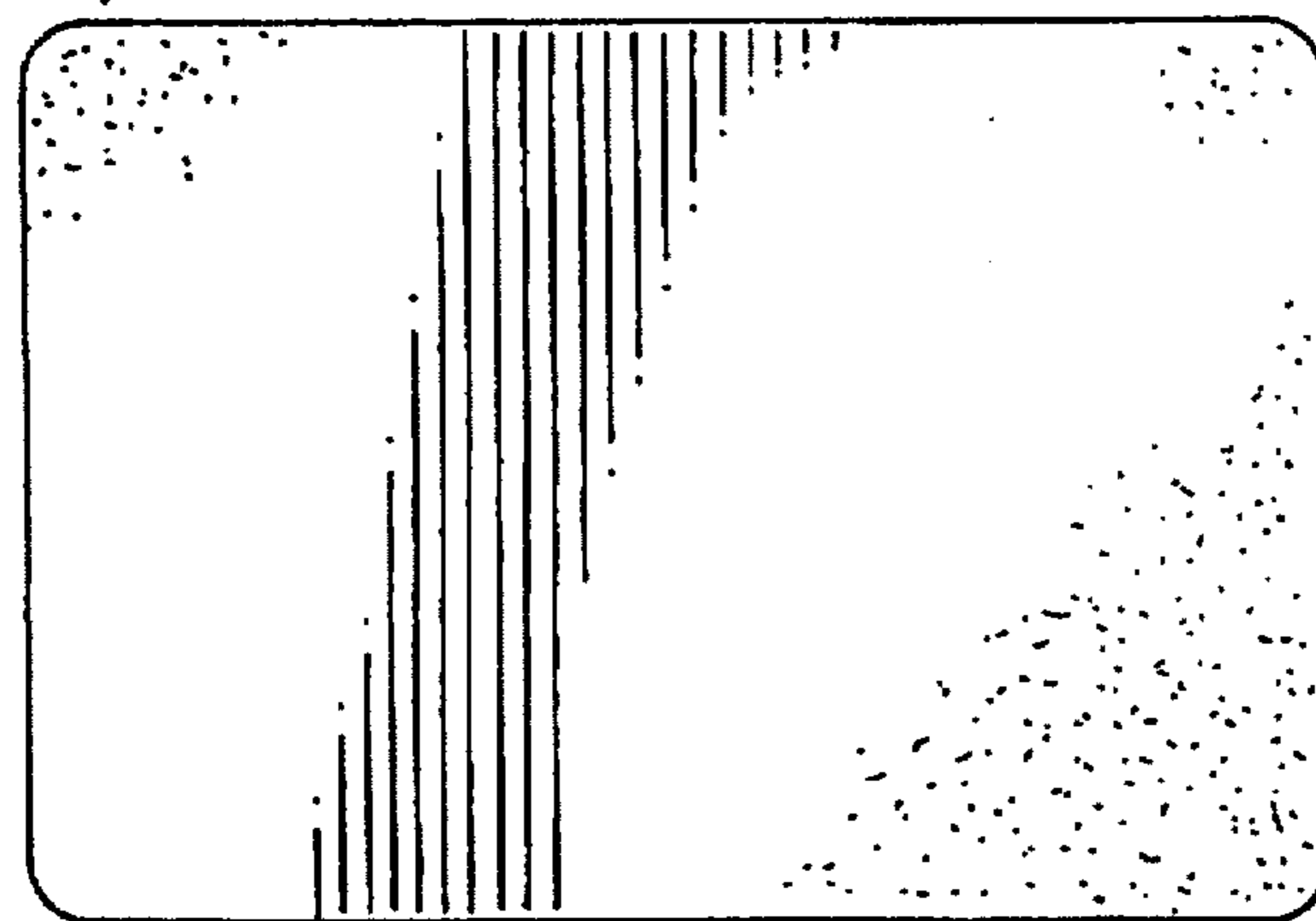

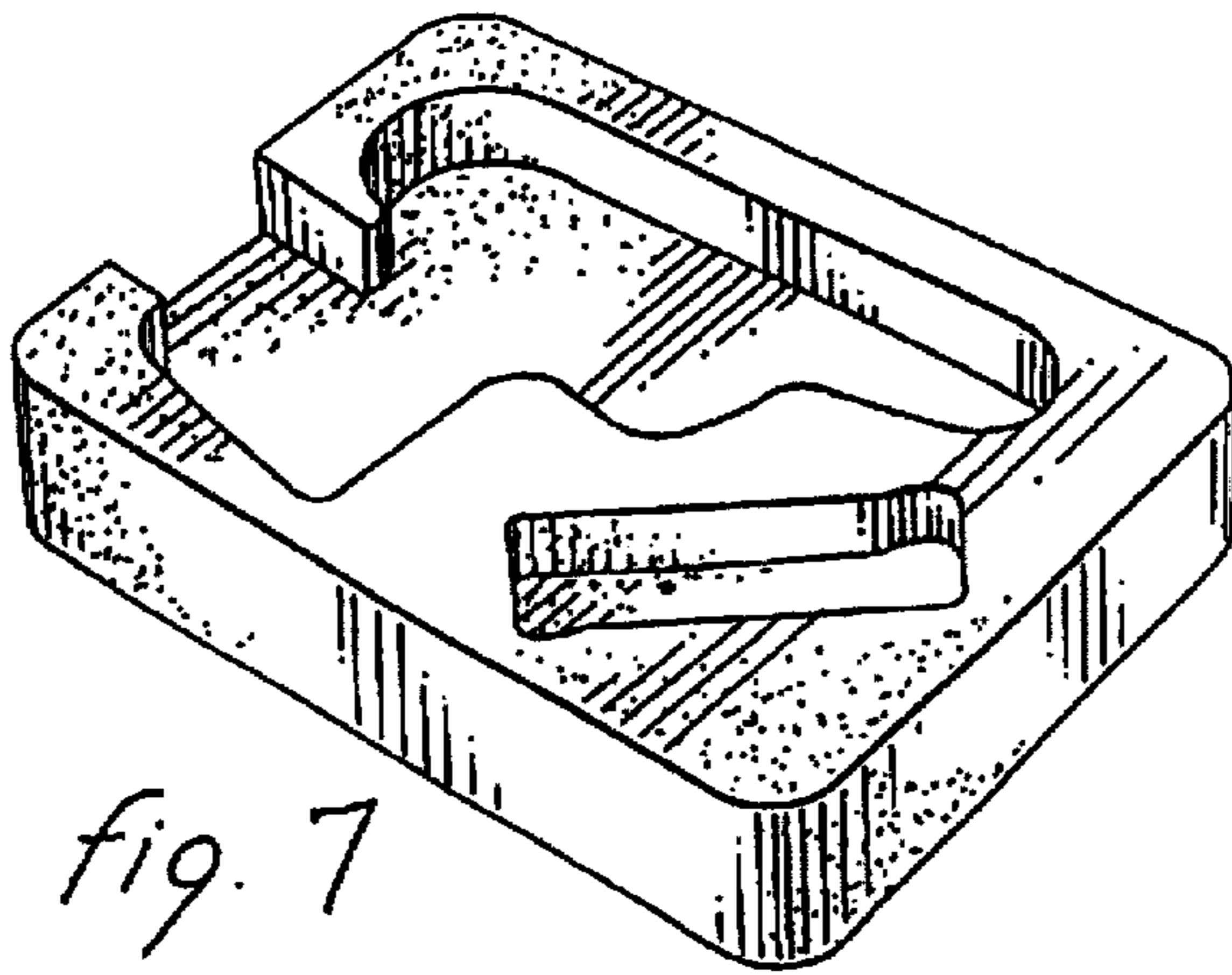

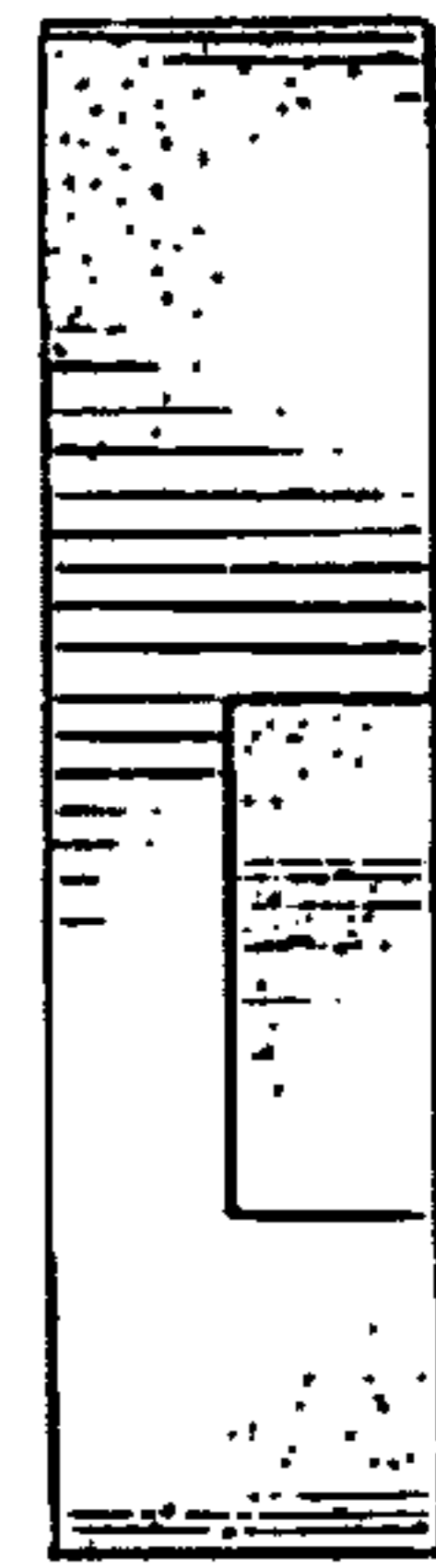

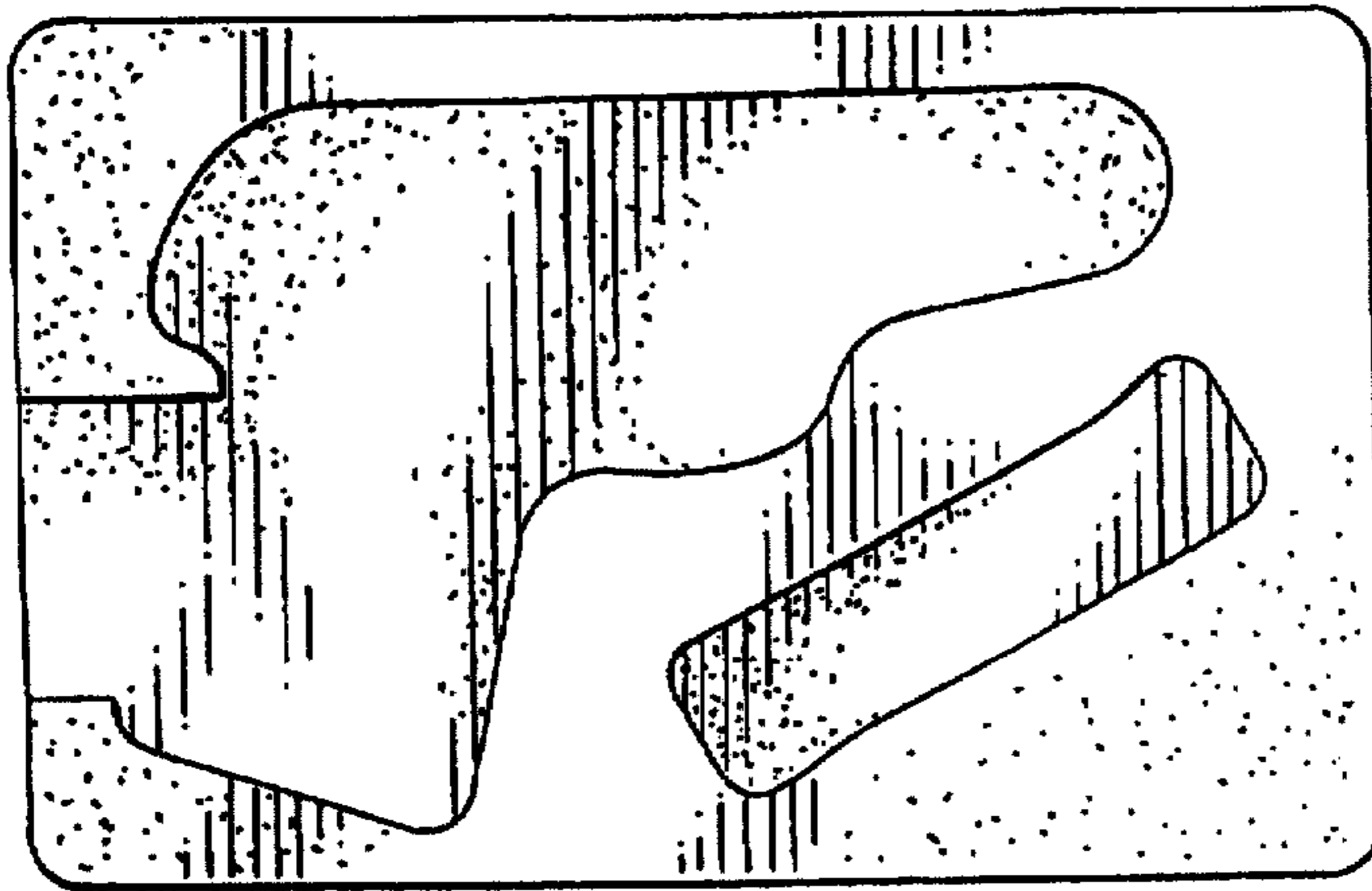

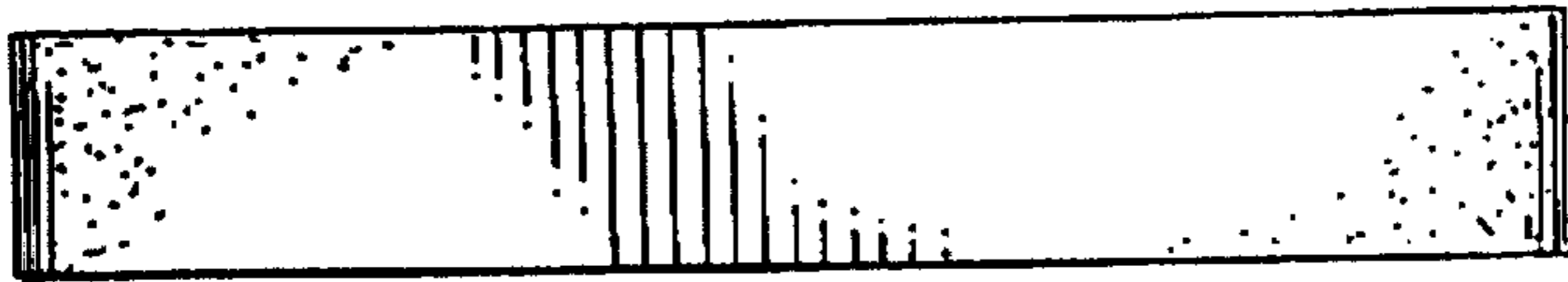

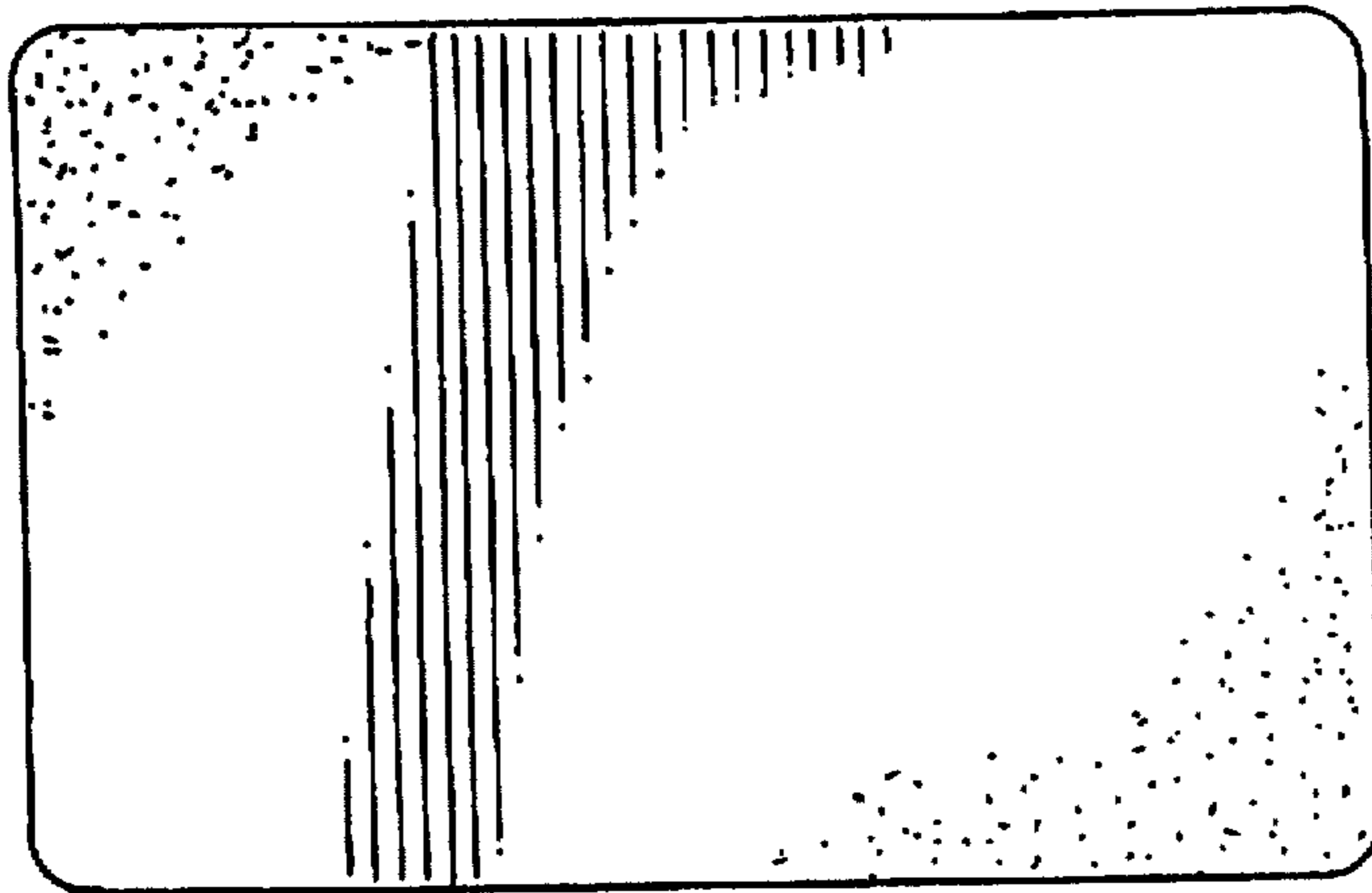
