The ornamental design for a seat, as shown and described.

## DESCRIPTION

FIG. 1 is a side perspective view showing our new seat  
design in the form of a sofa;

FIG. 2 is a front perspective view thereof;

FIG. 3 is a side elevational view;

FIG. 4 is a rear perspective view;

FIG. 5 is a top perspective view;

FIG. 6 is a side perspective view showing our new seat  
design in the form of a loveseat, the opposing side being a  
mirror image thereof;

FIG. 7 is a front perspective view;

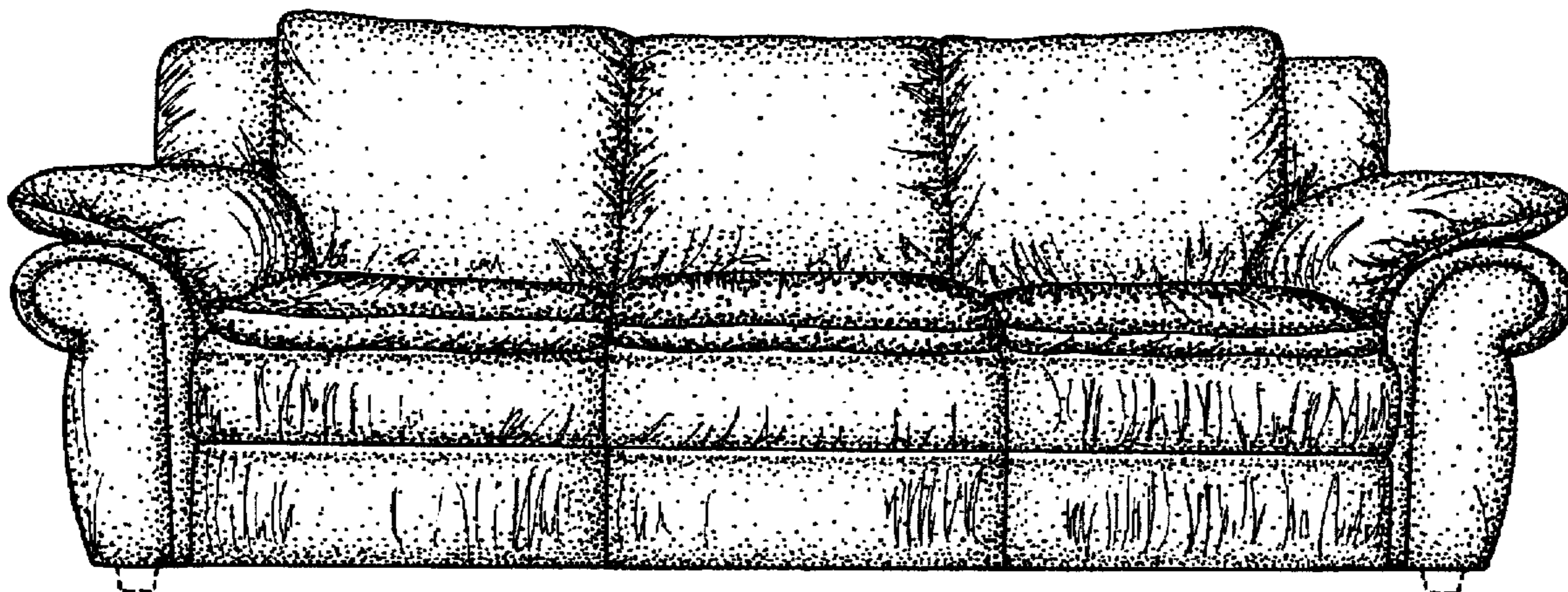
FIG. 8 is a side perspective view showing our new seat  
design in the form of a chair, the opposing side being a  
mirror image thereof; and,

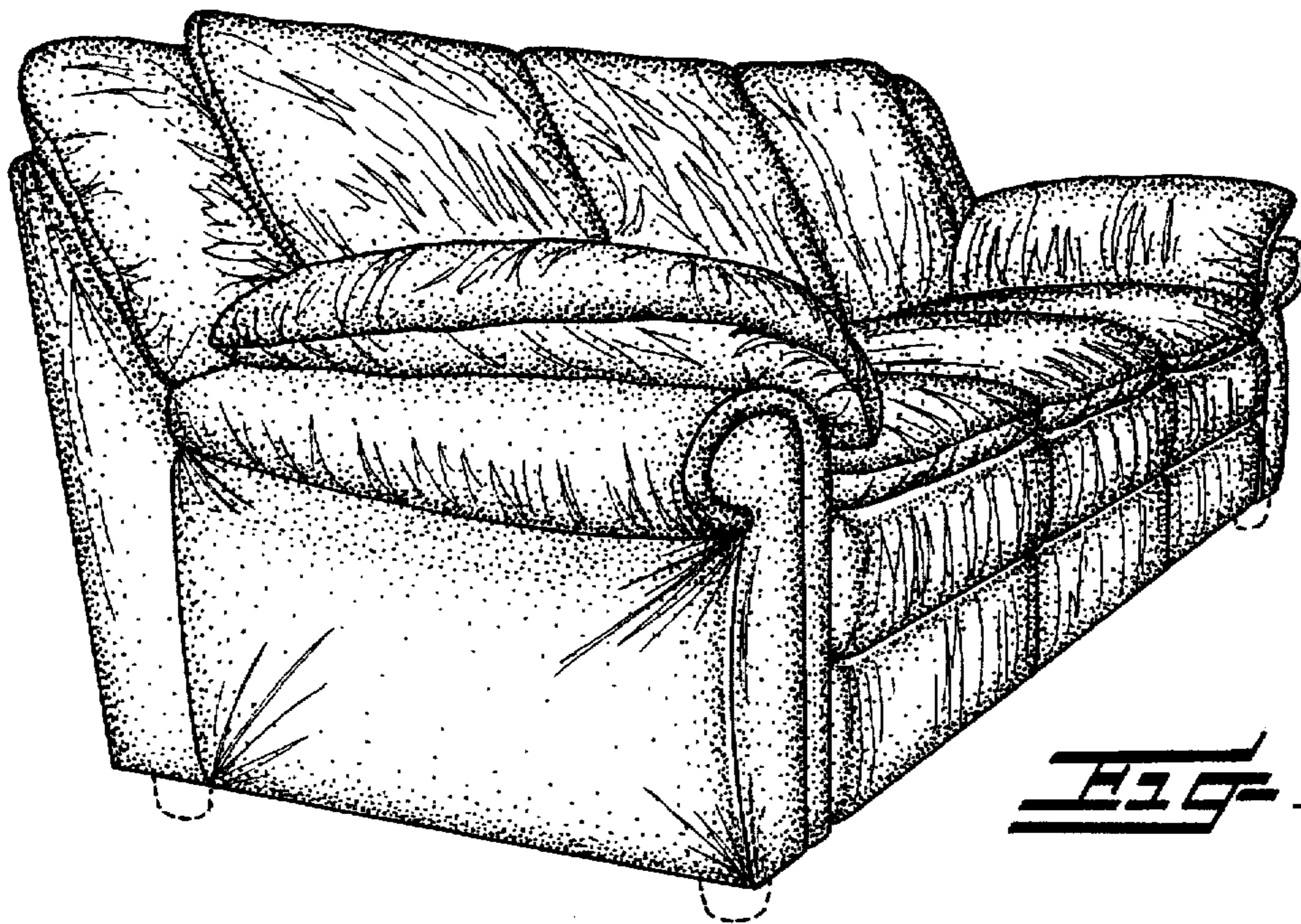
FIG. 9 is a front perspective view.

purposes only and forms no part of the claimed design.

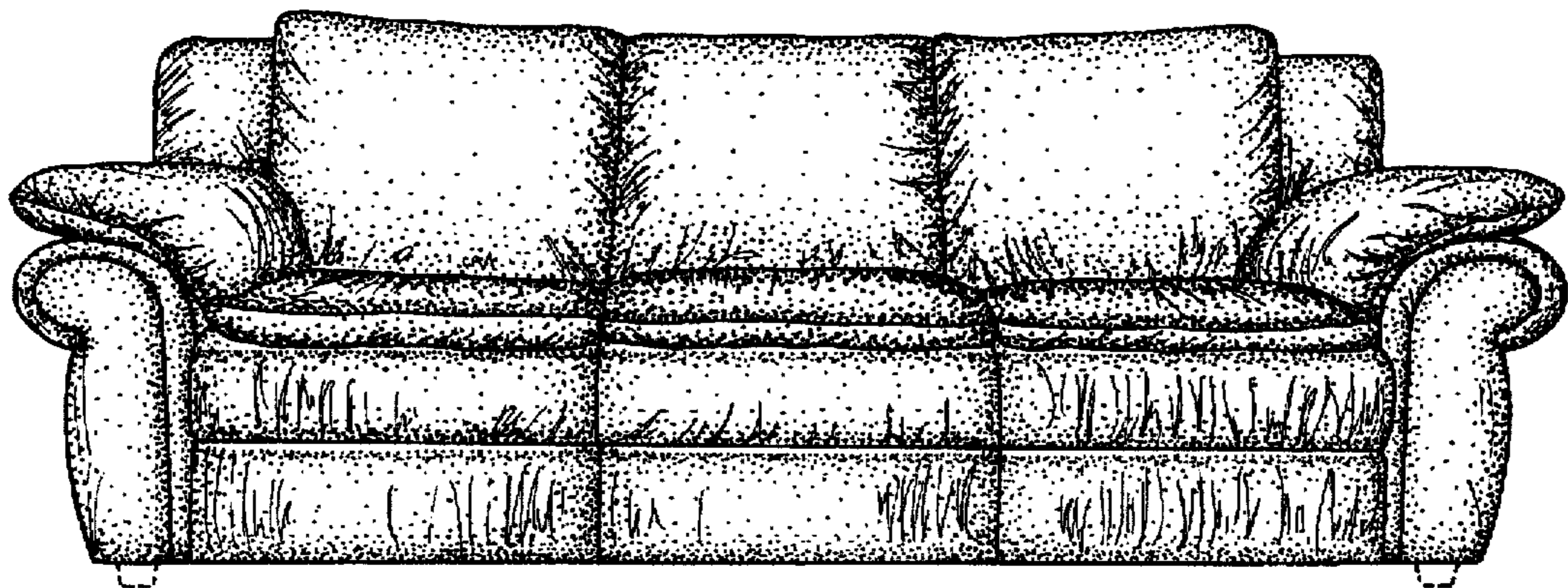
The rear view of the embodiments of FIGS. 6 and 8 are

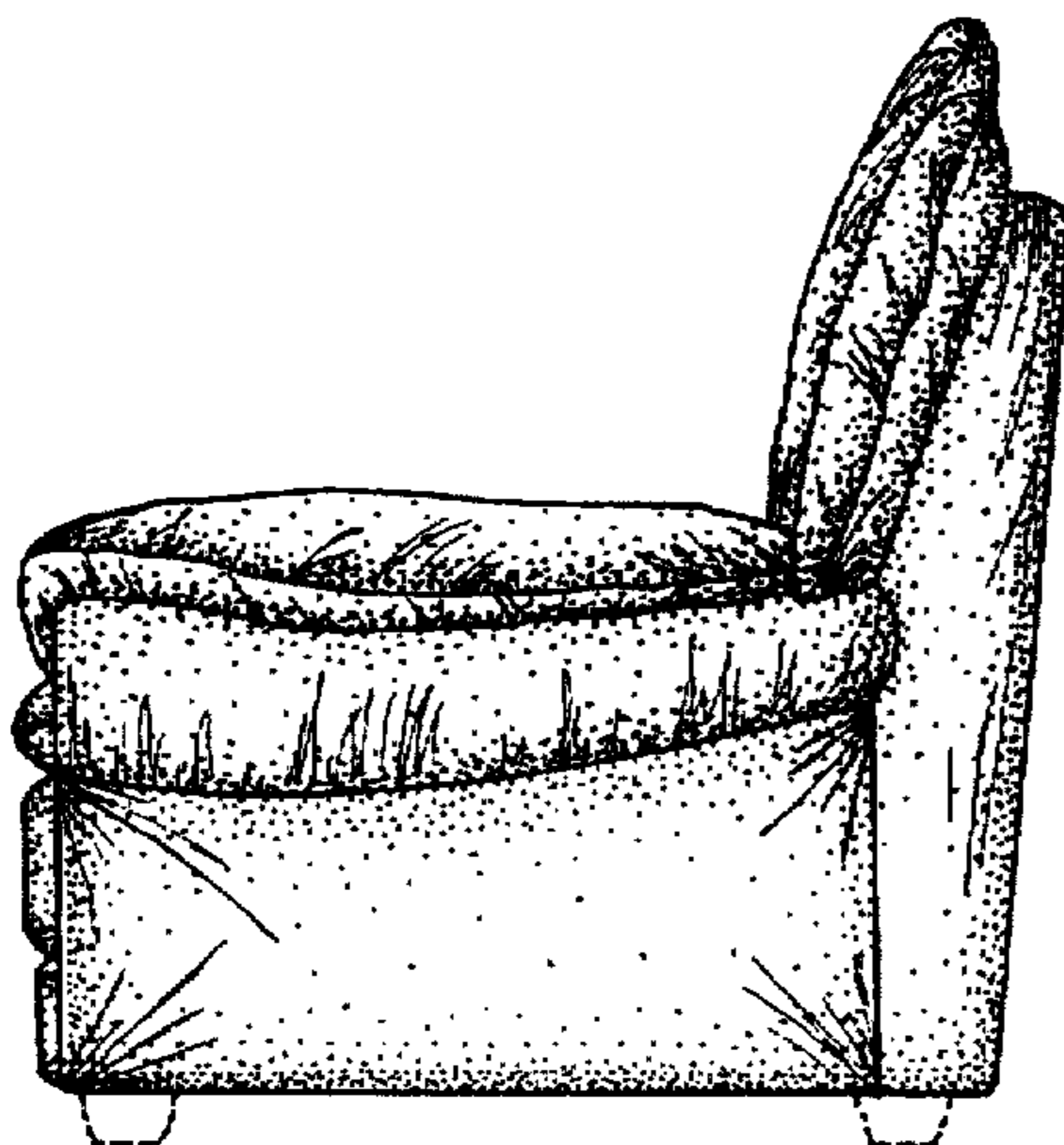




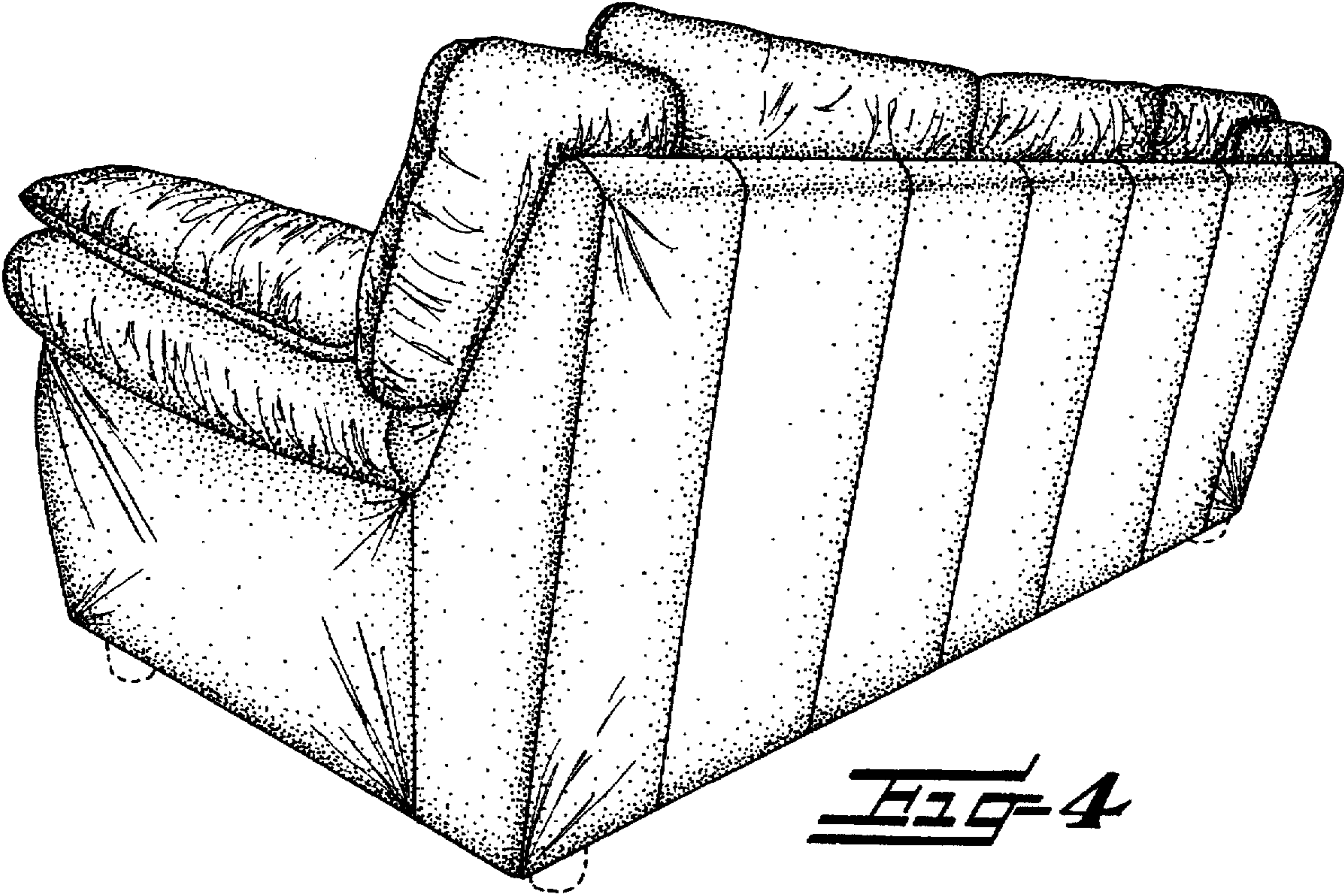

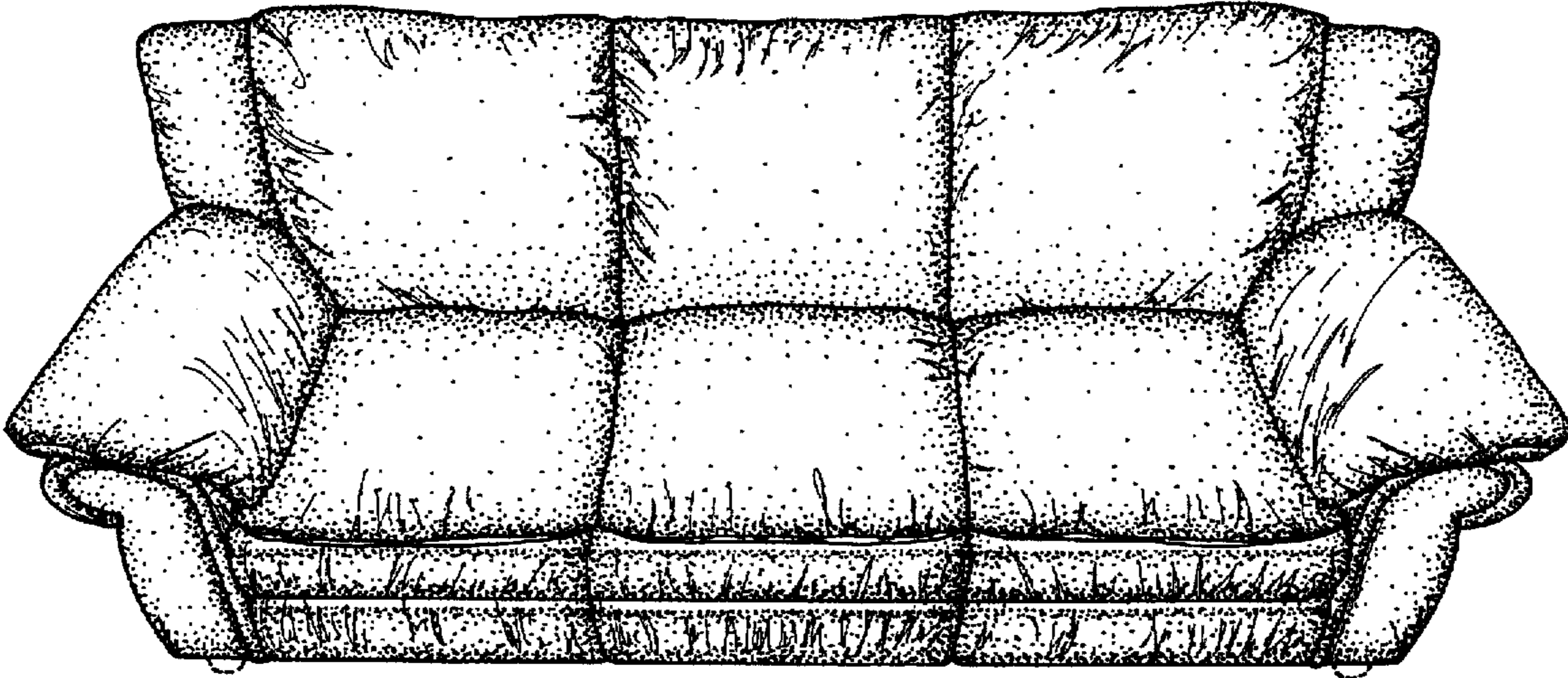

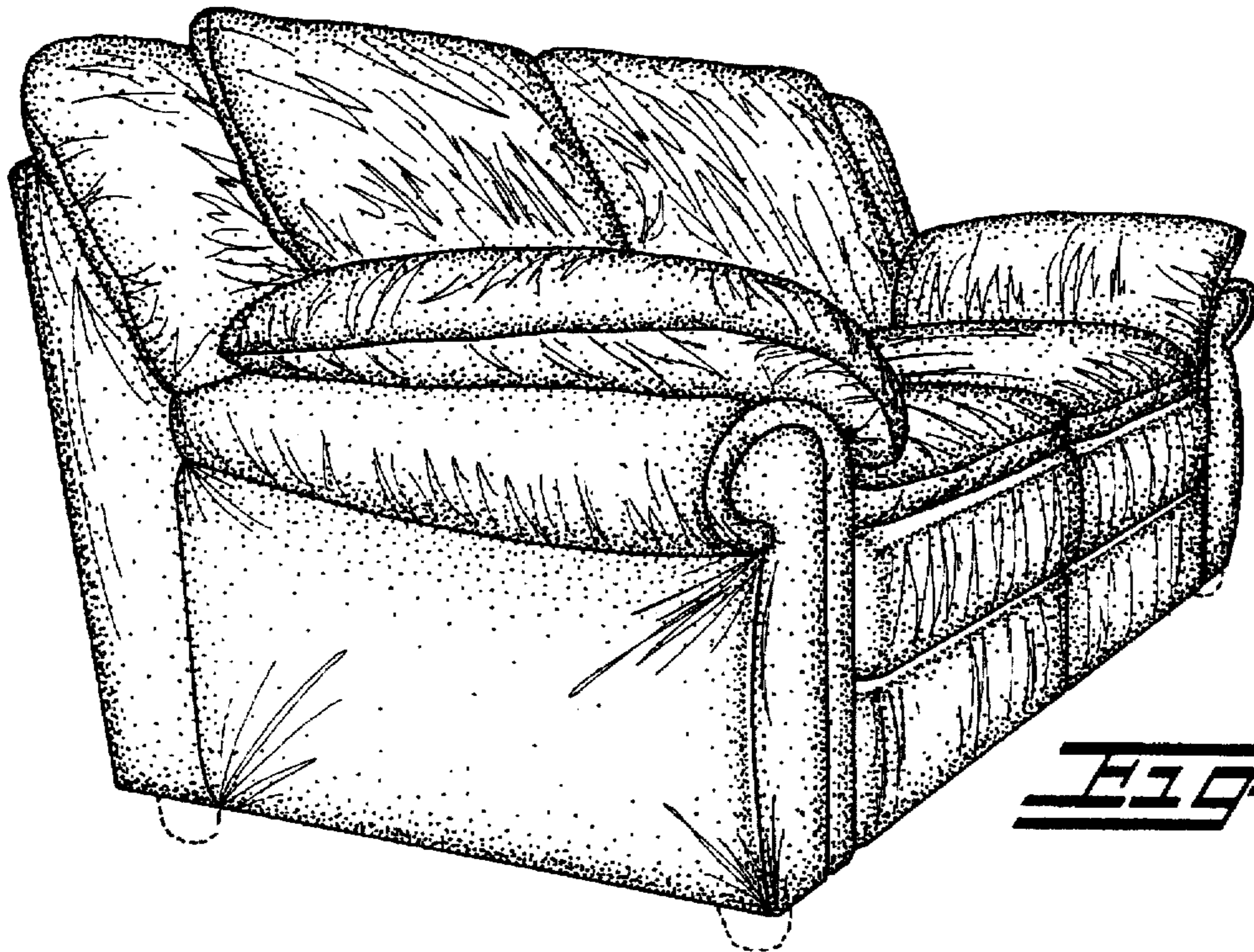

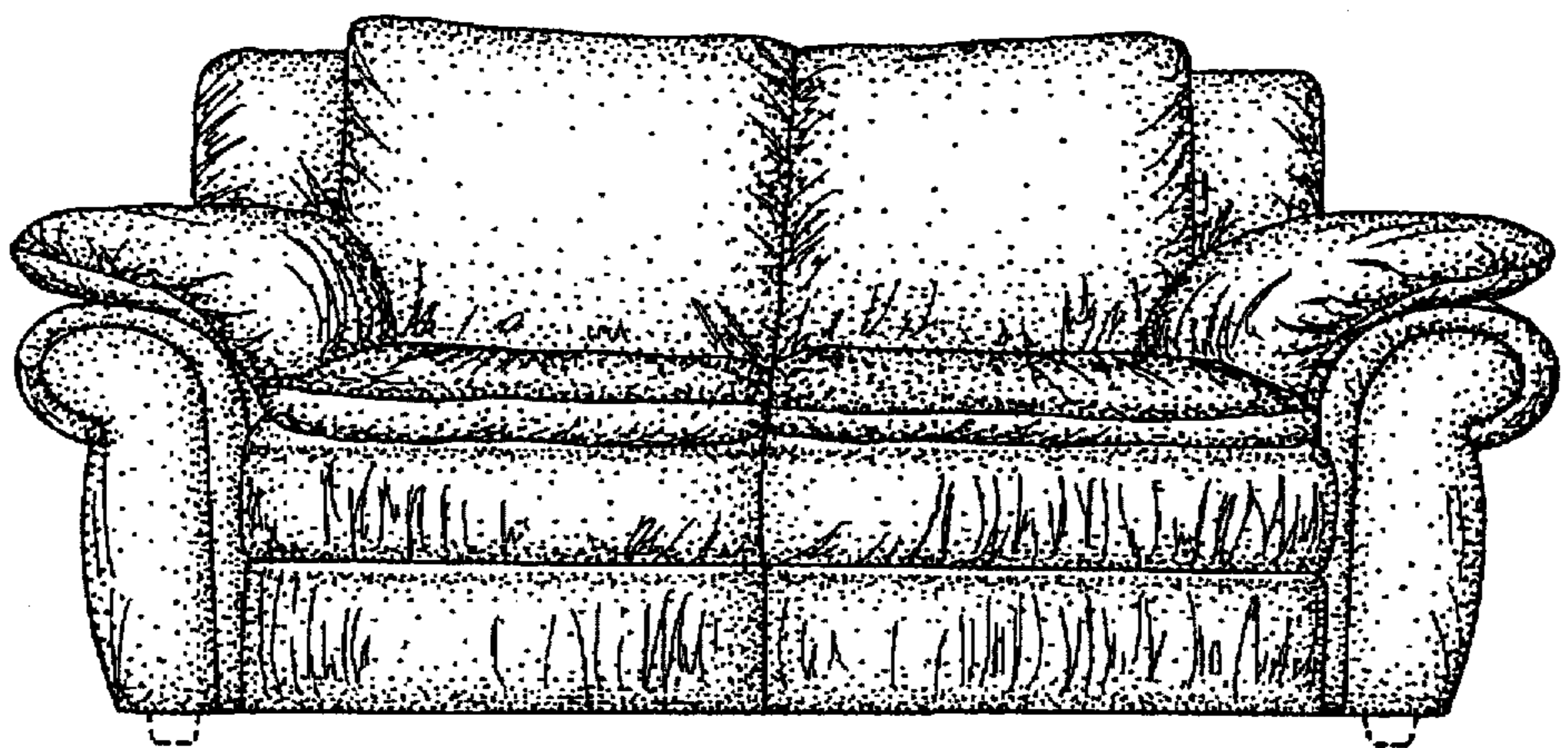

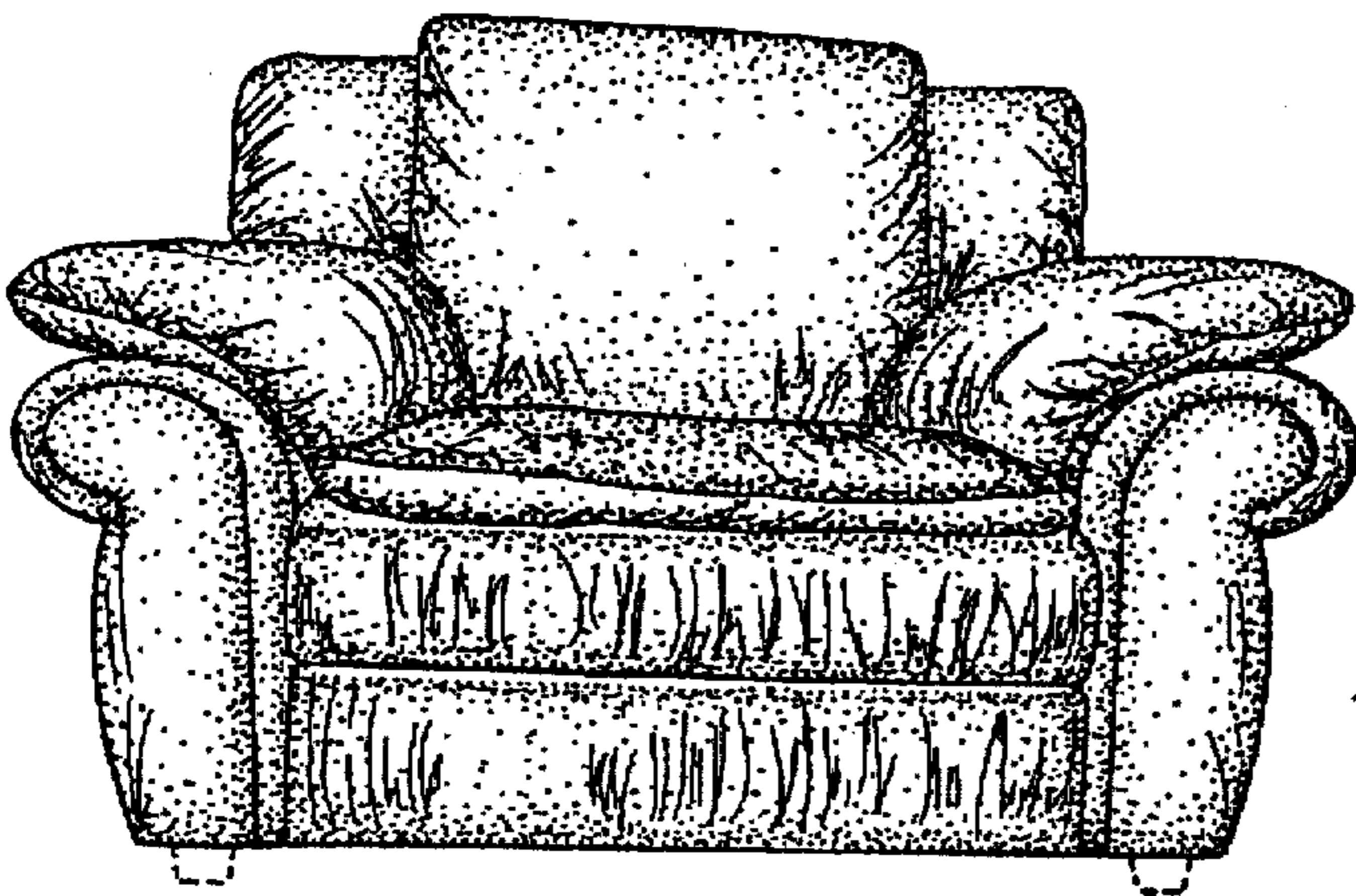
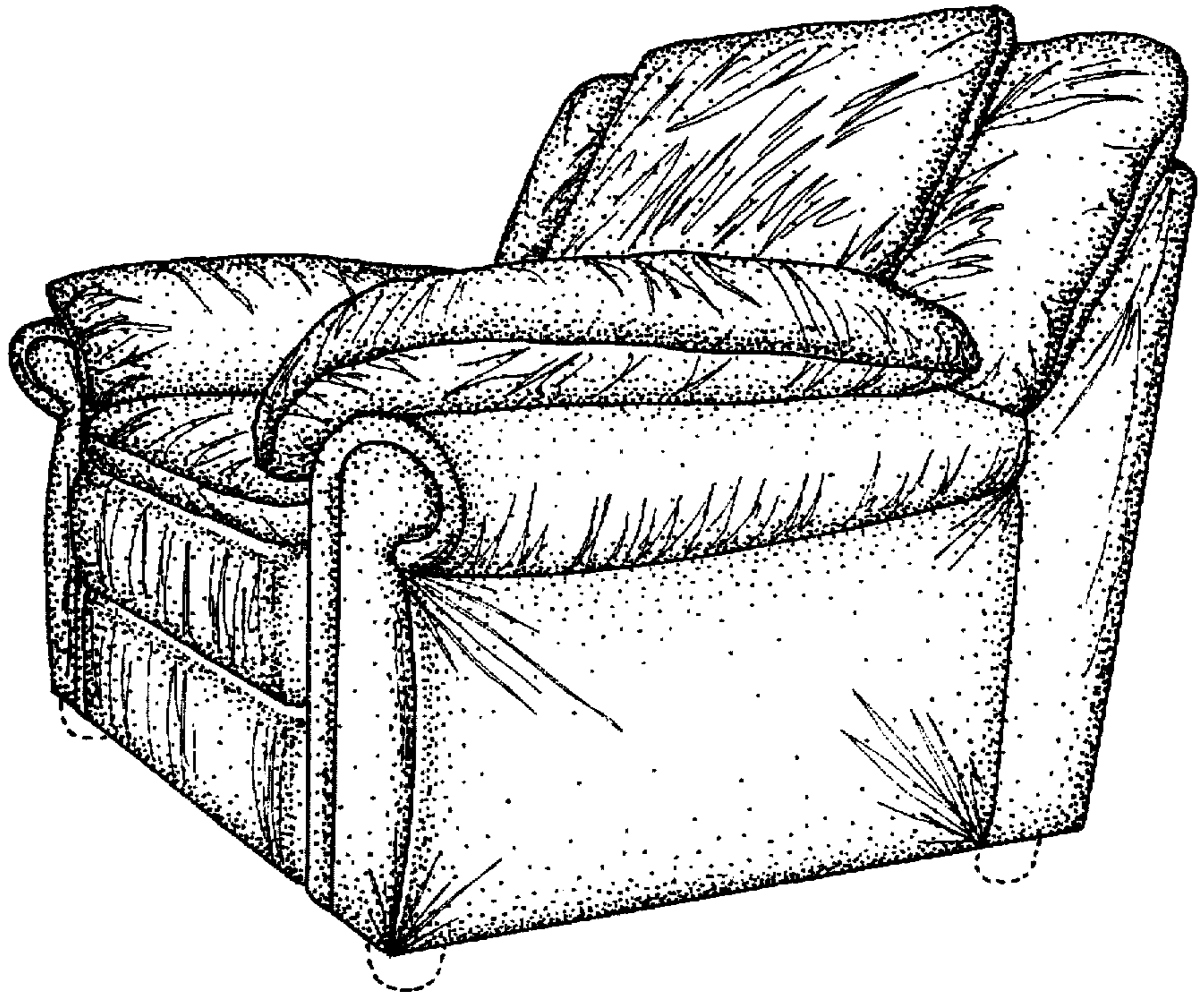
