The ornamental design for a portable radiotelephone, as shown and described.

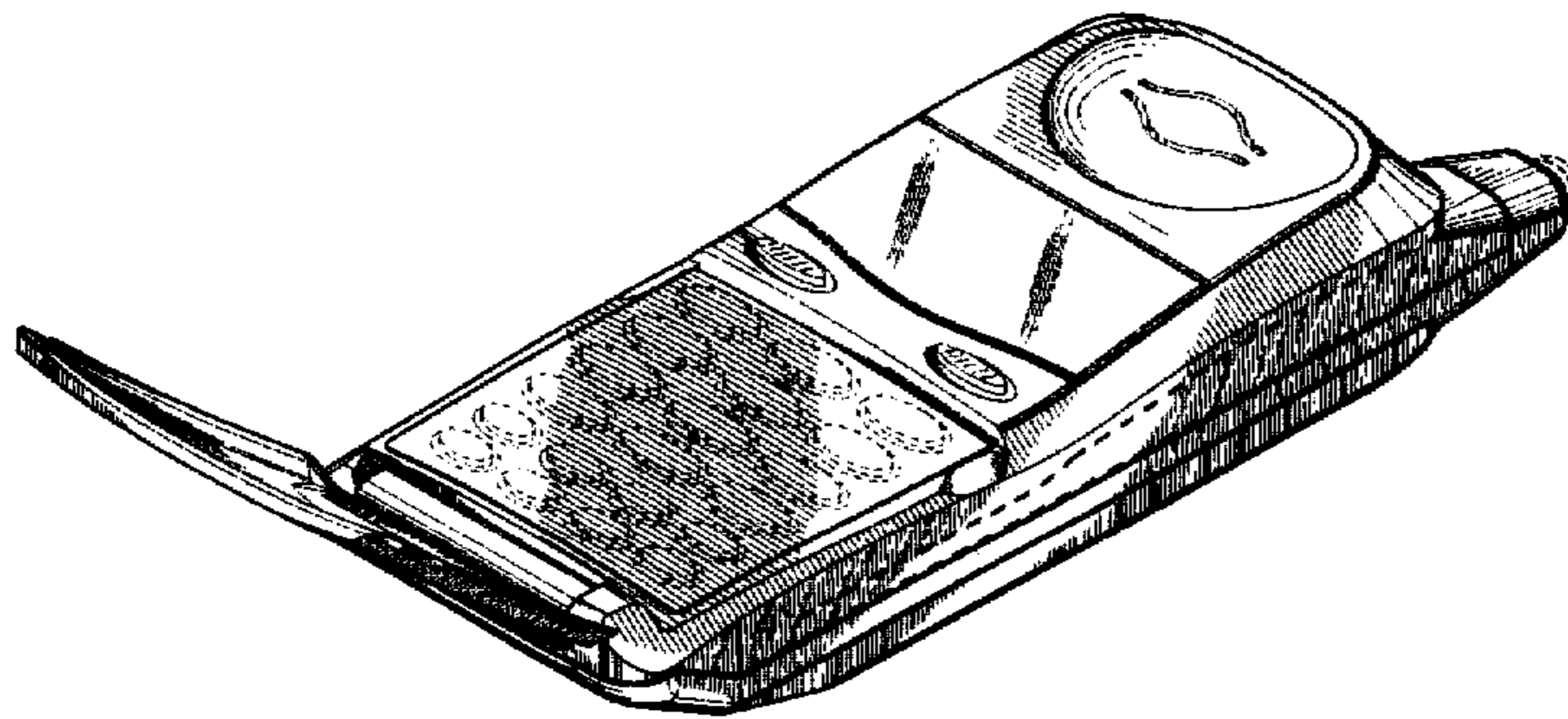
DESCRIPTION

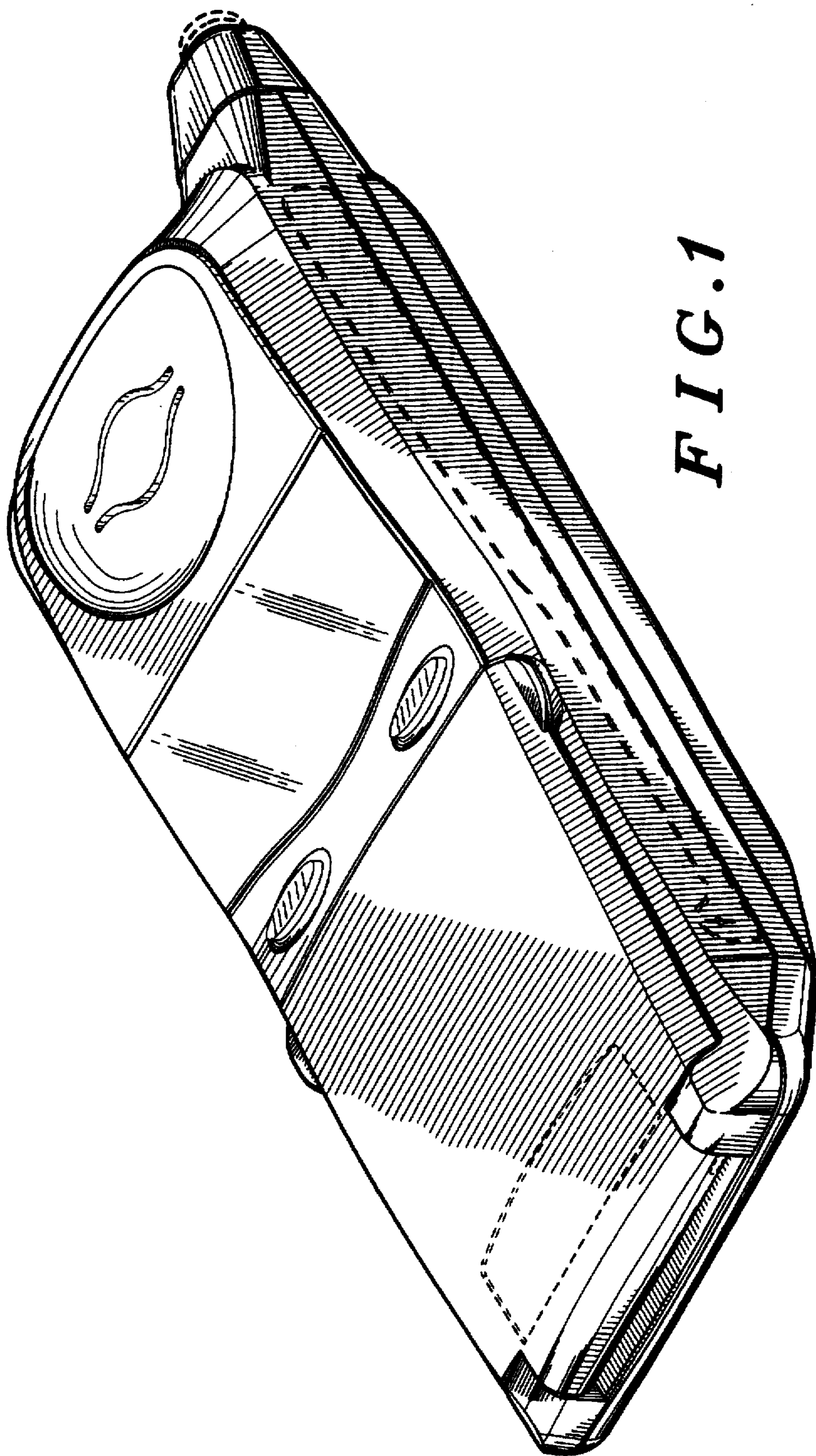

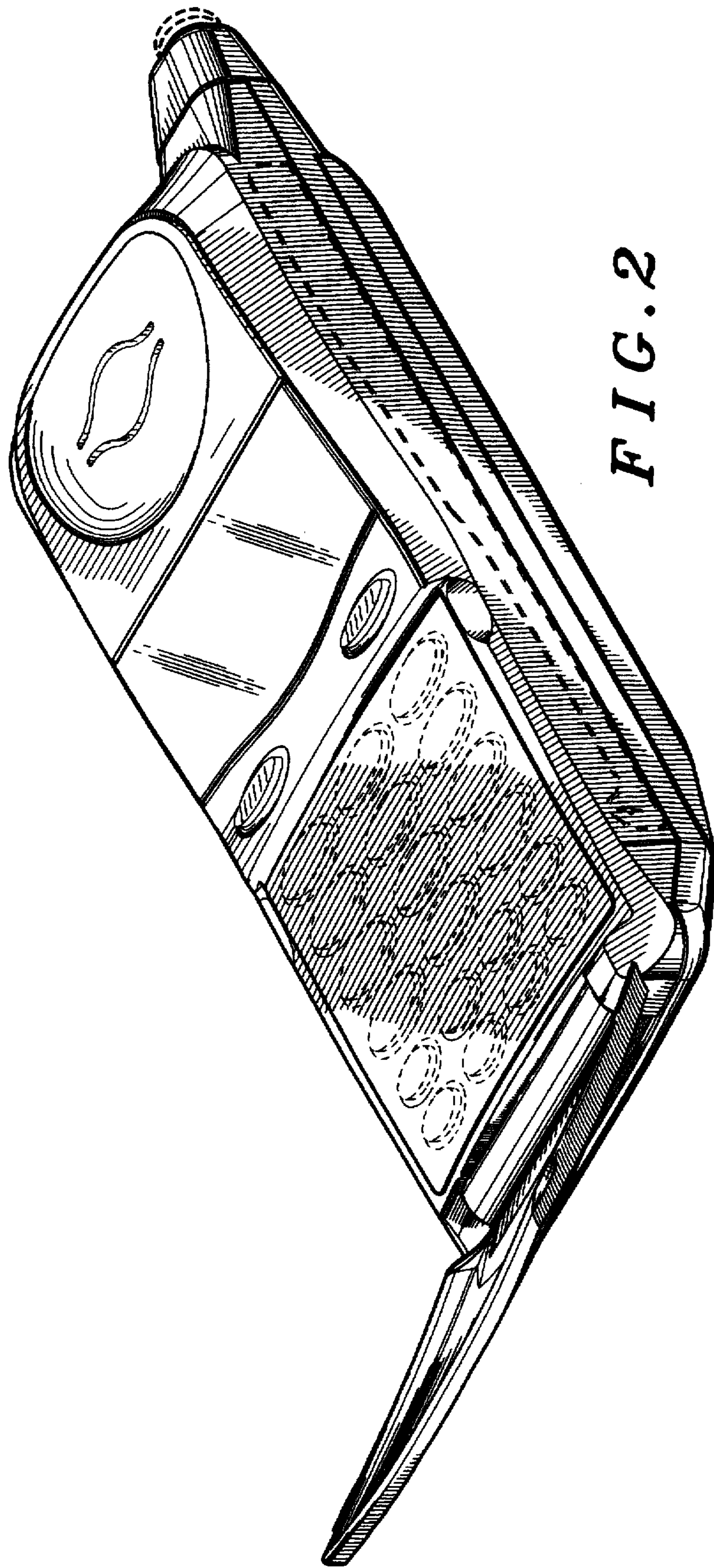

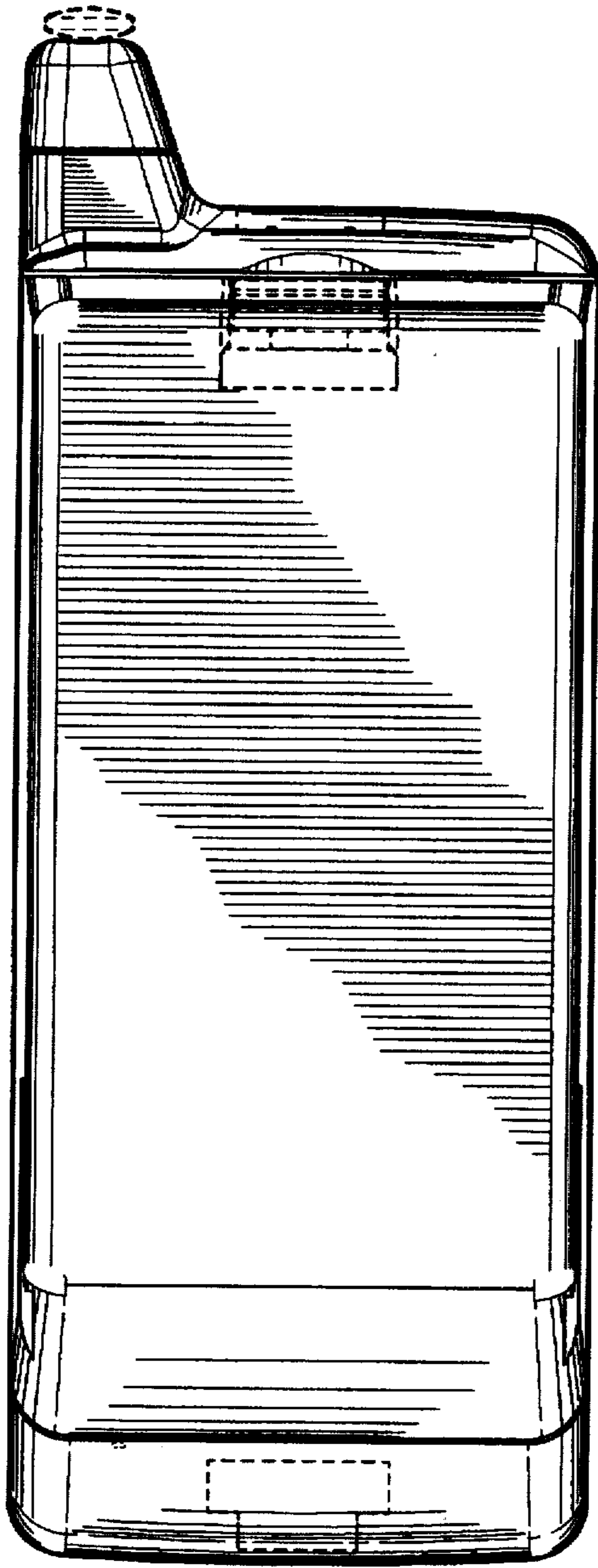

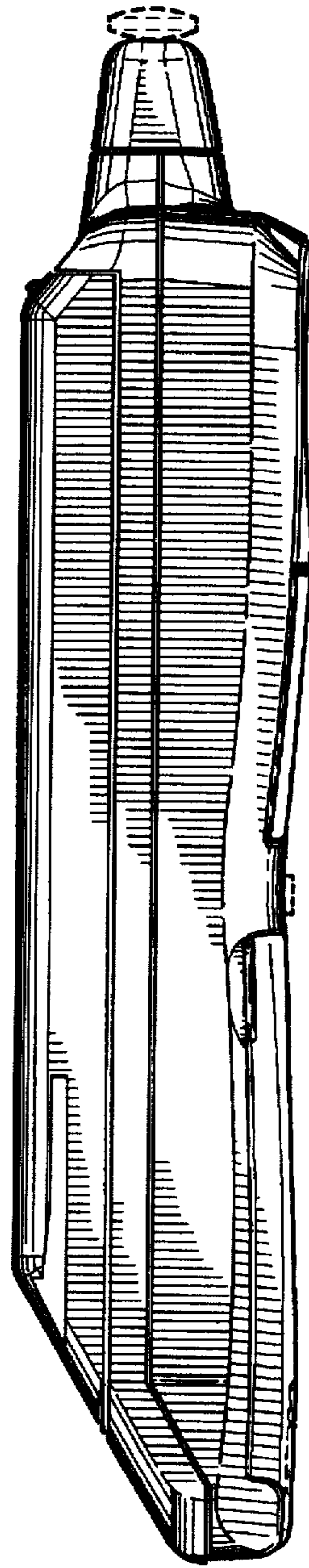

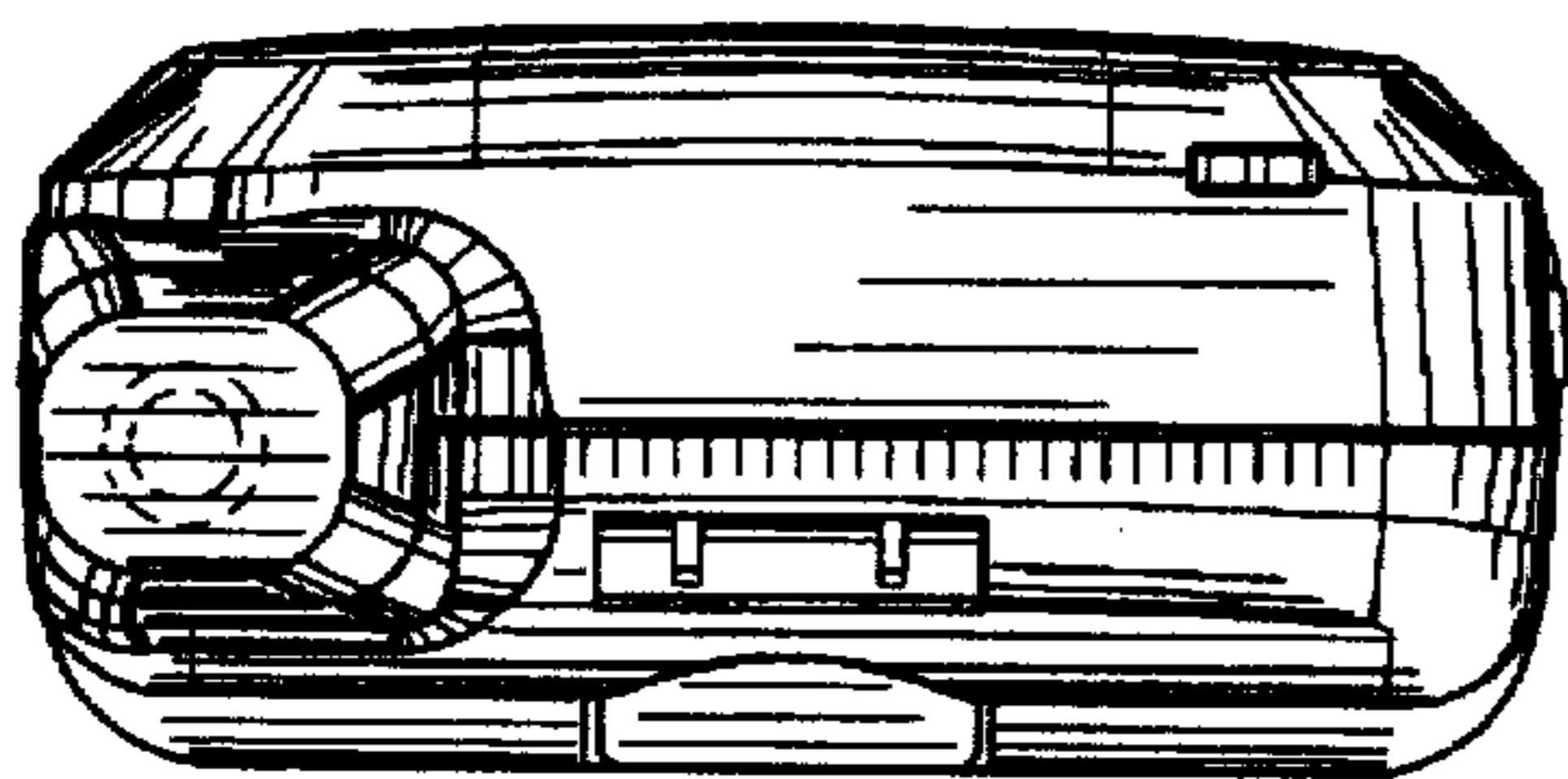
