DESCRIPTION

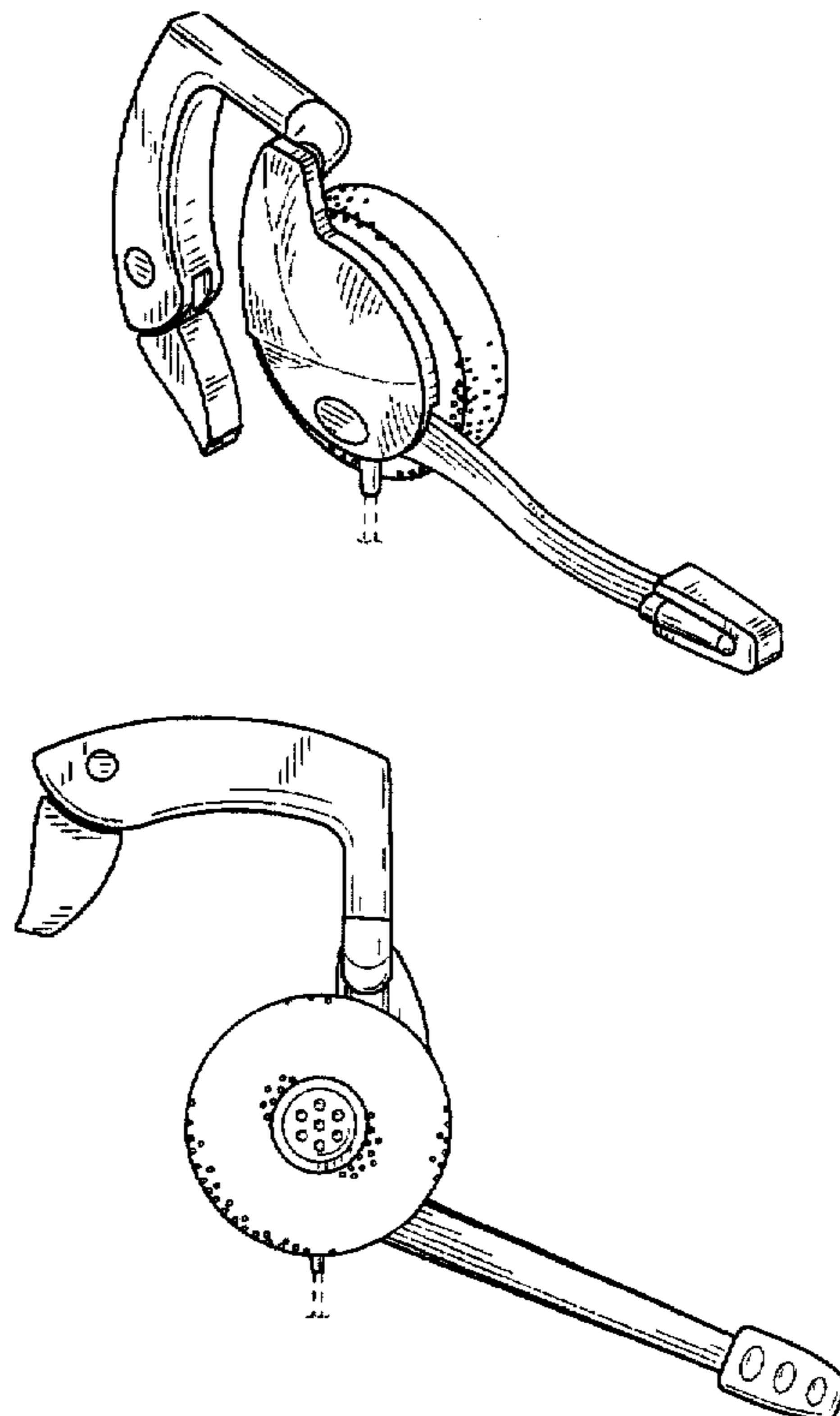
FIG. 1 is a perspective view of a communications headset showing our design;

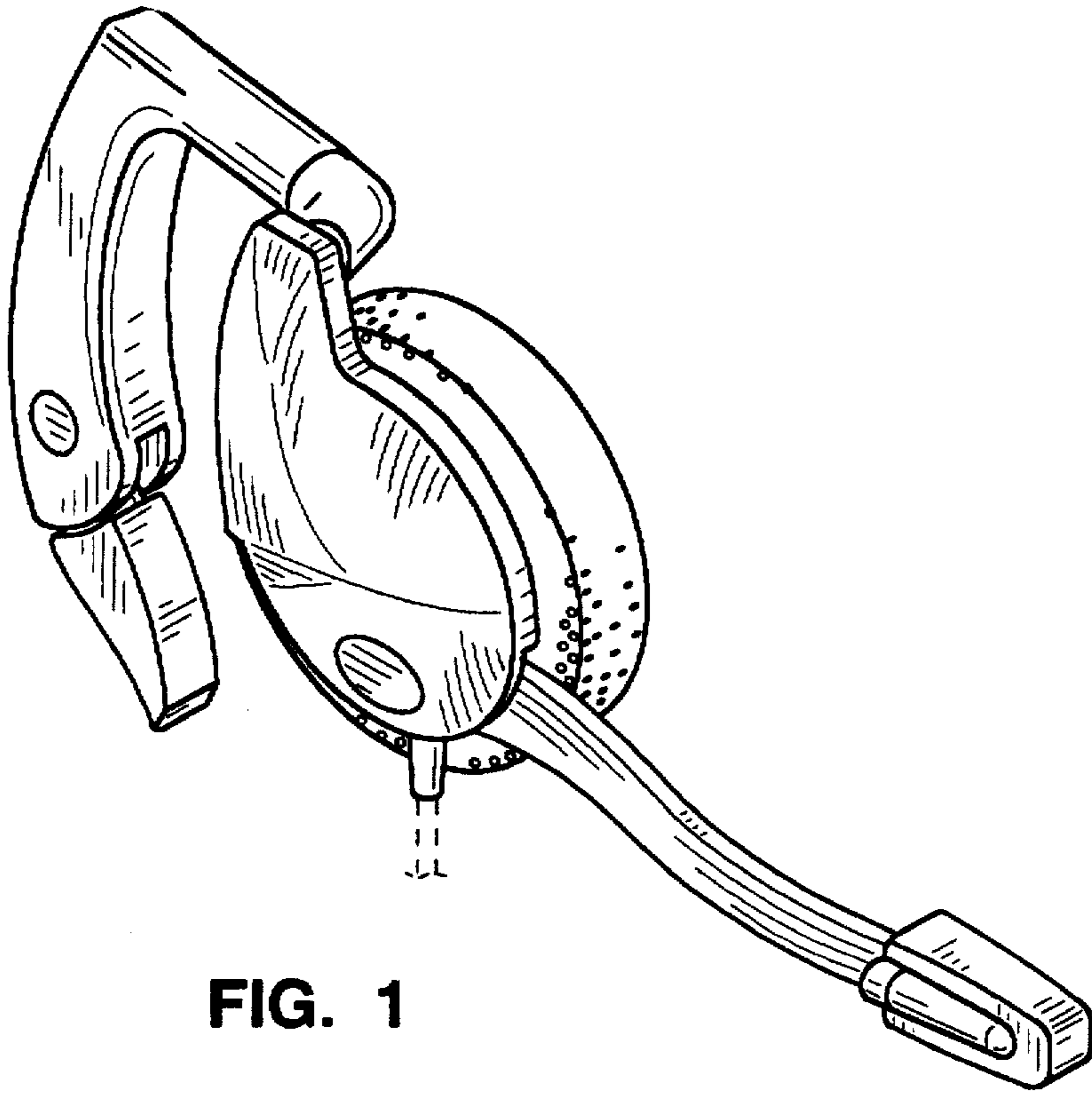

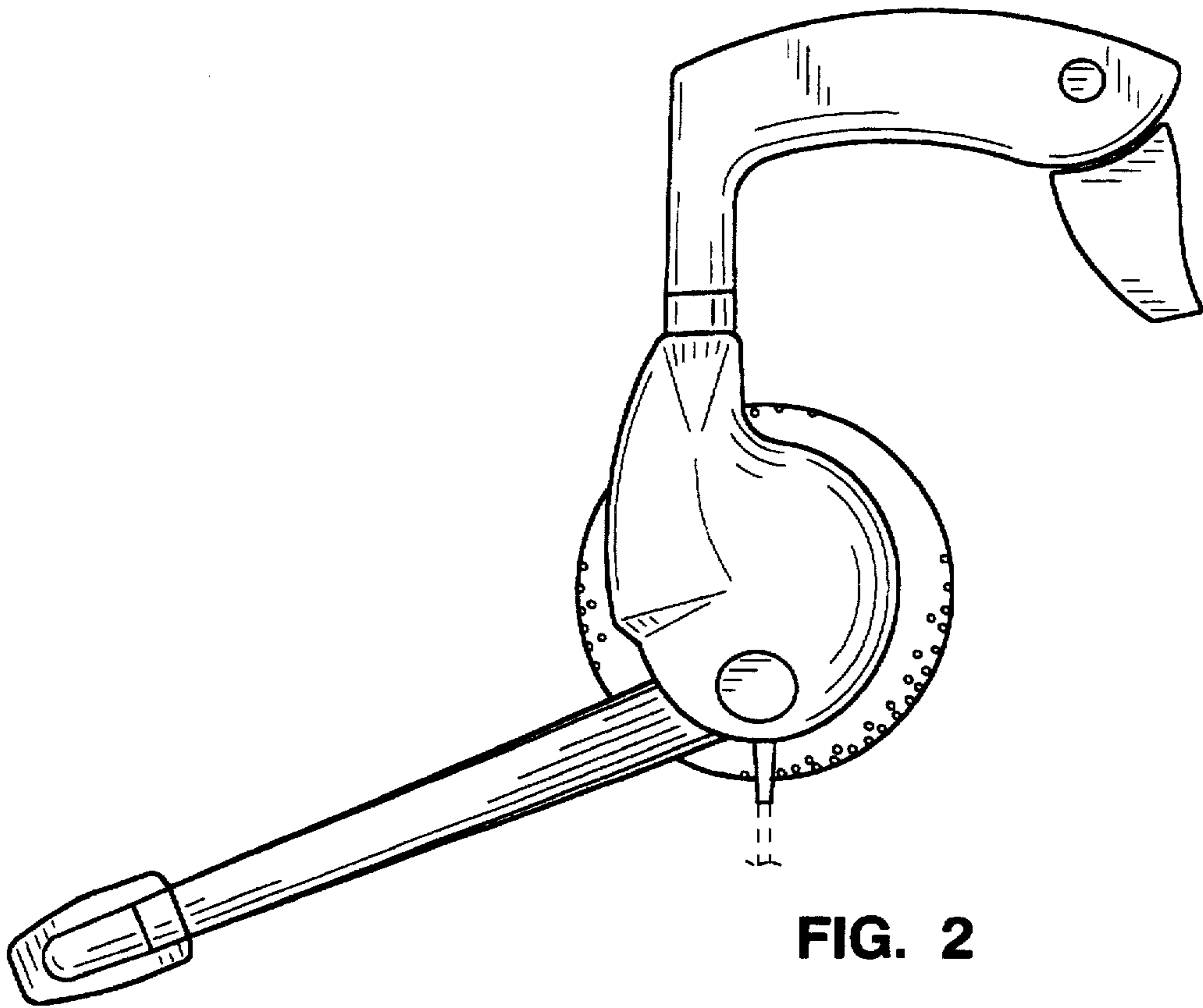

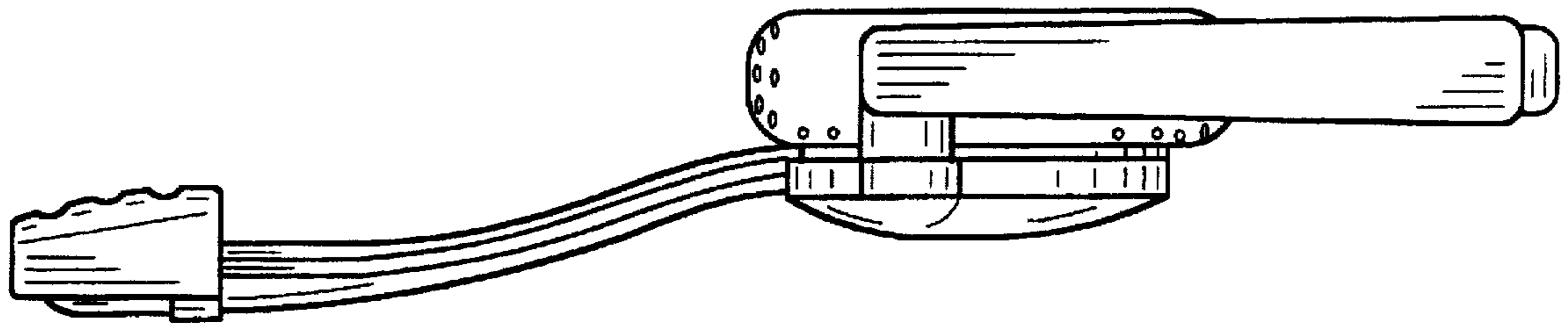

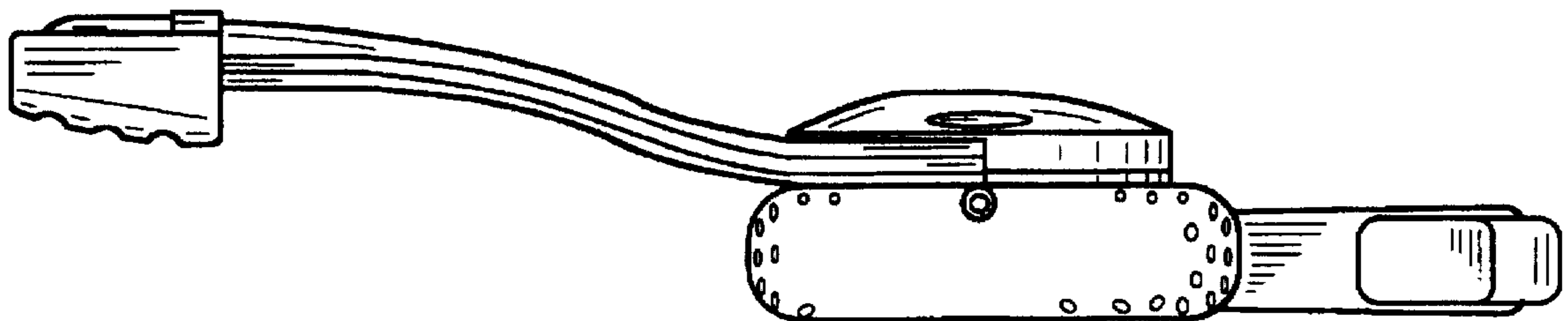

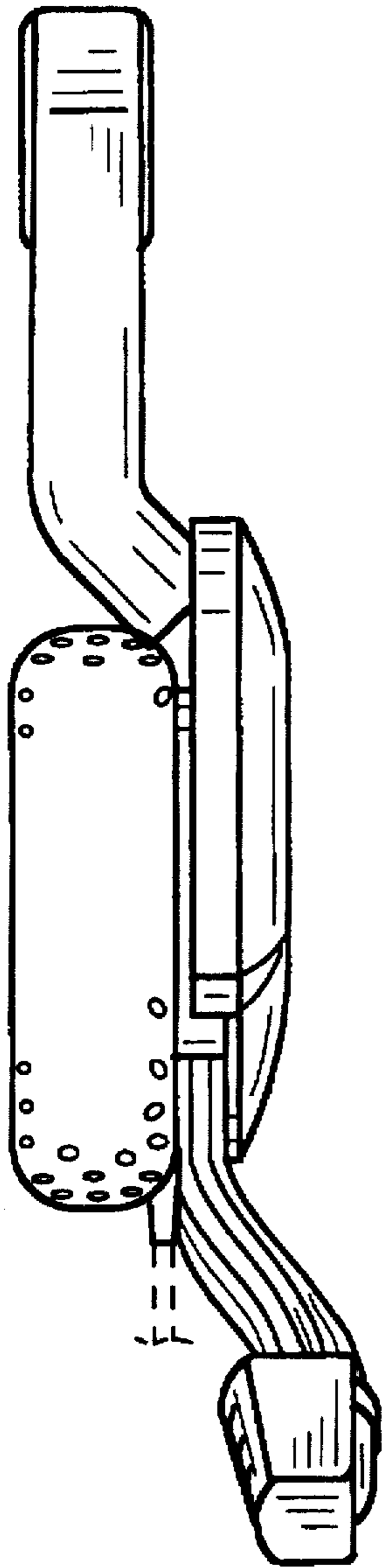

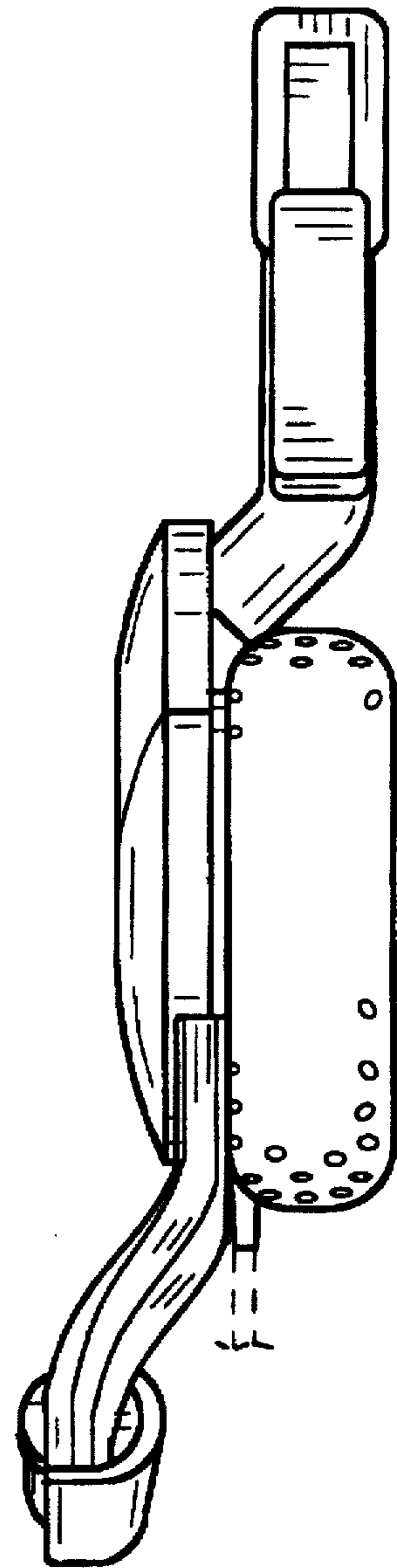

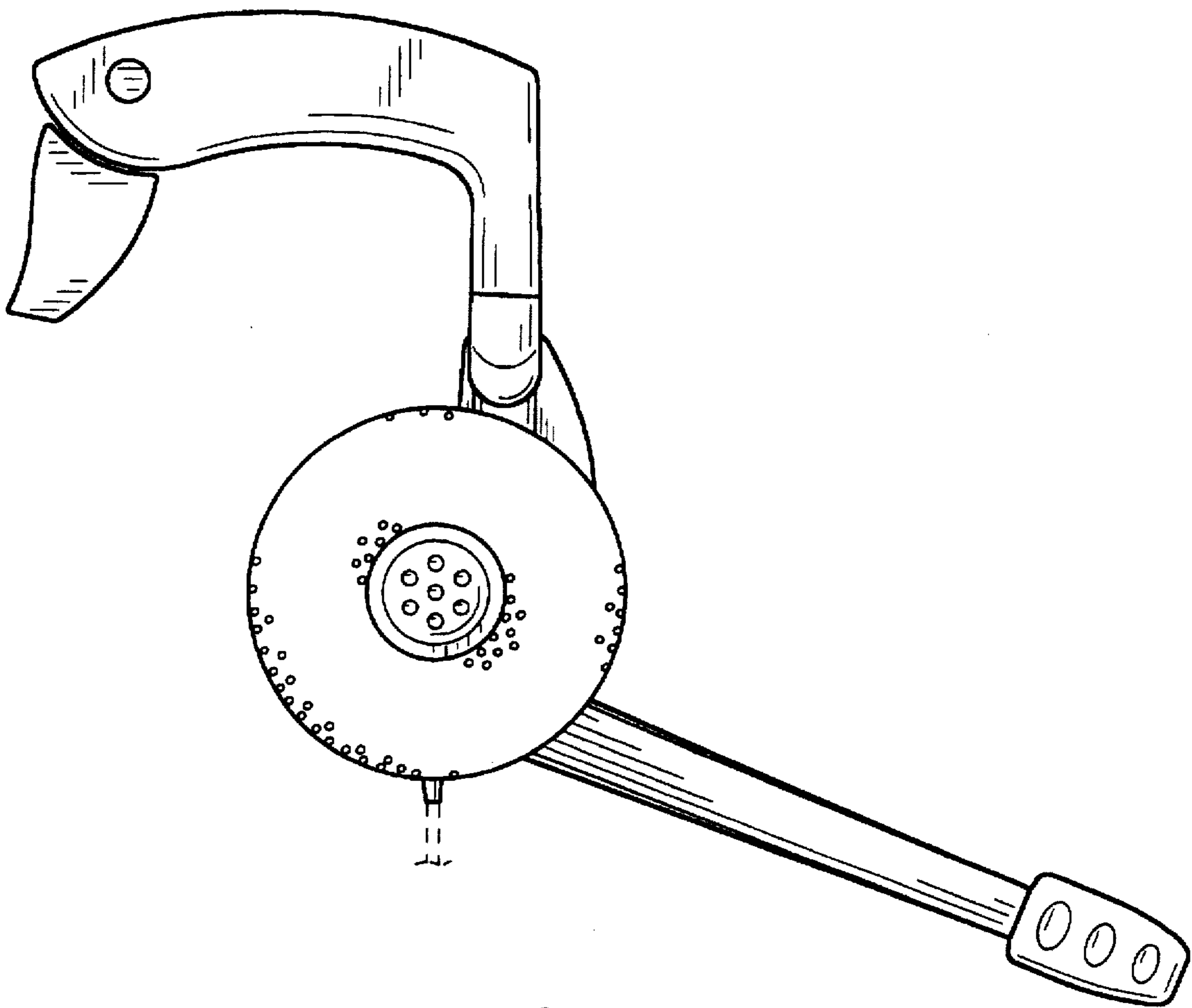
