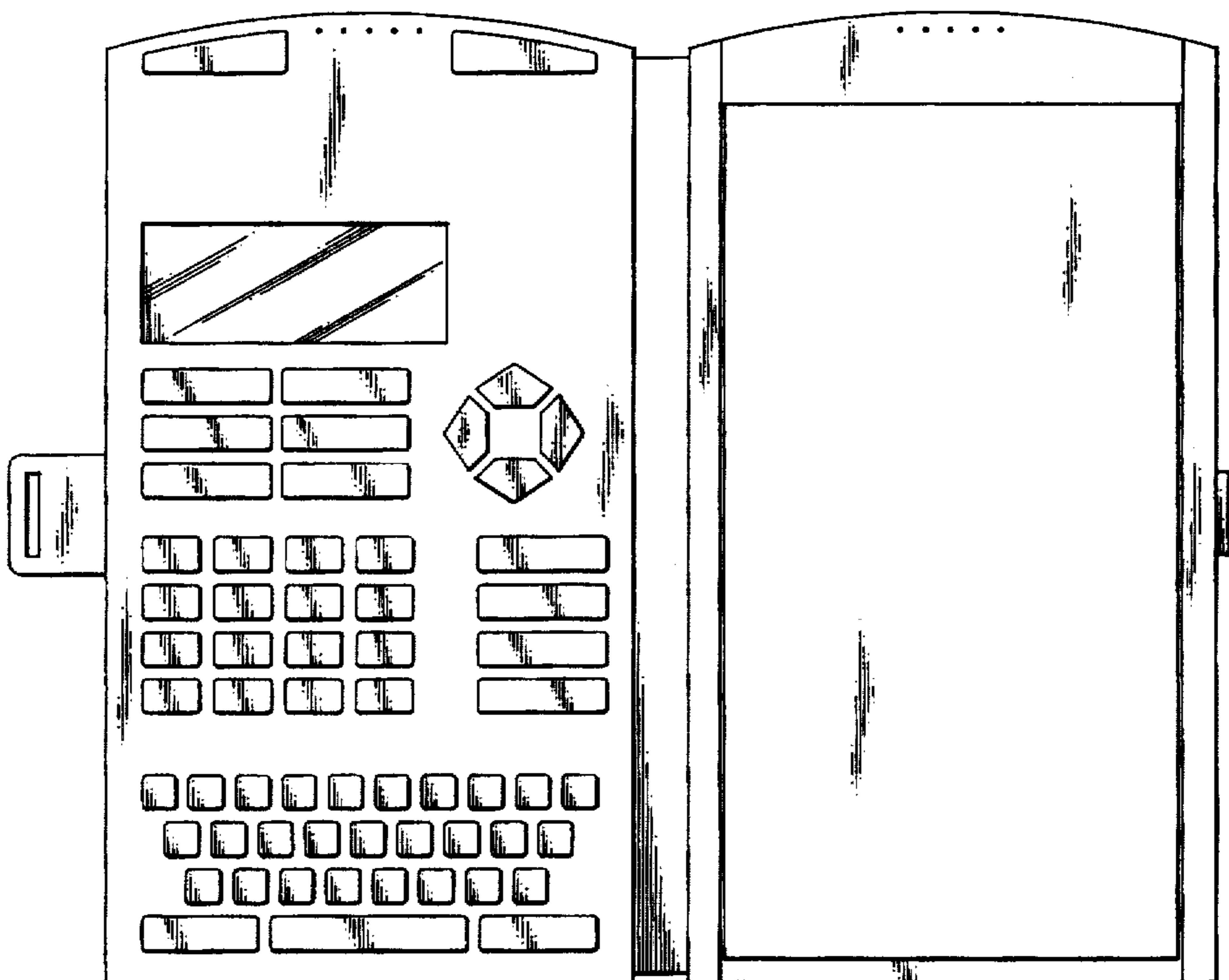
[57] **CLAIM**

The ornamental design for an attachment for a binder or book, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of an attachment for a binder or book showing our new design;  
 FIG. 2 is a left side elevational view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a bottom plan view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a front elevational view thereof;  
 FIG. 7 is a top plan view thereof in a closed position;  
 FIG. 8 is a right side elevational view thereof in the closed position;  
 FIG. 9 is a left side elevational view thereof in the closed position;  
 FIG. 10 is a bottom plan view thereof in the closed position;  
 FIG. 11 is a rear elevational view thereof in the closed position; and,  
 FIG. 12 is a front elevational view thereof in the closed position.

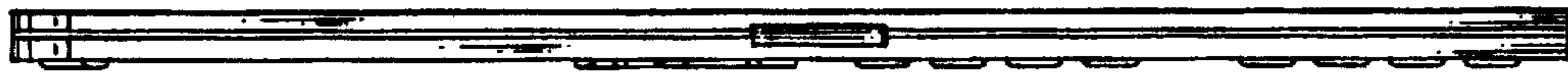

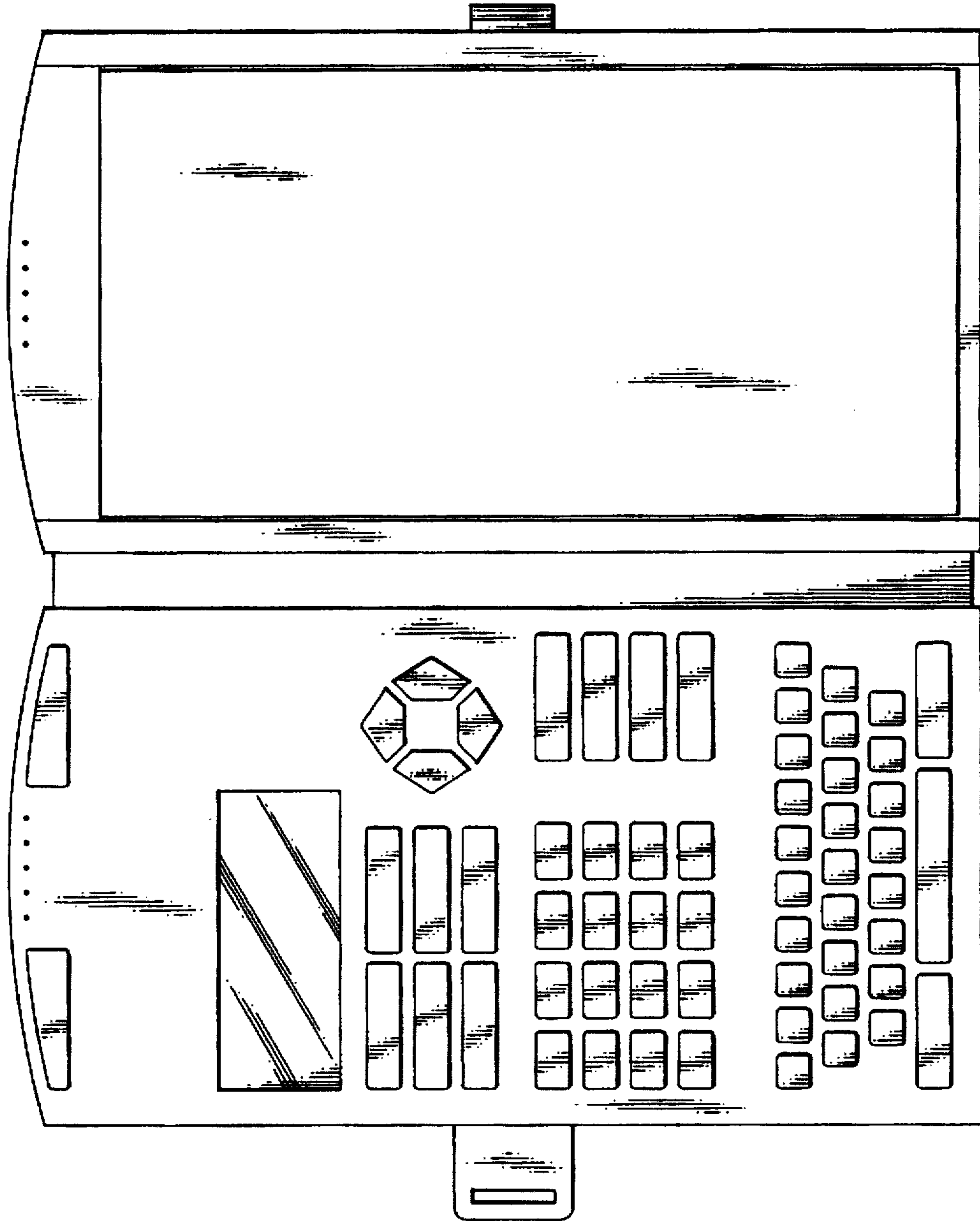

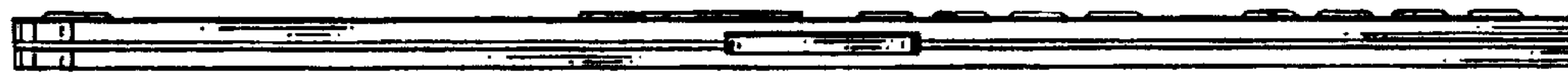

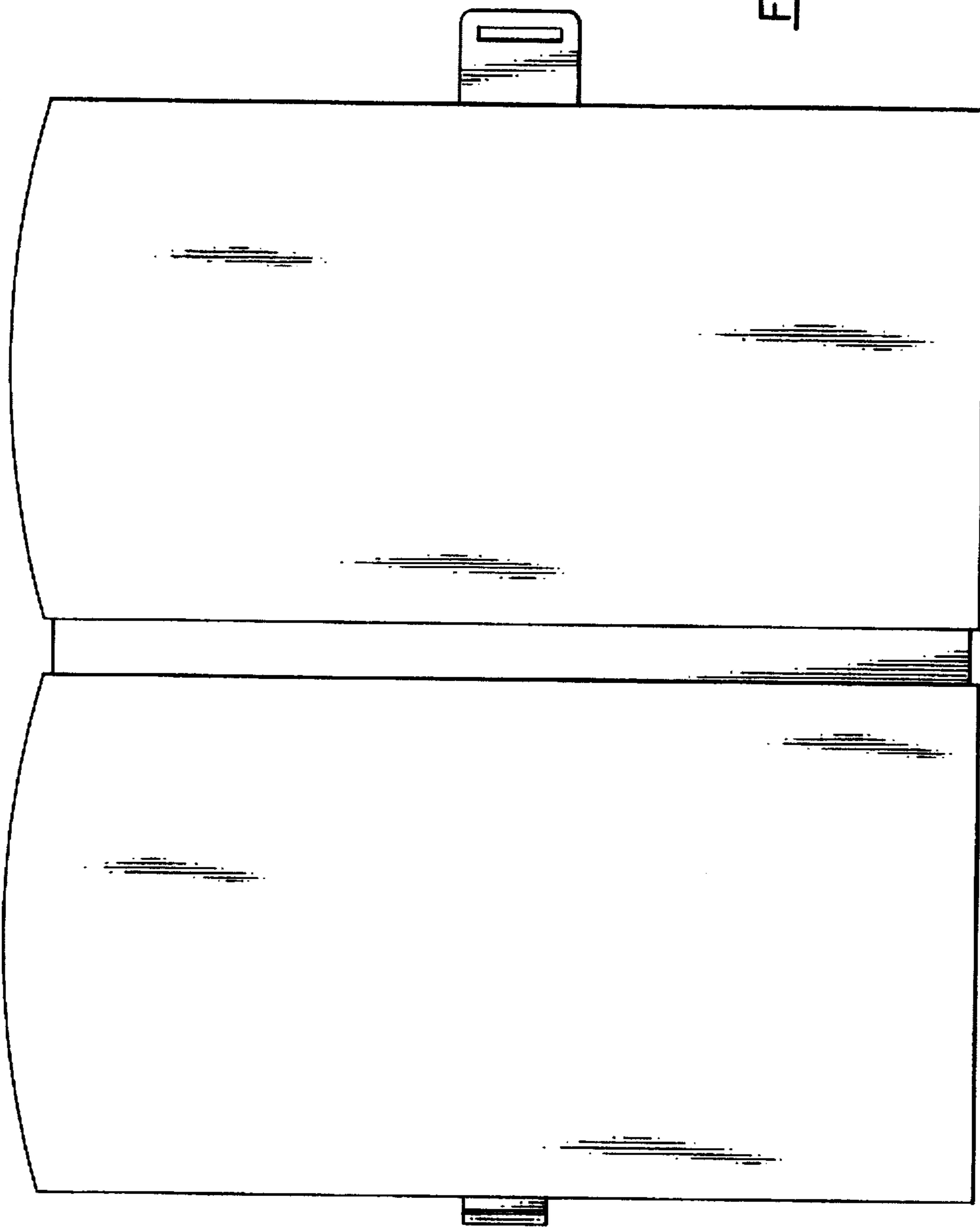

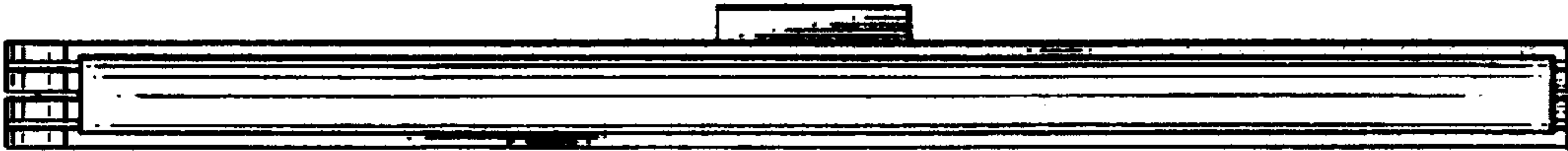

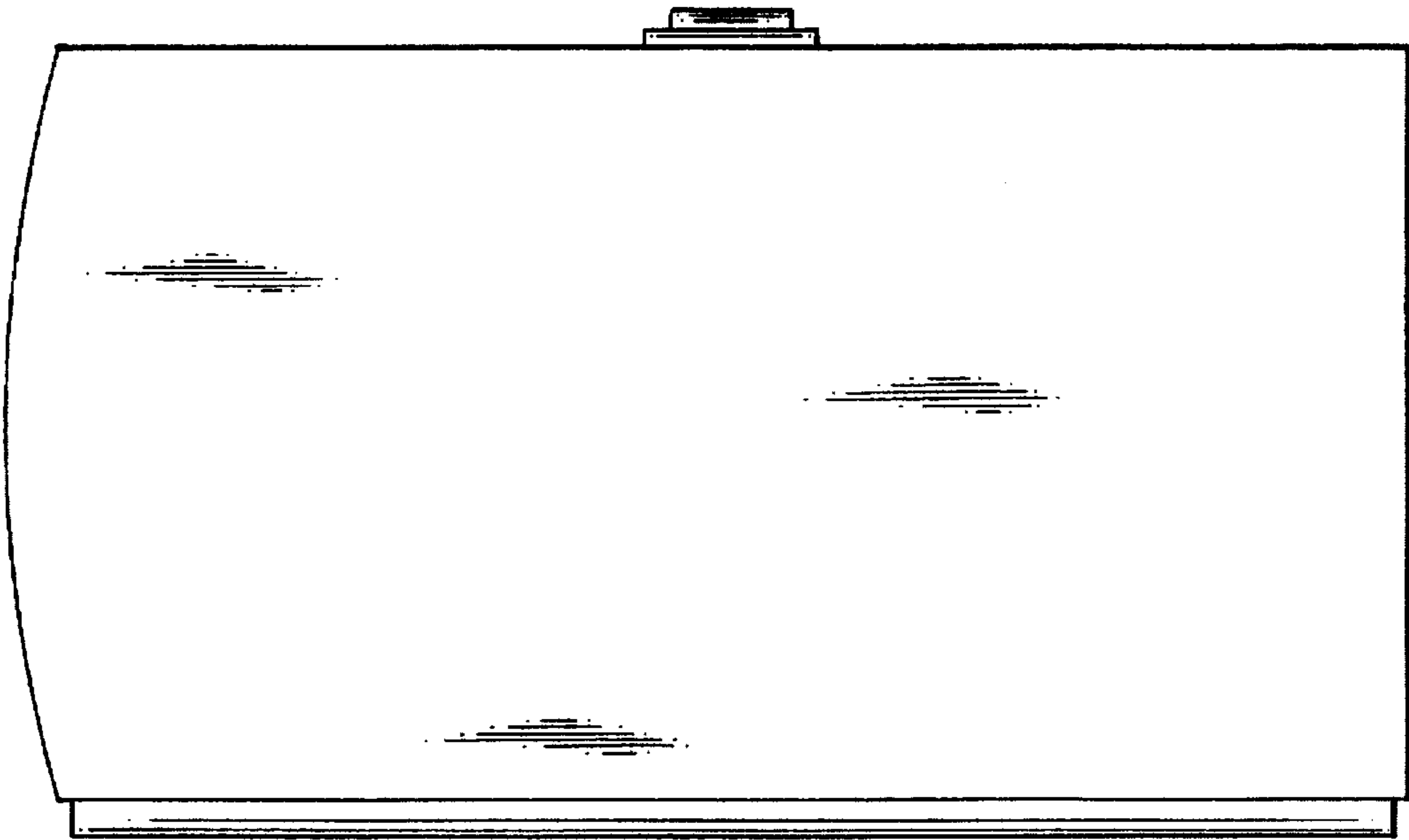

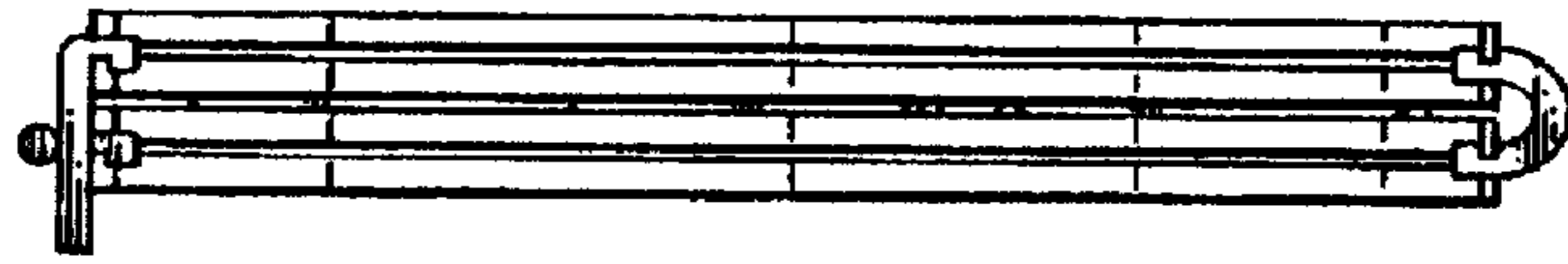

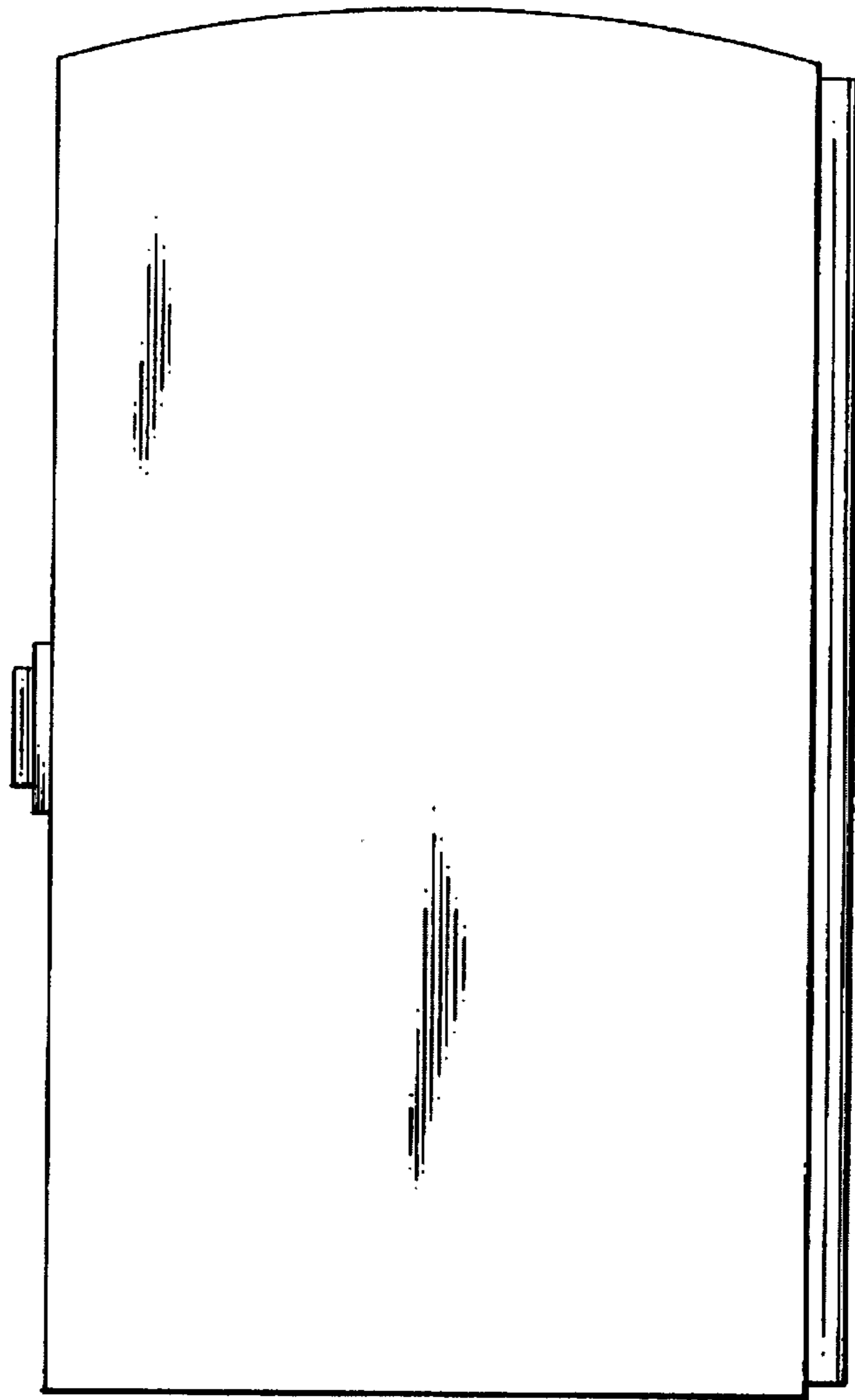
