FIG. 17 is a right side elevationl view of FIG. 15;

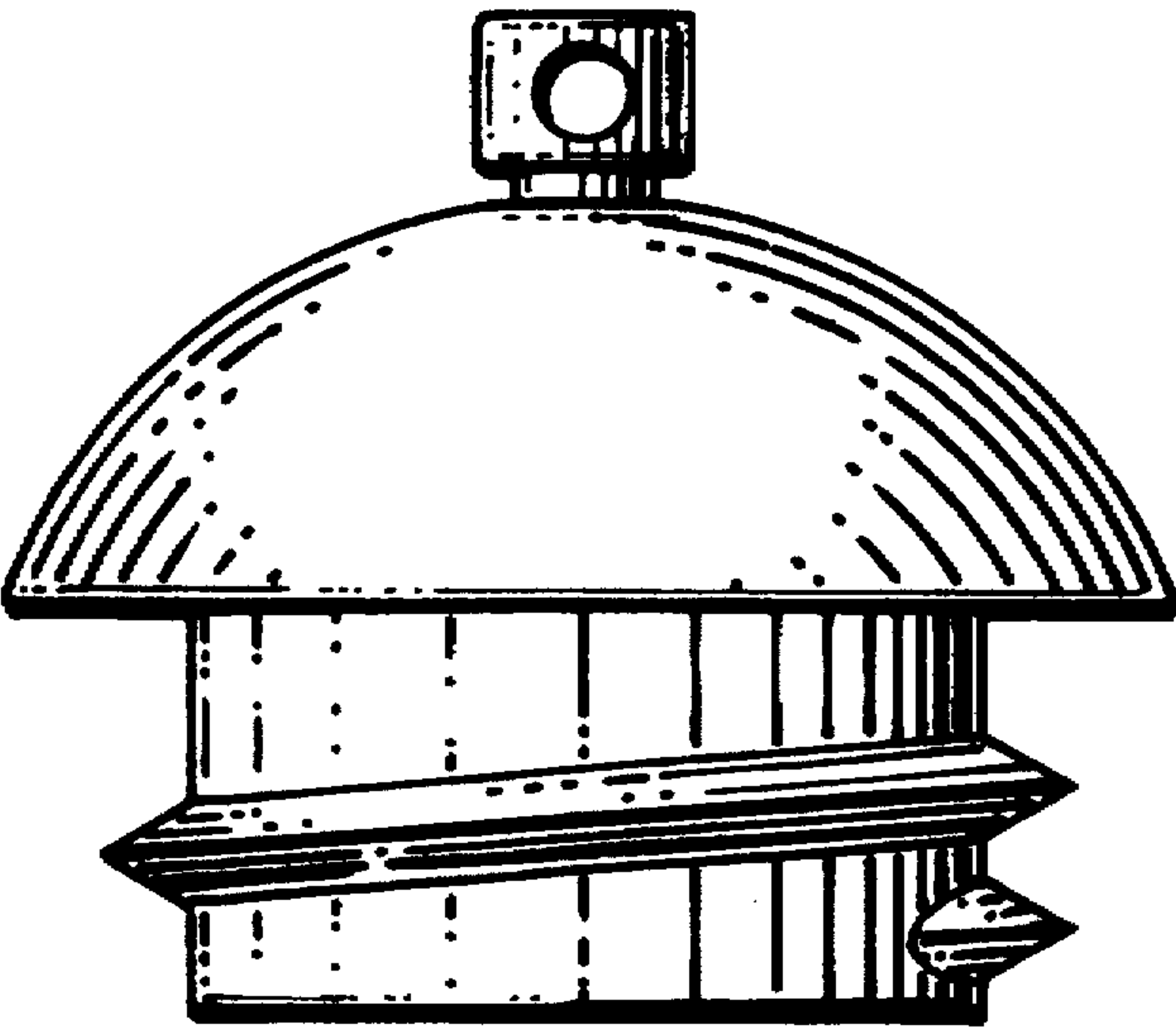
FIG. 18 is a rear elevational view of FIG. 15;

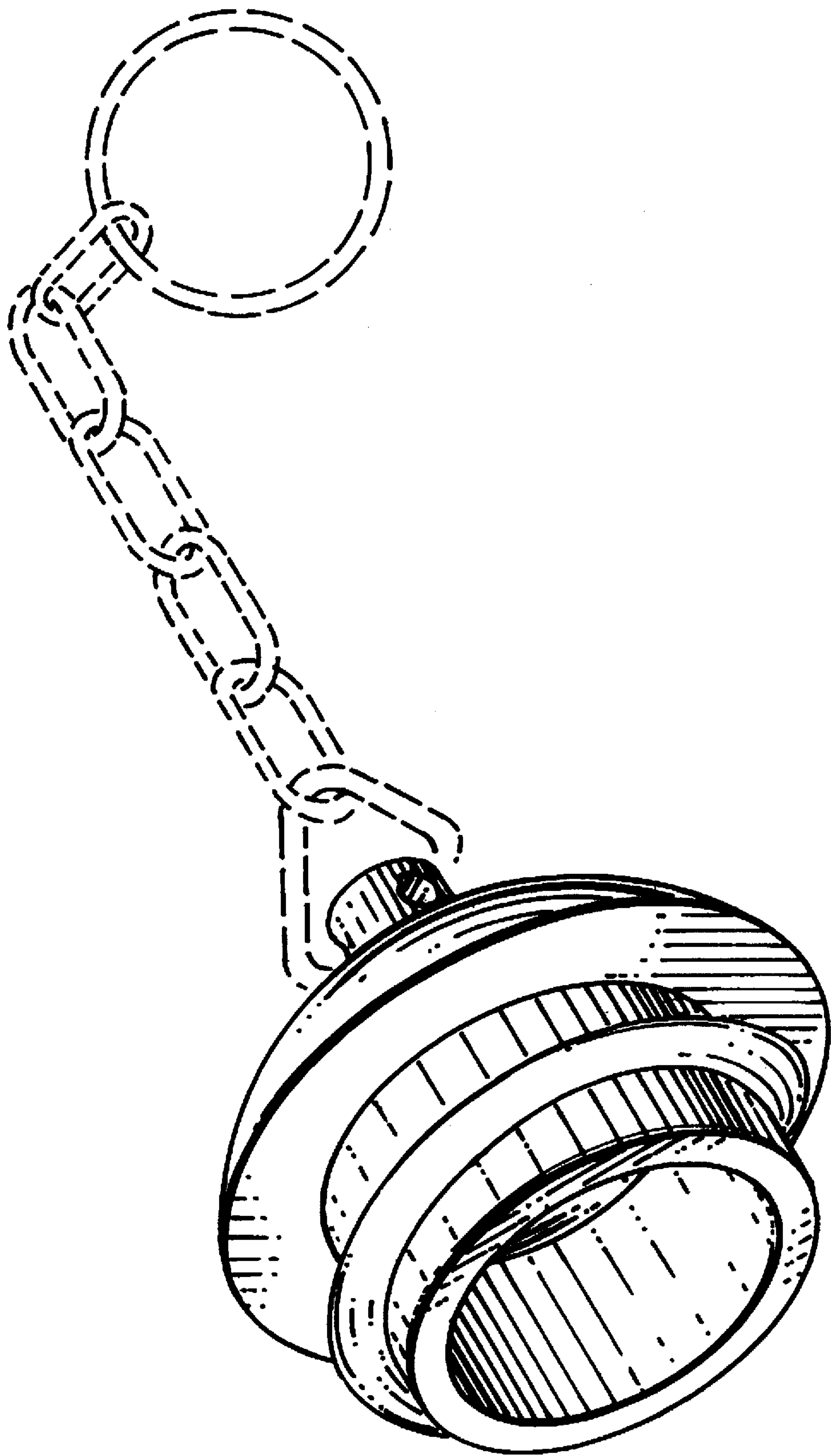

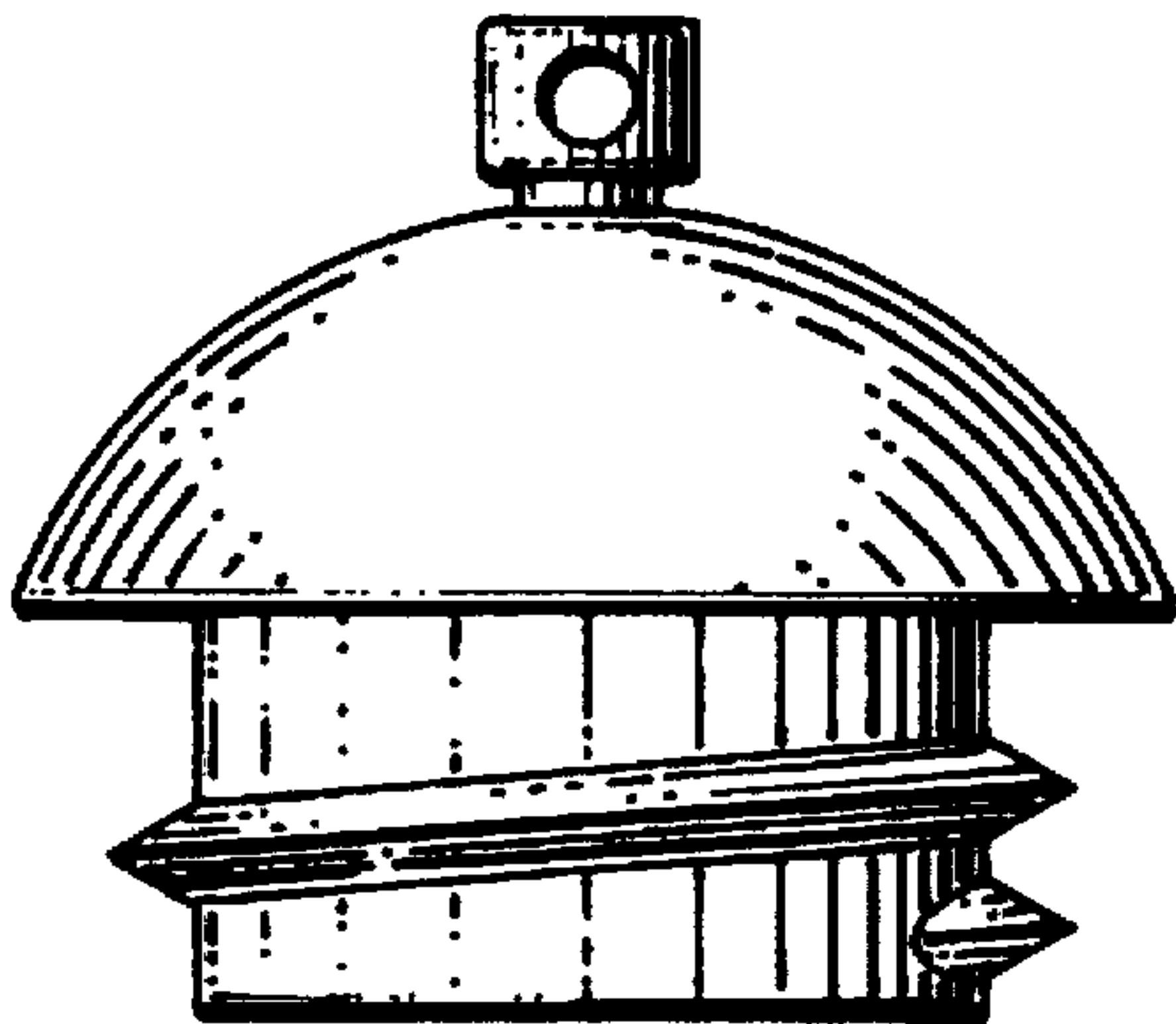

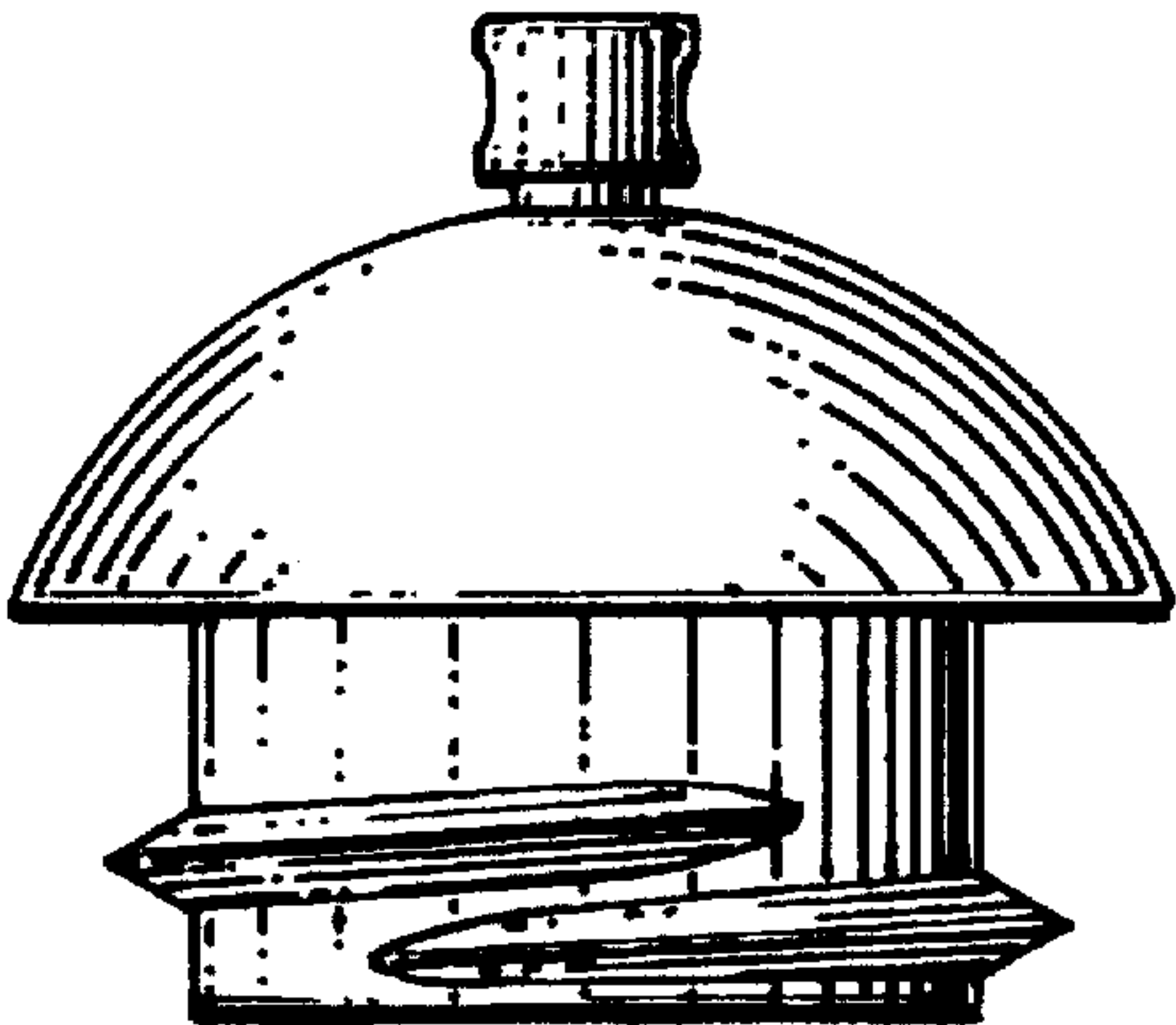

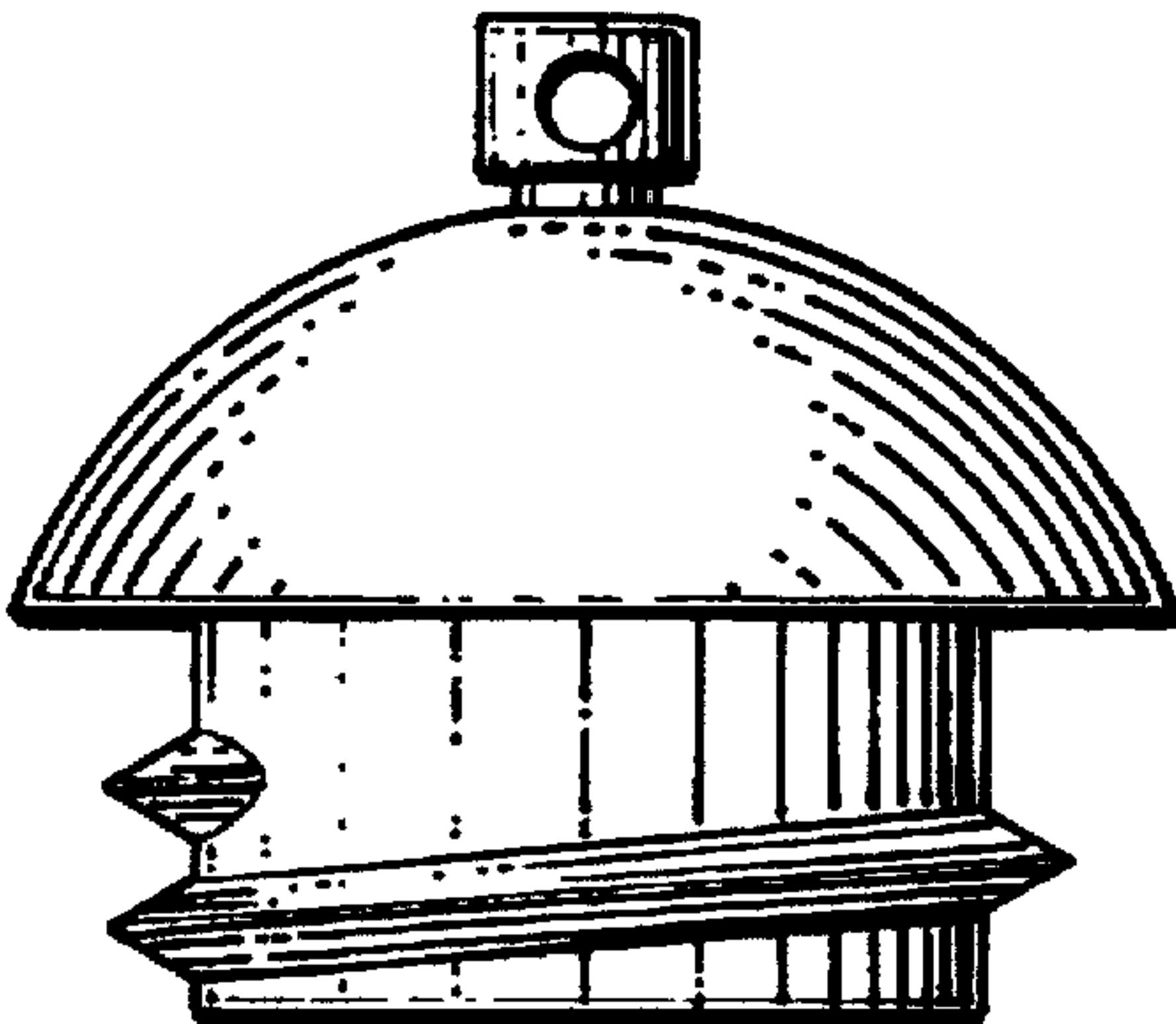

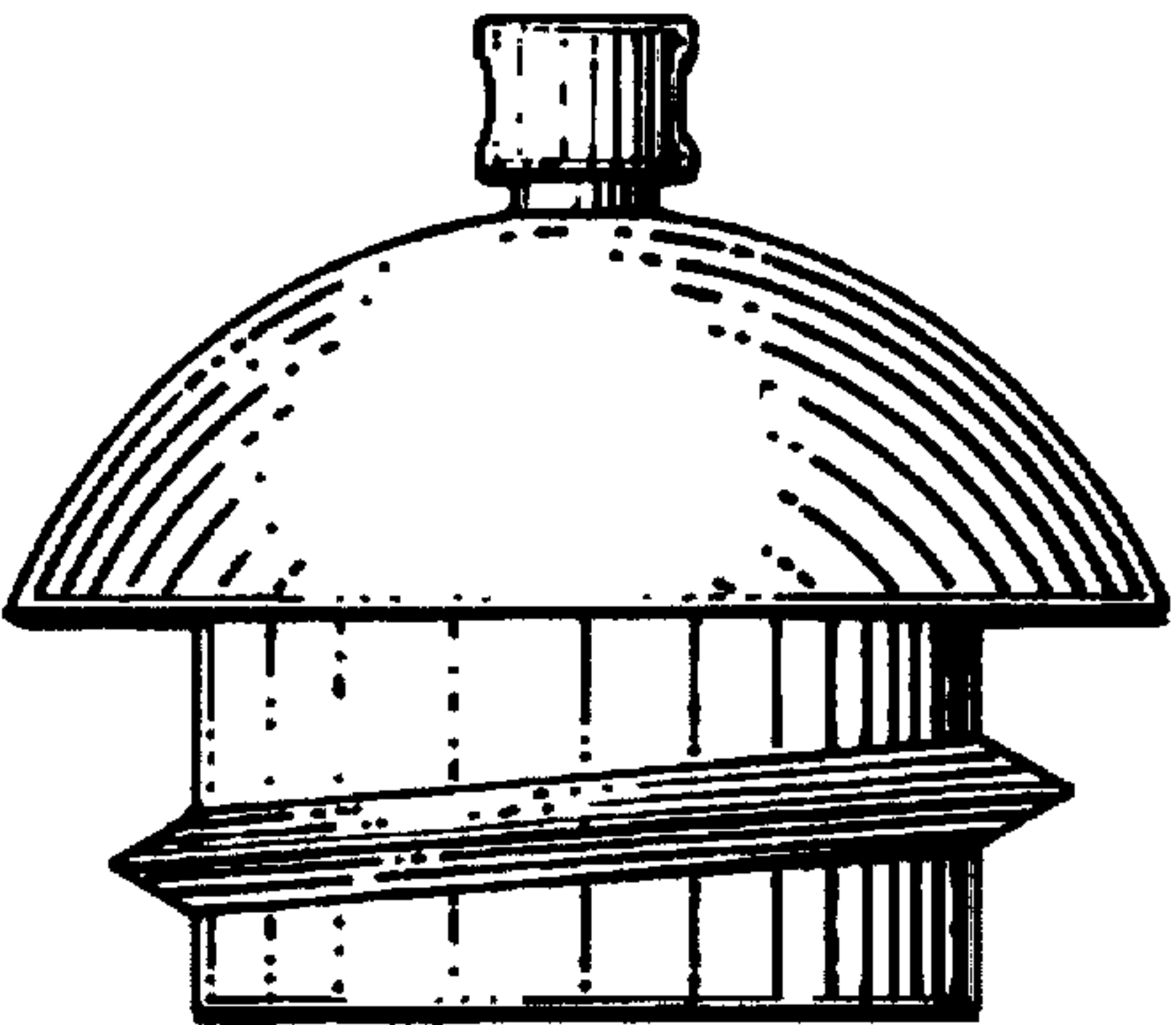

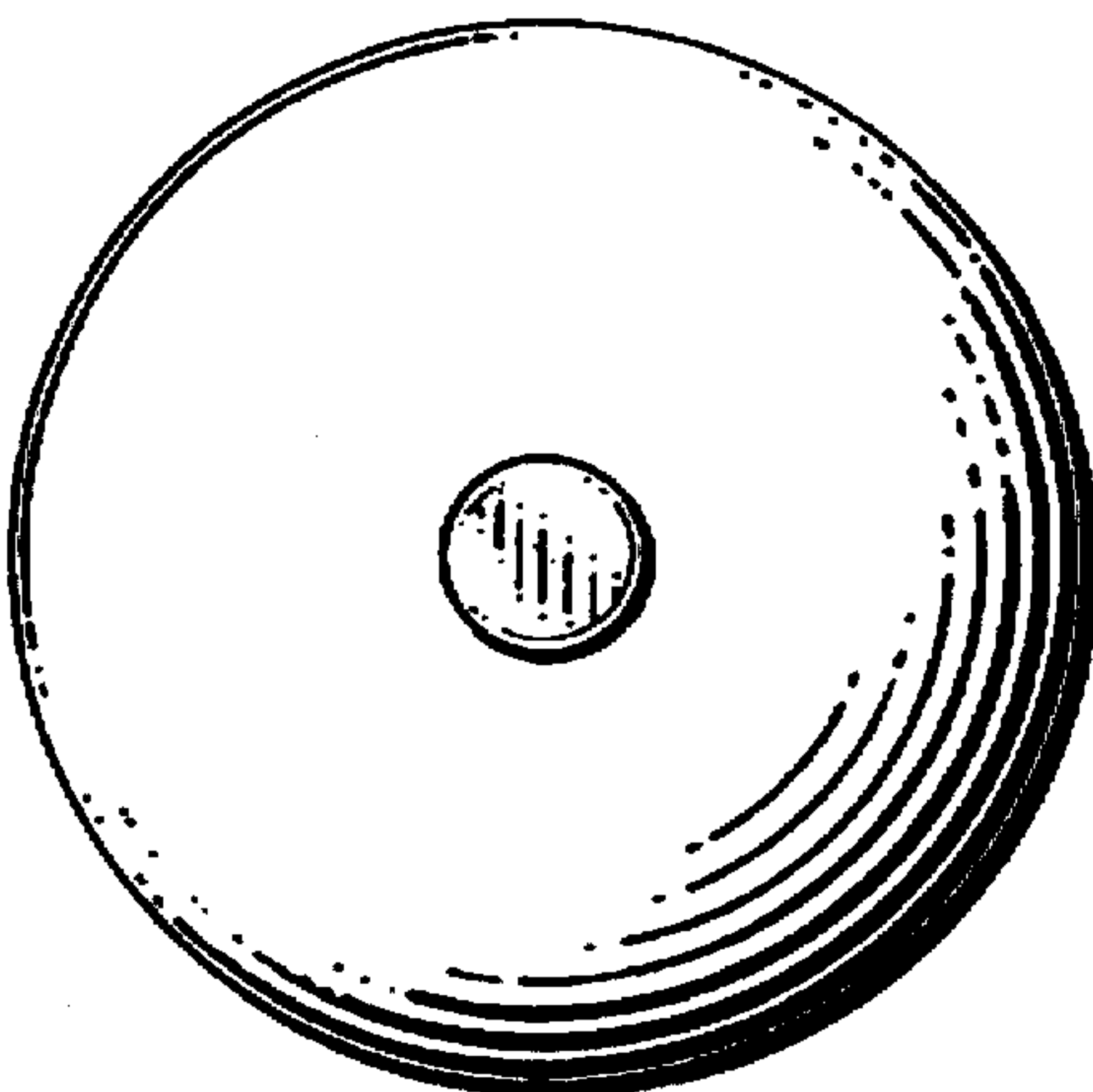

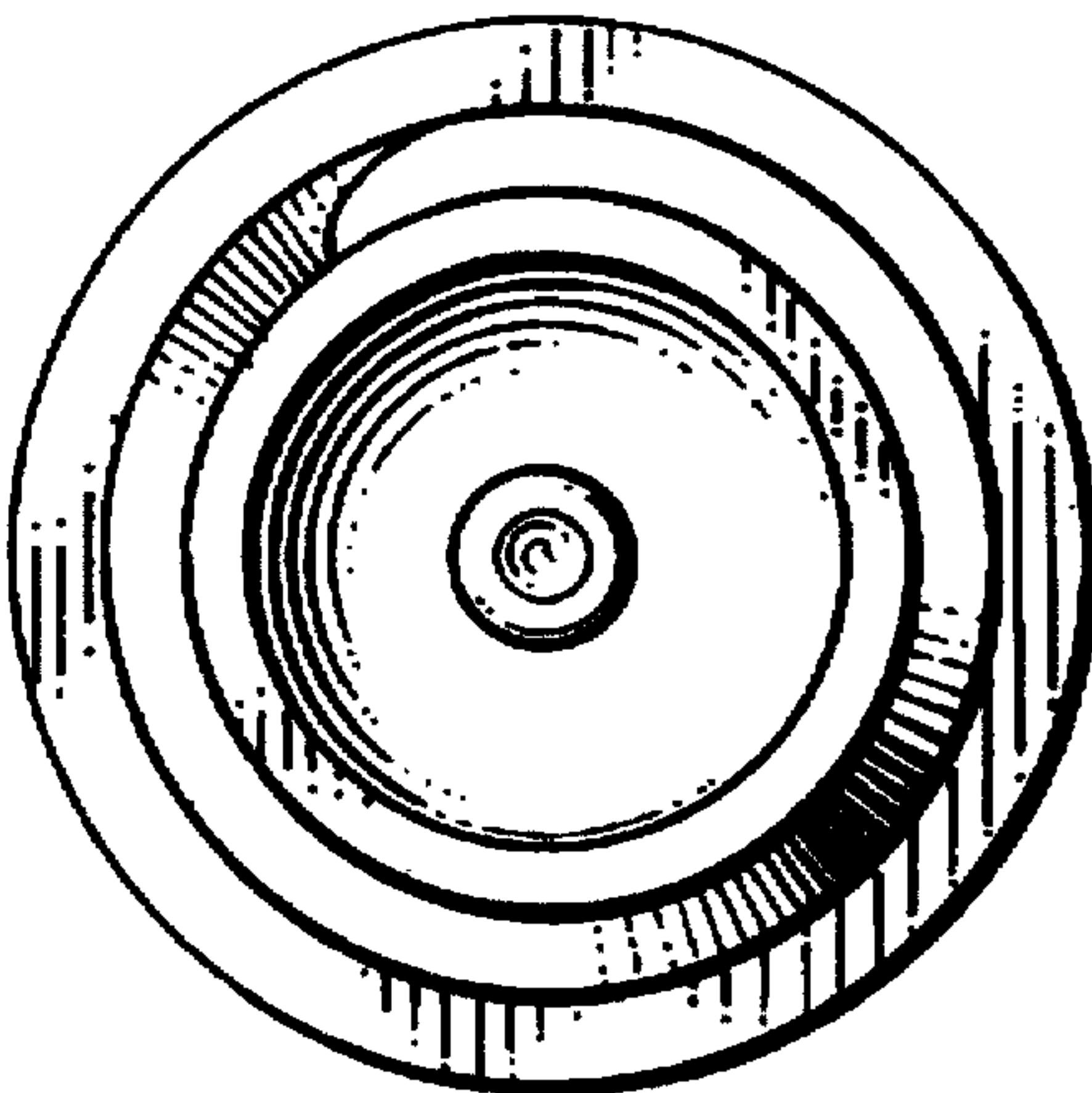

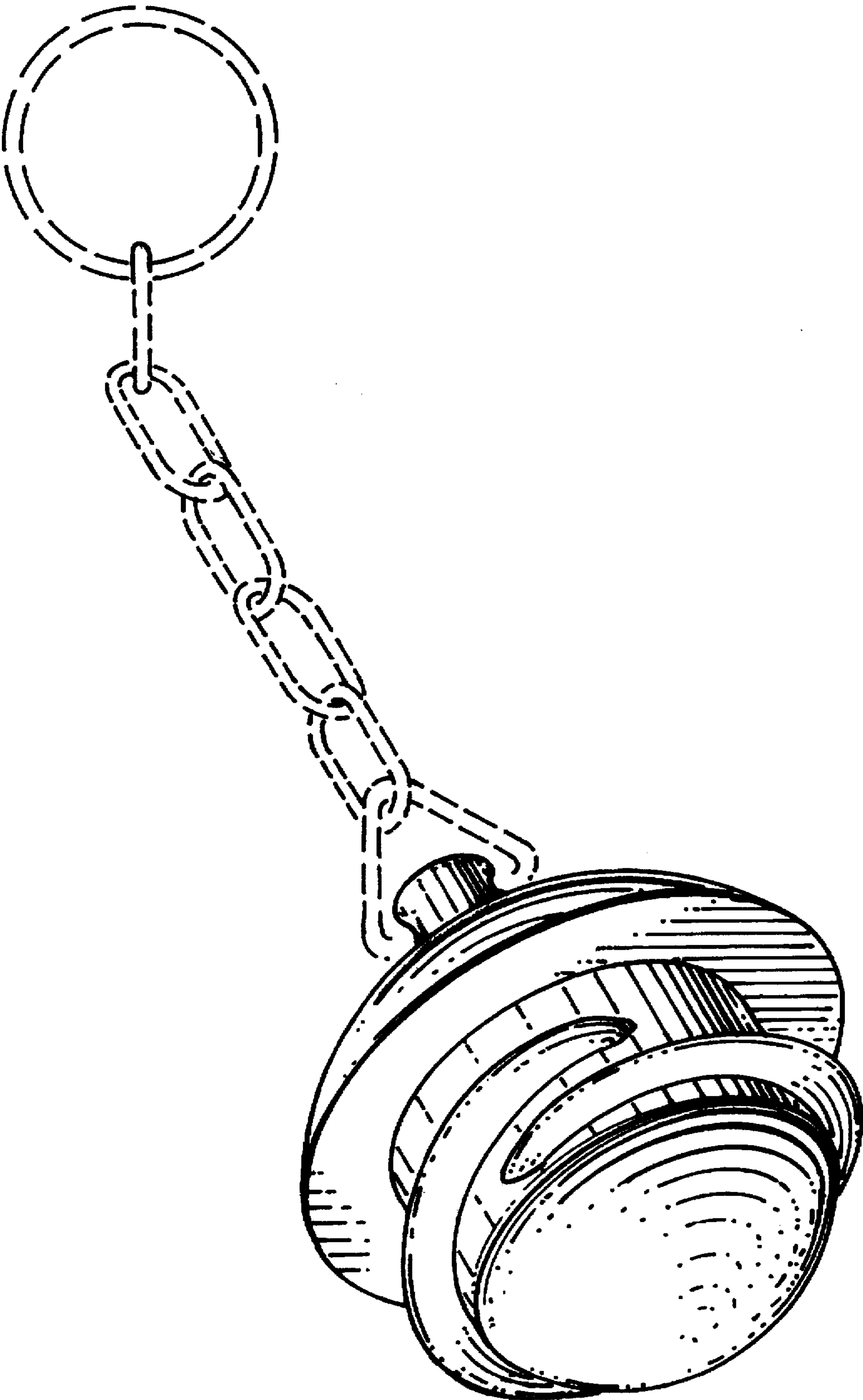

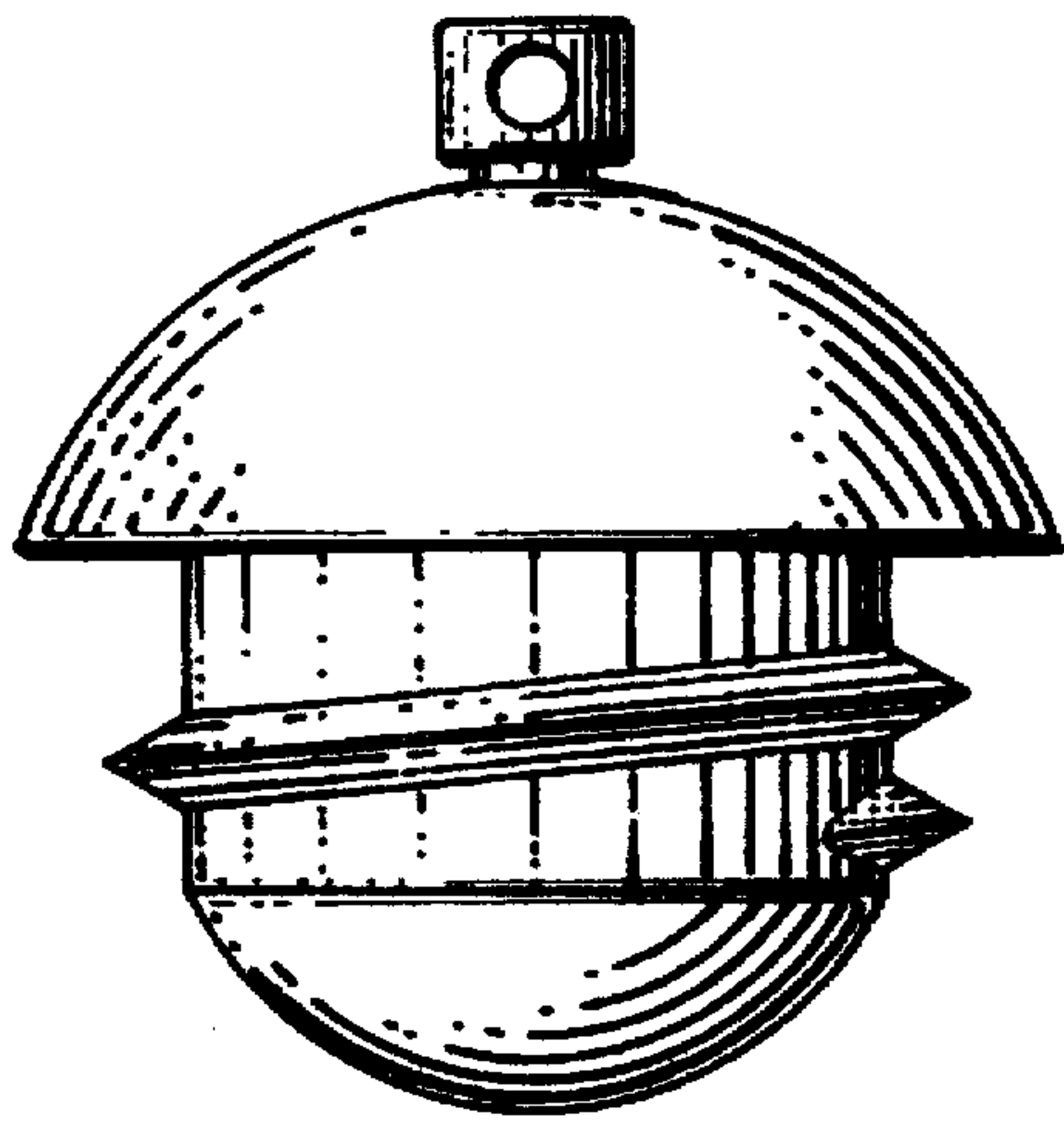

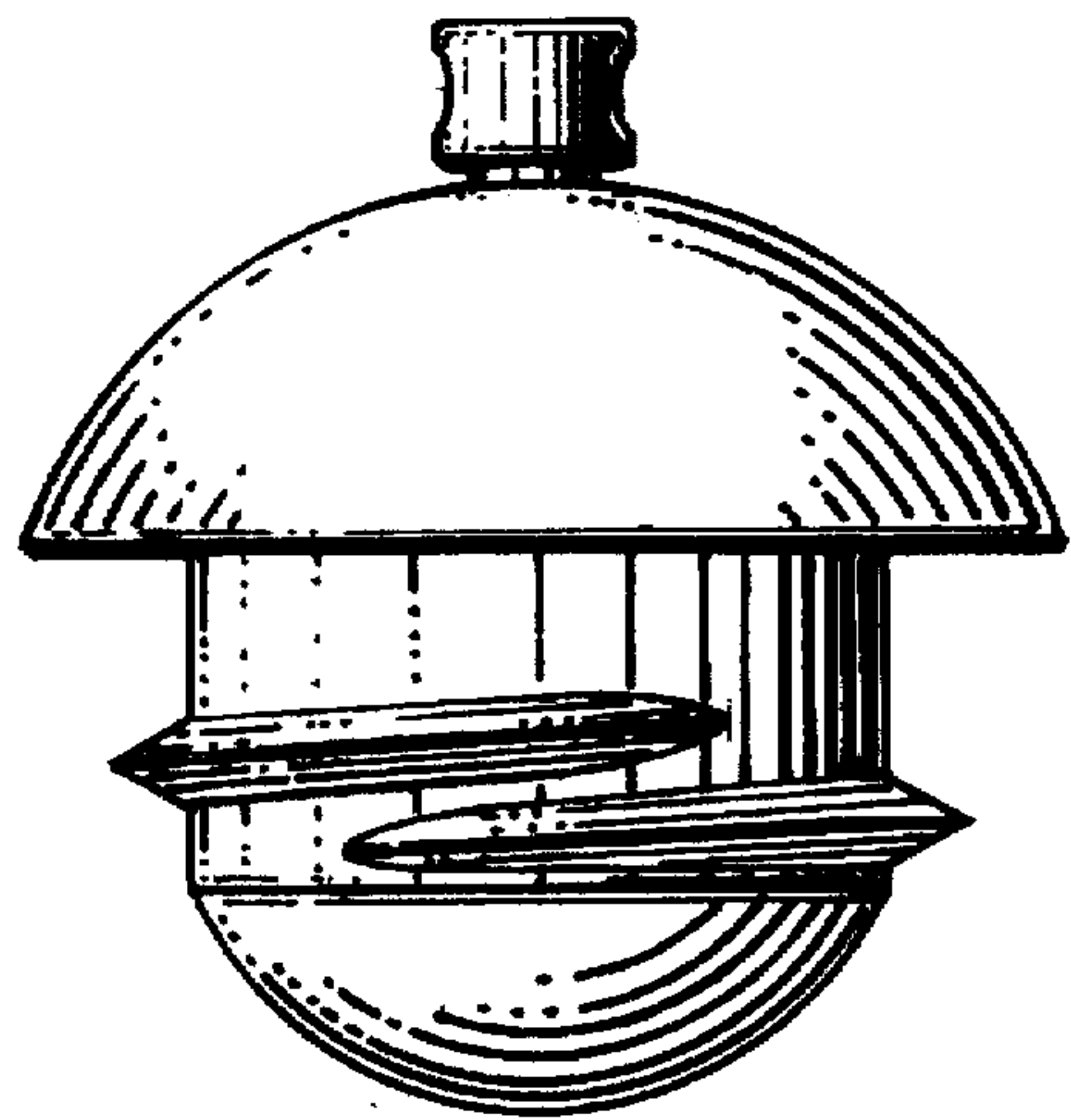

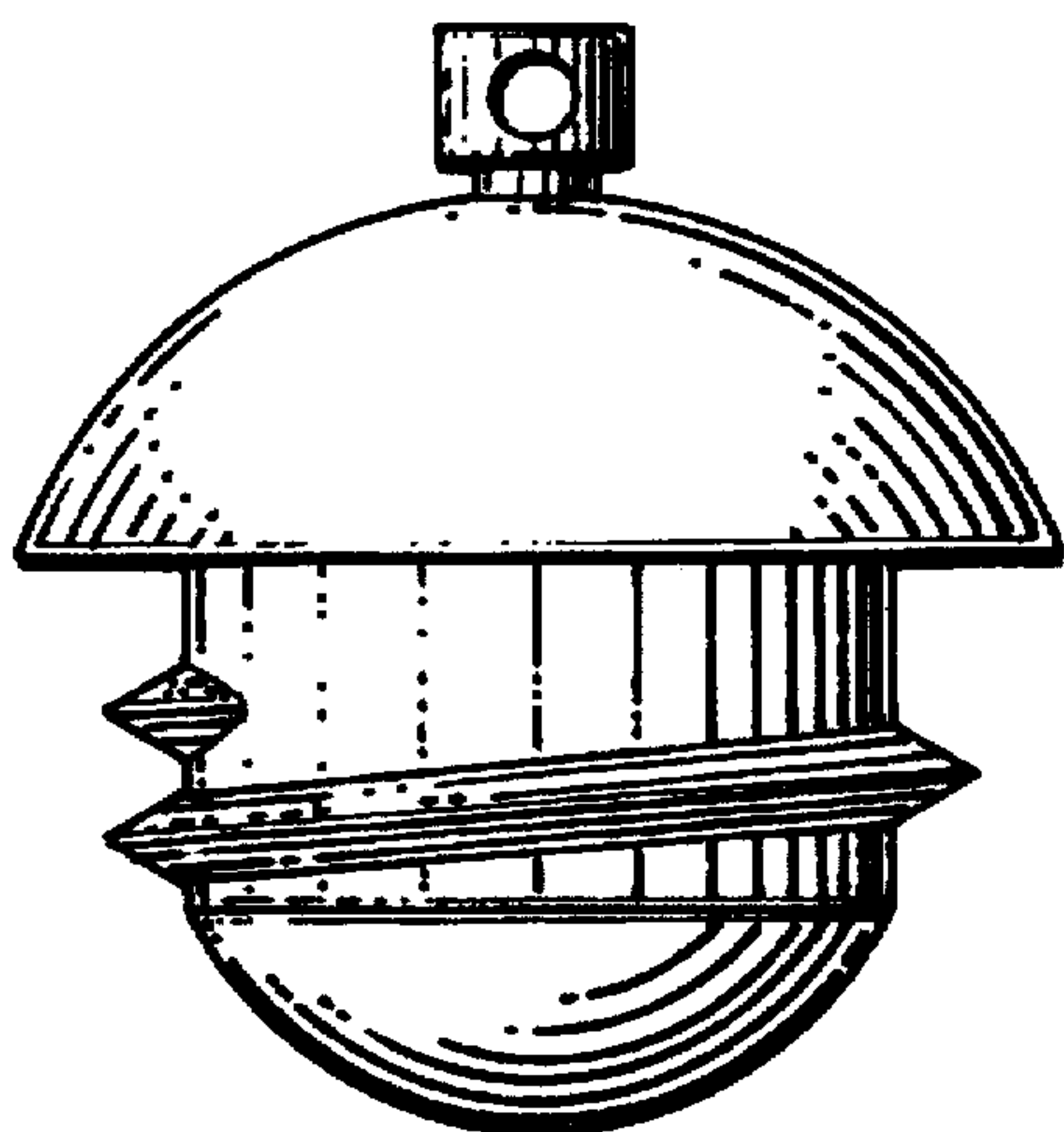

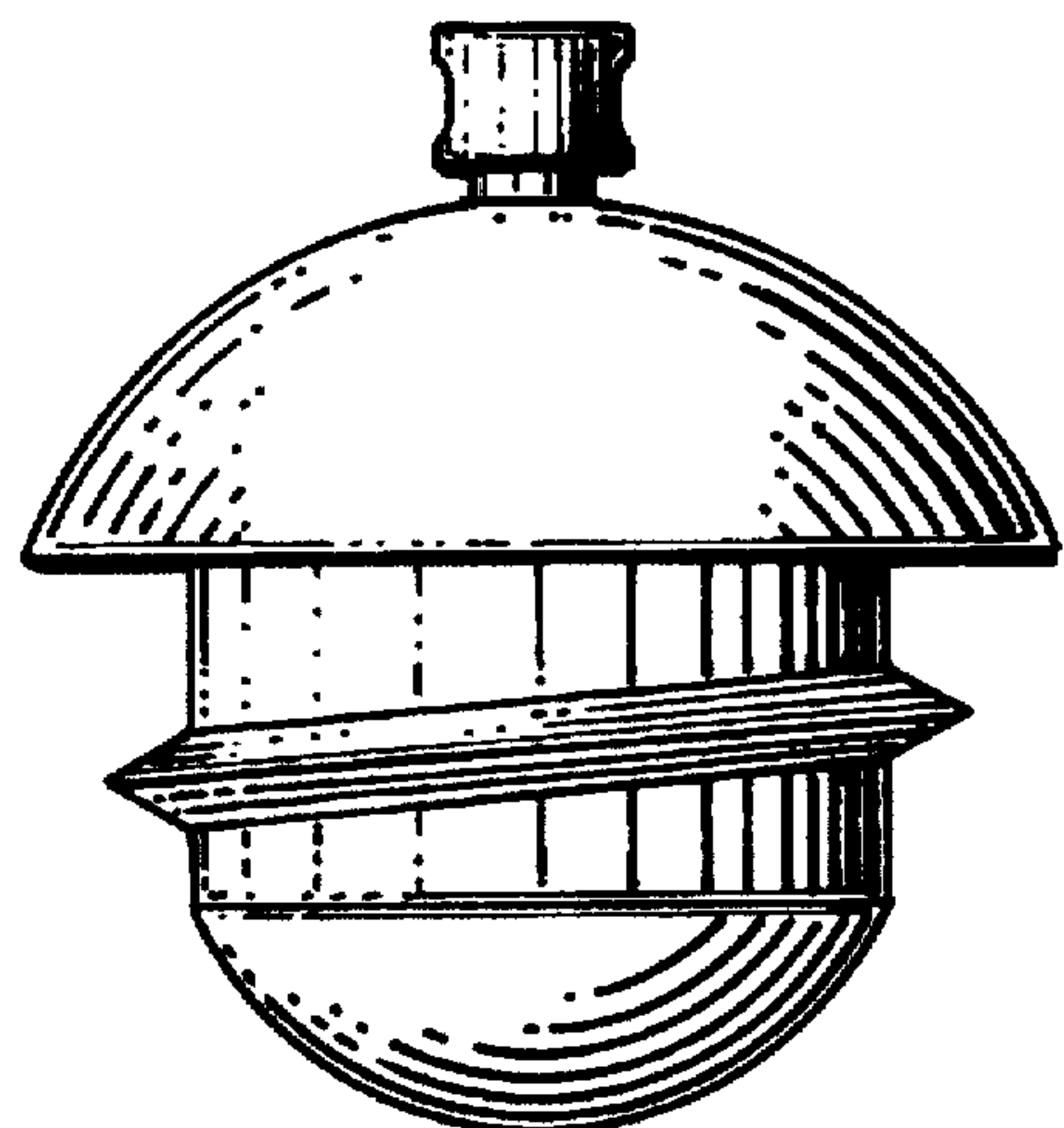

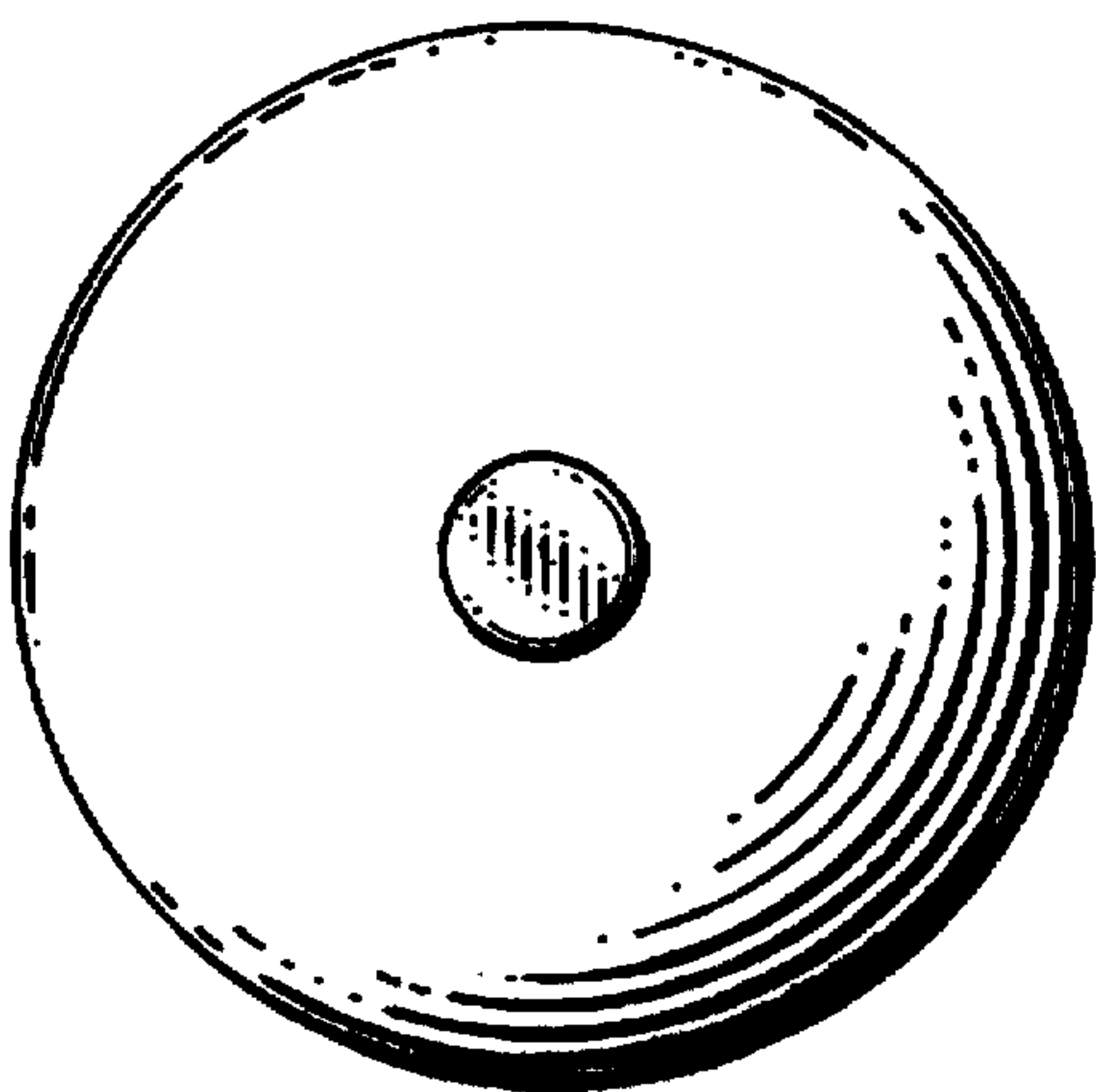

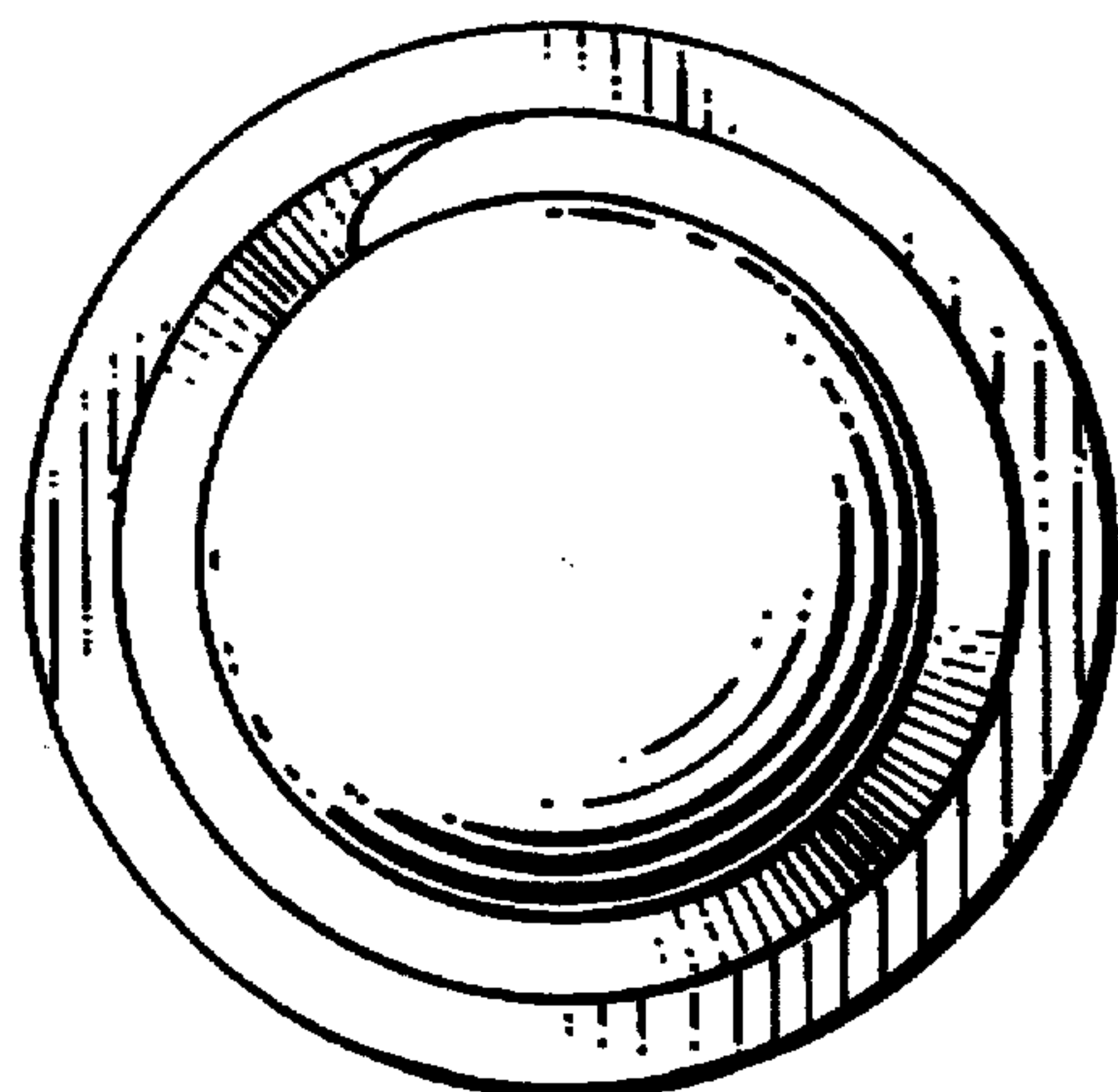

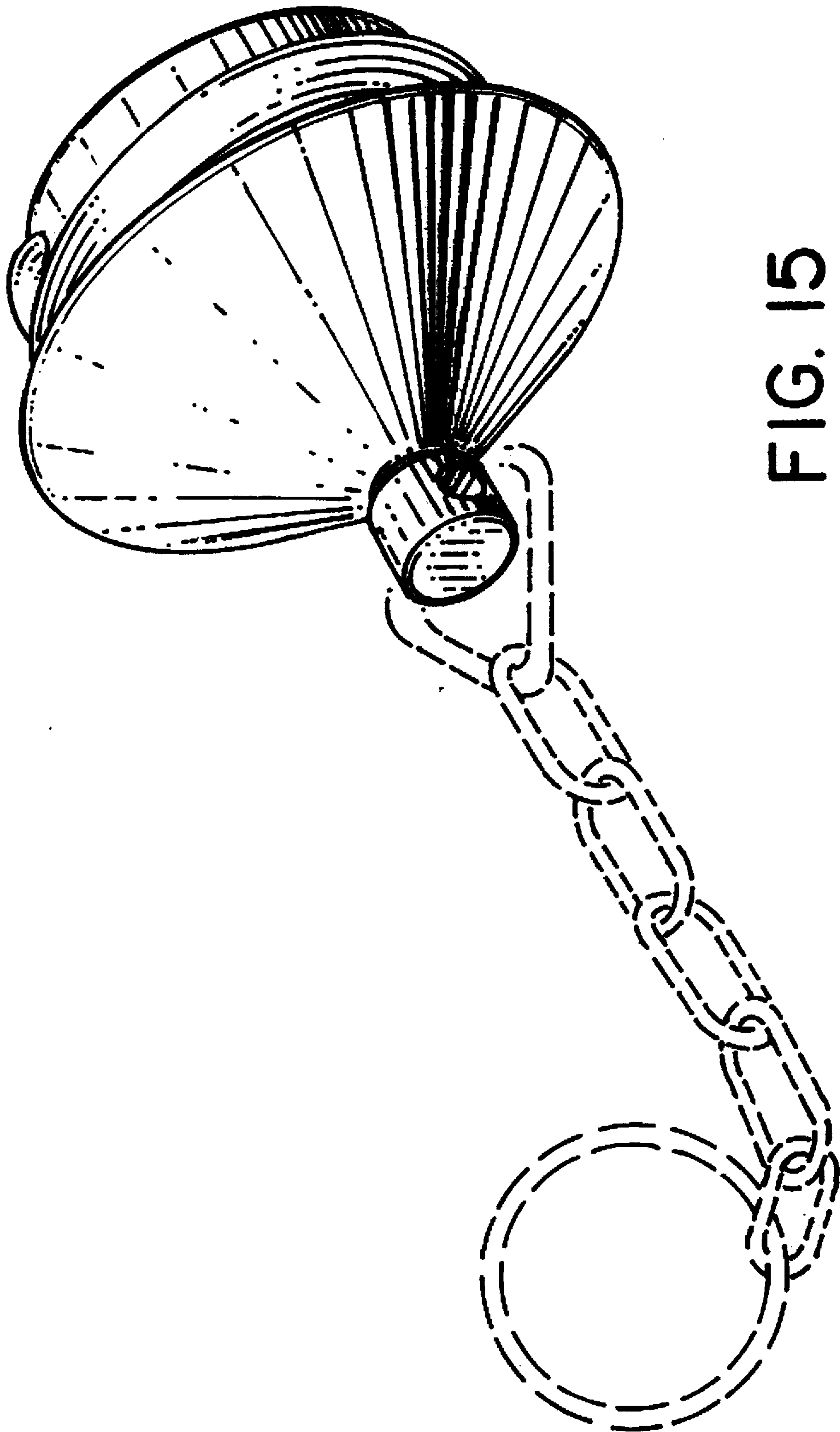

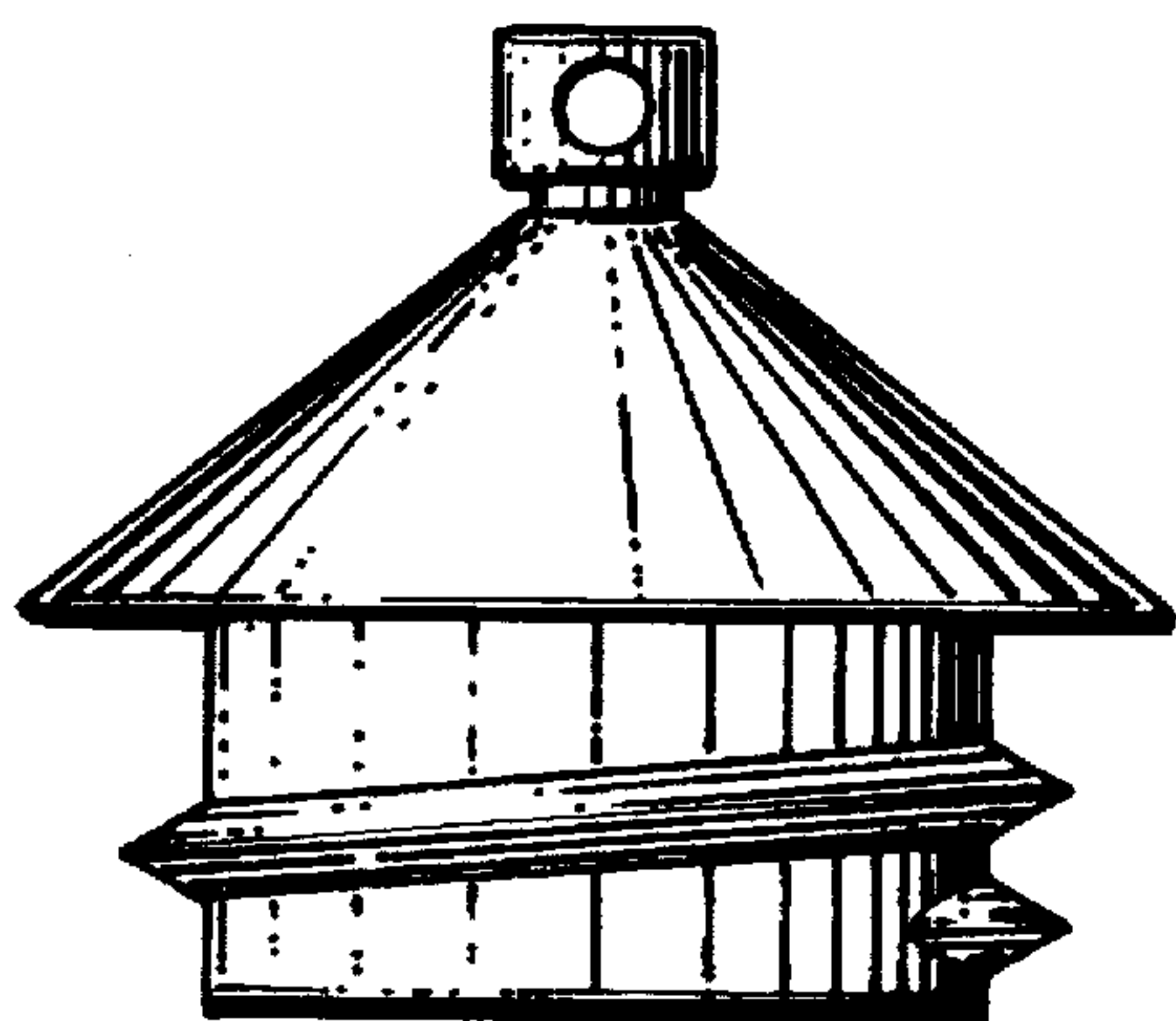

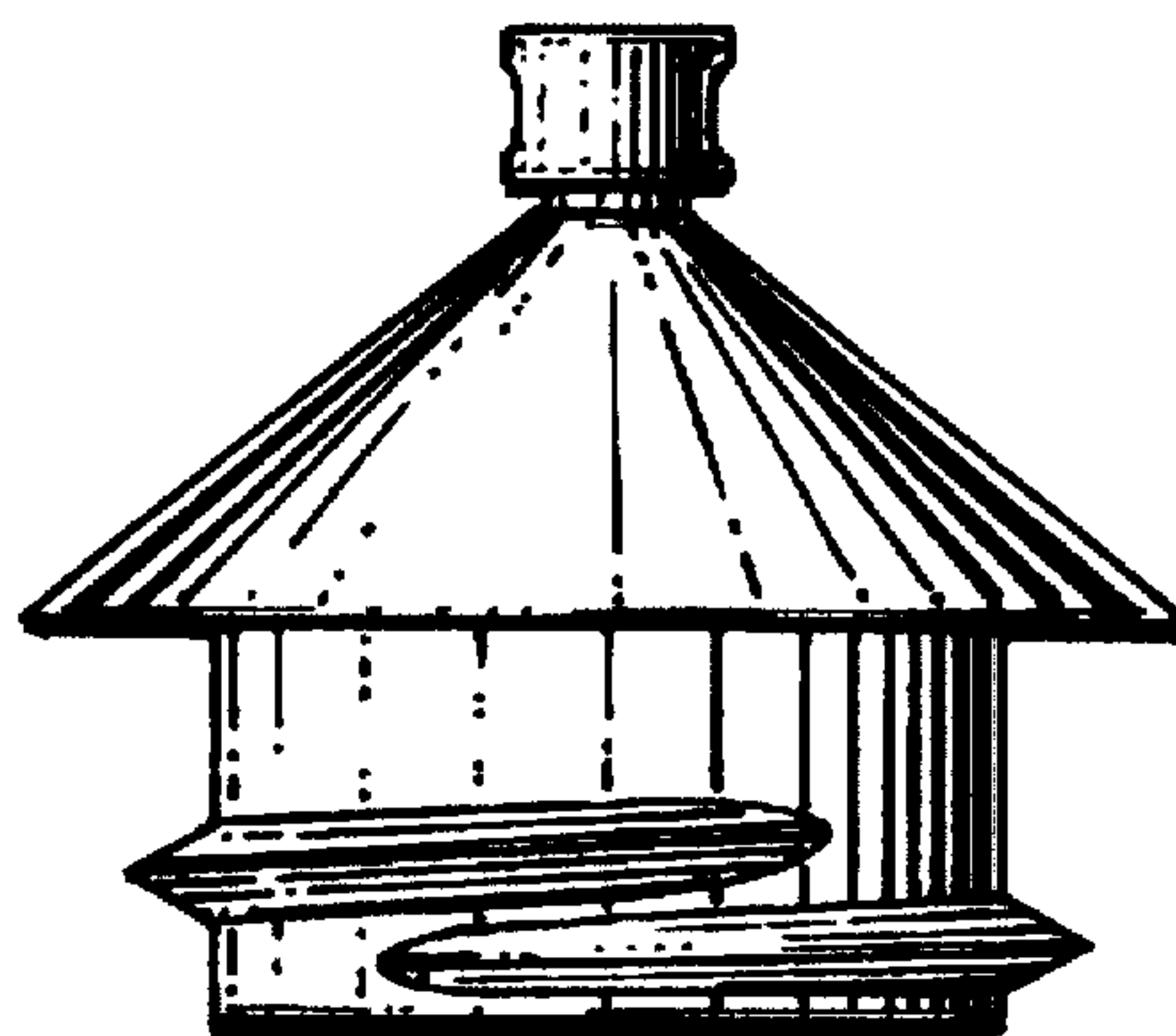

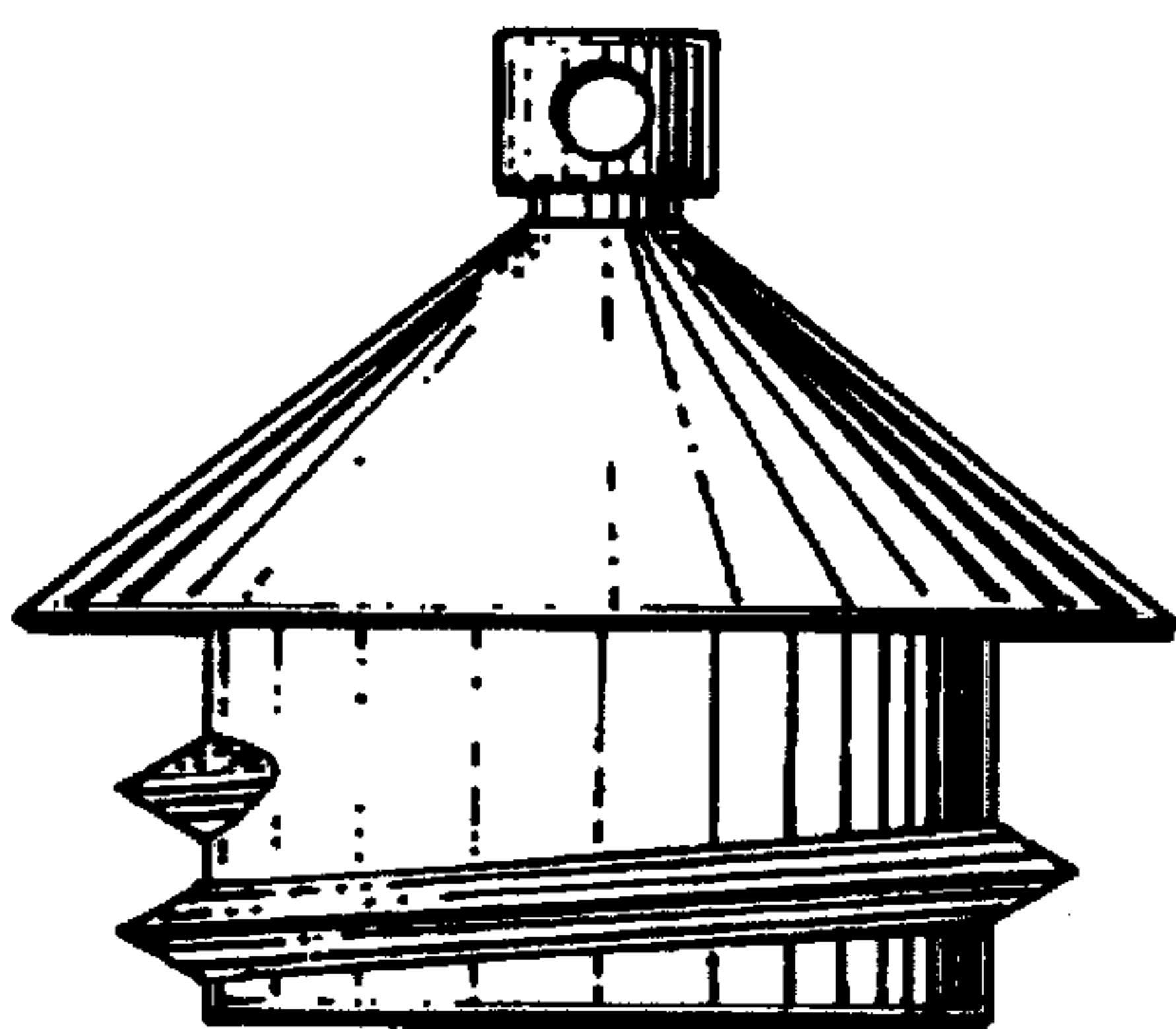

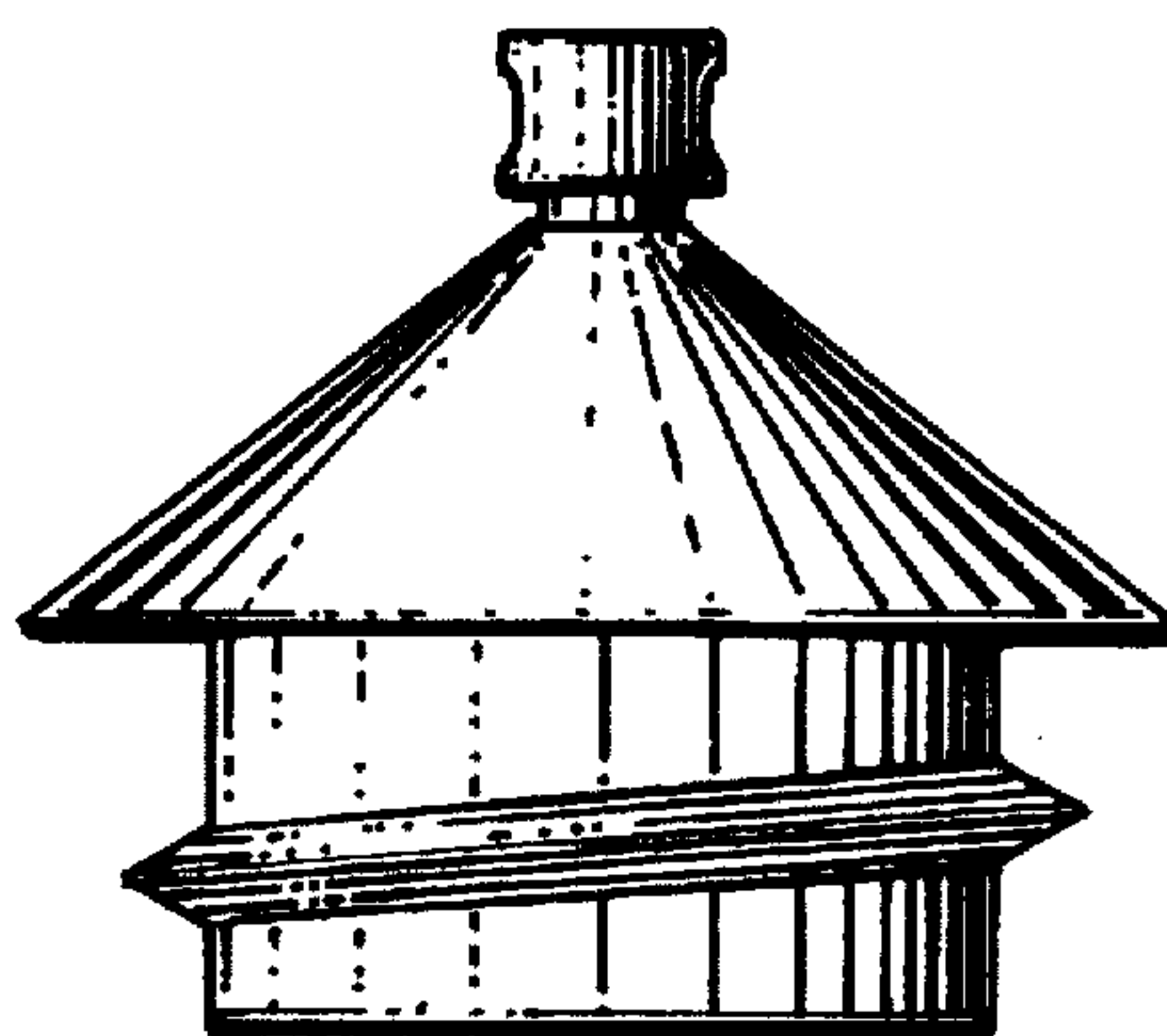

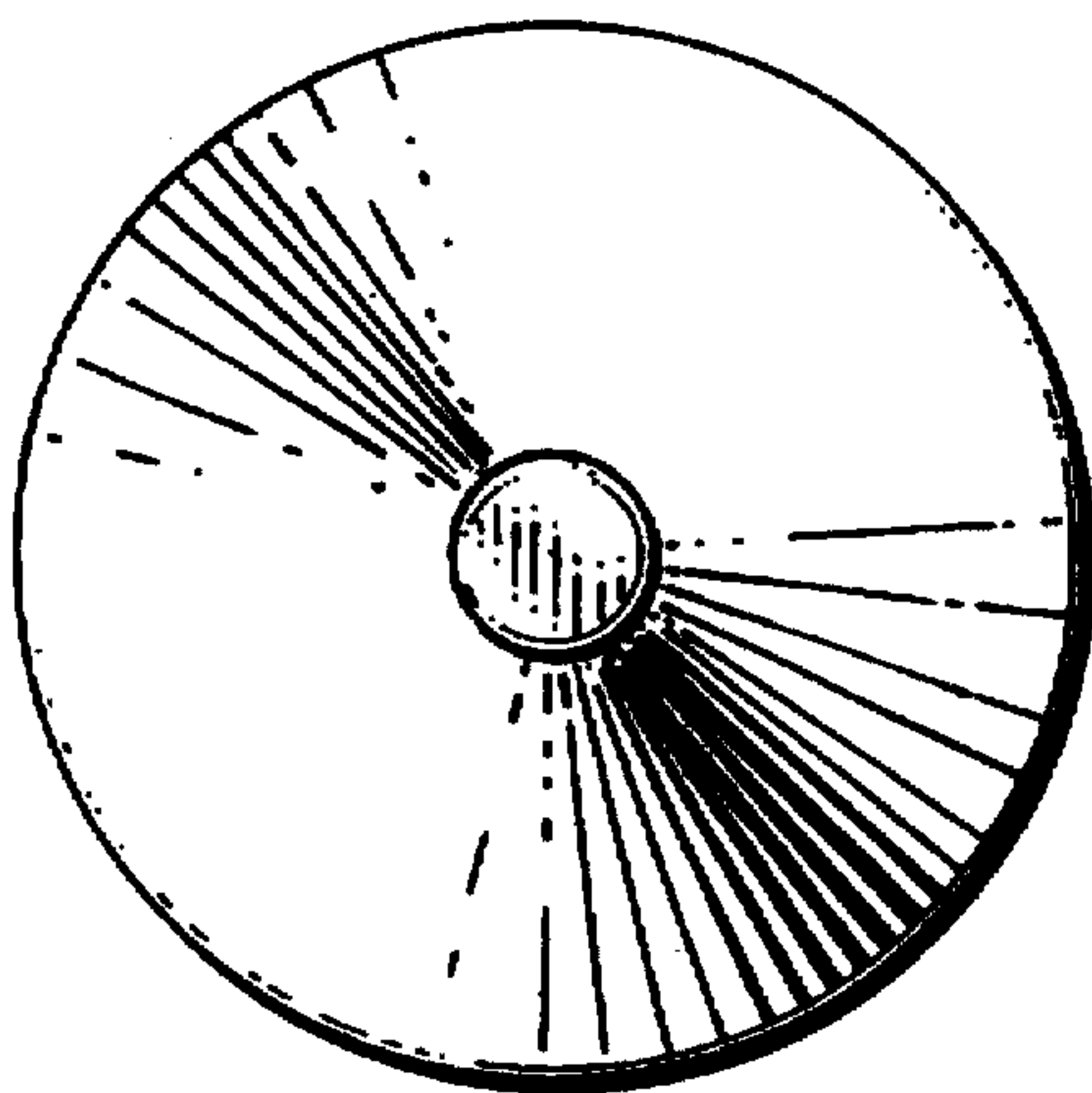

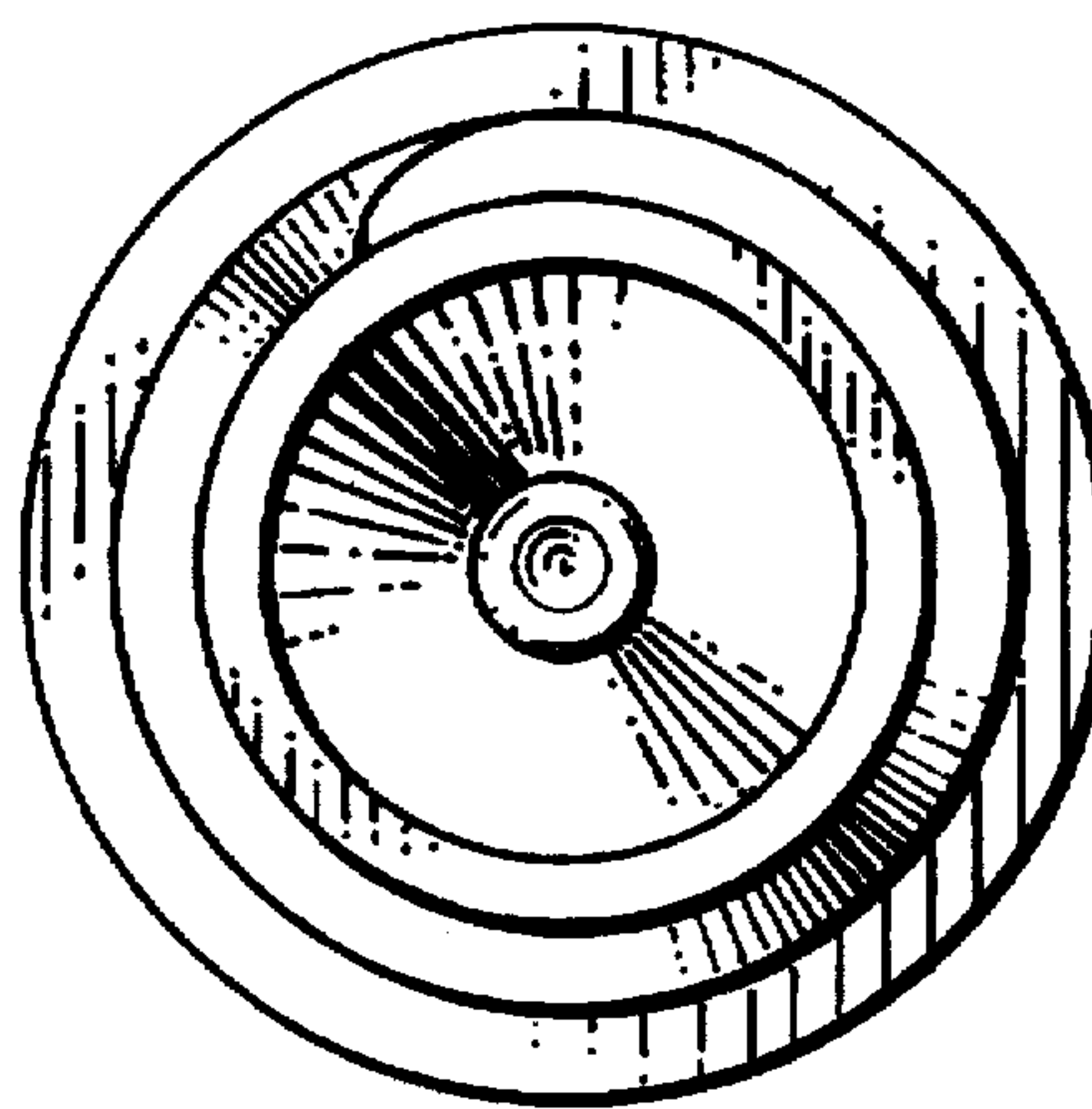
