The ornamental design for a seat for modular seating system, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of a seat for modular seating system showing my new design;  
FIG. 2 is a left side elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a back elevational view thereof;  
FIG. 6 is a top plan view thereof; and,

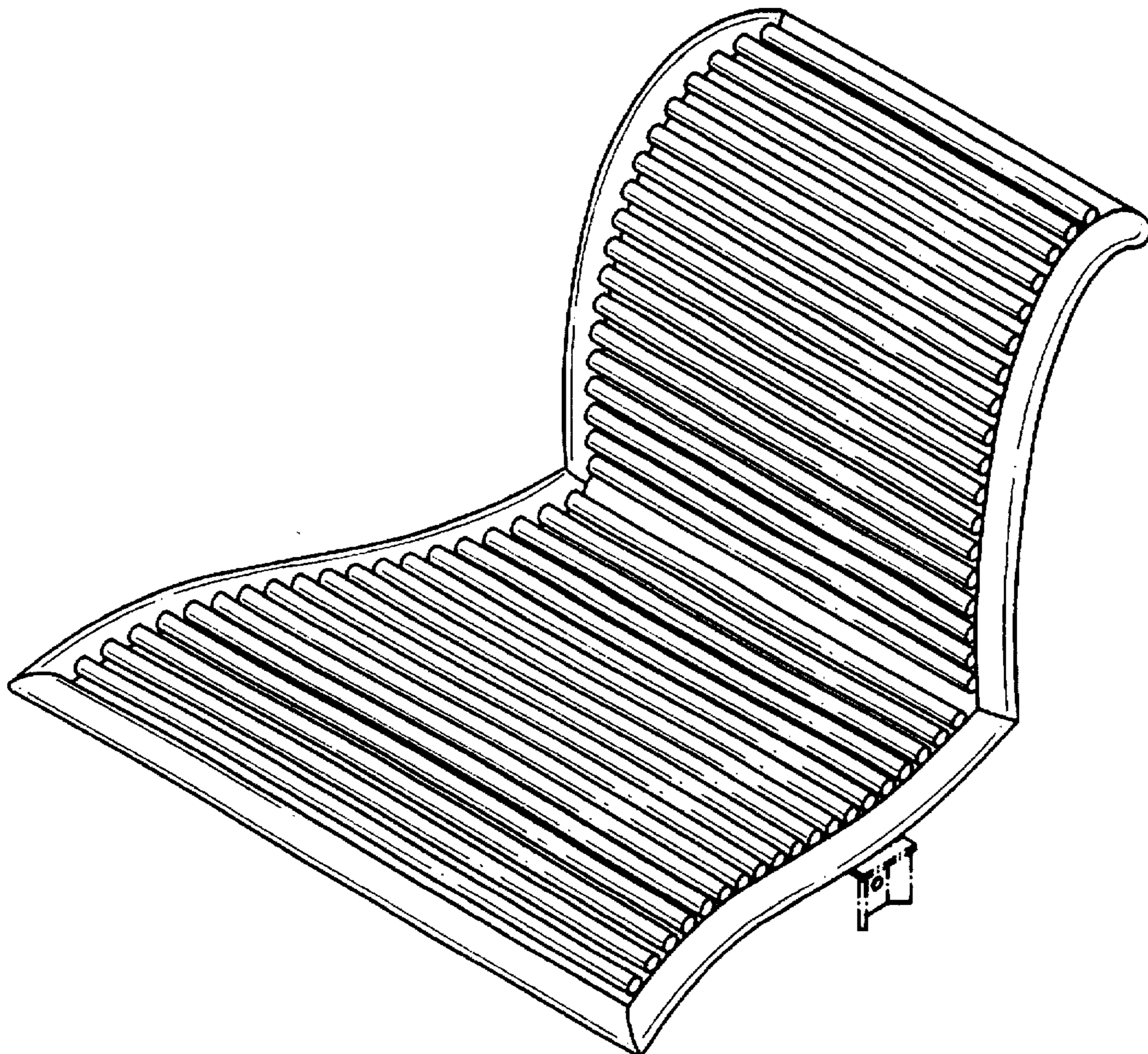
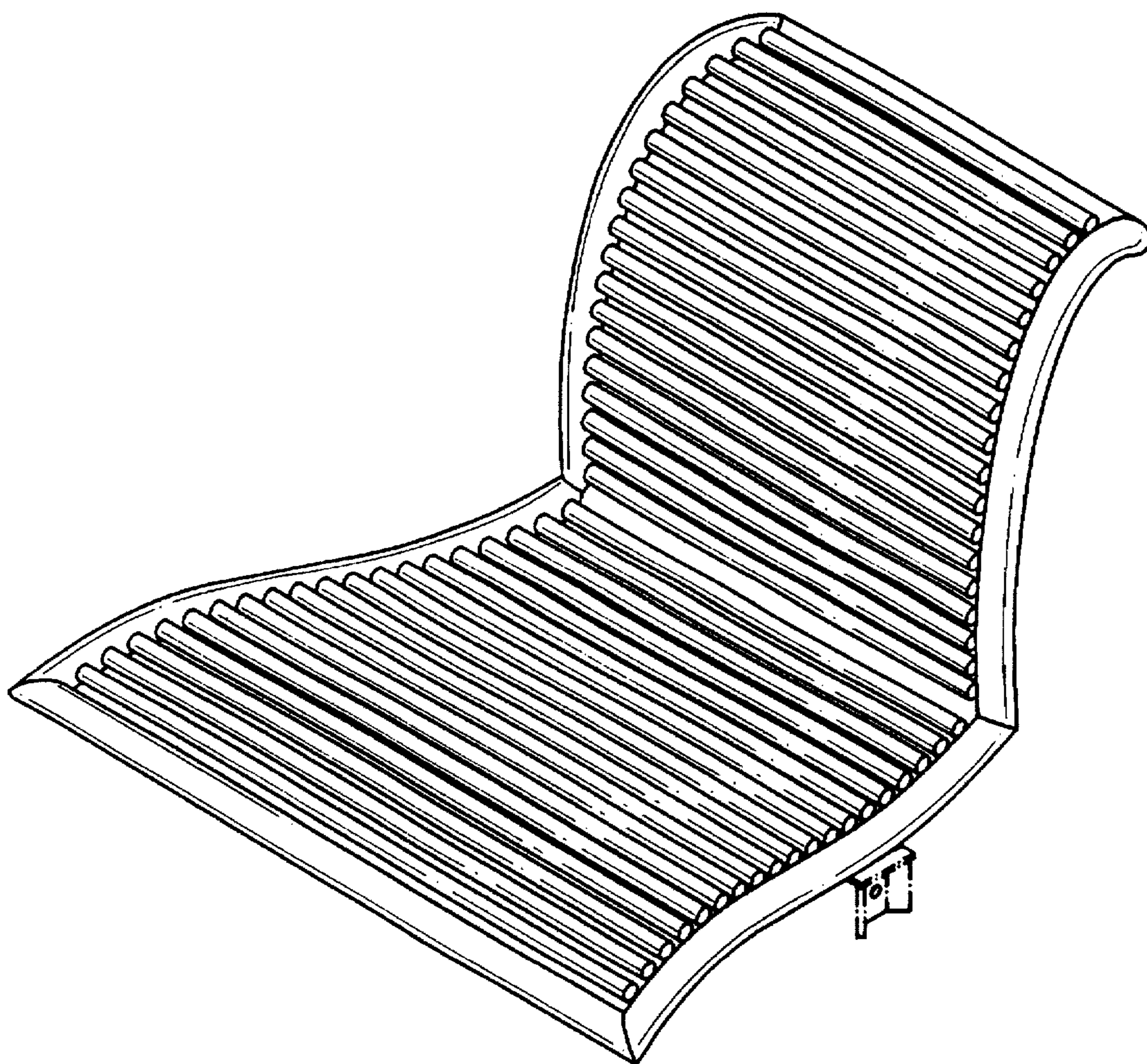
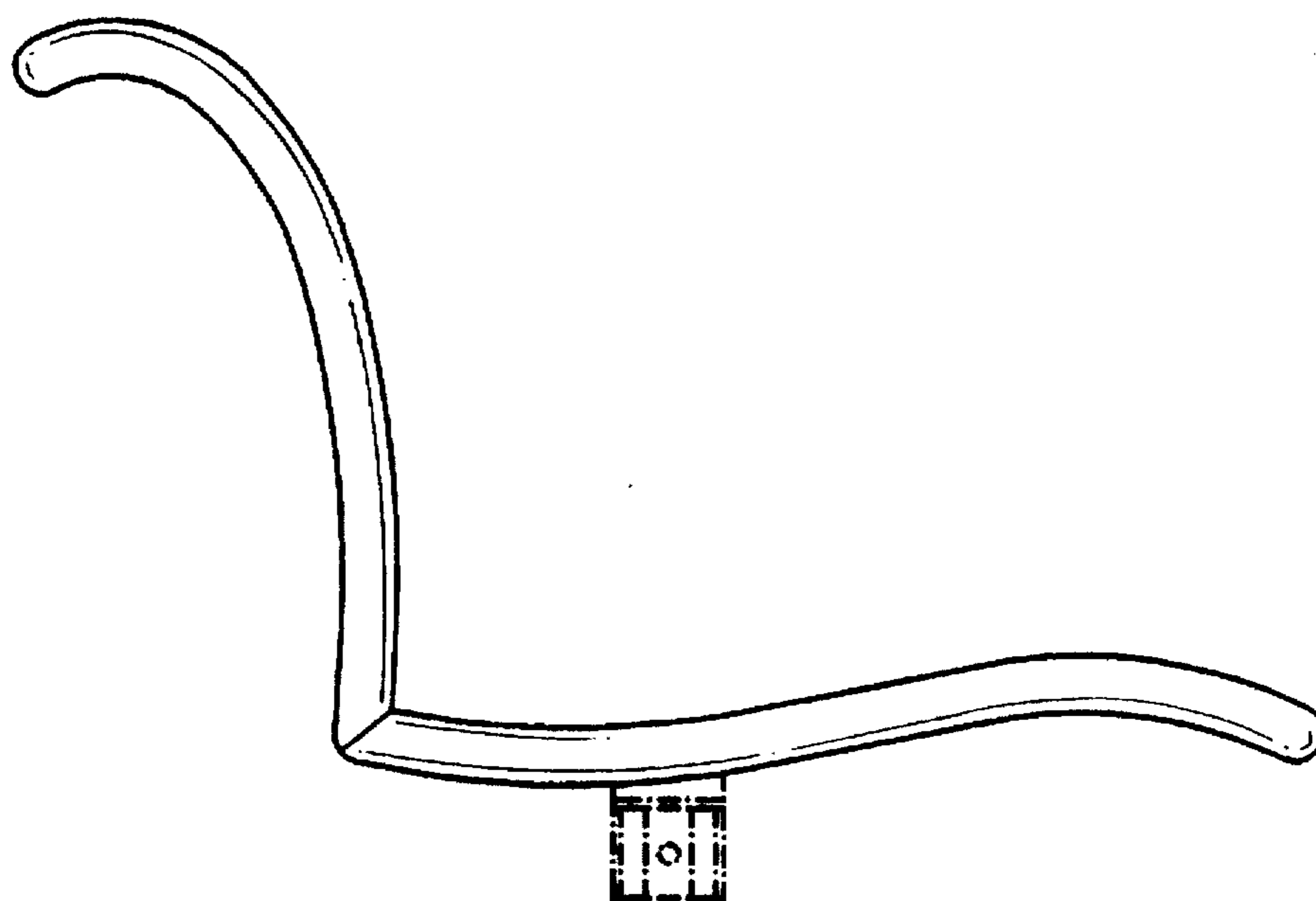




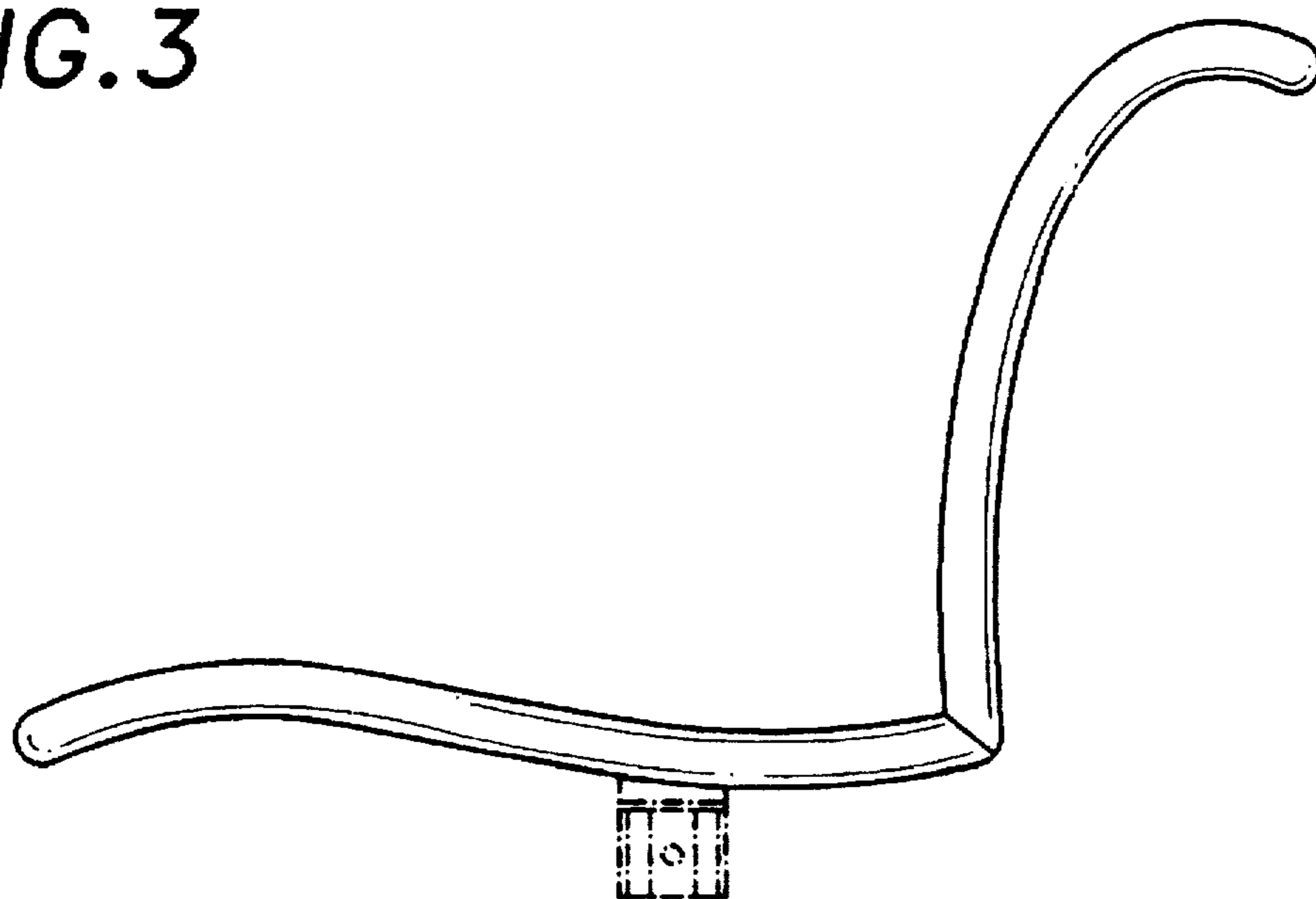

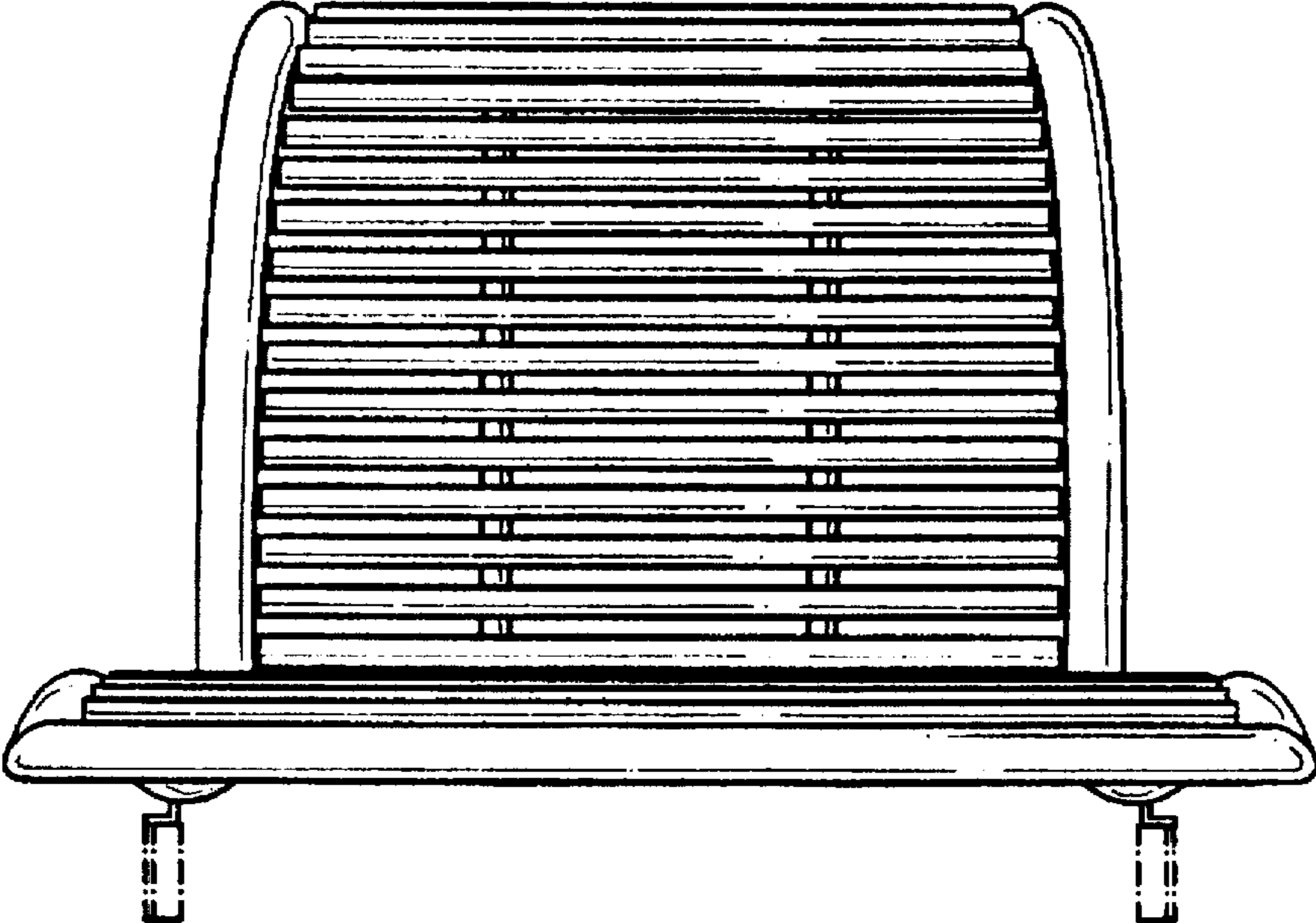

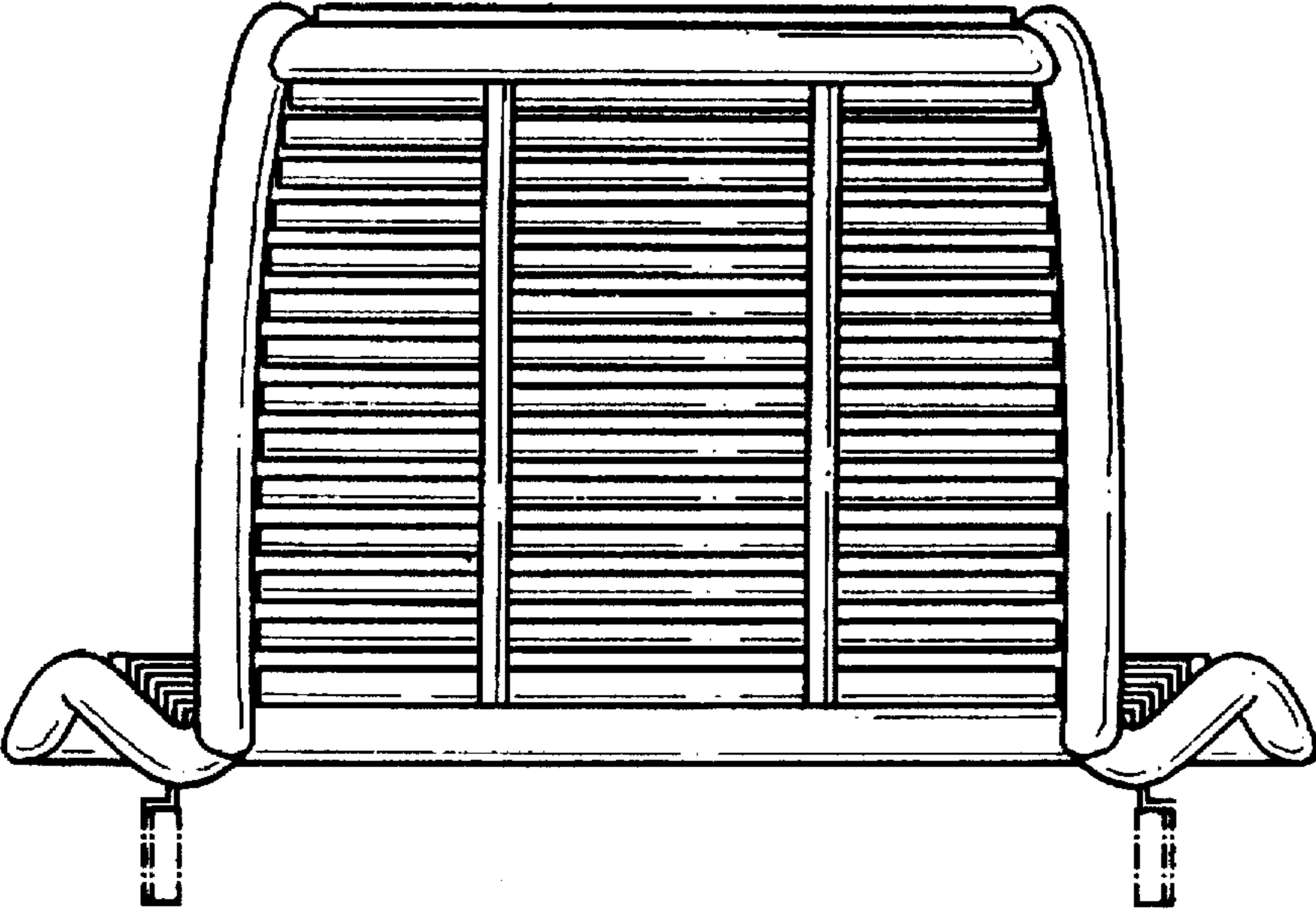

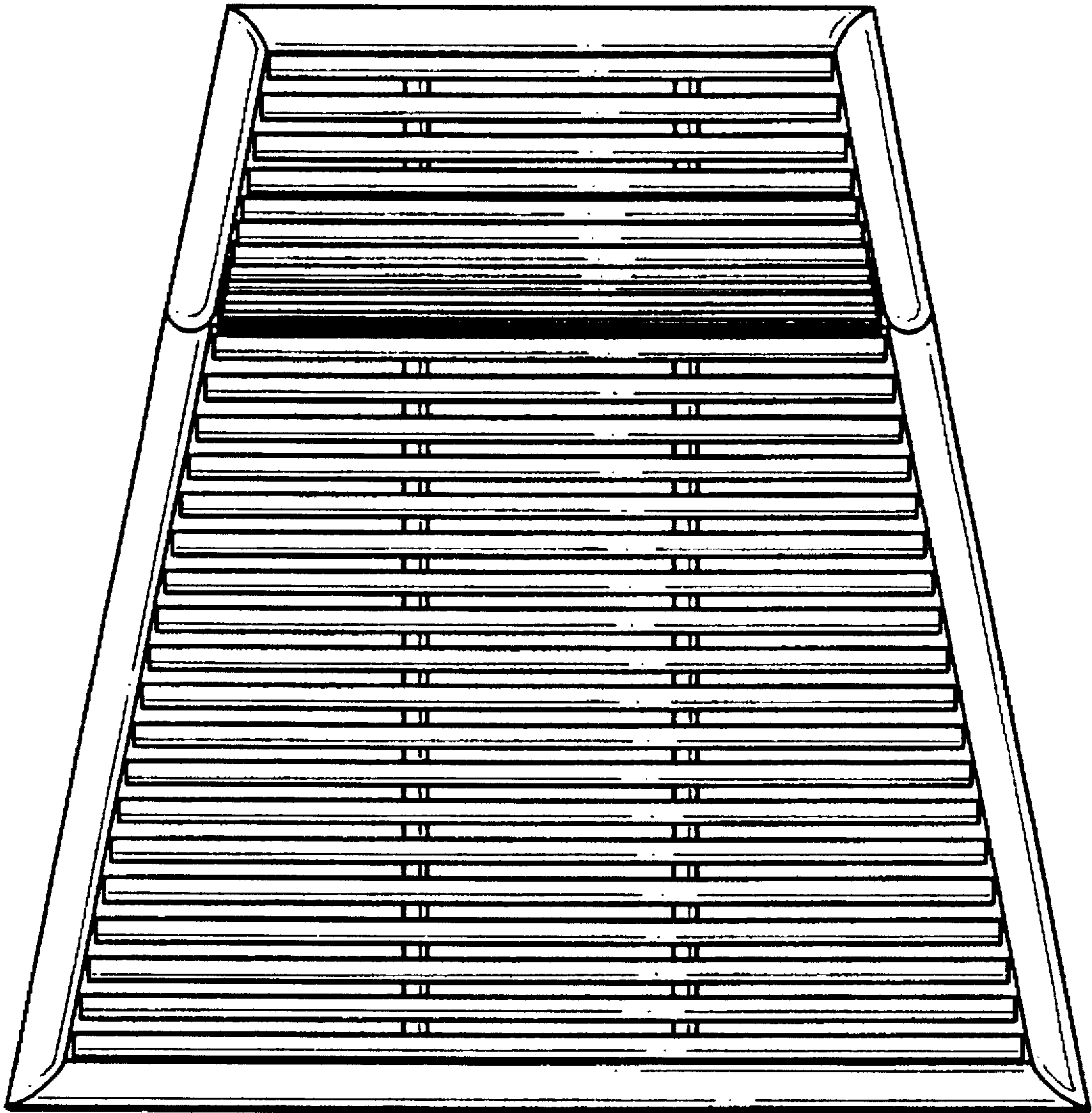
