FIG. 12 is a bottom view of the second embodiment;

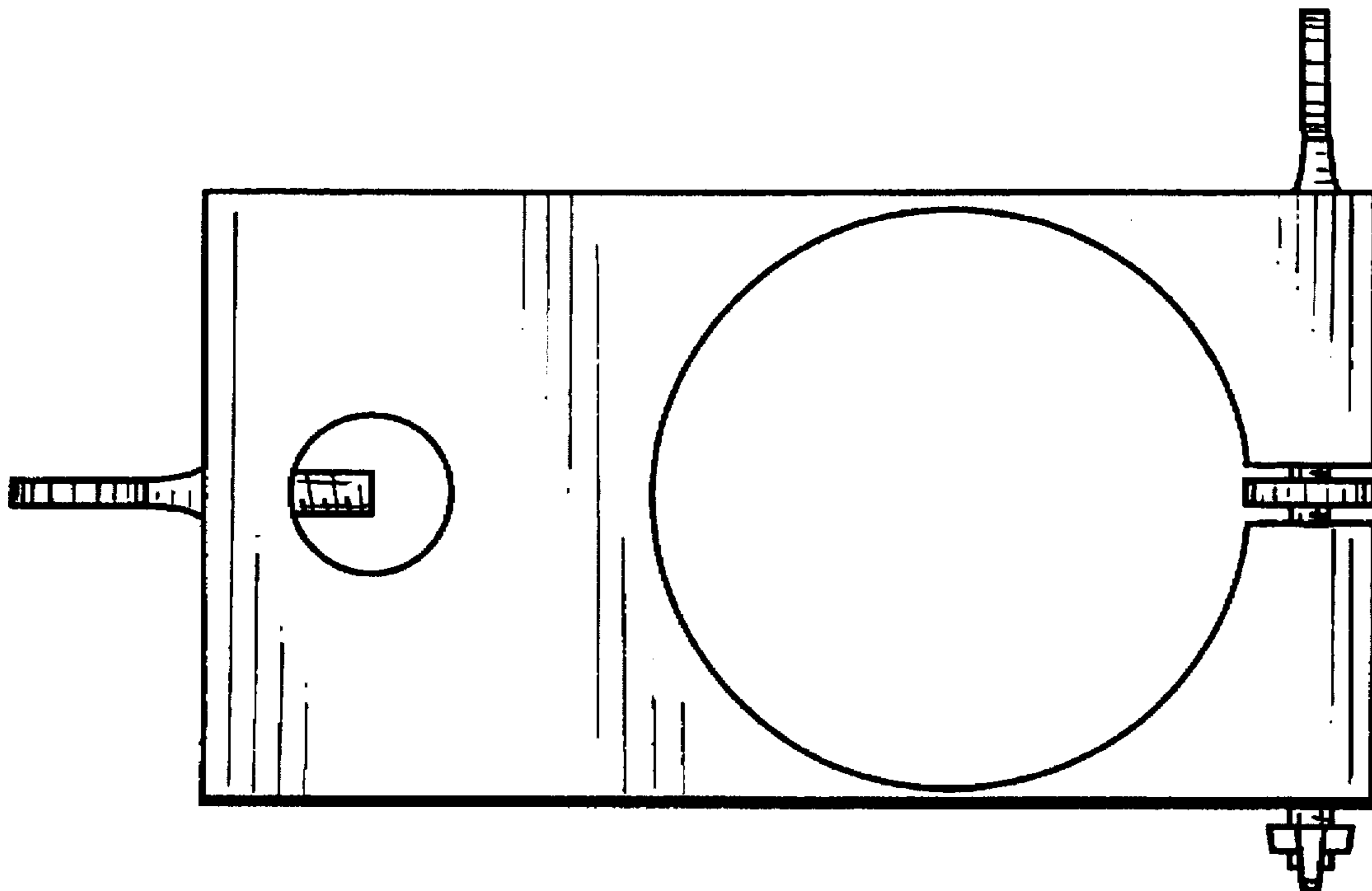
FIG. 13 is a front view of the second embodiment; and,

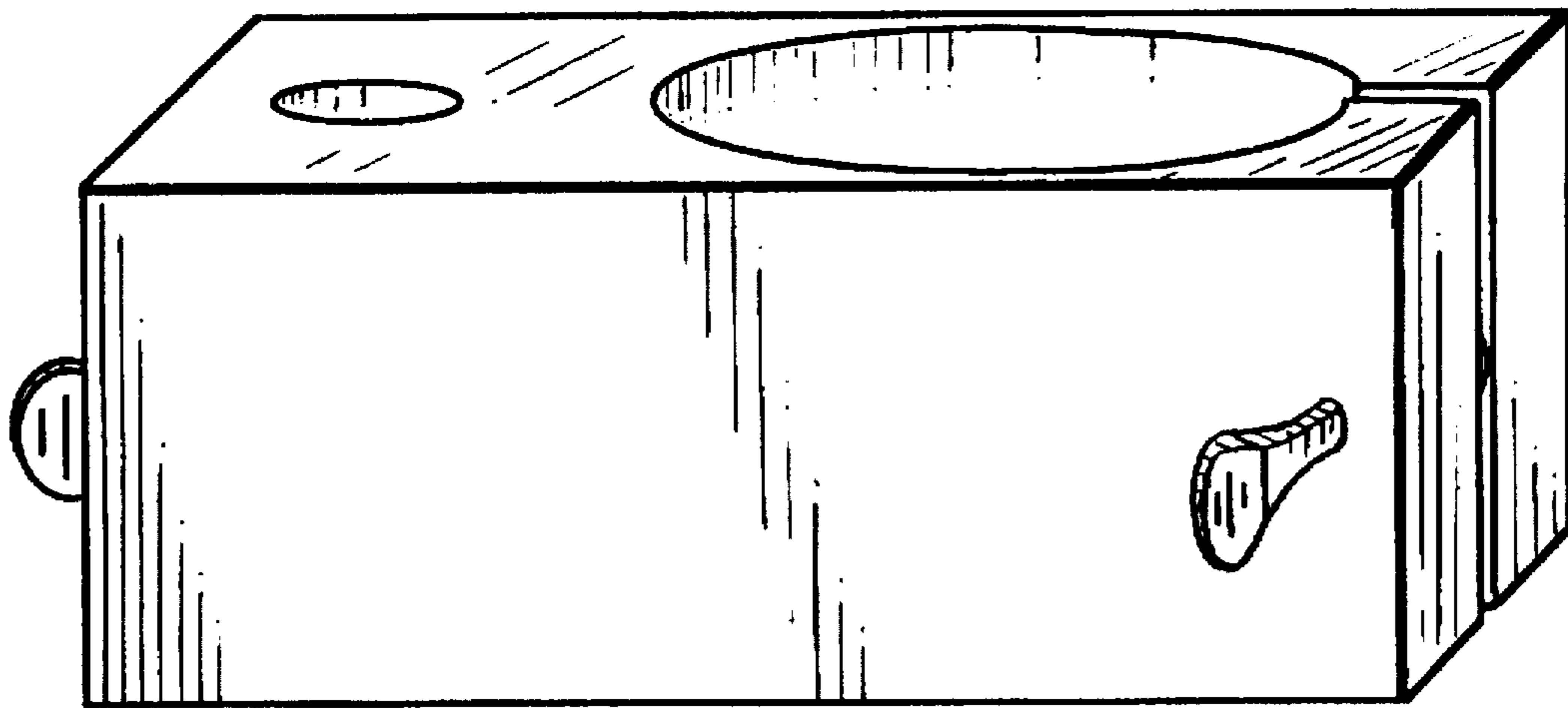

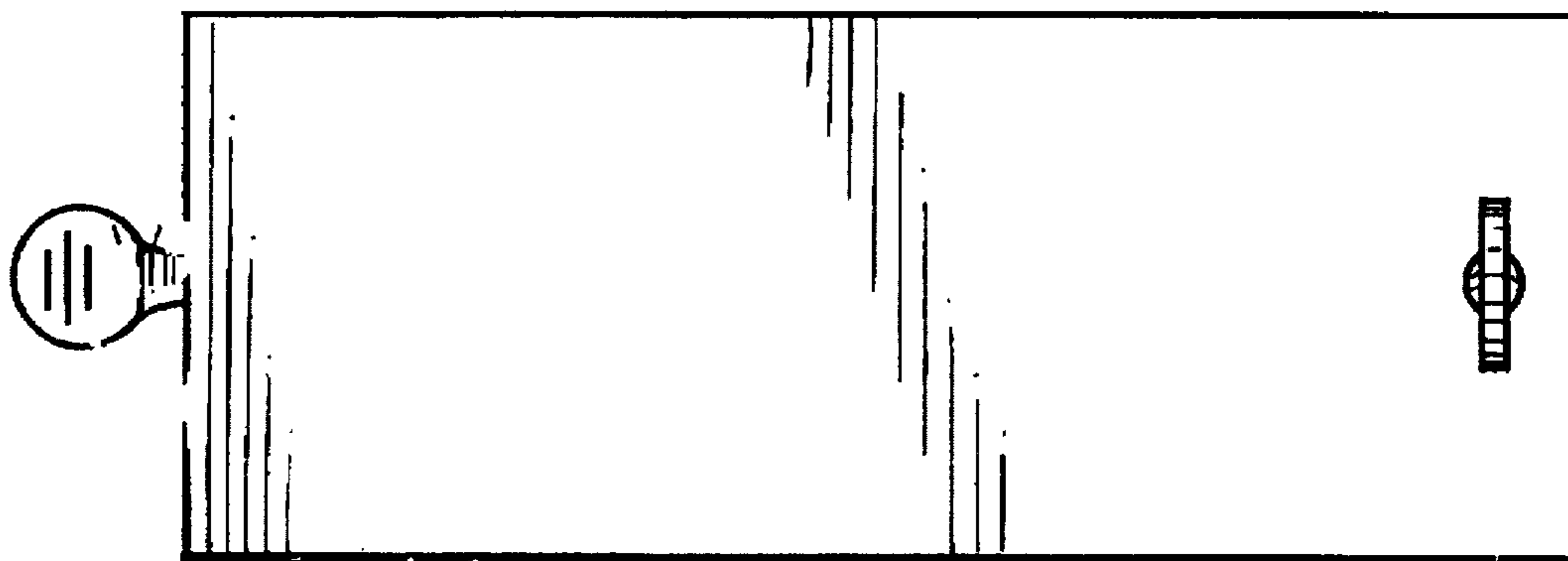

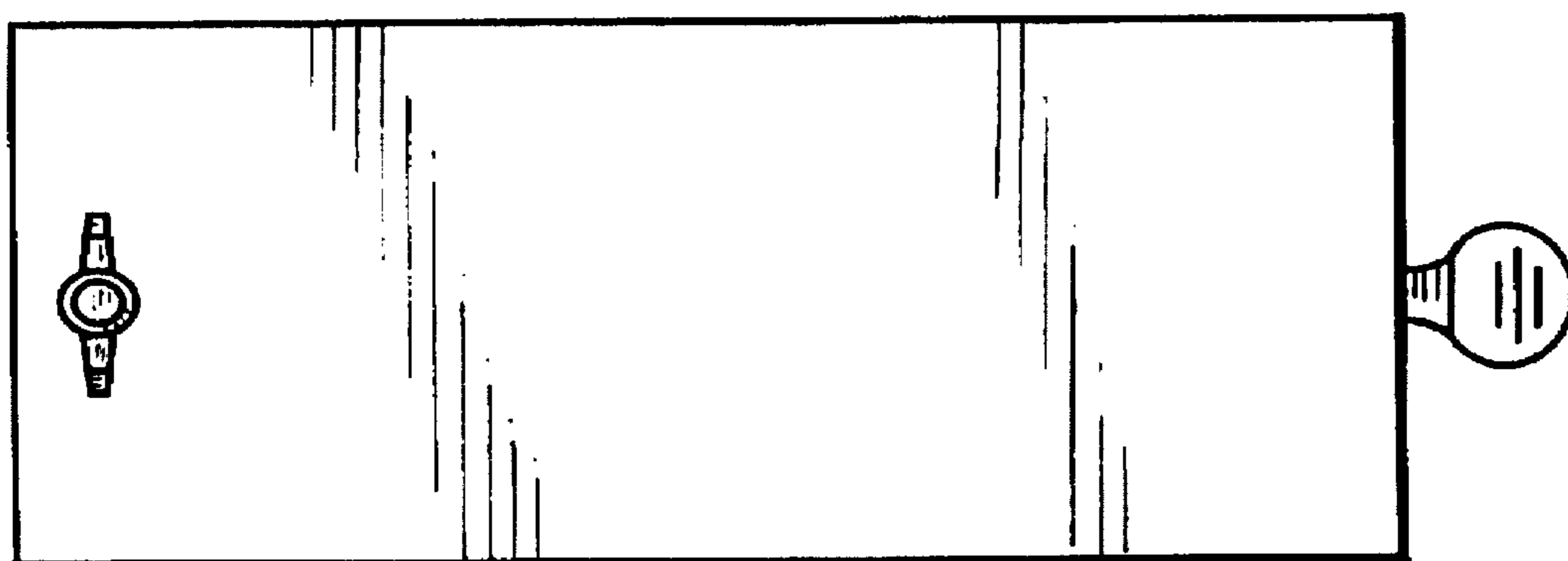

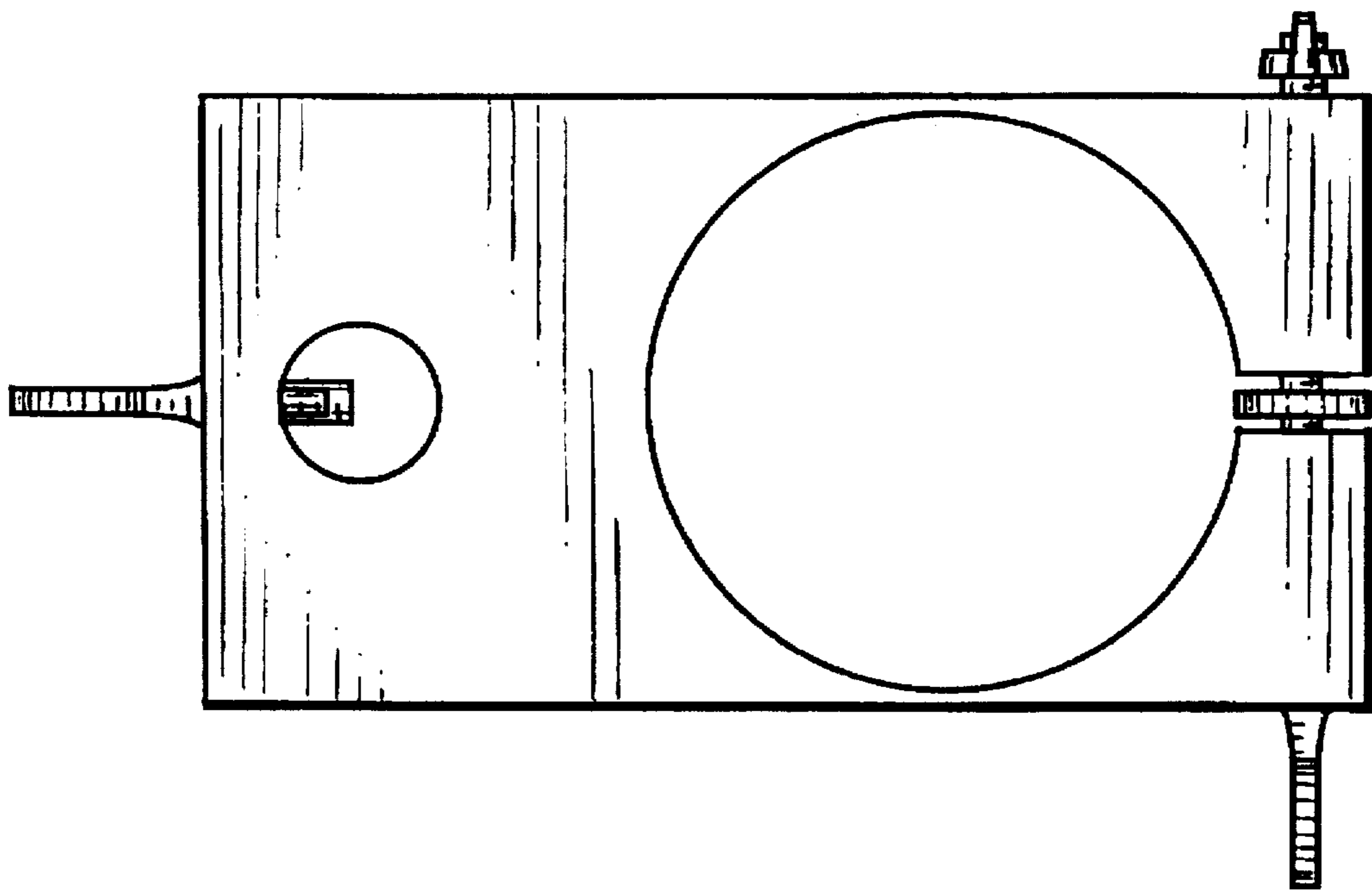

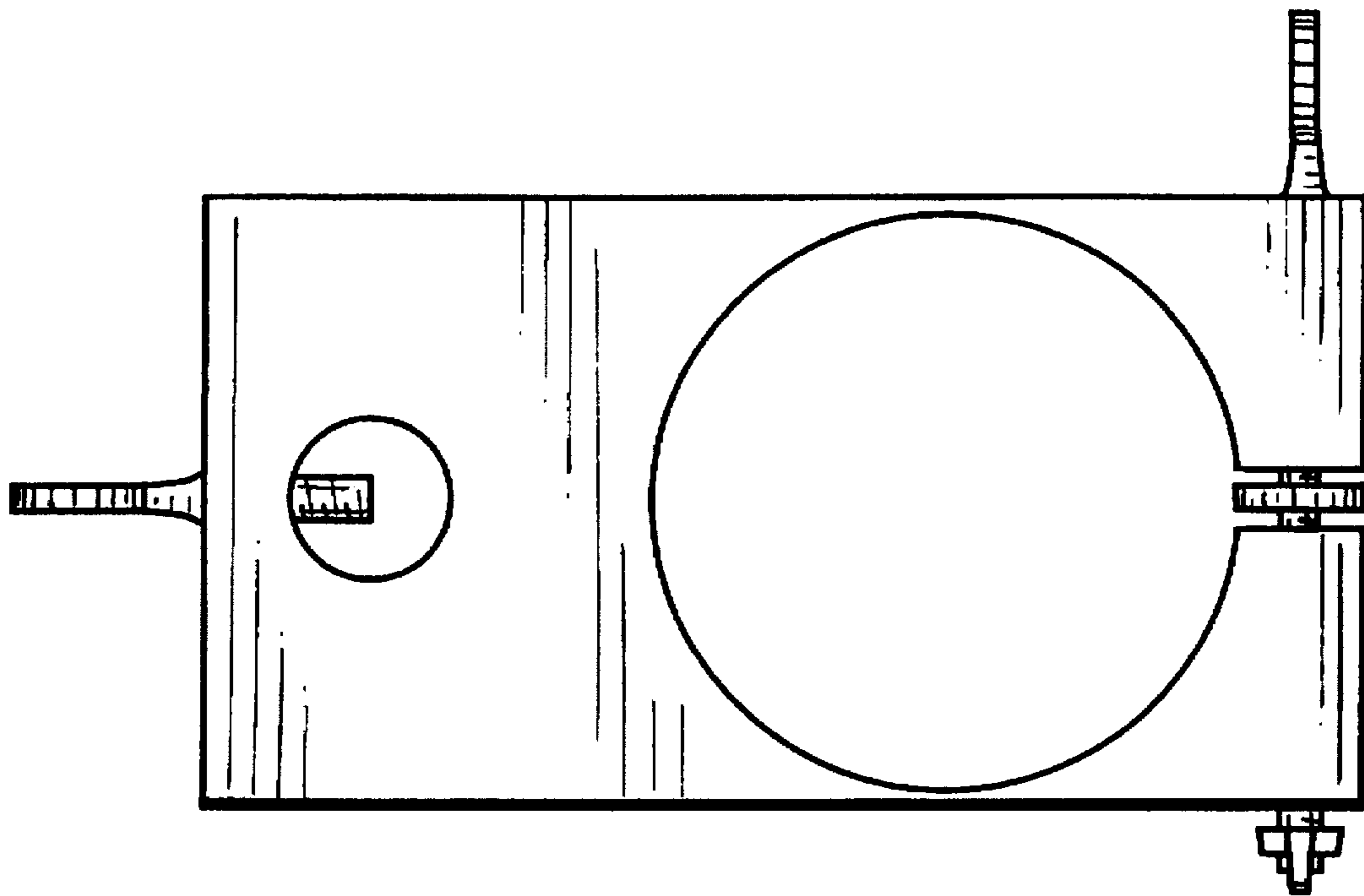

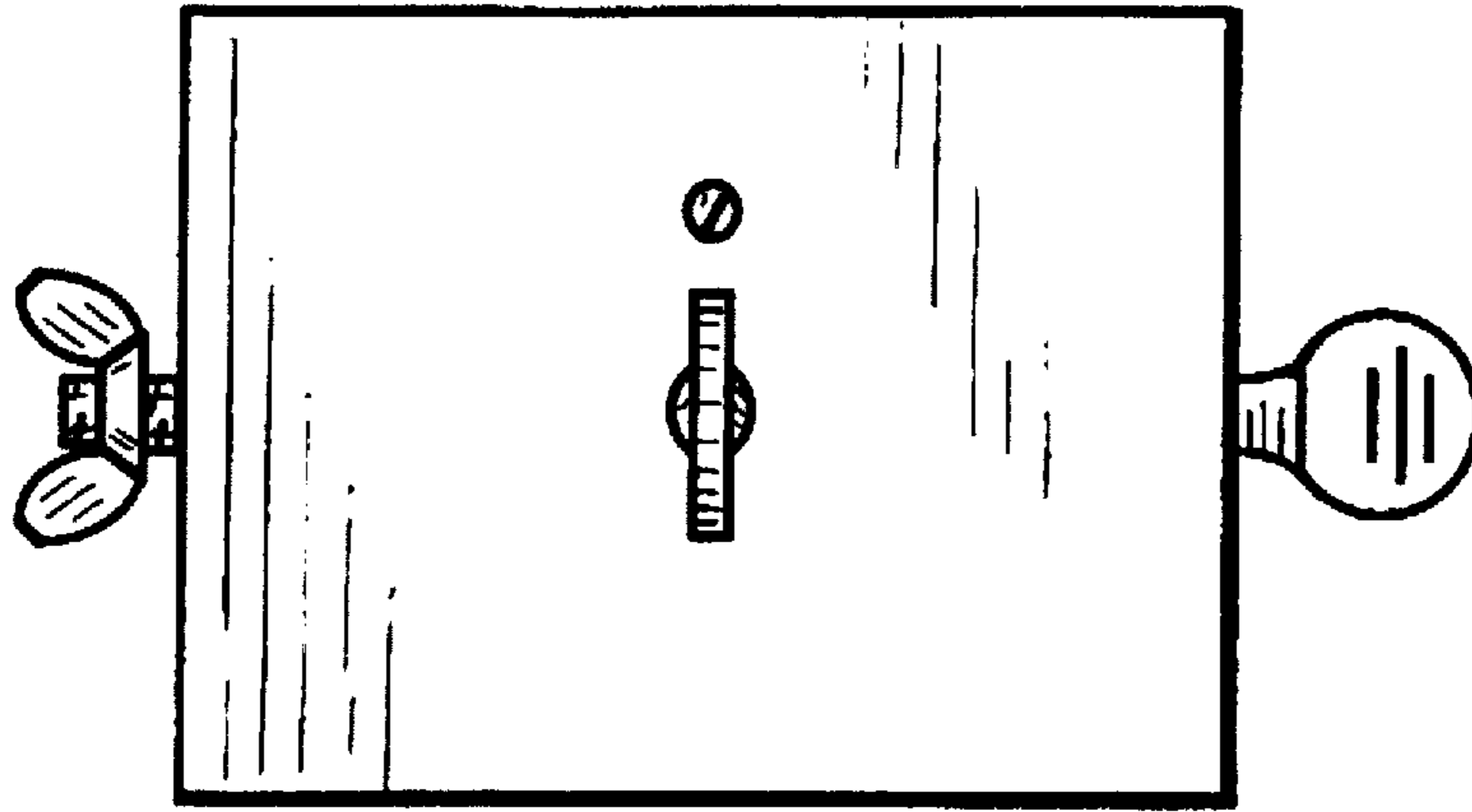

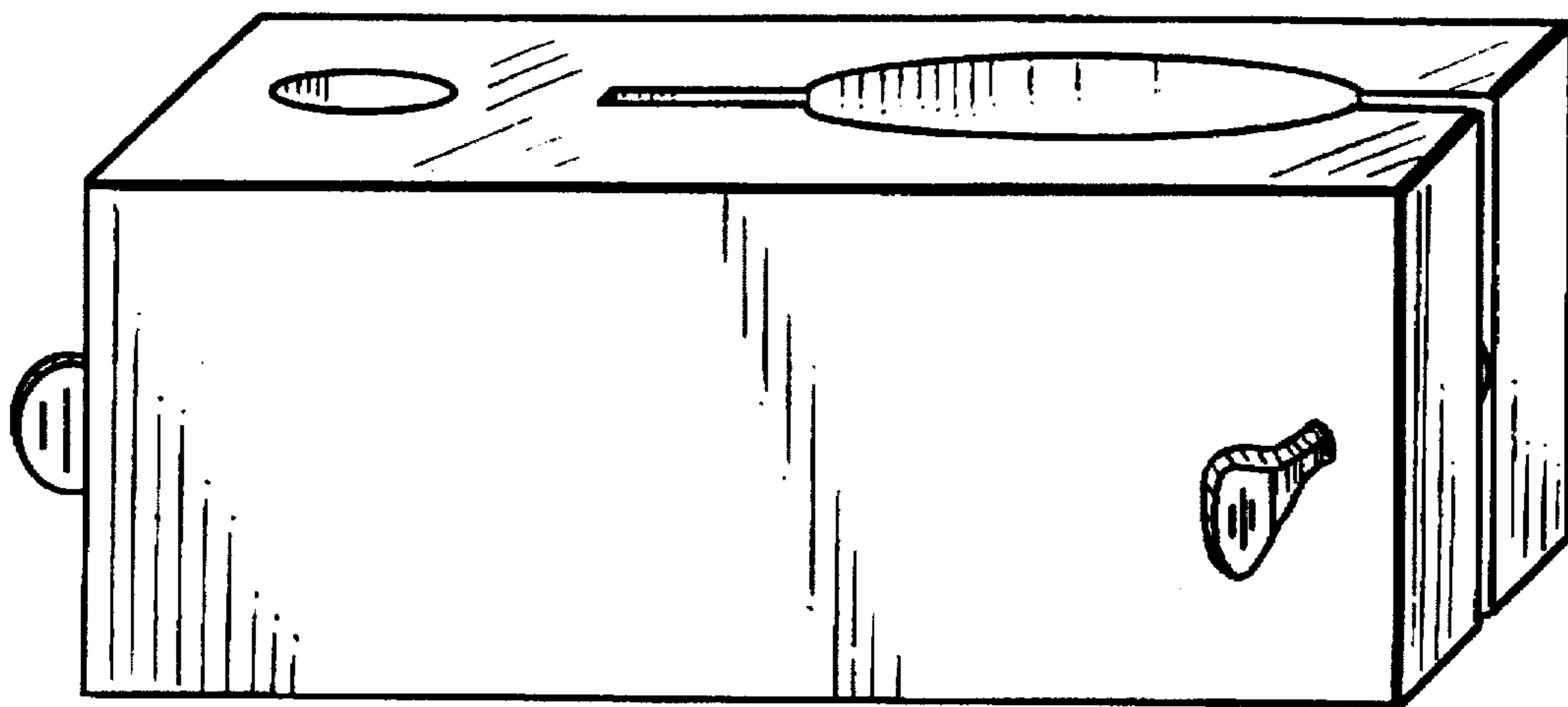

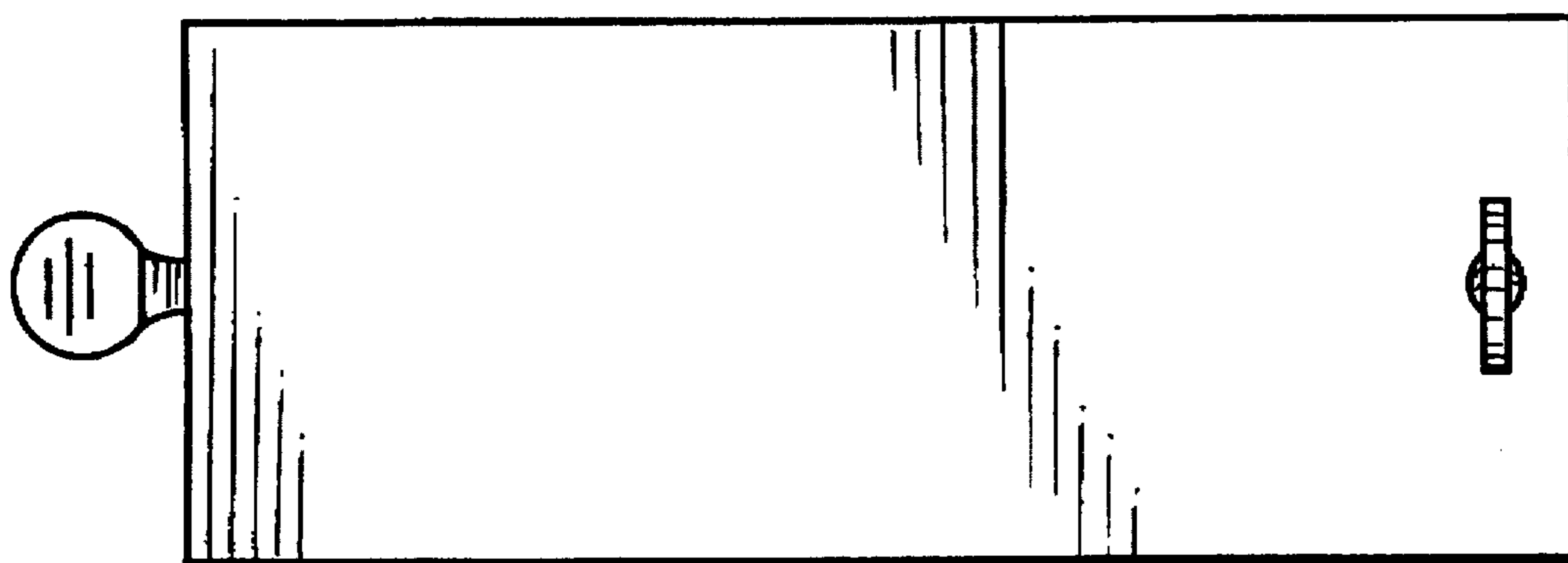

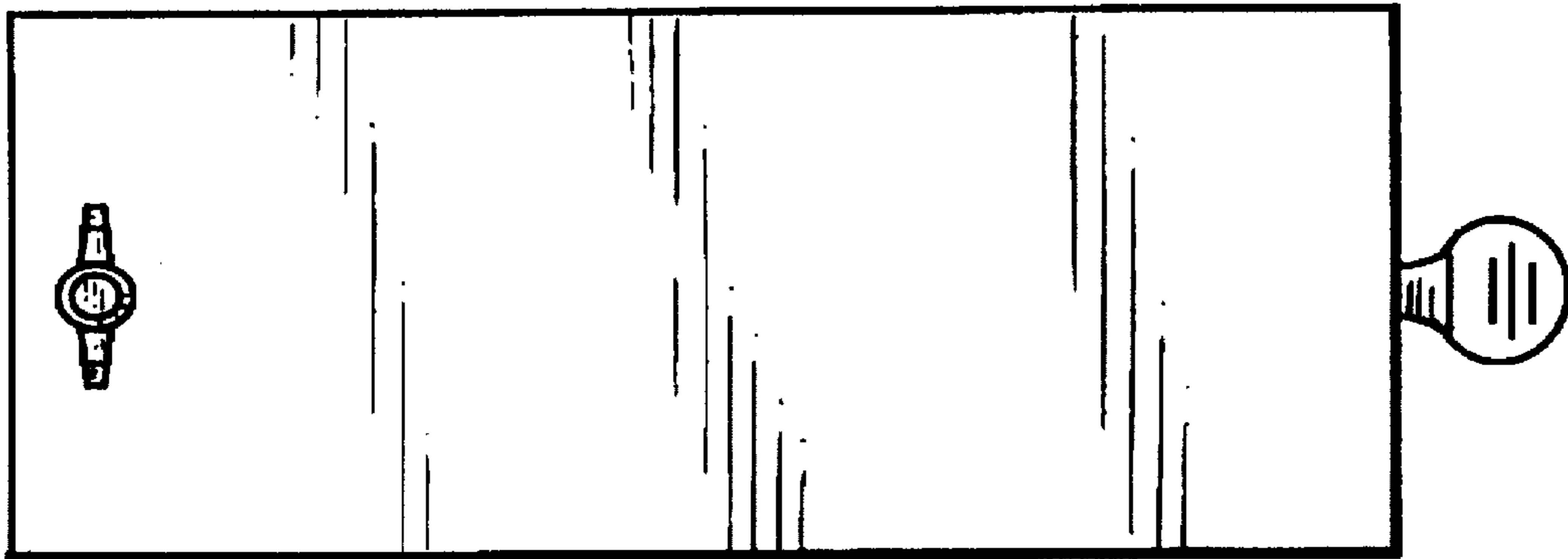

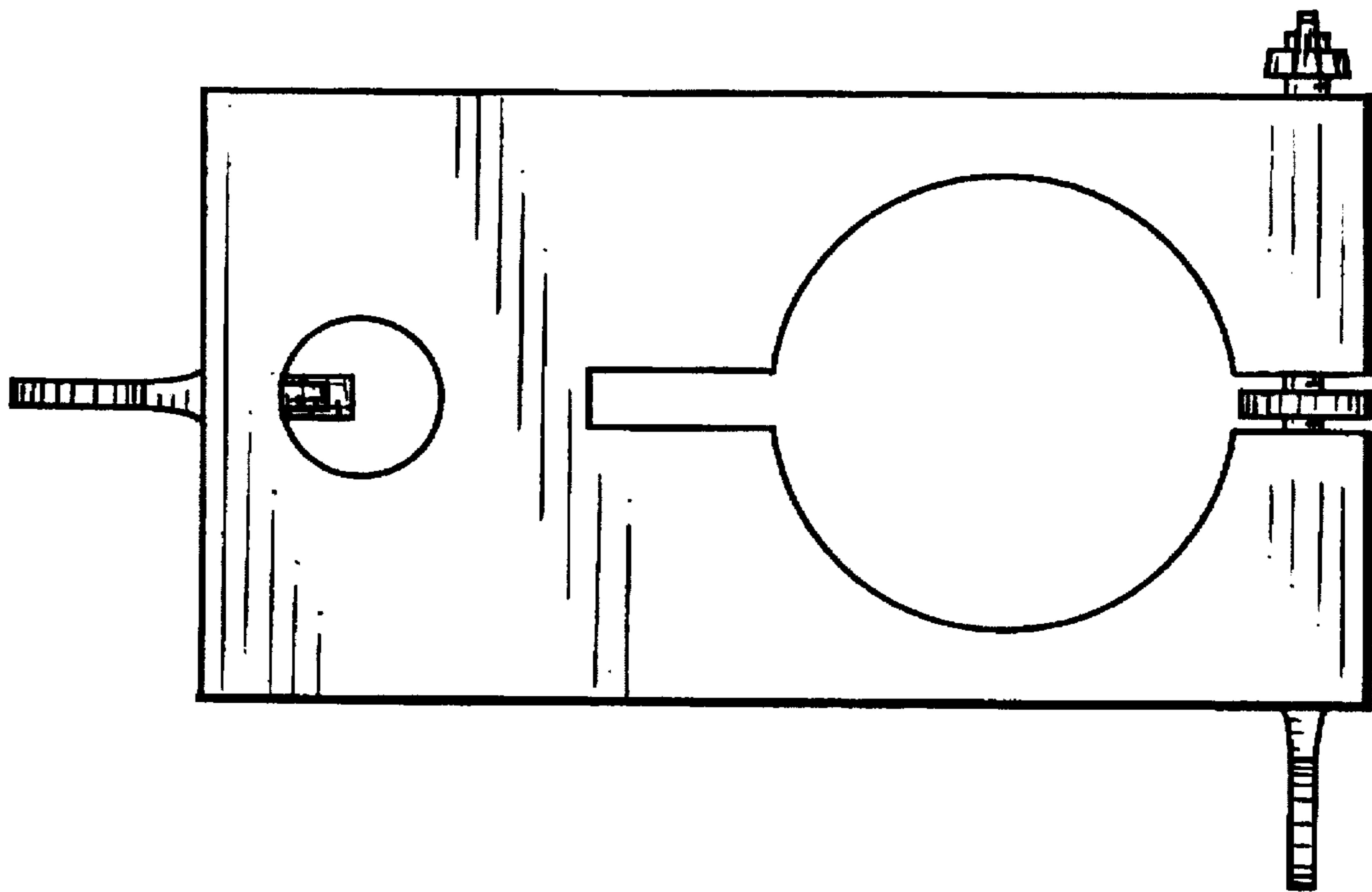

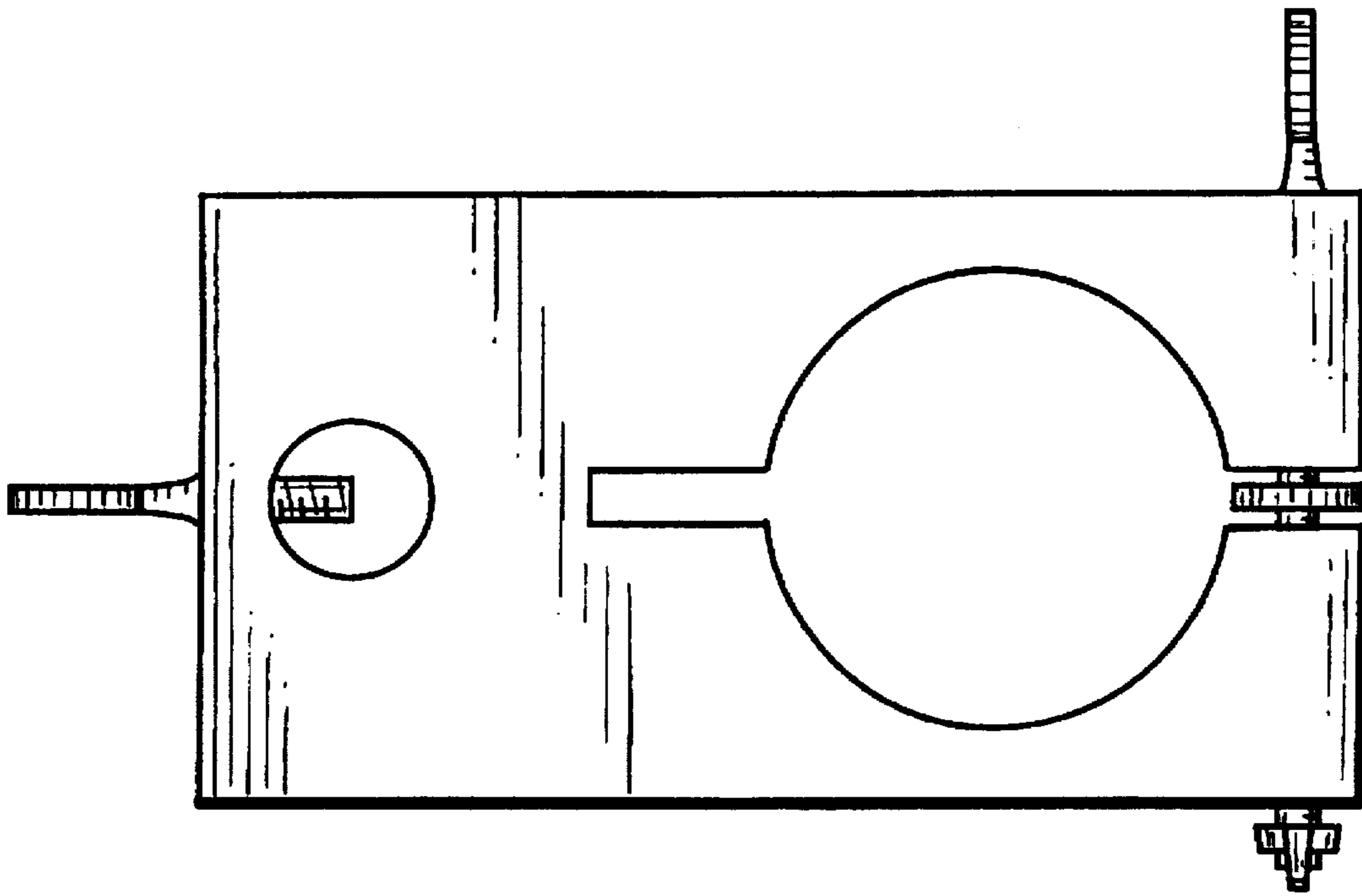

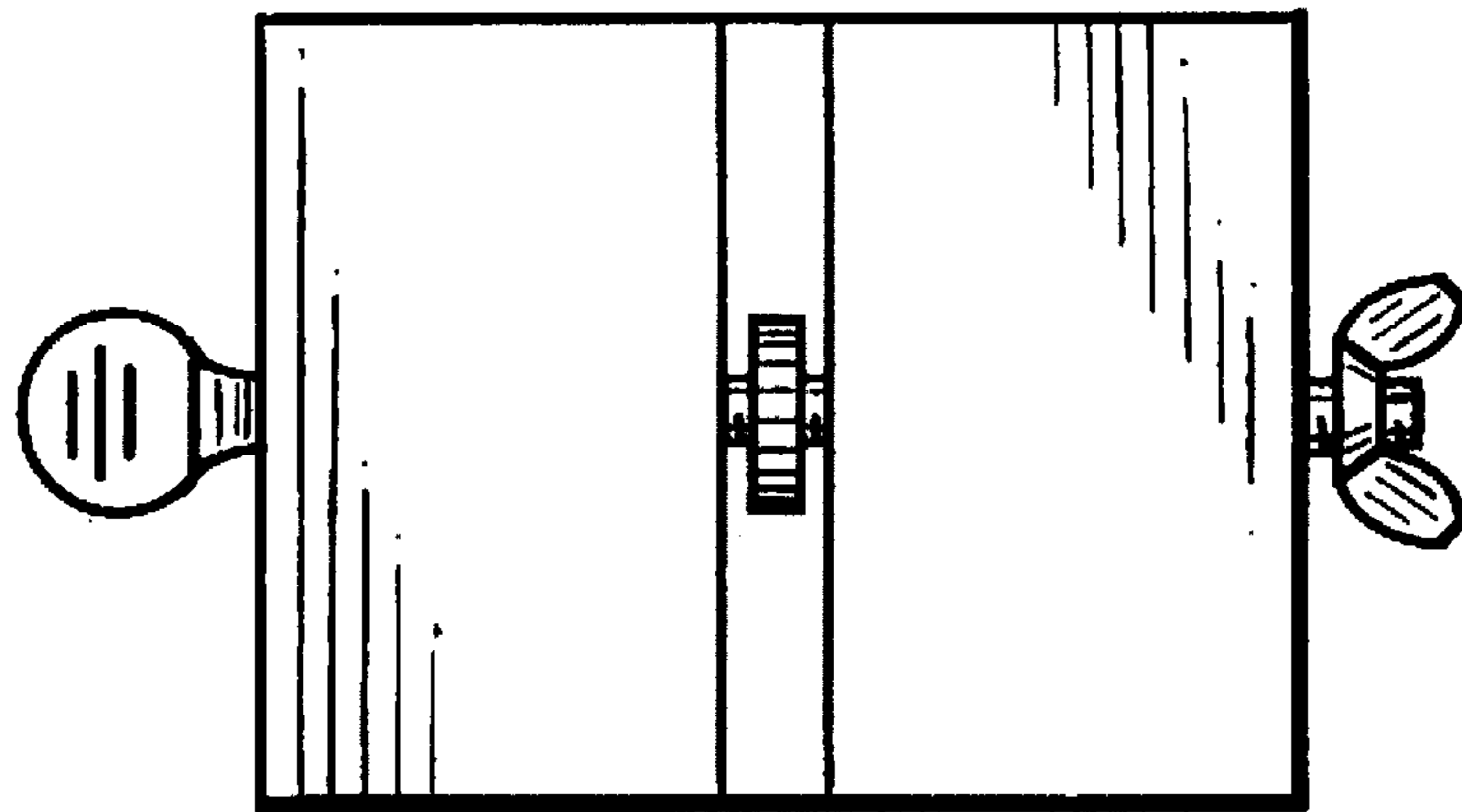

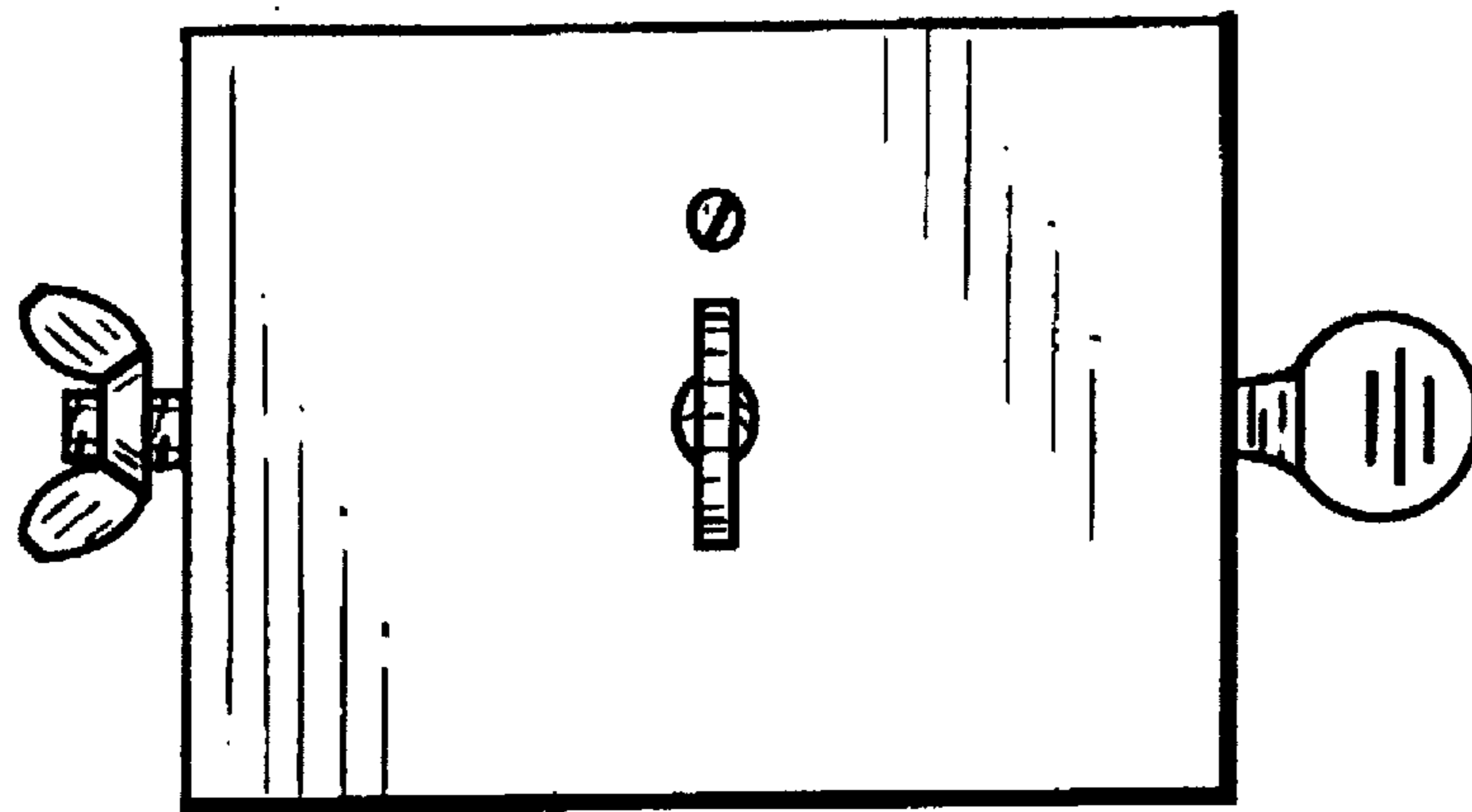
