DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a portable telephone handset showing our new design;
 FIG. 2 is a top plan view thereof;

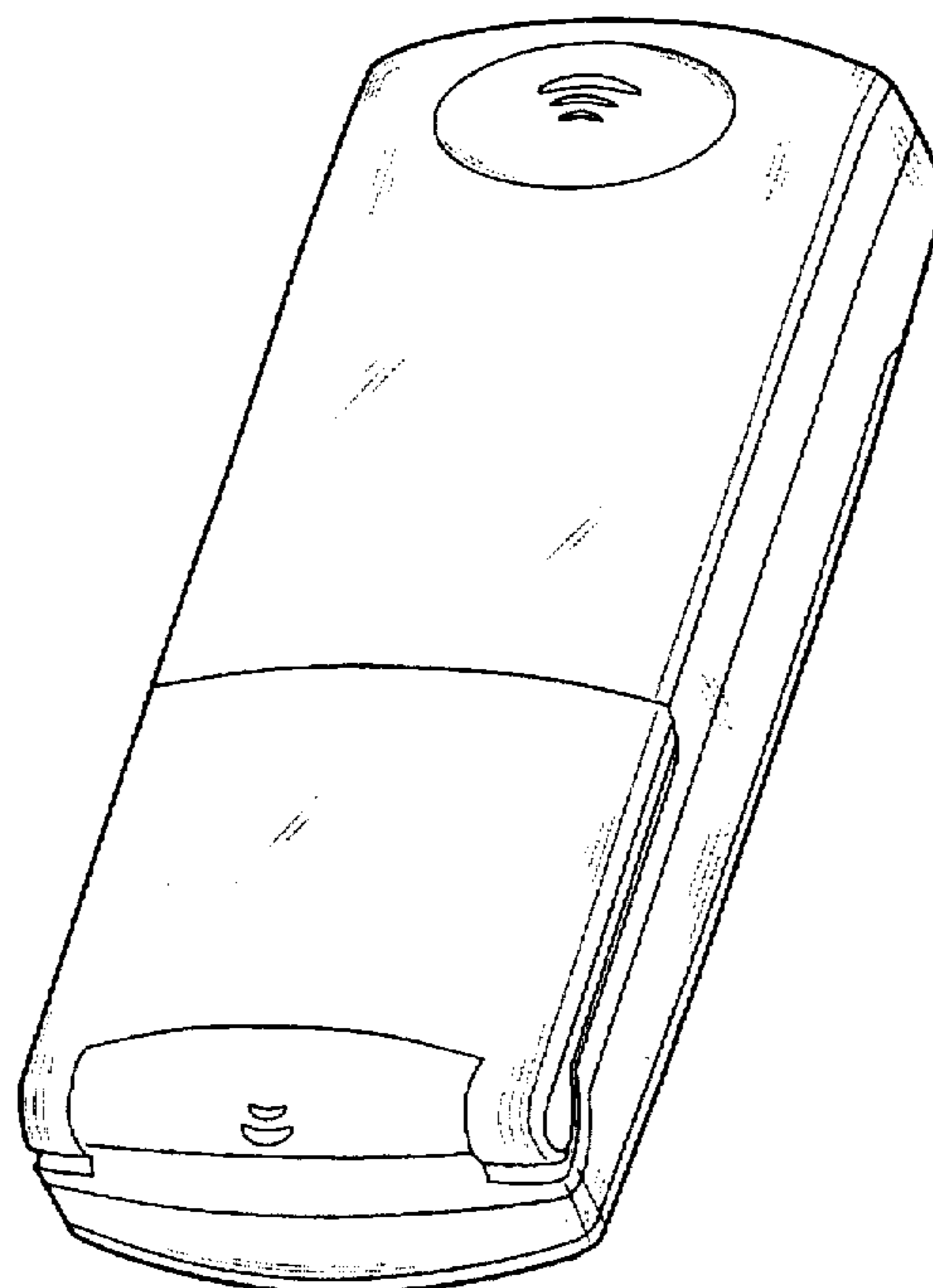

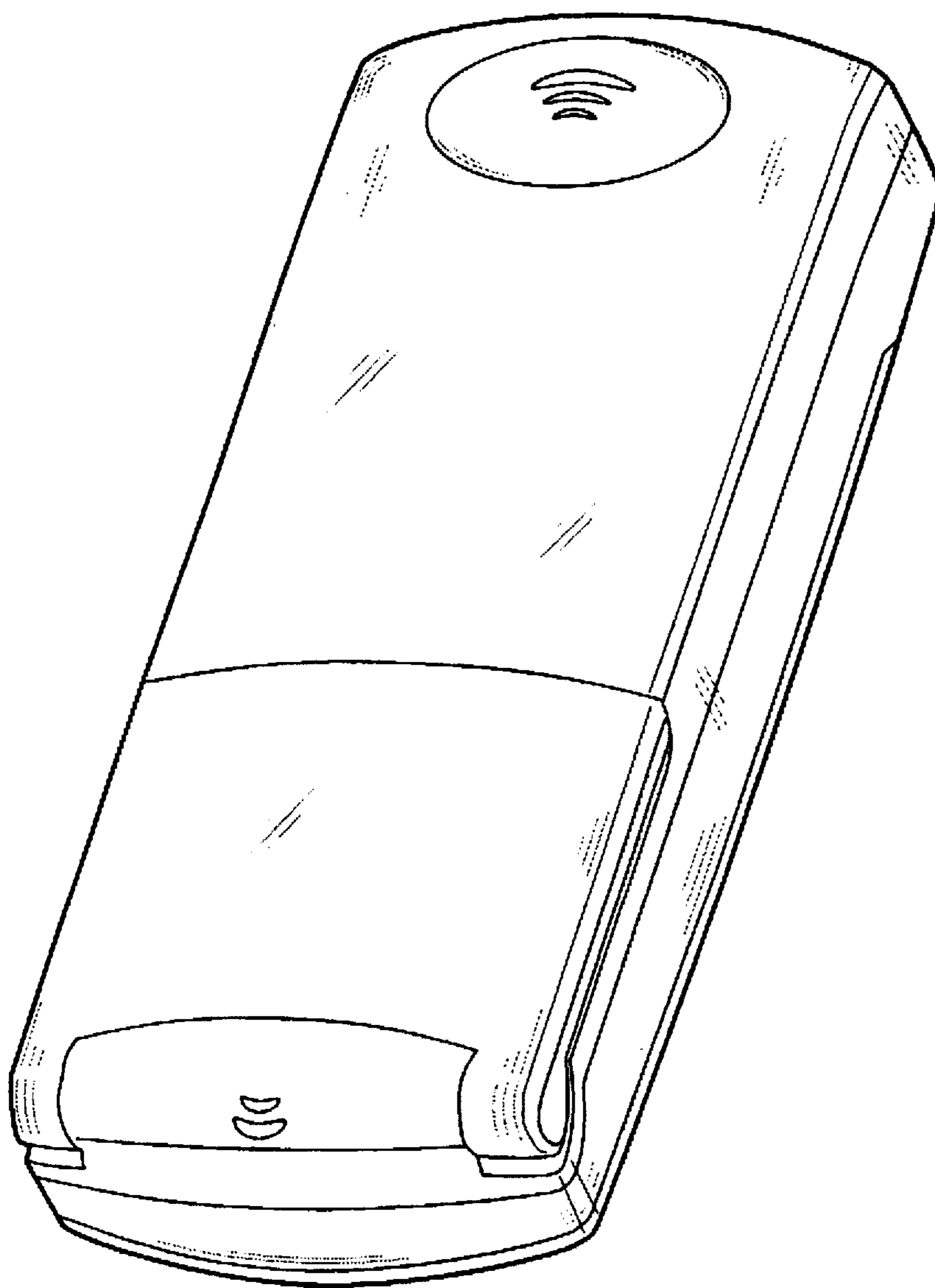

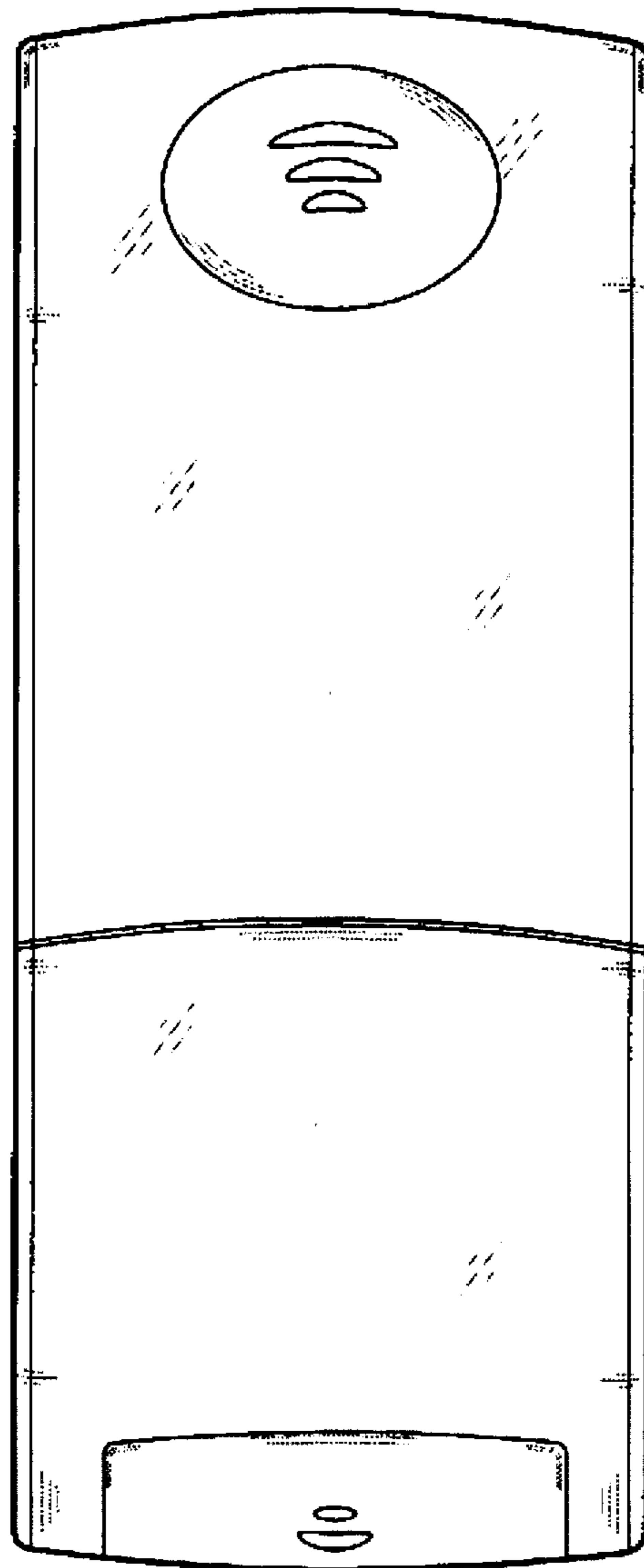

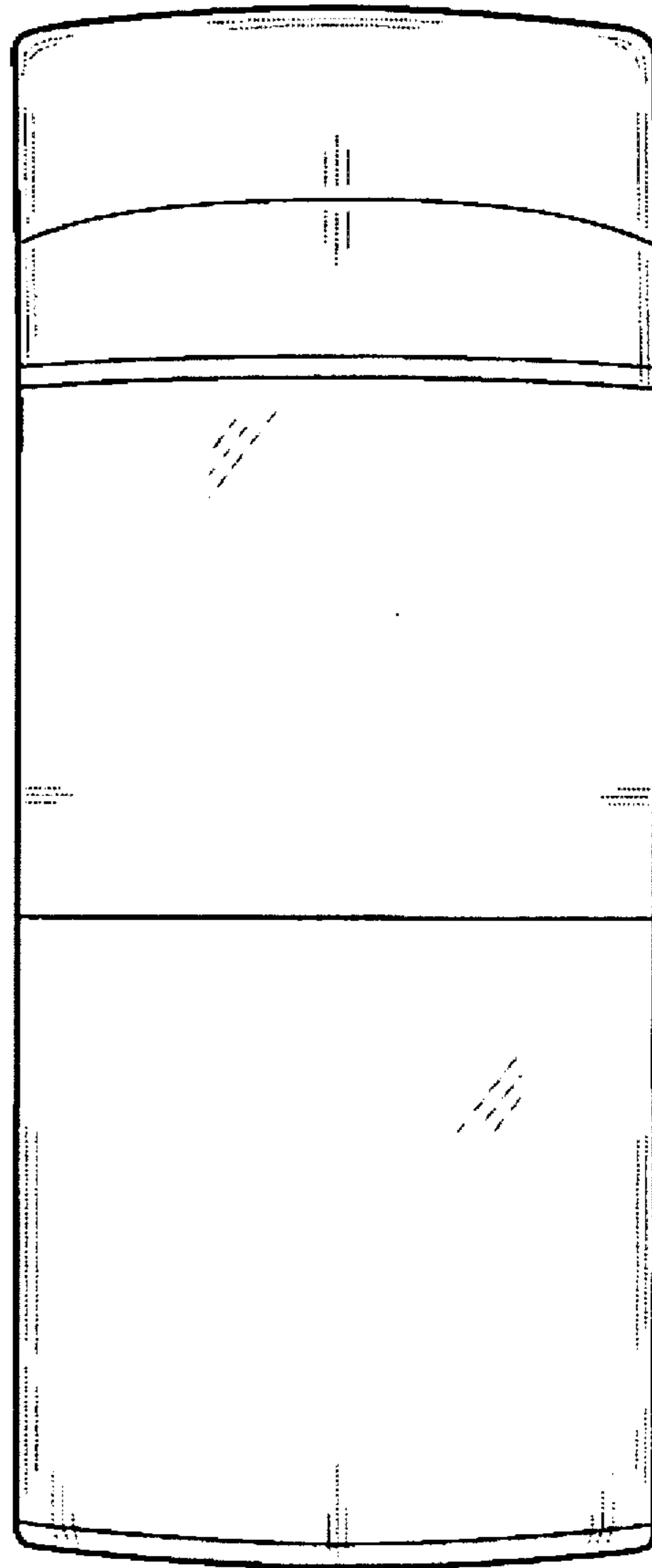

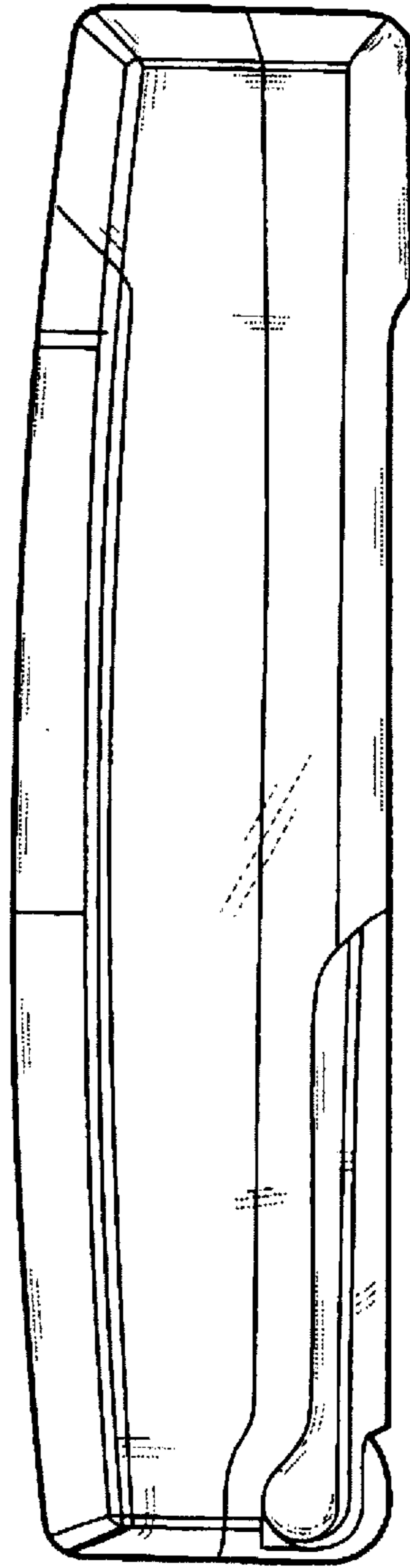

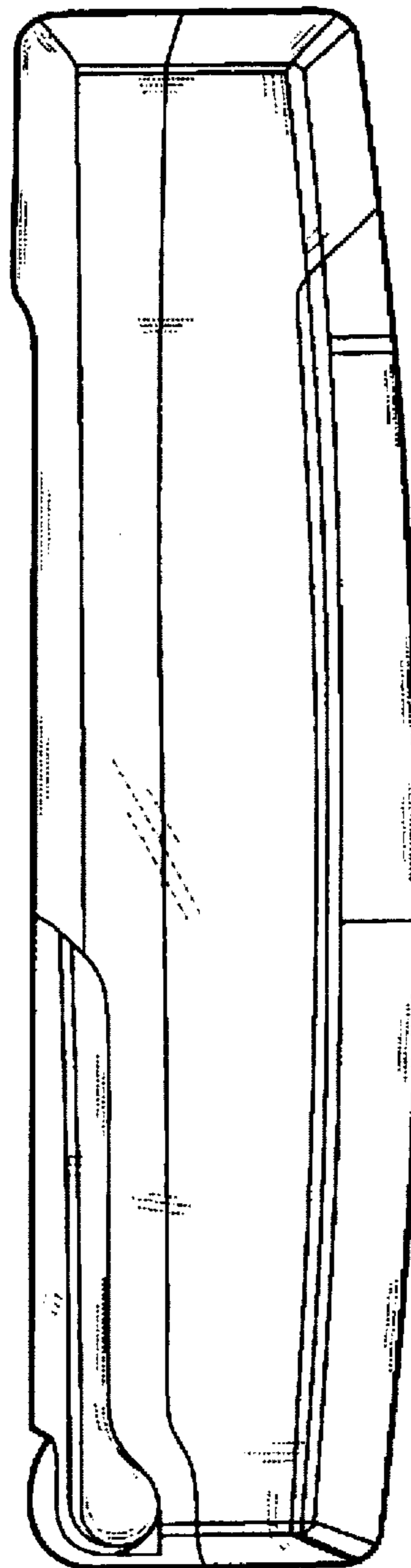

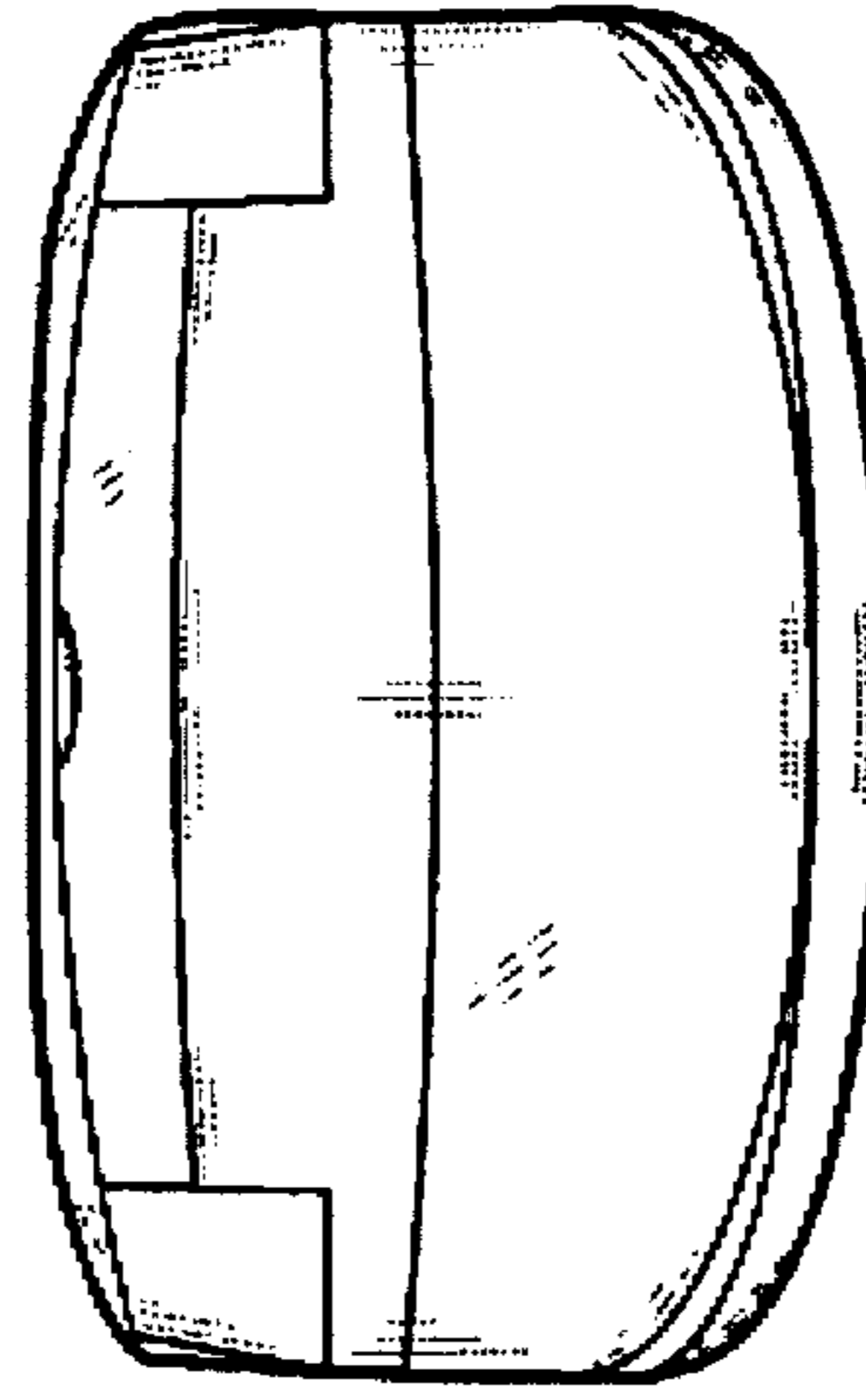
