DESCRIPTION

FIG. 1 is a top perspective view of a safety razor handle showing my new design;

FIG. 7 is a rear elevational view thereof; and,

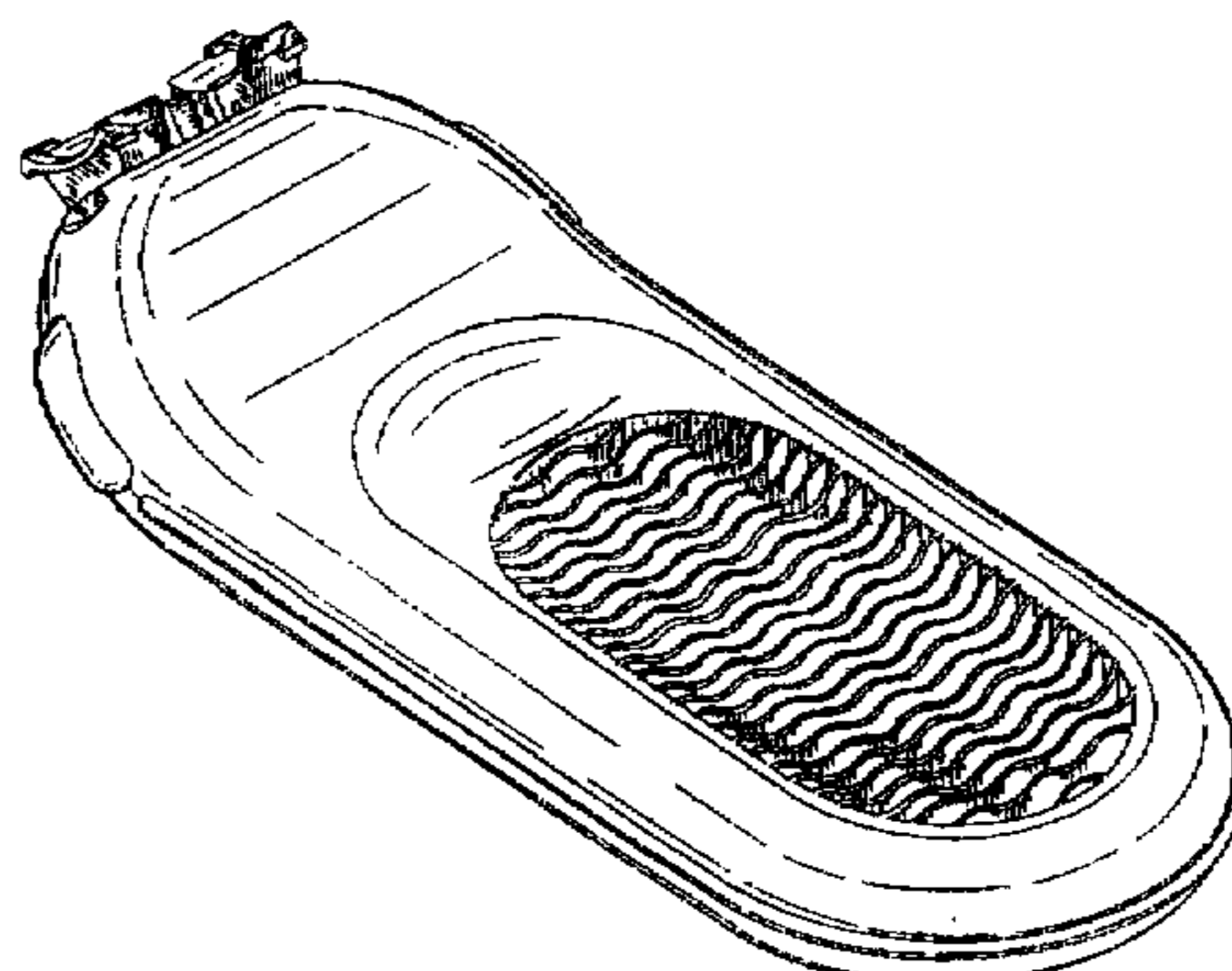
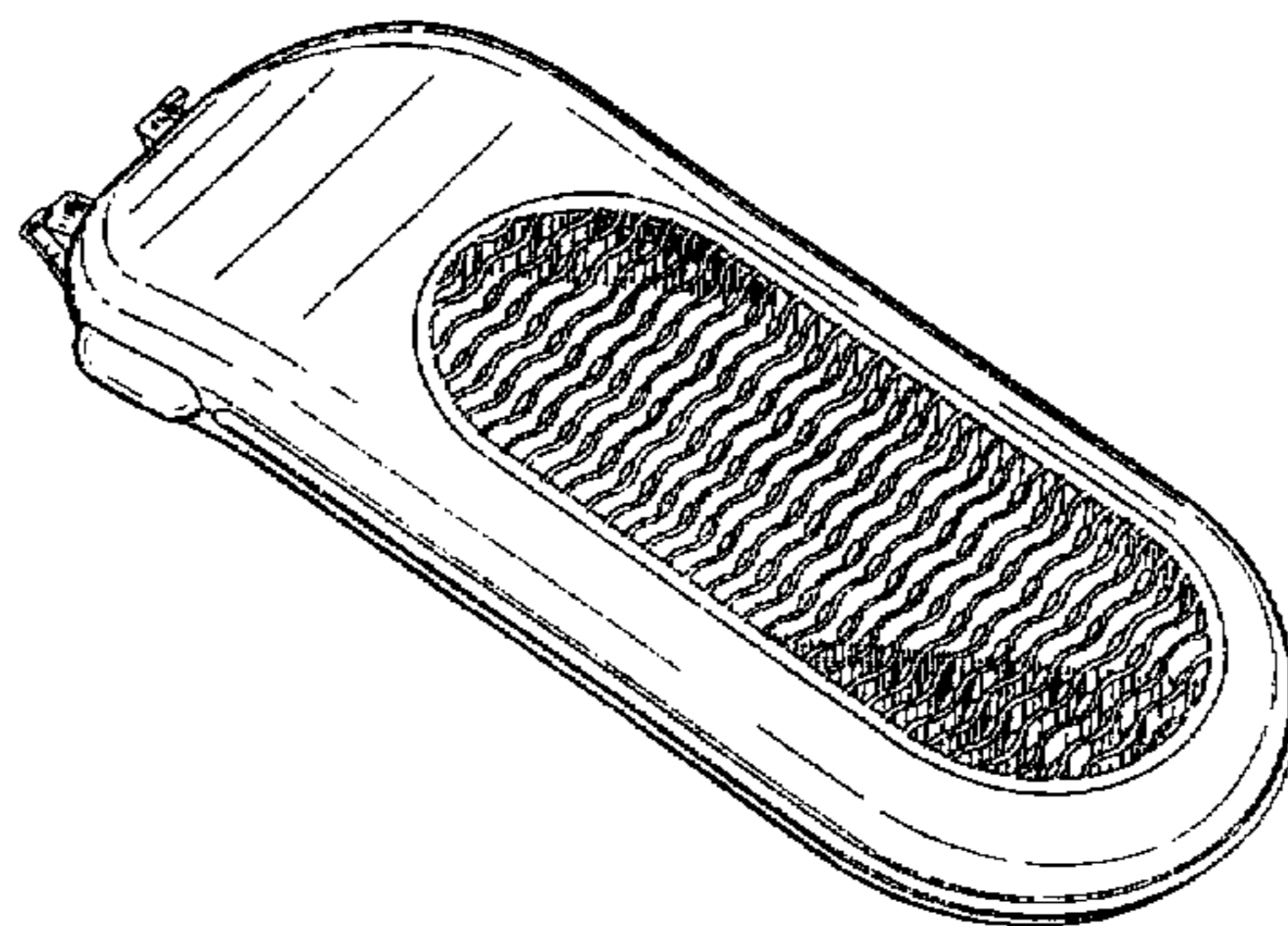
FIG. 8 is a left side elevational view similar to FIG. 4 having portions thereof removed to the longitudinal centerline to show top and bottom surface details;

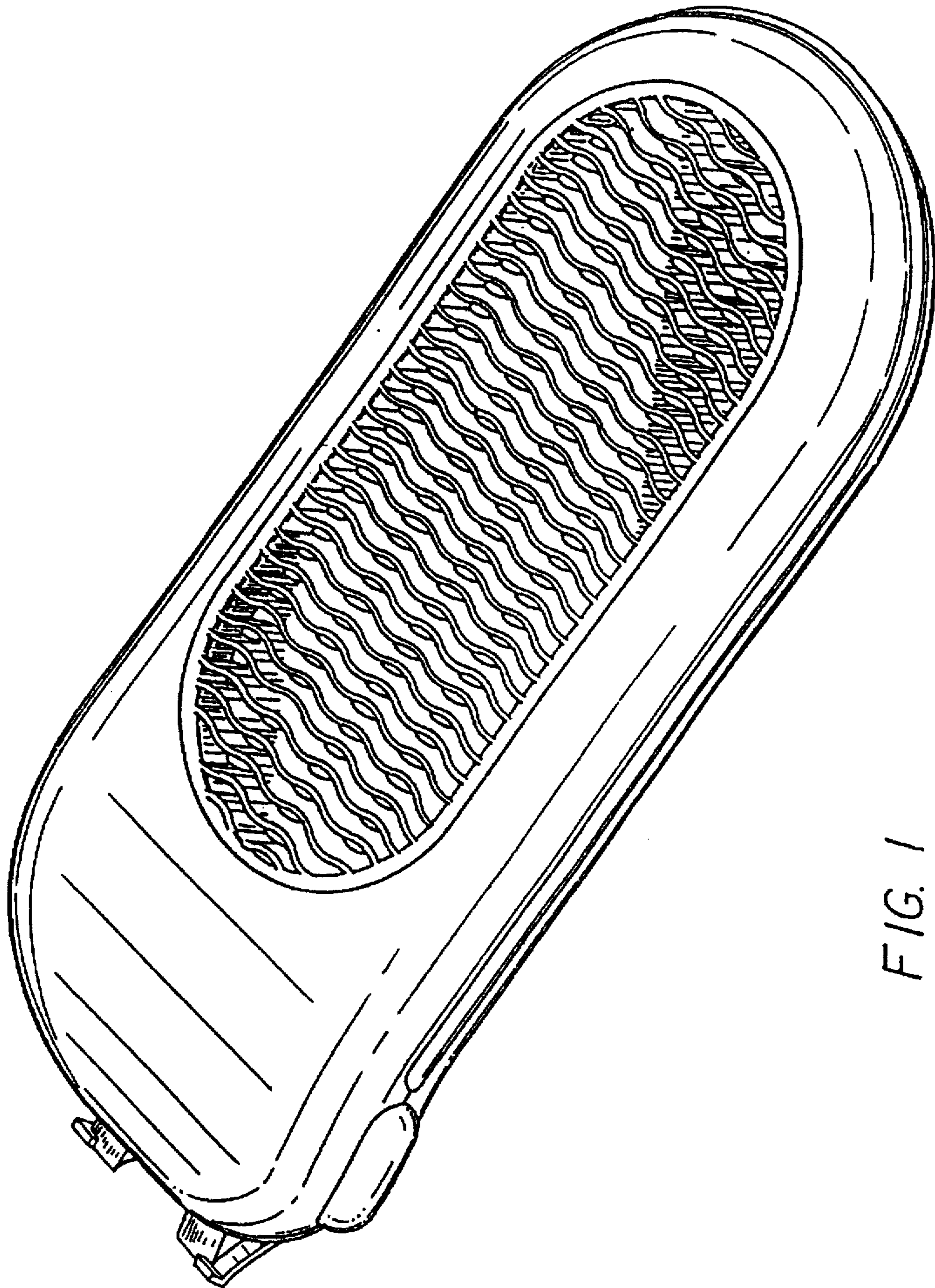

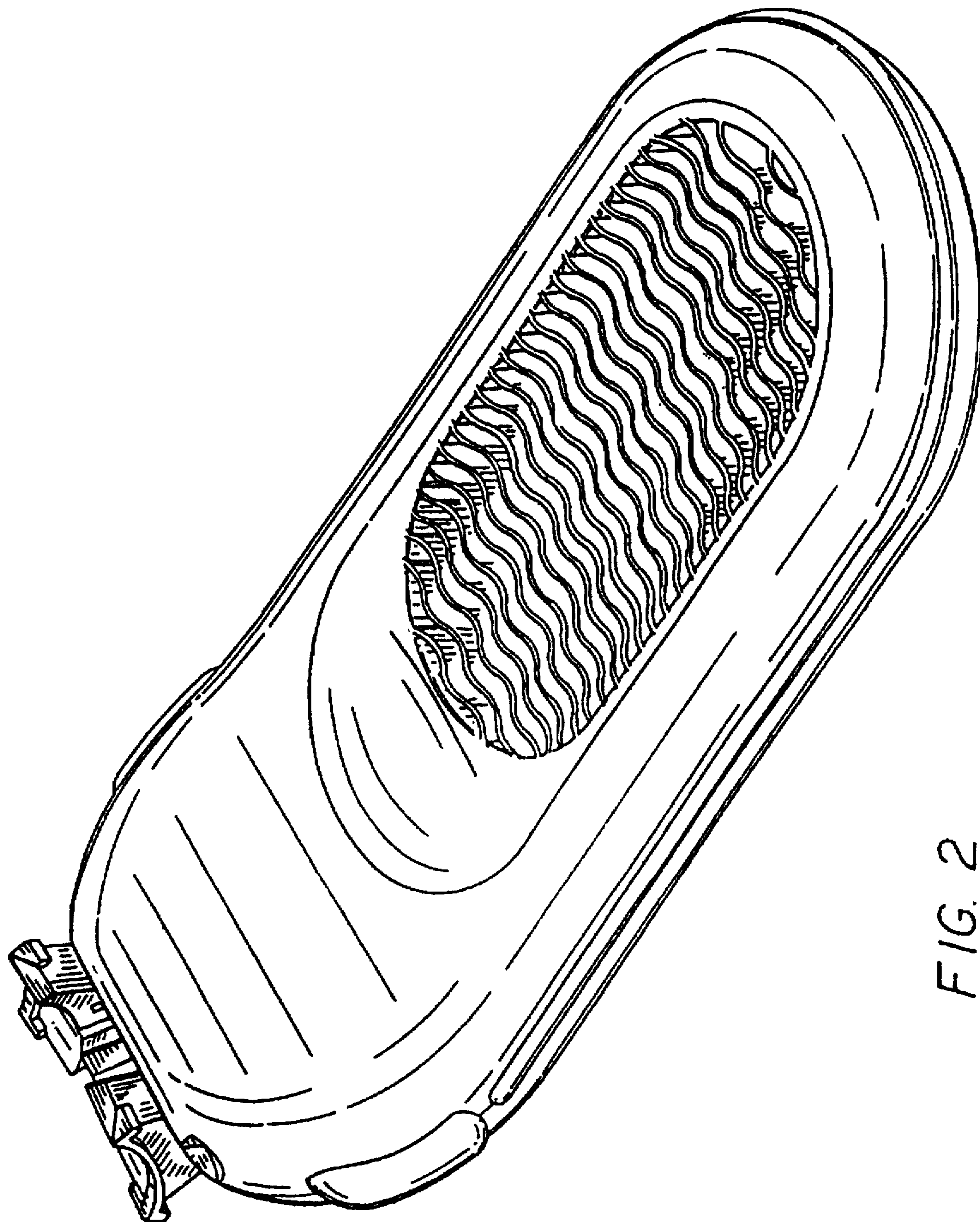

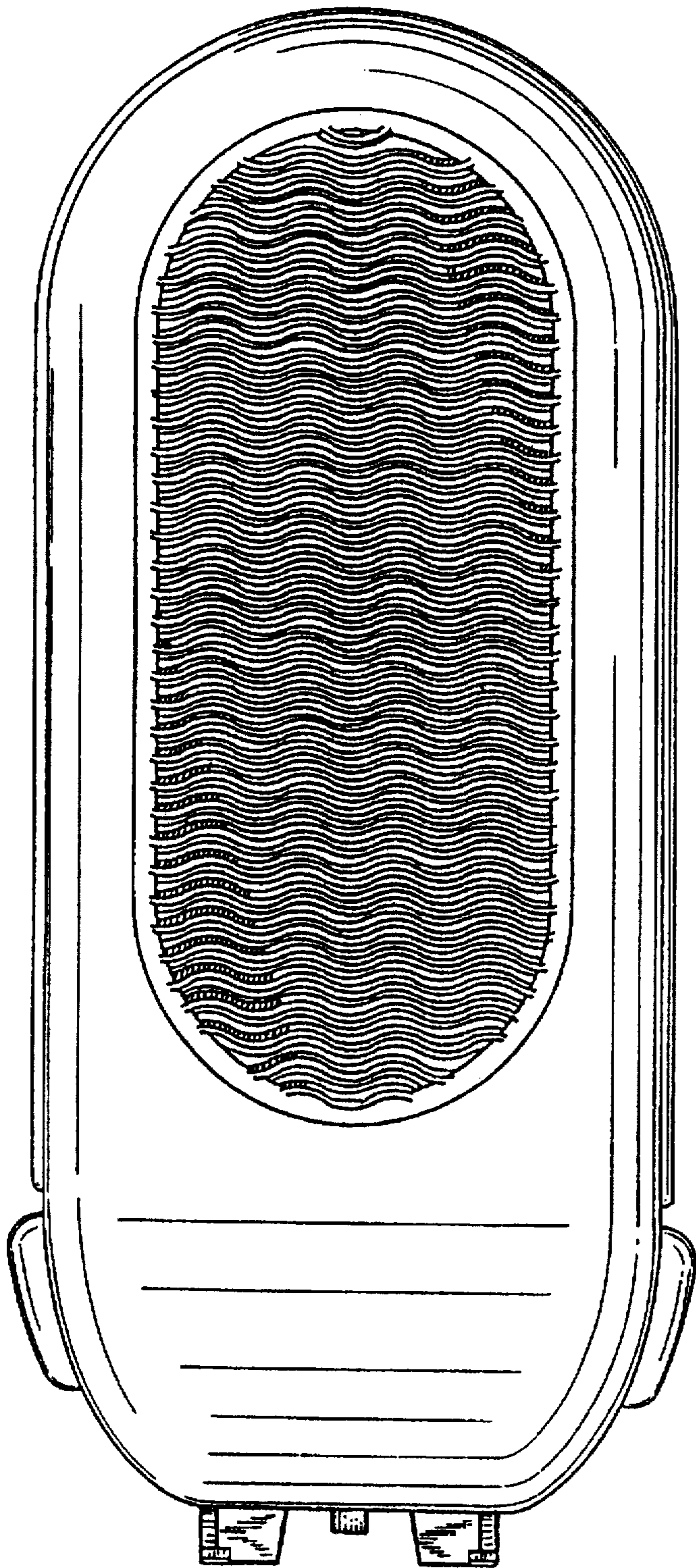

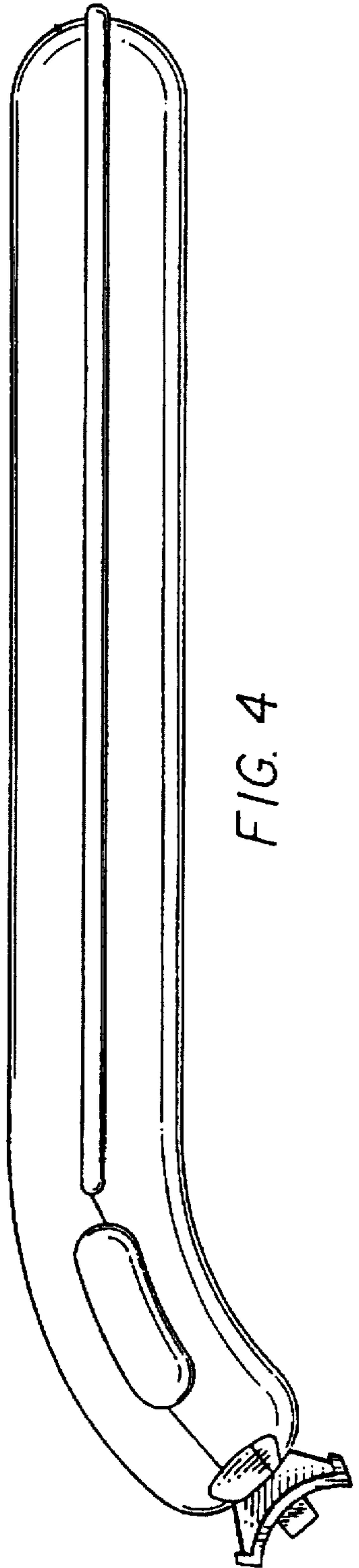

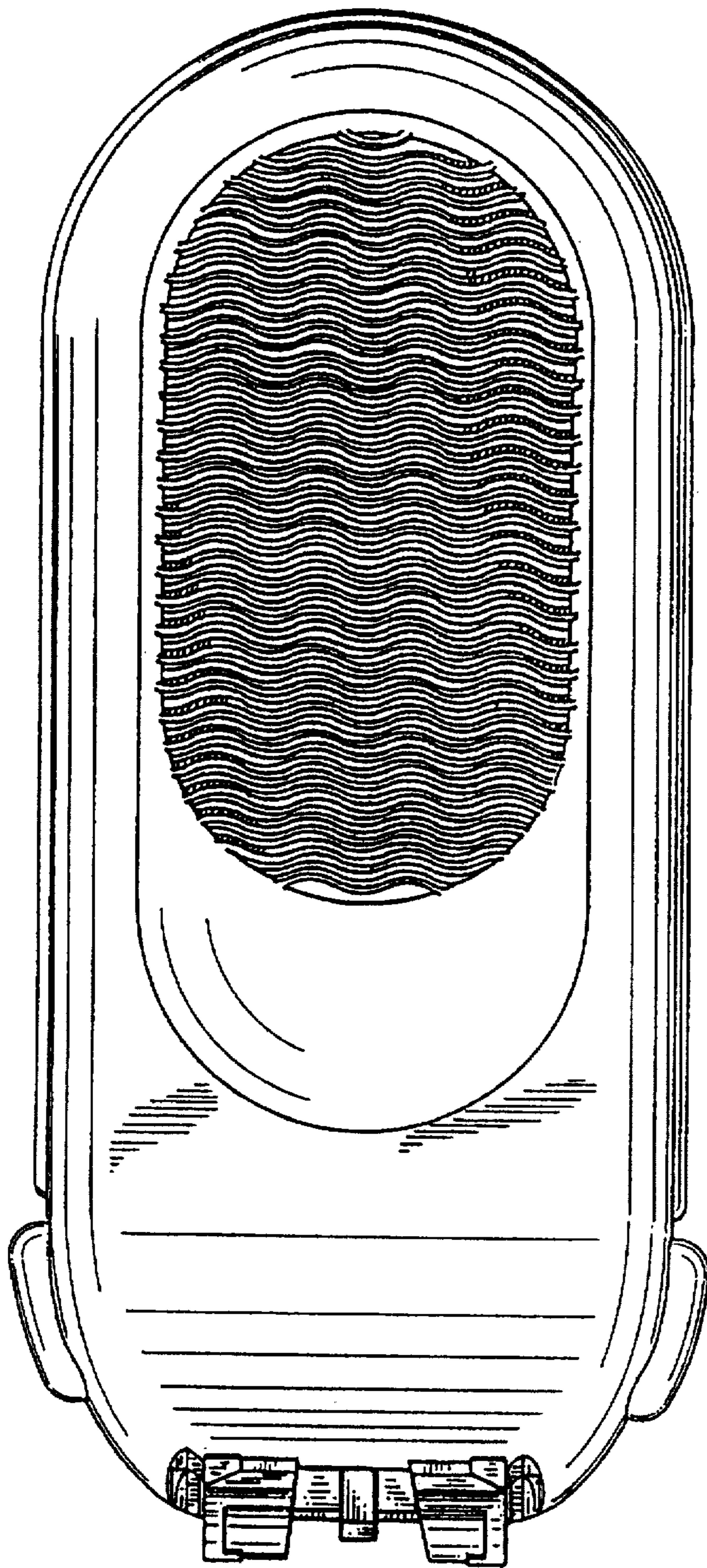

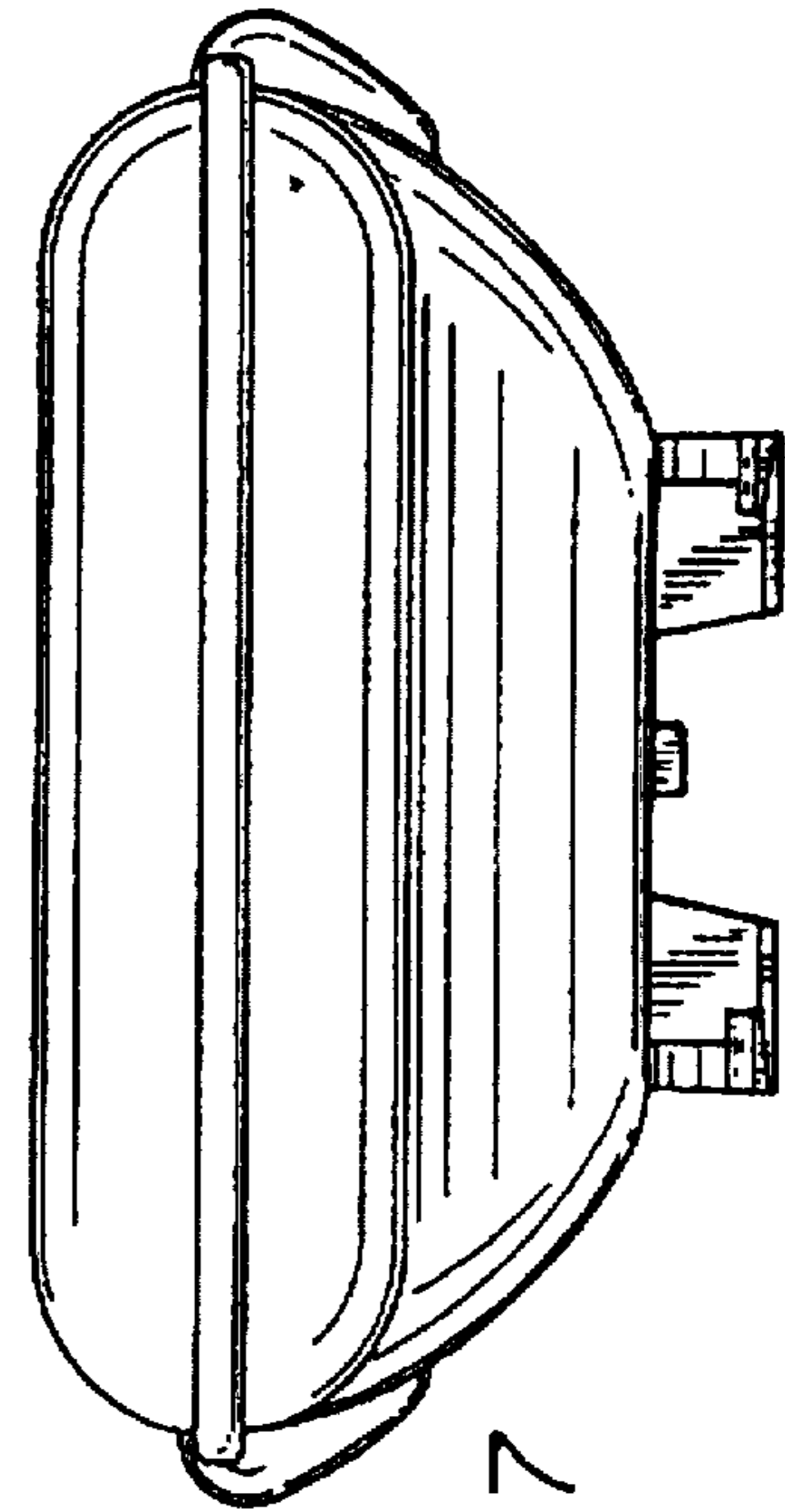

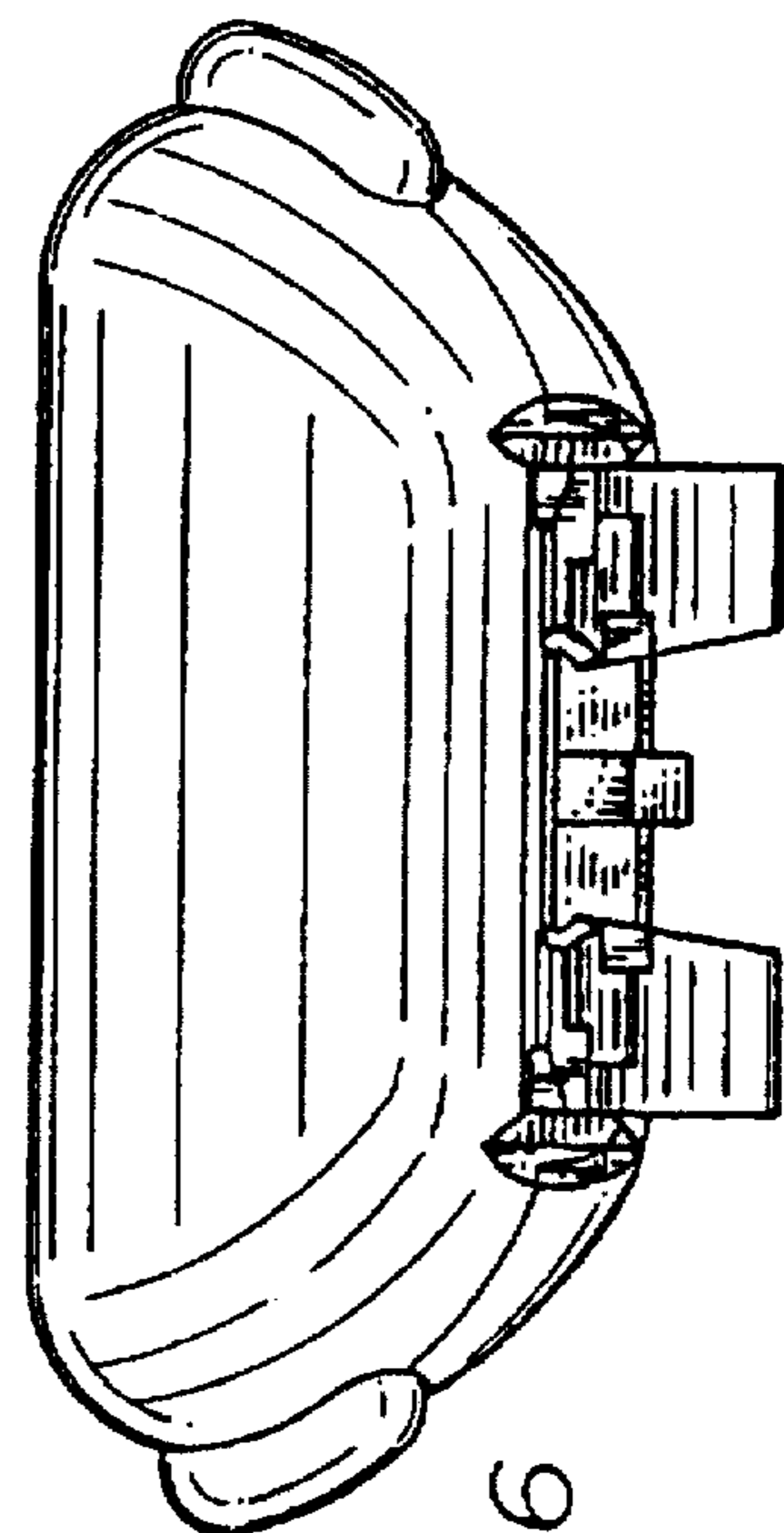

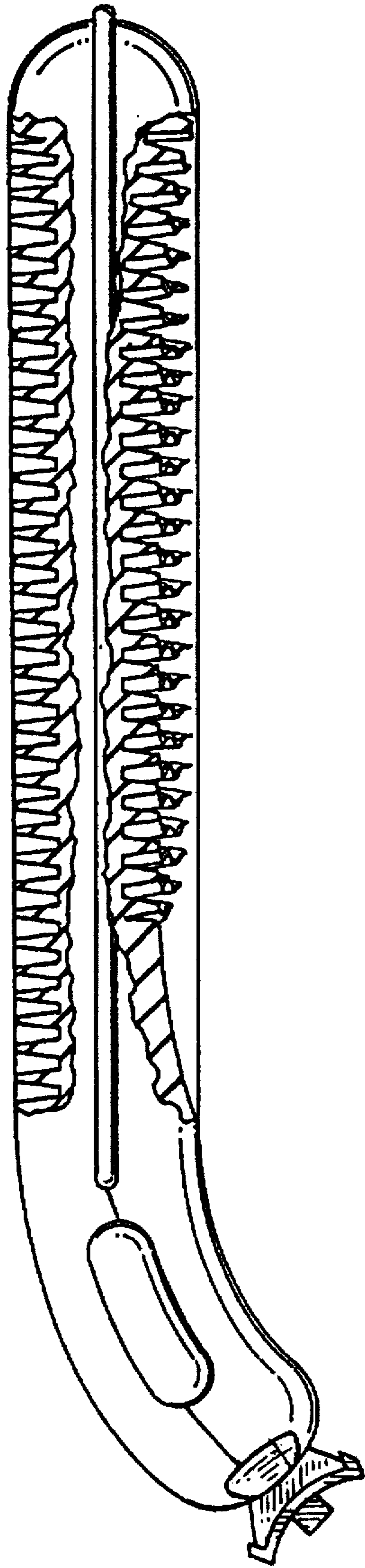
