[57] **CLAIM**

The ornamental design for a bow holder with removable cover, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a bow holder with removable

cover showing my new design, in a position of use, with the cover removed for convenience of illustration;

FIG. 2 is a right side view thereof;

FIG. 3 is a top view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a rear view thereof;

FIG. 6 is a left side view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a right side view of the removable cover, shown removed from the bow holder for convenience of illustration;

FIG. 9 is a bottom view thereof;

FIG. 10 is a front view thereof;

FIG. 11 is a rear view thereof;

FIG. 12 is a left side view thereof;


FIG. 13 is a top view thereof;

FIG. 14 is another perspective view of the bow holder shown hanging from a saddle horn, with the cover removed for convenience of illustration; and,






















