[57] **CLAIM**

The ornamental design for a magnet optical disc recorder/player, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the magnet optical disc recorder/player including my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a rear elevational view thereof;

FIG. 8 is a rear perspective view of the magnet optical disc recorder/player wherein the stand thereof is in the open position;

FIG. 9 is a perspective view thereof (the hand and paper portions are shown in broken lines for illustrative purposes only and forms no part of the claimed invention);

FIG. 10 is a perspective view of another embodiment of the magnet optical disc recorder/player;

FIG. 11 is a top plan view of the embodiment of FIG. 10;

FIG. 12 is a left side elevational view of the embodiment of FIG. 10;

FIG. 13 is a front elevational view of the embodiment of FIG. 10;

FIG. 14 is a right side elevational view of the embodiment of FIG. 10; and,

FIG. 15 is a rear elevational view of the embodiment of FIG. 10.

The bottom plan view of the embodiment of FIG. 10 is shown in FIG. 5.

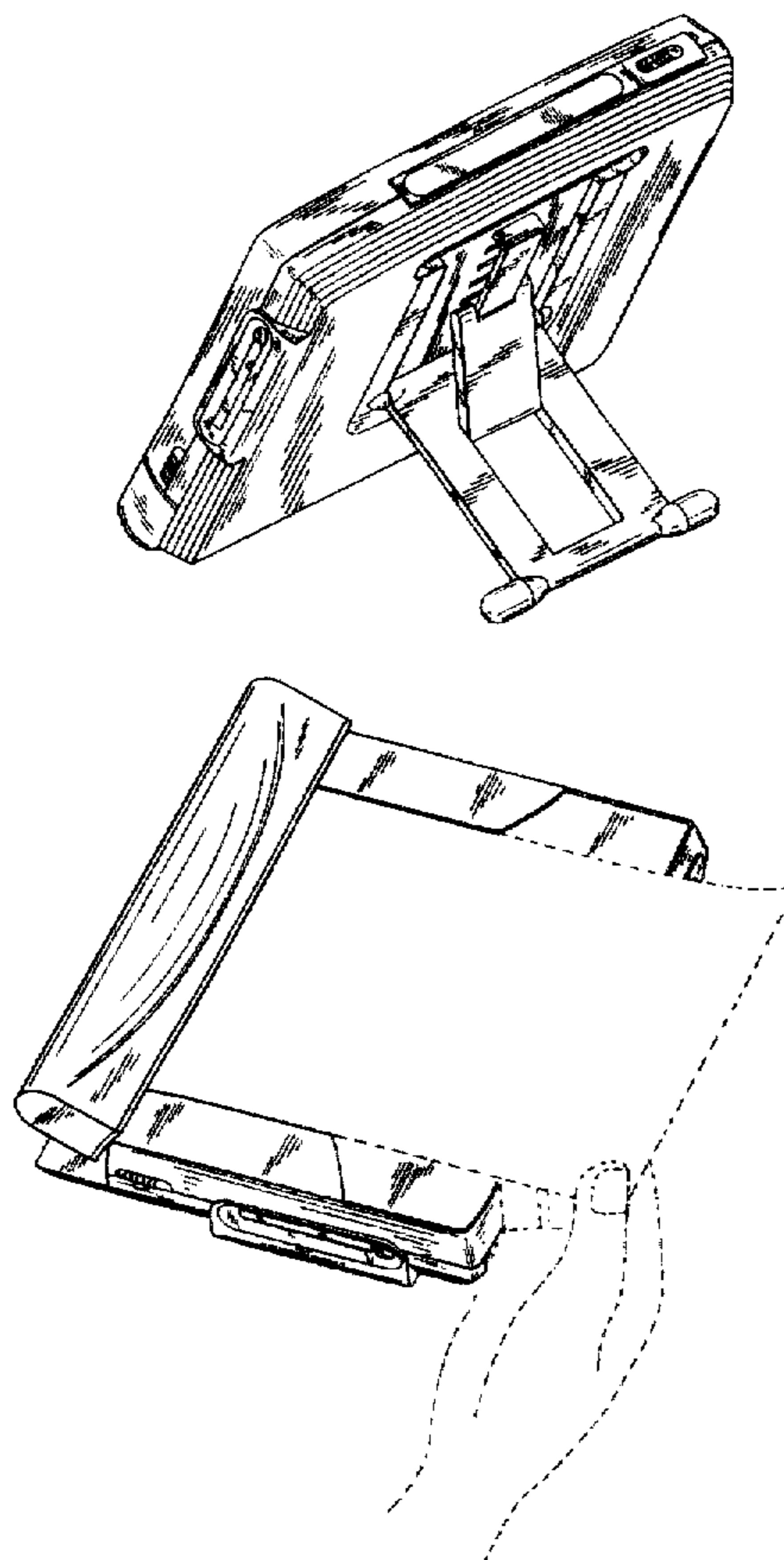

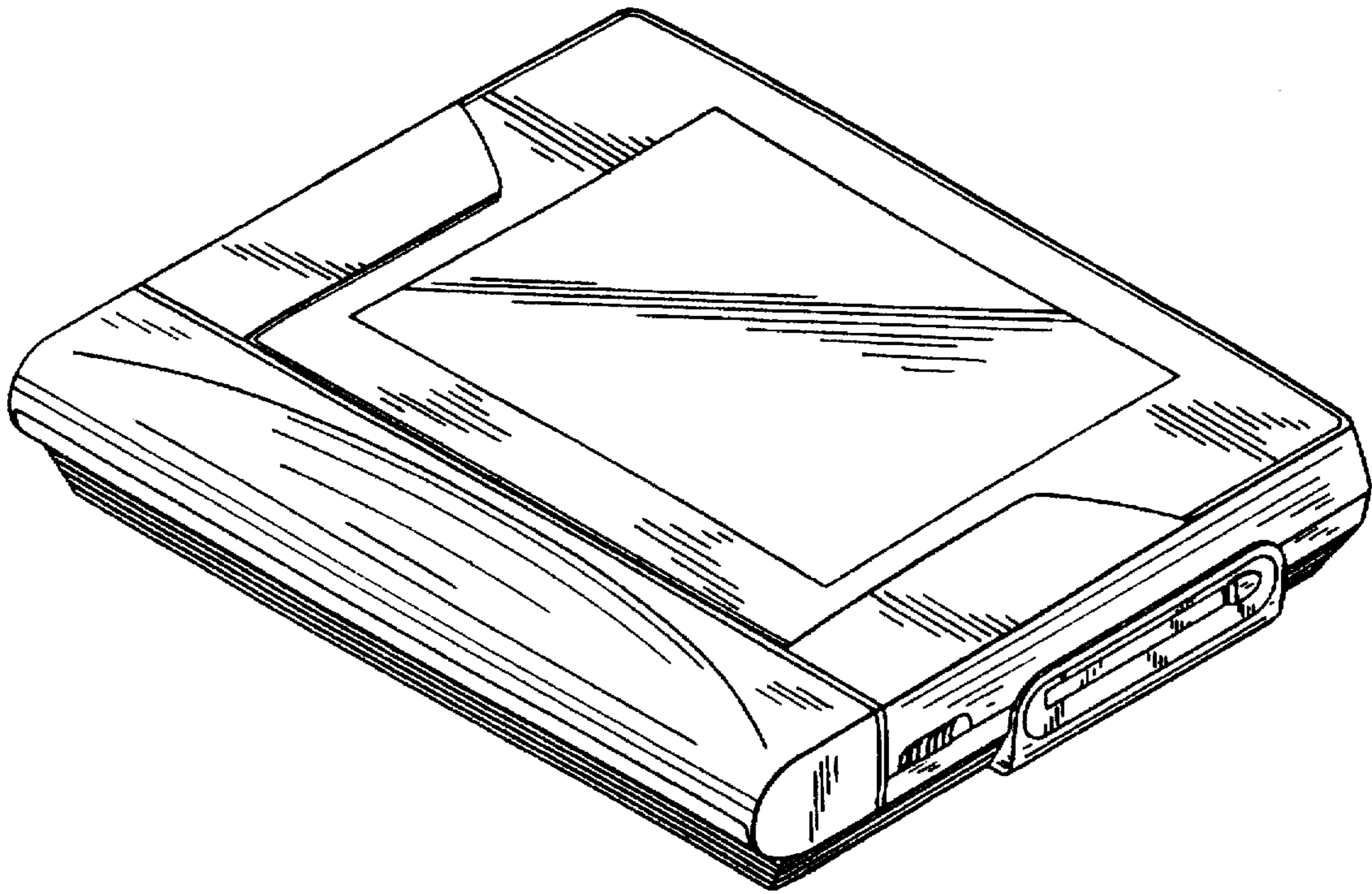

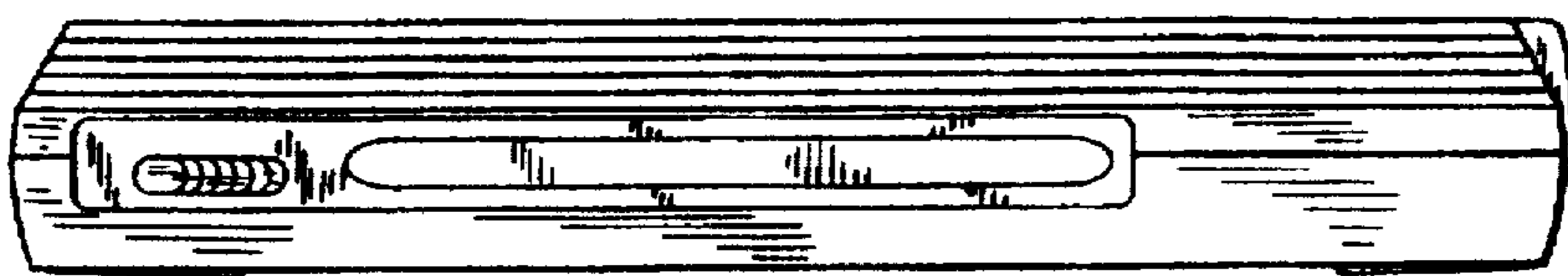

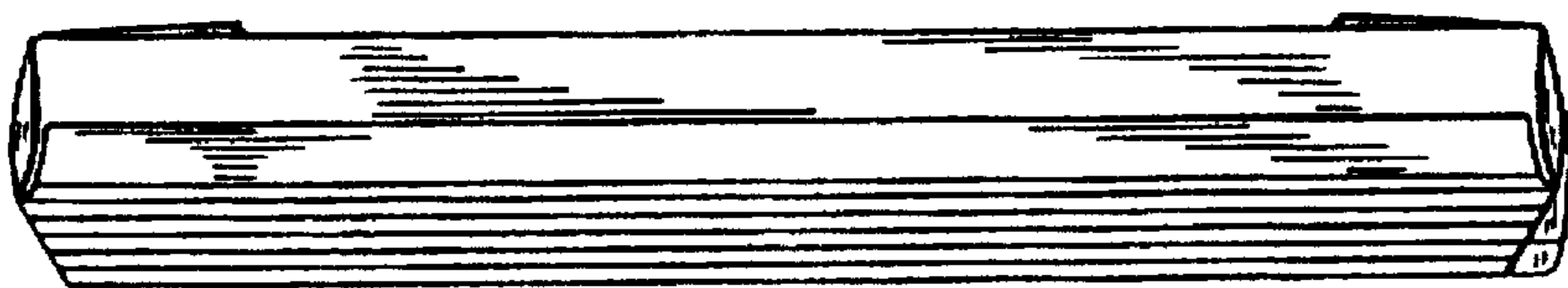

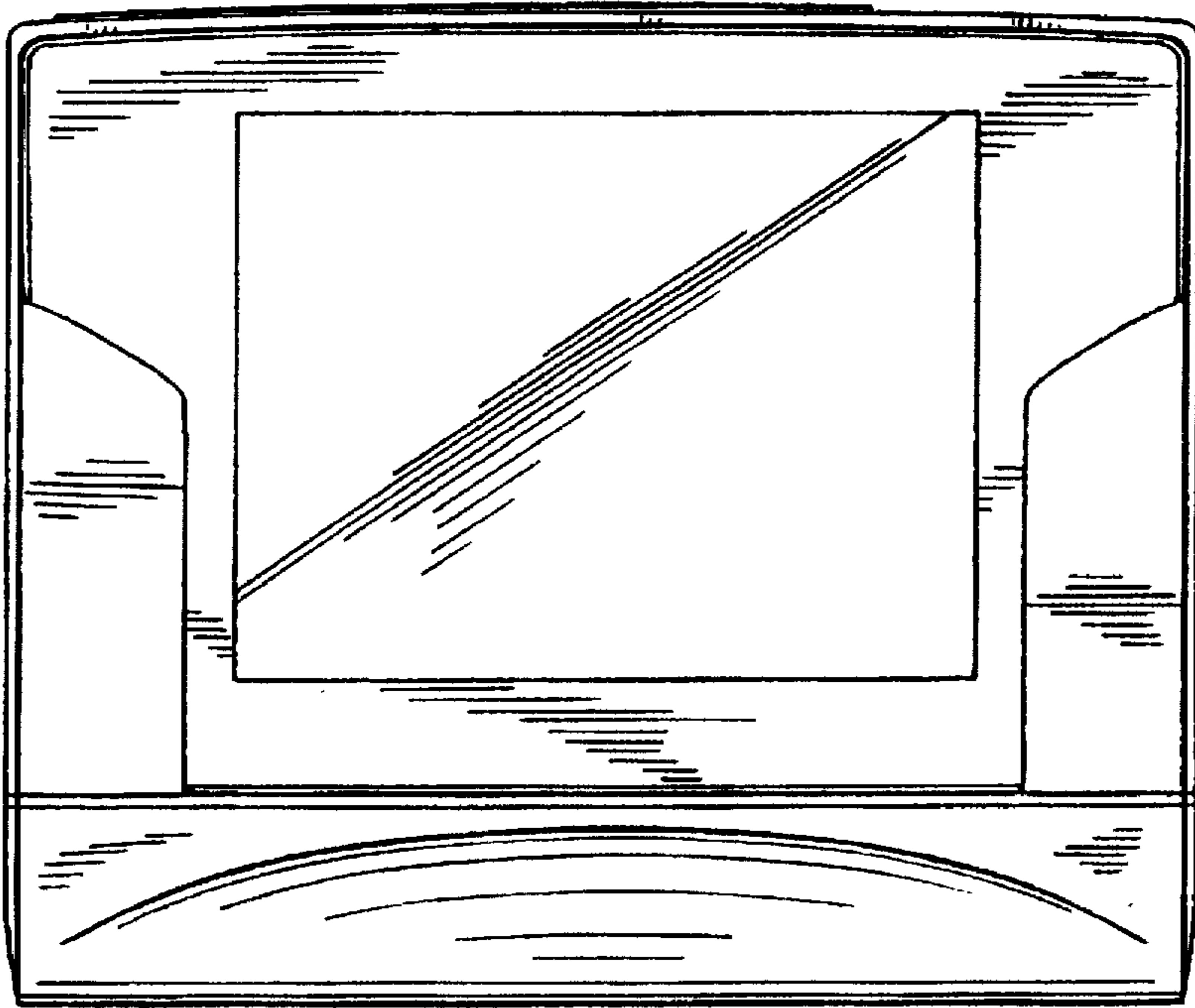

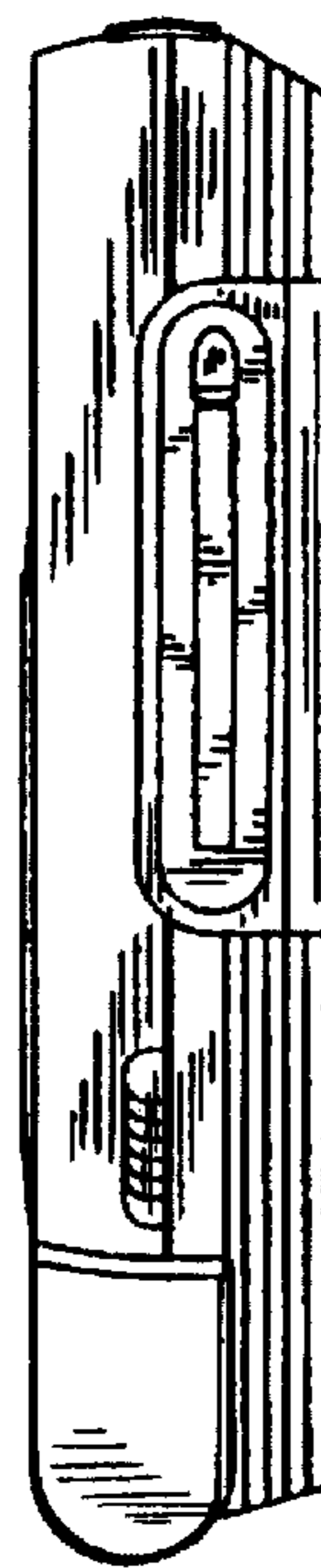

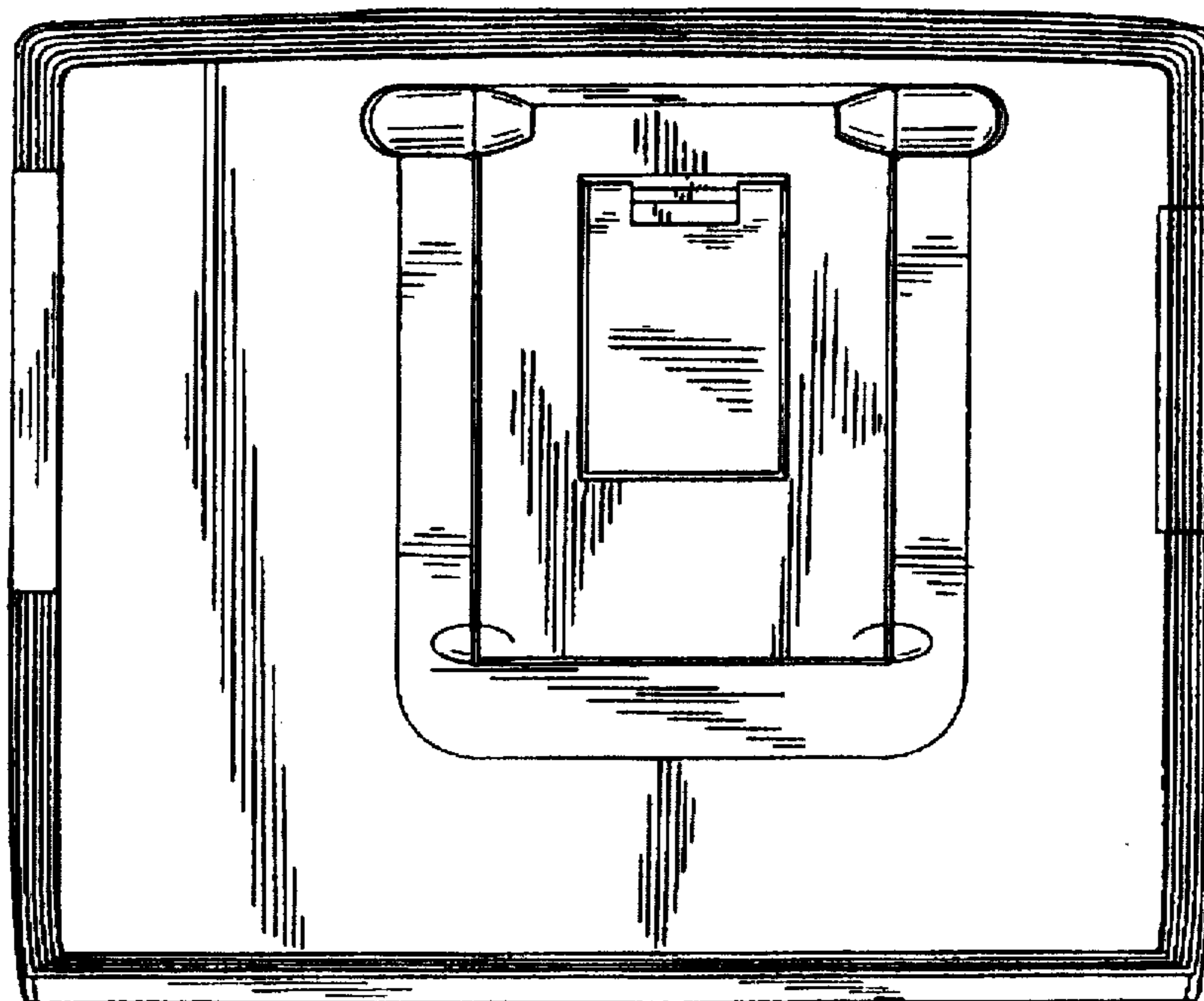

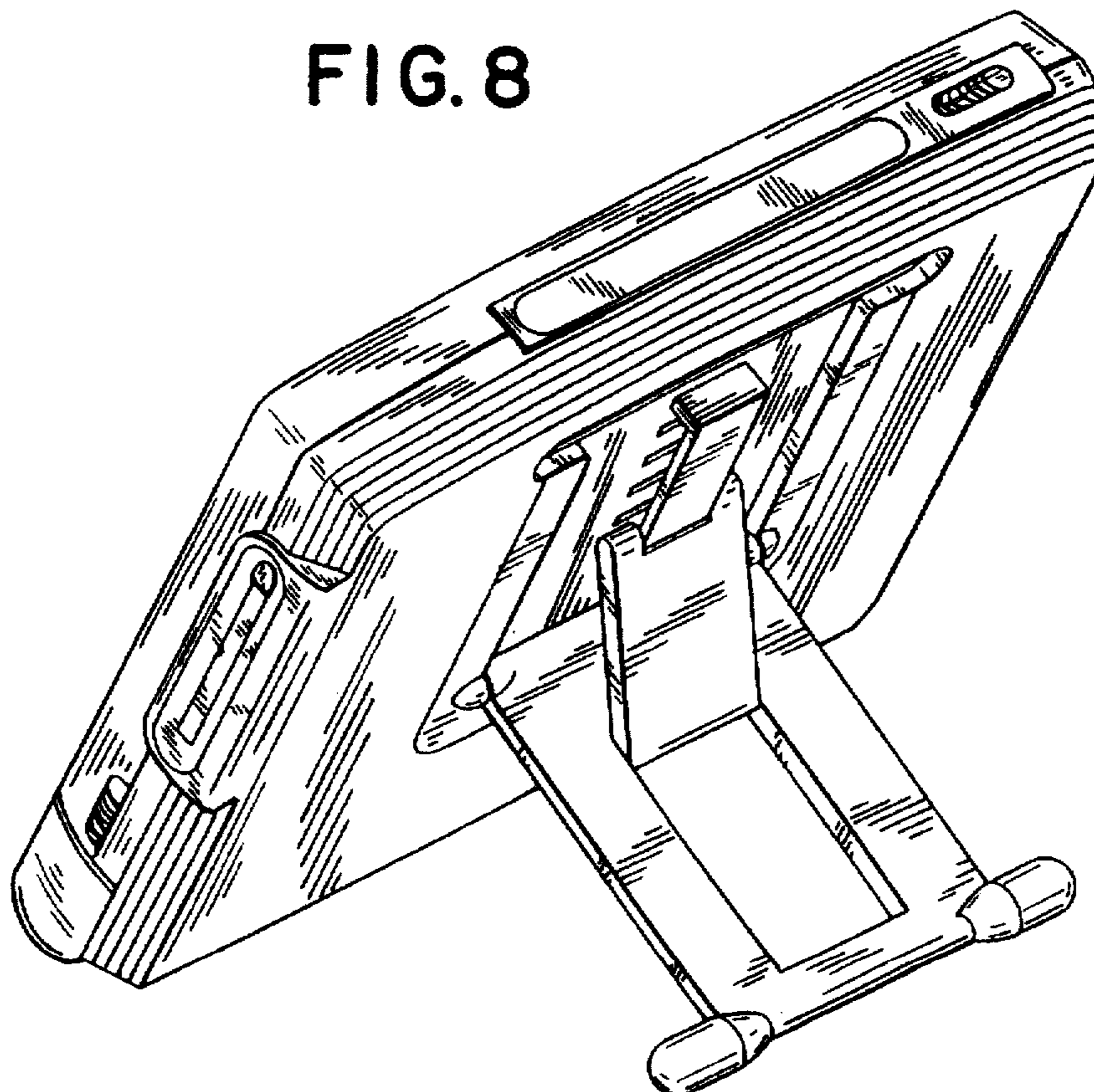

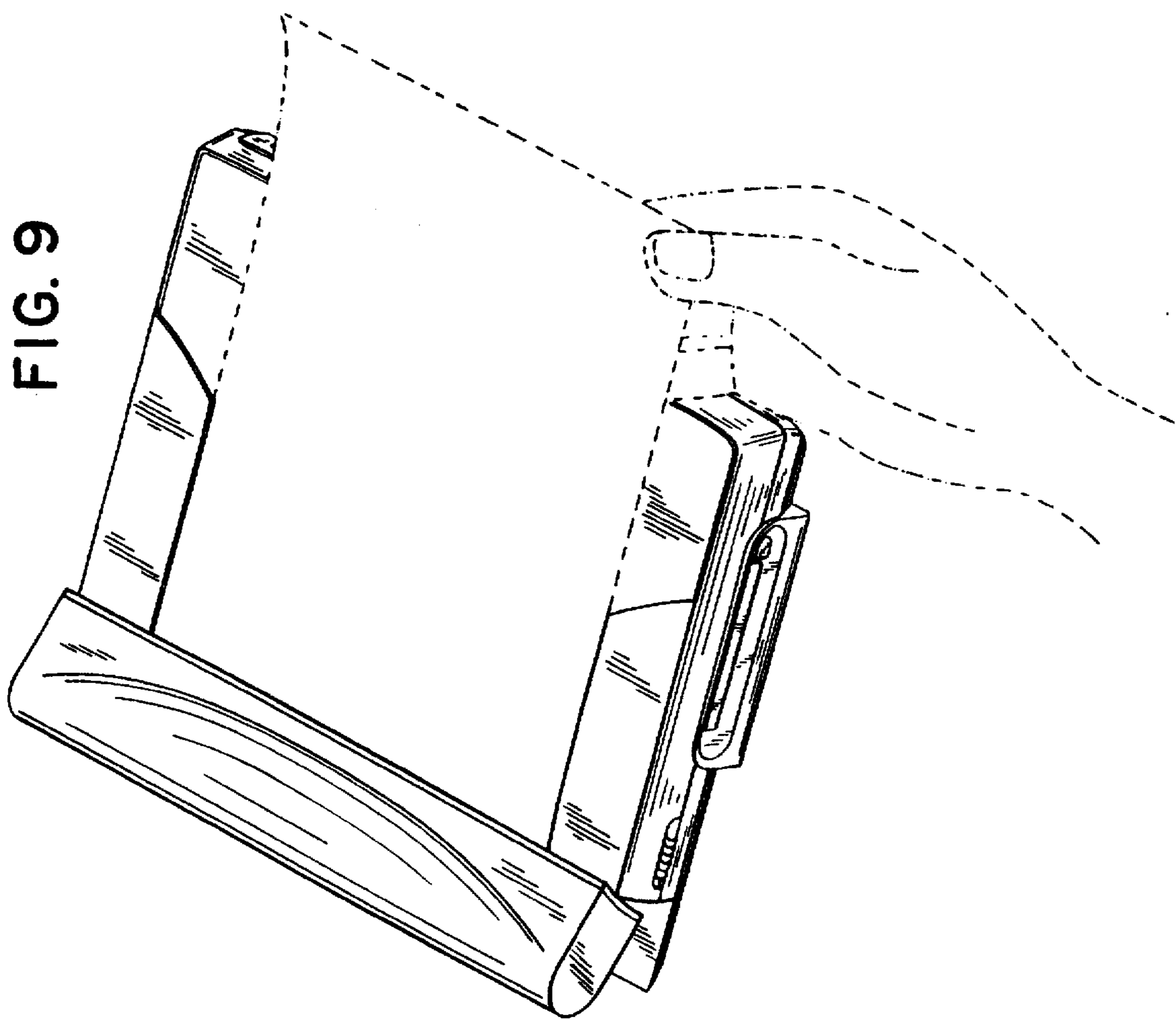

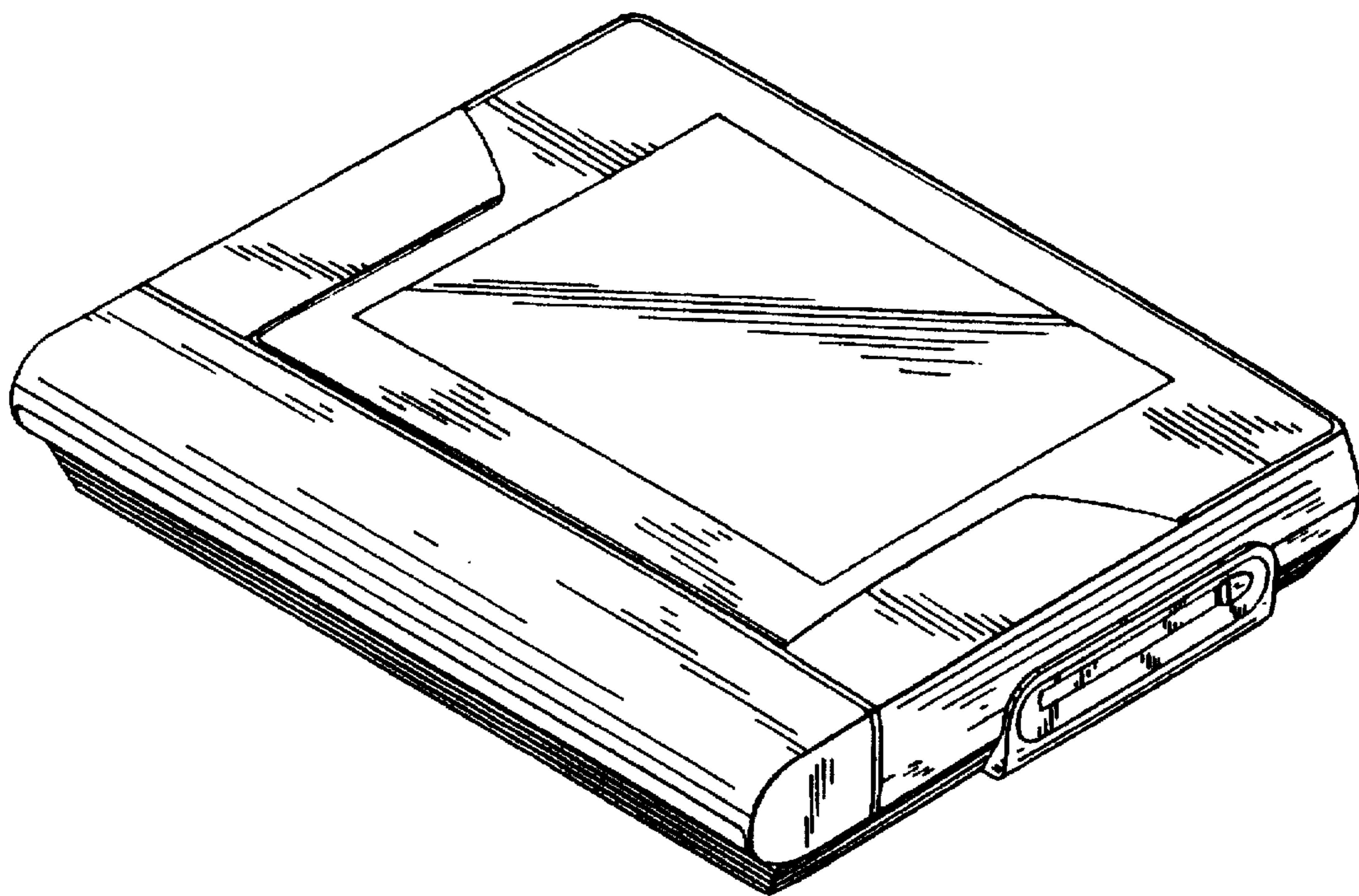

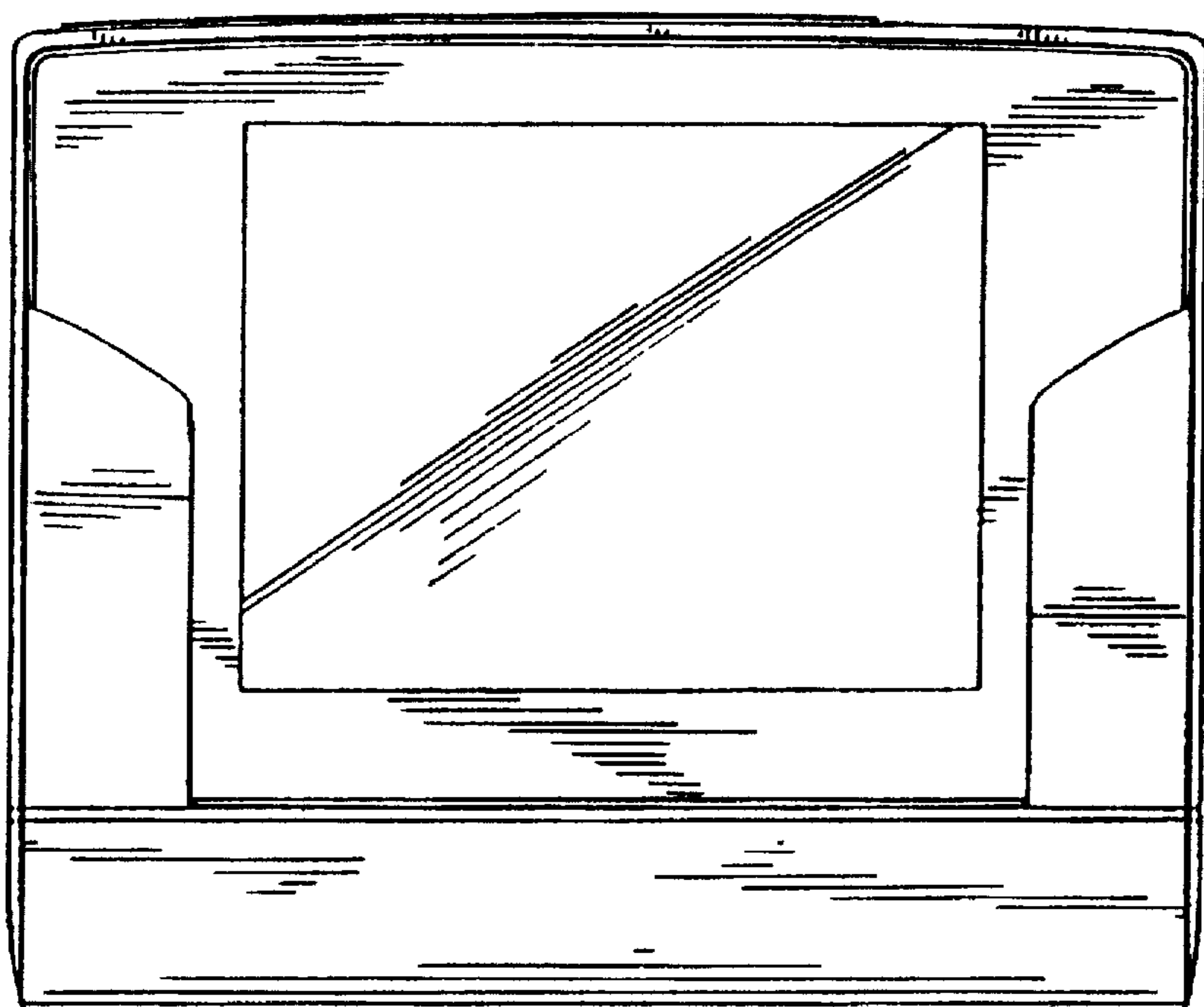

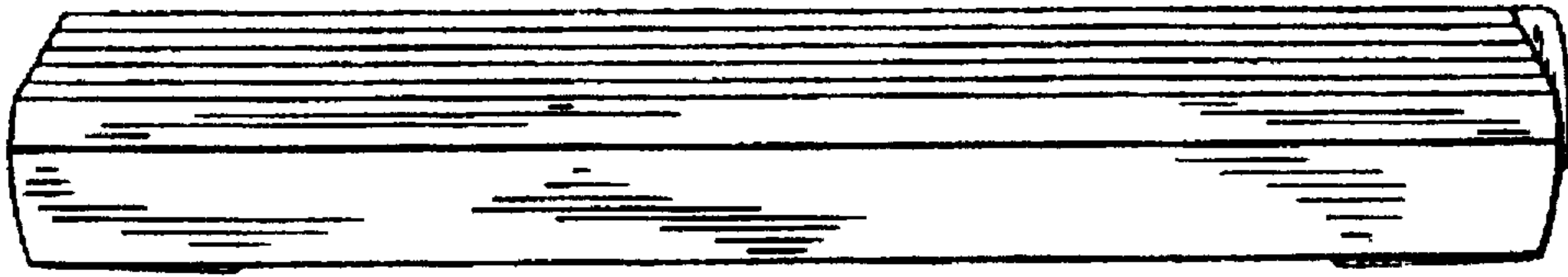

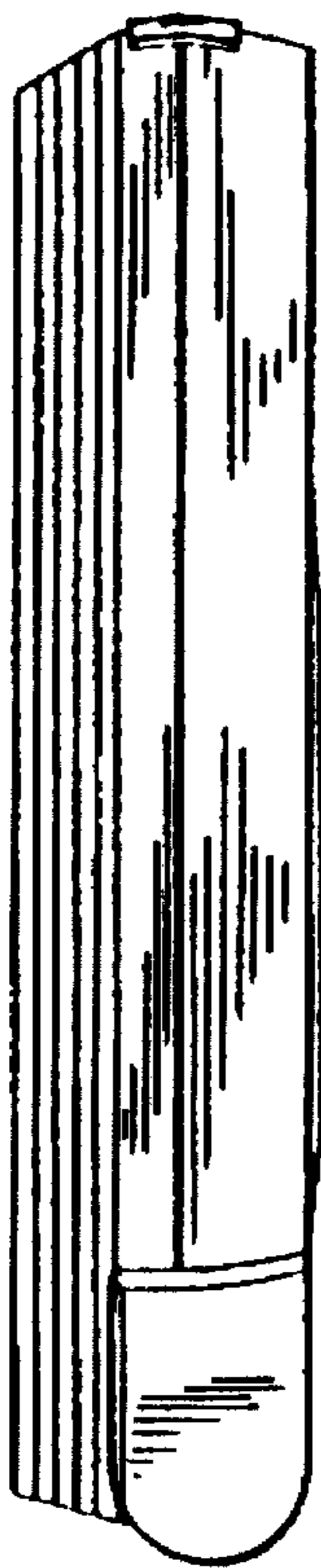

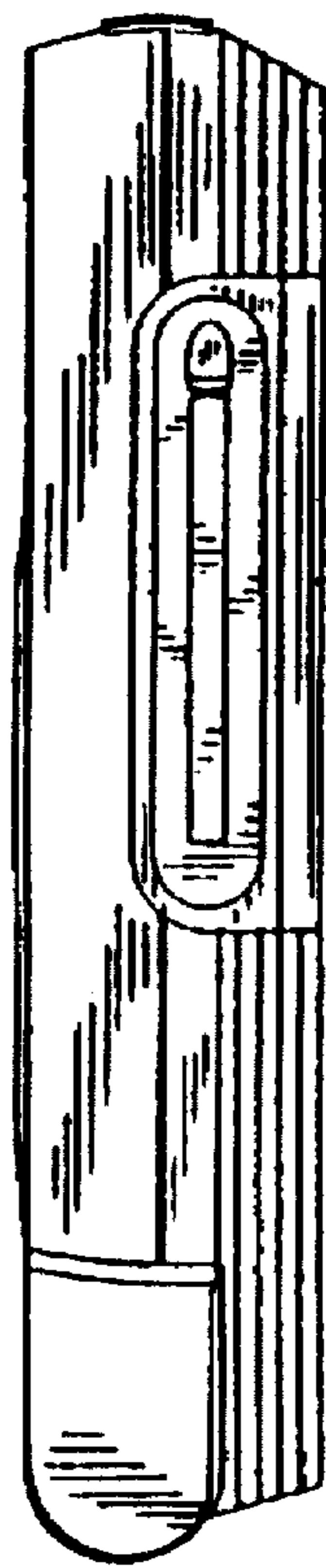
