FIG. 4 is a right side elevation view;

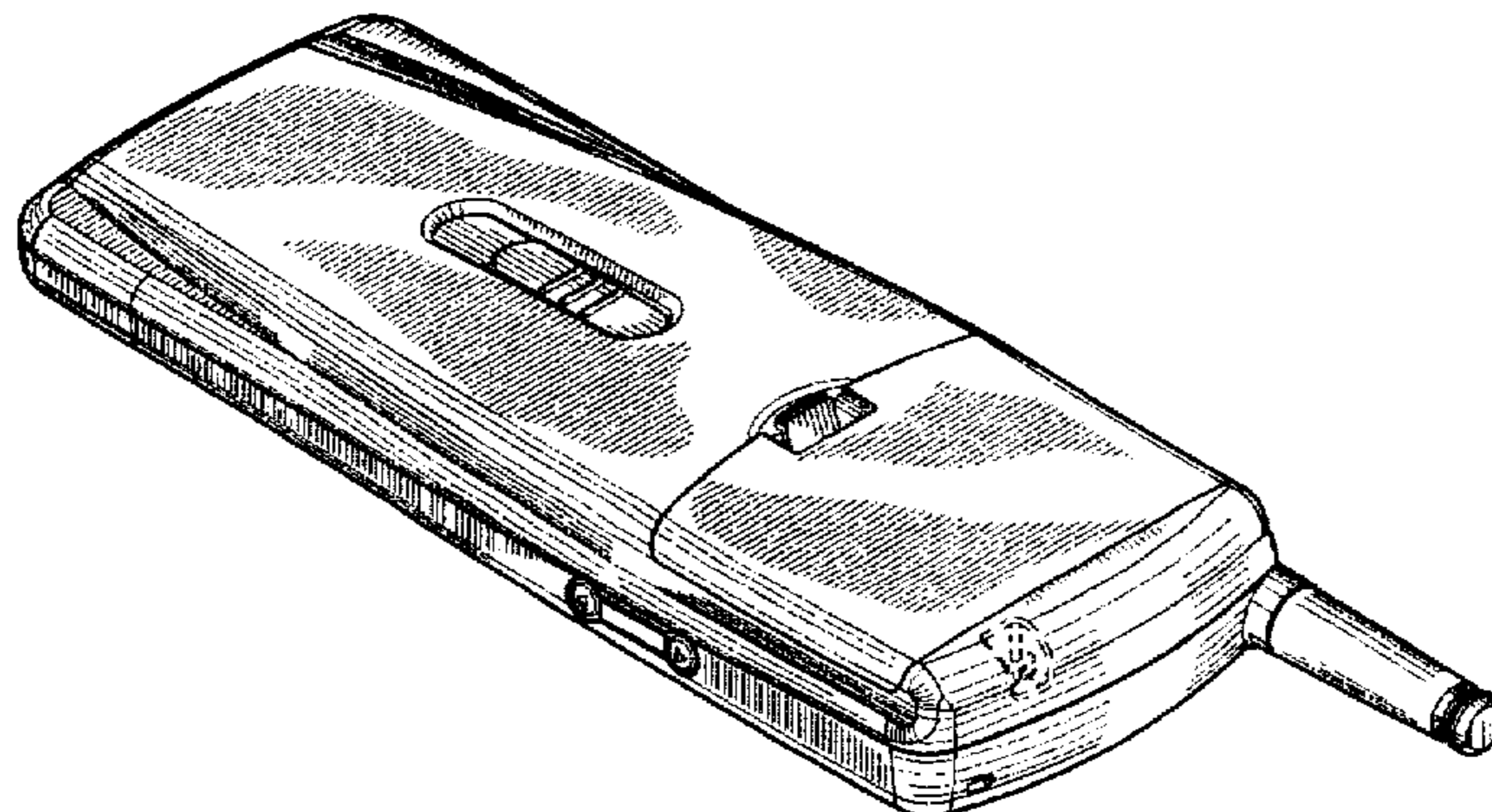
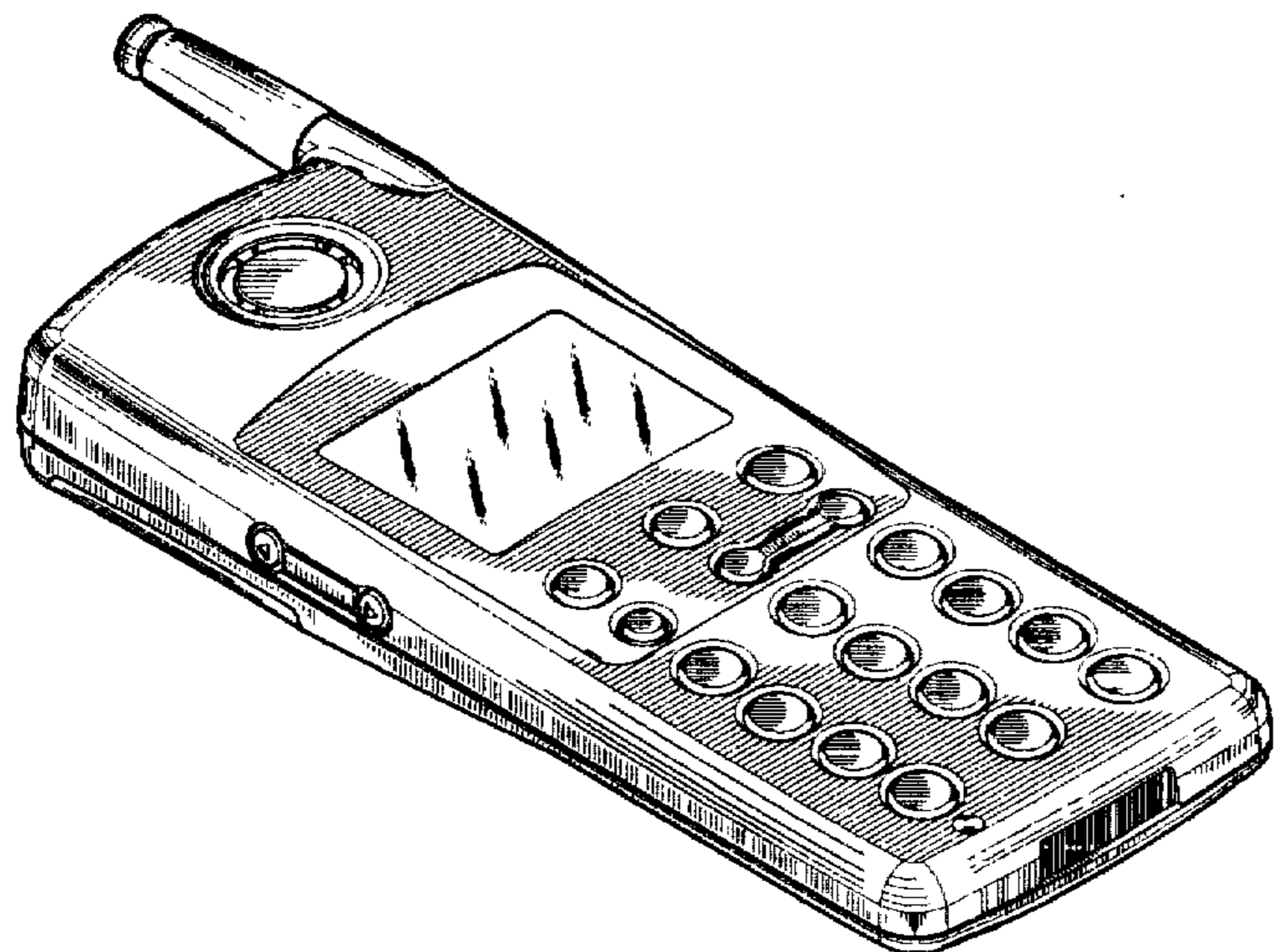
FIG. 5 is a top plan view;

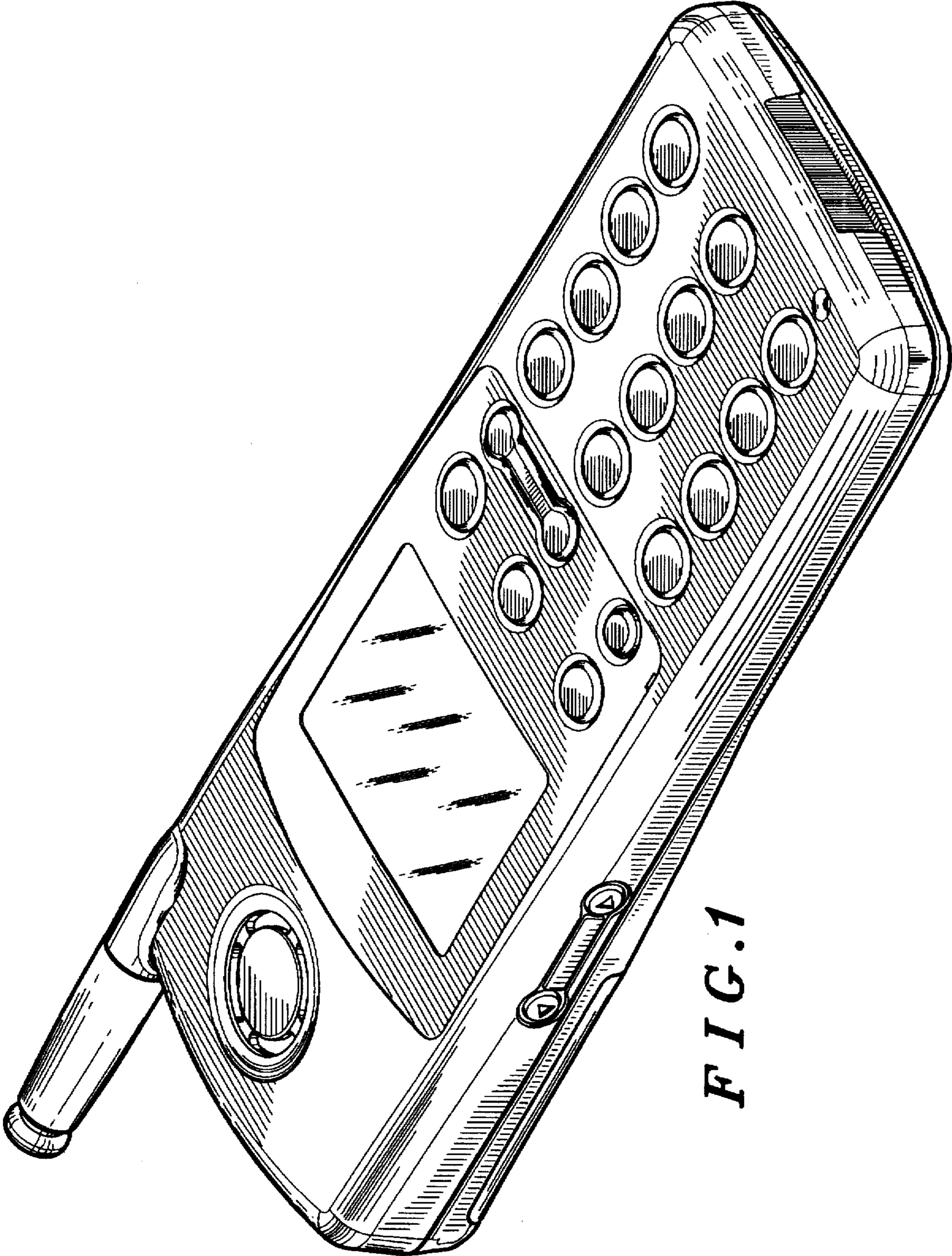

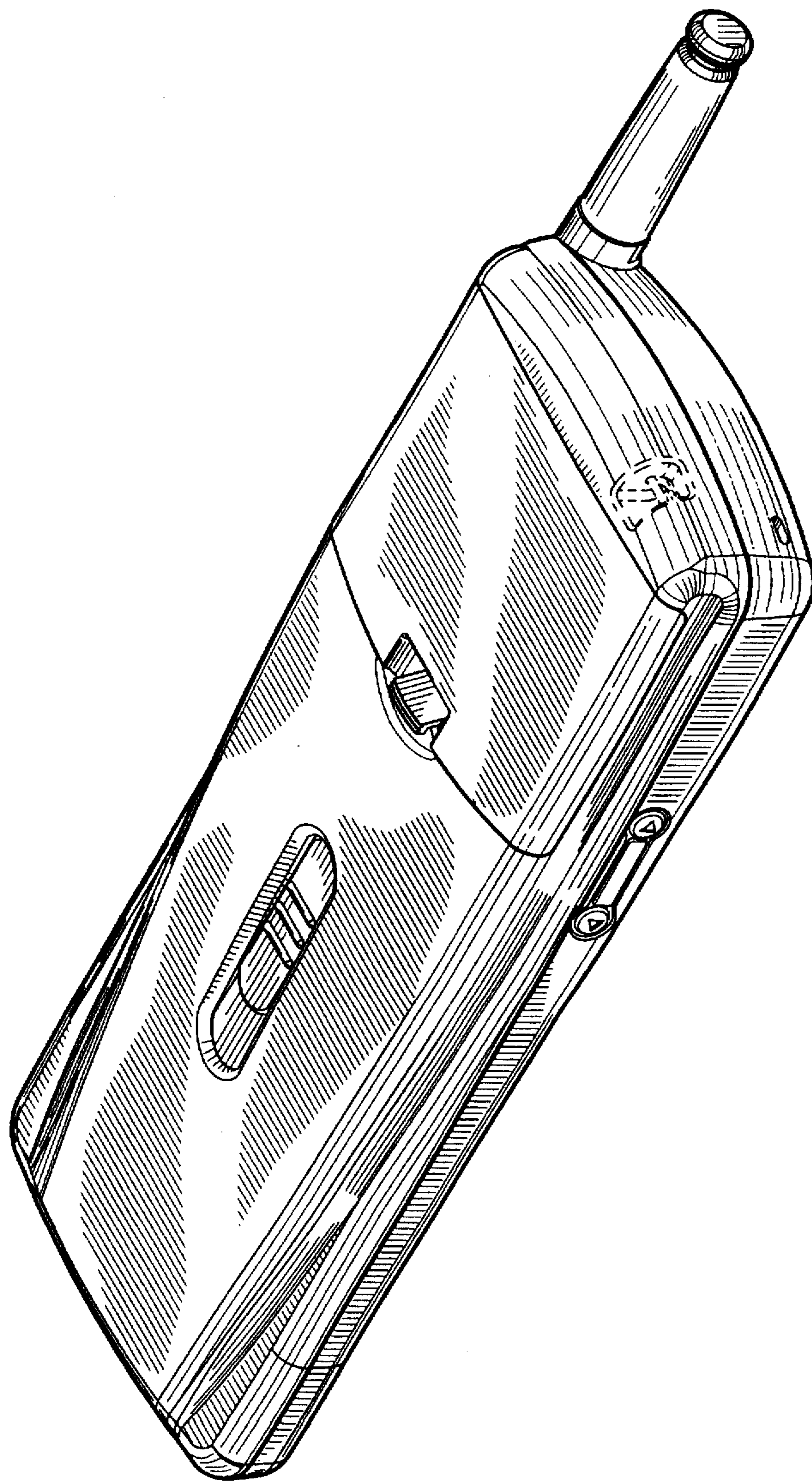
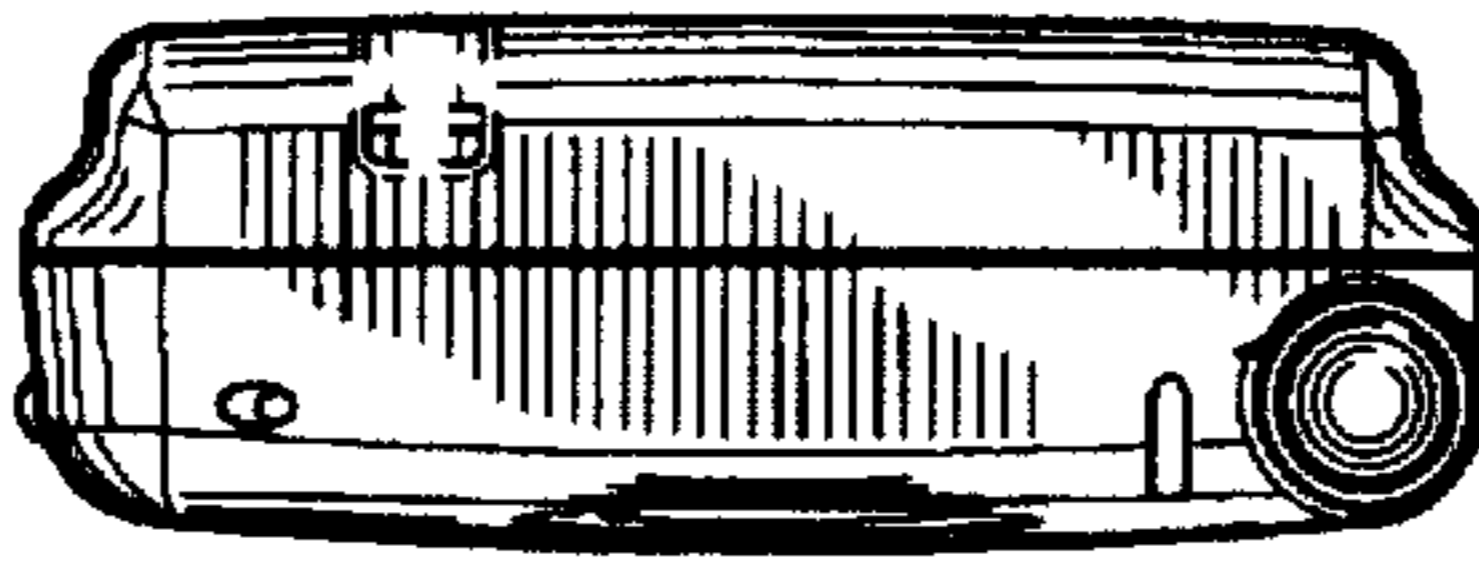
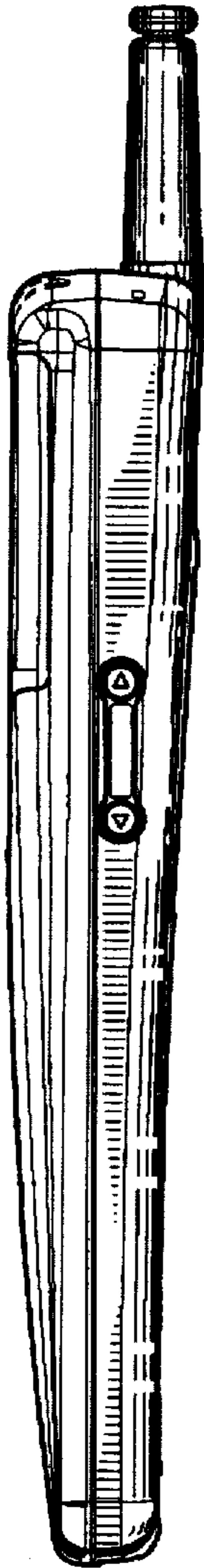

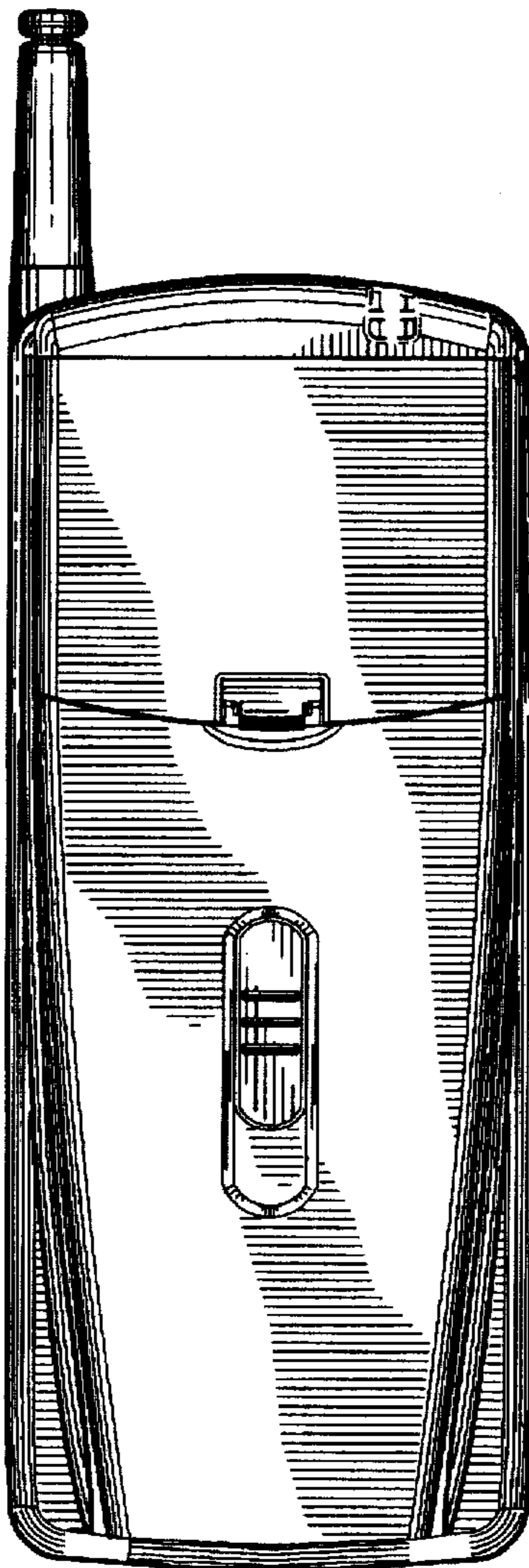




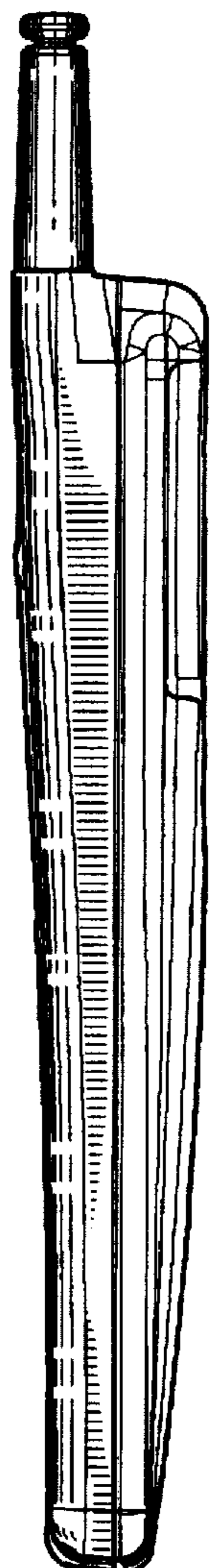
