[57] **CLAIM**

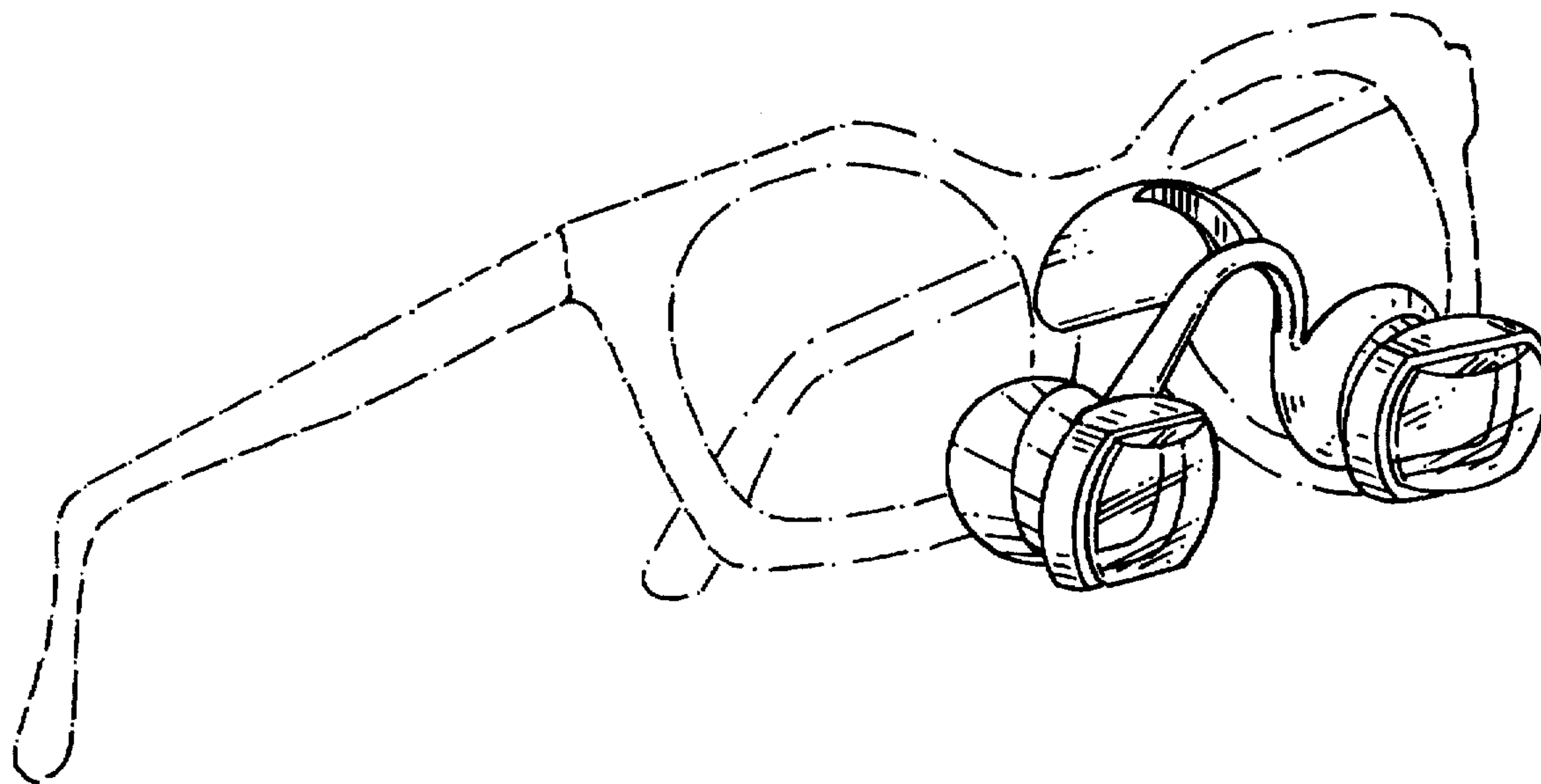
The ornamental design for flip up telescopes for spectacles,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of flip up telescopes for spectacles showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is an elevational view thereof, the side opposite being a mirror image;  
 FIG. 5 is a top plan view thereof; and,  
 FIG. 6 is a bottom plan view thereof.

The broken line showing of the spectacles in FIGS. 1-6 is for illustrative purposes only and forms no part of the claimed design.

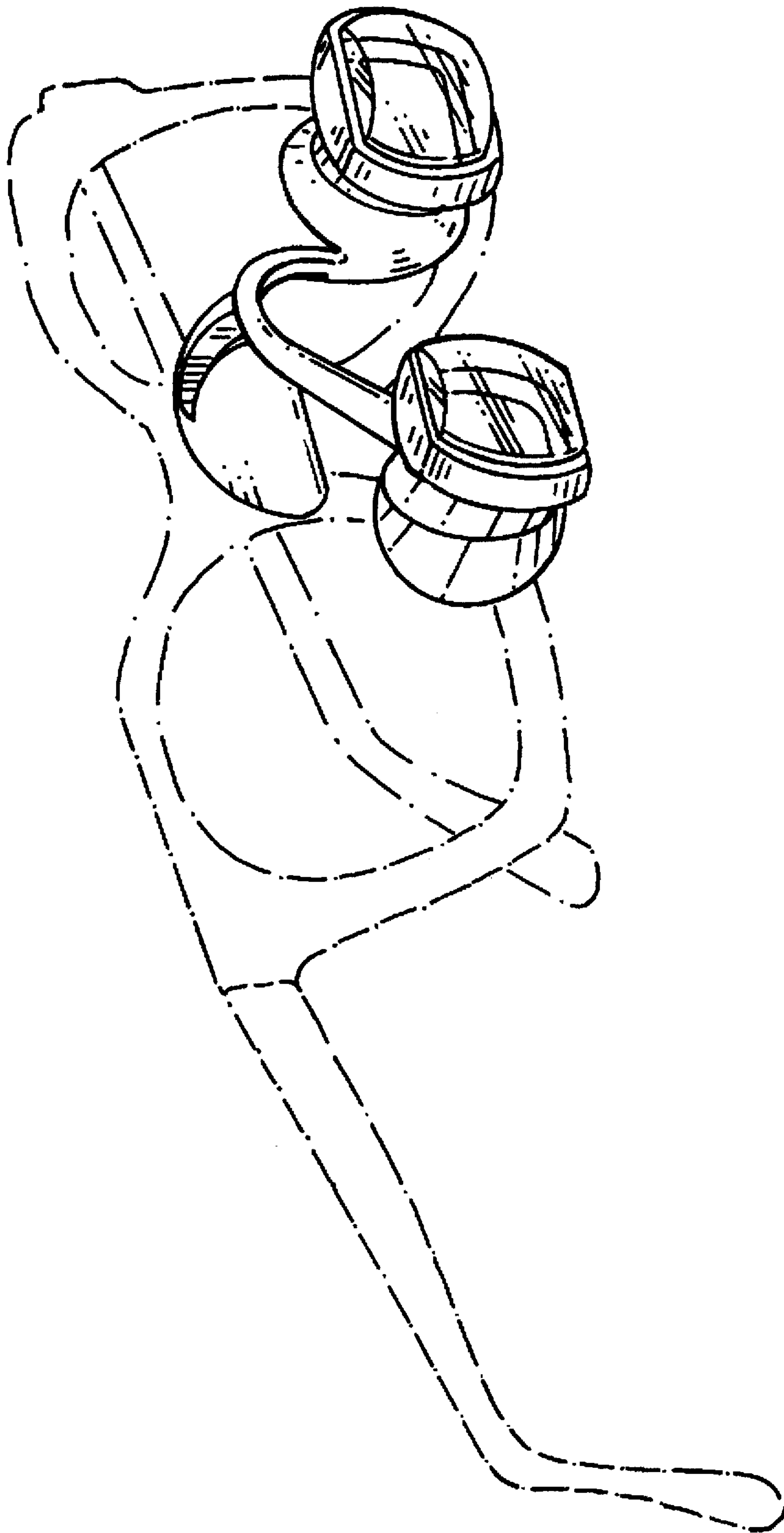

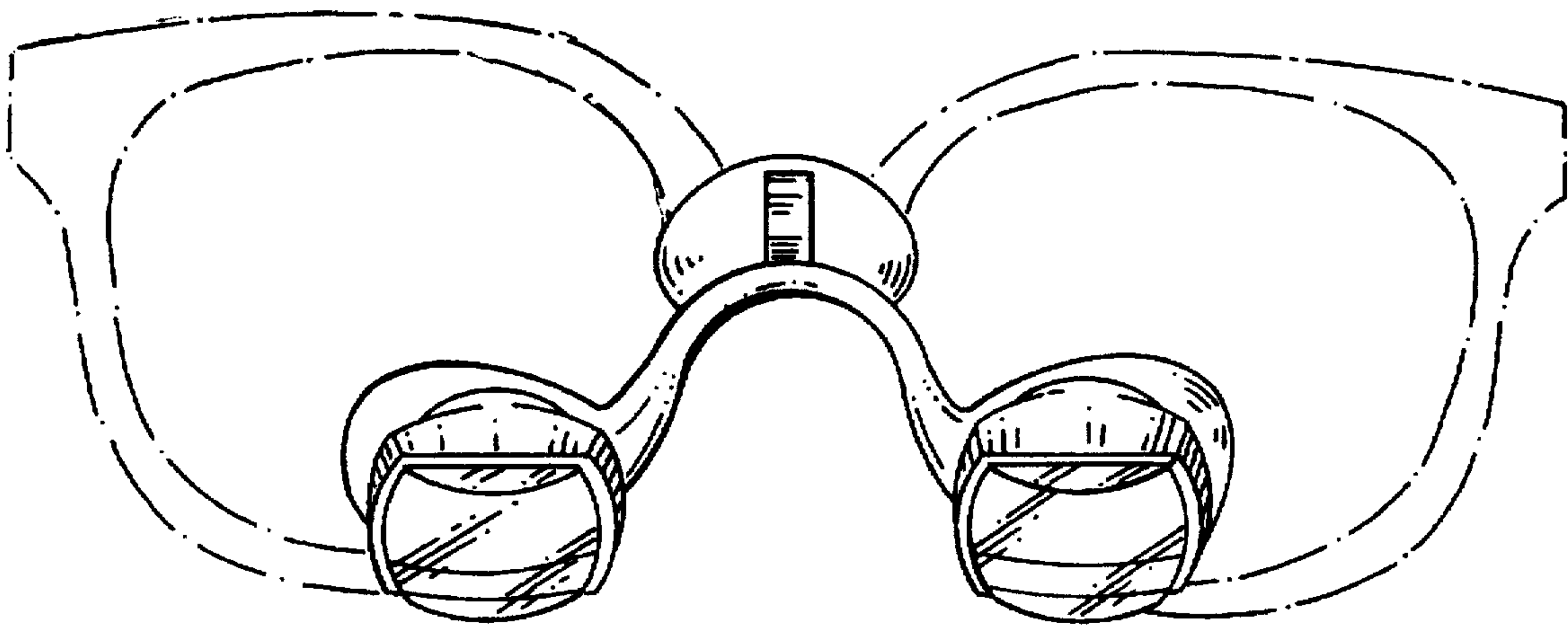

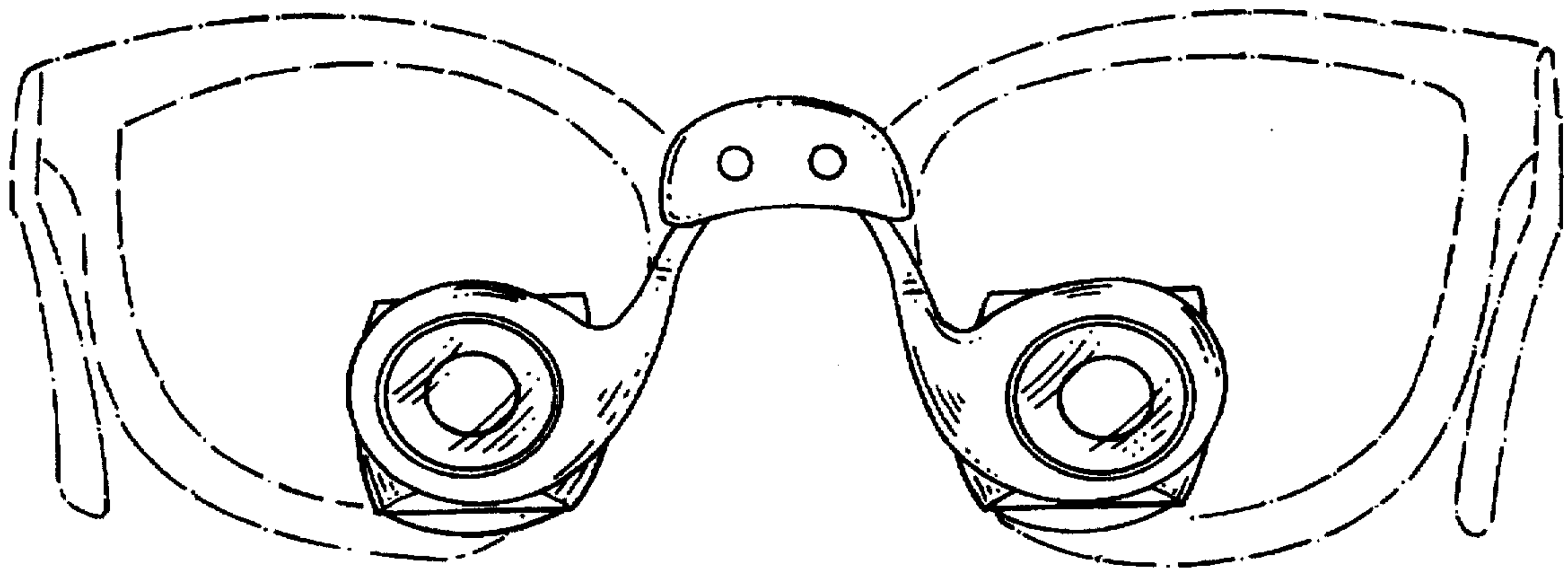

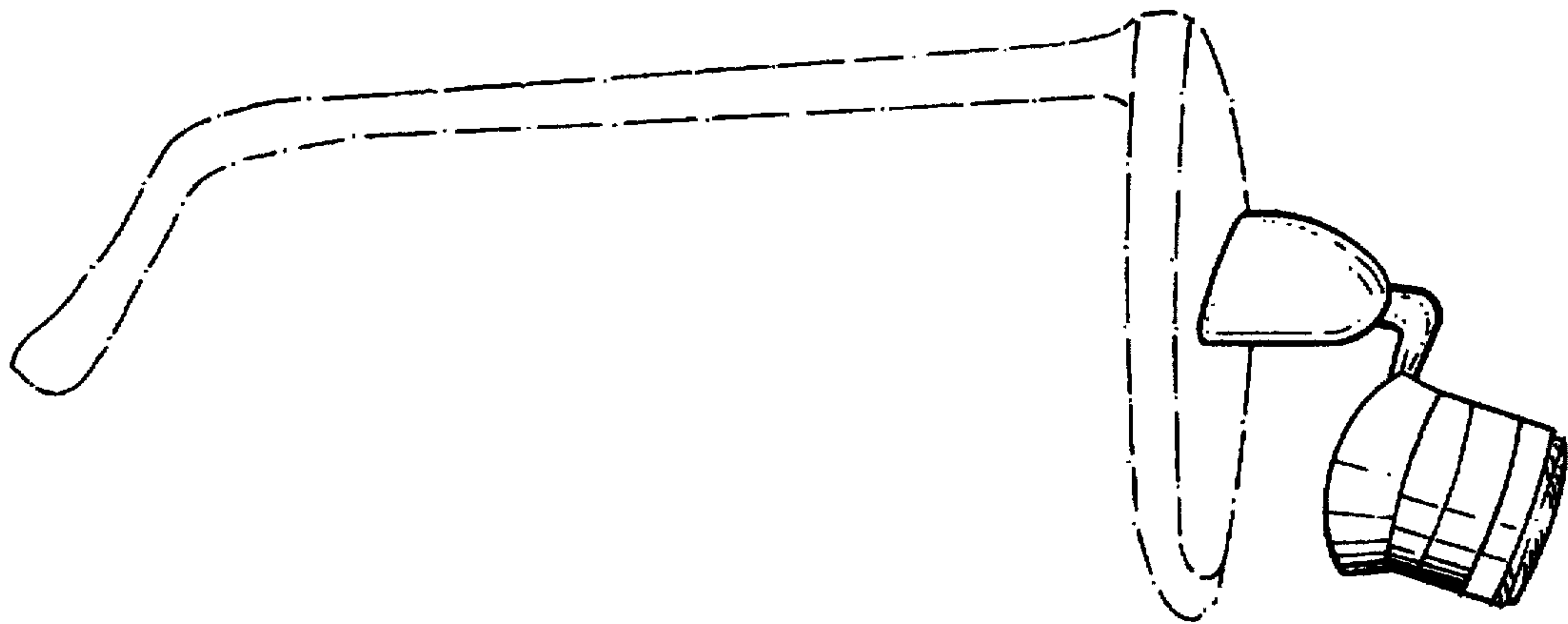

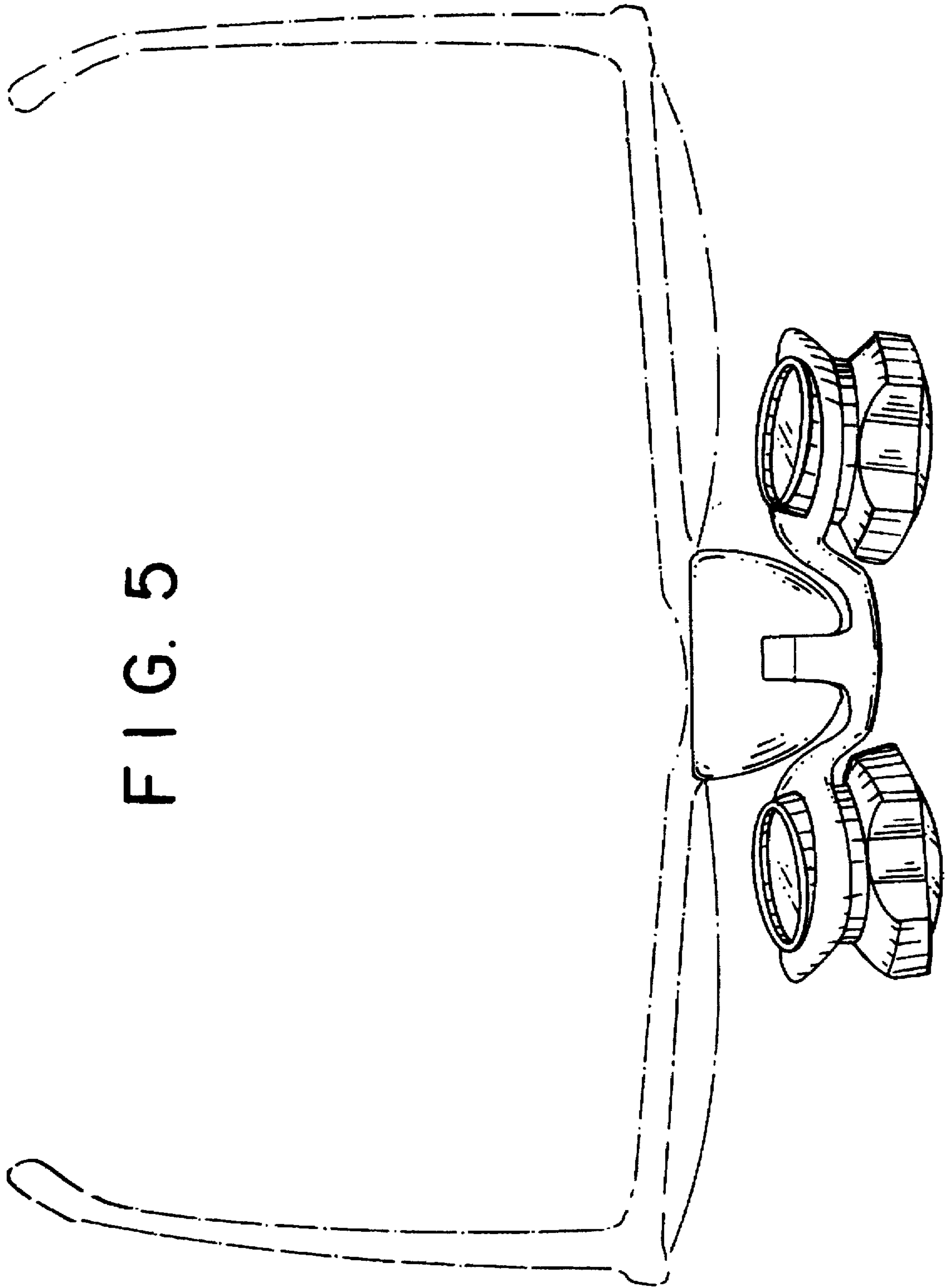

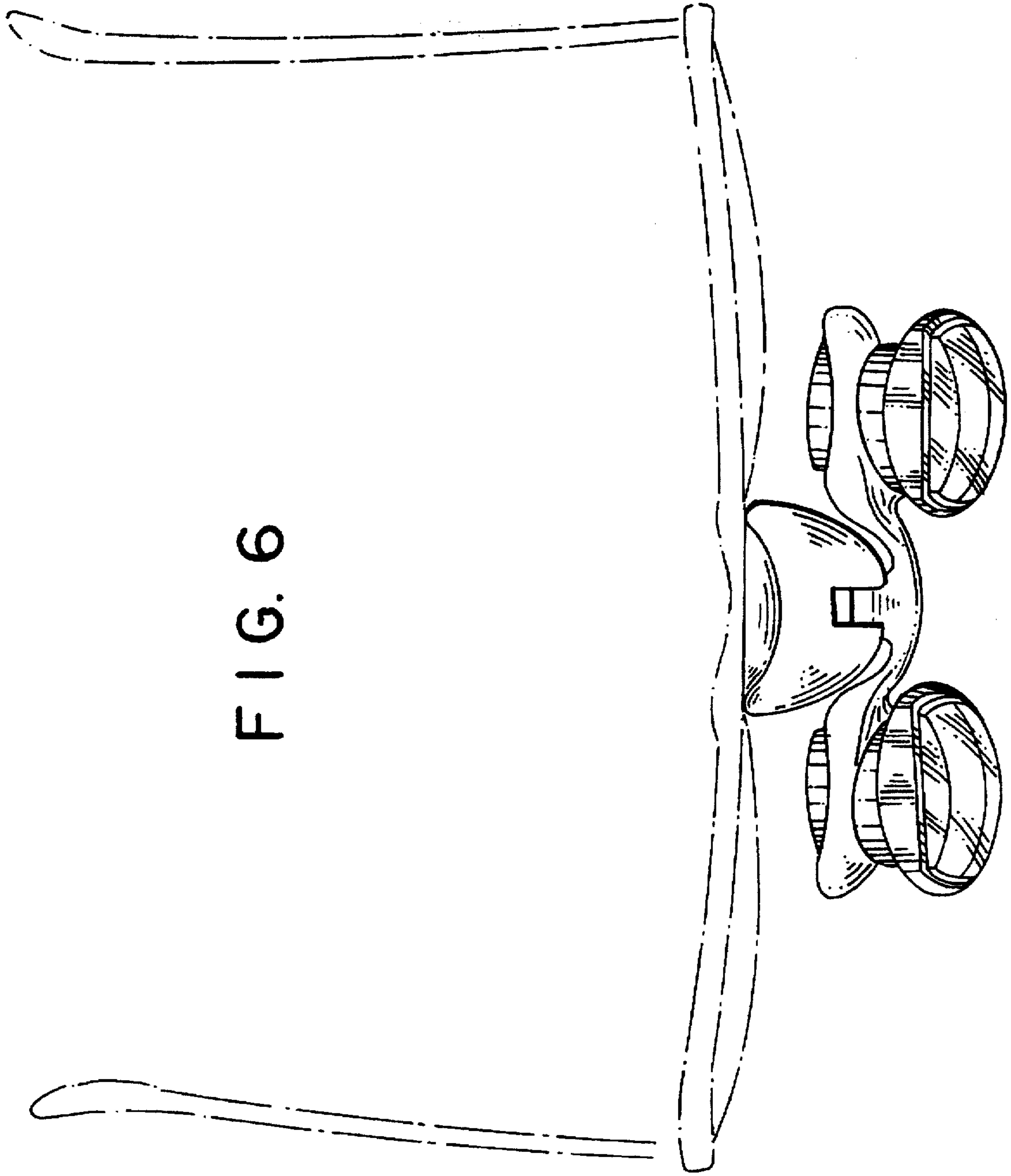
