[57] **CLAIM**

The ornamental design for a fluid container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a fluid container showing my new design, the rear elevational view being identical thereto;

FIG. 2 is a right side elevational view of the fluid container of FIG. 1, the left side elevational view being identical thereto;

FIG. 3 is a top plan view of the fluid container of FIG. 1; FIG. 4 is a bottom plan view of the fluid container of FIG. 1;

FIG. 5 is a front elevational view of another fluid container showing my new design, the rear elevational view being identical thereto;

FIG. 6 is a right side elevational view of the fluid container of FIG. 5, the left side elevational view being identical thereto;

FIG. 7 is a top plan view of the fluid container of FIG. 5; FIG. 8 is a bottom plan view of the fluid container of FIG. 5;

FIG. 9 is a perspective view of the fluid container of FIG. 1; and,

FIG. 10 is a perspective view of the fluid container of FIG. 5.

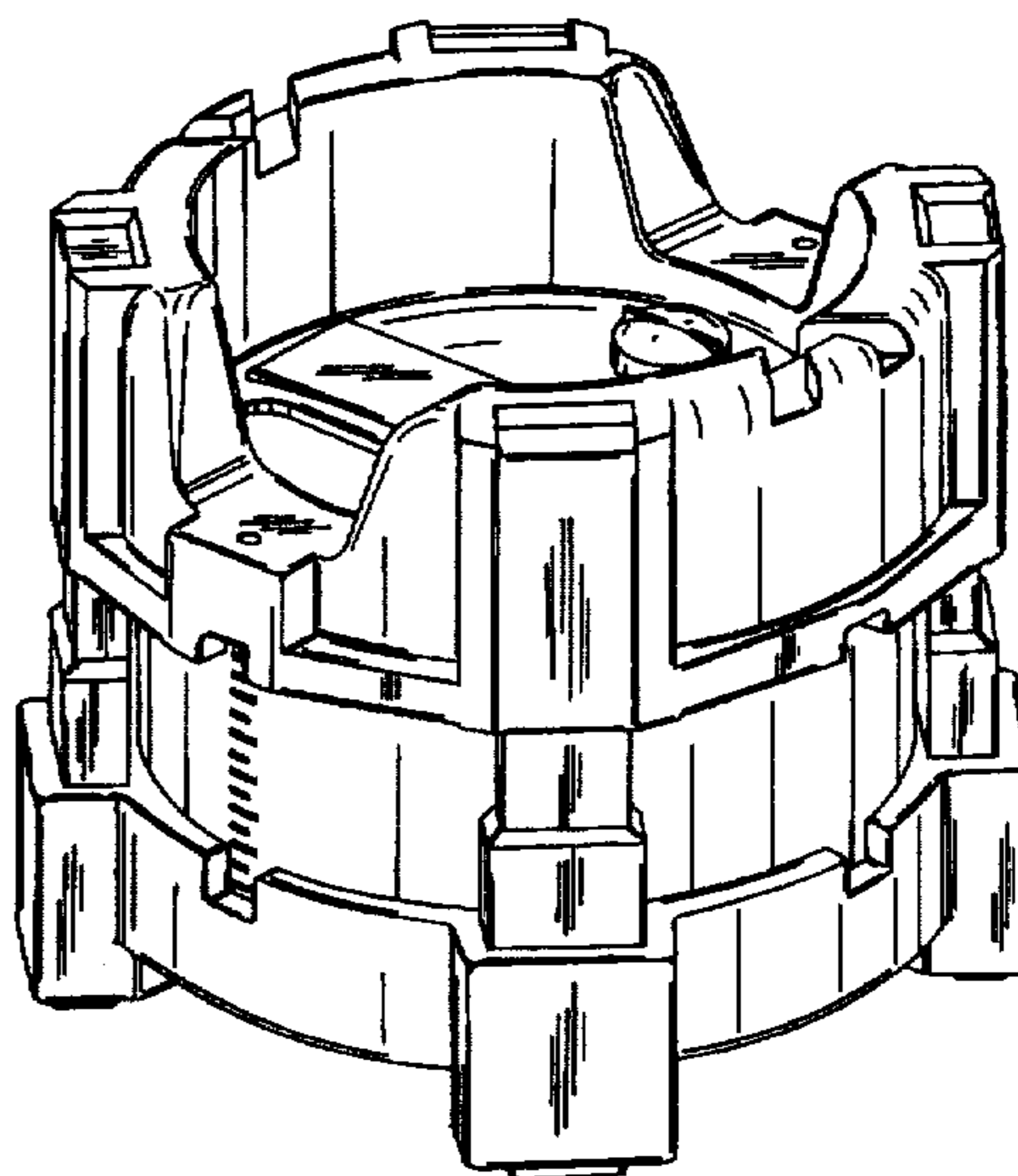
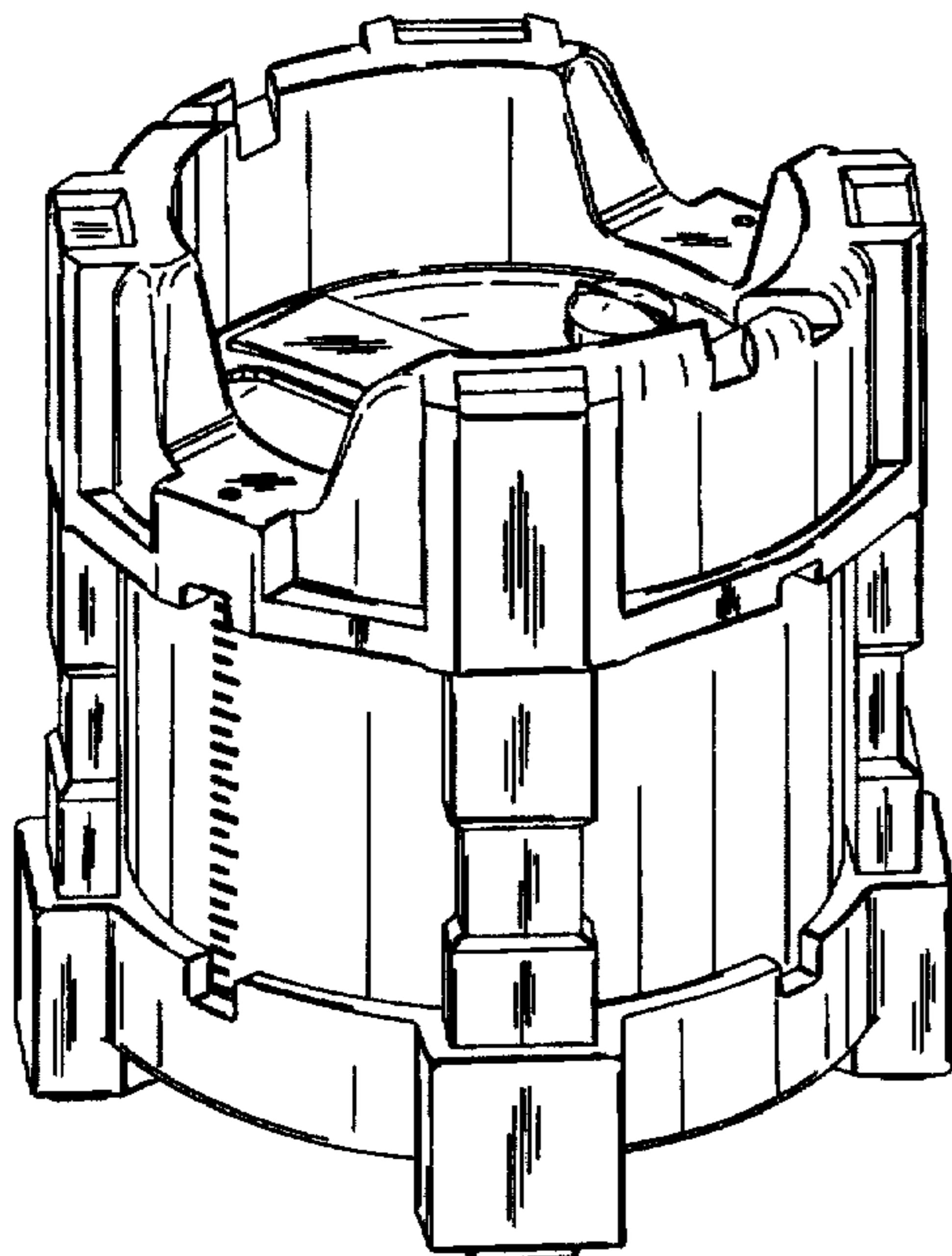

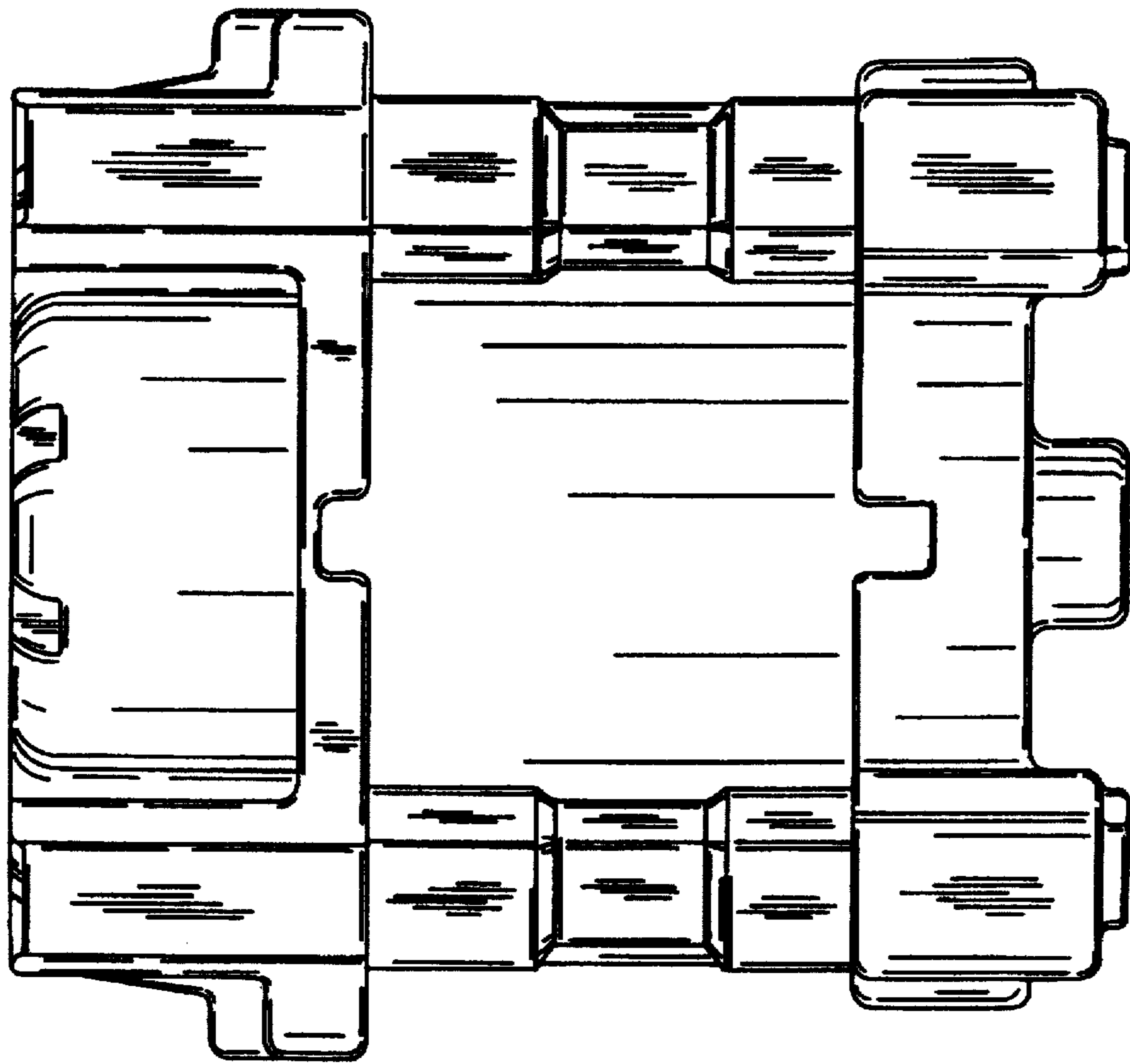

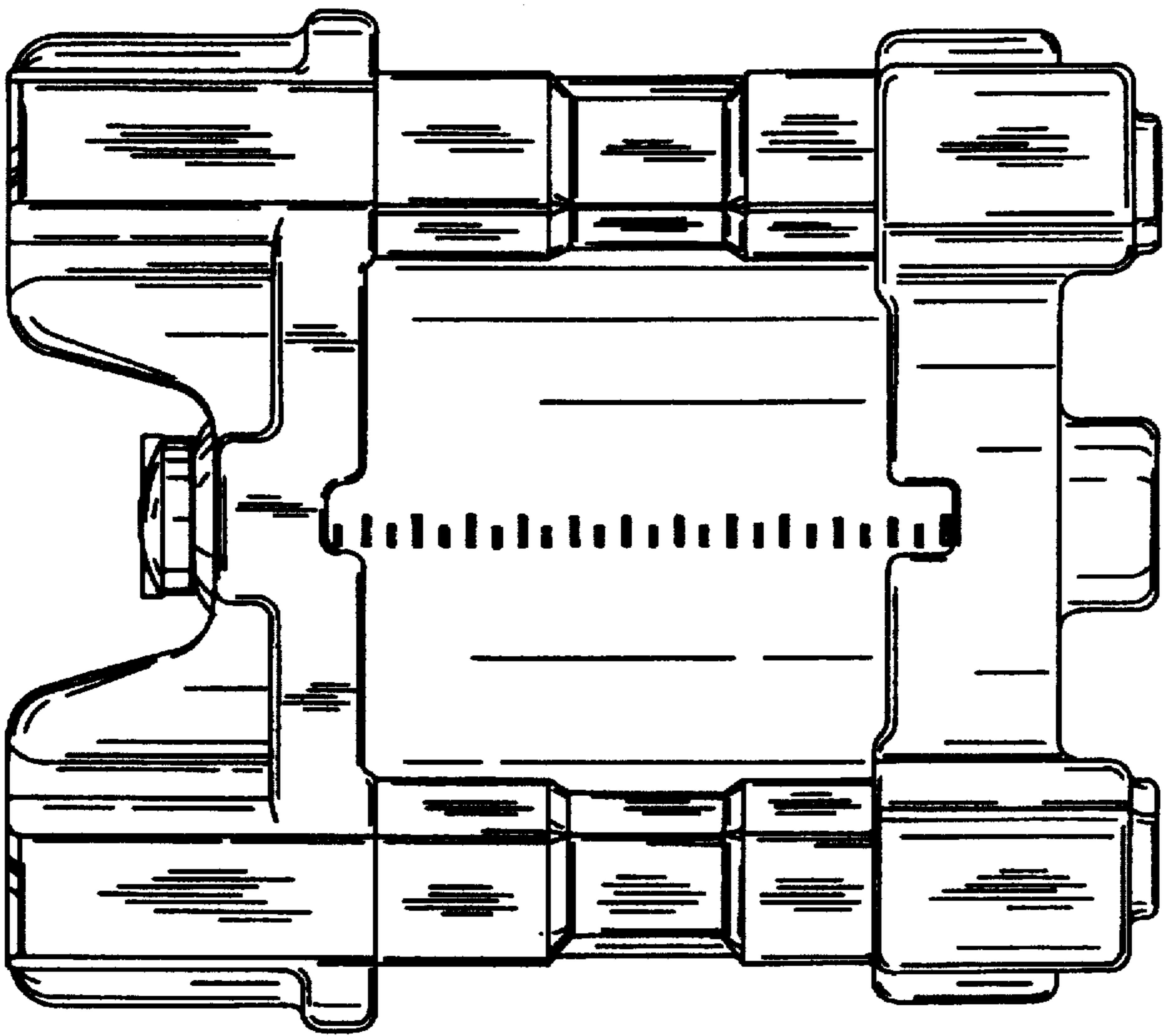

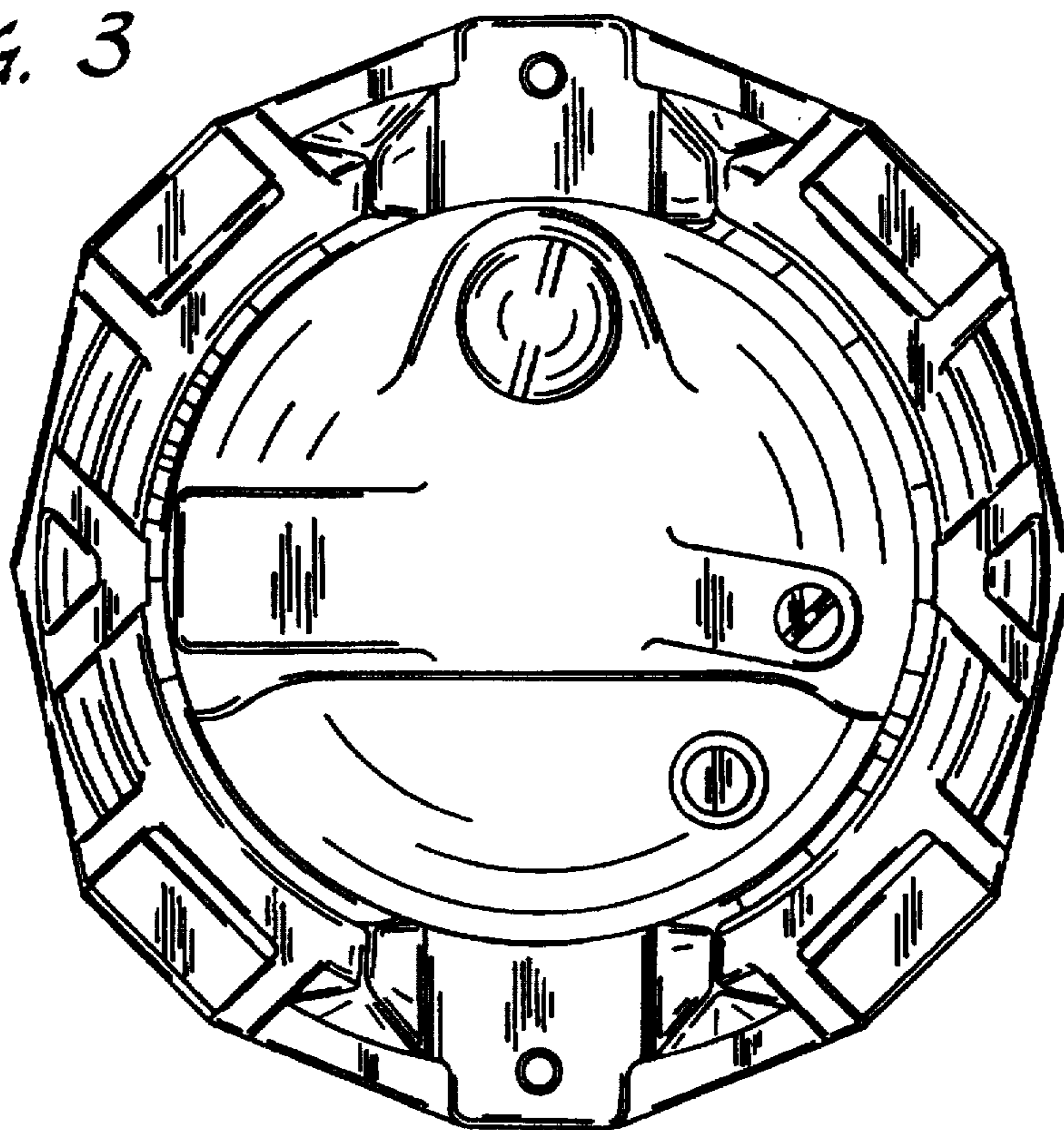
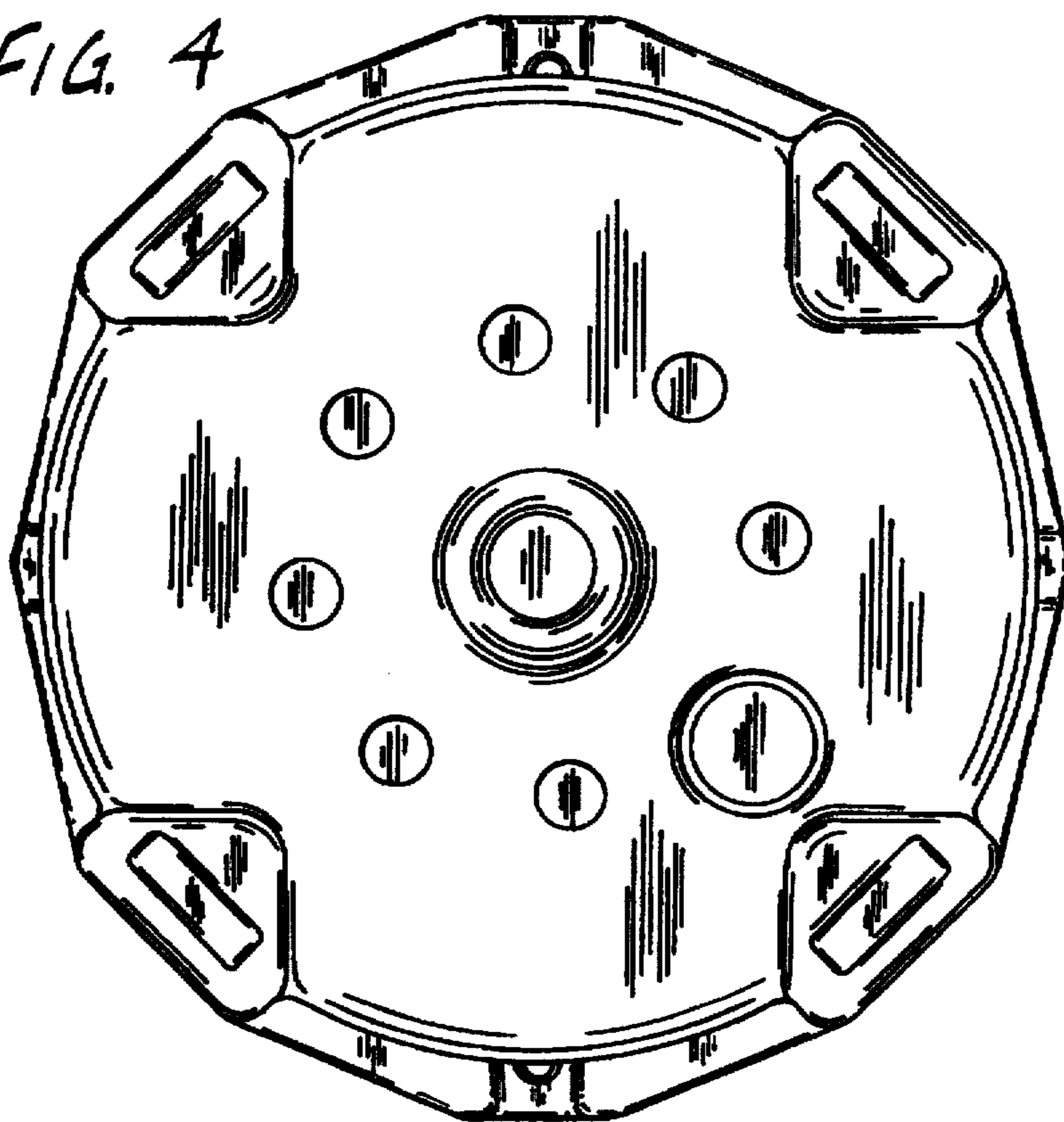

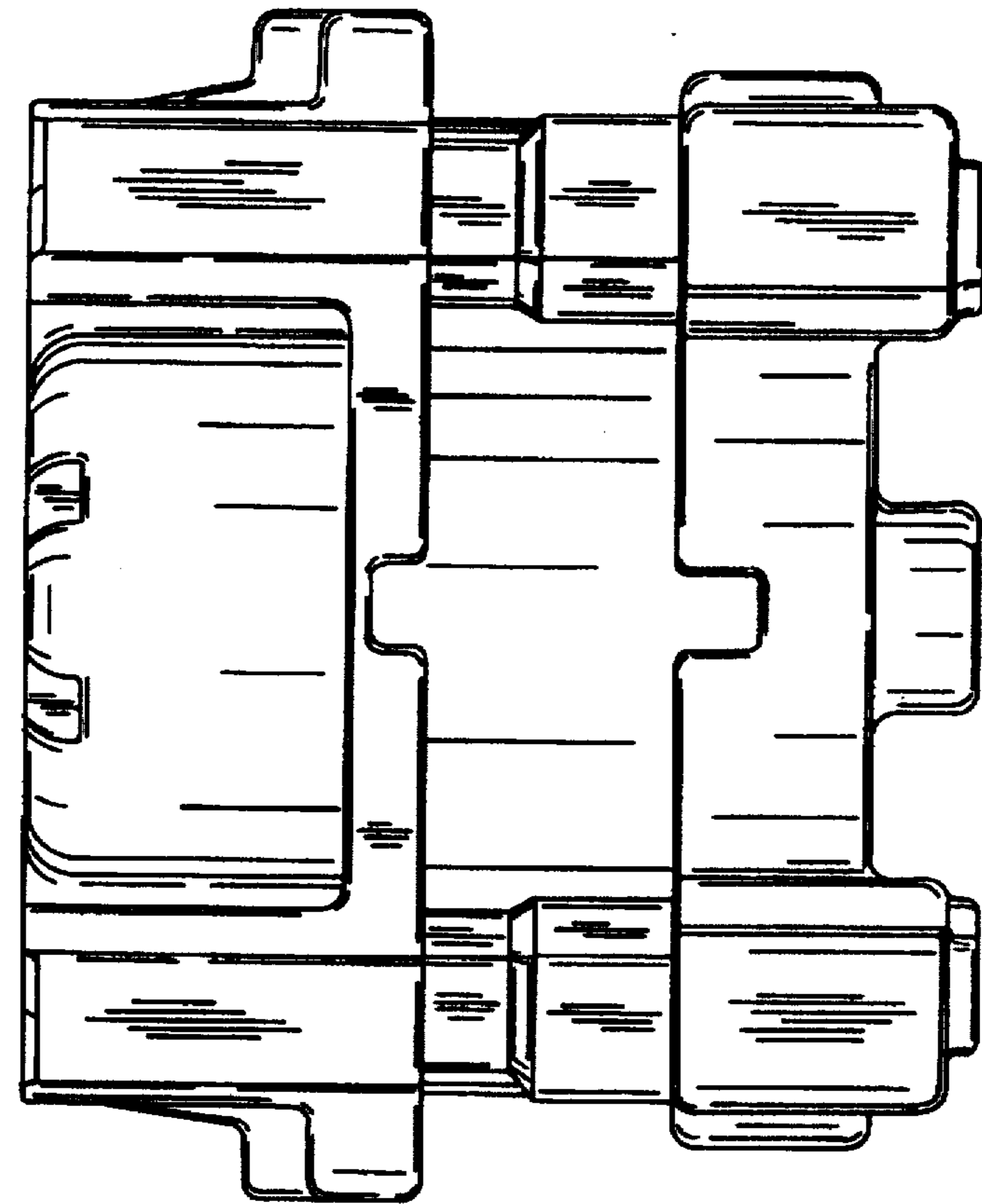

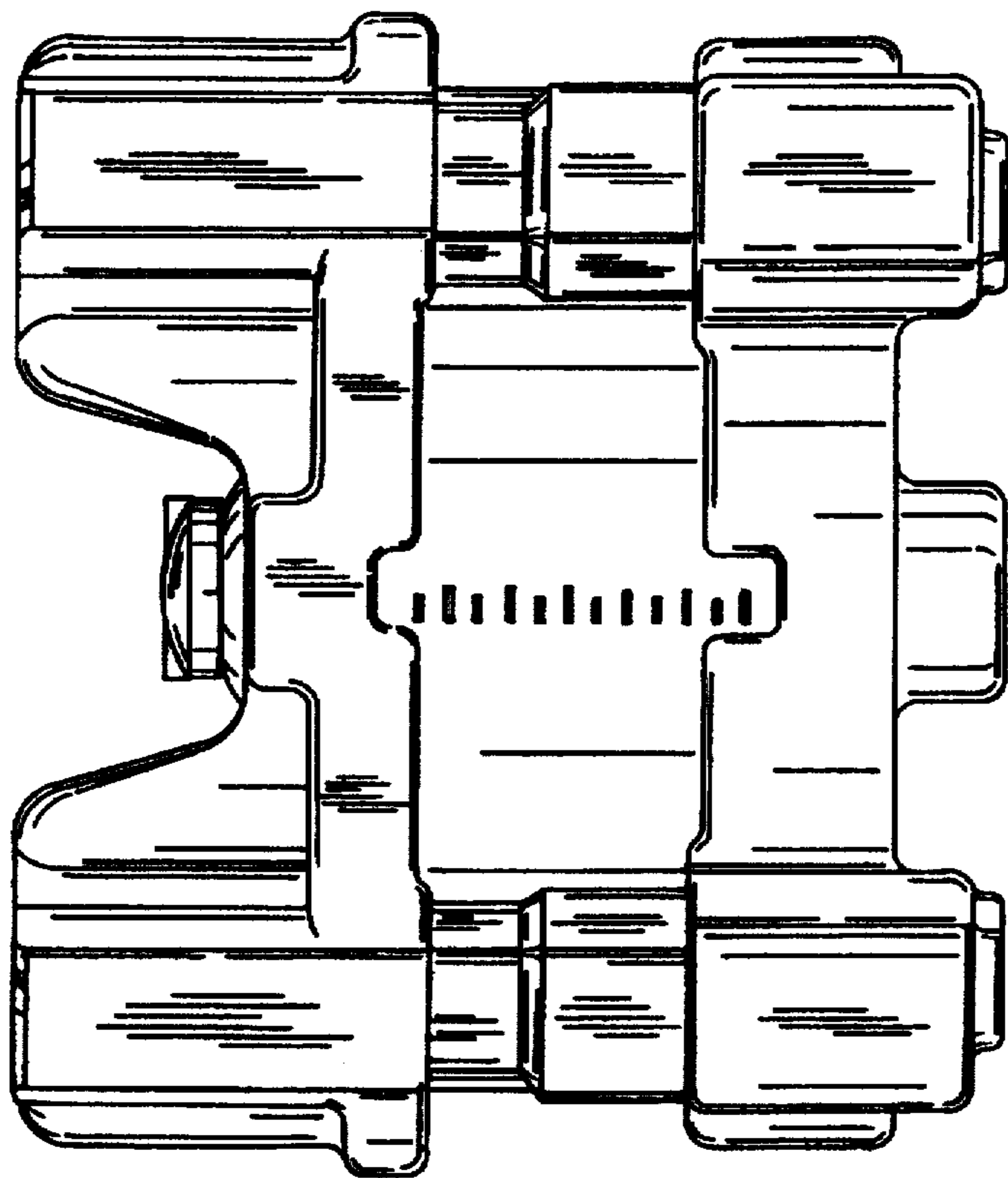

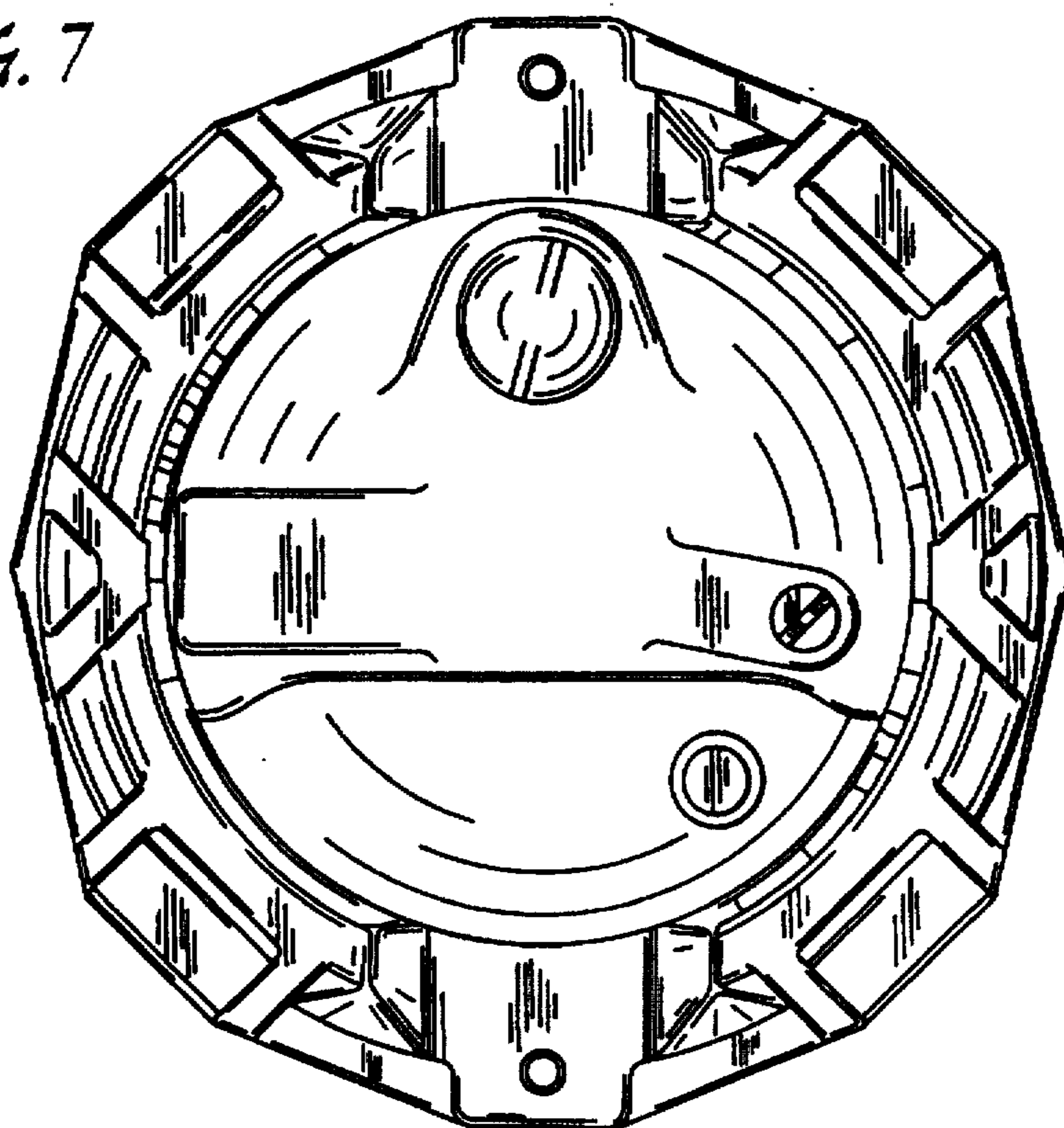

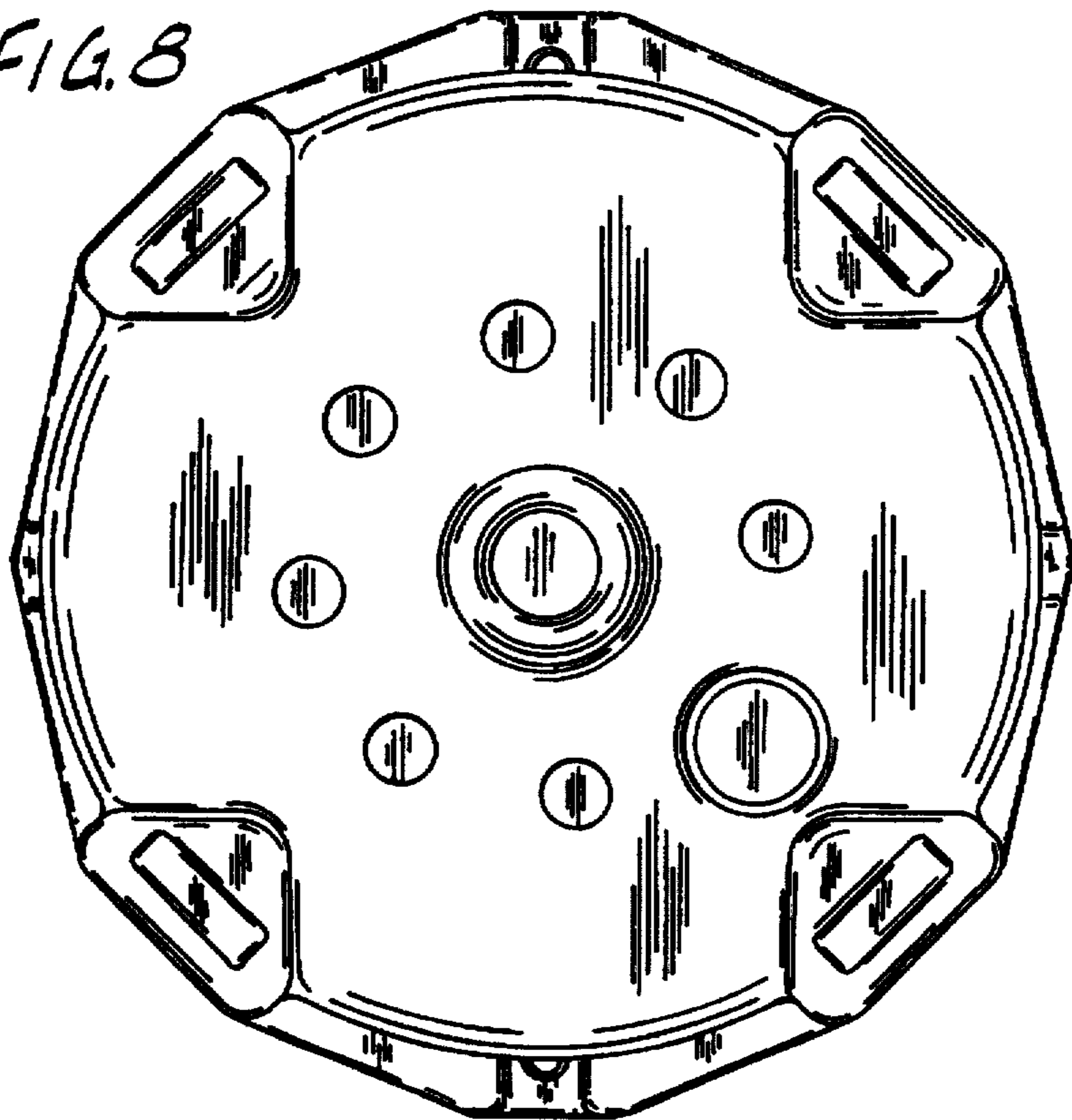

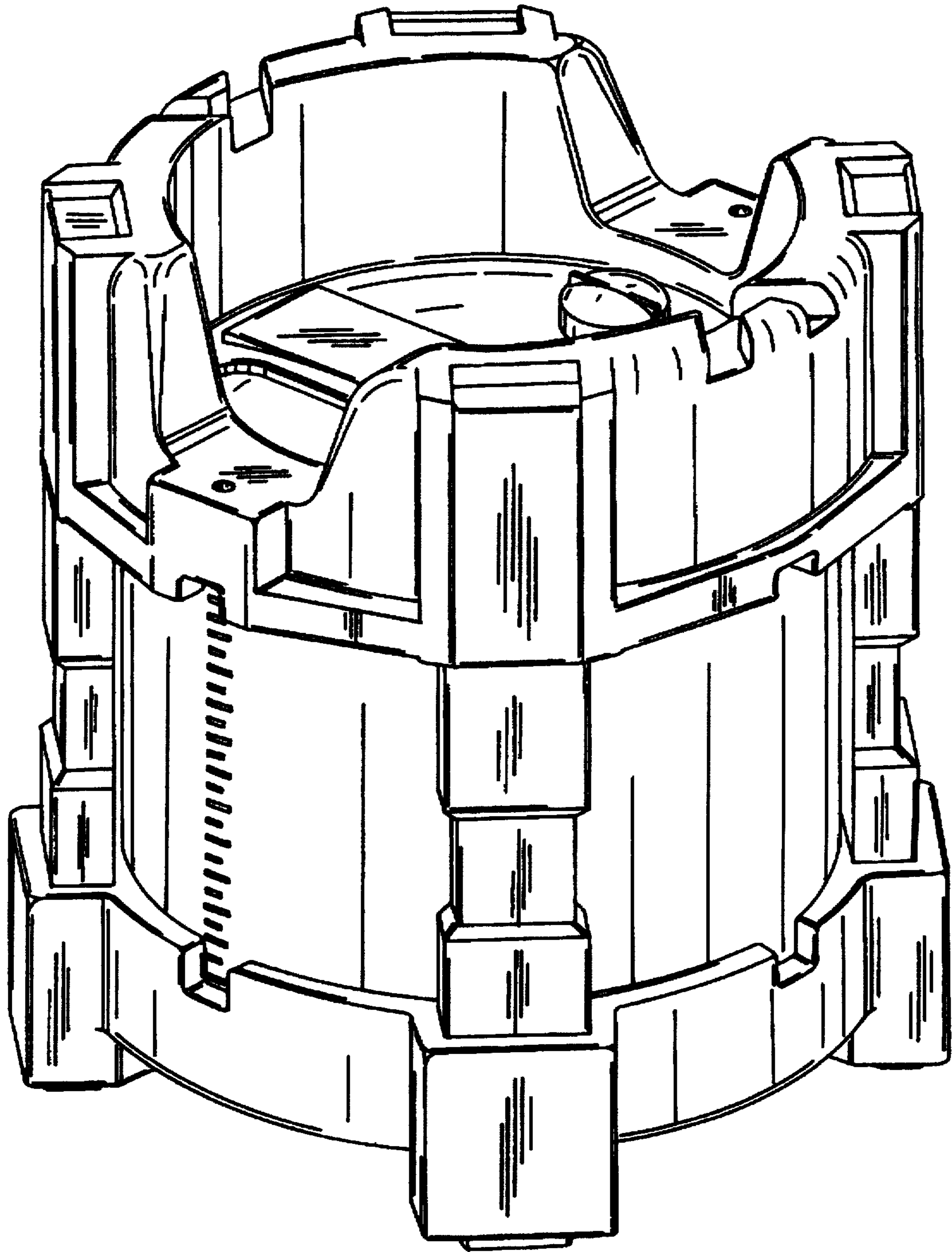
