**DESCRIPTION**

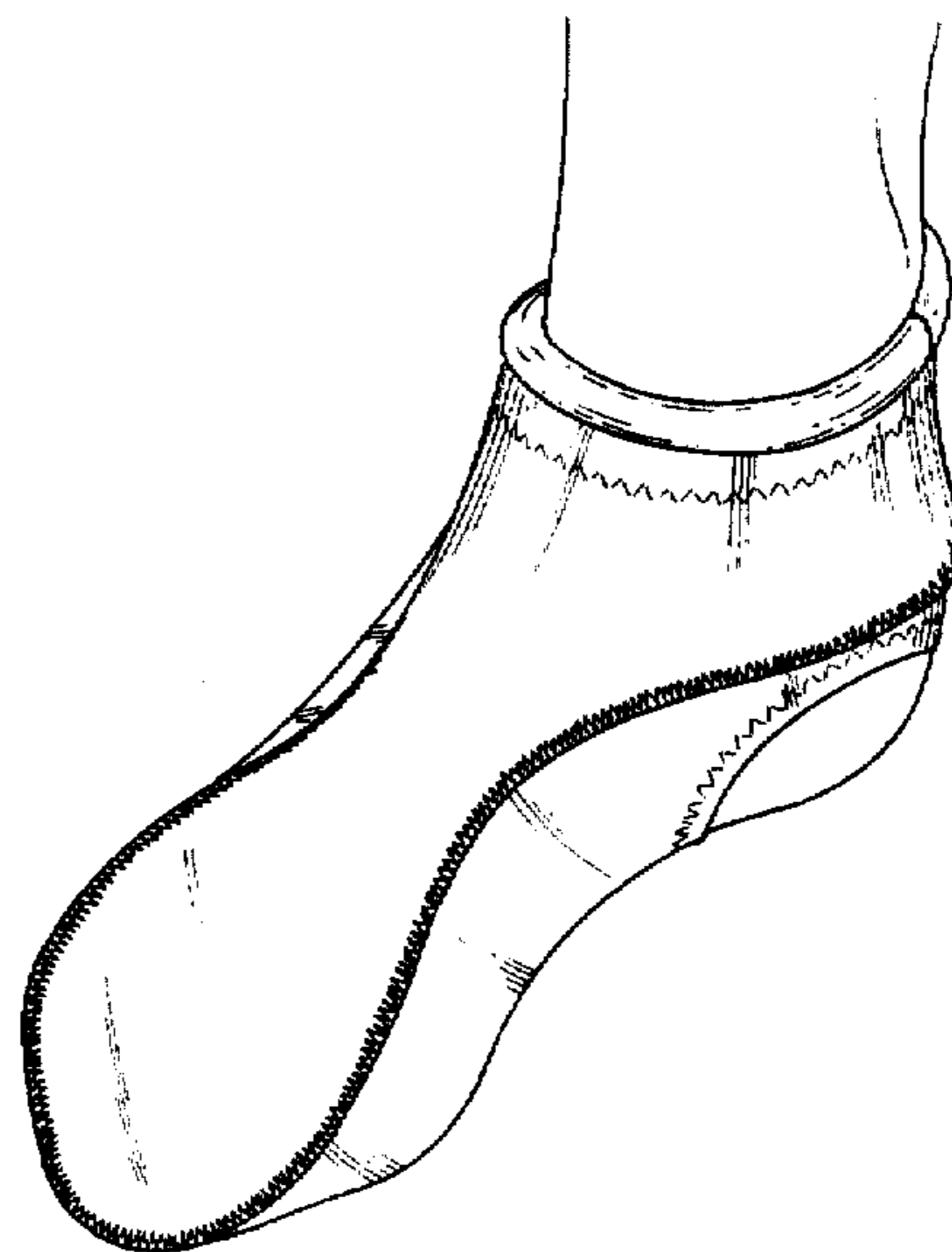
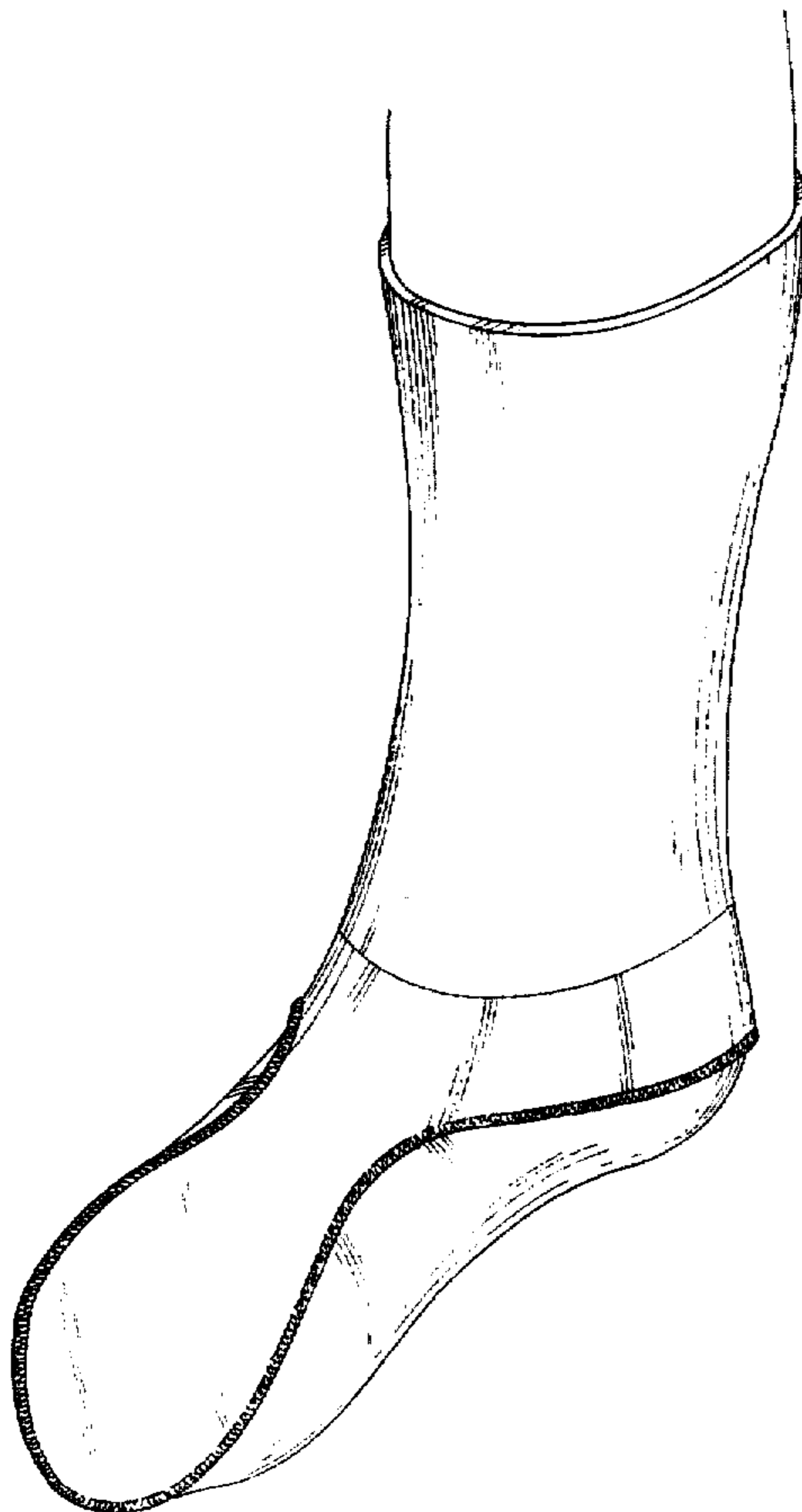

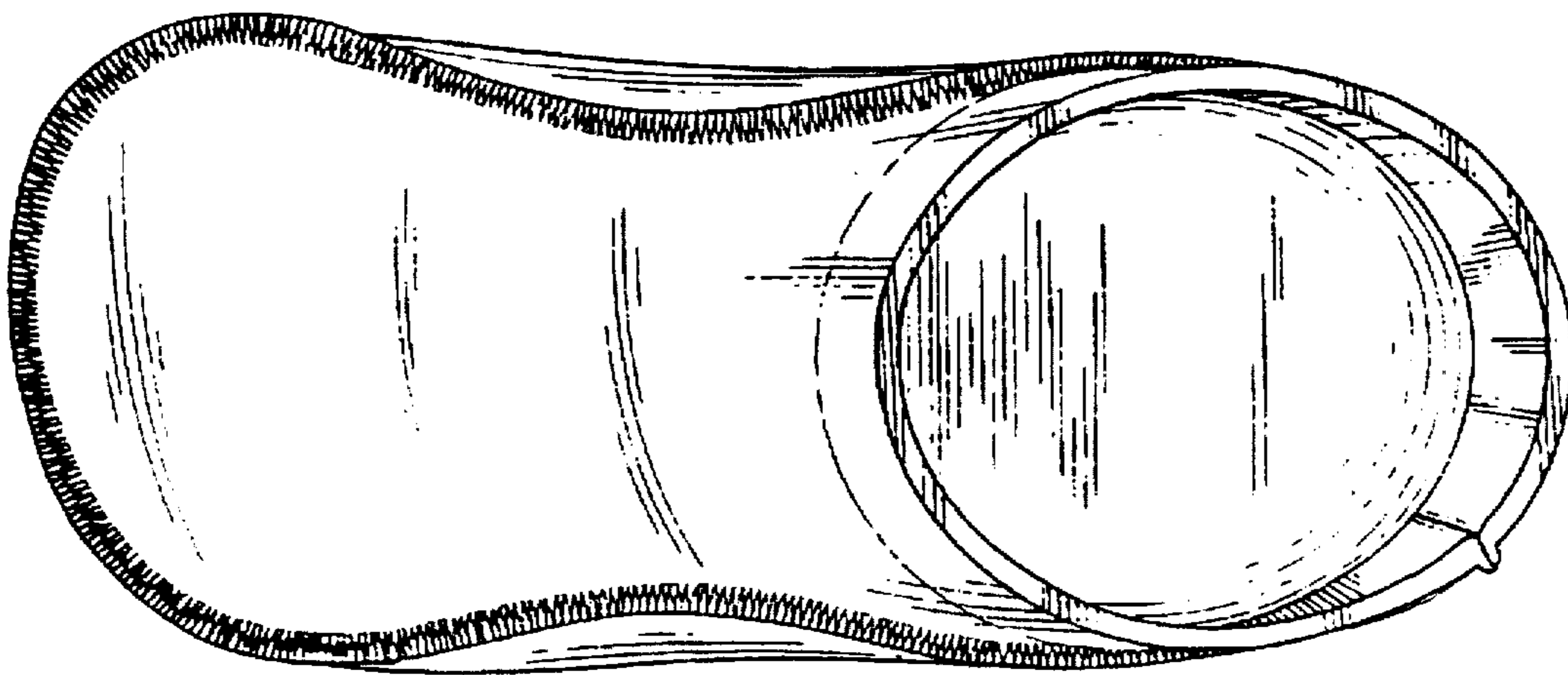
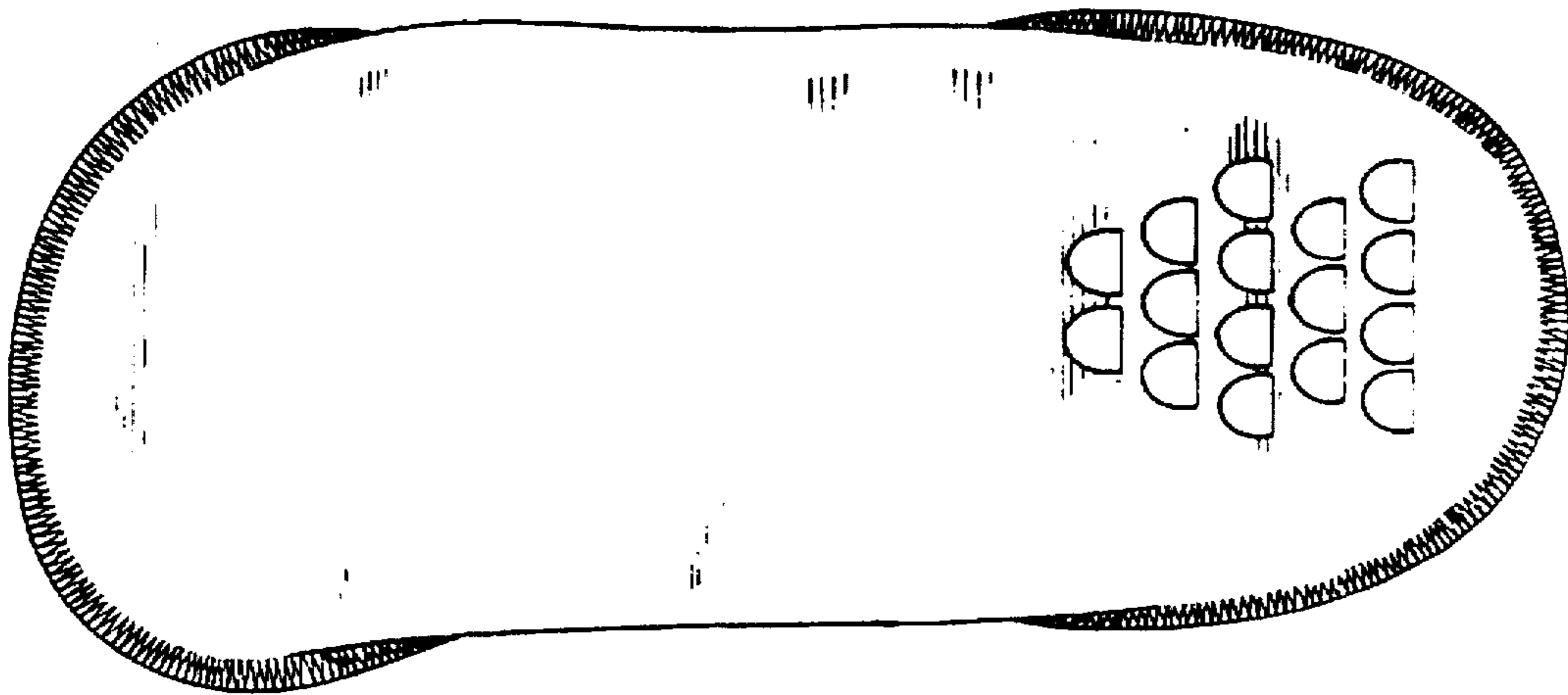

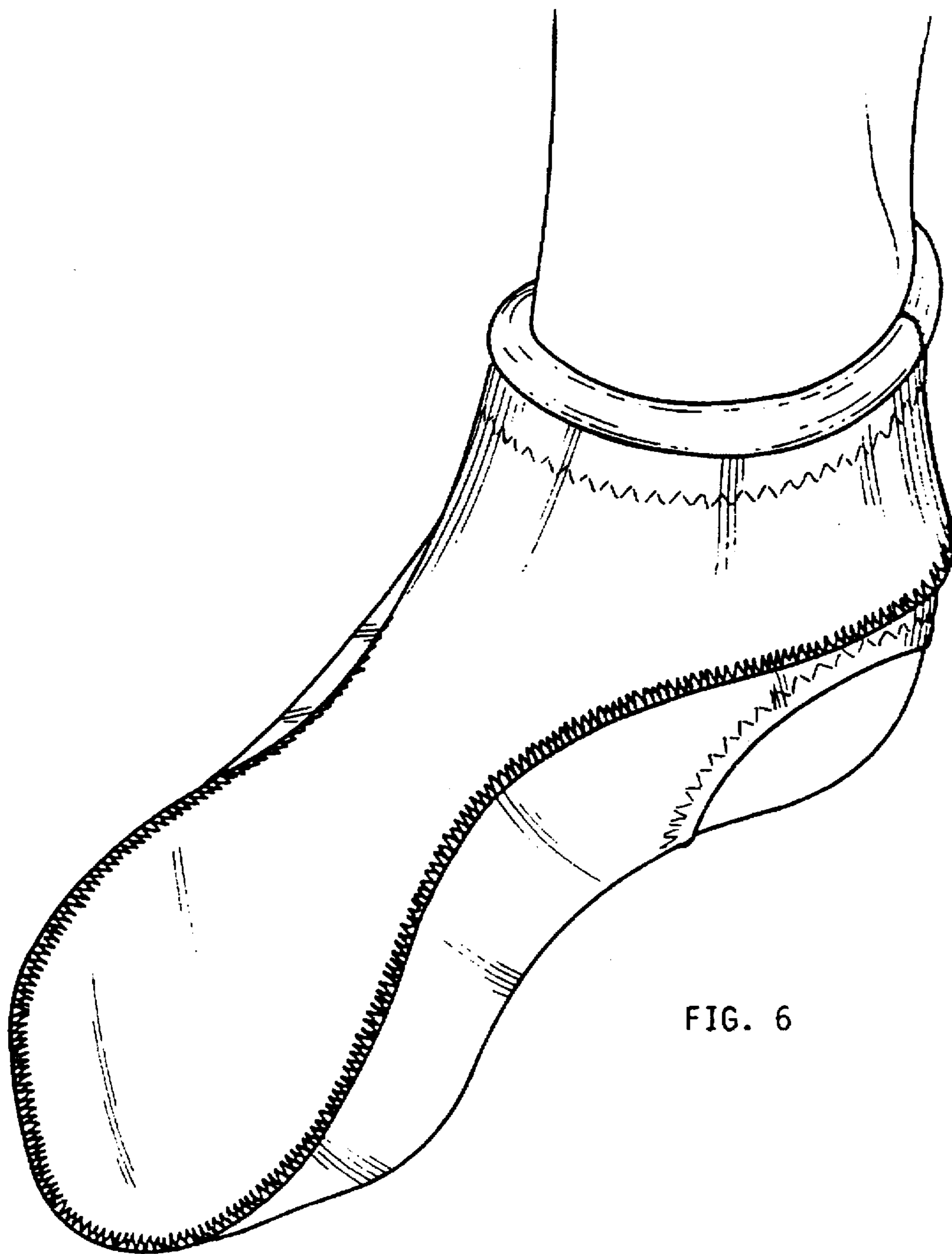

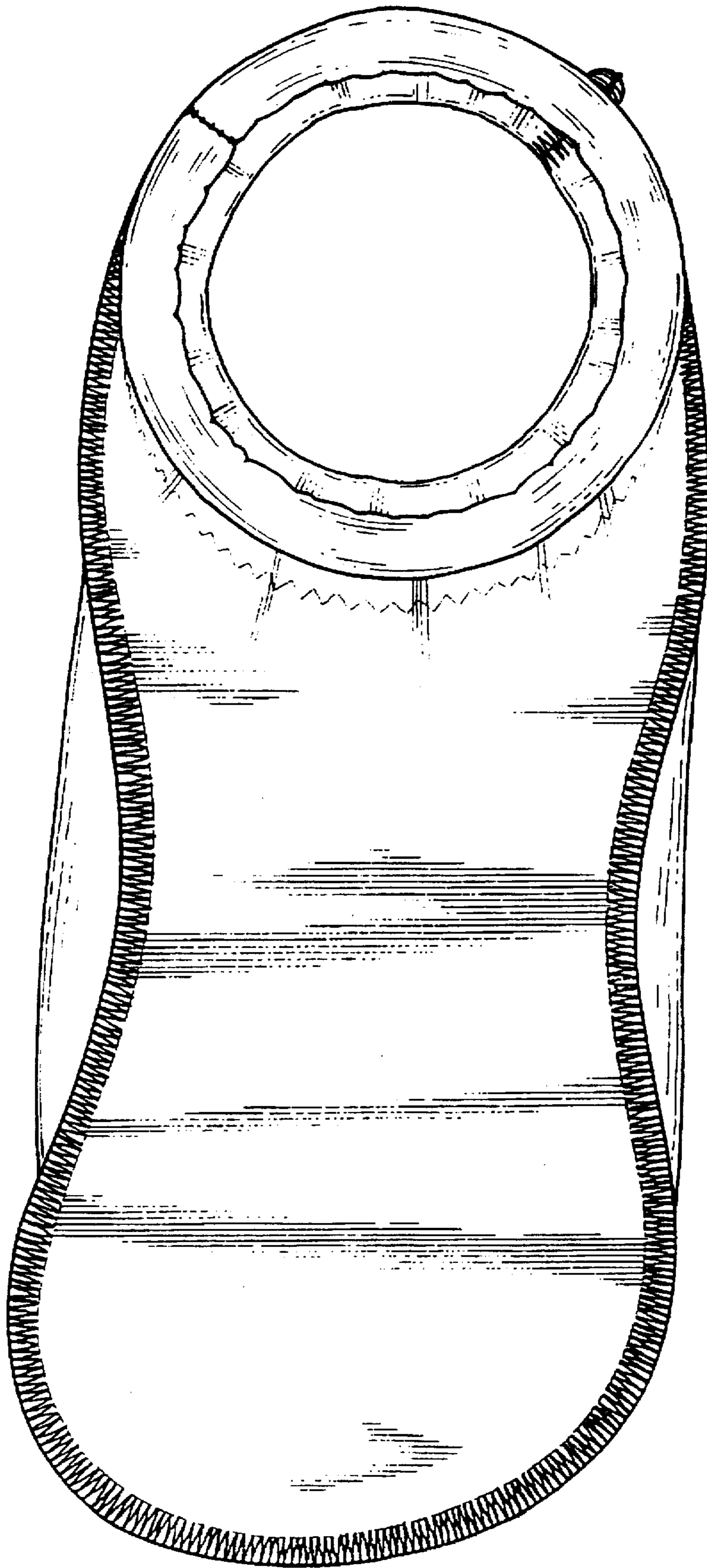

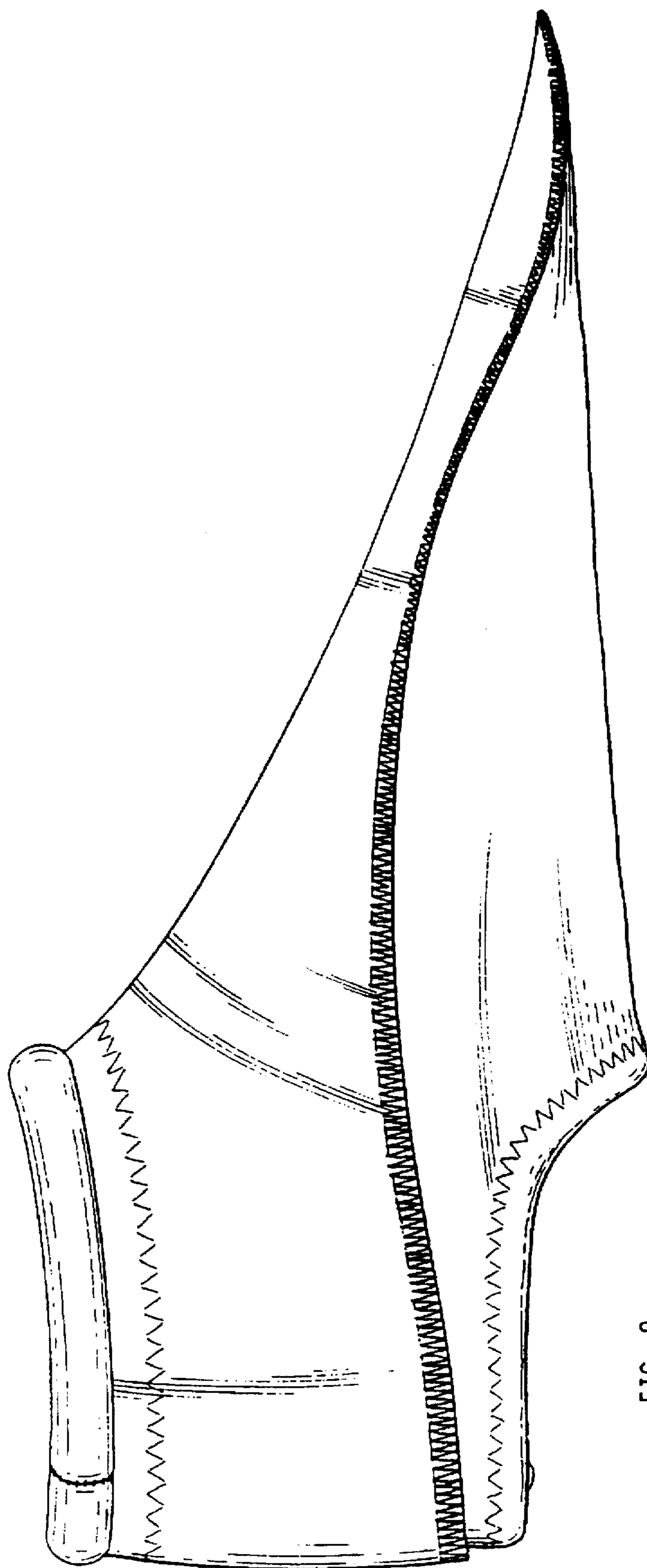

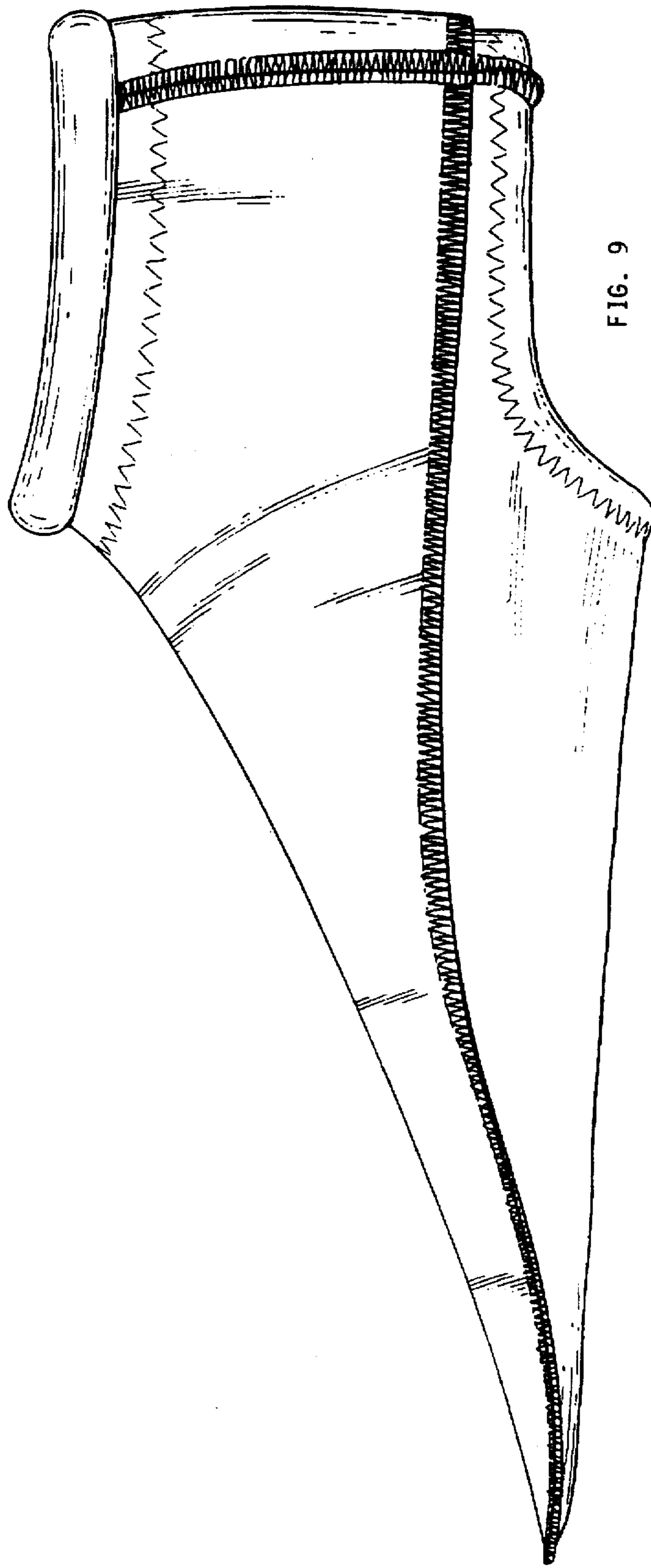

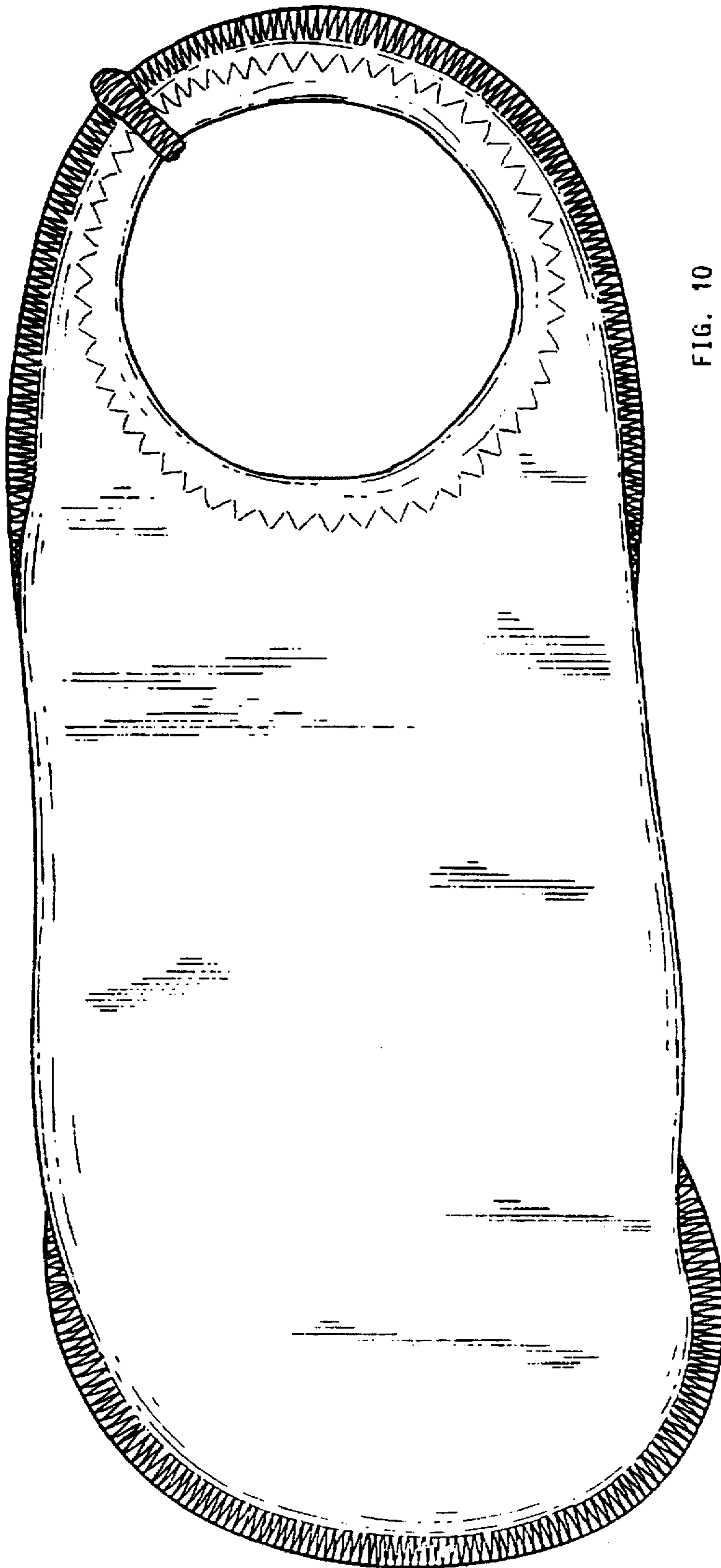
