The ornamental design for a compact disc storage case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a compact disc storage case showing my new design;
FIG. 2 is a rear-elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front-elevational view thereof;
FIG. 5 is a left side-elevational view thereof;
FIG. 6 is a right side-elevational view thereof;

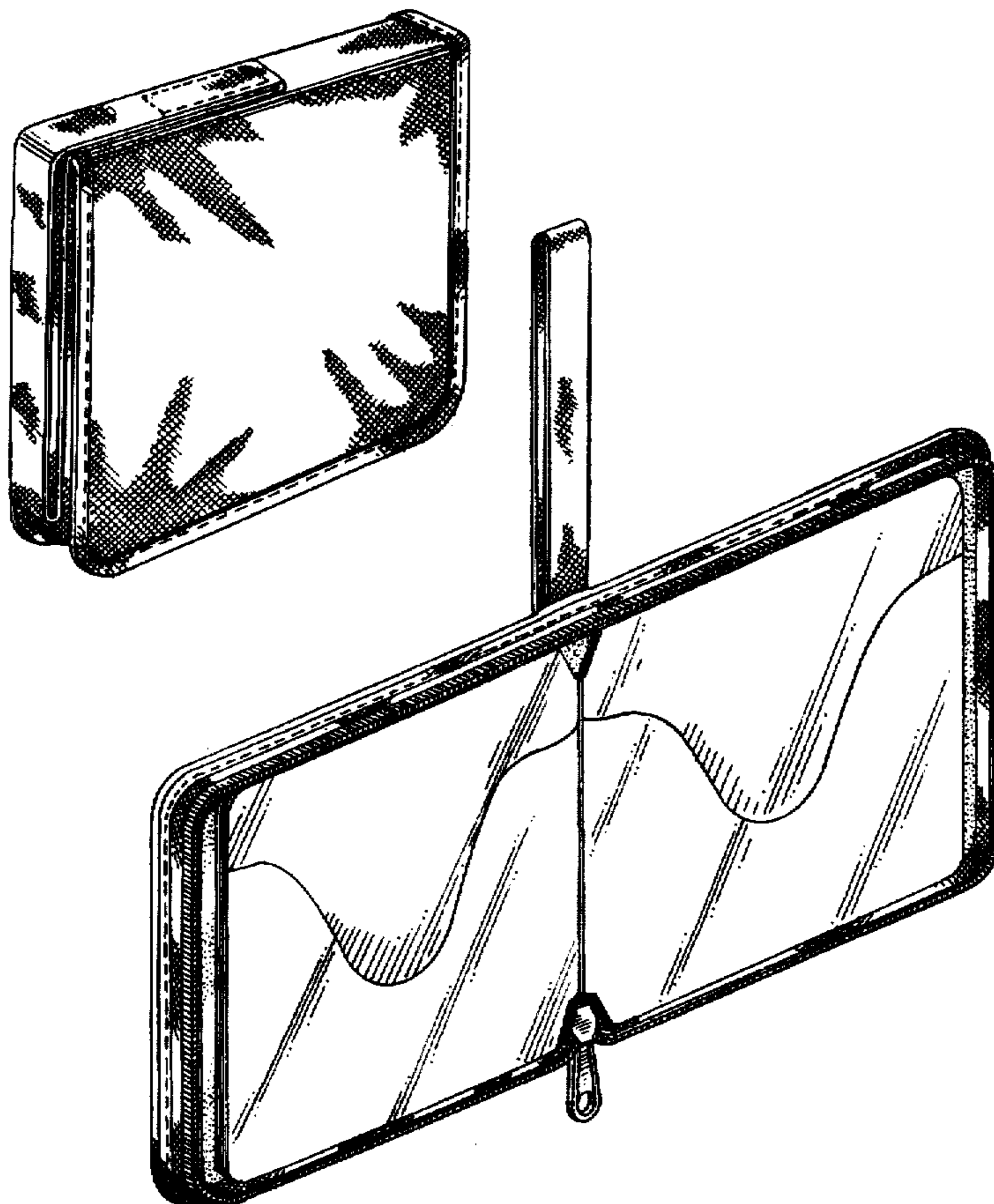

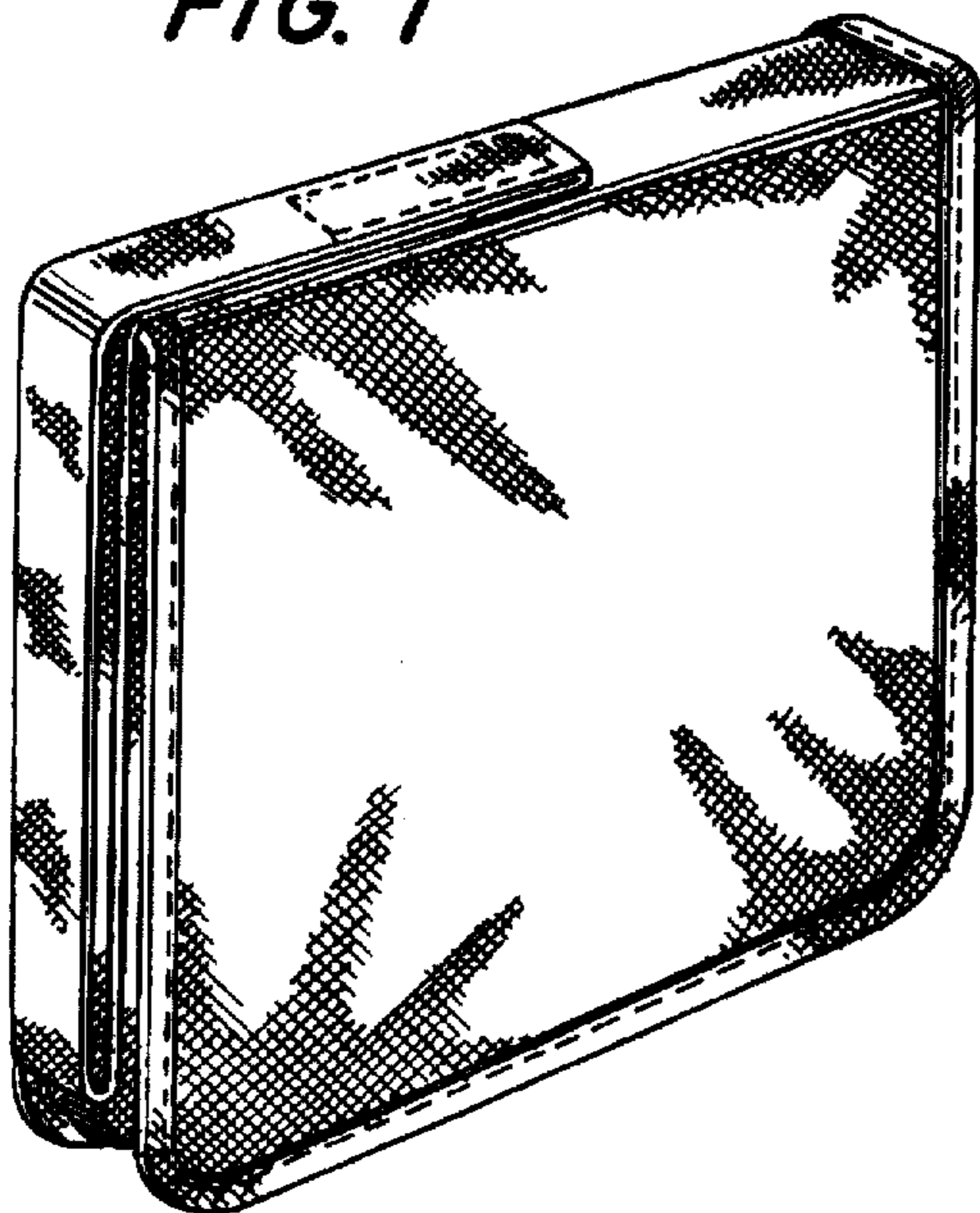

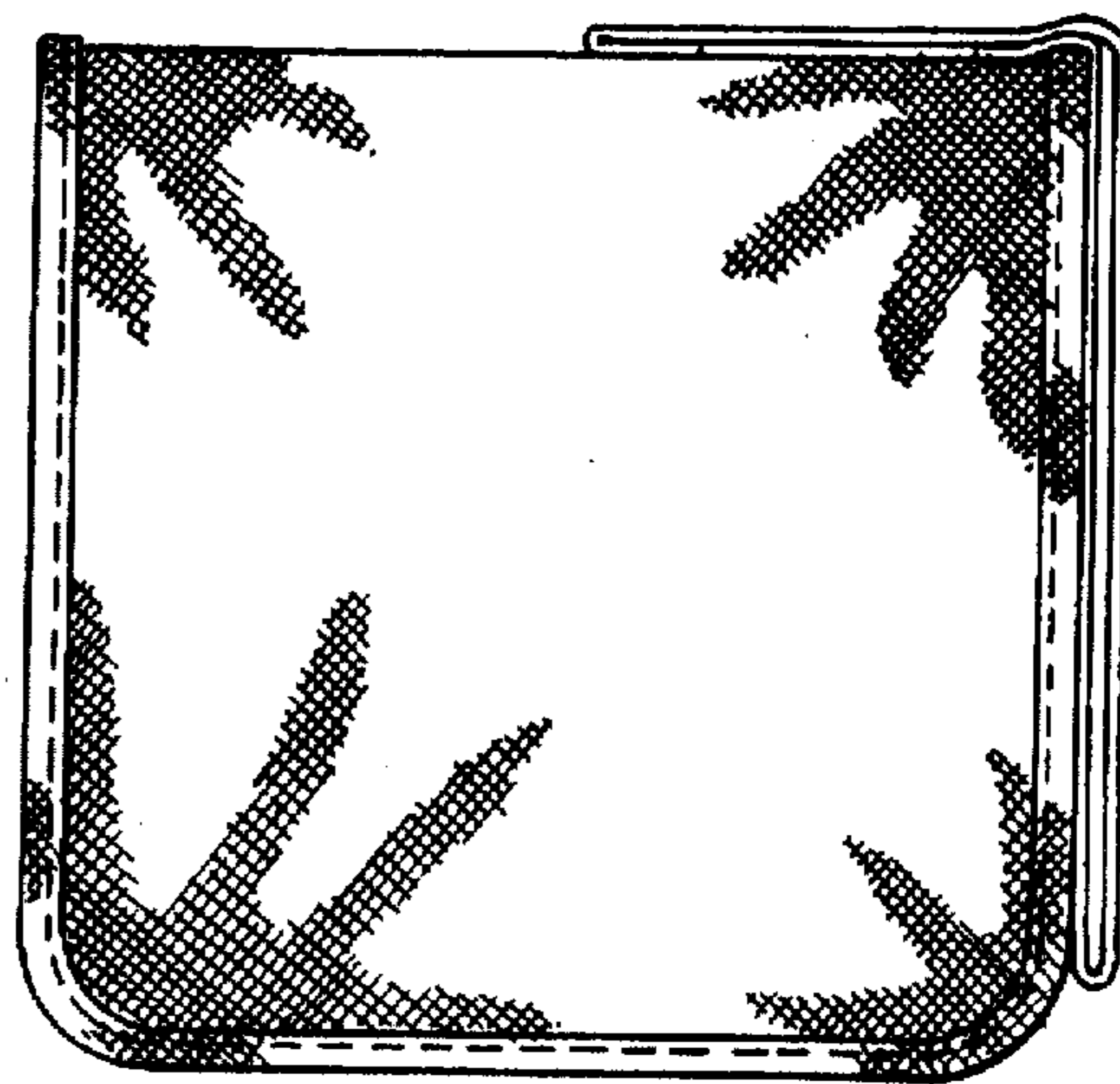

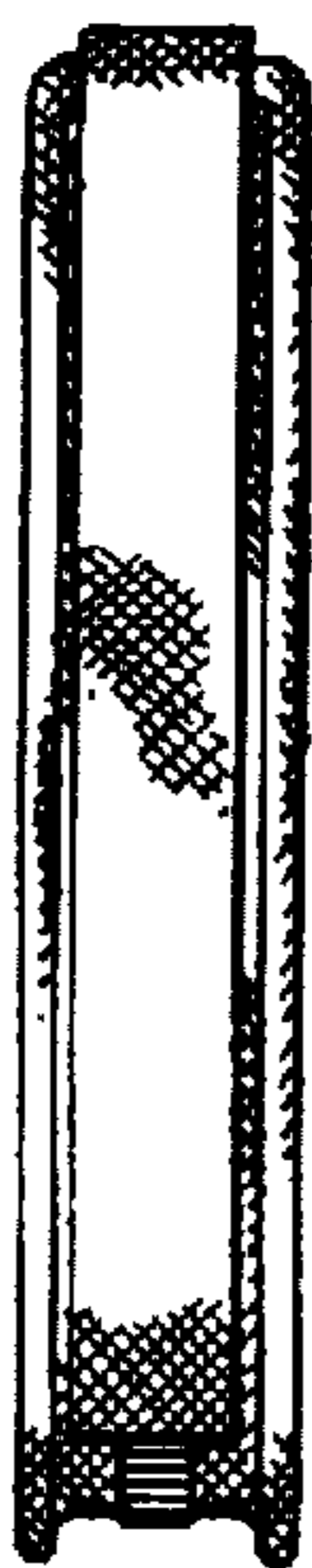

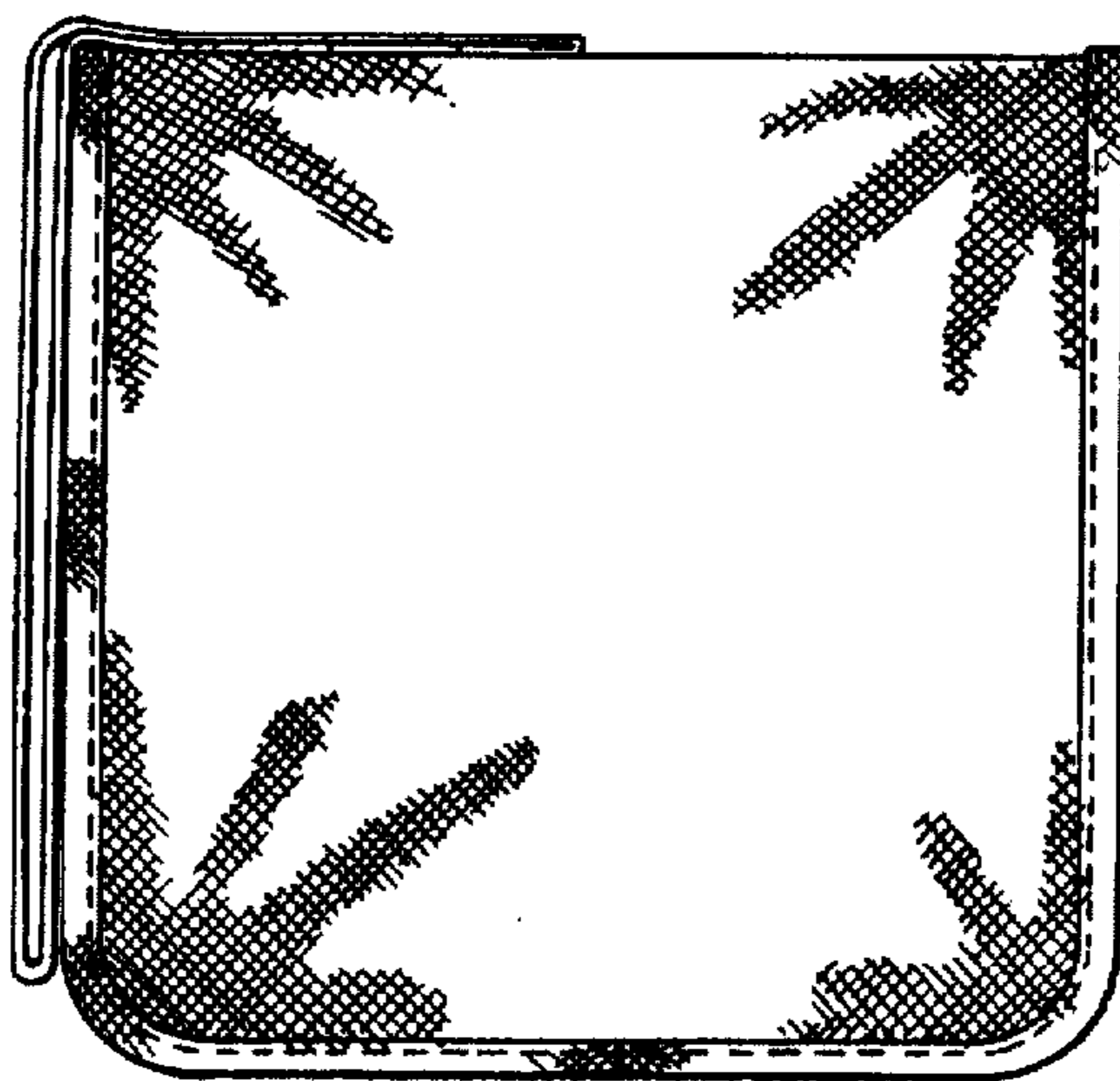
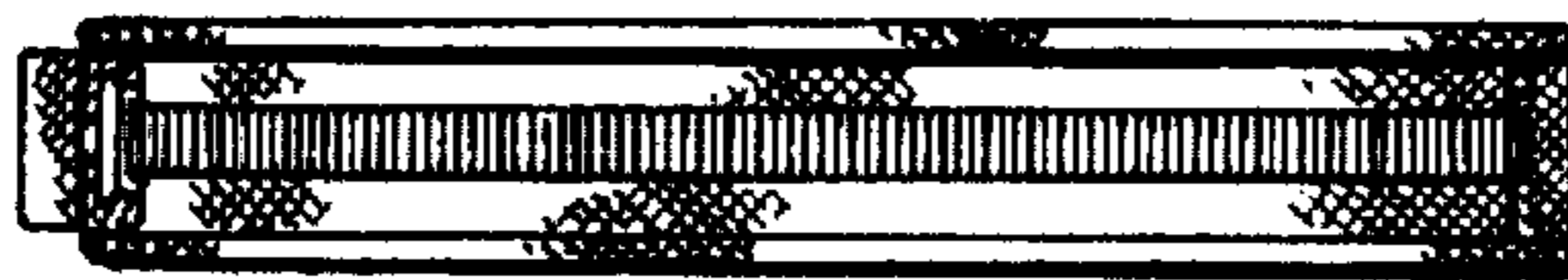

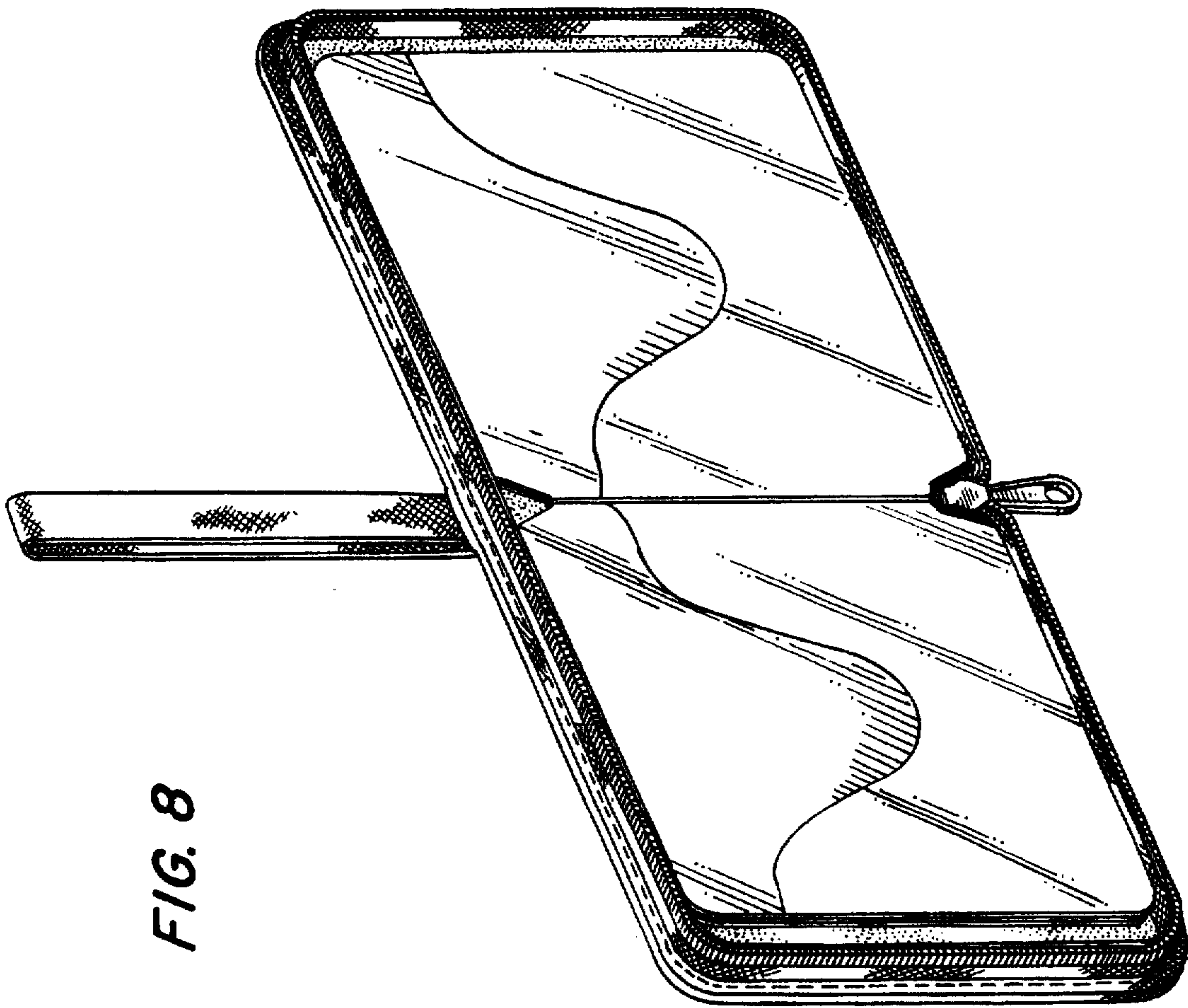
