[57] CLAIM

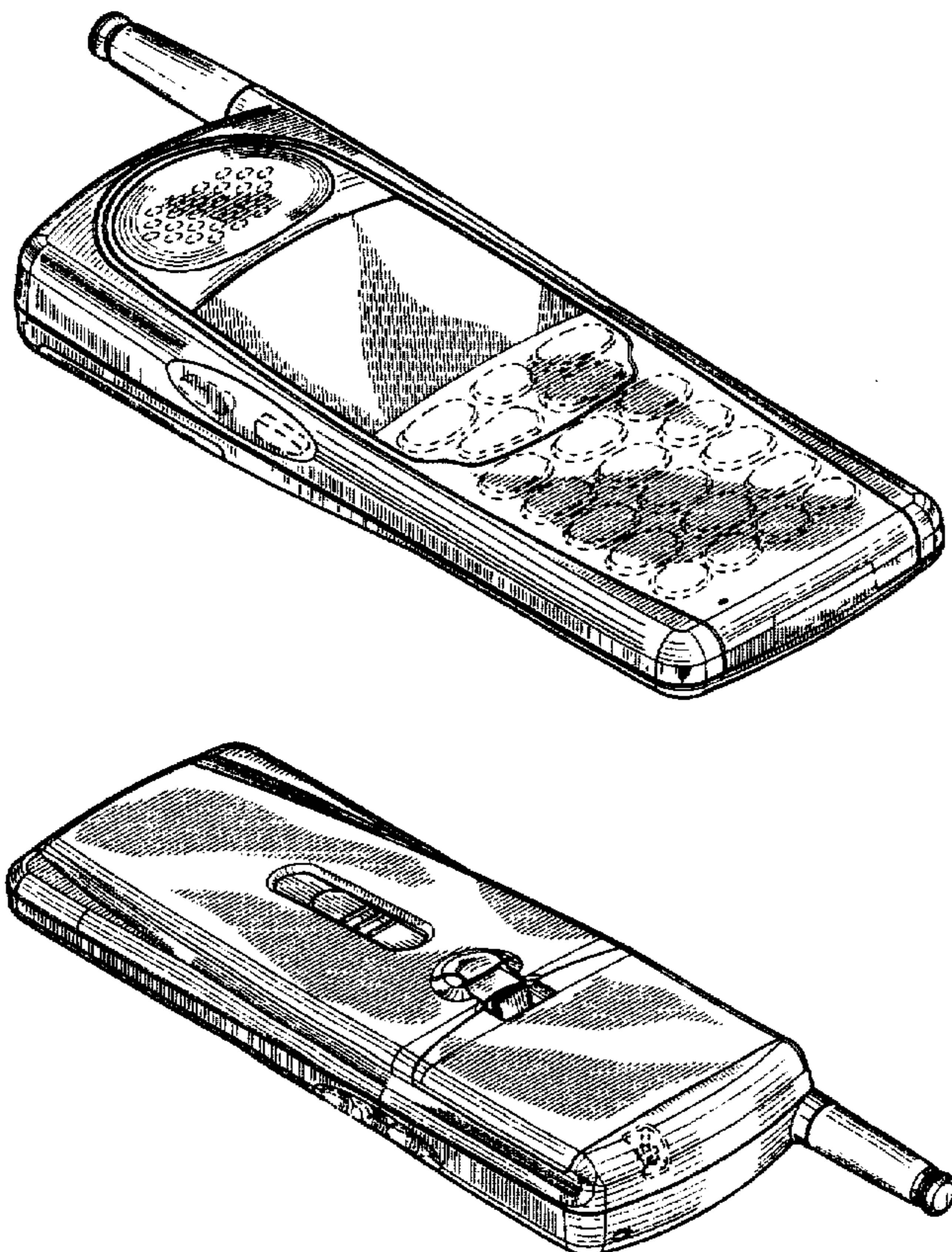
The ornamental design for a portable telephone, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom, and left side perspective view showing our new design for a portable telephone;
 FIG. 2 is a back, top, and left side perspective view thereof;
 FIG. 3 is a left side elevation view thereof;
 FIG. 4 is a right side elevation view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof; and,
 FIG. 7 is a rear elevation view thereof.

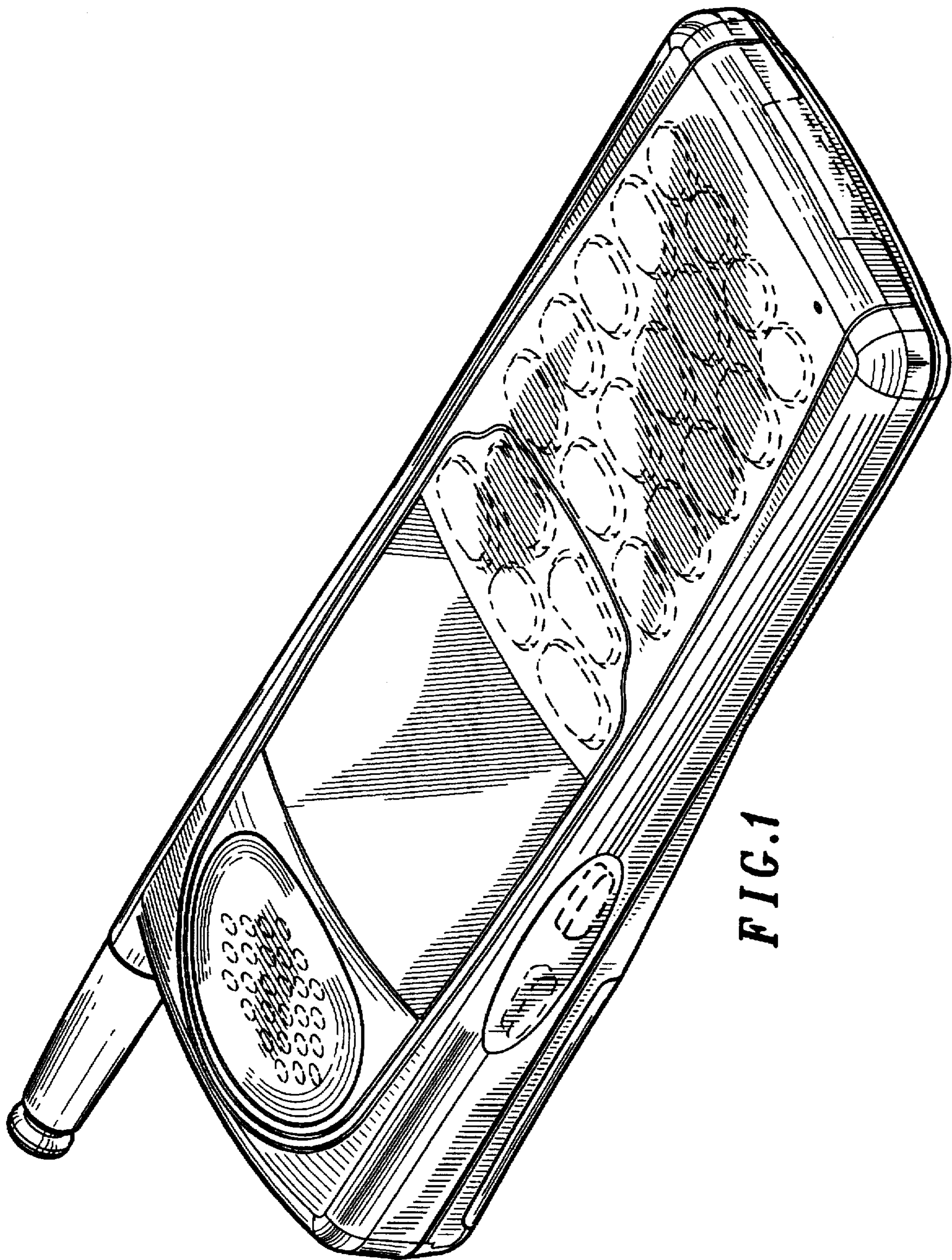

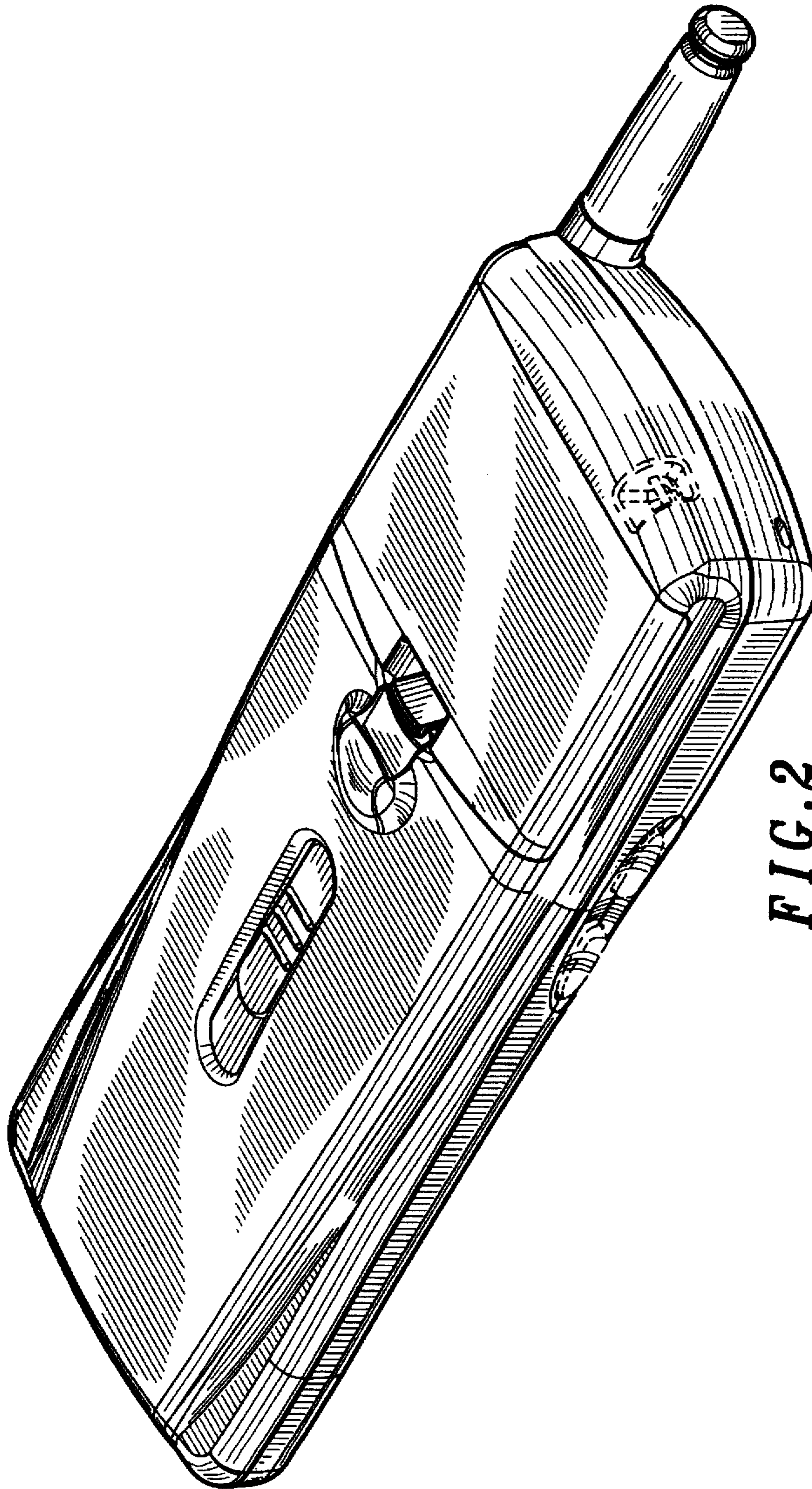

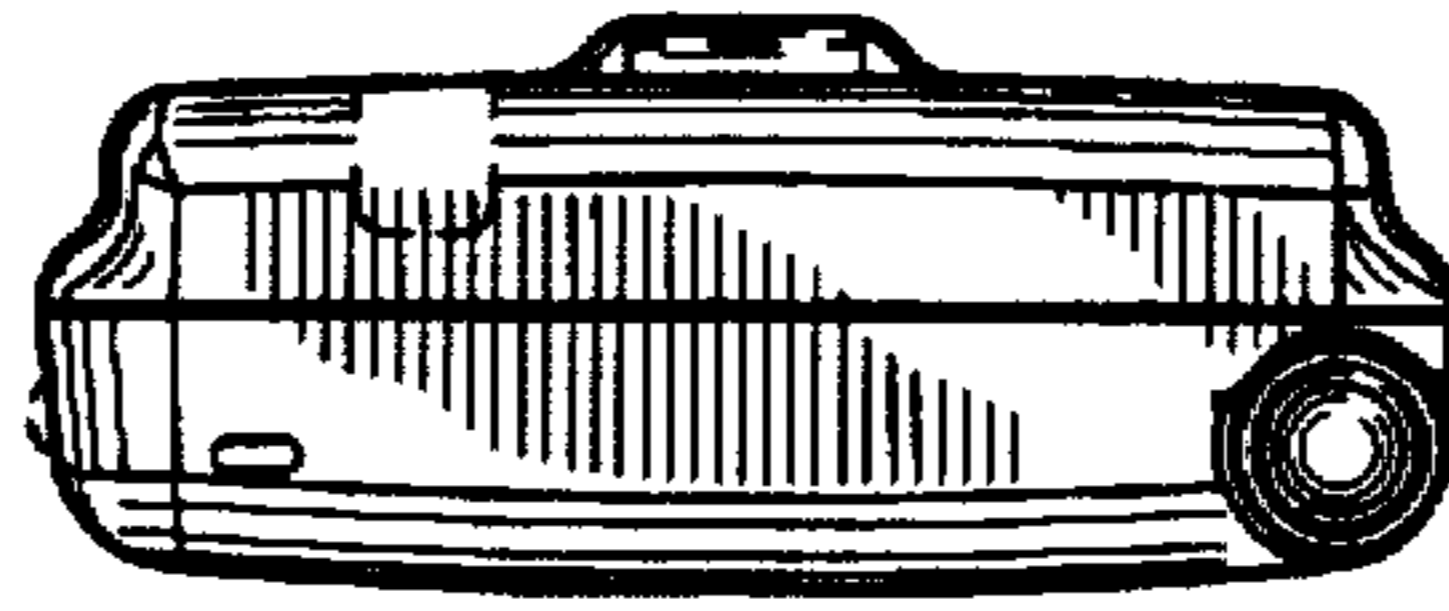

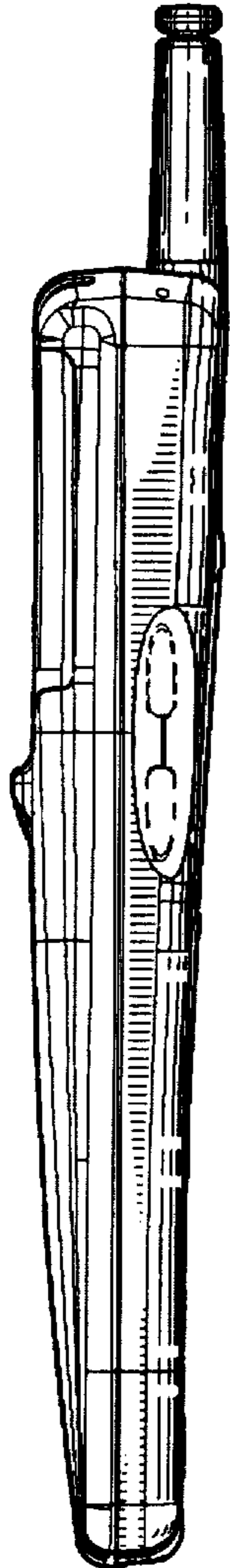

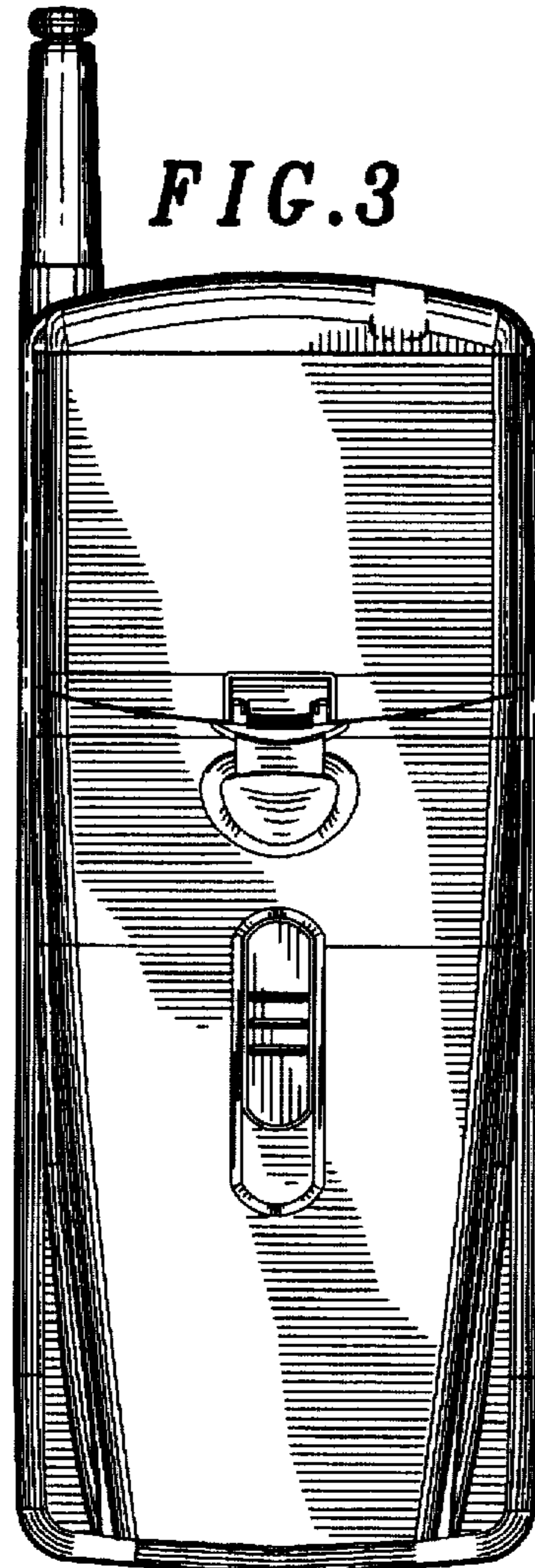
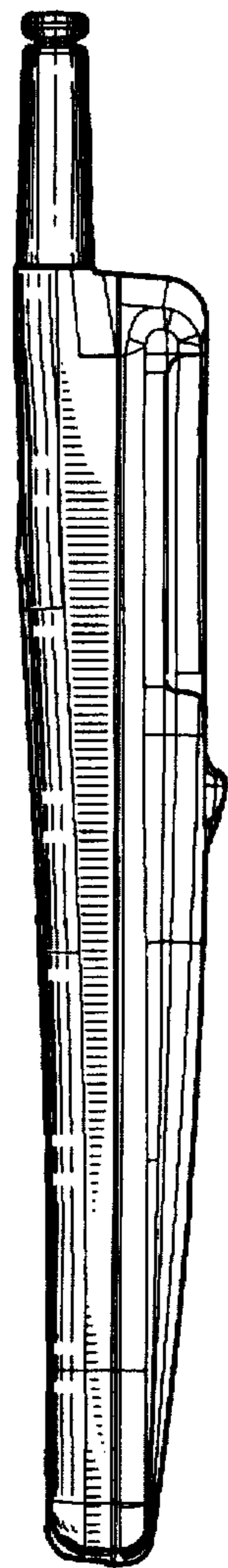
