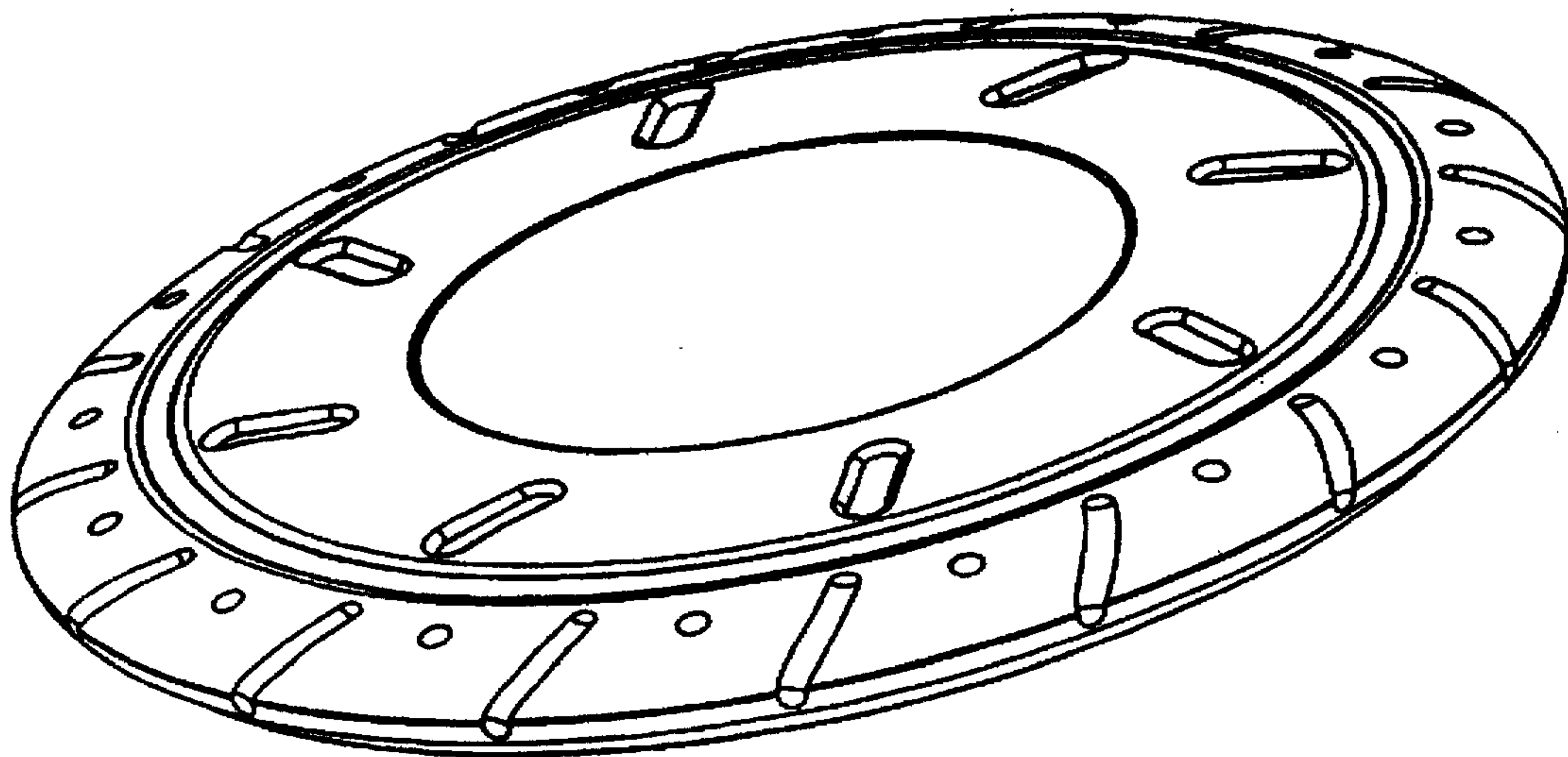
[57] **CLAIM**

The ornamental design for a high performance flying disc, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a high performance flying disc showing my new design;
 FIG. 2 is a top plan view of the flying disc shown in FIG. 1;
 FIG. 3 is a bottom plan view of the flying disc shown in FIG. 1;
 FIG. 4 is a left side view of the flying disc shown in FIG. 1; and,
 FIG. 5 is a right side view of the flying disc shown in FIG. 1.

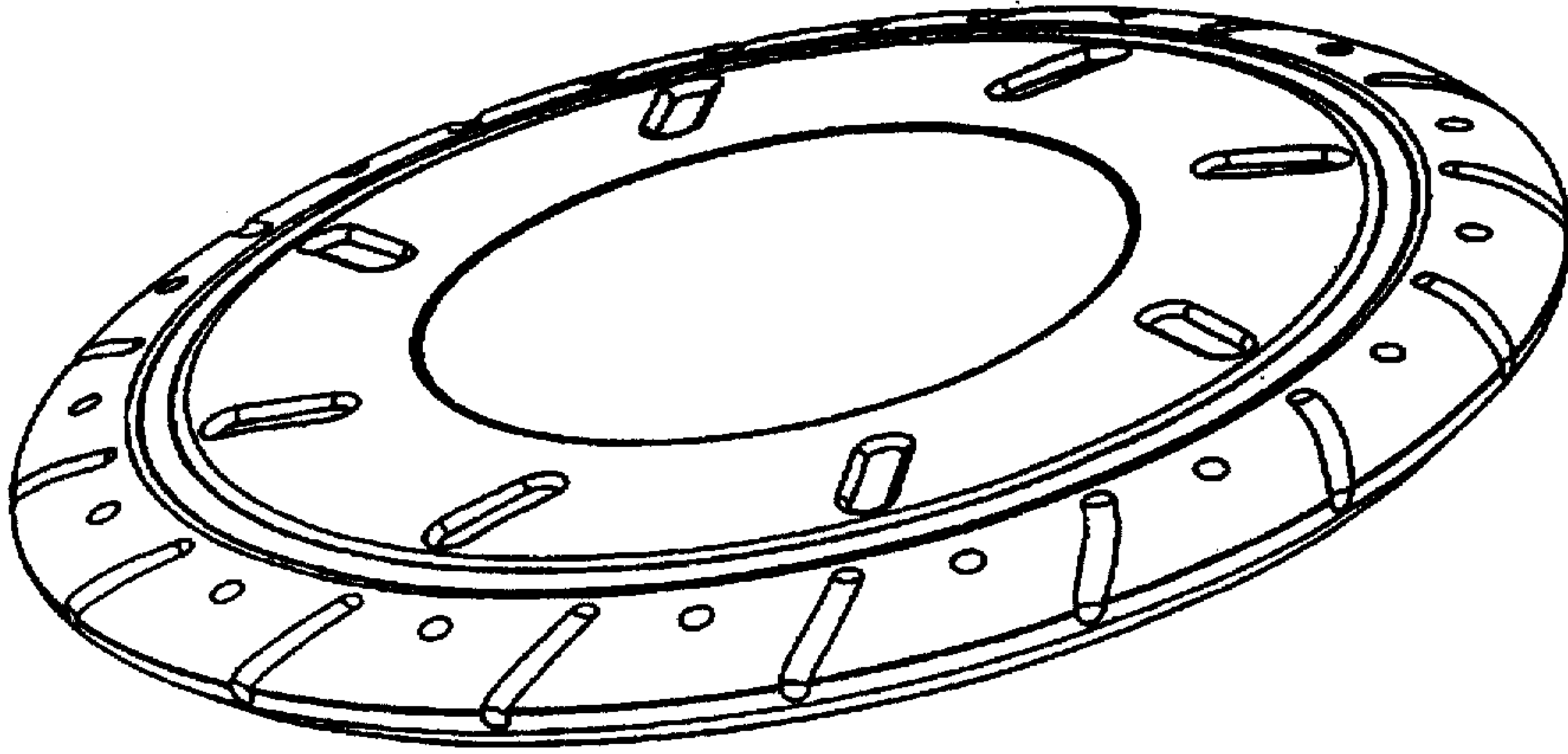

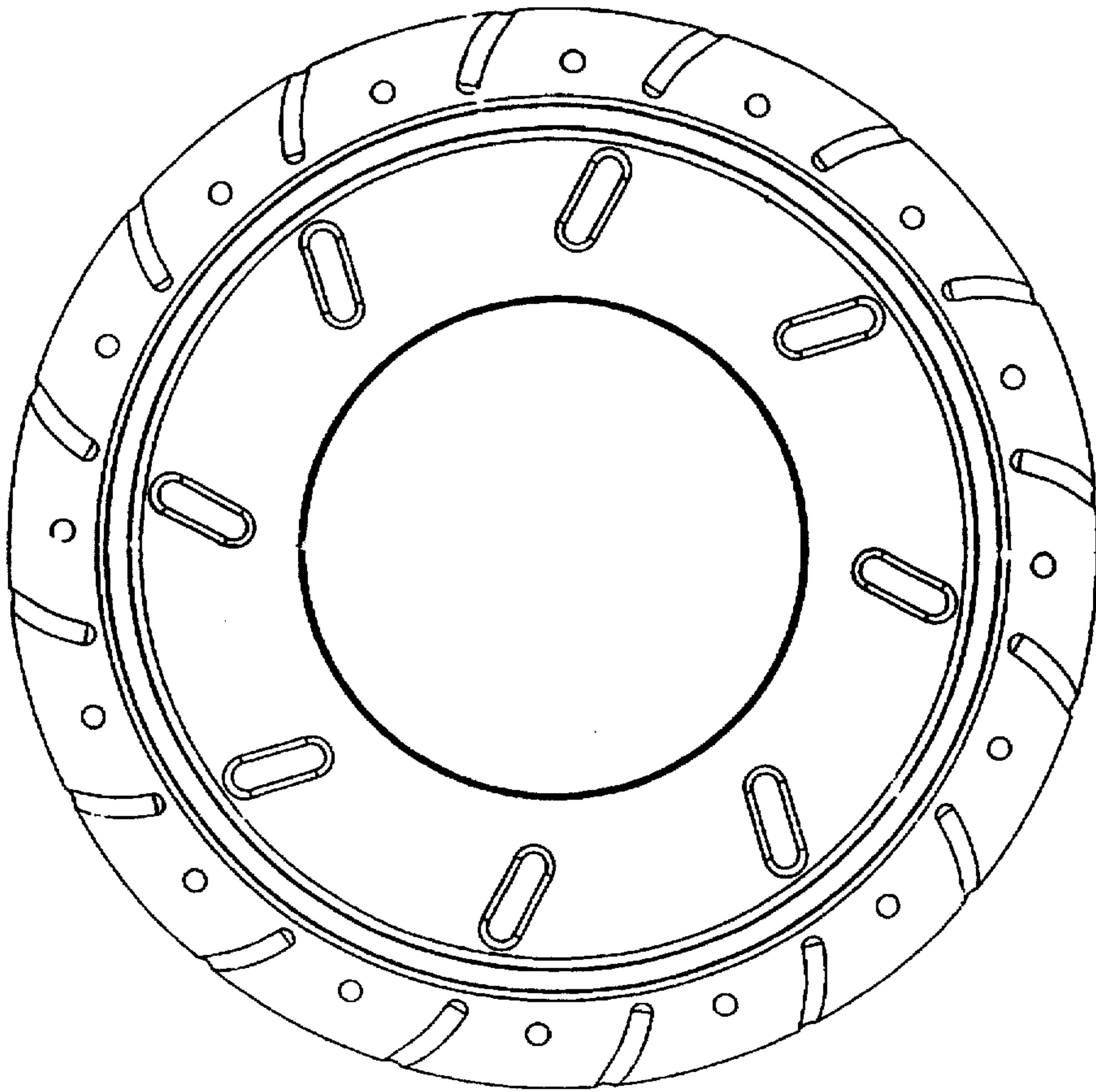

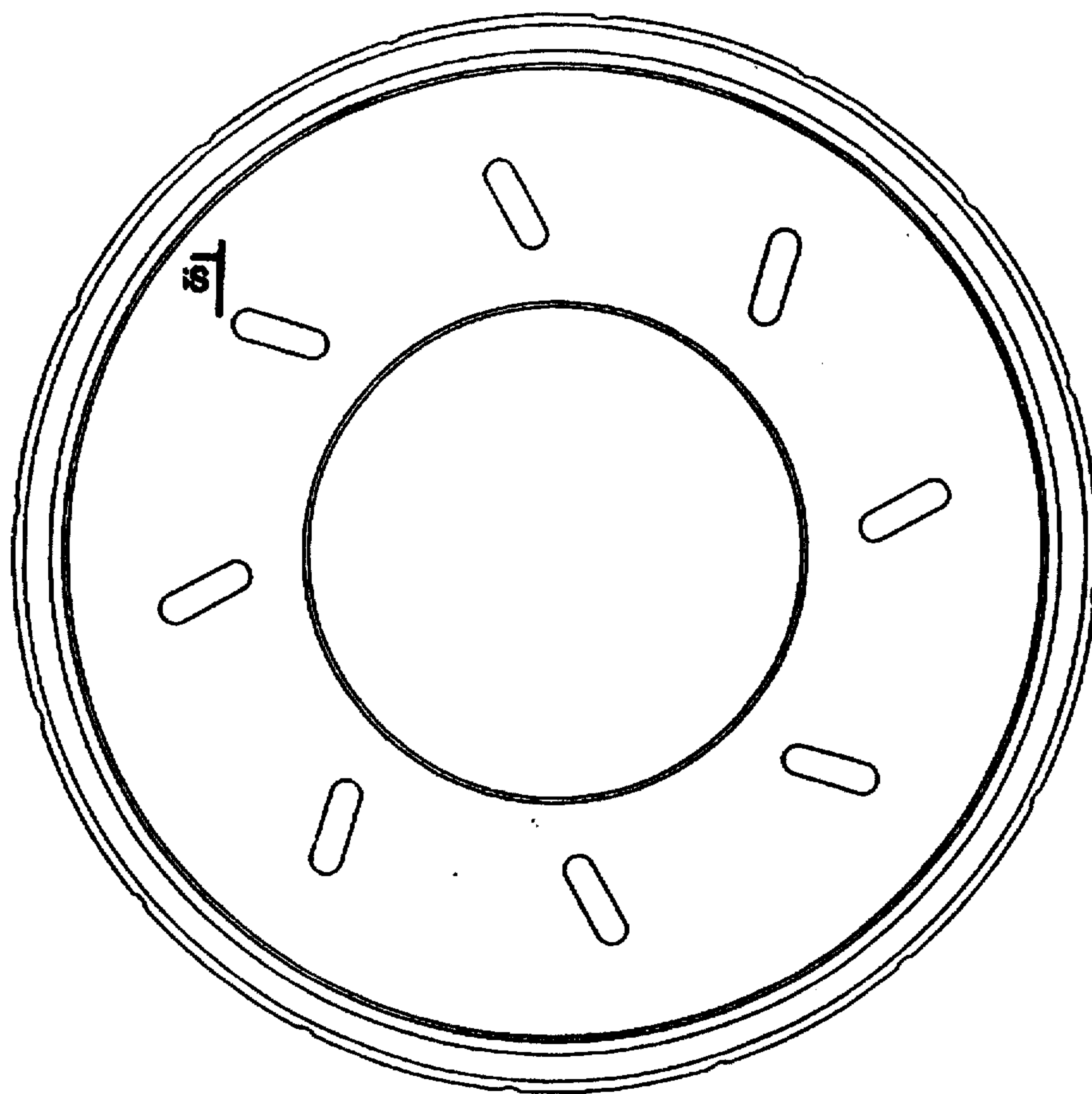

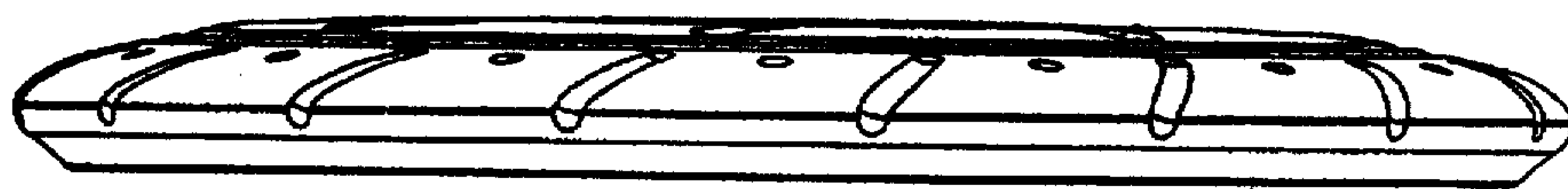

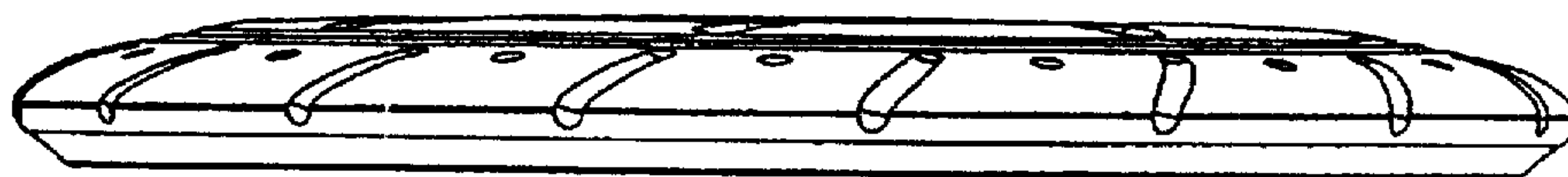
