DESCRIPTION

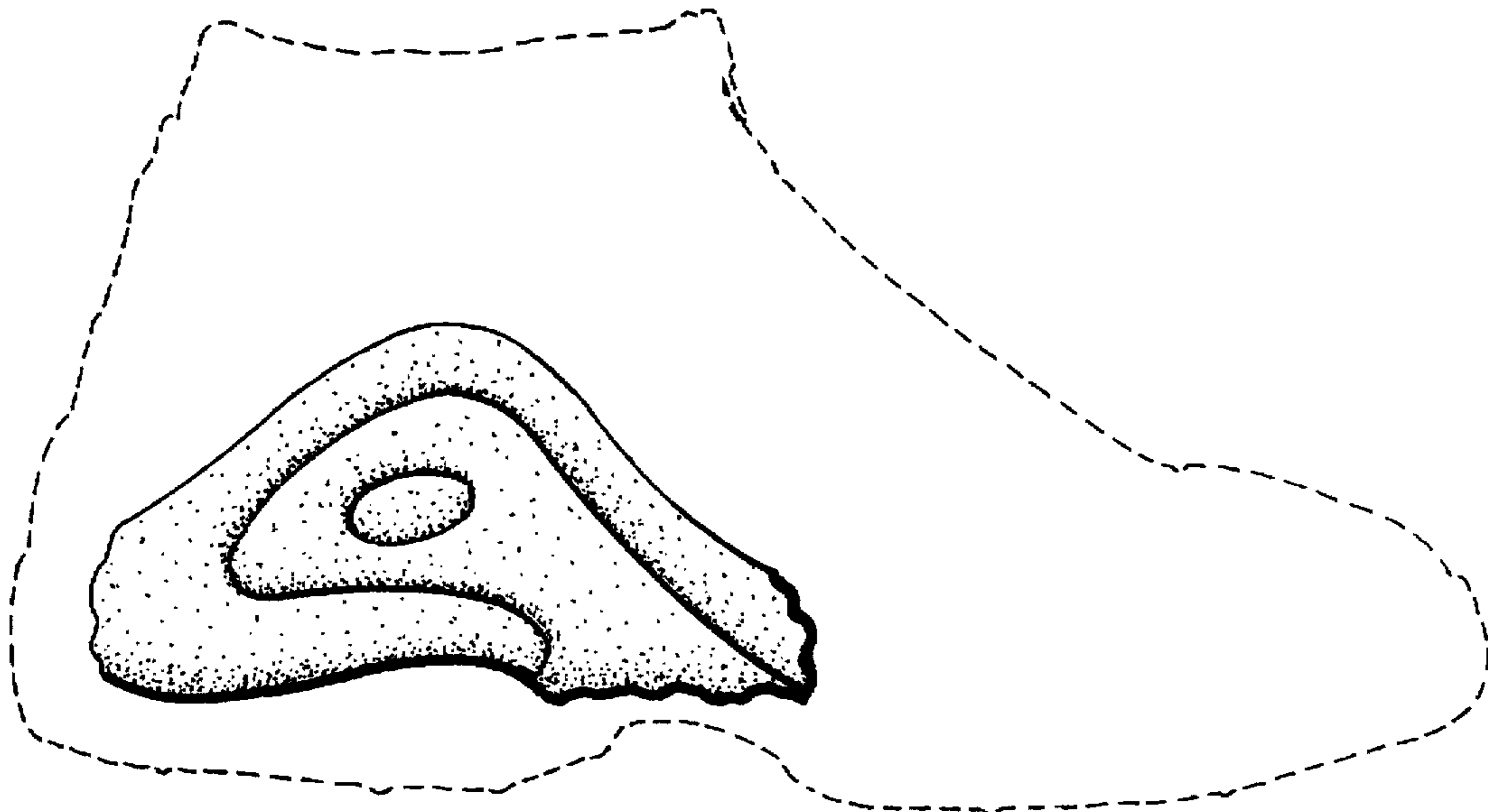
FIG. 1 is a side elevational view of a portion of a shoe showing my new design;

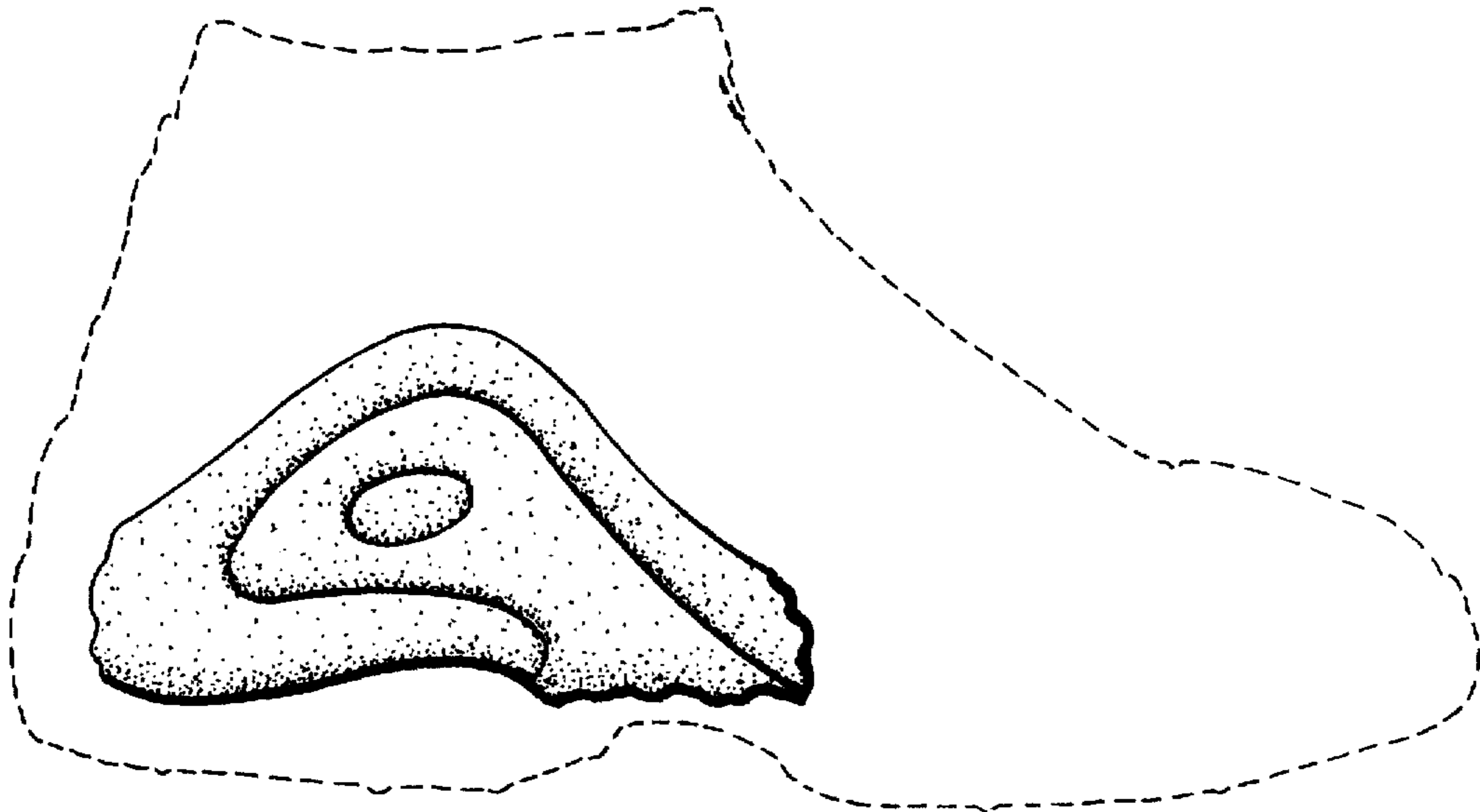

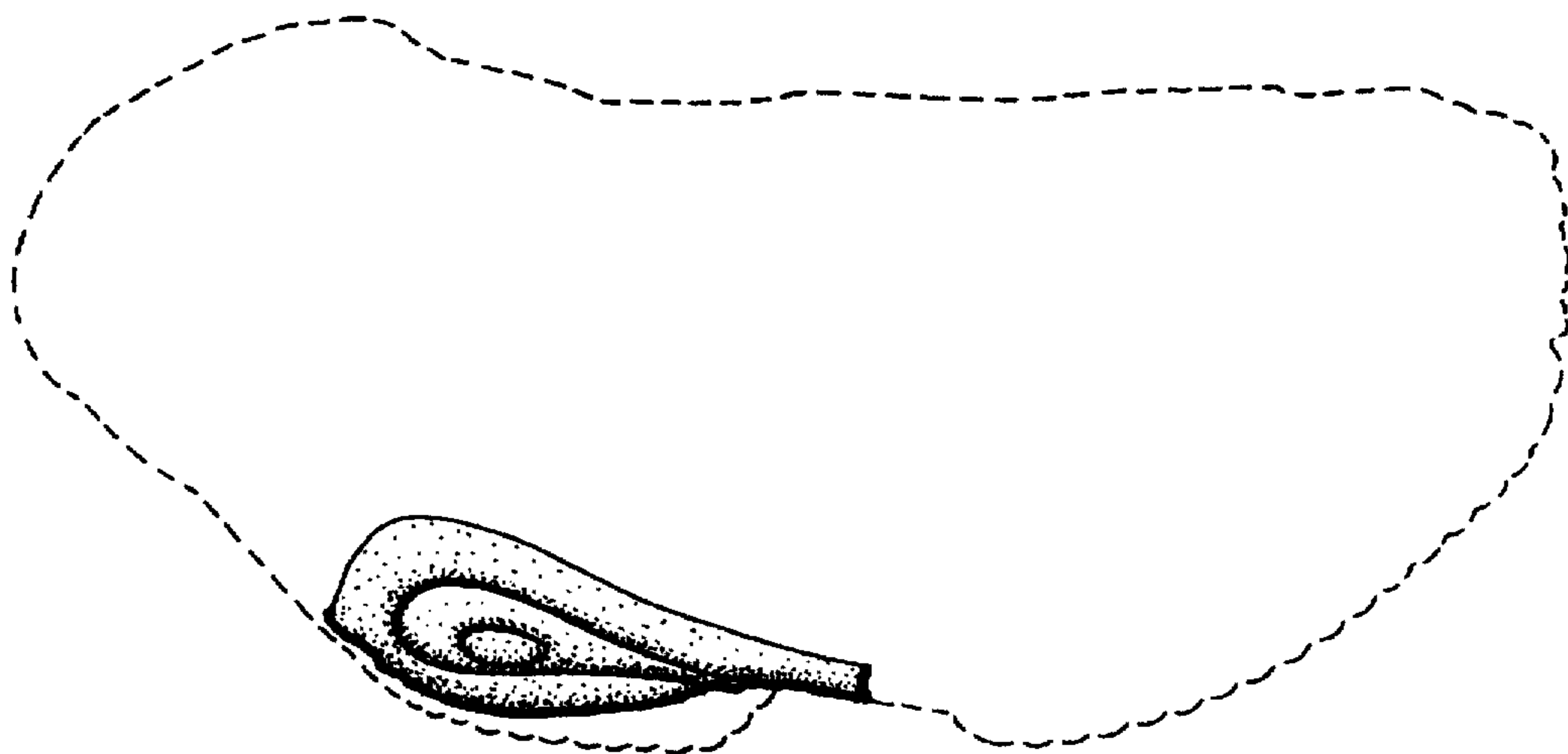

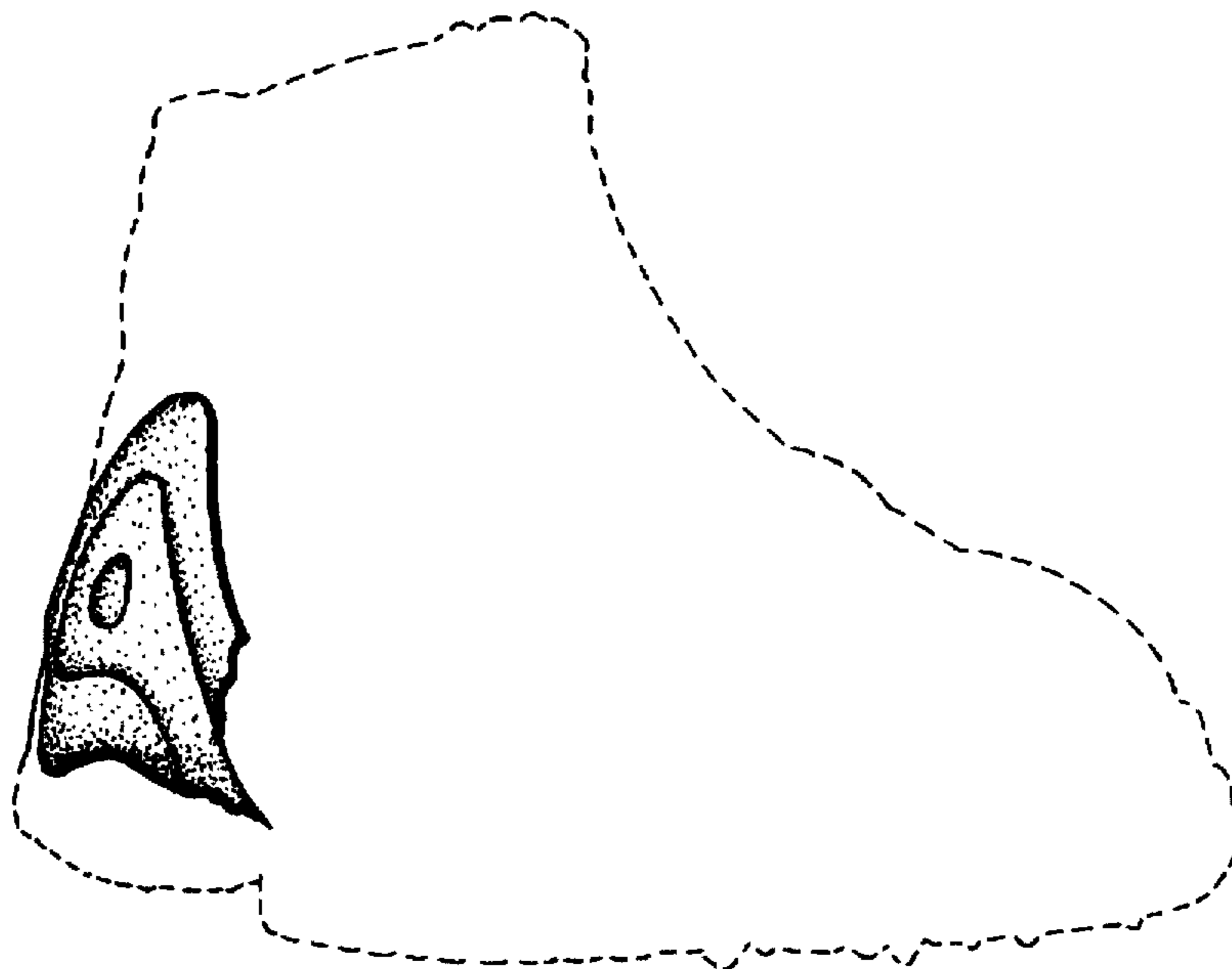

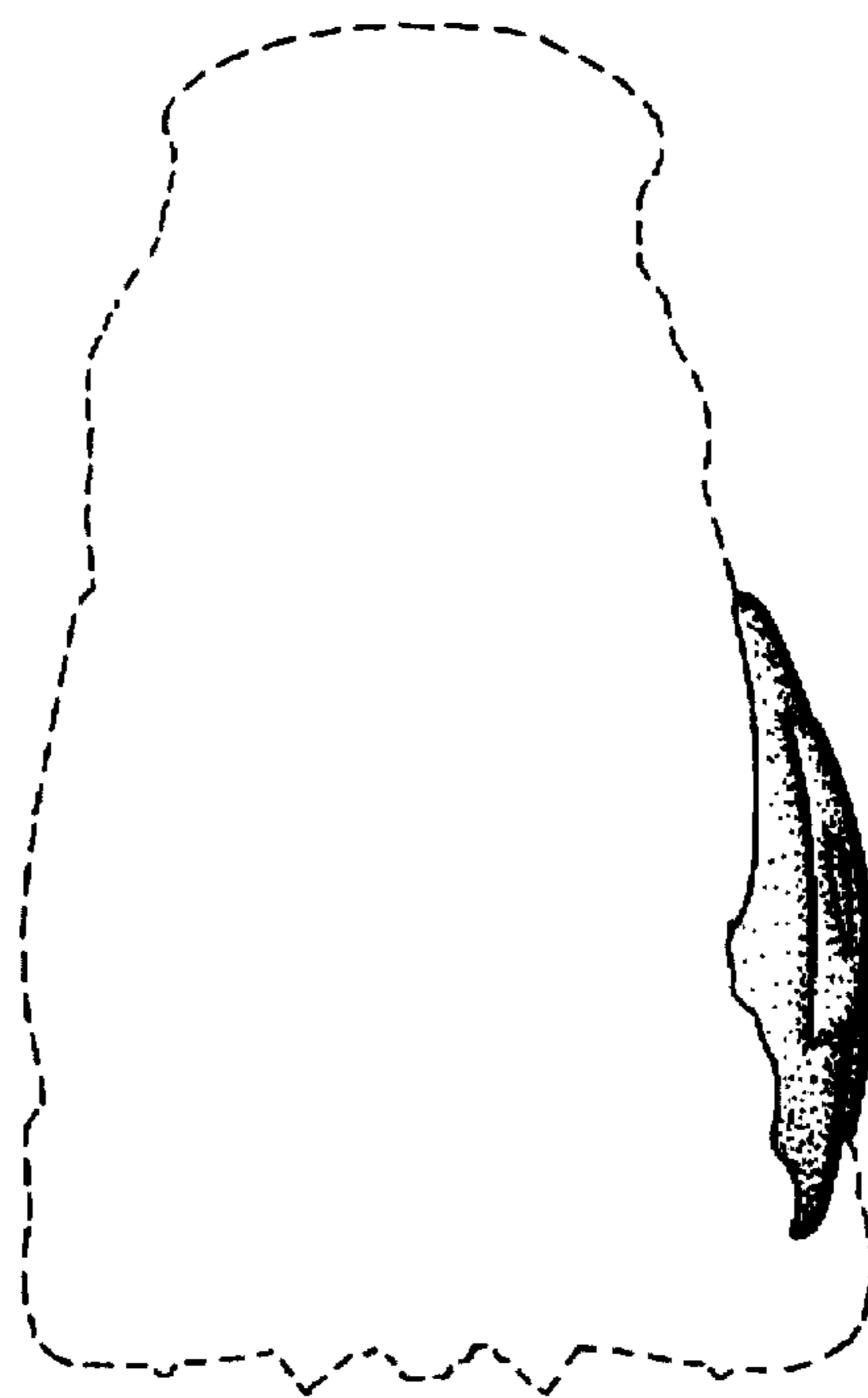
