[57] **CLAIM**

The ornamental design for a clutch sized bag expandable to backpack, as shown and described.

DESCRIPTION

FIG. 1 is a front plan view of my clutch sized bag expandable to backpack shown in its packed nonexpanded condition;

FIG. 2 is a rear plan view of the clutch sized bag expandable to backpack of FIG. 1;

FIG. 3 is a bottom plan view of the clutch sized bag expandable to backpack of FIG. 1;

FIG. 4 is a top plan view of the clutch sized bag expandable to backpack of FIG. 1;

FIG. 5 is a left side plan view of the clutch sized bag expandable to backpack of FIG. 1;

FIG. 6 is a right side plan view of the clutch sized bag expandable to backpack of FIG. 1;

FIG. 7 is a rear plan view of the clutch sized bag expandable to backpack of FIG. 1 shown in a partially unpacked condition;

FIG. 8 is a front plan view of the clutch sized bag expandable to backpack of FIG. 1 shown in the same partially unpacked condition of FIG. 7;

FIG. 9 is a rear plan view of the clutch sized bag expandable to backpack of FIG. 1 in its fully unpacked condition expanded to a backpack;

FIG. 10 is a front plan view of the clutch sized bag expandable to backpack of FIG. 1 shown in its same expanded backpack condition of FIG. 9;

FIG. 11 is a left side plan view of the clutch sized bag expandable to backpack shown in FIG. 9;

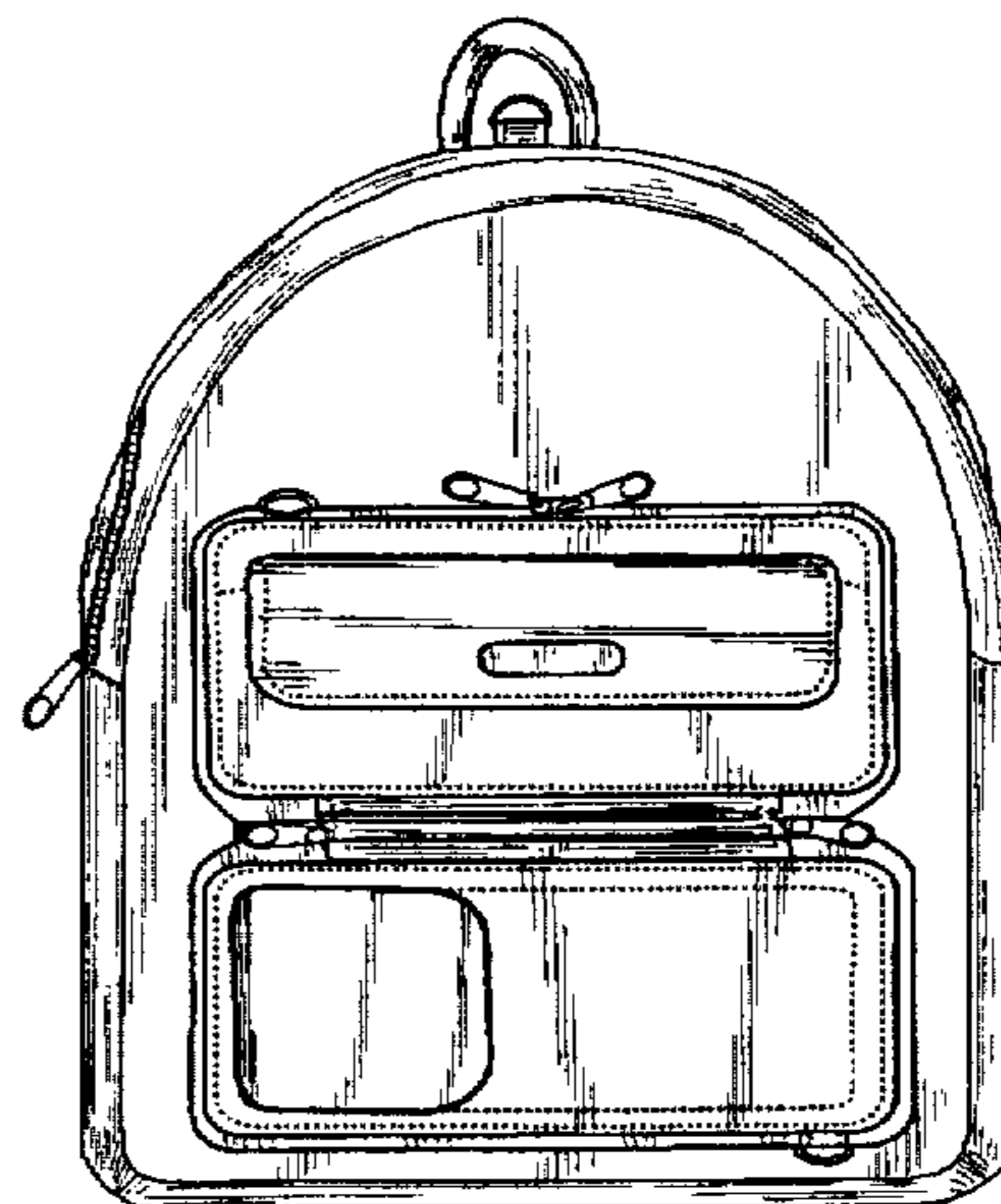
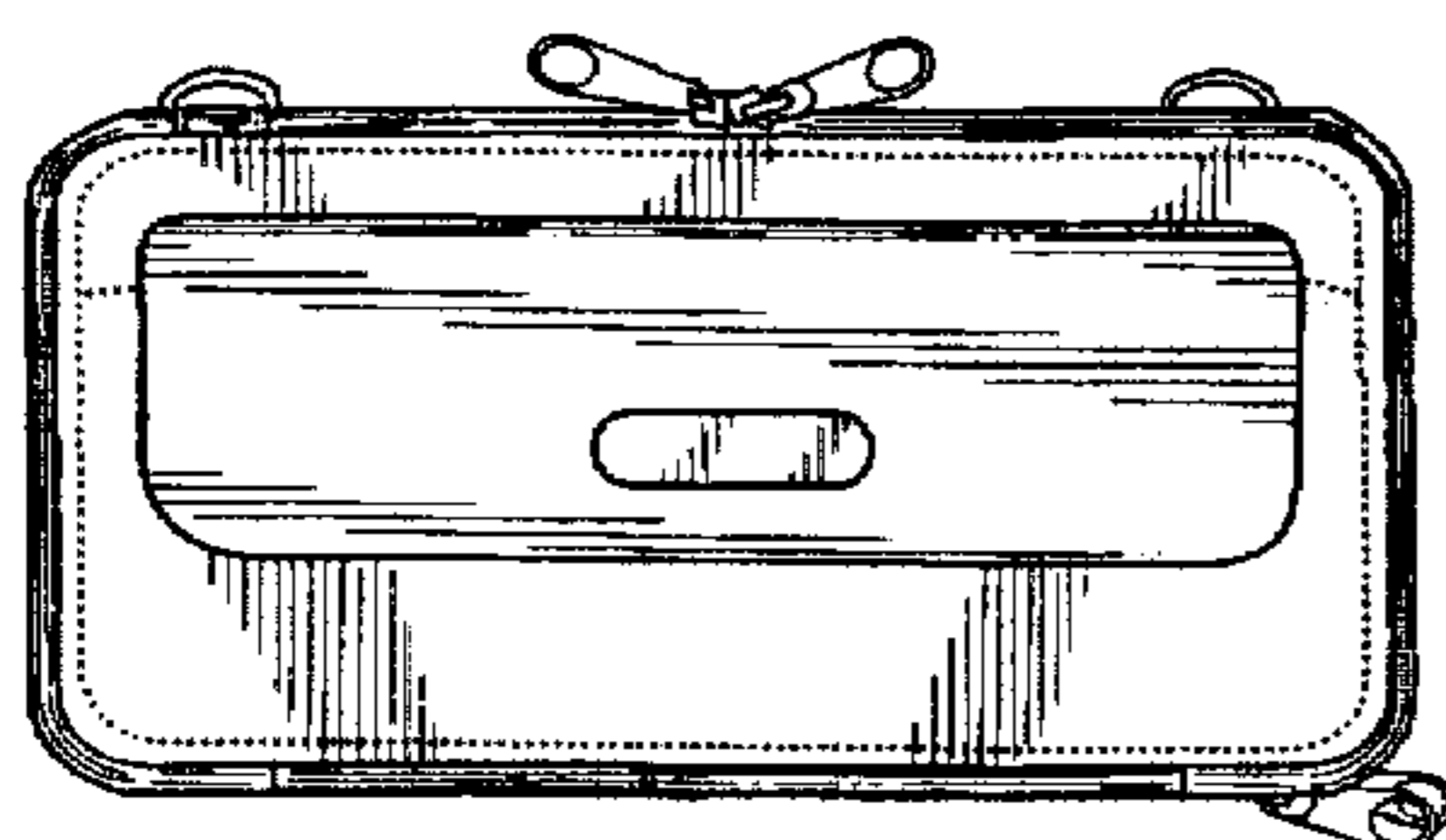
FIG. 12 is a right side plan view of the clutch sized bag expandable to backpack shown in FIG. 9;

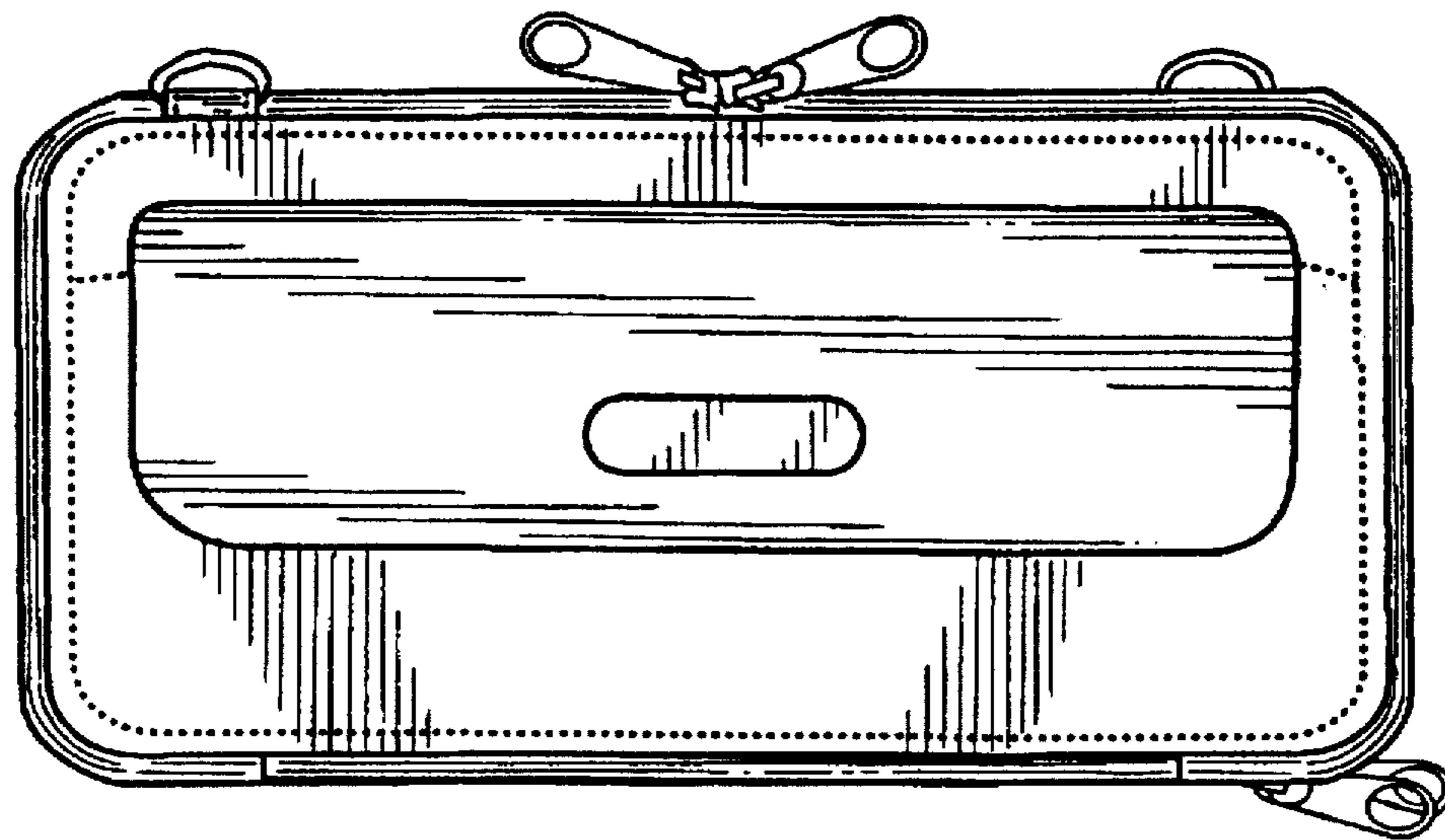

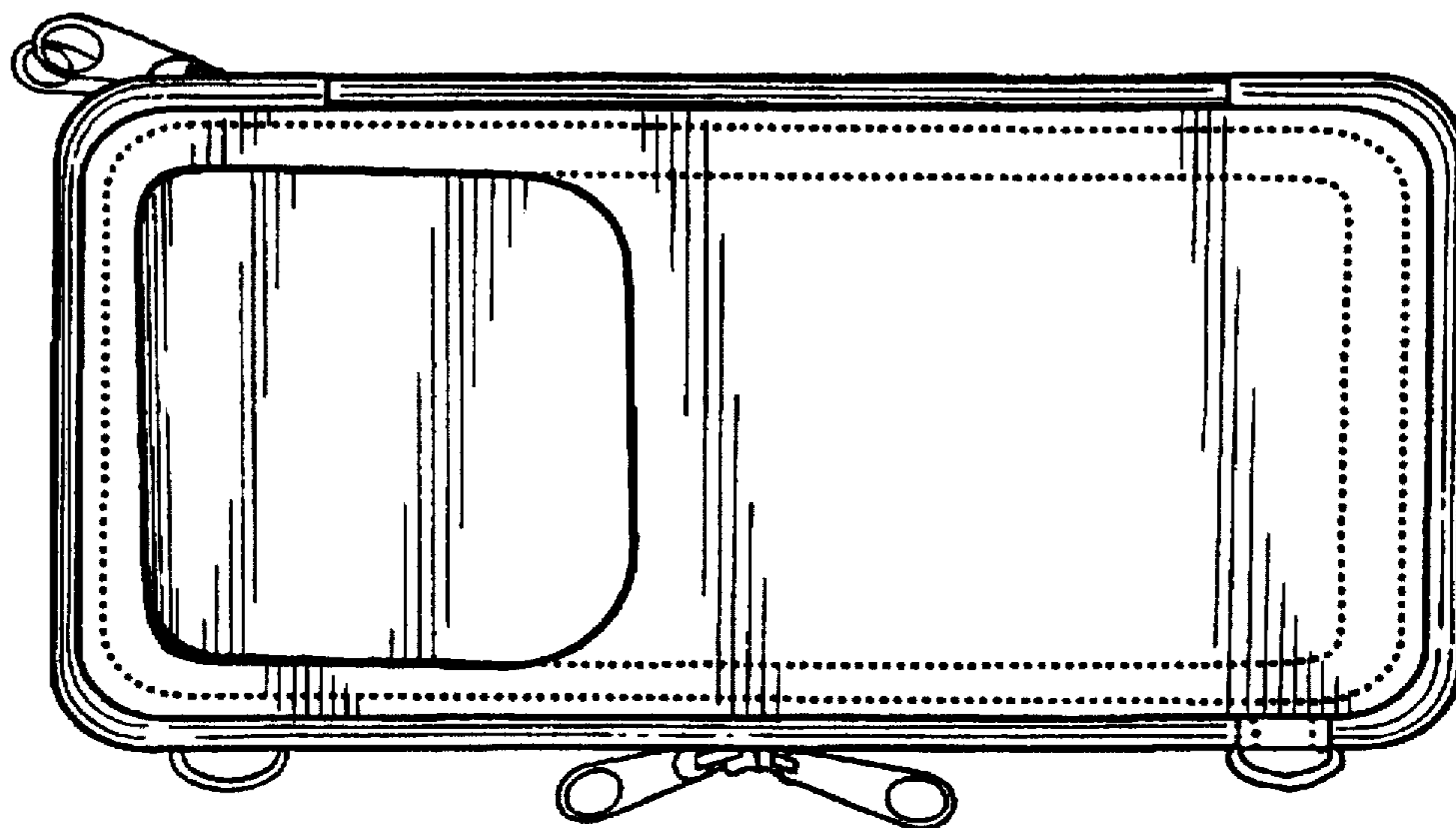

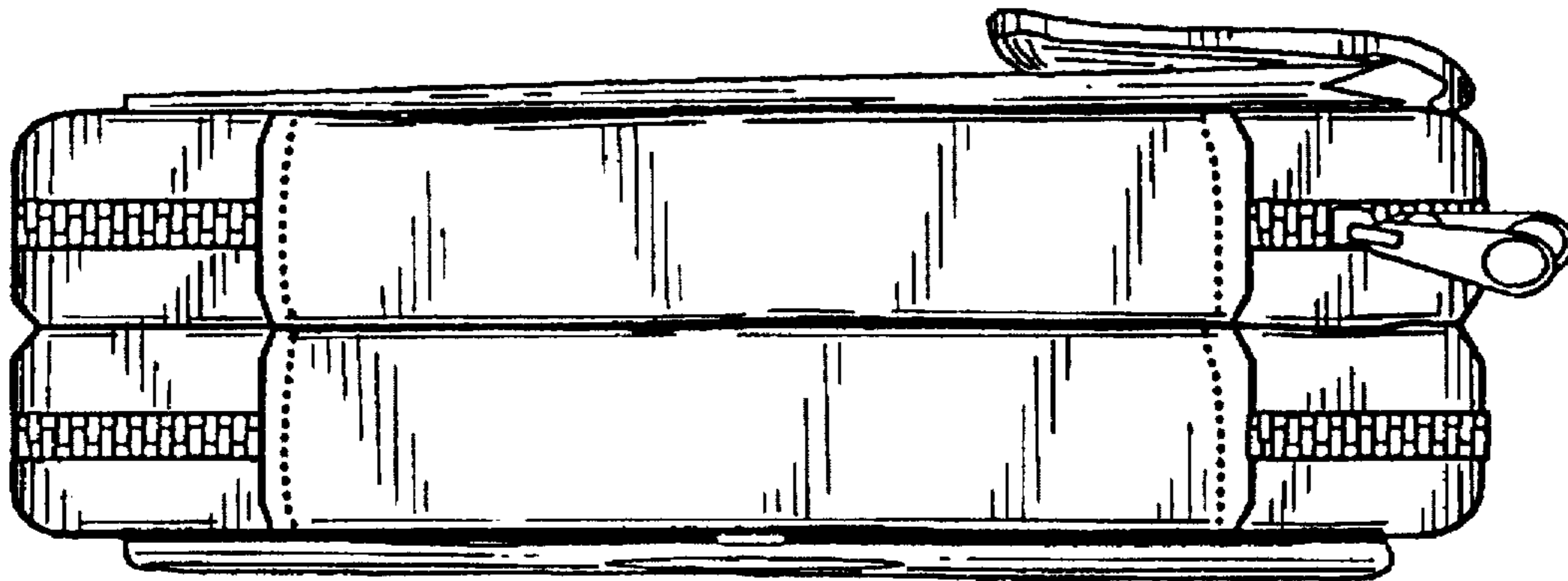

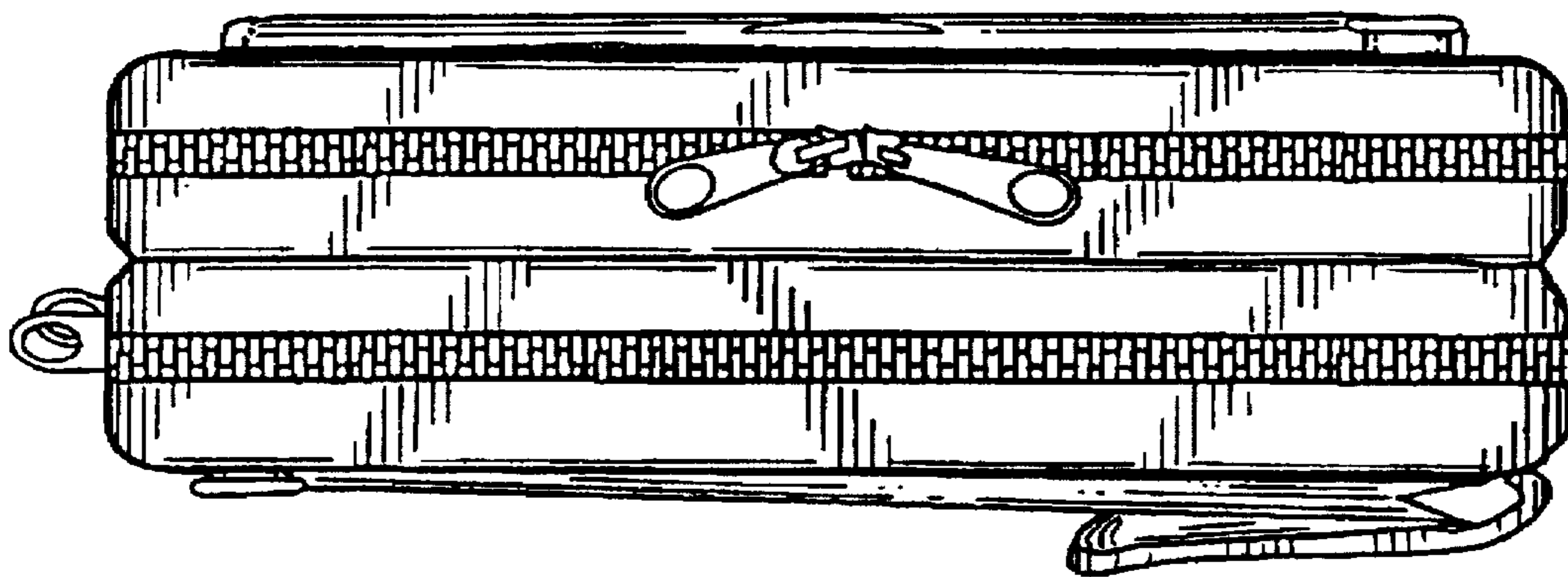

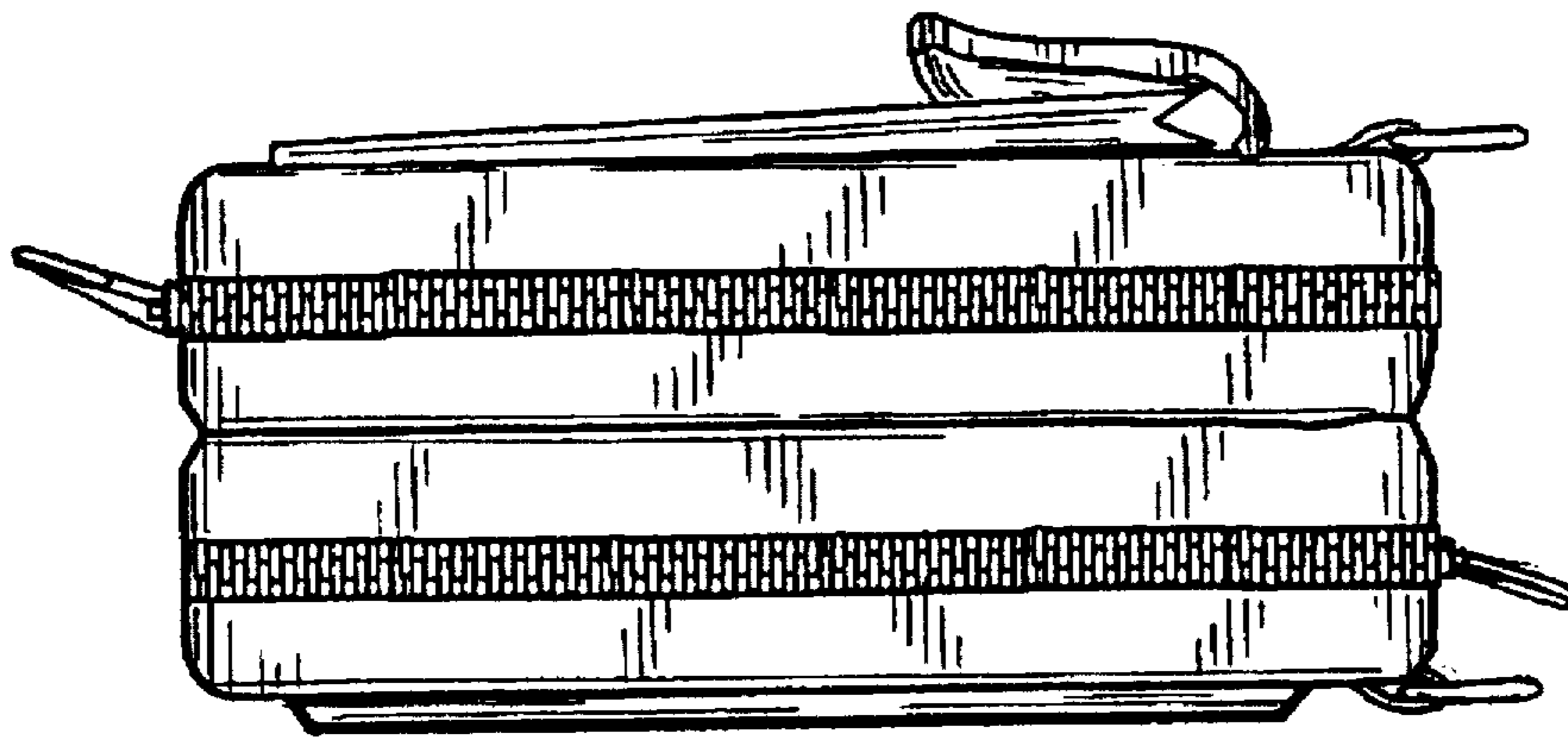

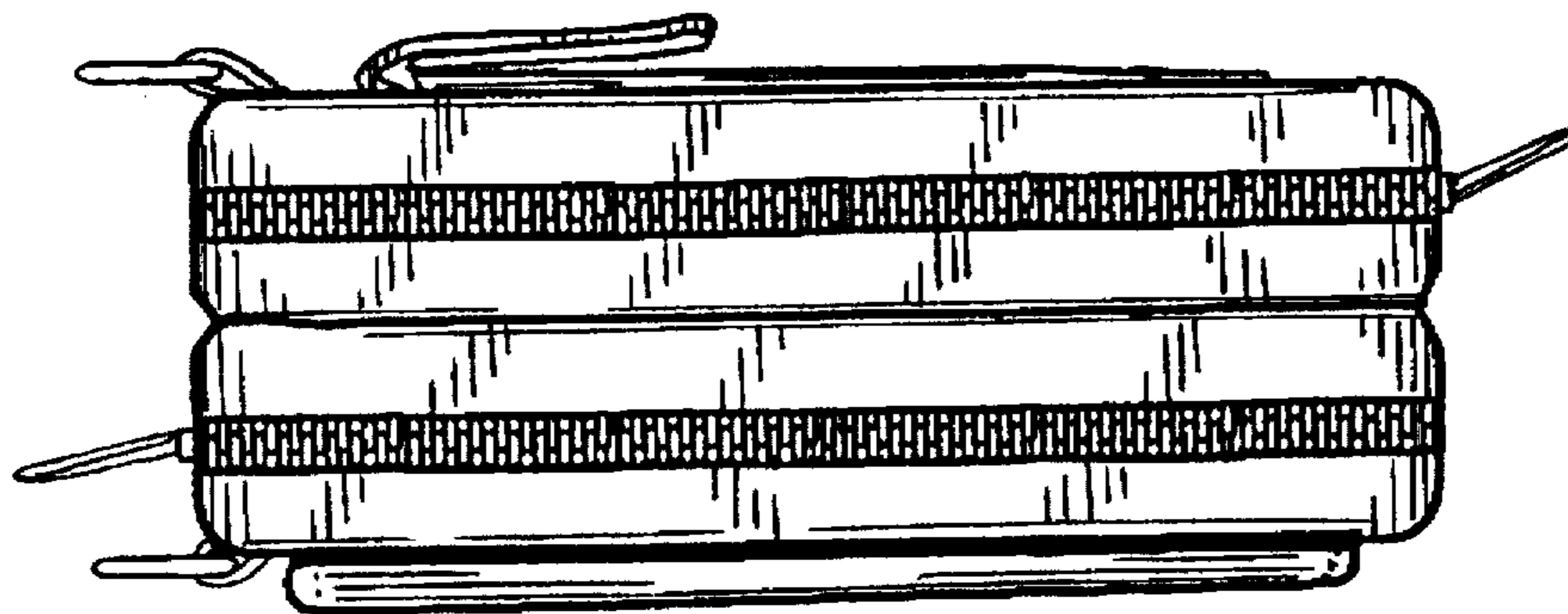

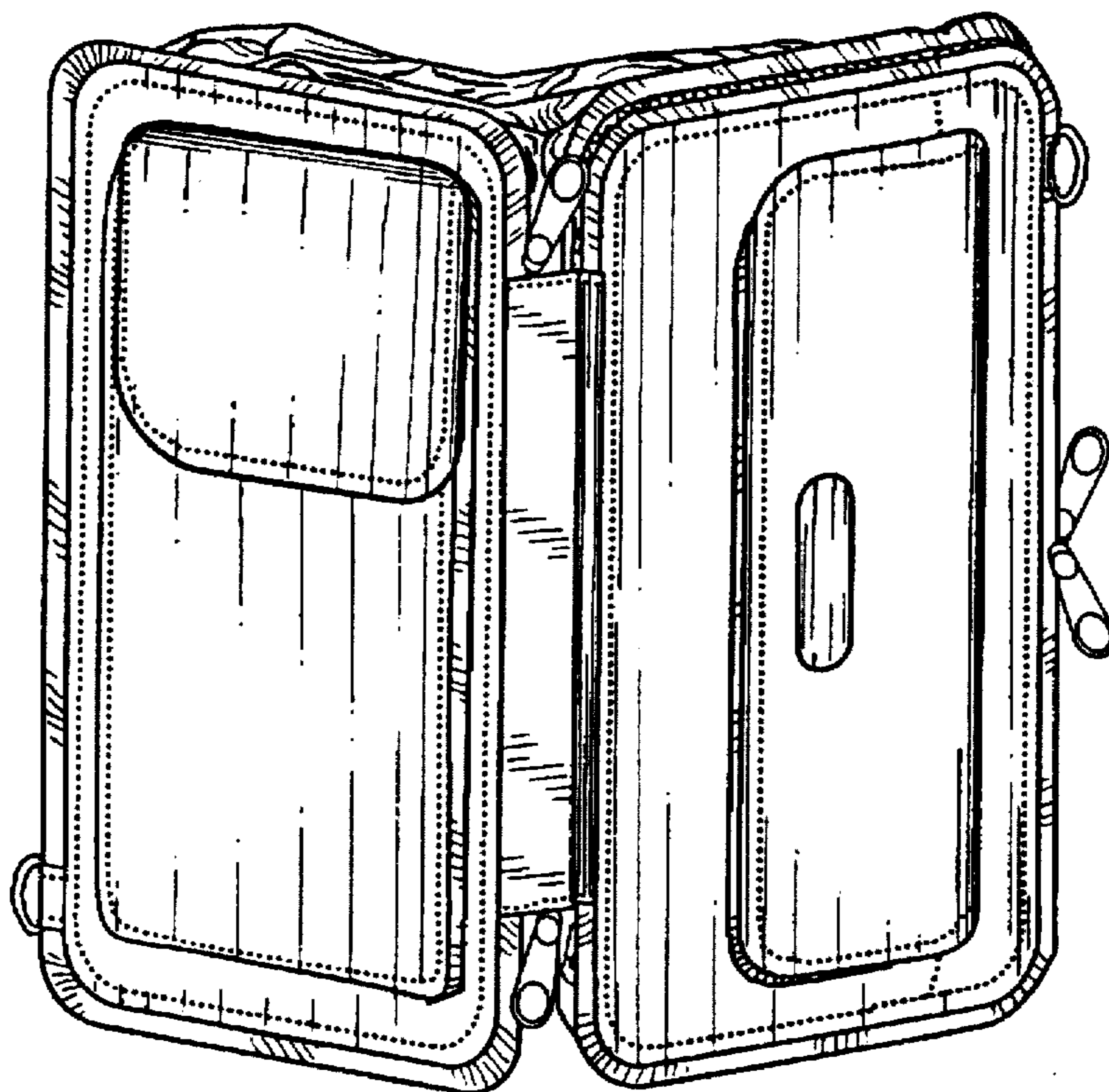

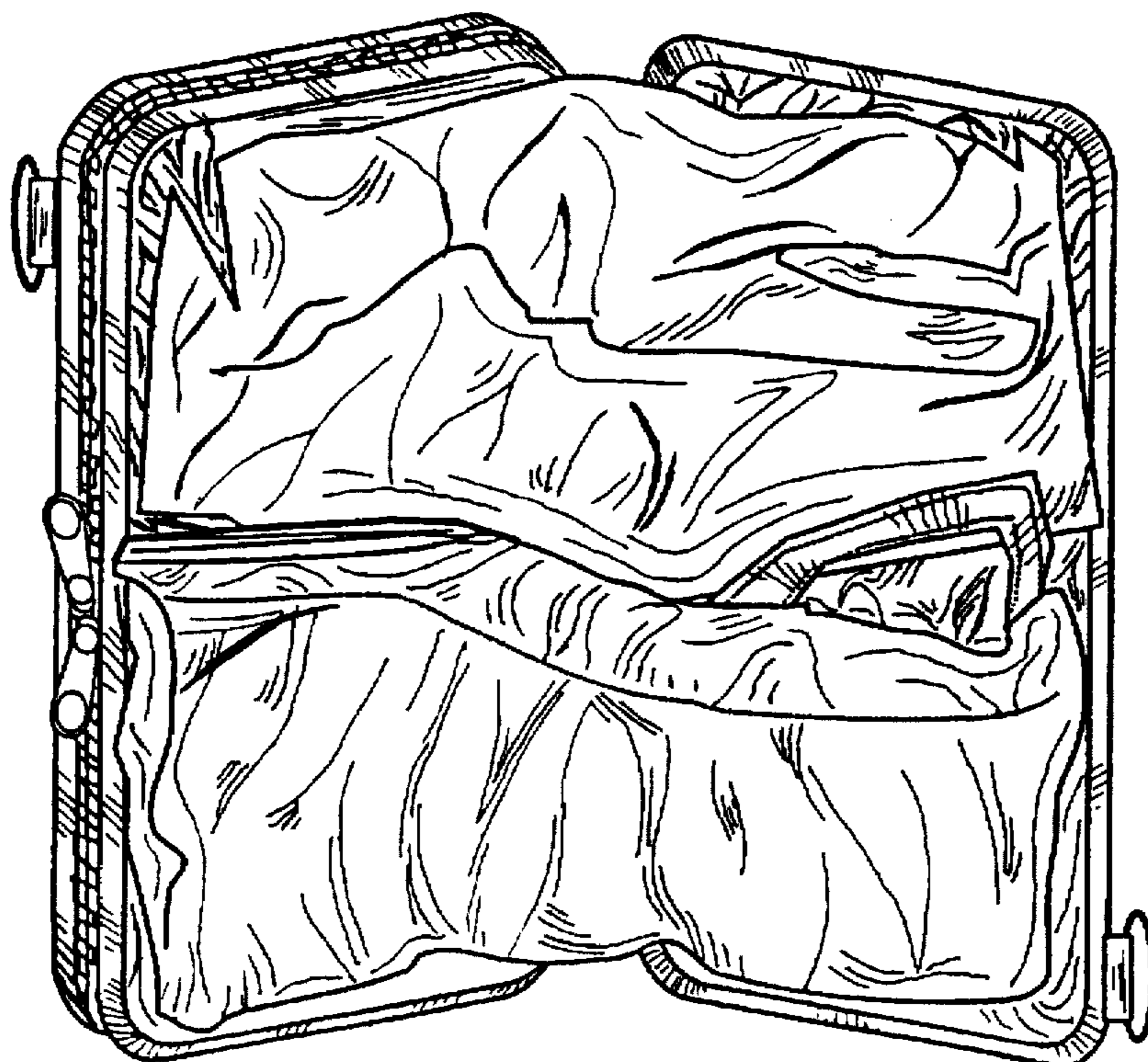

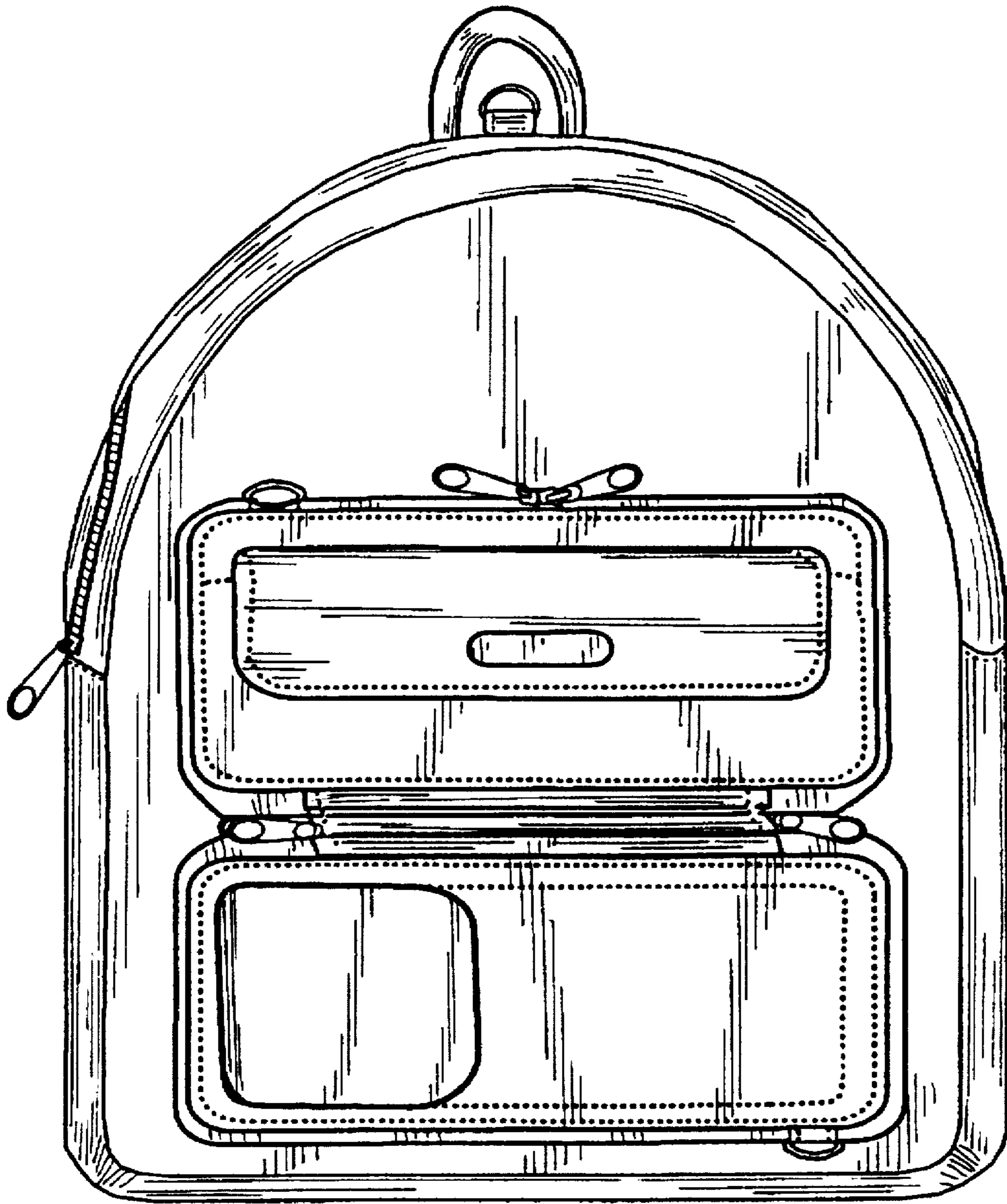

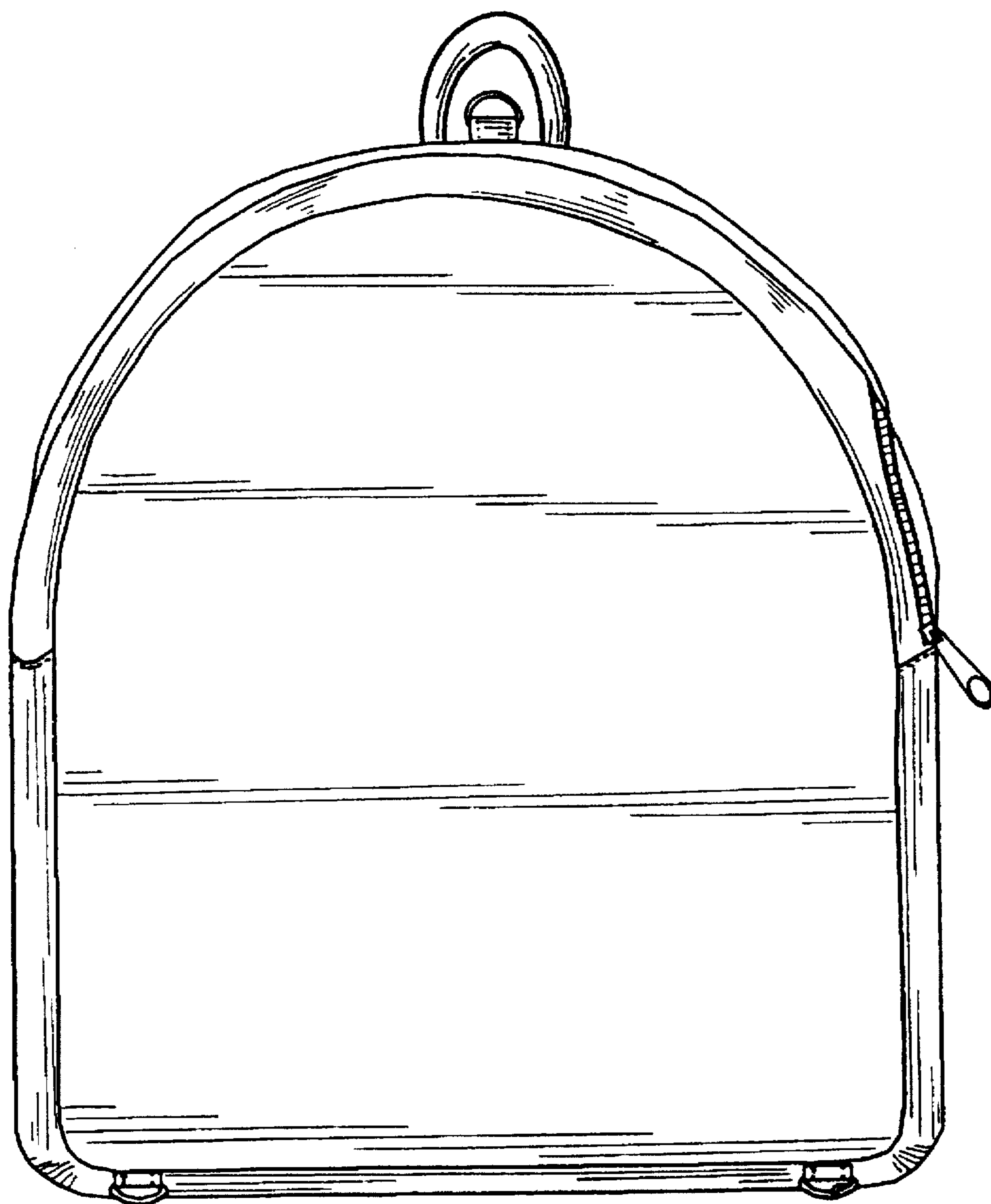

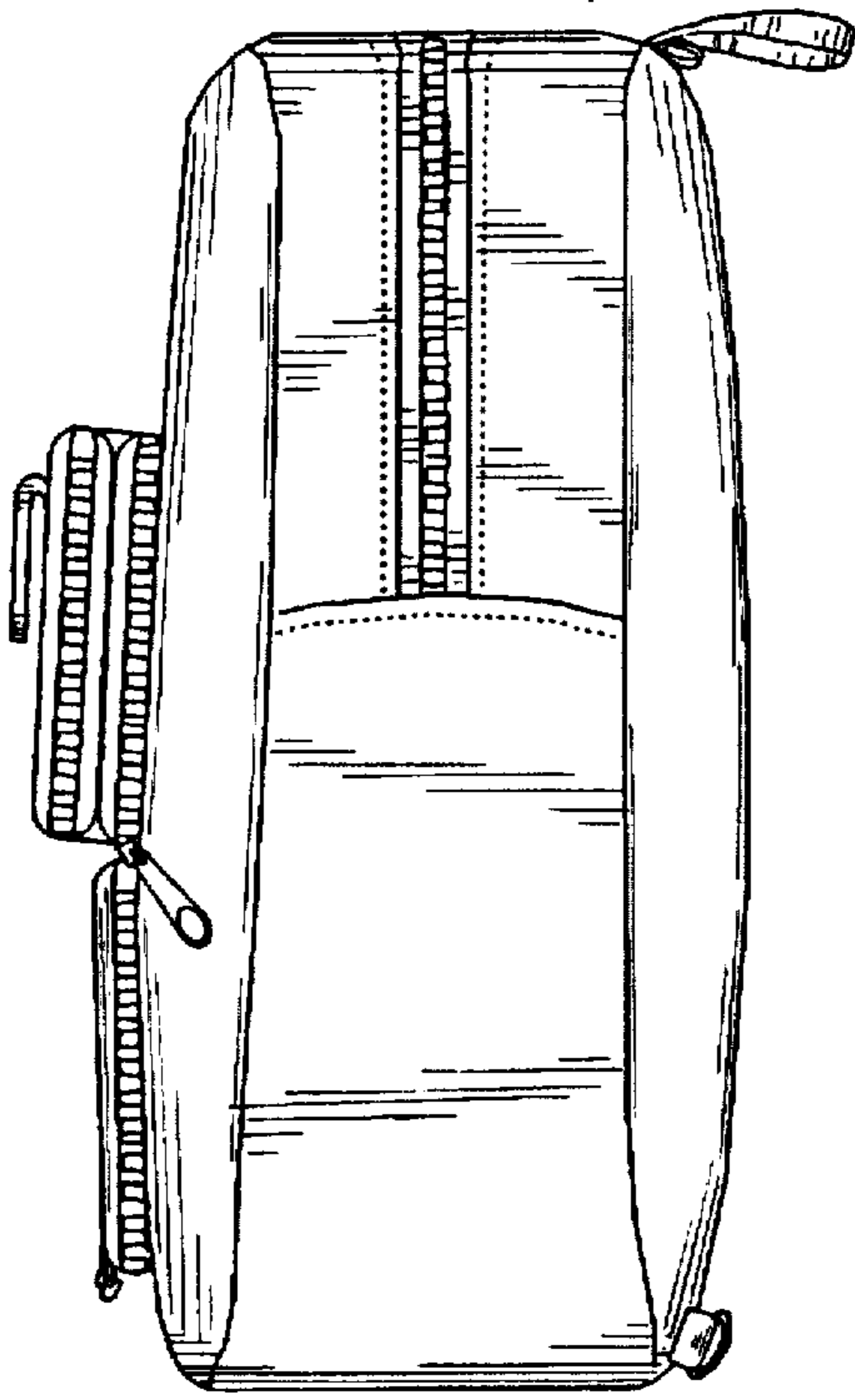

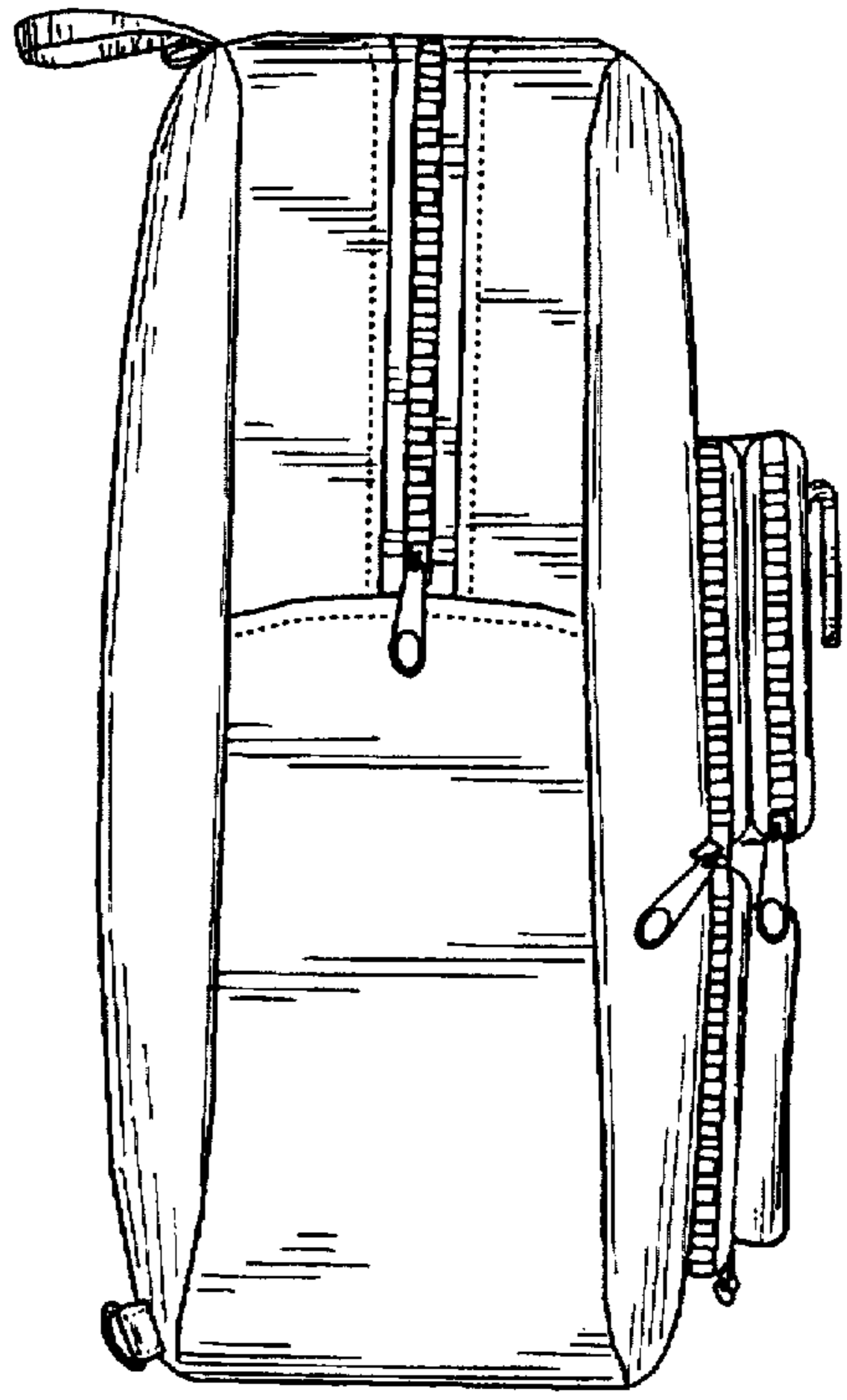

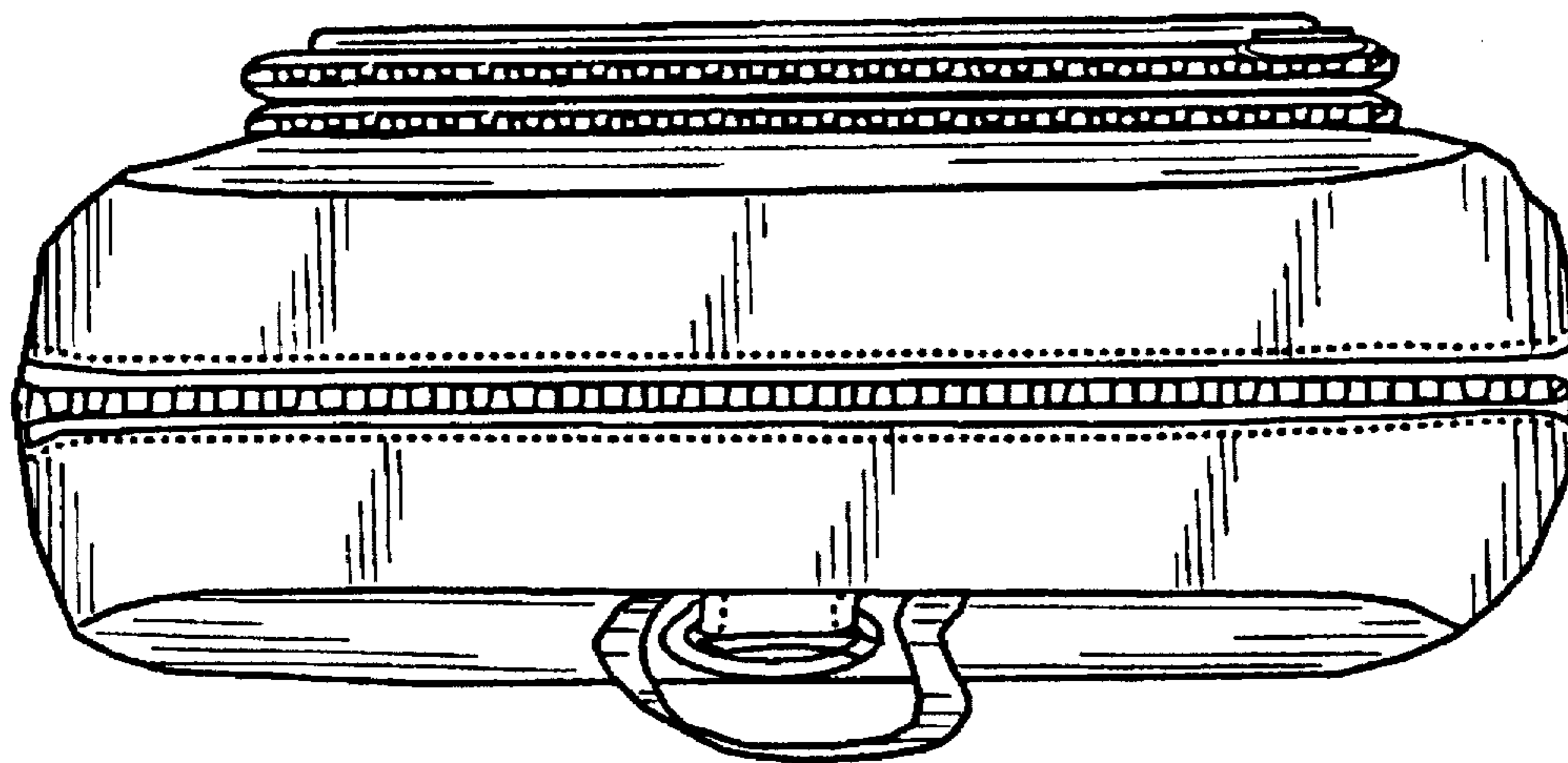

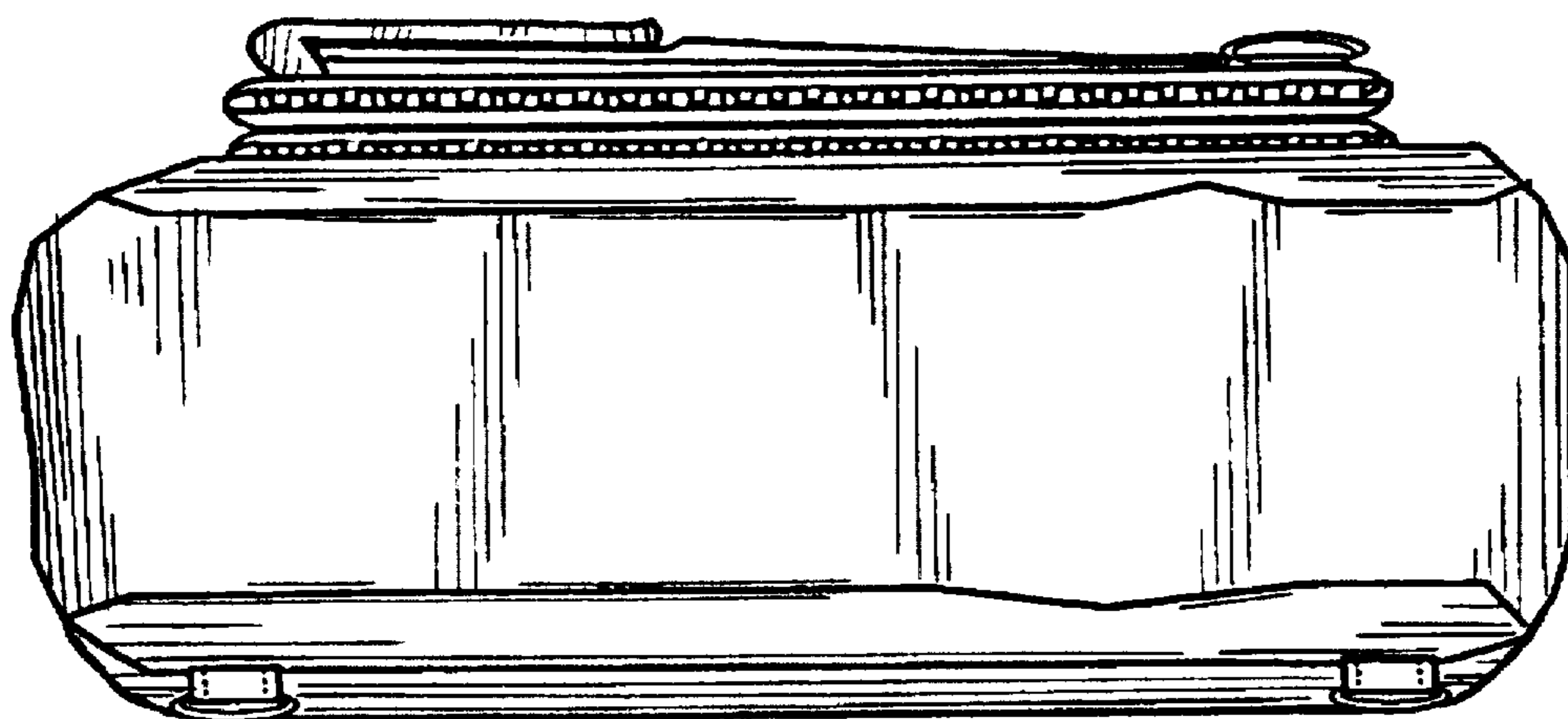
