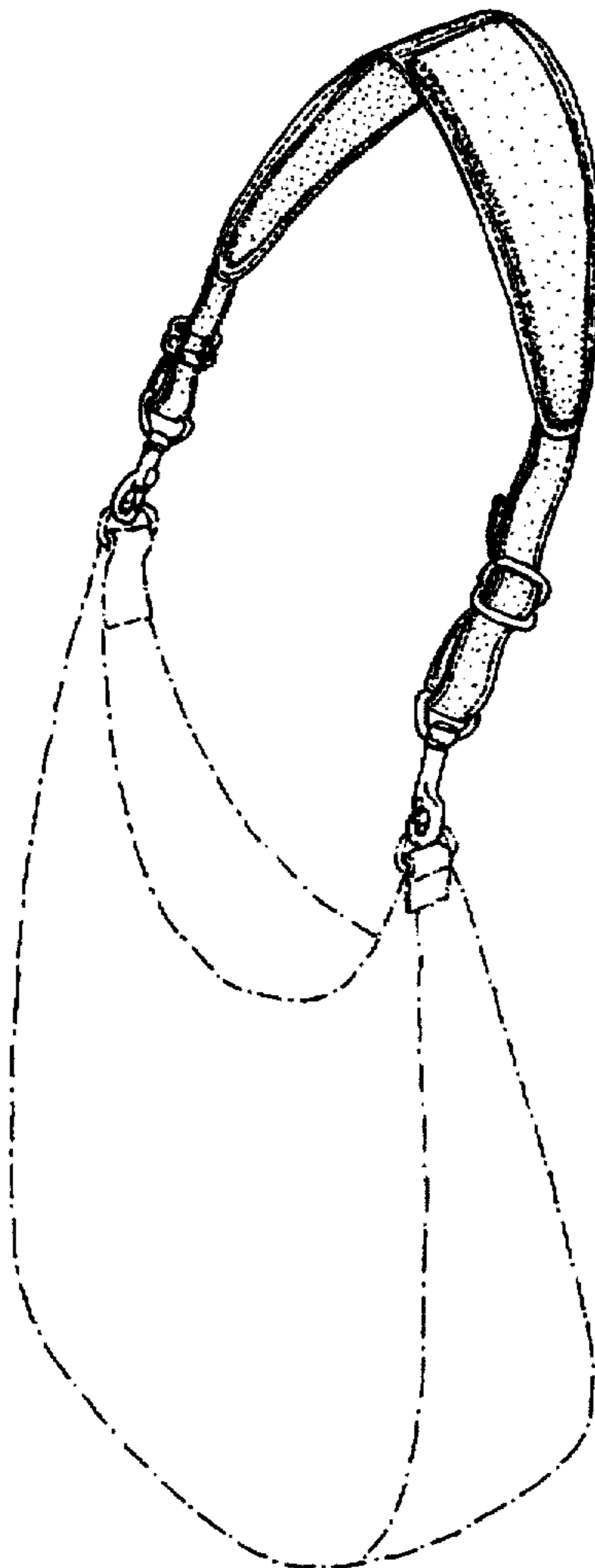

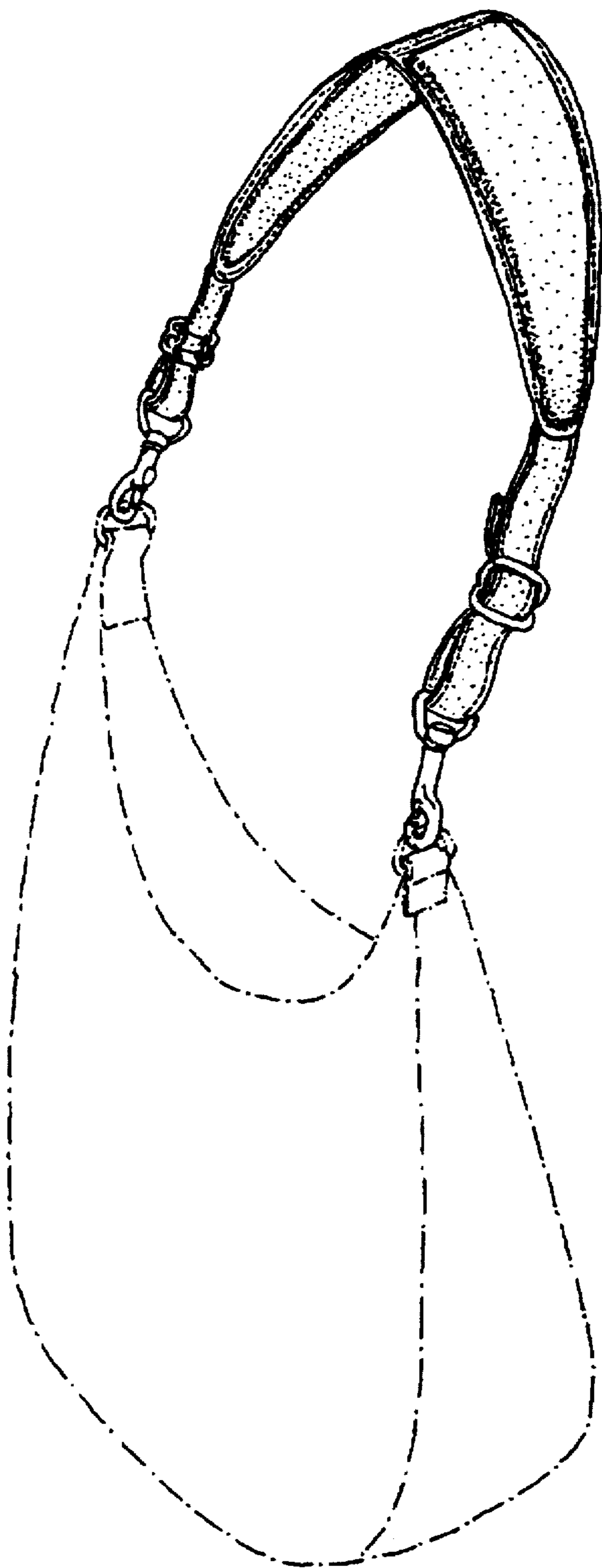
The ornamental design for a shoulder carrying strap, as shown and described.

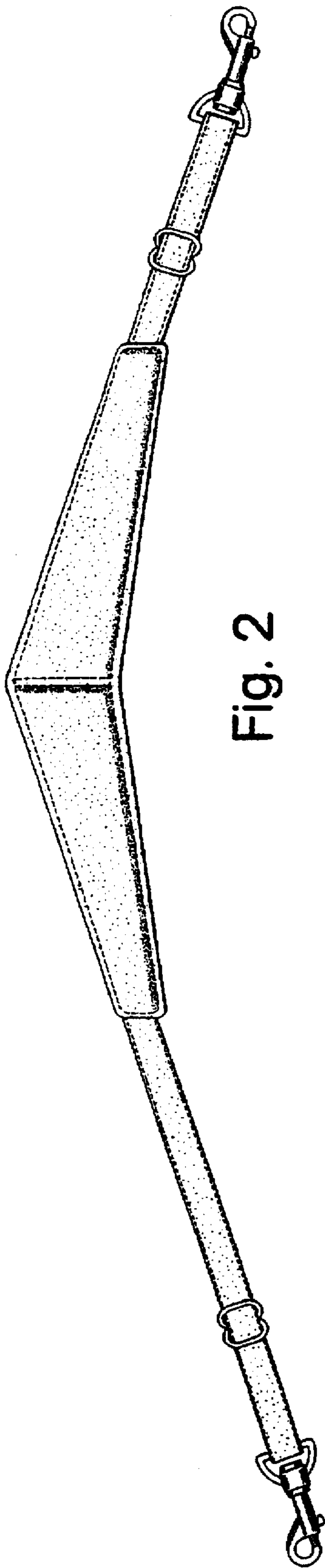

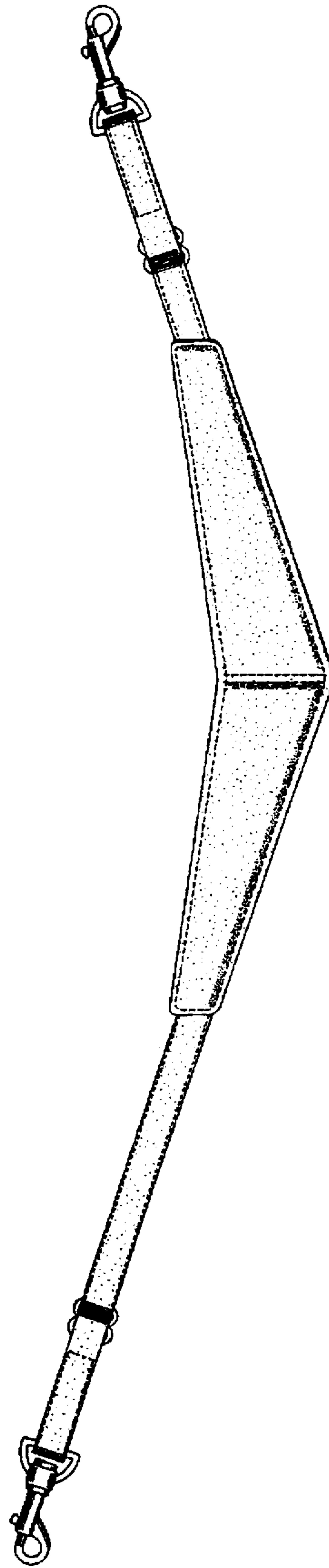
