[57] **CLAIM**

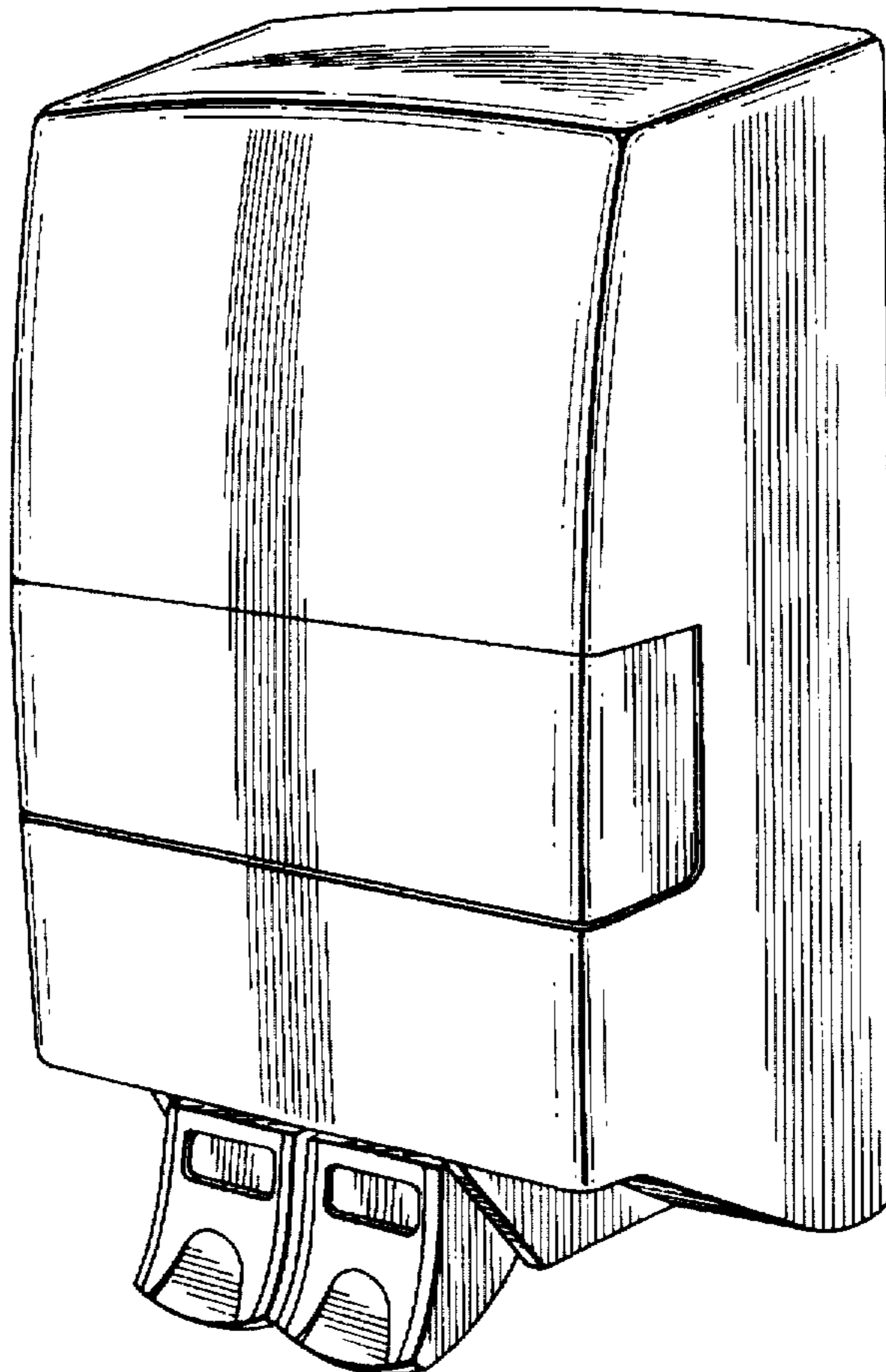
The ornamental design for a "liquid soap dispenser," as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and right side perspective view of a liquid soap dispenser showing our new design; FIG. 2 is an enlarged front elevational view thereof, the rear being plain and unornamented and forming no part of the claimed design; FIG. 3 is an enlarged left side elevational view thereof; FIG. 4 is an enlarged right side elevational view thereof; FIG. 5 is an enlarged top plan view thereof; and, FIG. 6 is an enlarged bottom plan view thereof.

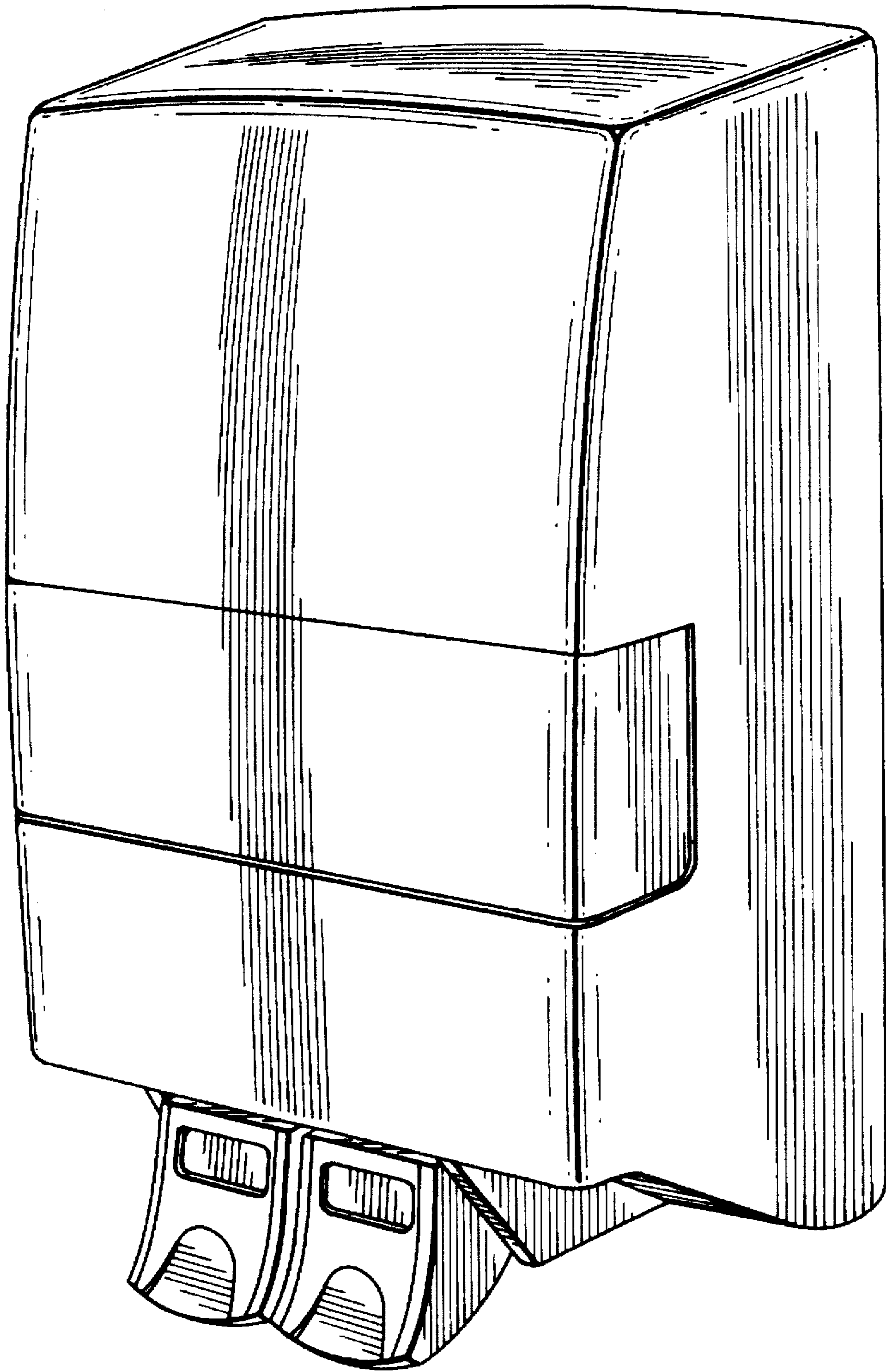

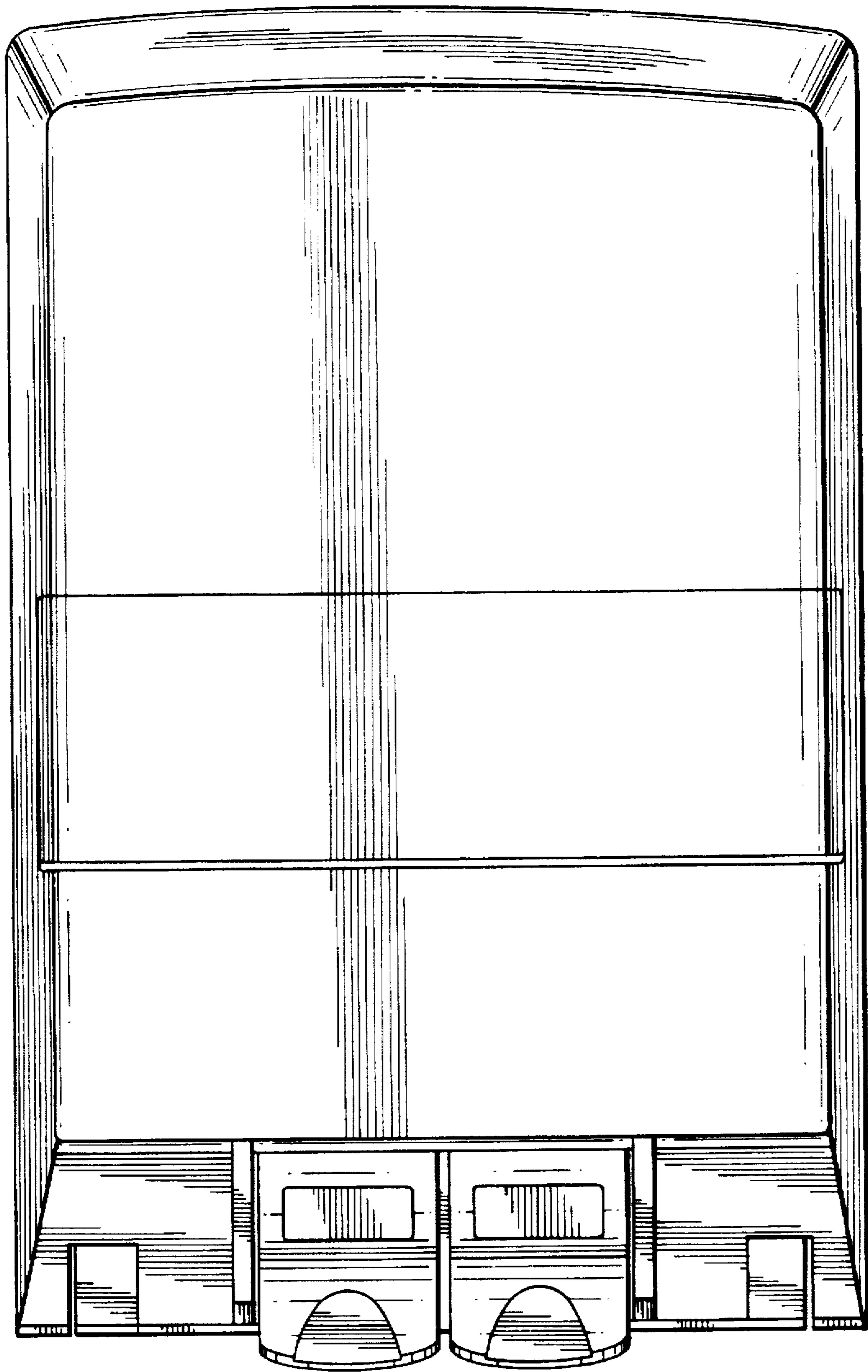

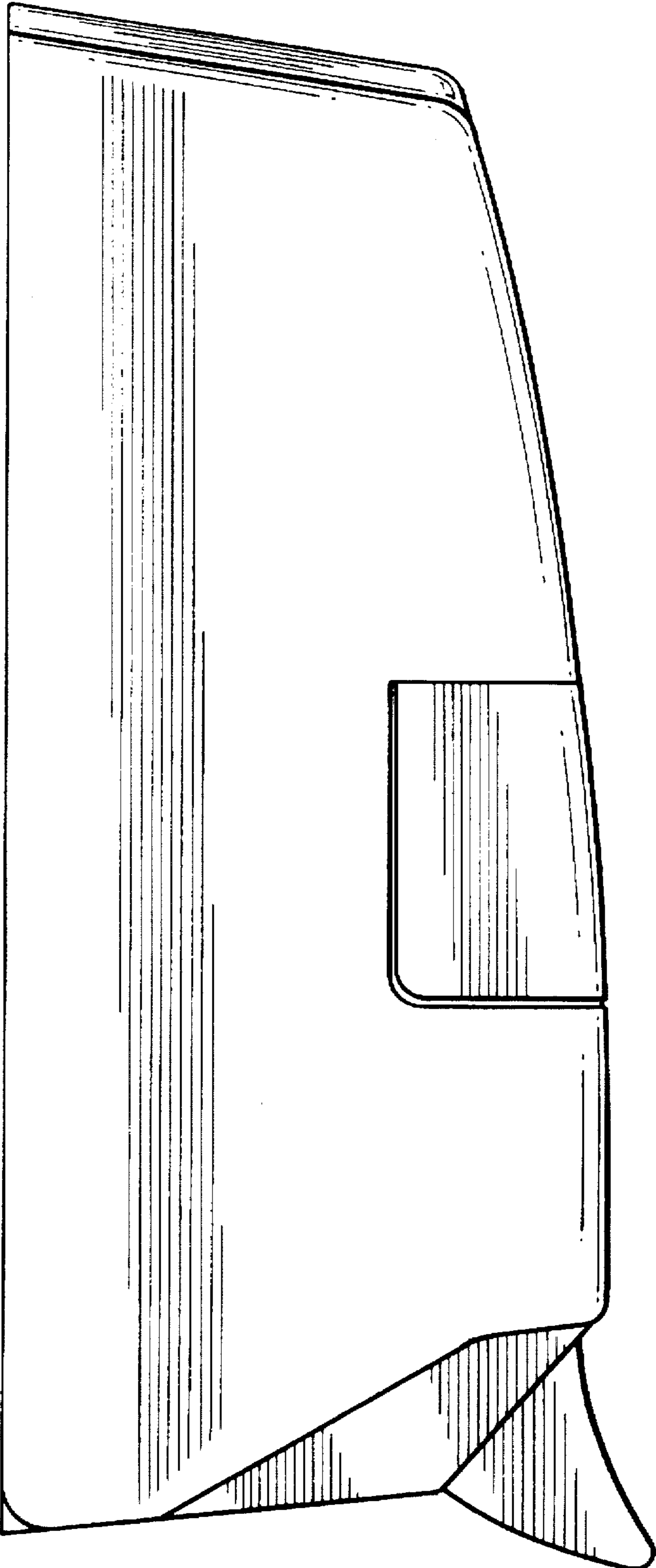

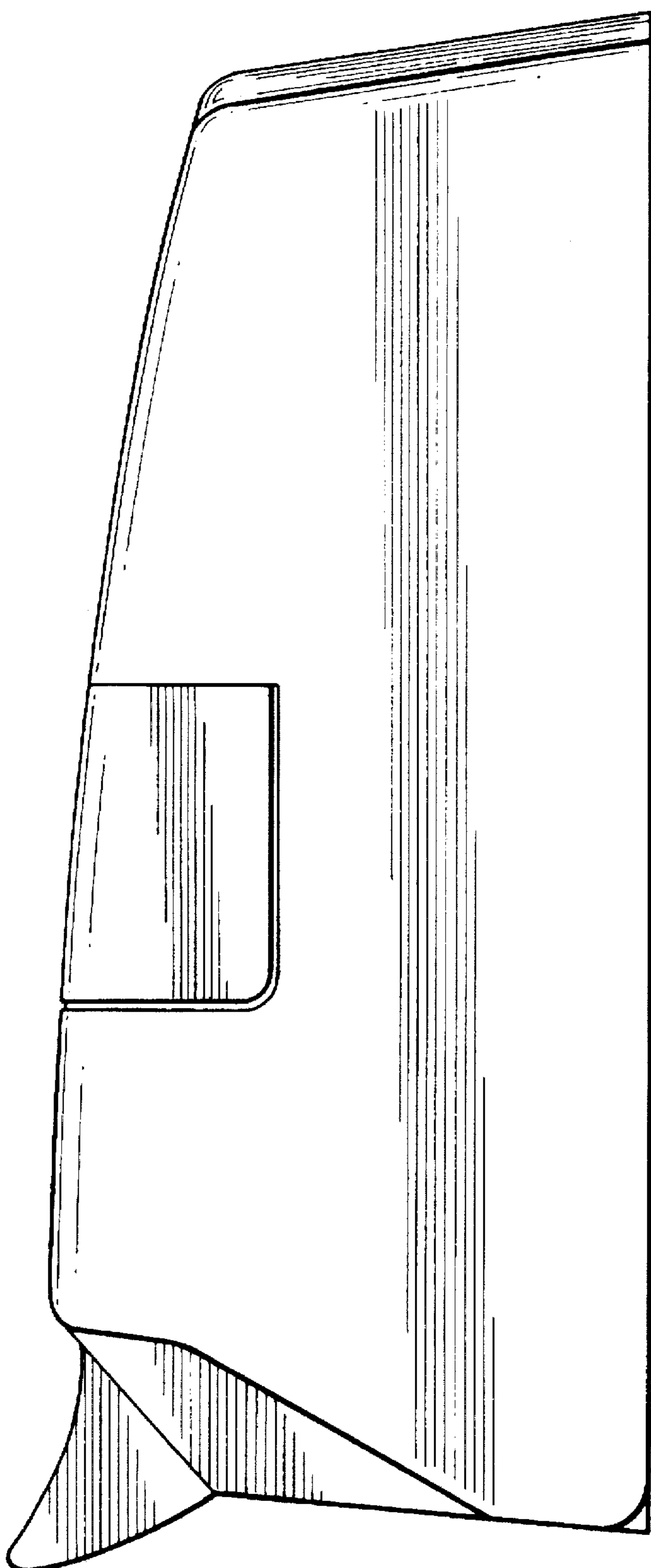

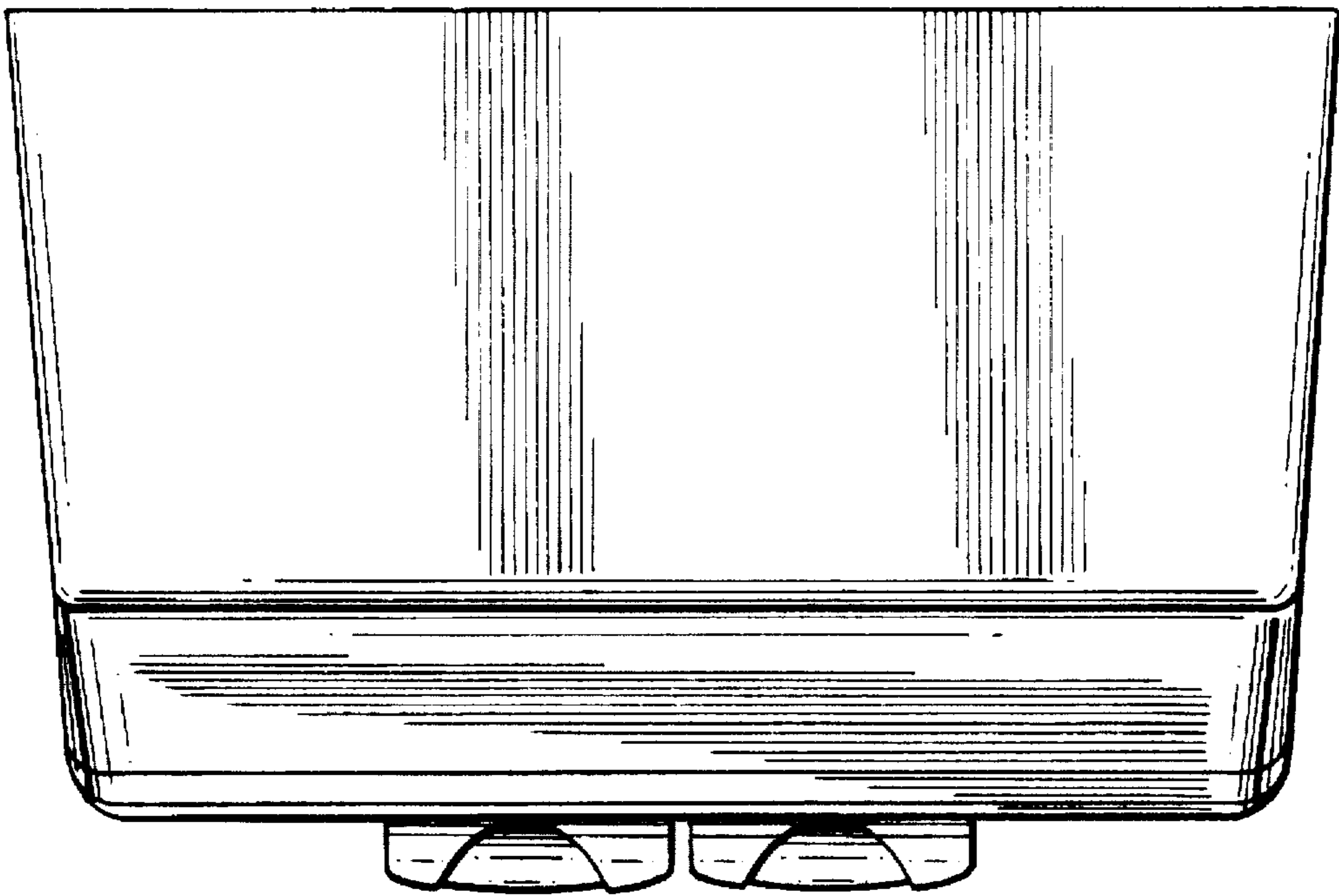

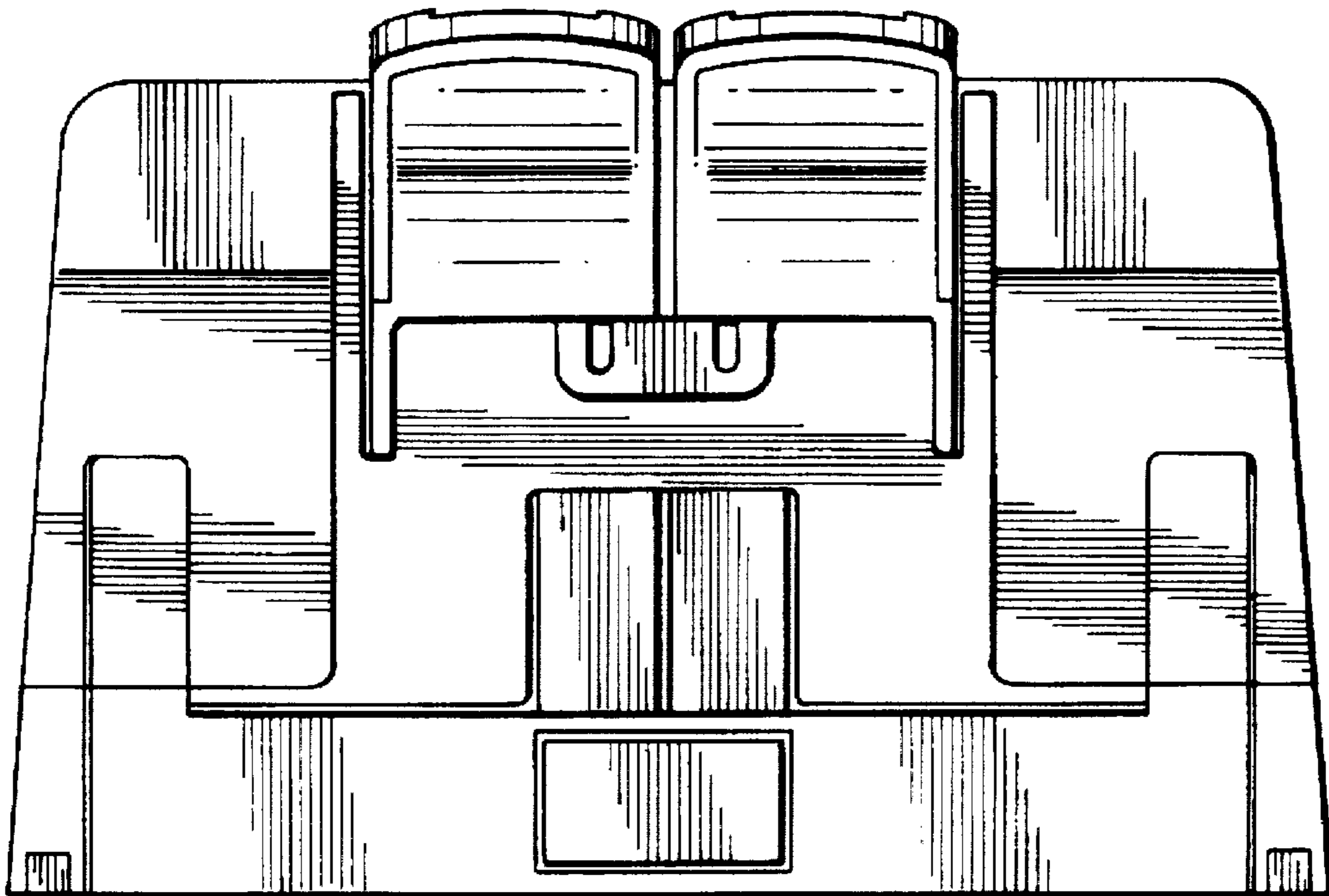
