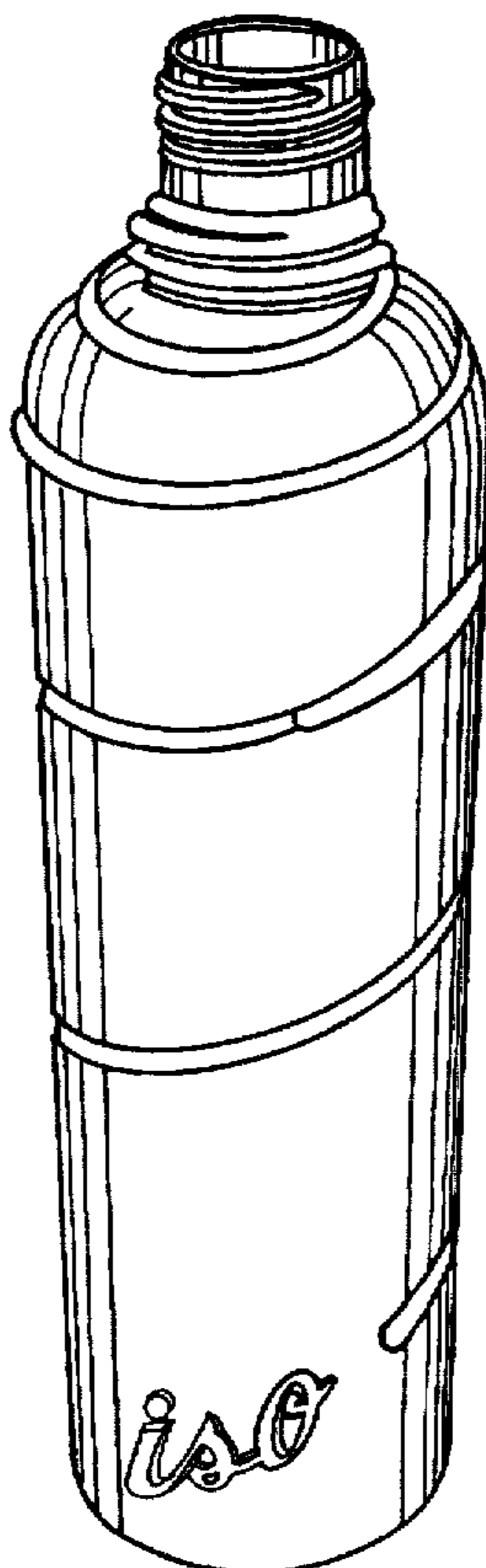
[57] **CLAIM**

The ornamental design for a bottle with helical groove formation, as shown and described.

**DESCRIPTION**

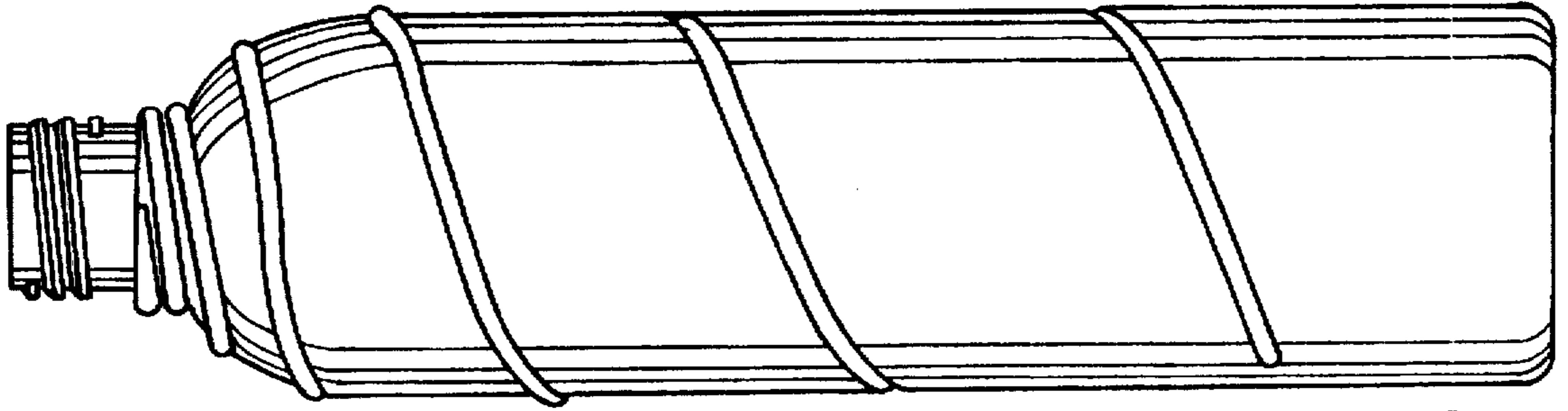

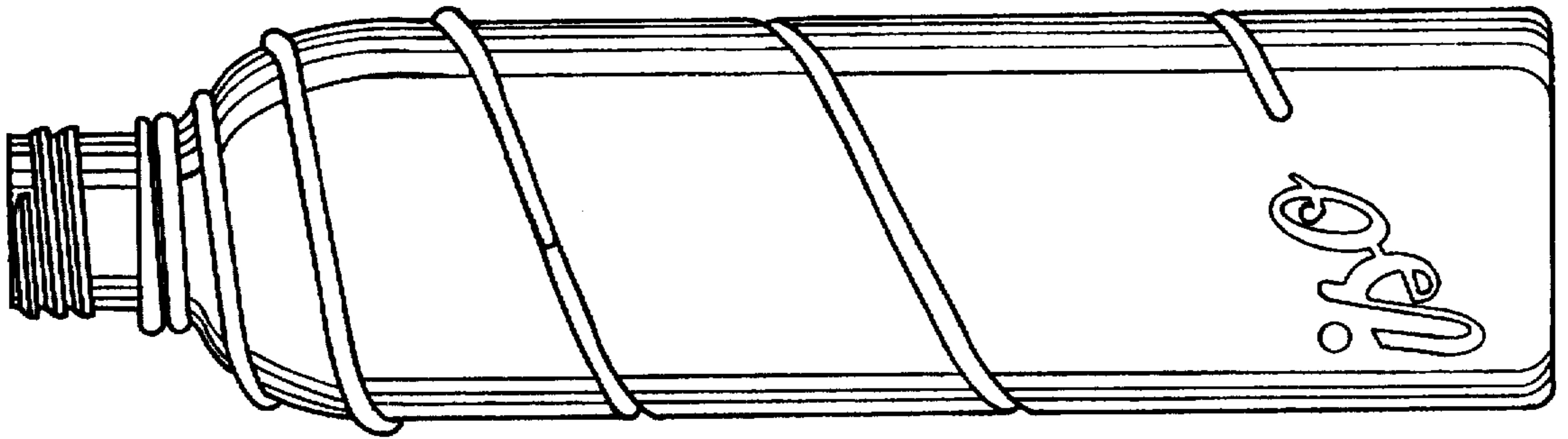

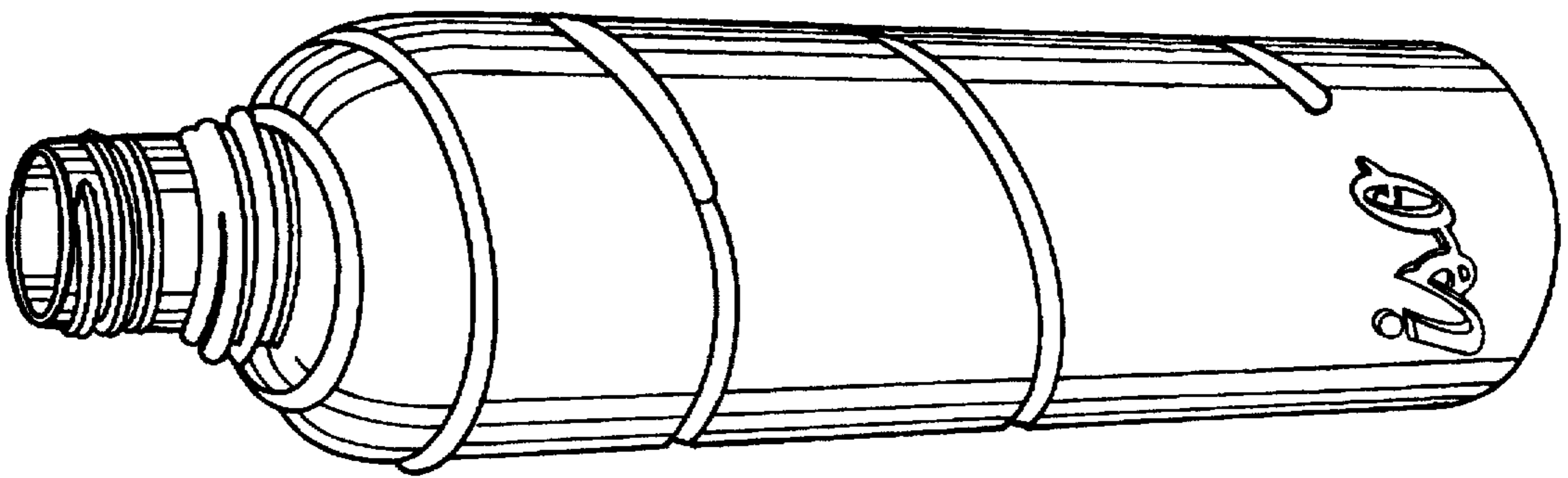

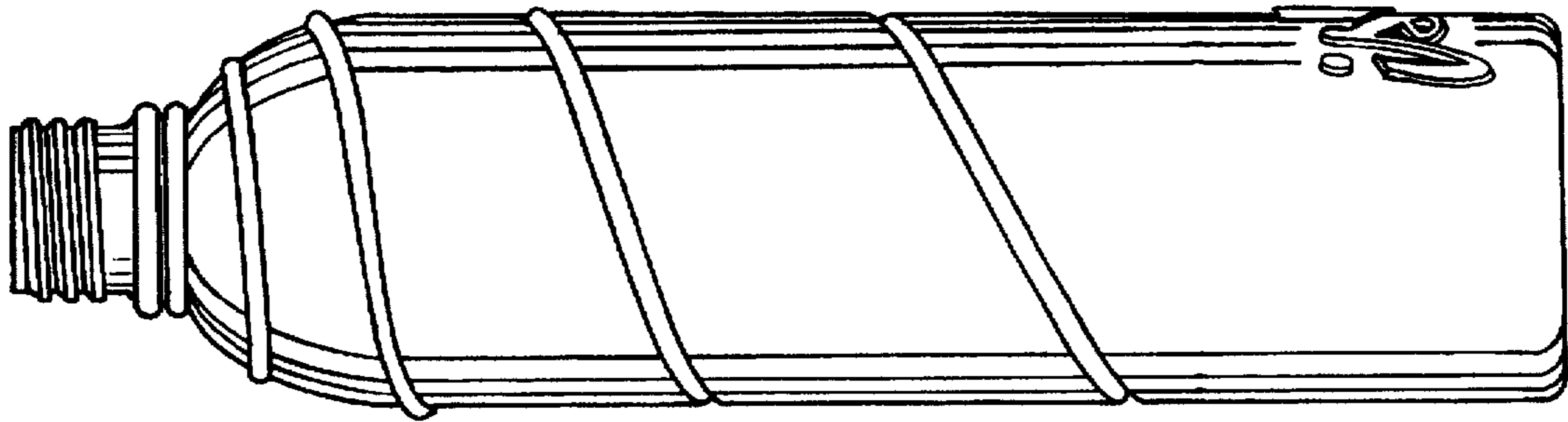

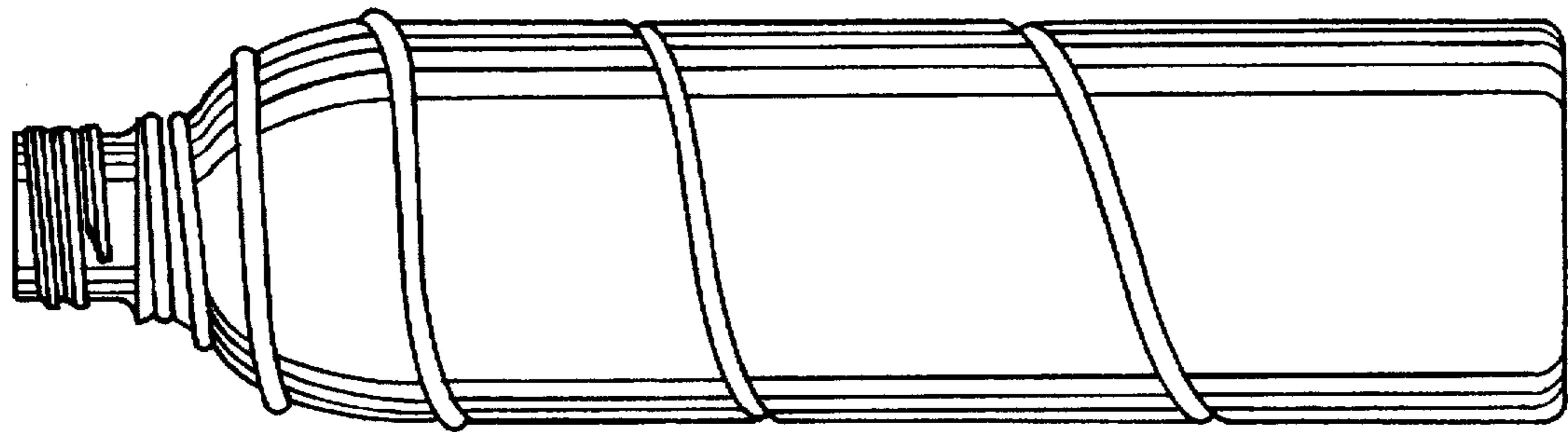

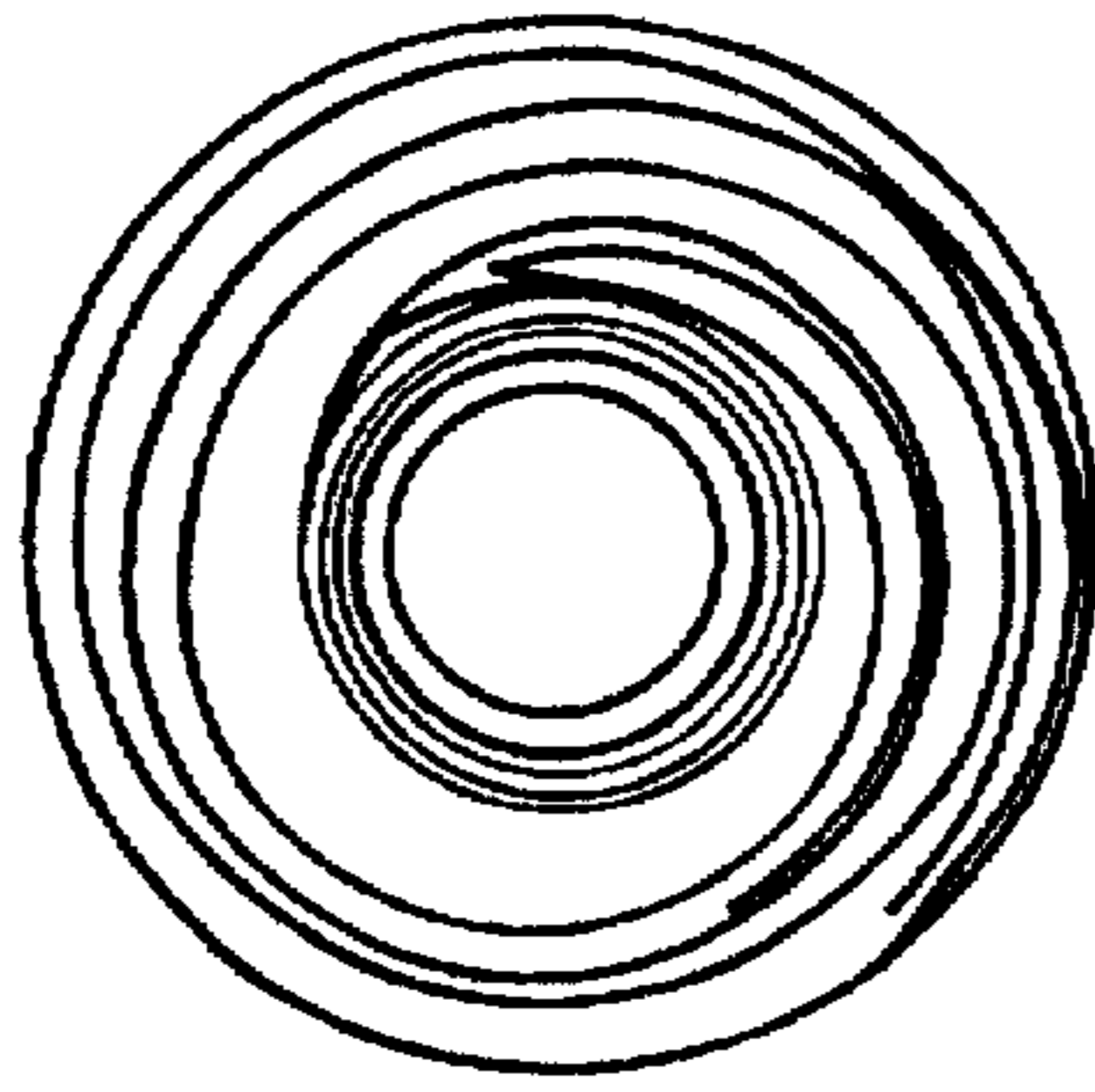

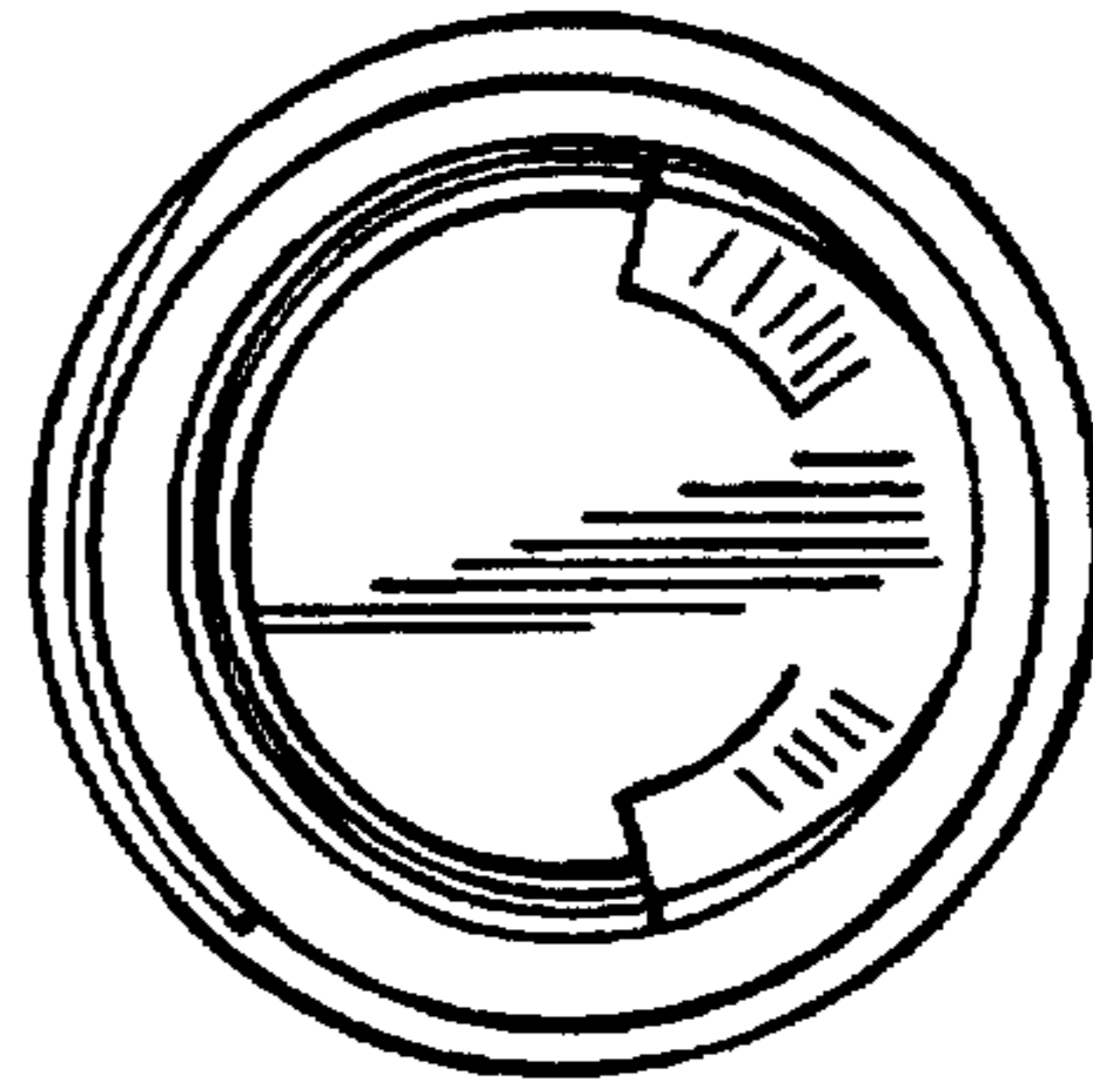

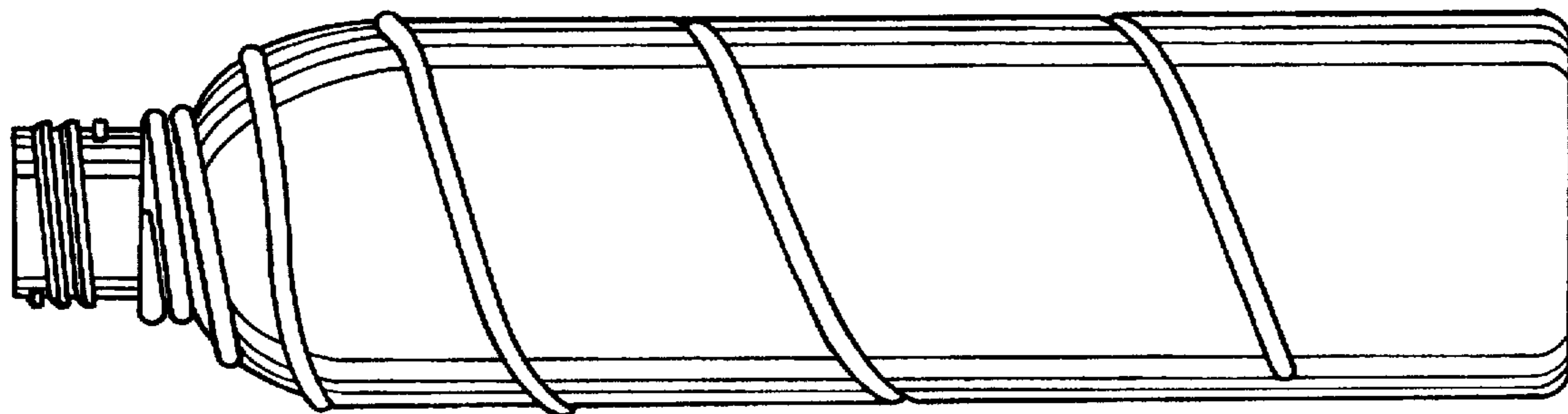

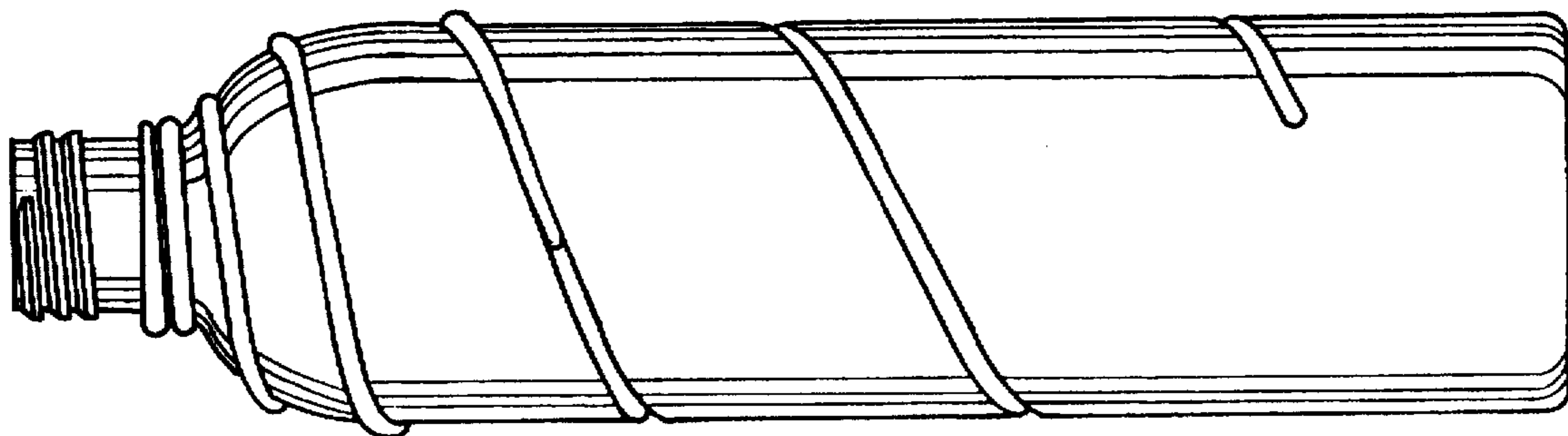

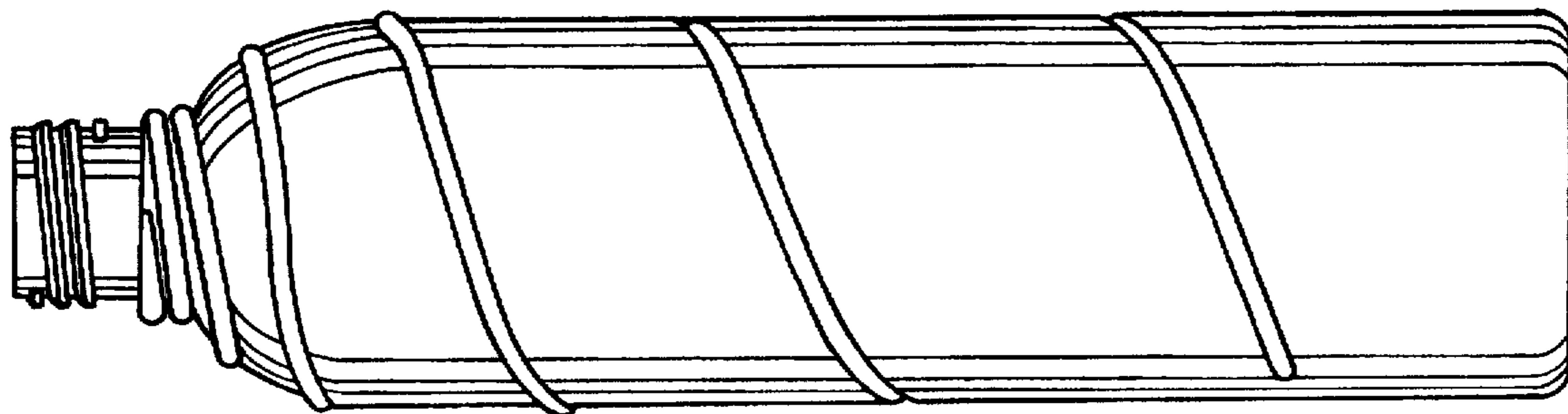

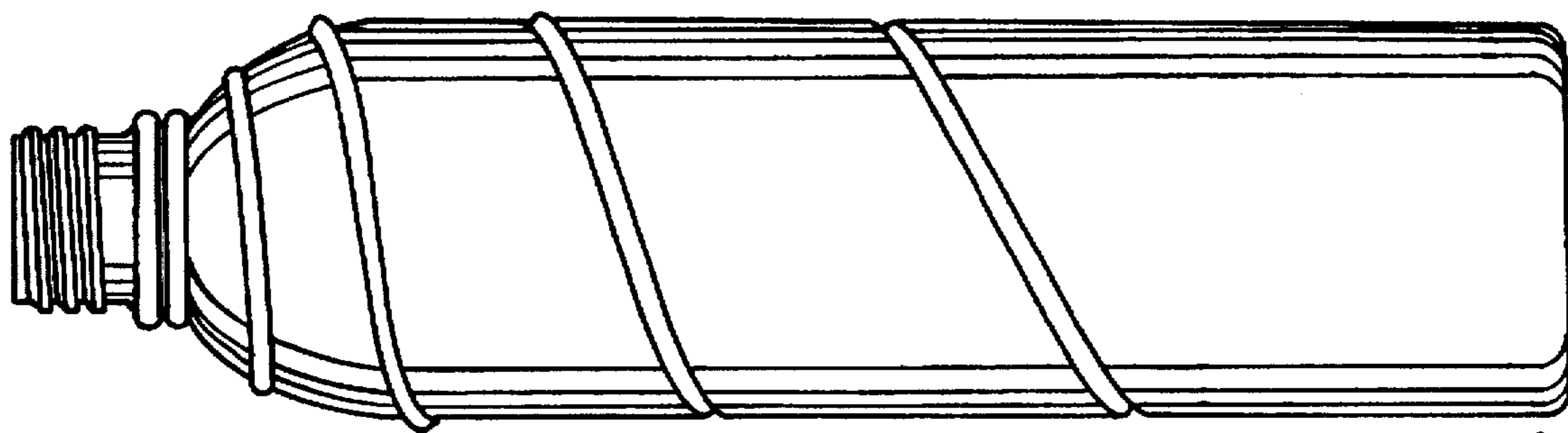

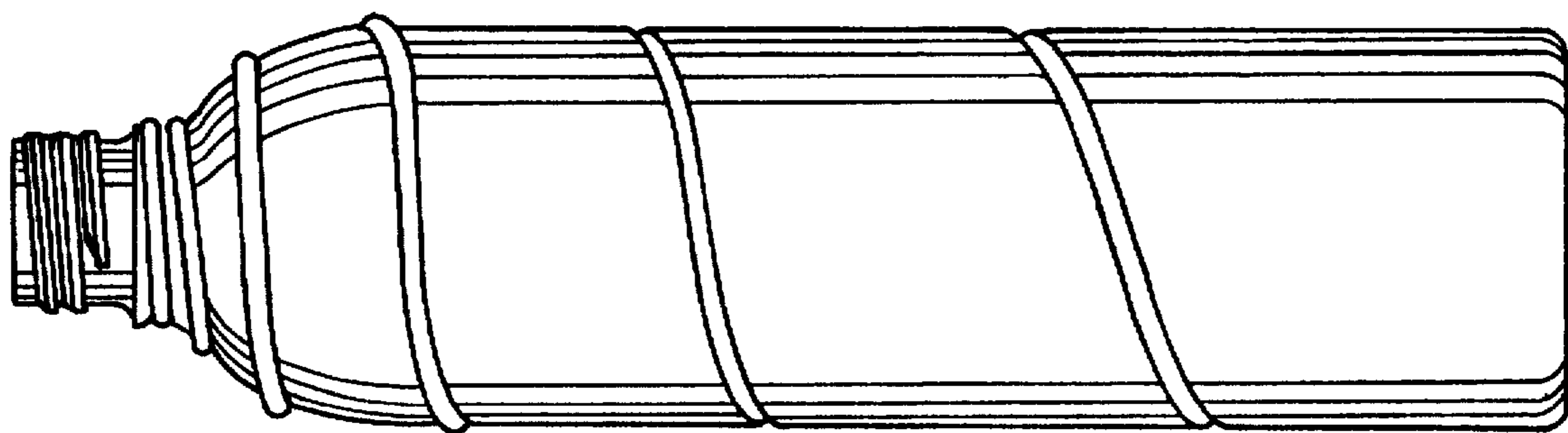

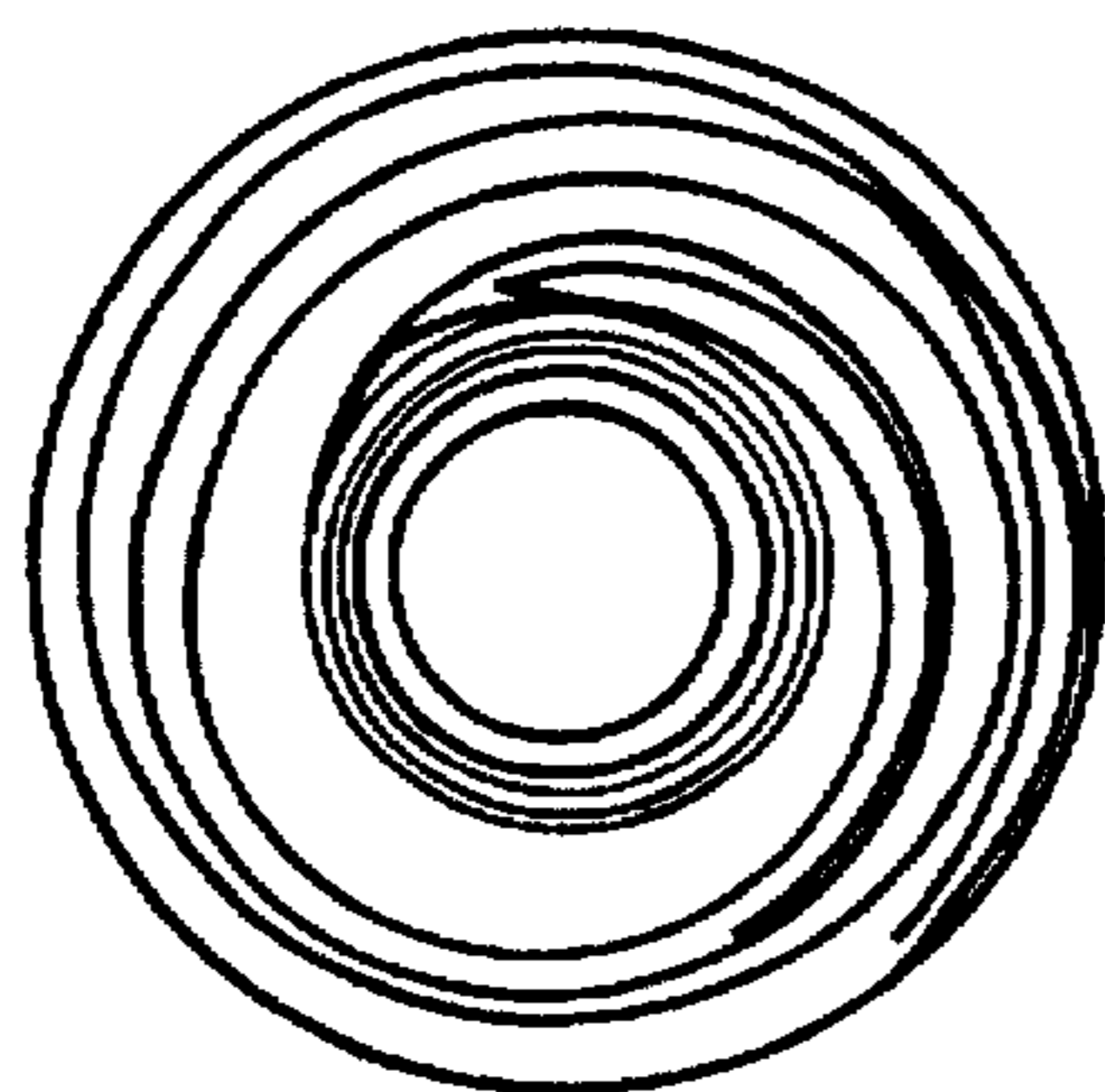

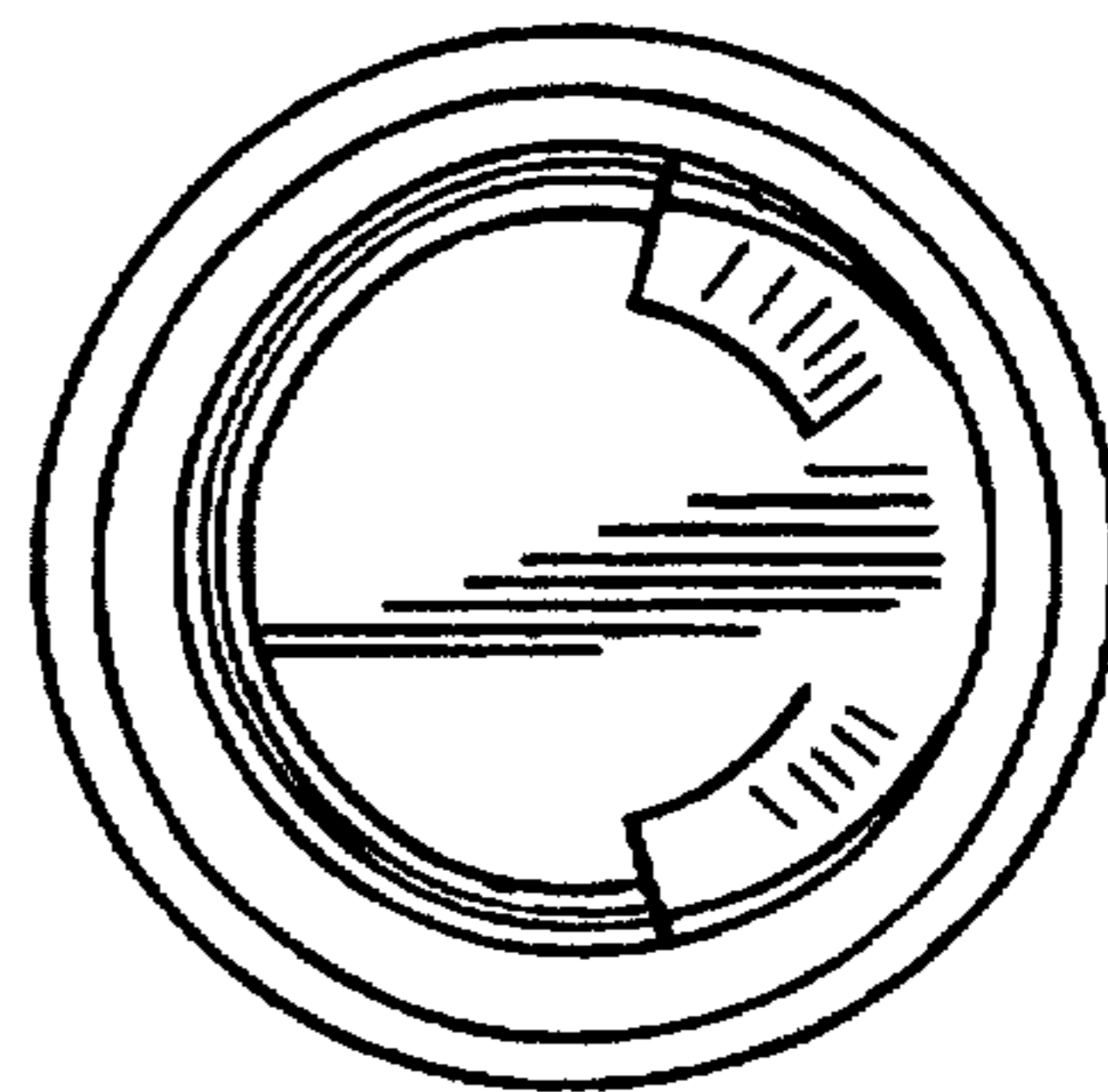
