[57] **CLAIM**

The ornamental design for a battery operated hand-held dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a battery operated hand-held dispenser showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a left side elevation view thereof; and, FIG. 5 is a bottom plan view thereof.

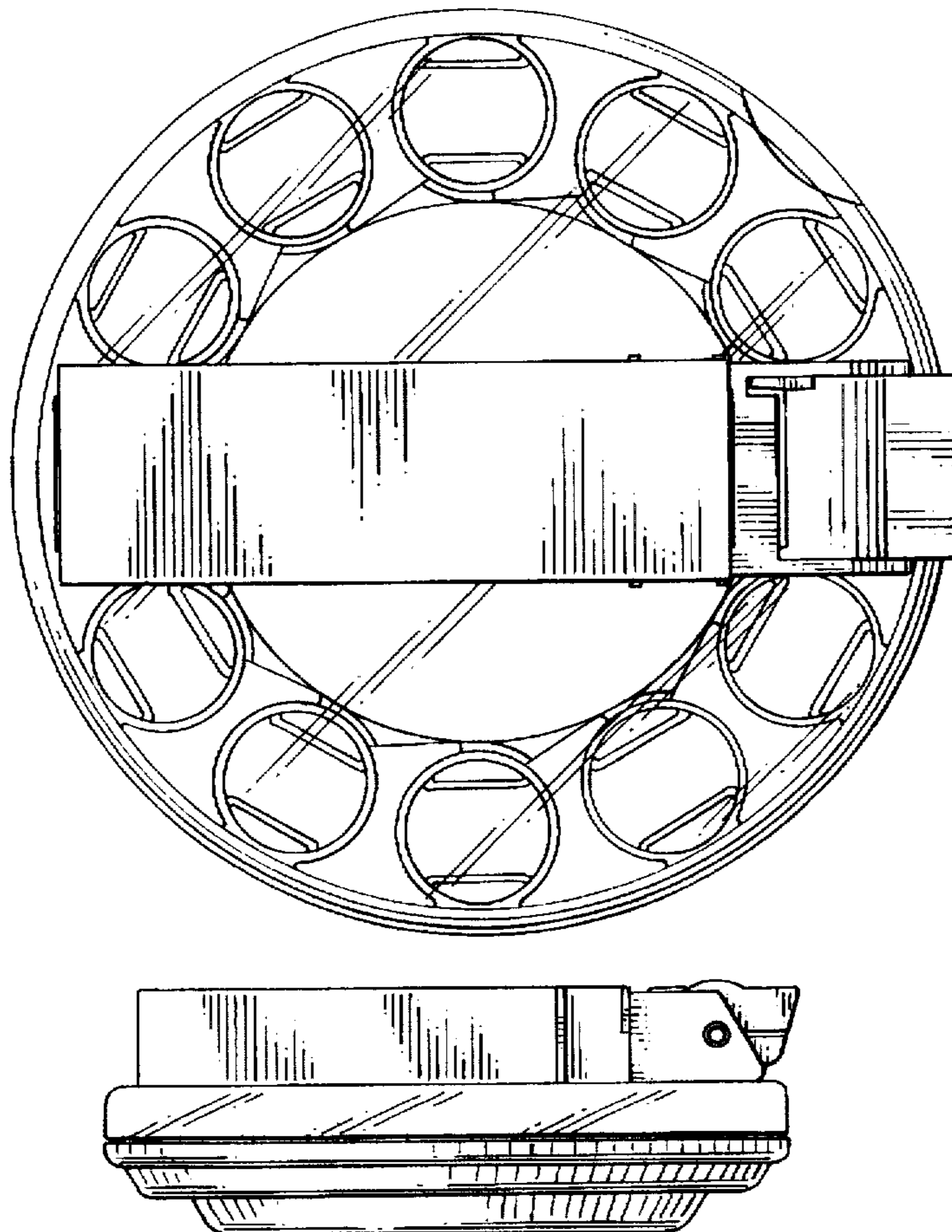

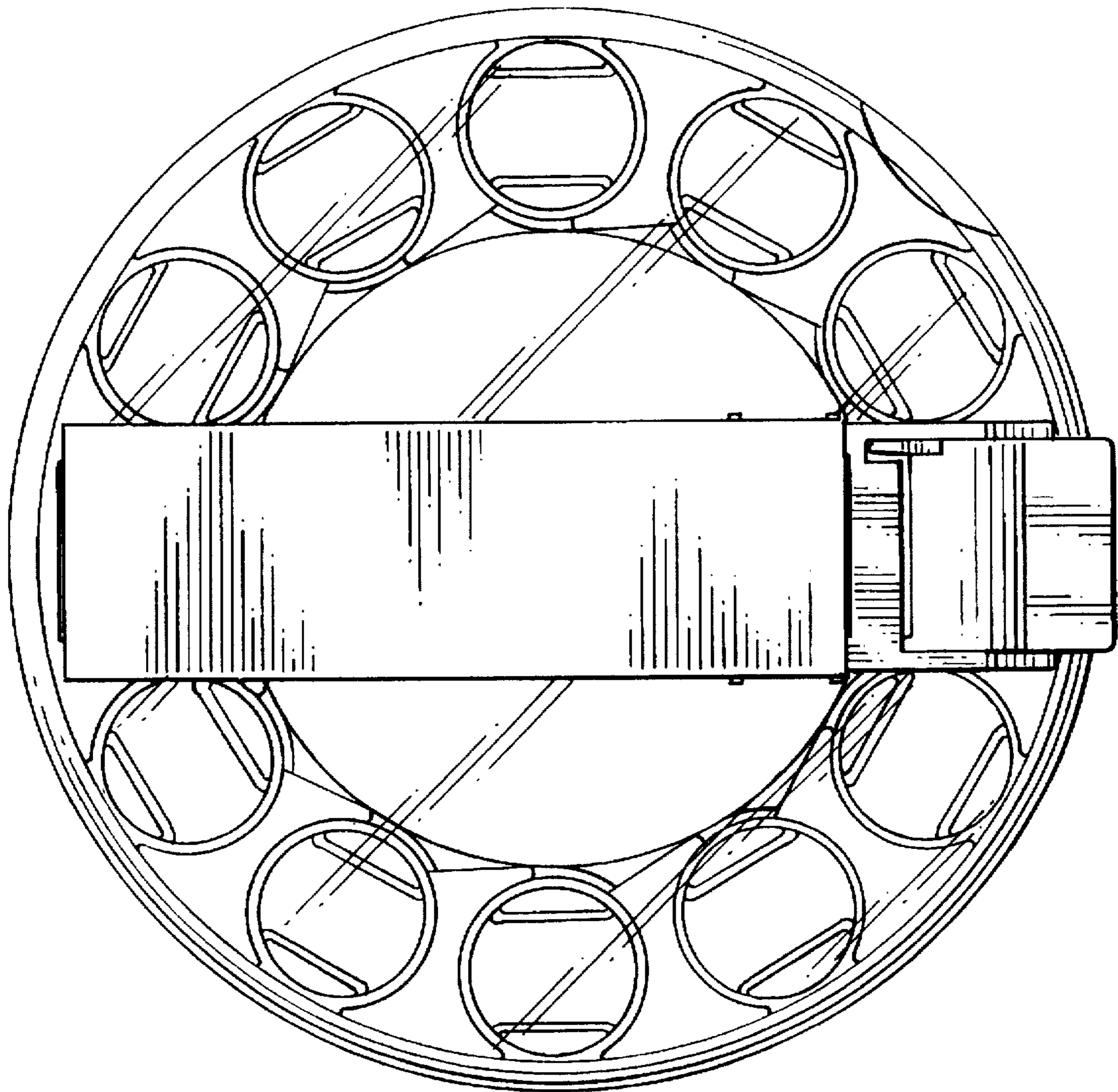

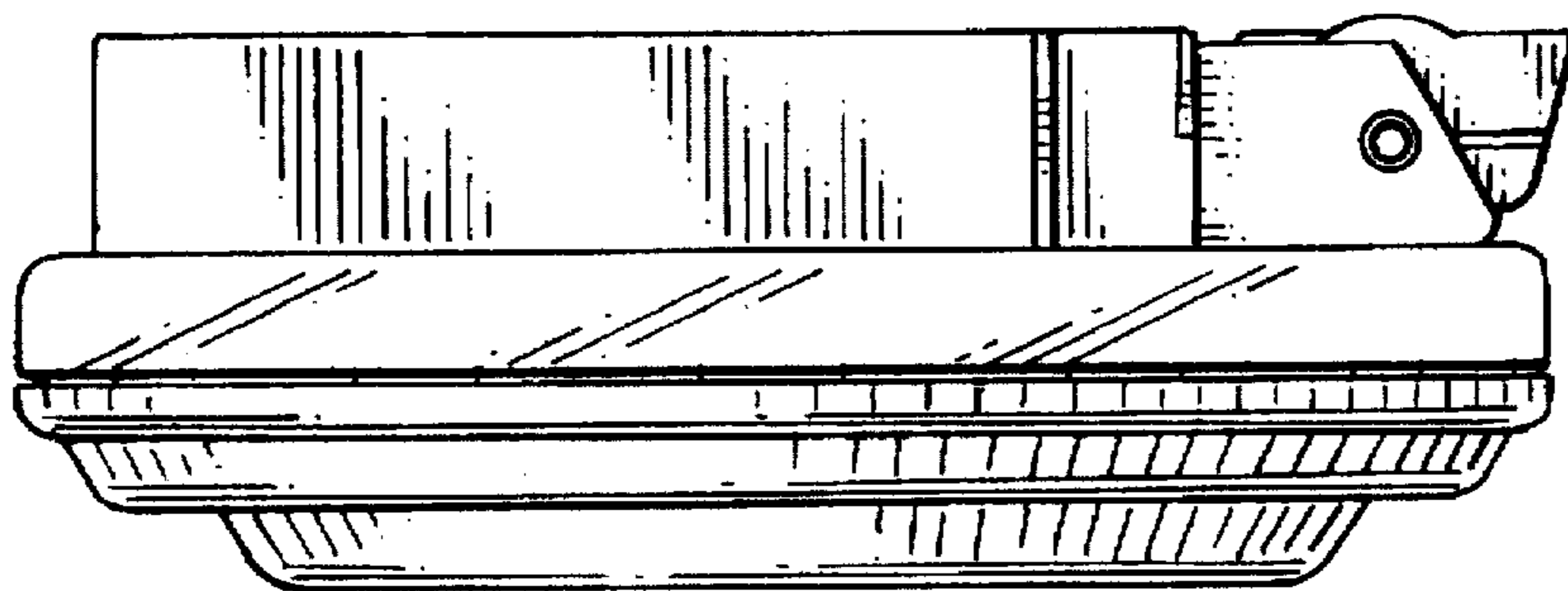

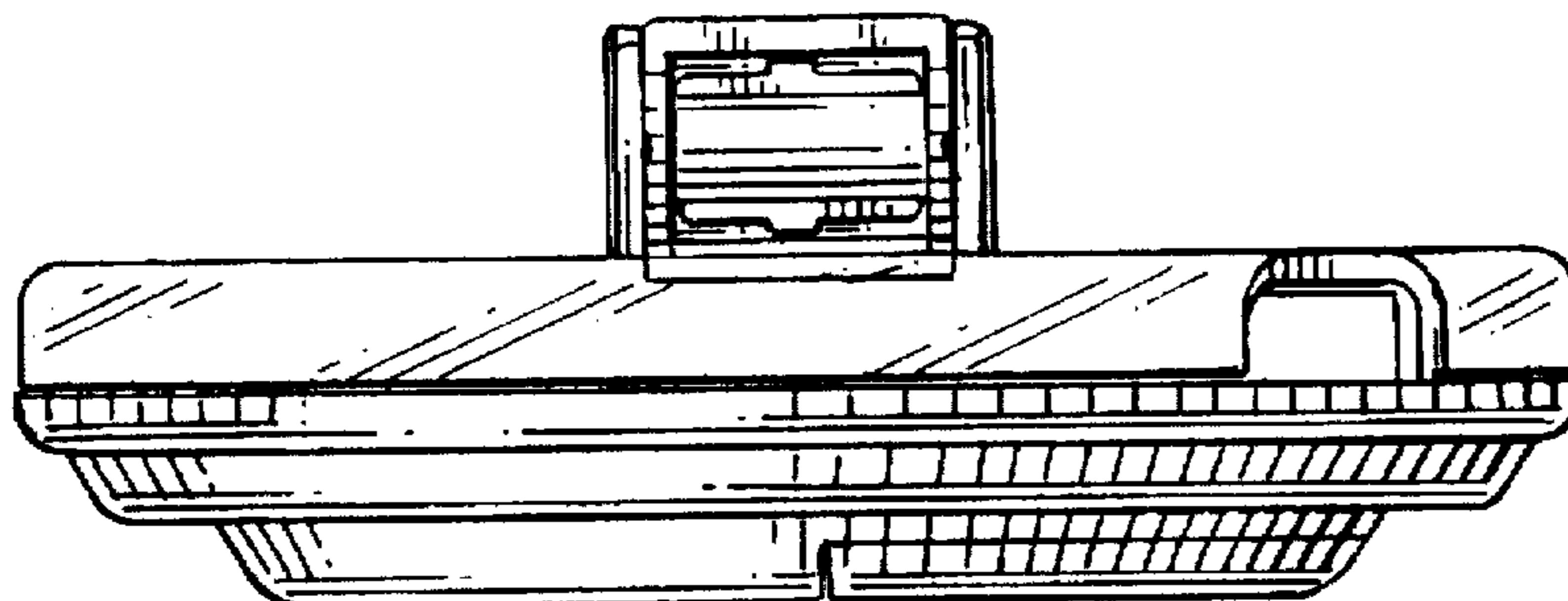

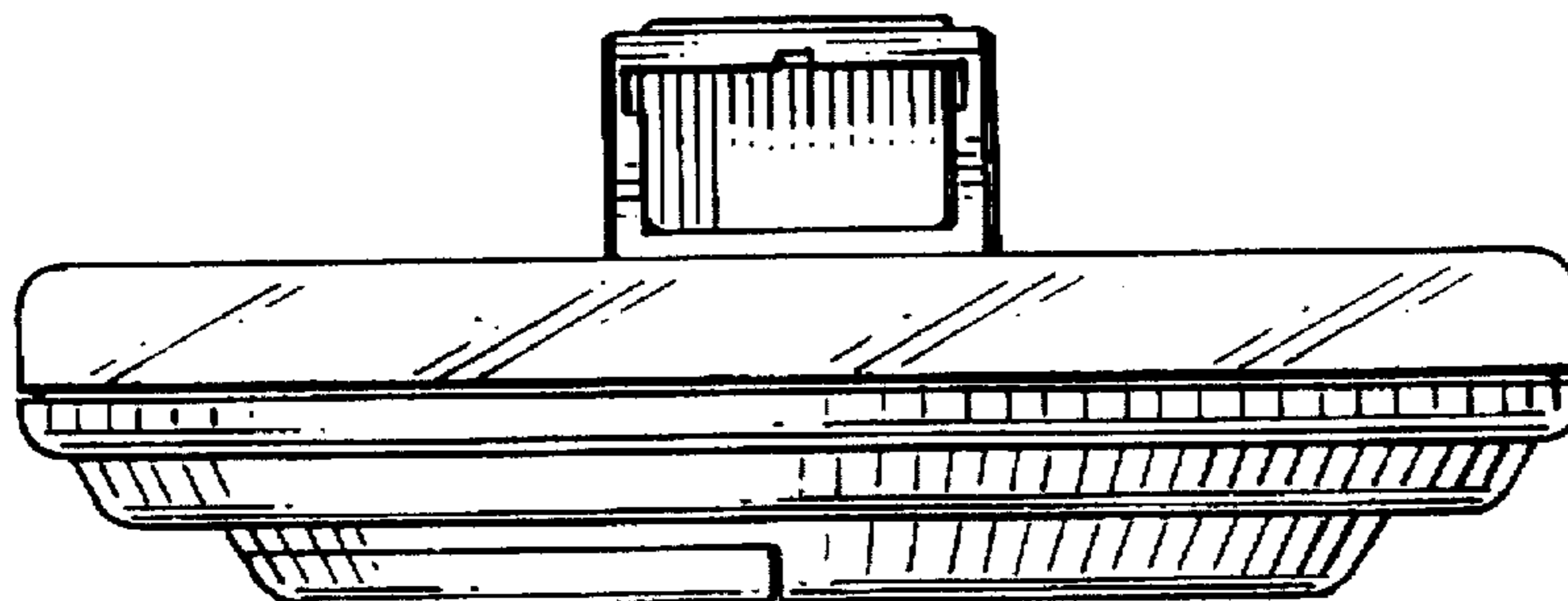
