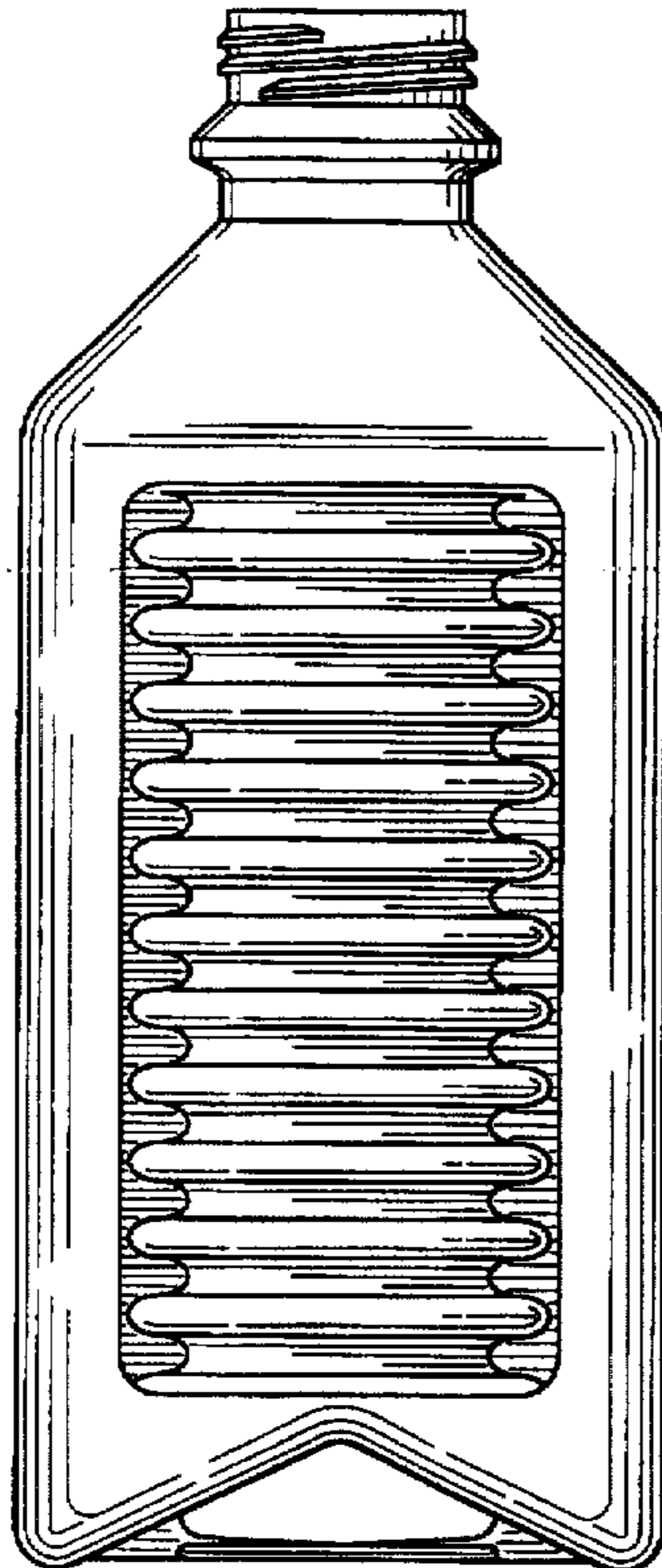
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of bottle for a nutritional product showing our new design;

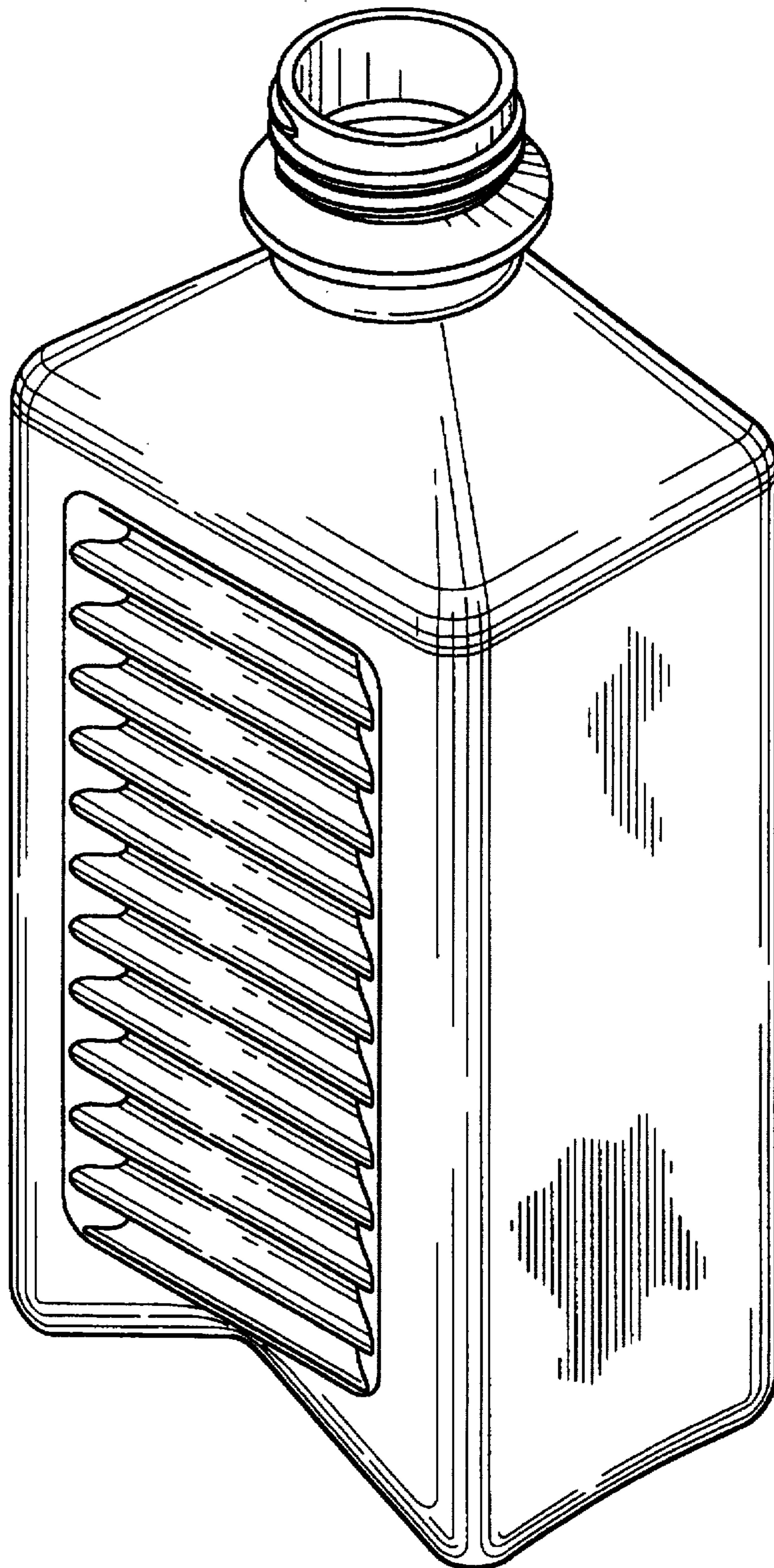

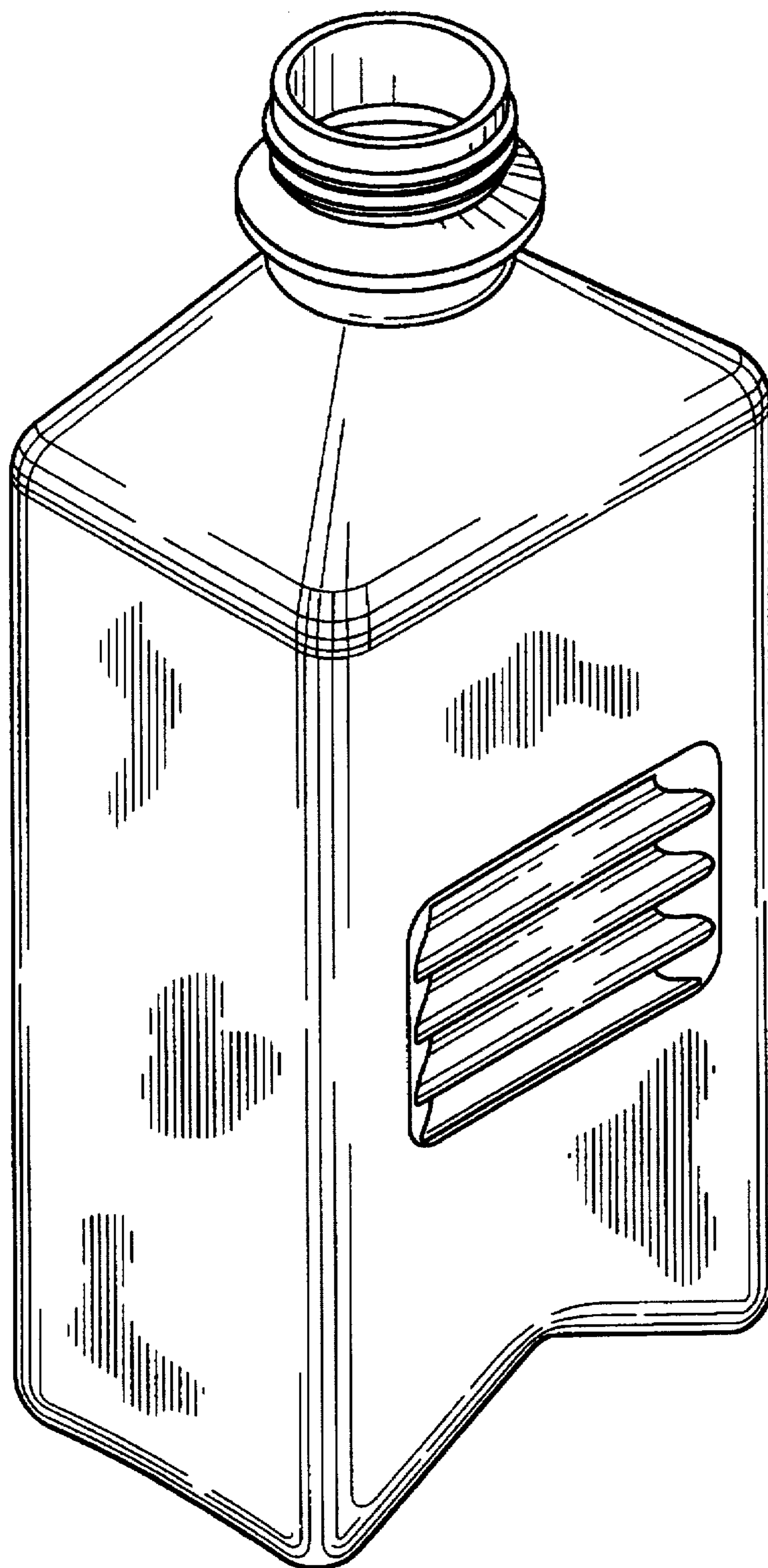

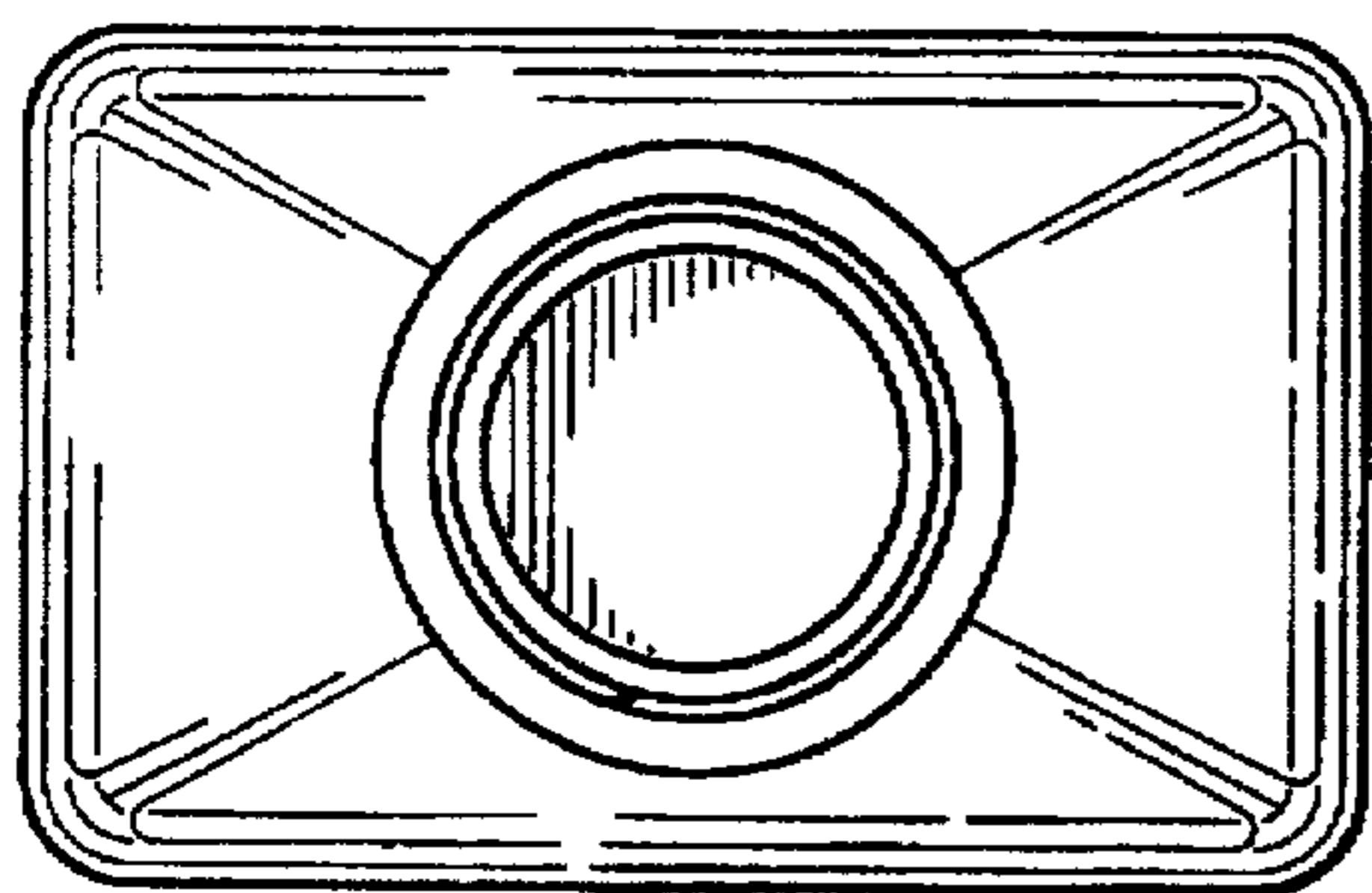

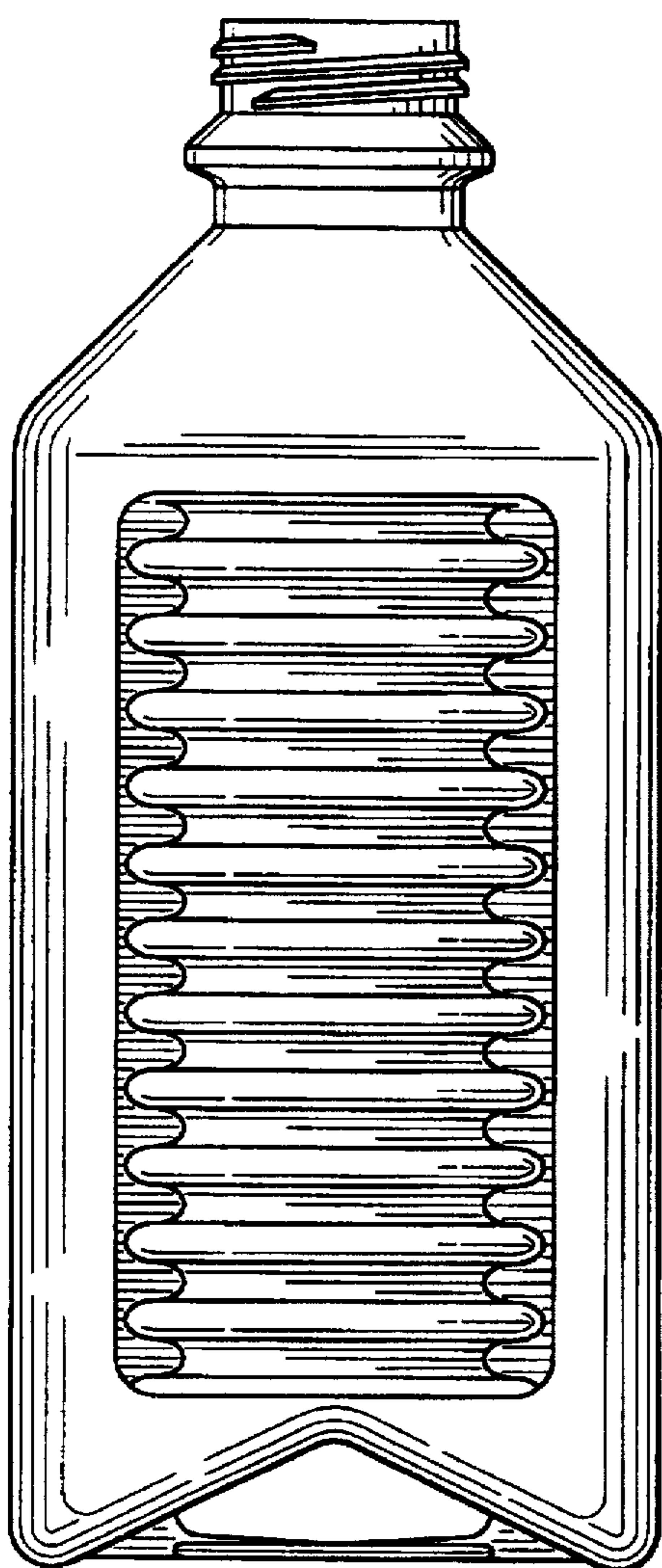

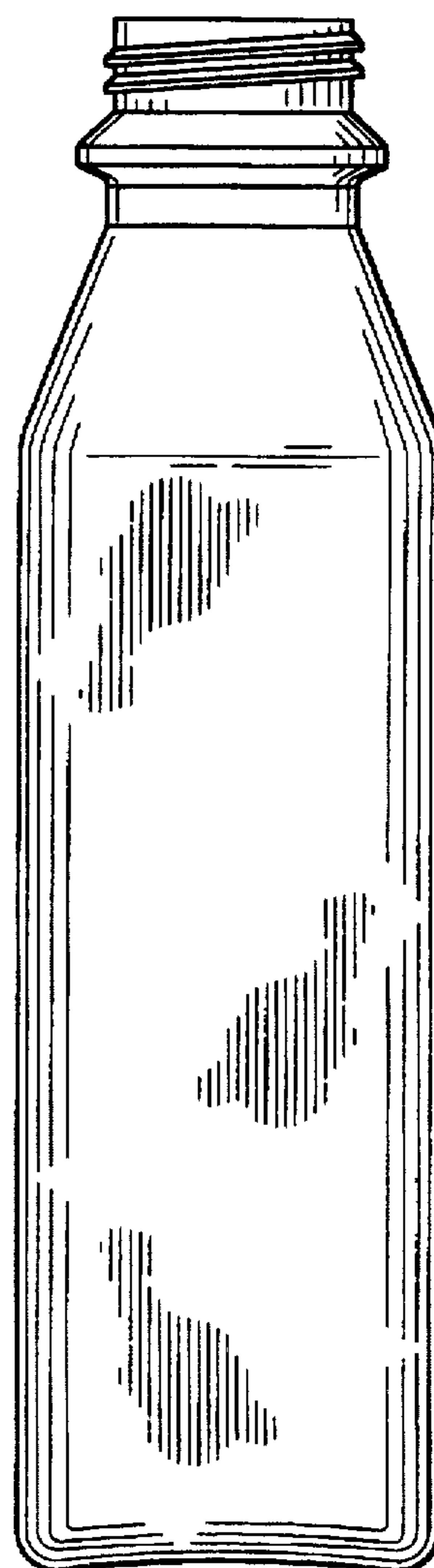

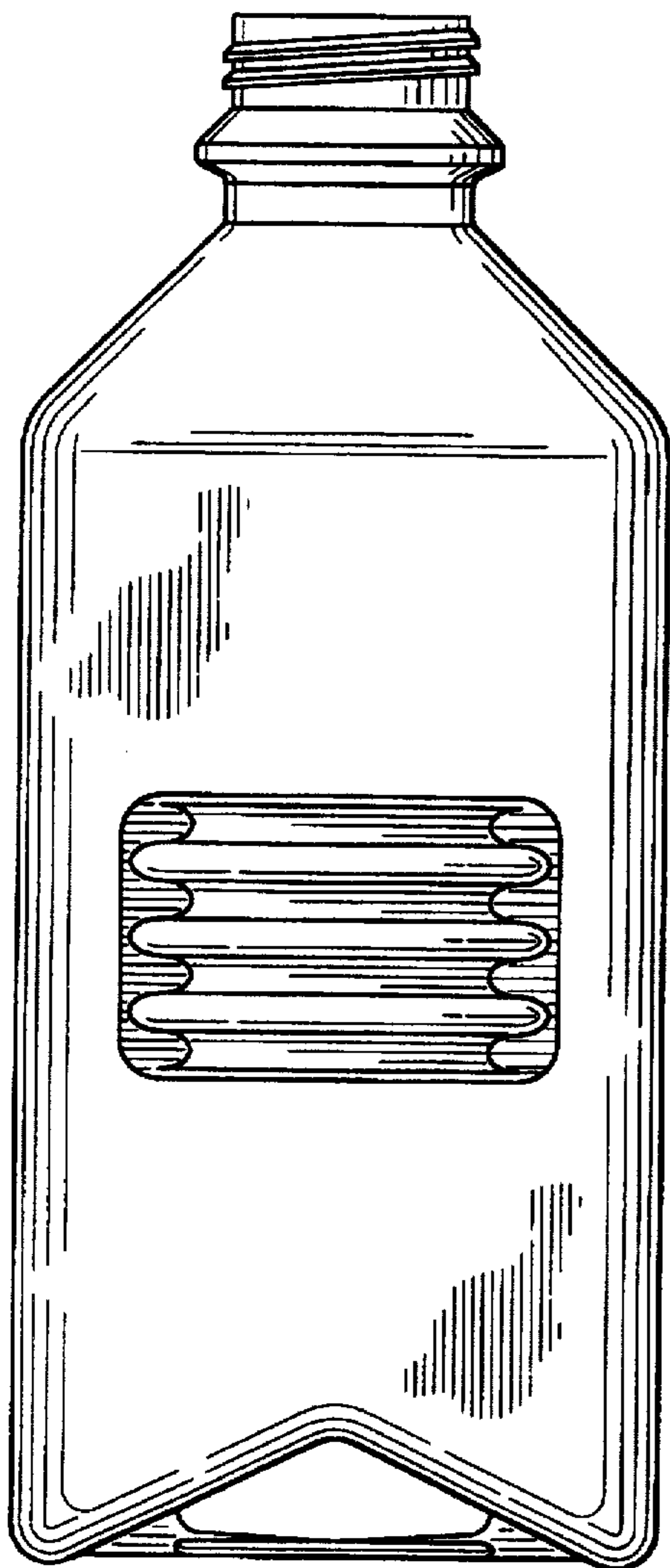

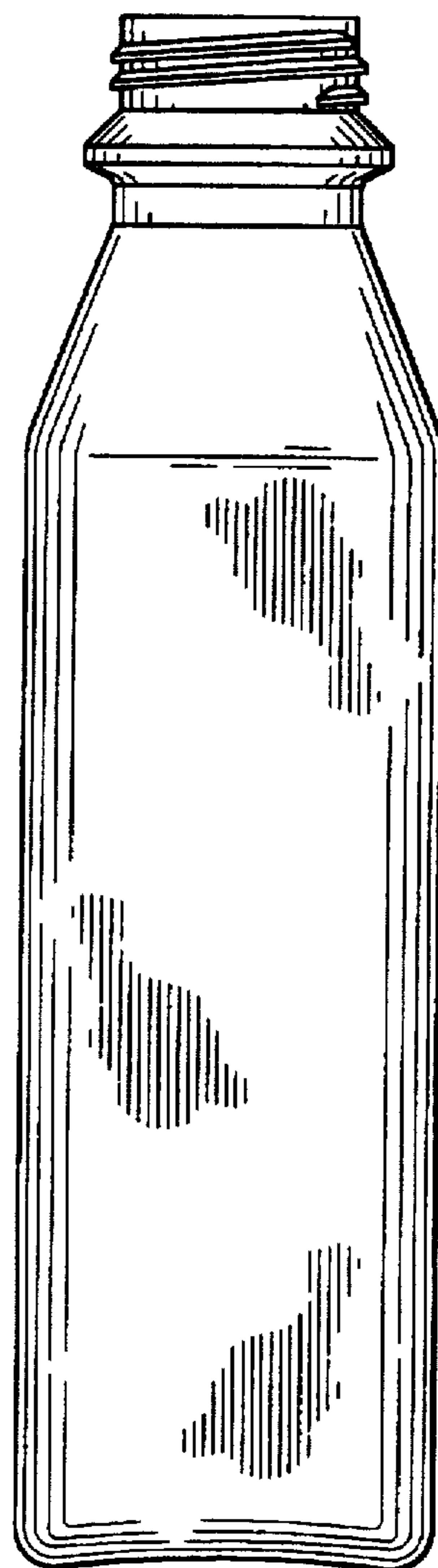

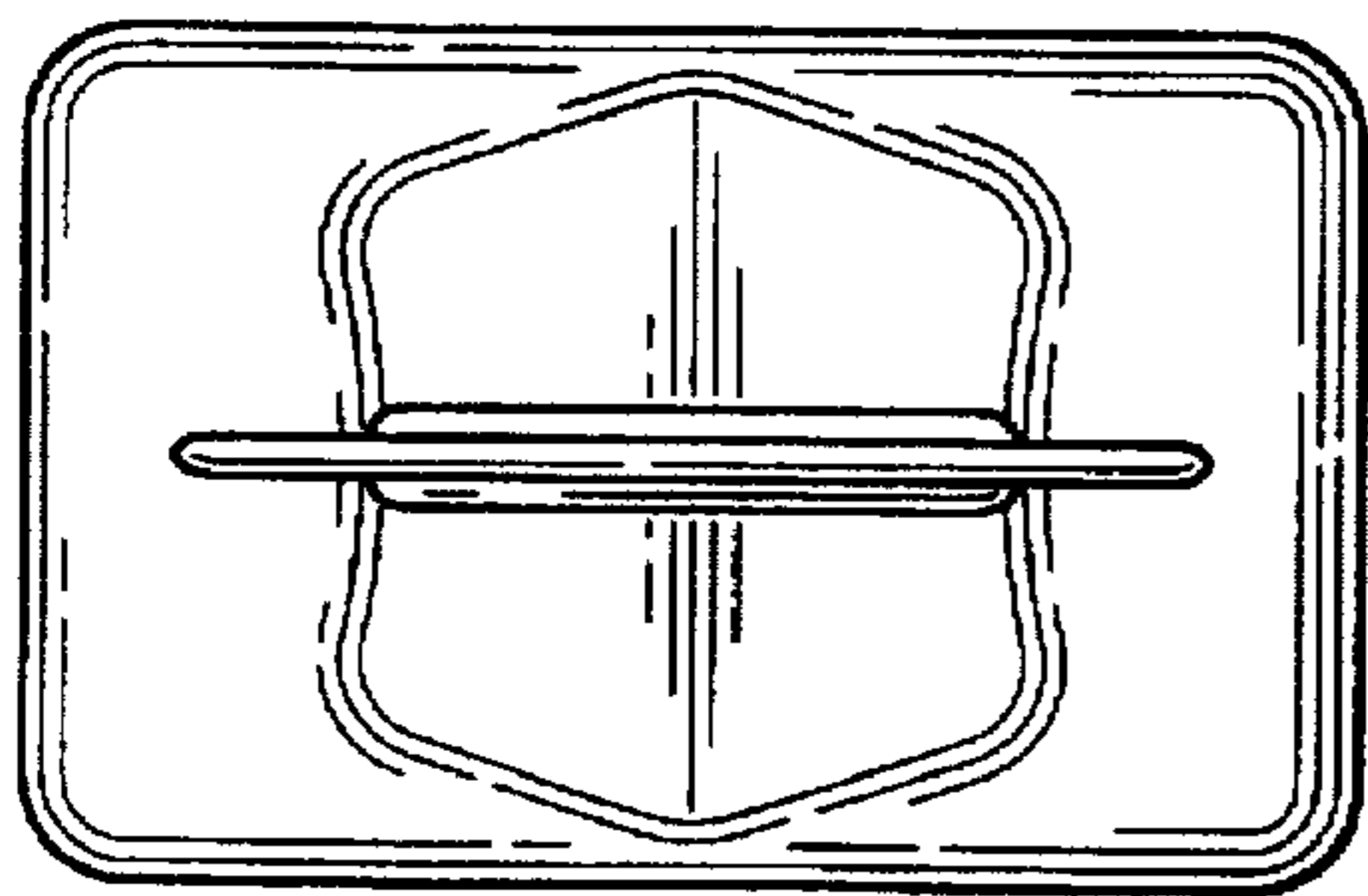
