[57] **CLAIM**

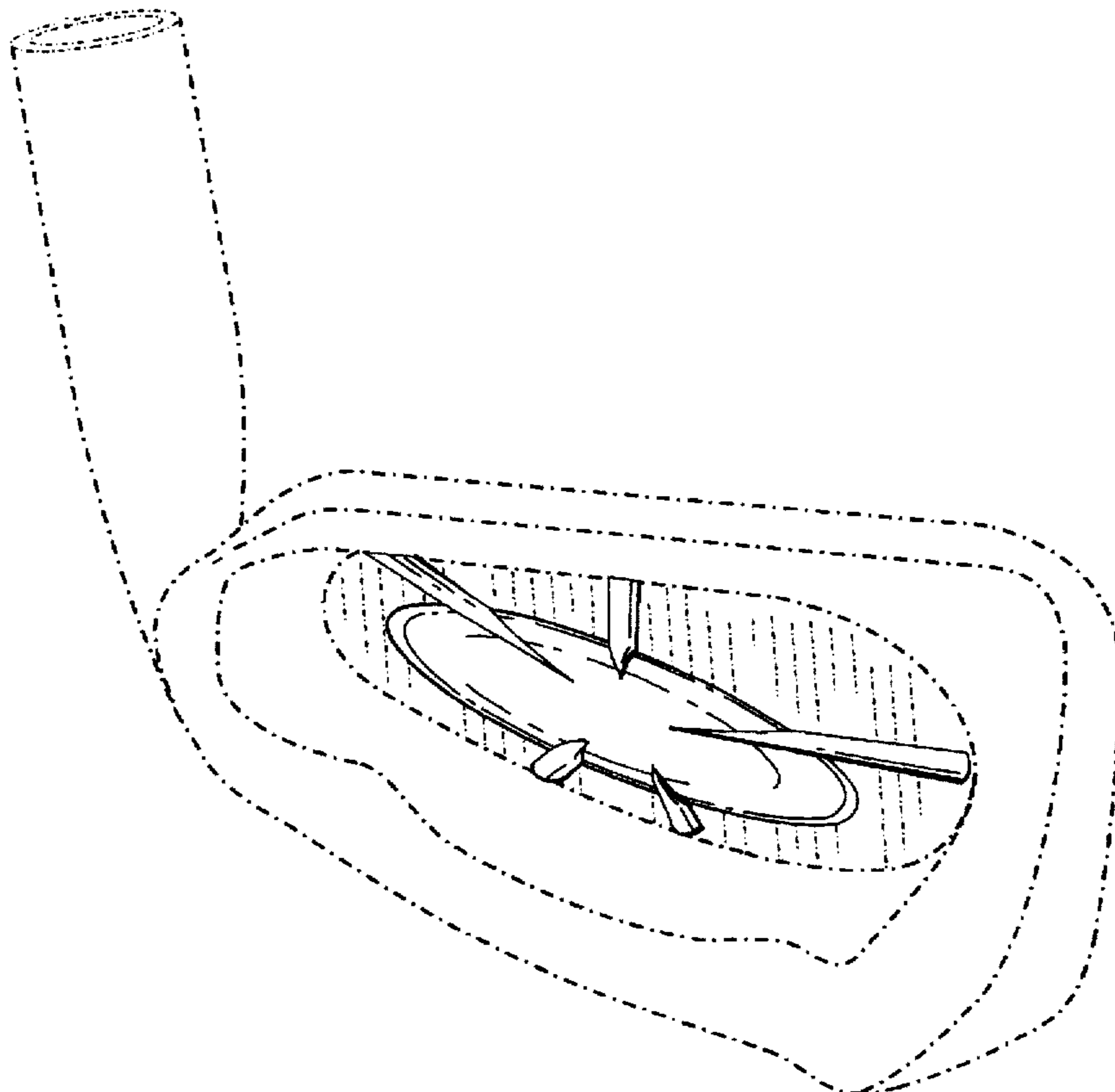
The ornamental design for a cavity insert for a golf club head, as shown and described.

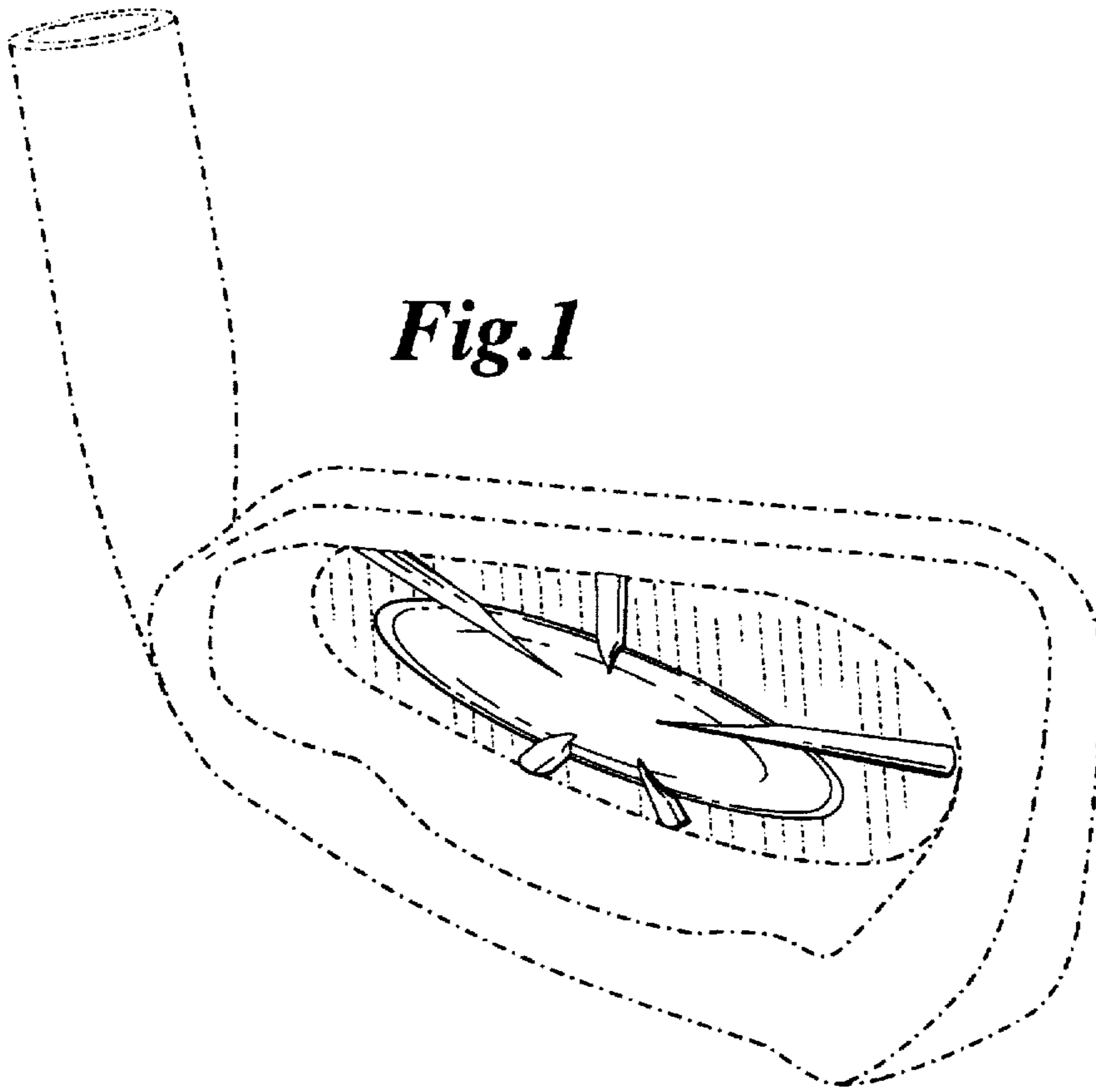

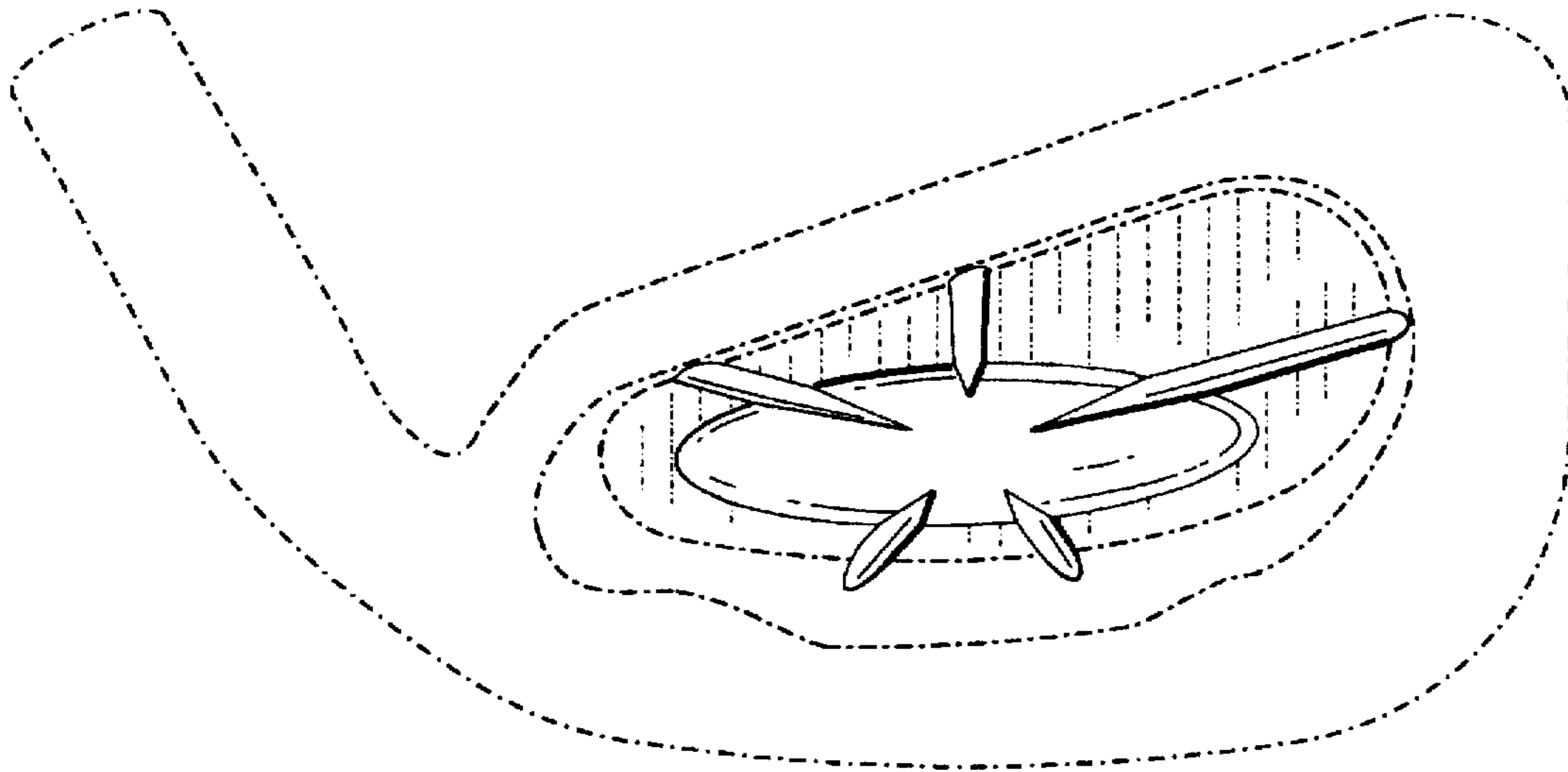
