## [57] CLAIM

The ornamental design for a combined carrying device and separable mini-carrying device, as shown and described.

## DESCRIPTION

FIG. 1 is a front elevational view of a combined carrying device and separable mini-carrying device showing my new design;

FIG. 2 is a back elevational view of the combined carrying device and separable mini-carrying device shown in FIG. 1;

FIG. 3 is a right-side elevational view of the combined carrying device and separable mini-carrying device shown in FIG. 1;

FIG. 4 is a left-side elevational view of the combined carrying device and separable mini-carrying device shown in FIG. 1;

FIG. 5 is a top plan view of the combined carrying device and separable mini-carrying device shown in FIG. 1;

FIG. 6 is a bottom view of the combined carrying device and separable mini-carrying device shown in FIG. 1; and,

FIG. 7 is a front, right-side and top perspective view of a combined carrying device a separable mini-carrying device showing my new design in an unassembled state.

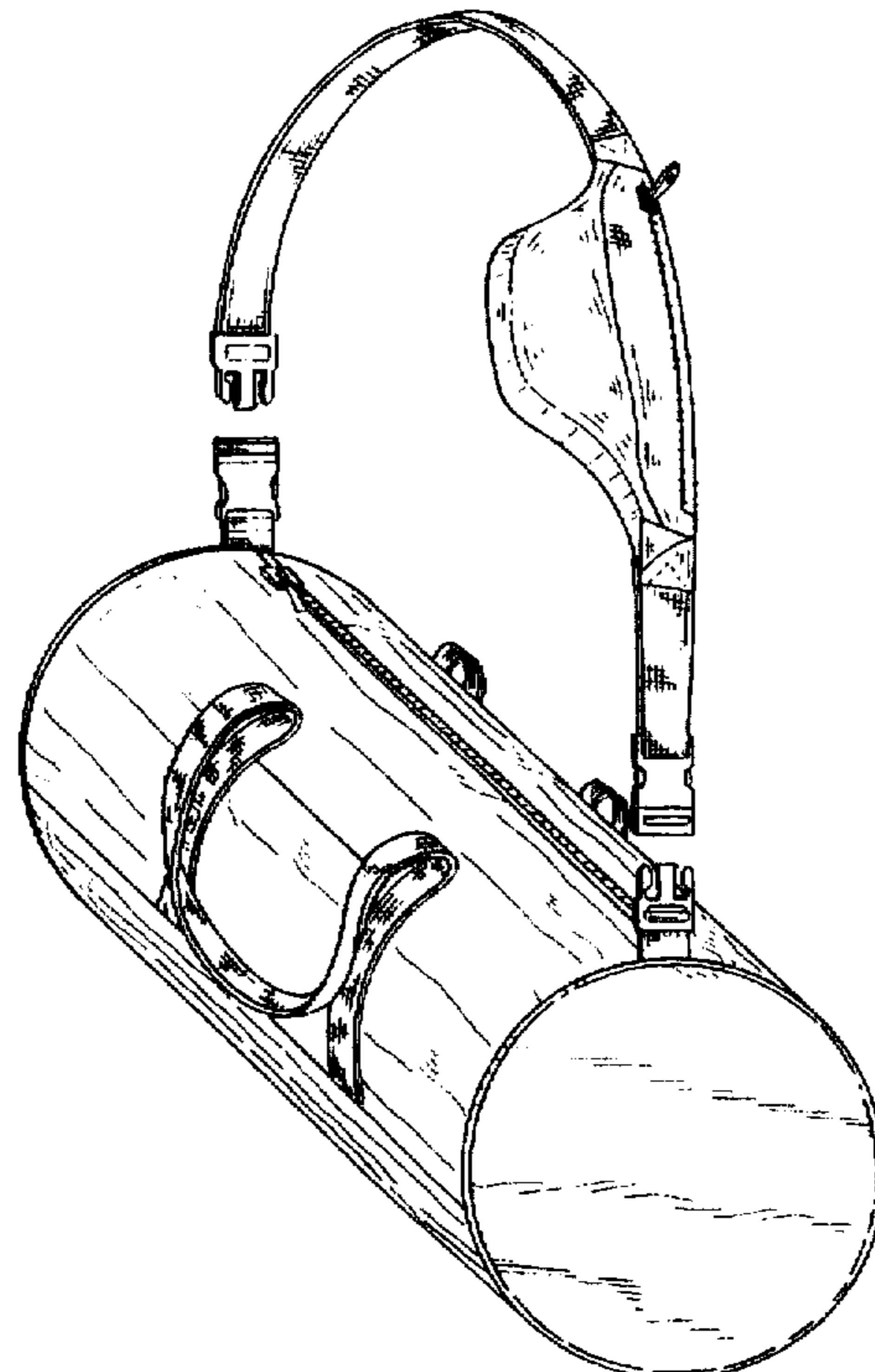

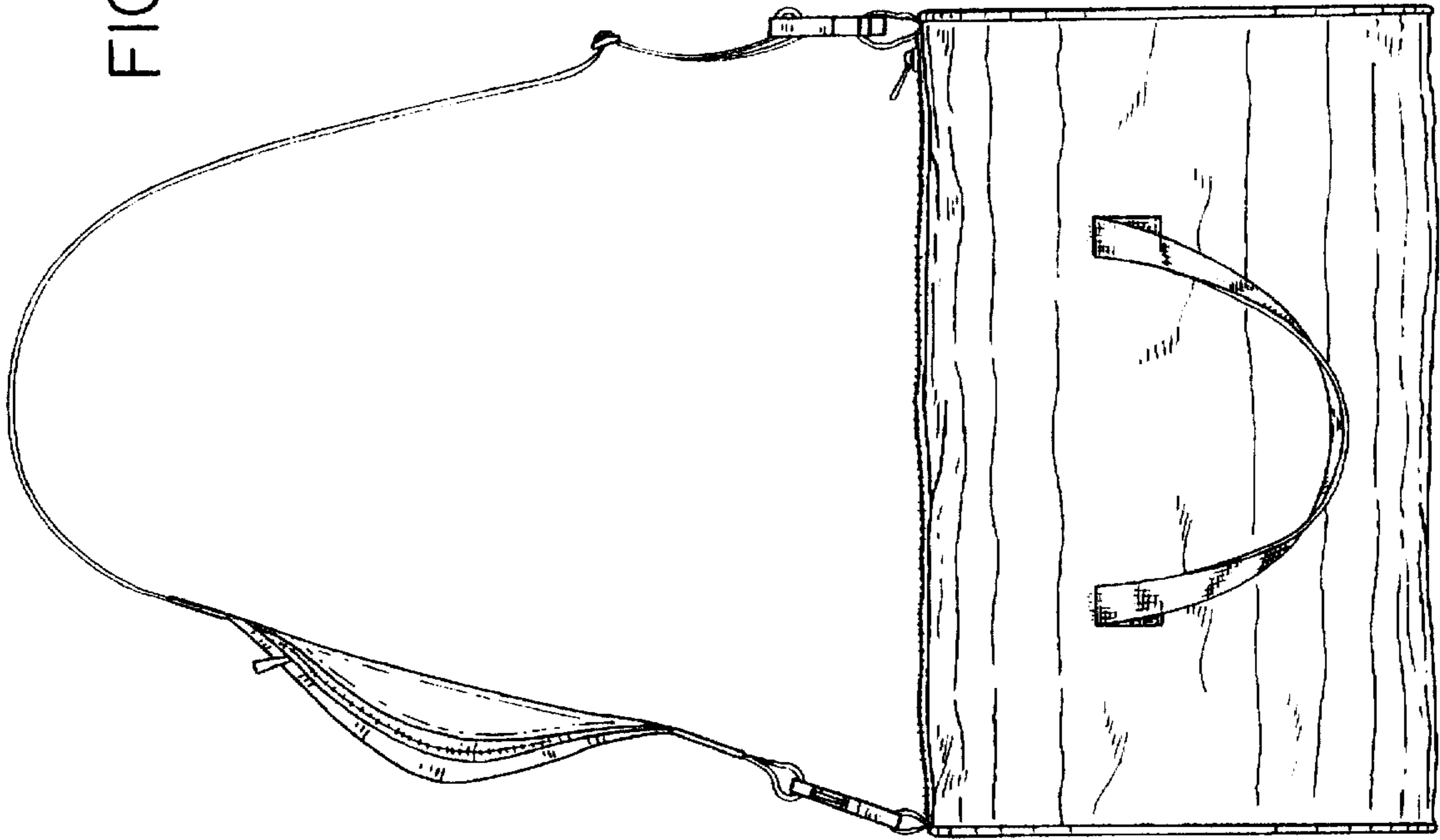

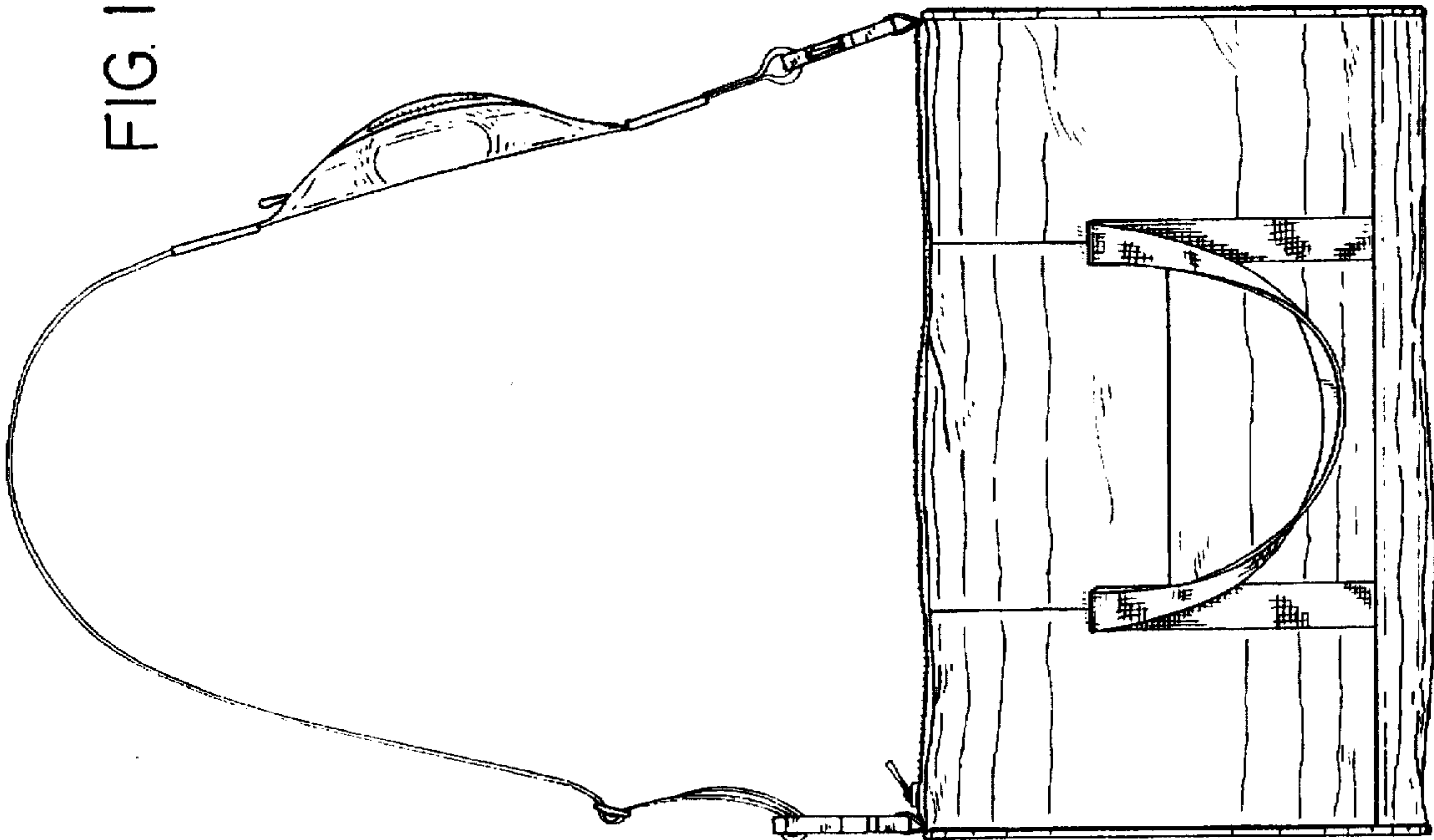

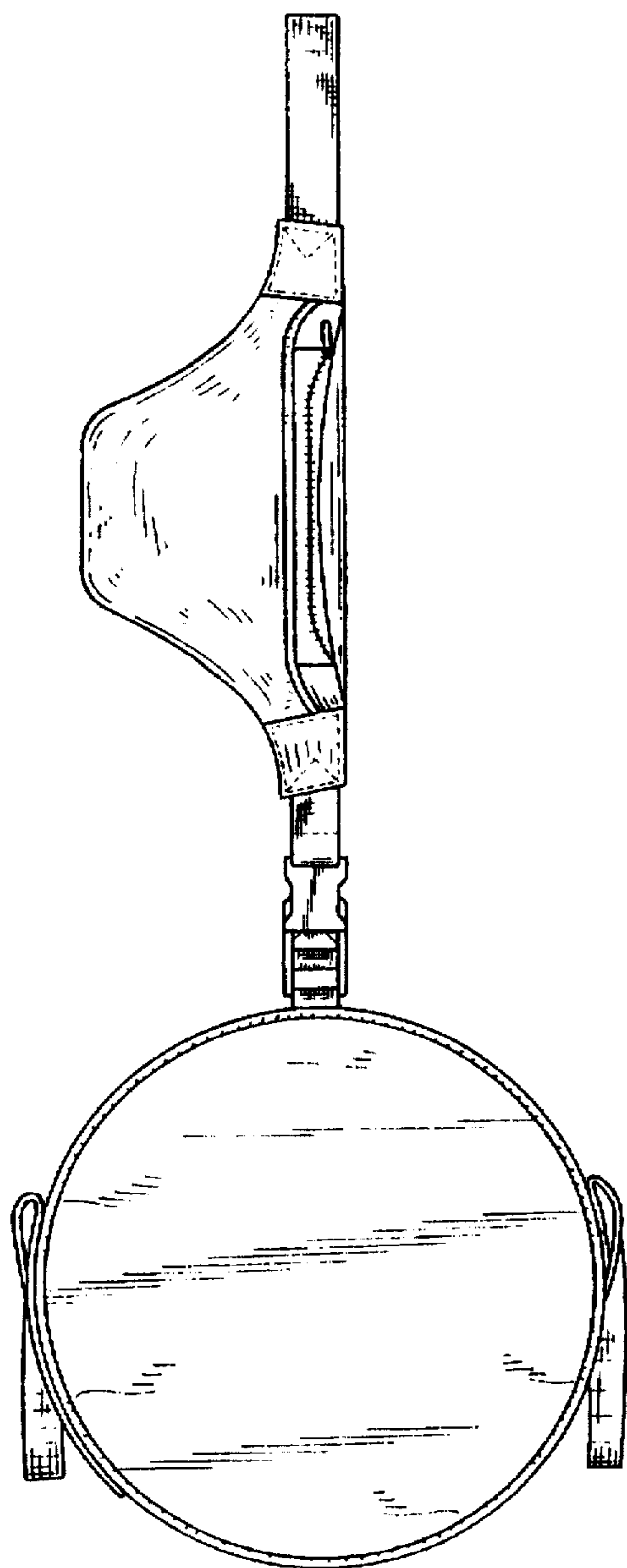

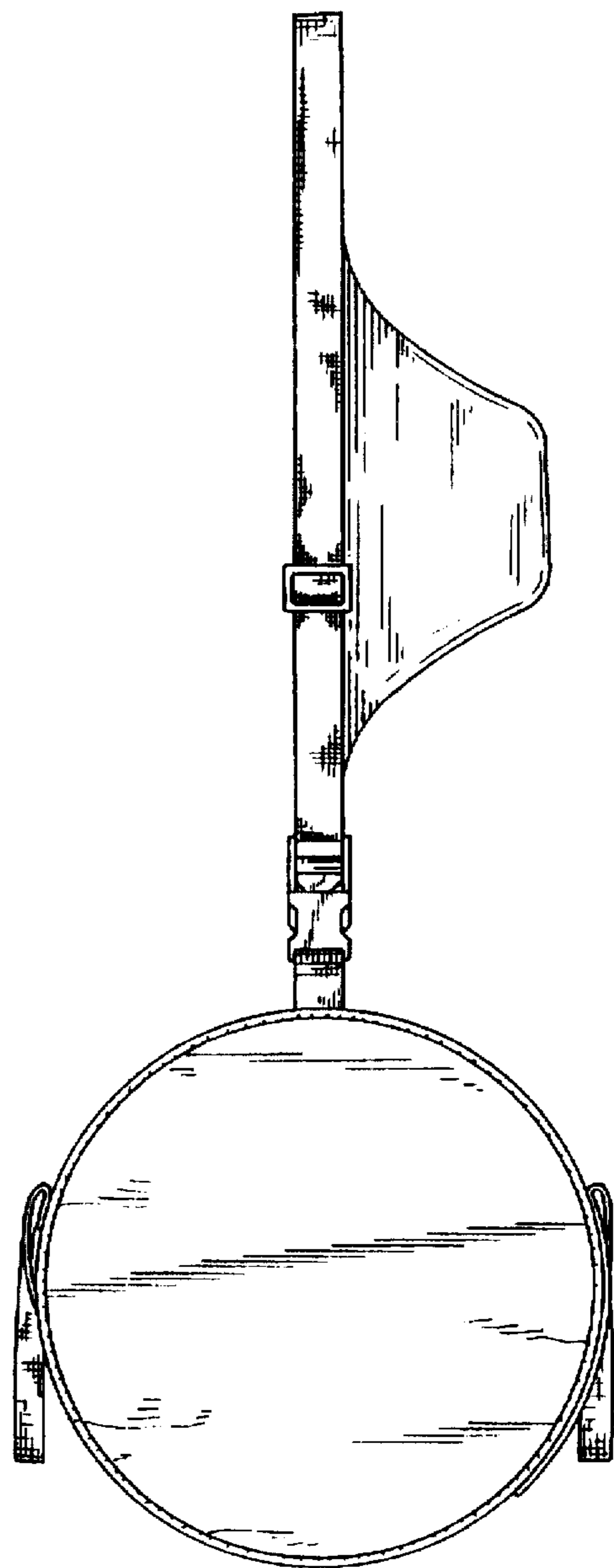

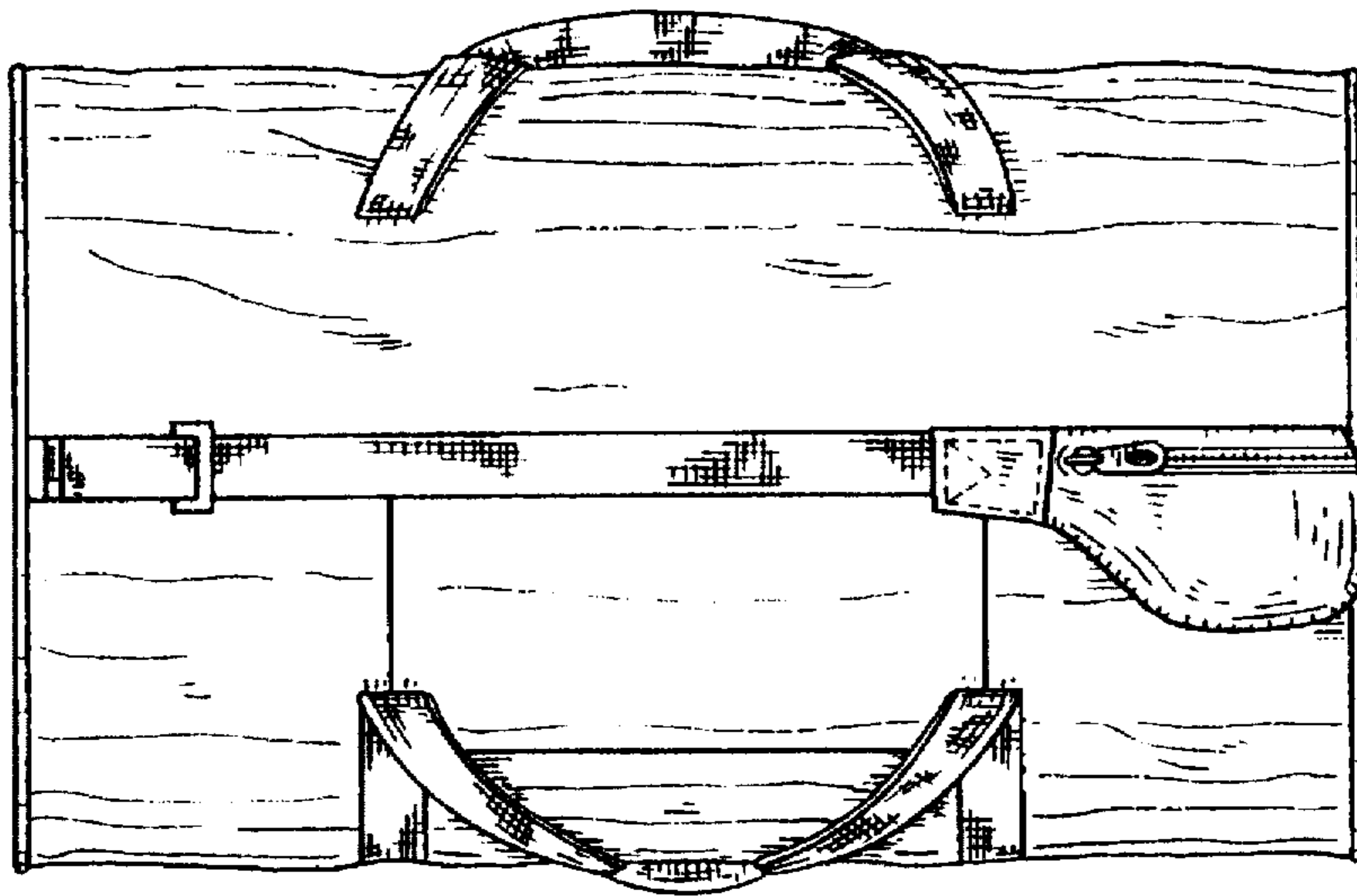
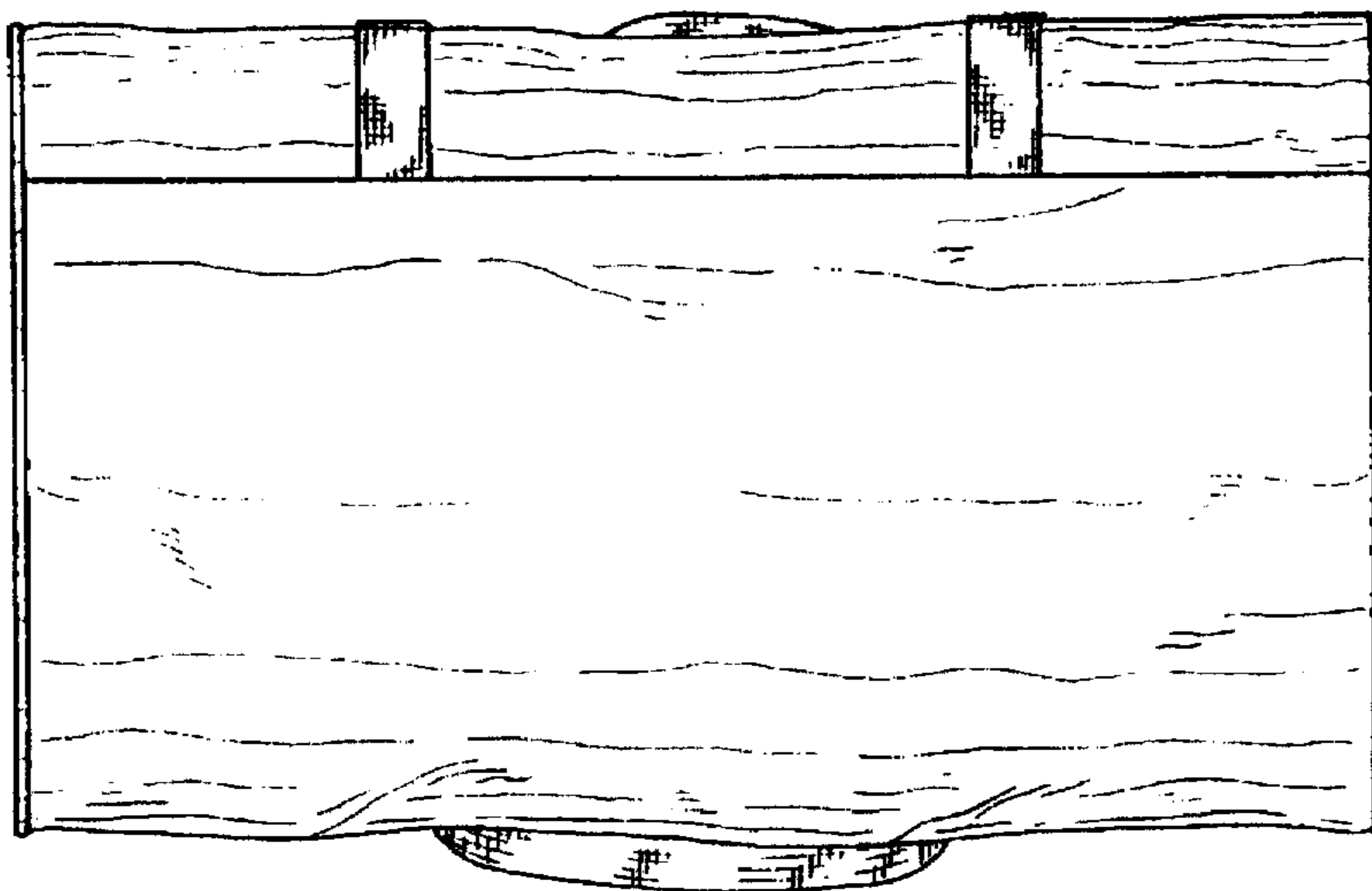

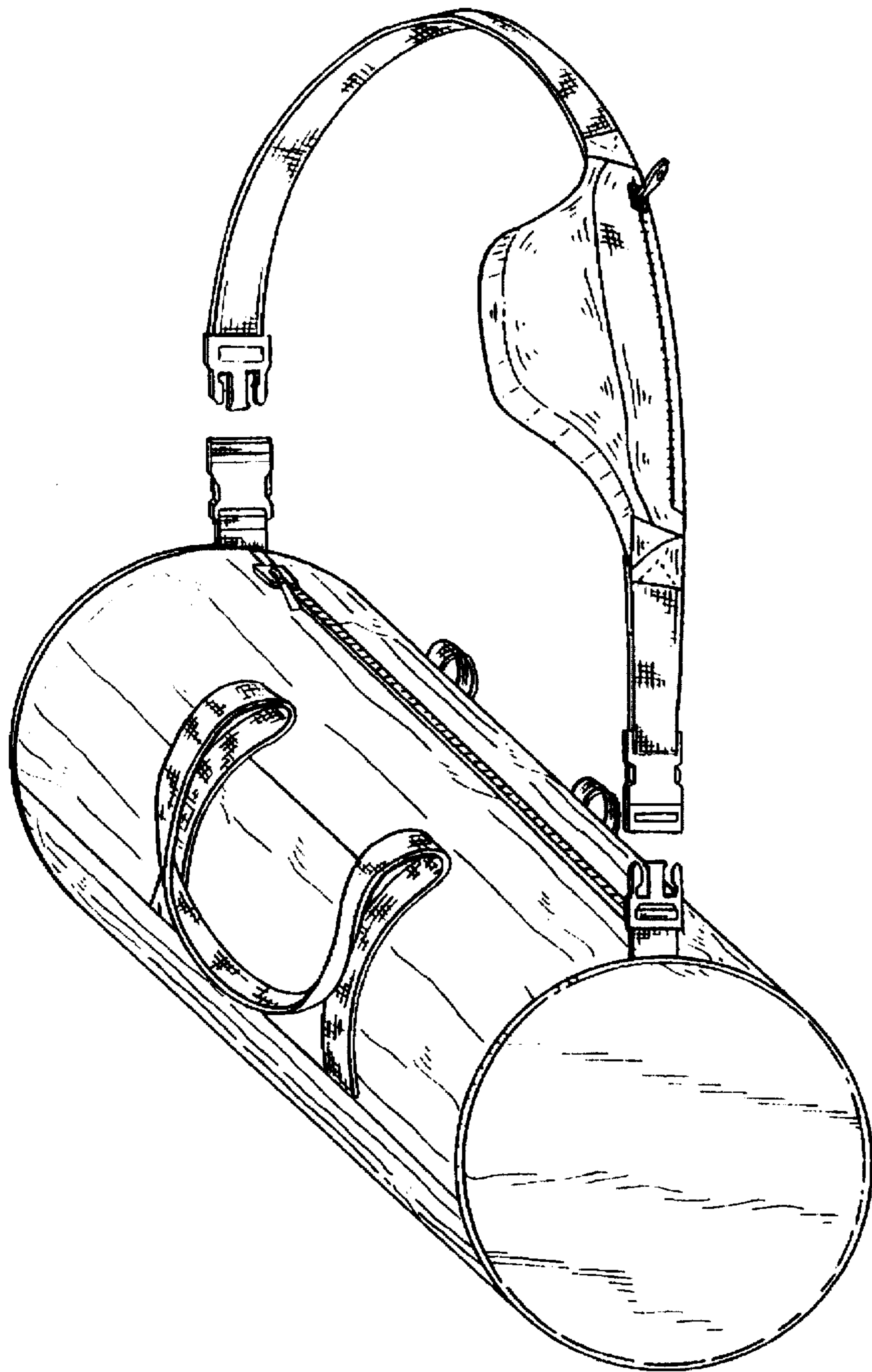
