The ornamental design for pliers, as shown and described.

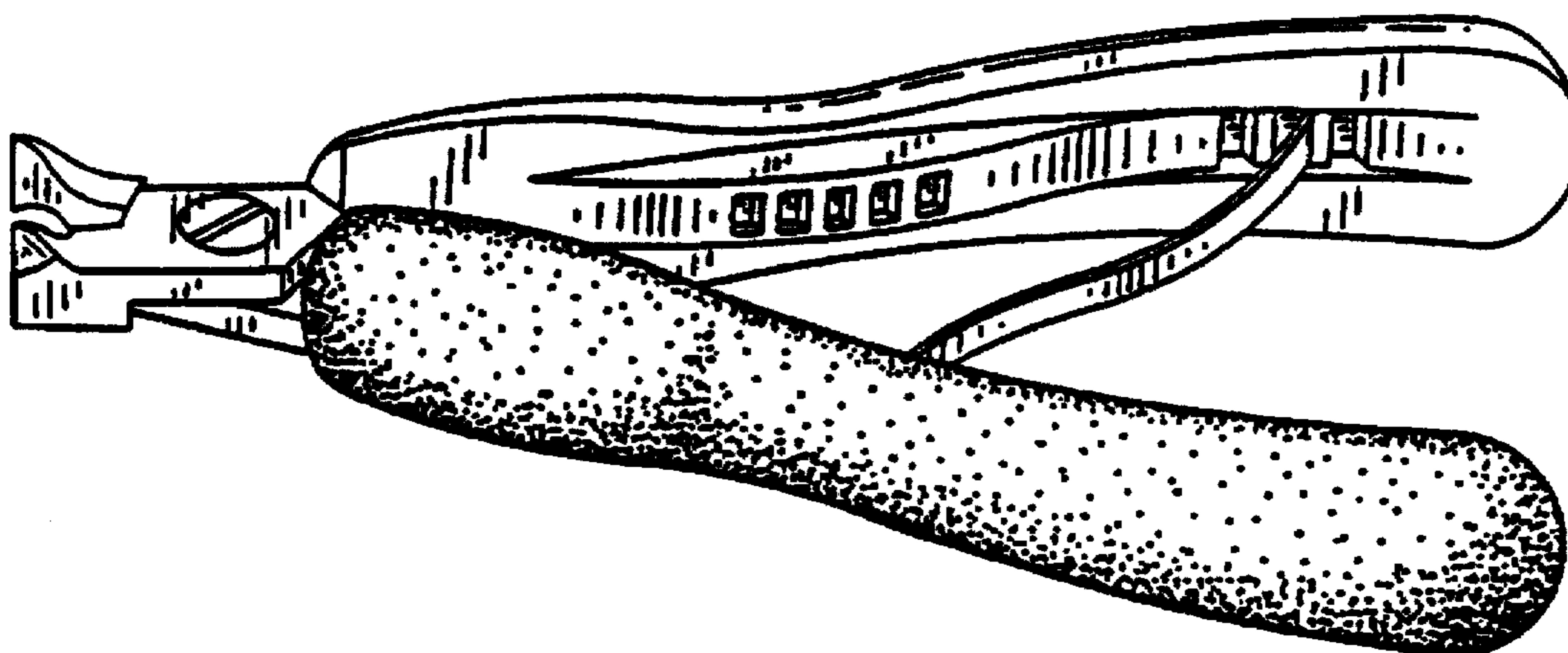
#### DESCRIPTION

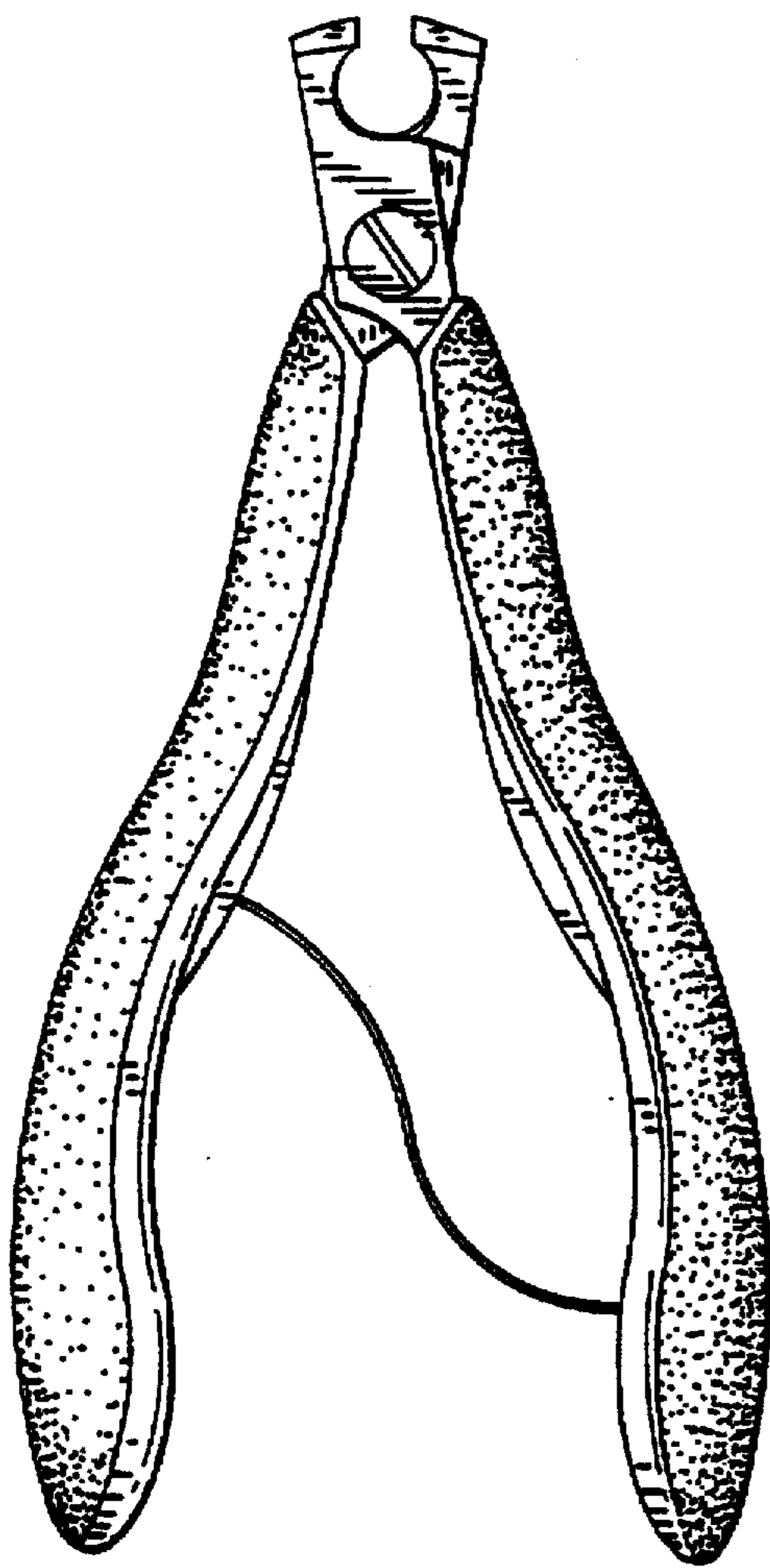

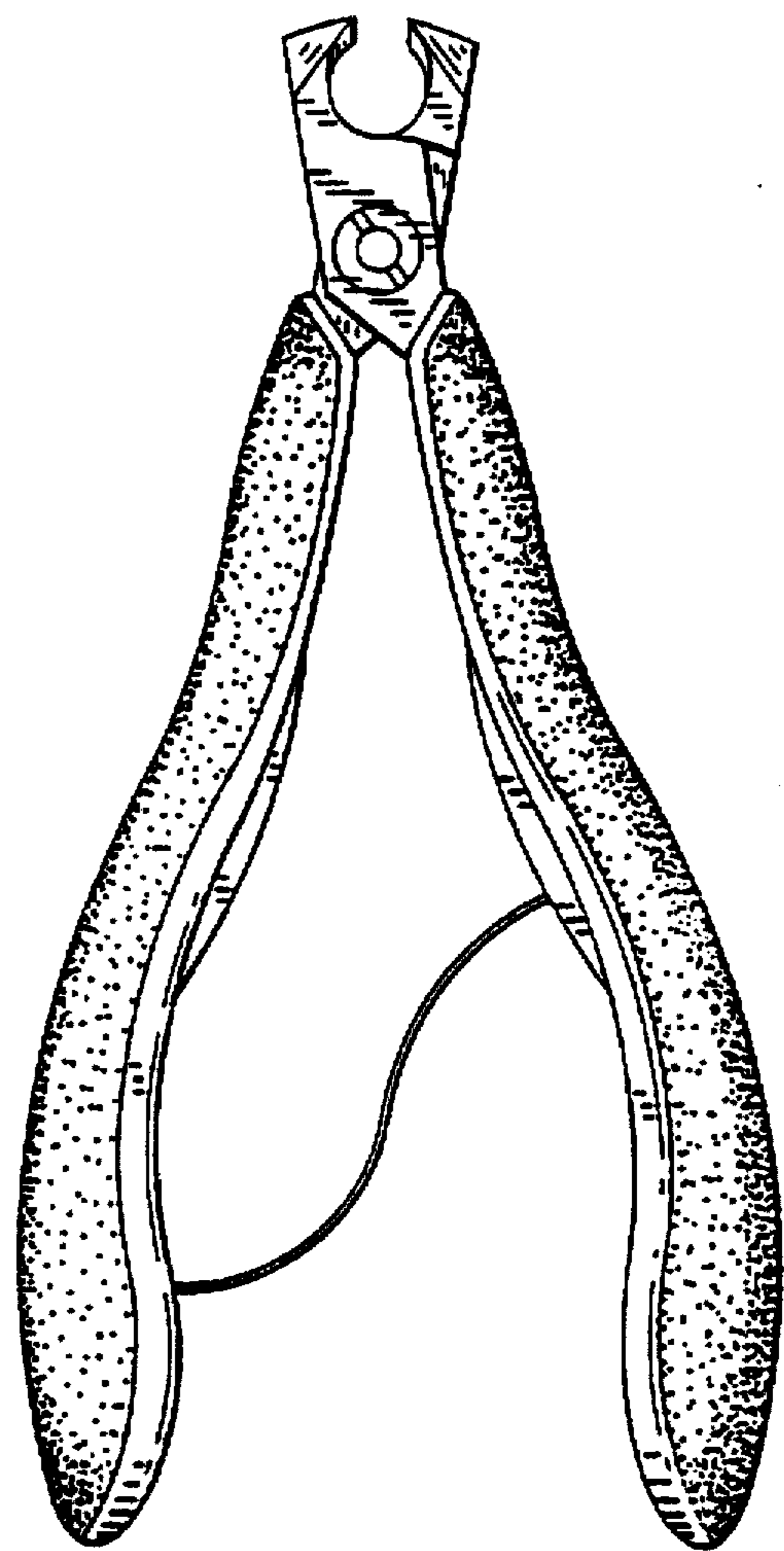

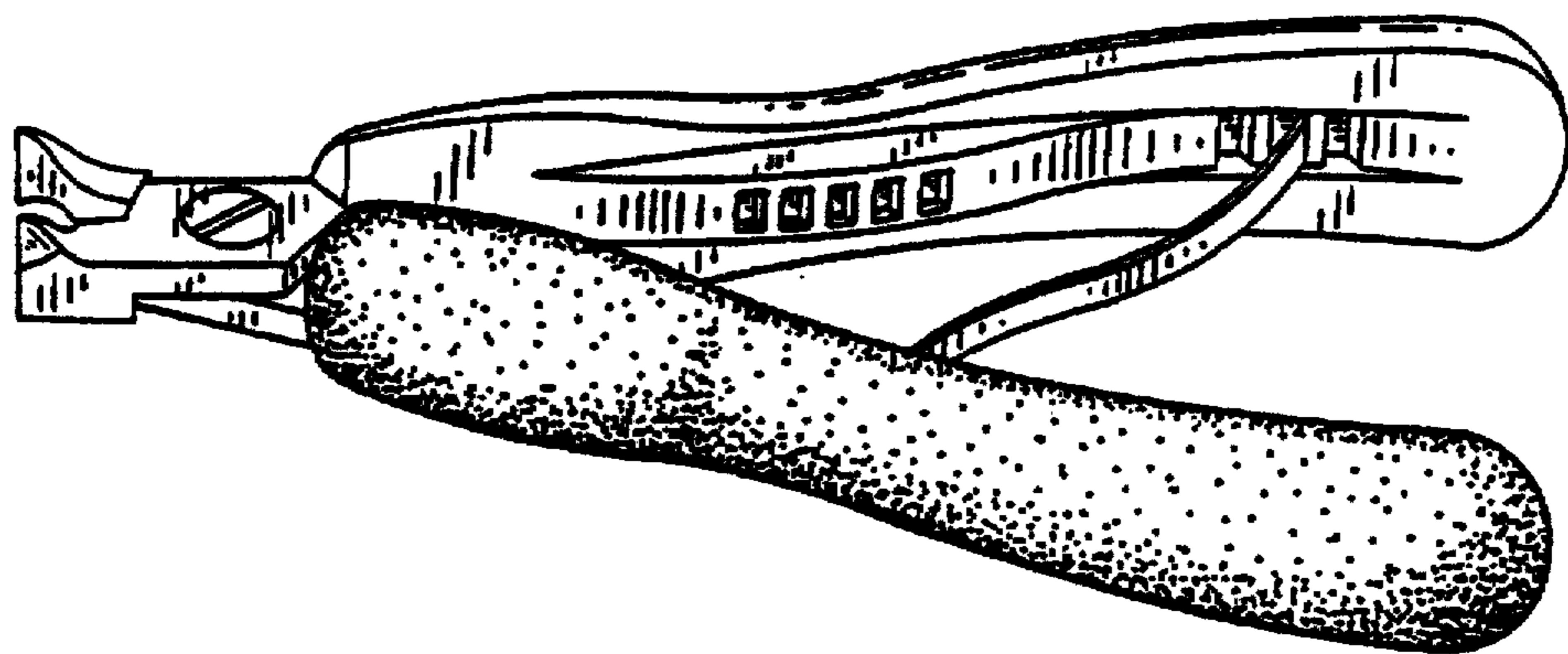
