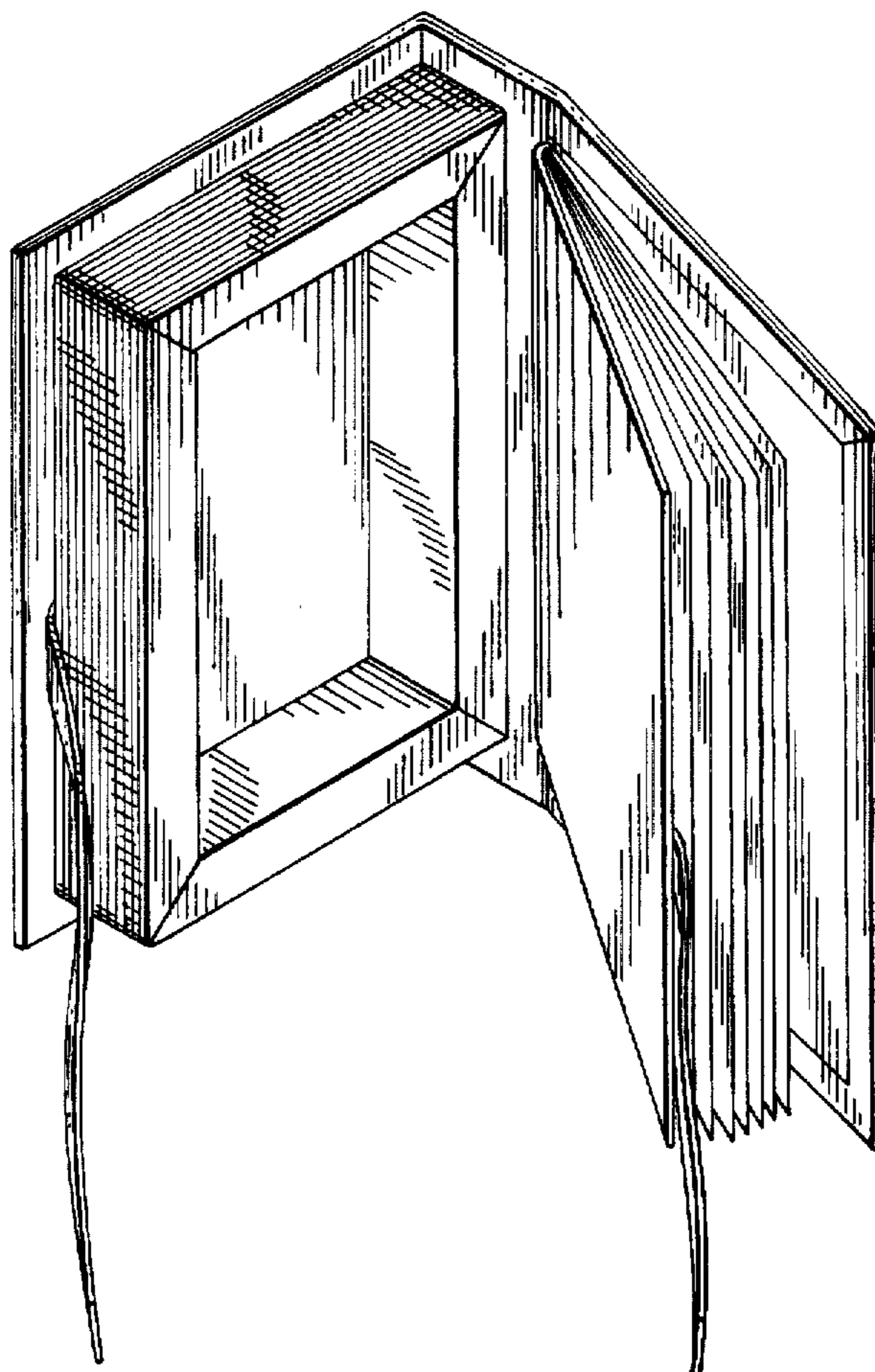

The ornamental design for a box book, as shown and described

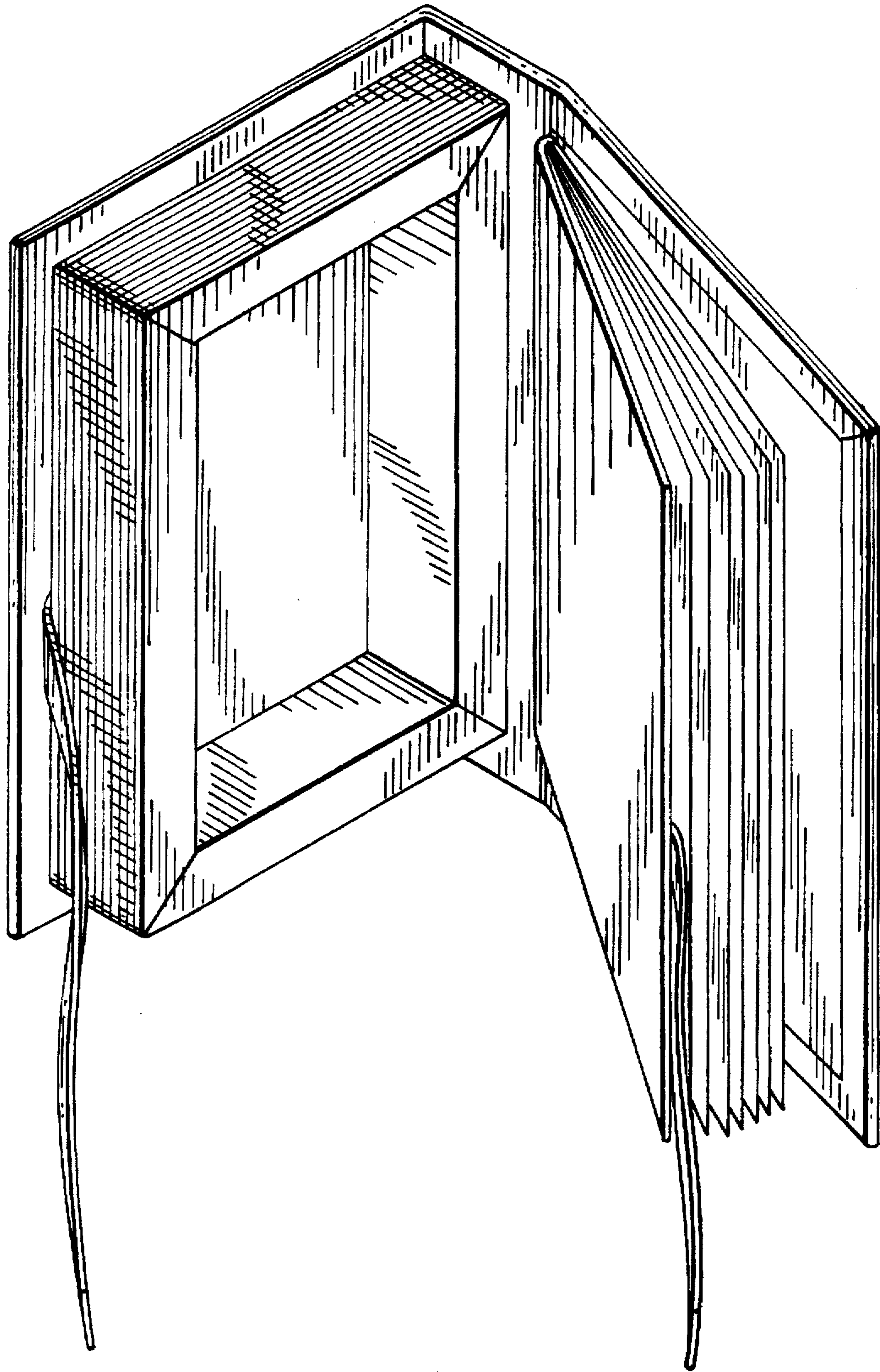
**DESCRIPTION**

FIG. 1 is a perspective view of a box book showing my new design;  
FIG. 2 is a left side elevation view shown in a closed position;  
FIG. 3 is a top plan view thereof; the opposite side being a mirror image;

FIG. 5 is a right side elevation view thereof.

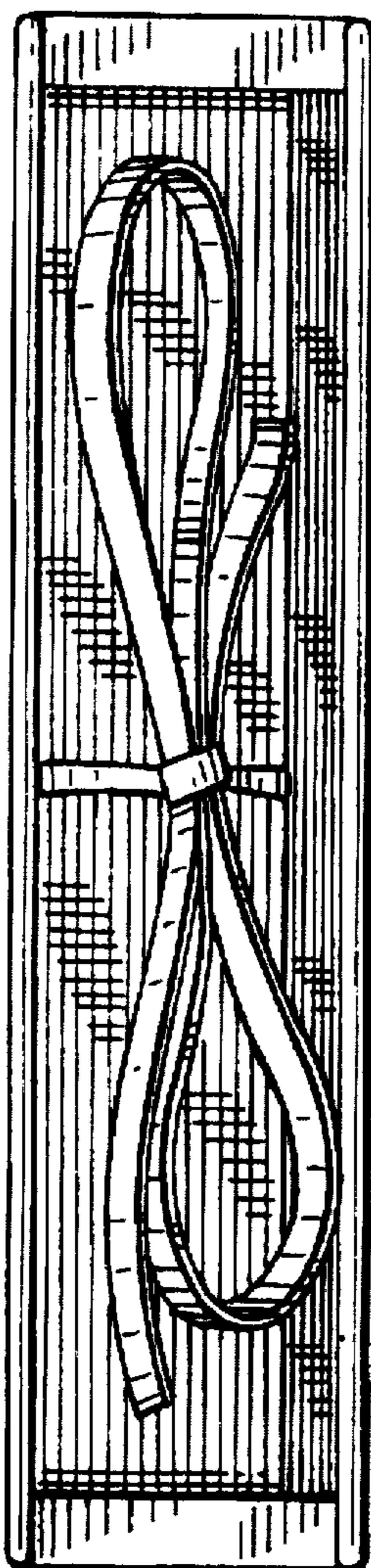

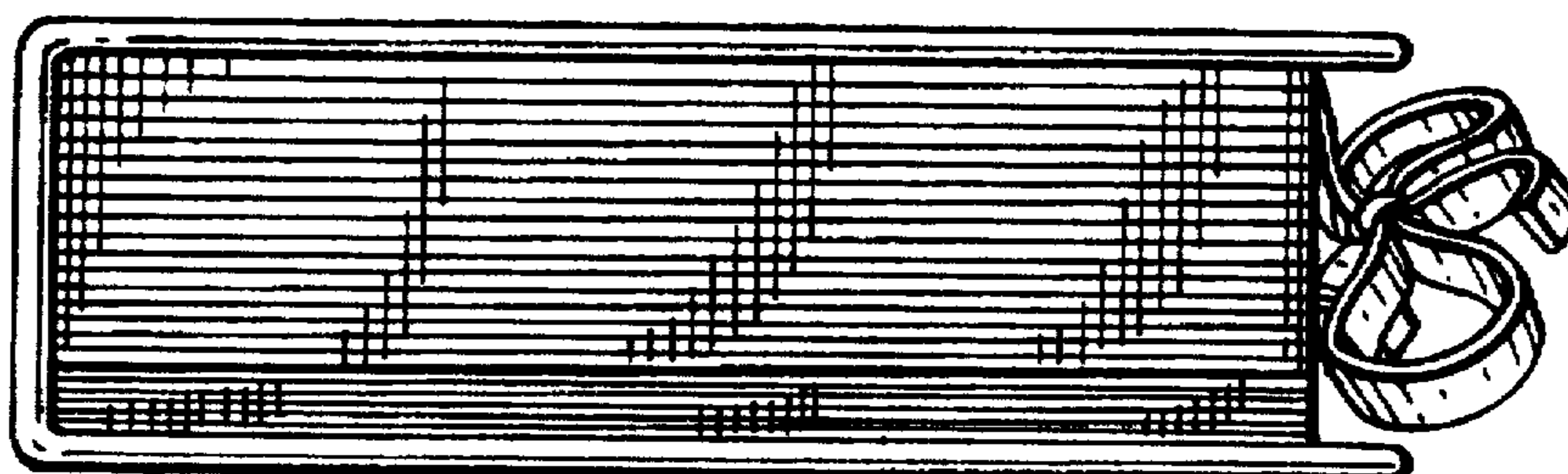

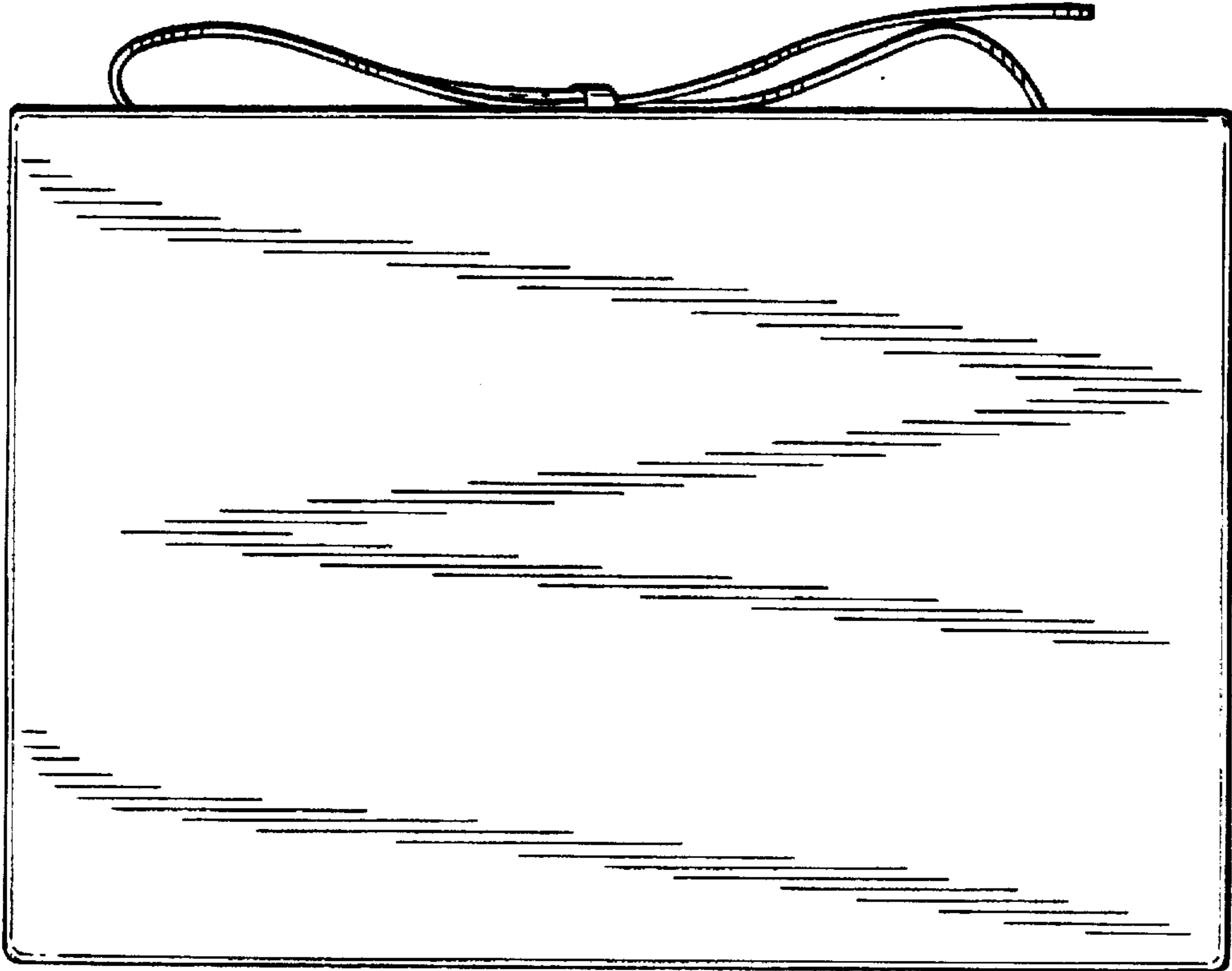
