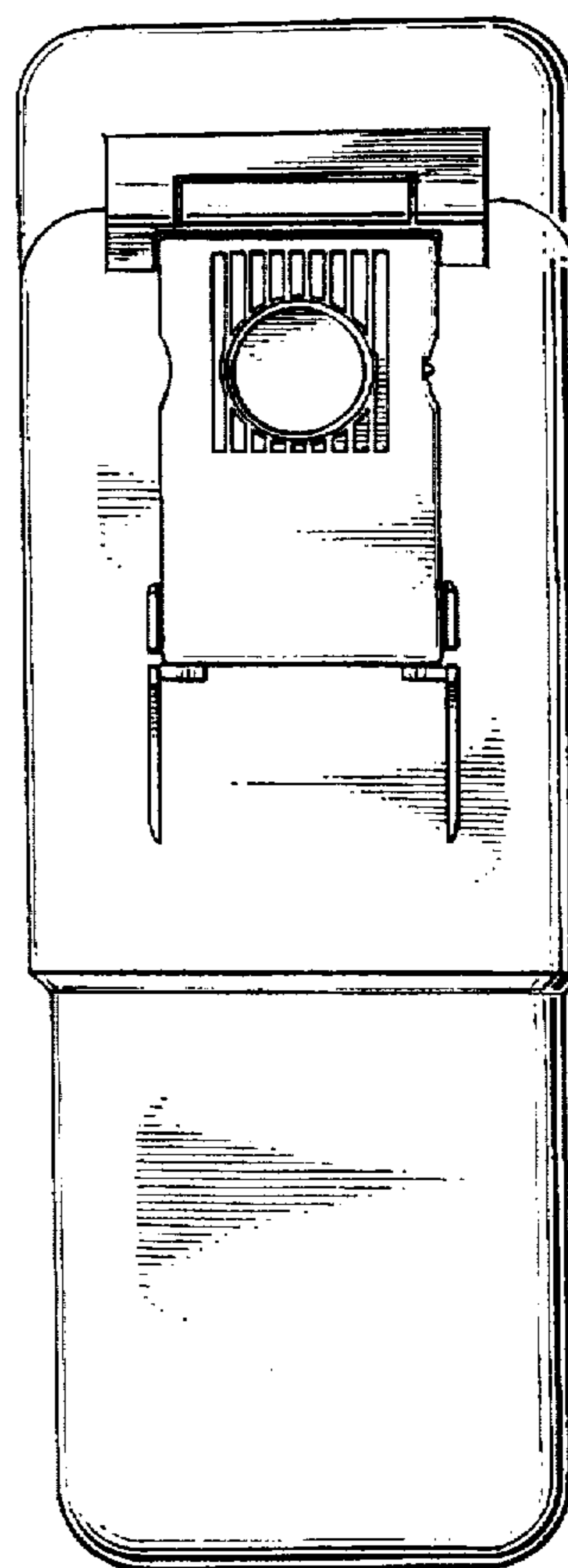
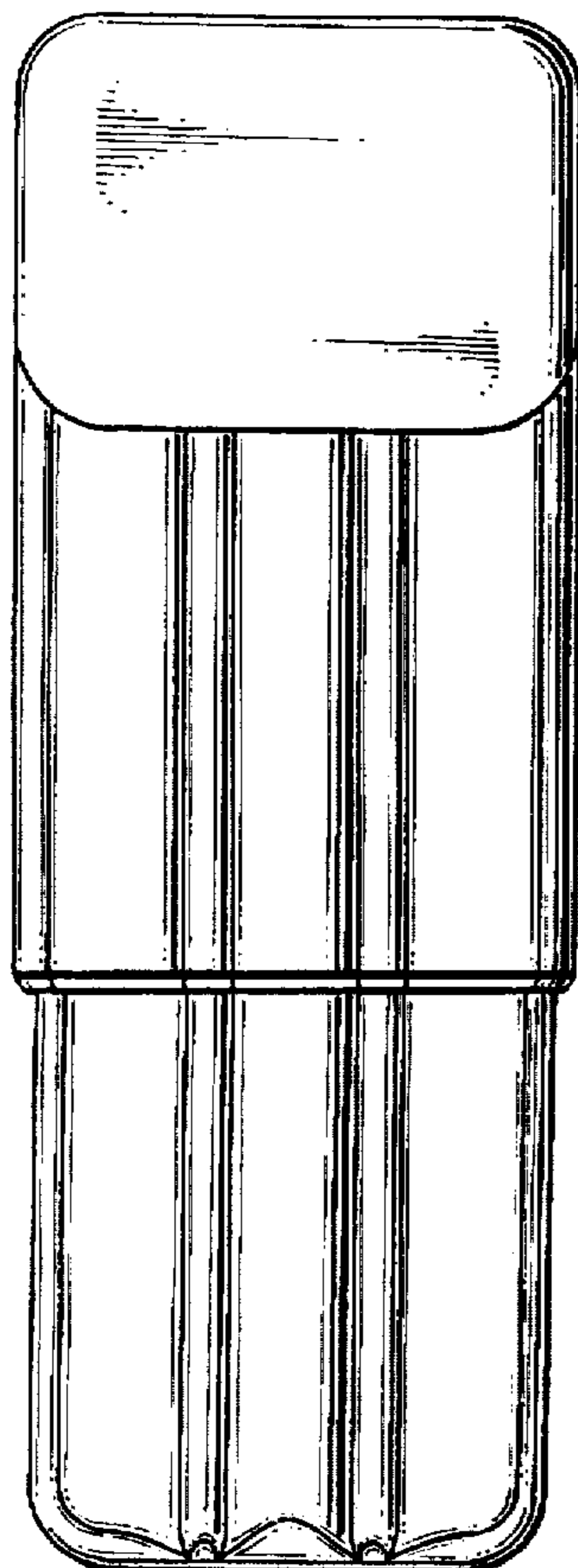
[57] CLAIM

The new ornamental design for a cigar humidor, as shown.

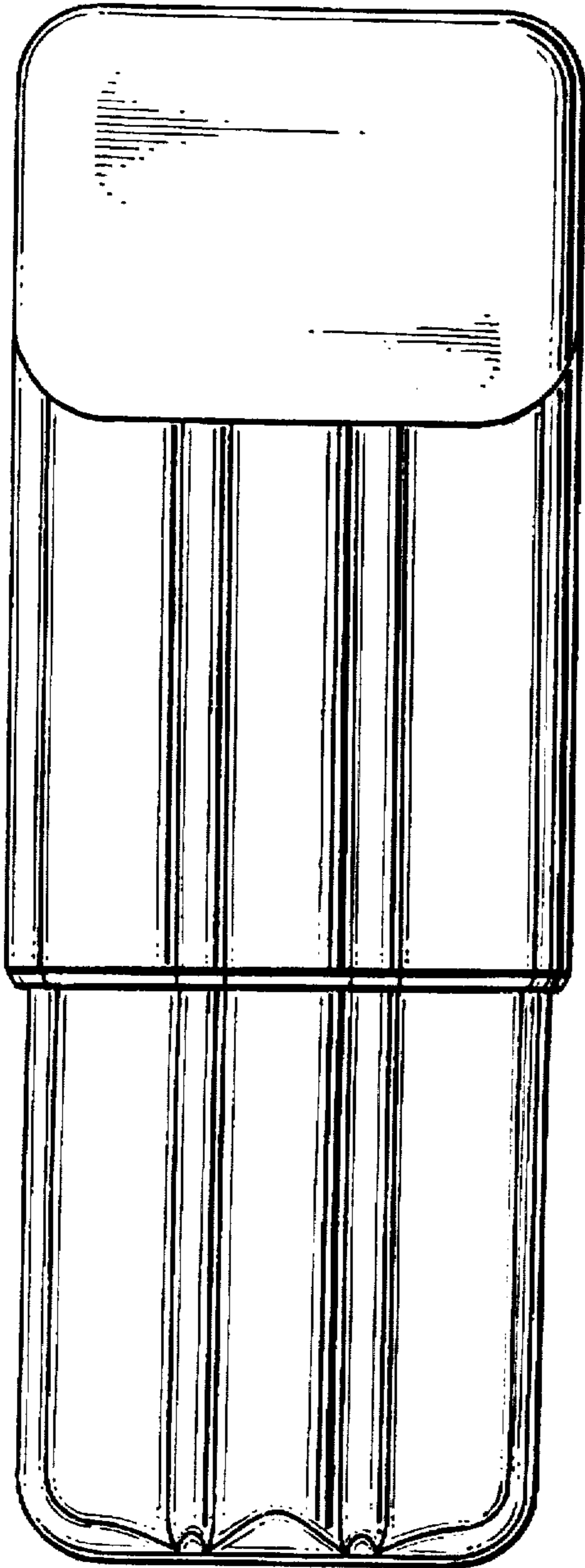
DESCRIPTION

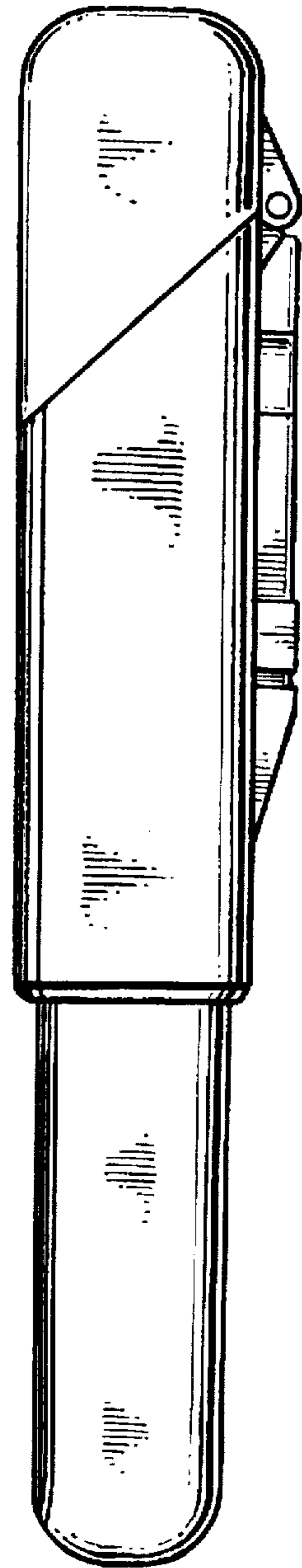

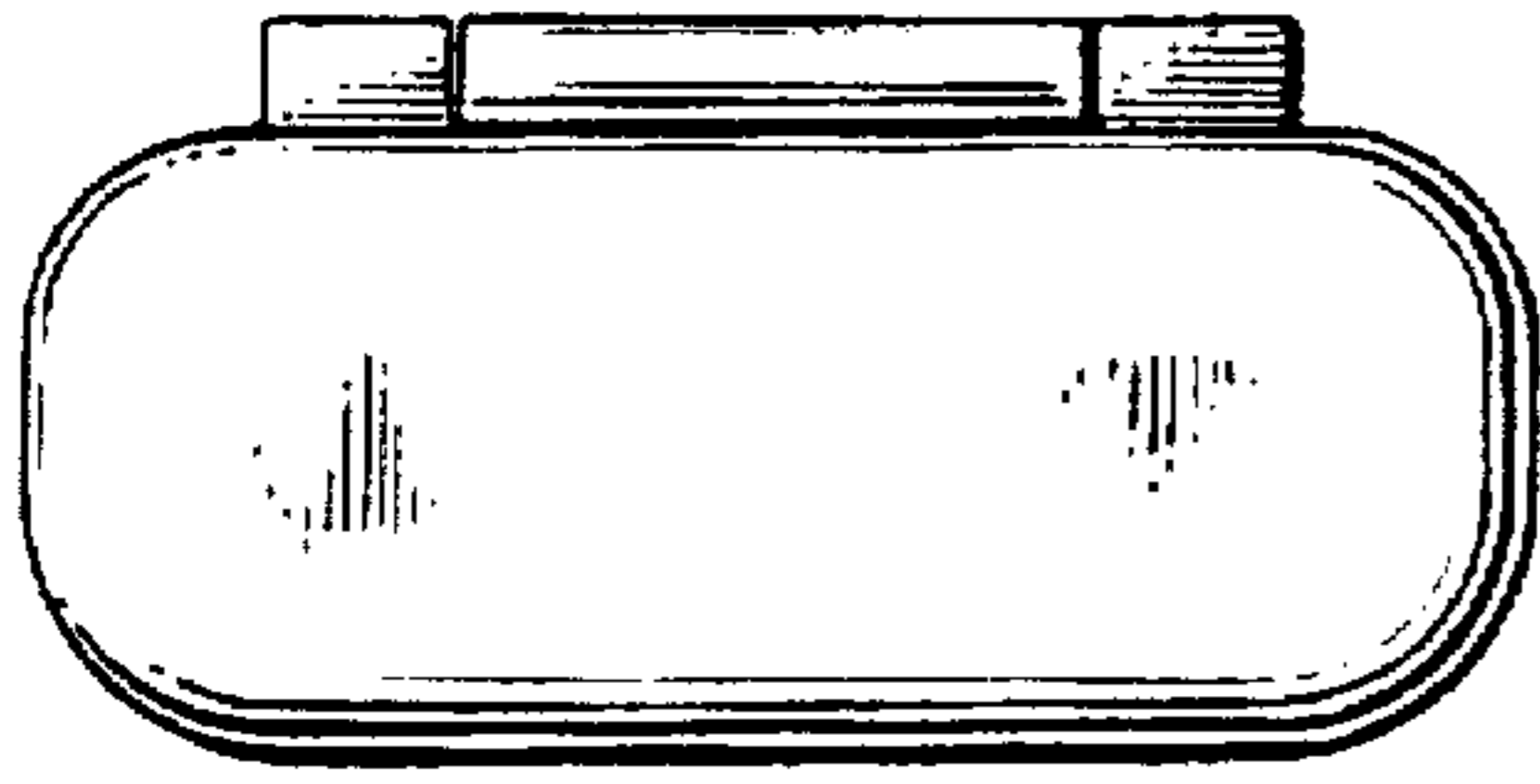

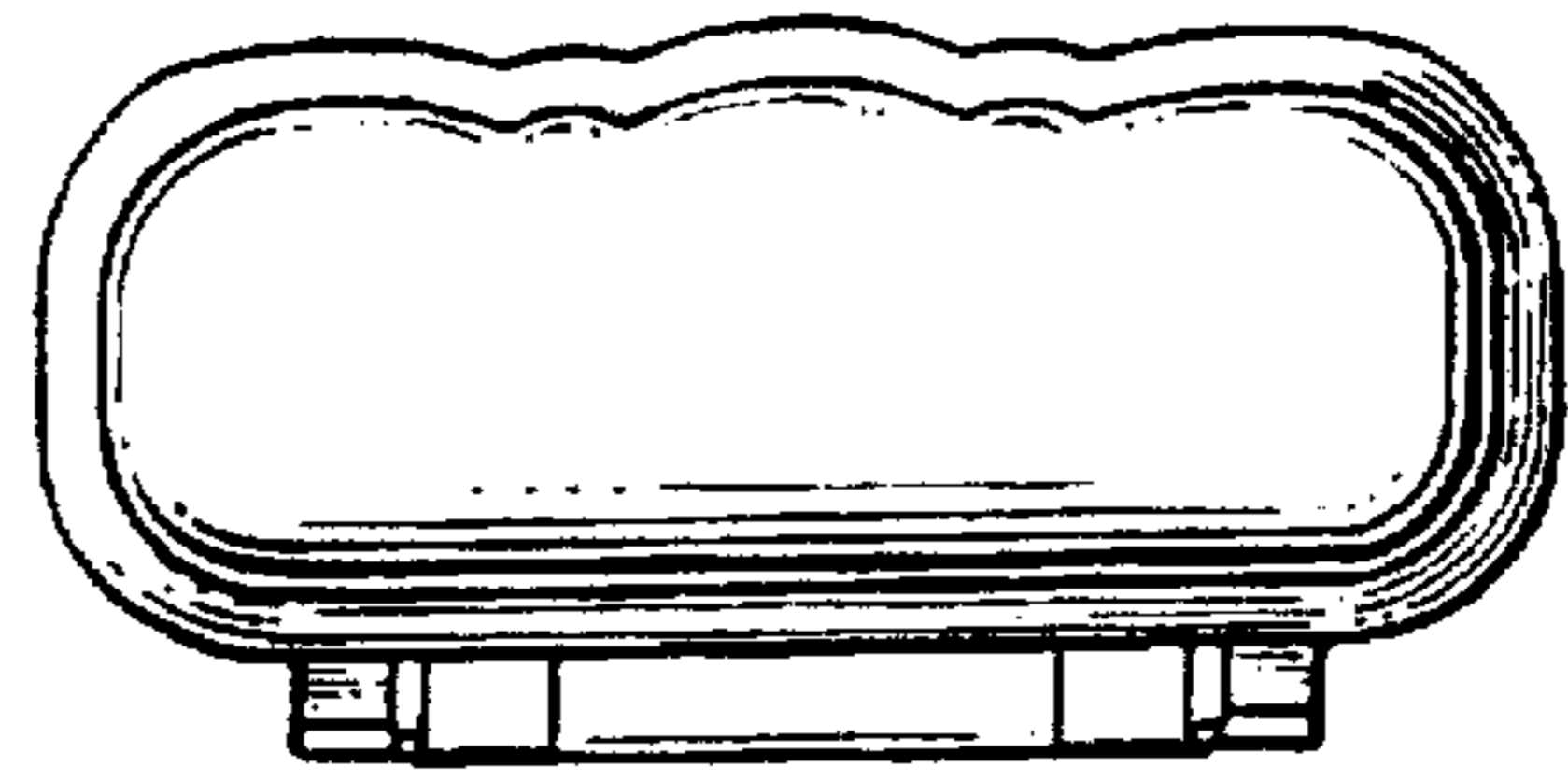

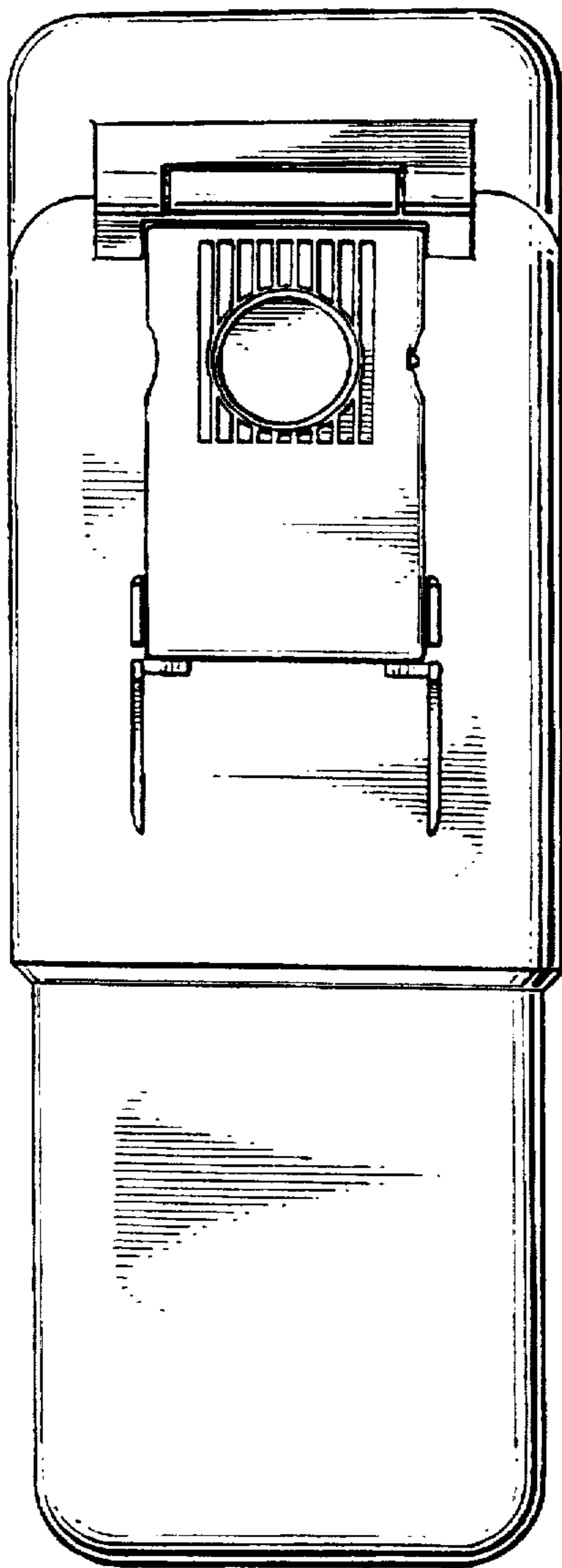
