[57] CLAIM

The ornamental design for a bed for pets, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bed for pets embodying my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image of the left side;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a perspective view thereof, showing the bed zipped up;
 FIG. 8 is a top plan view thereof, showing the bed zipped up; and
 FIG. 9 is a perspective view of a modification of FIG. 1, the inside bottom cushion is round and the quilting is continuous throughout.

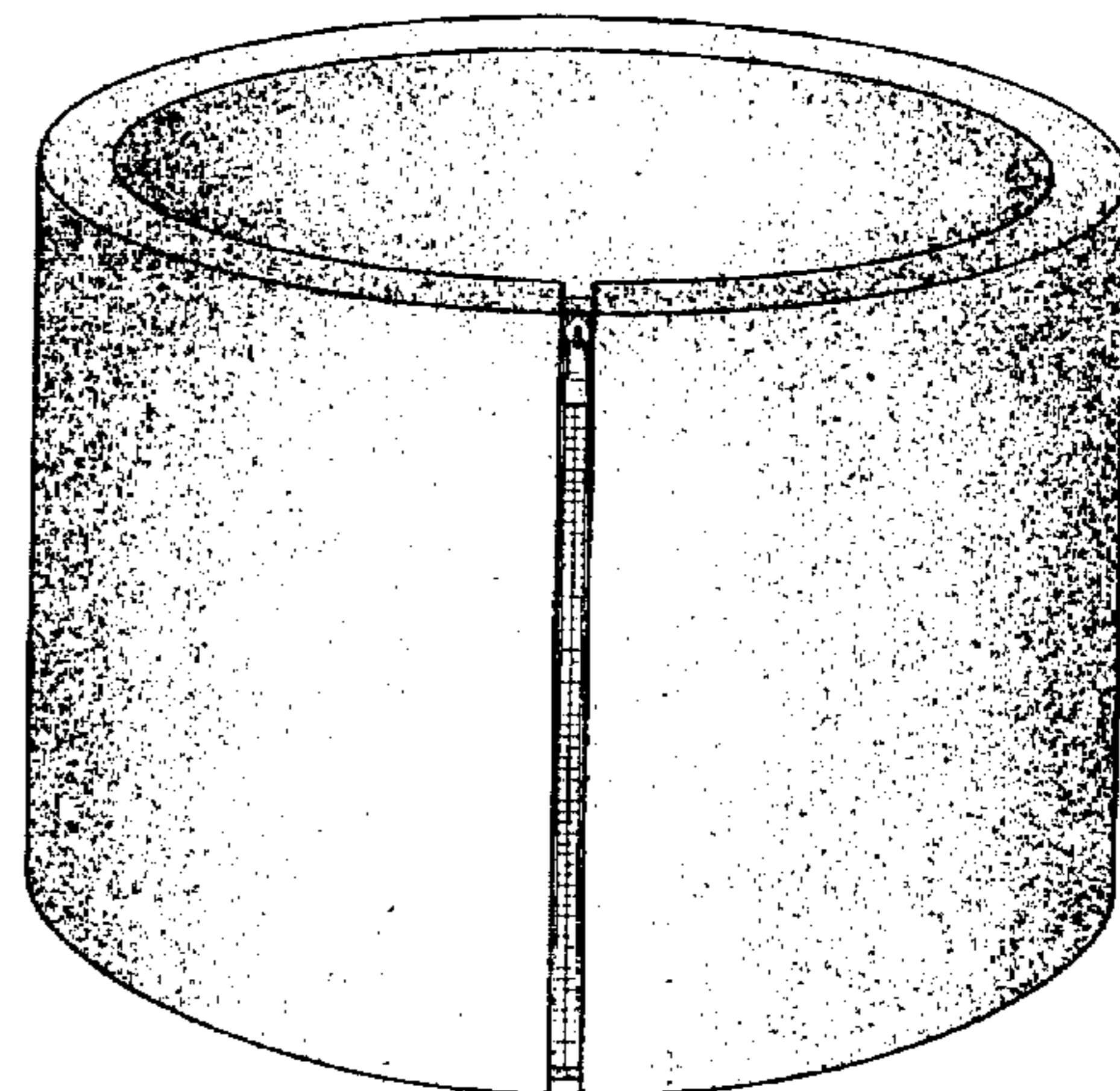
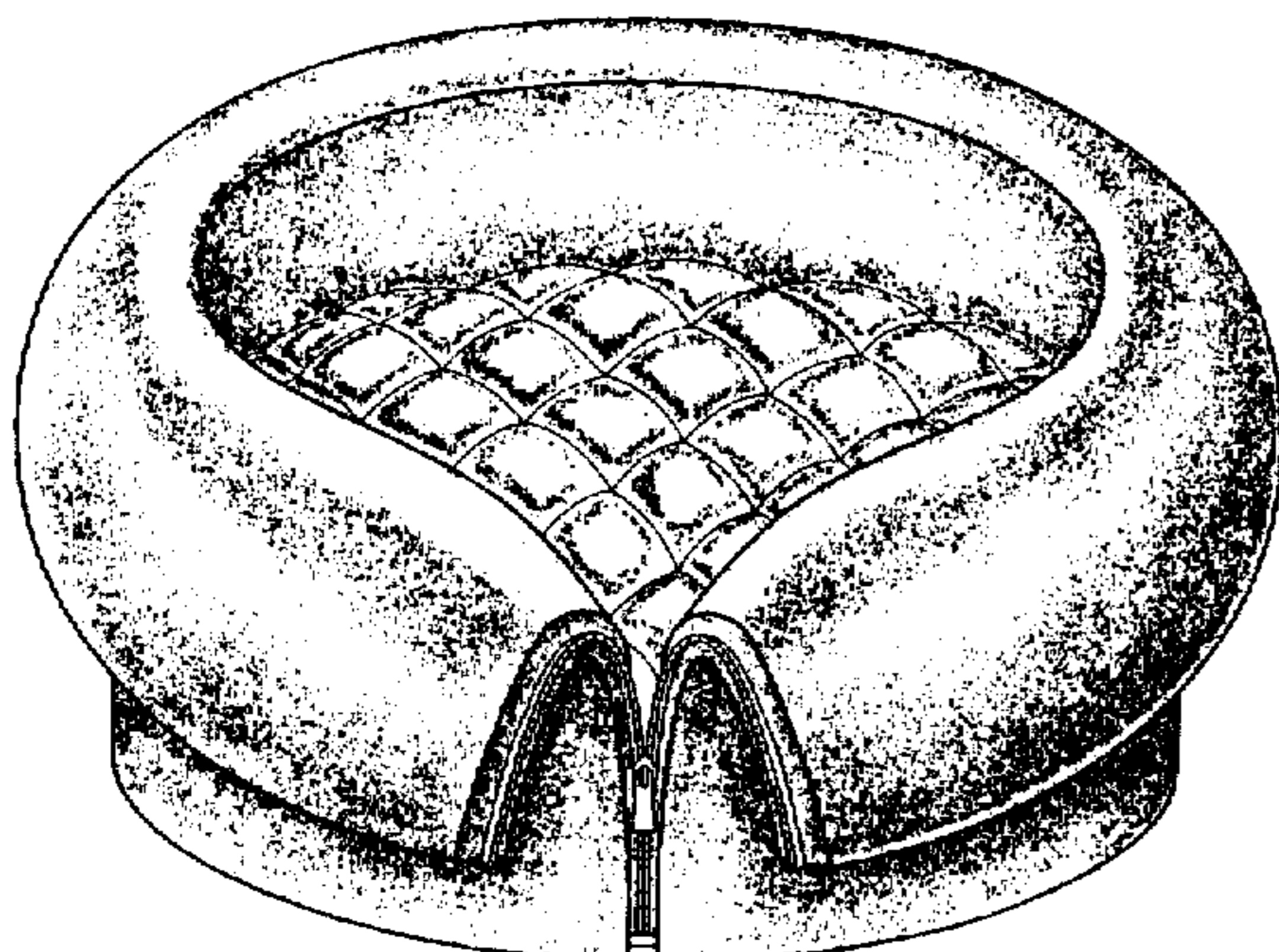
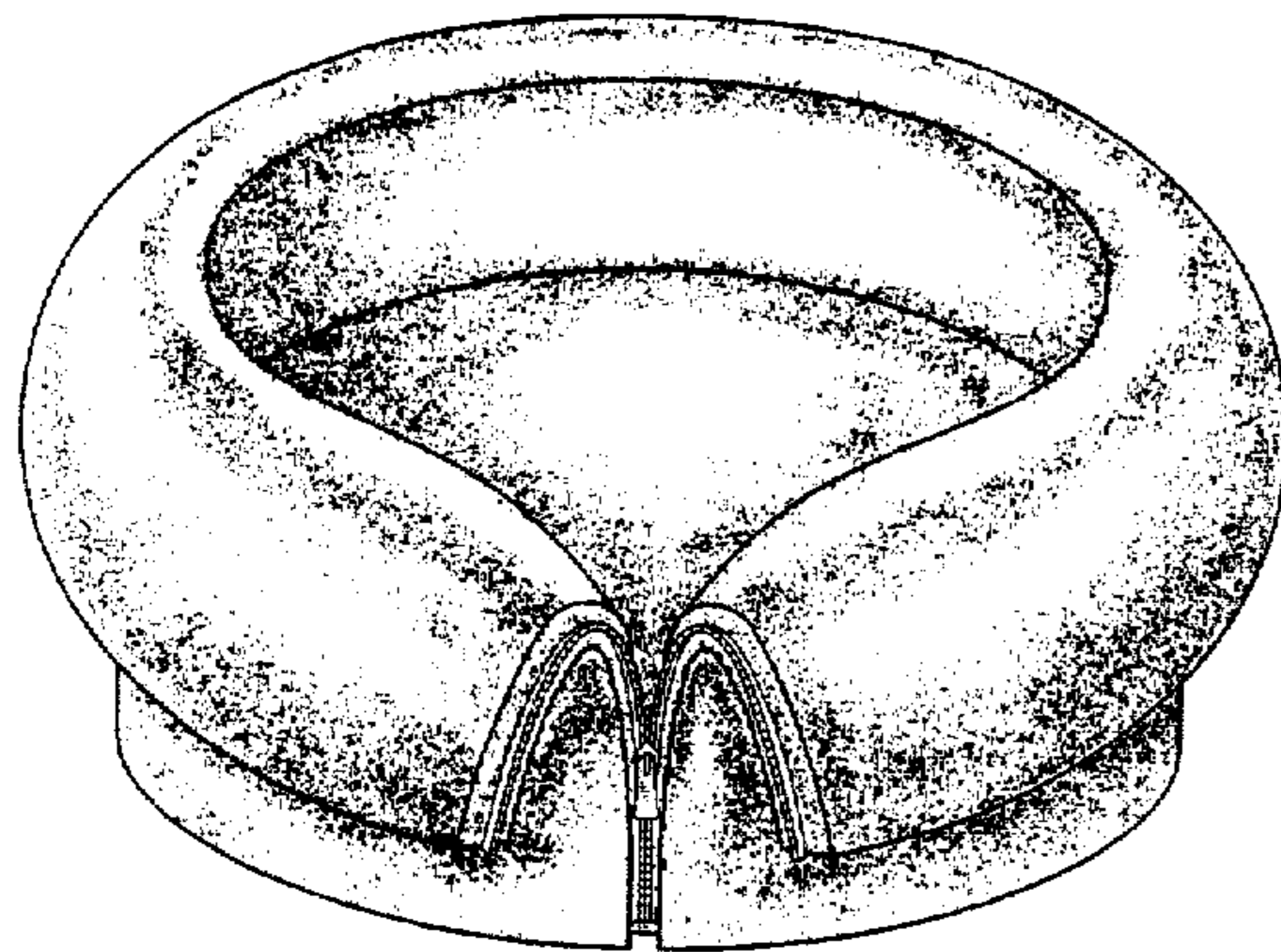

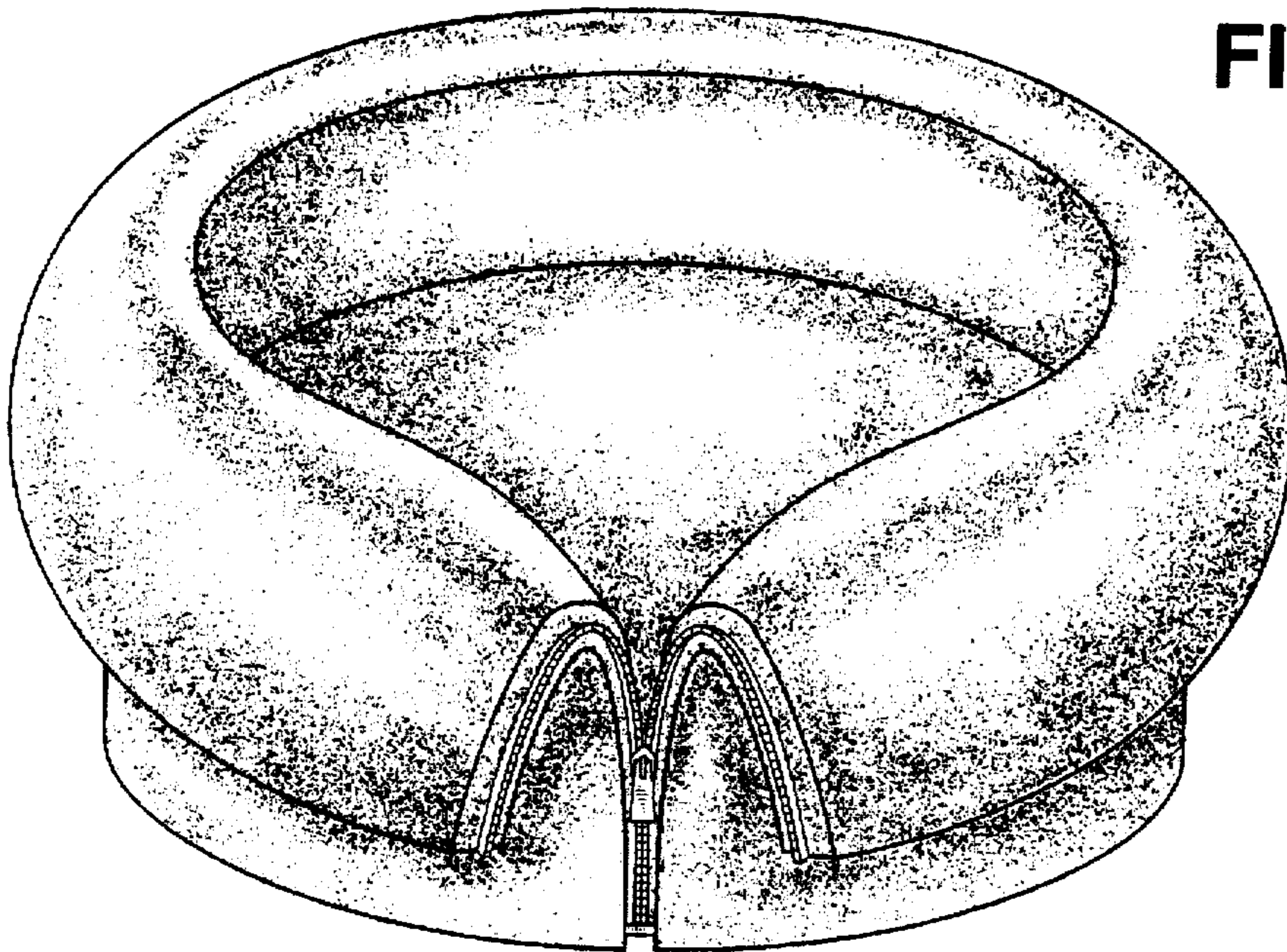
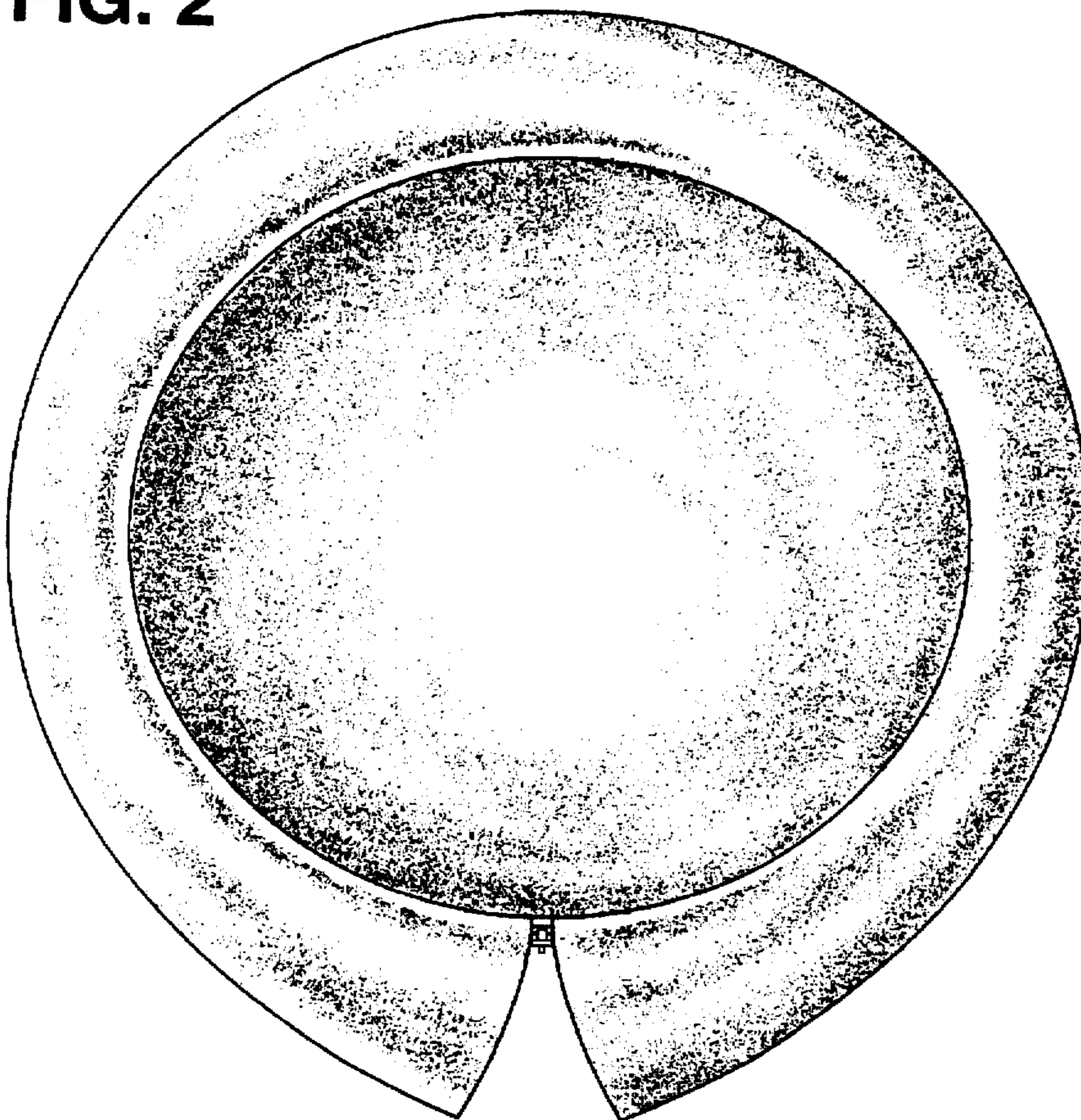

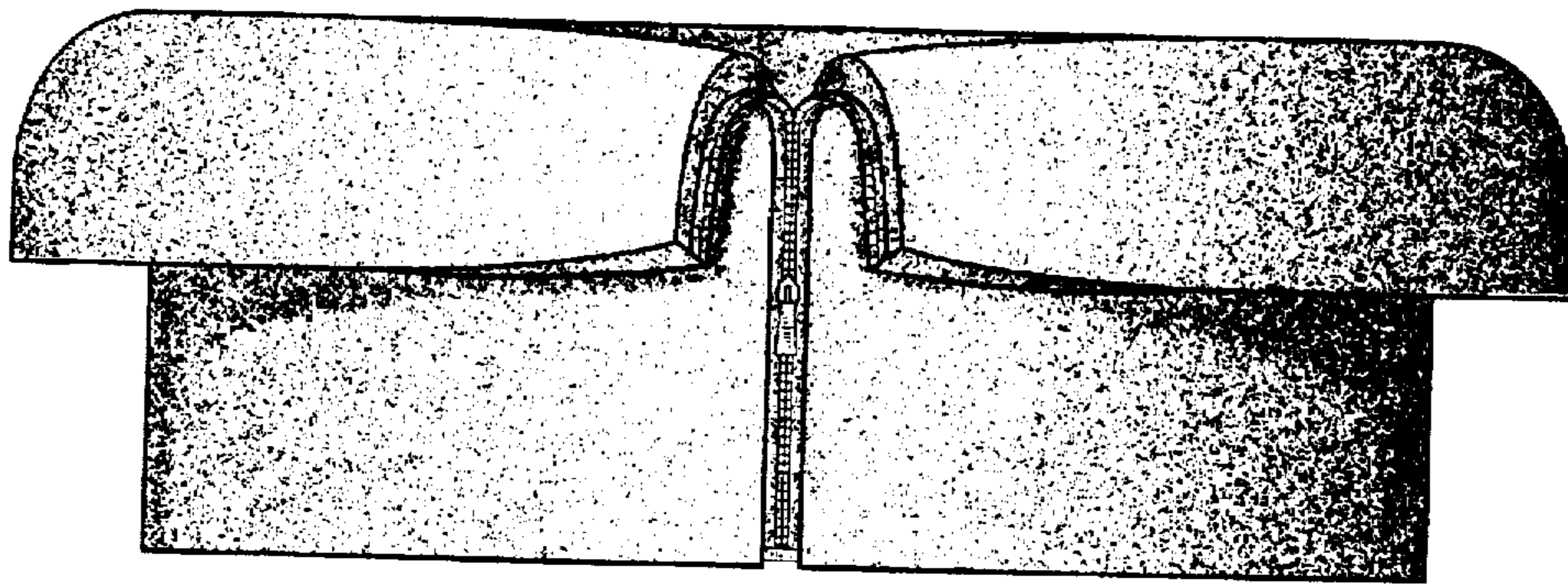

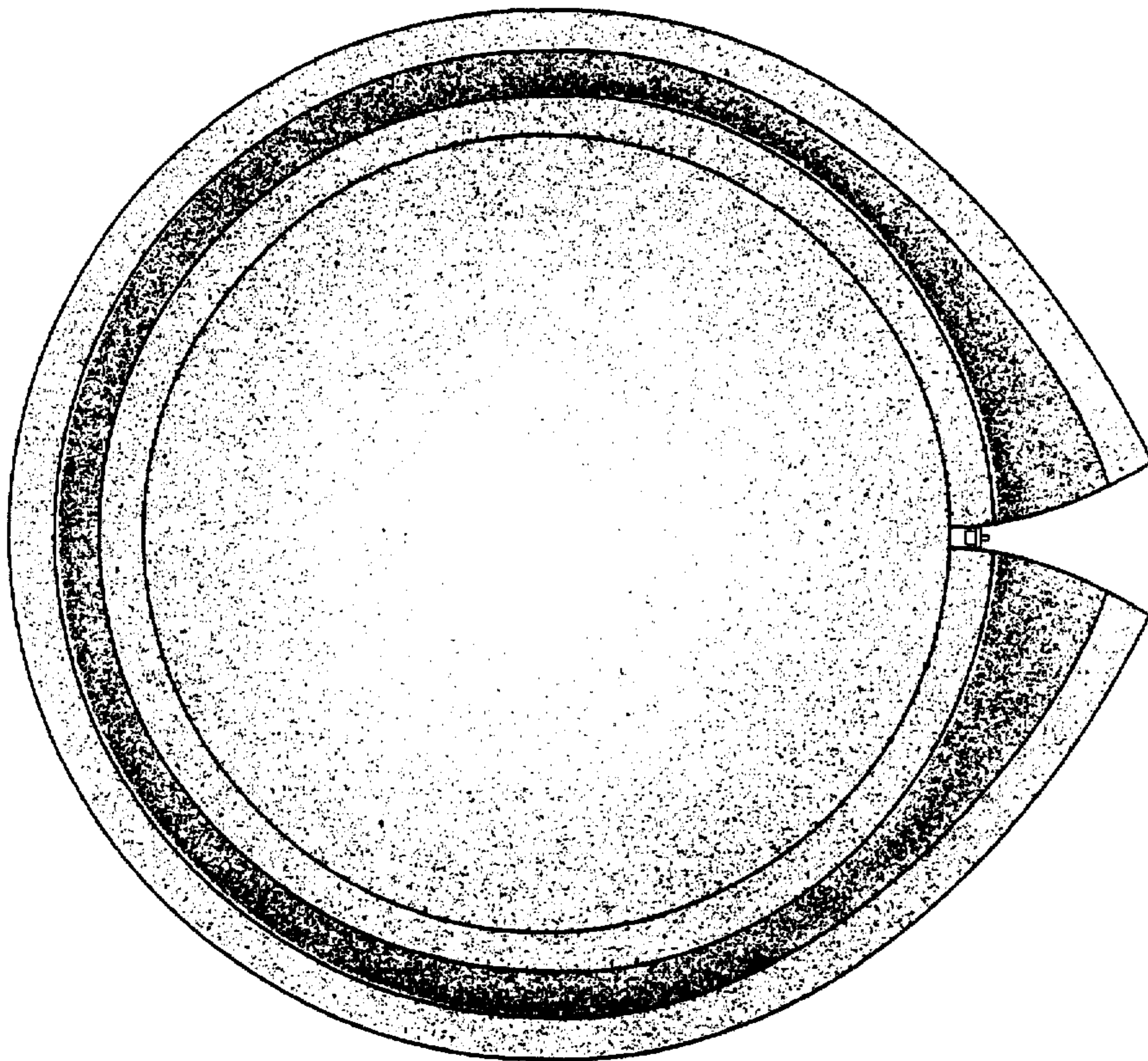

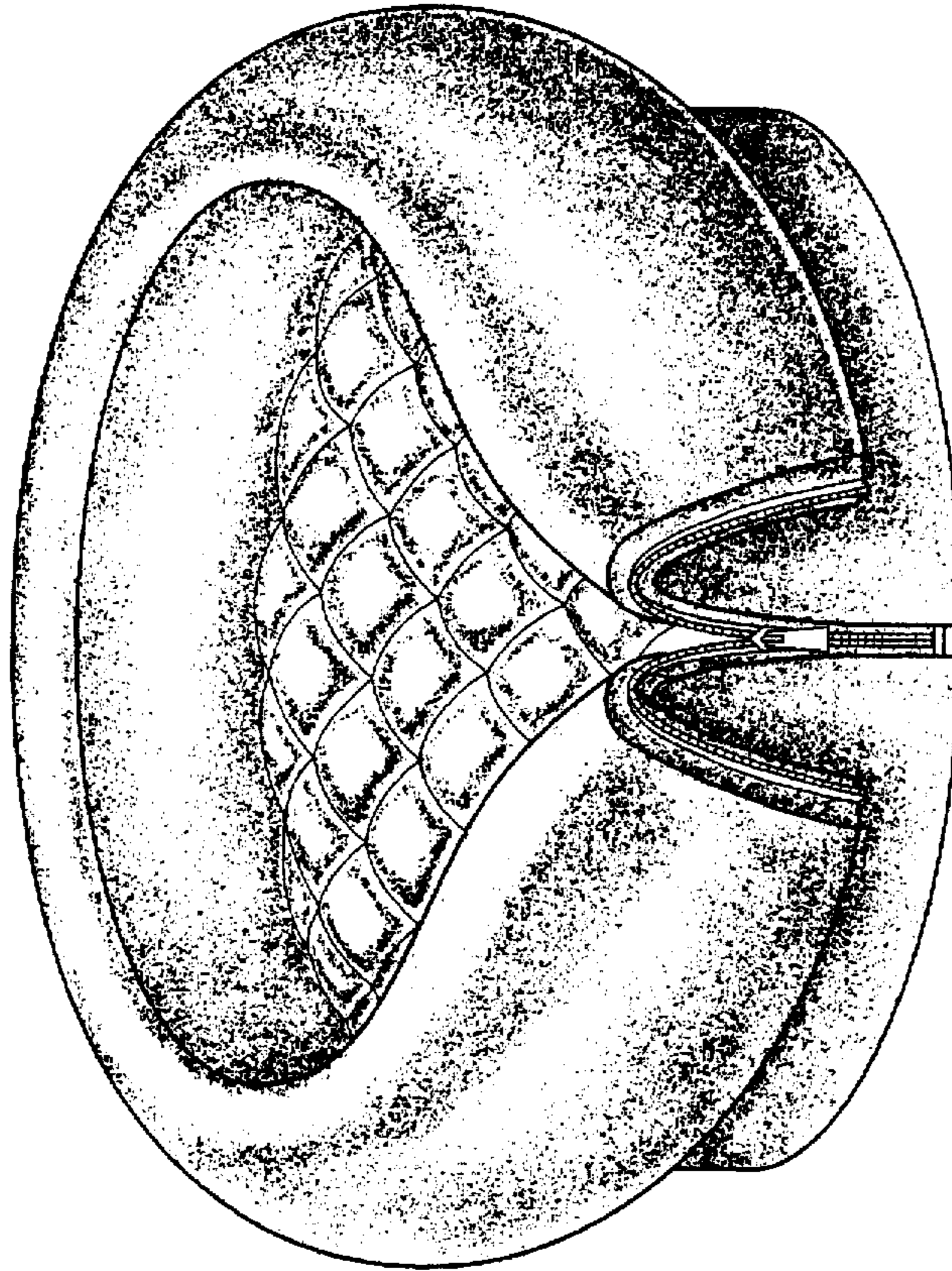

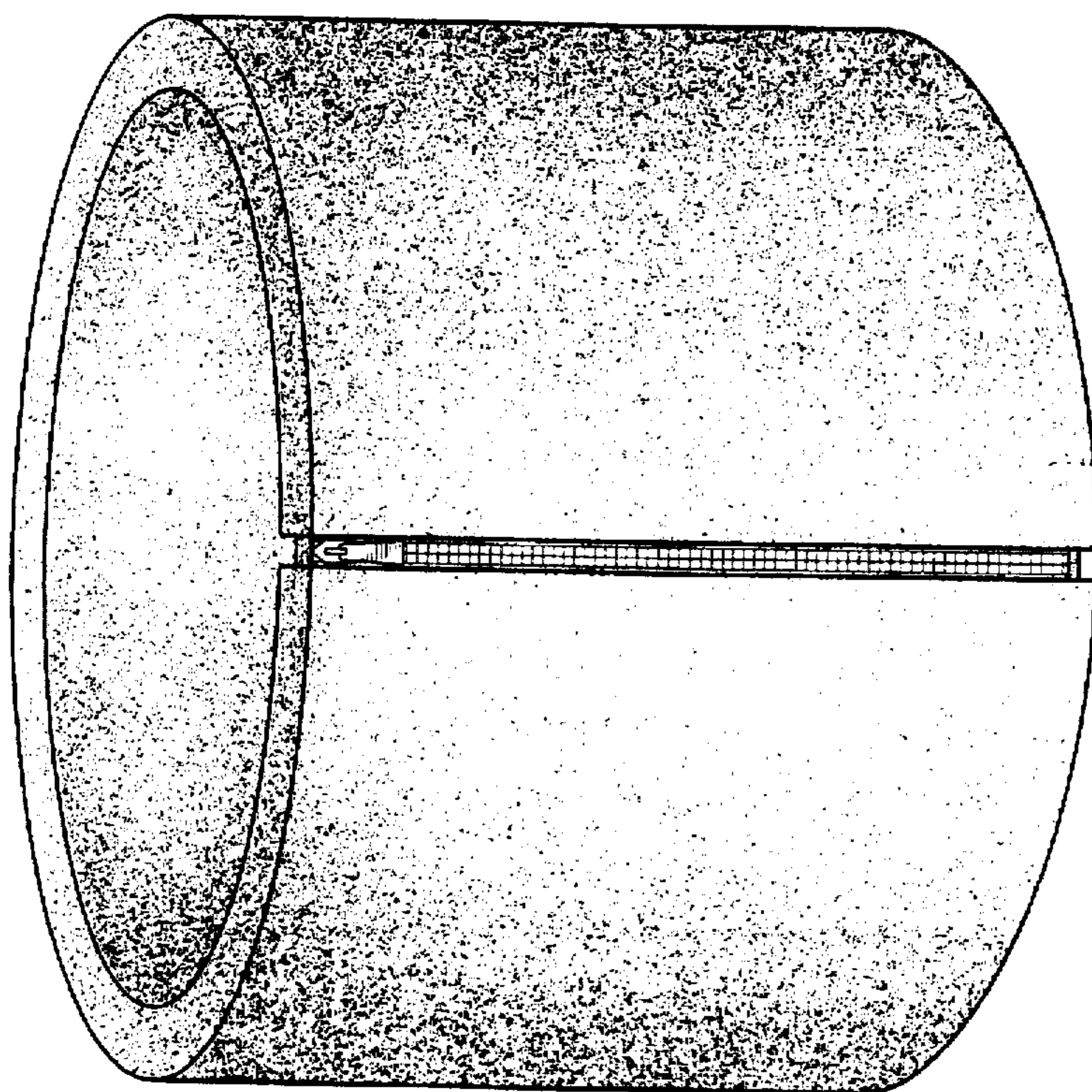

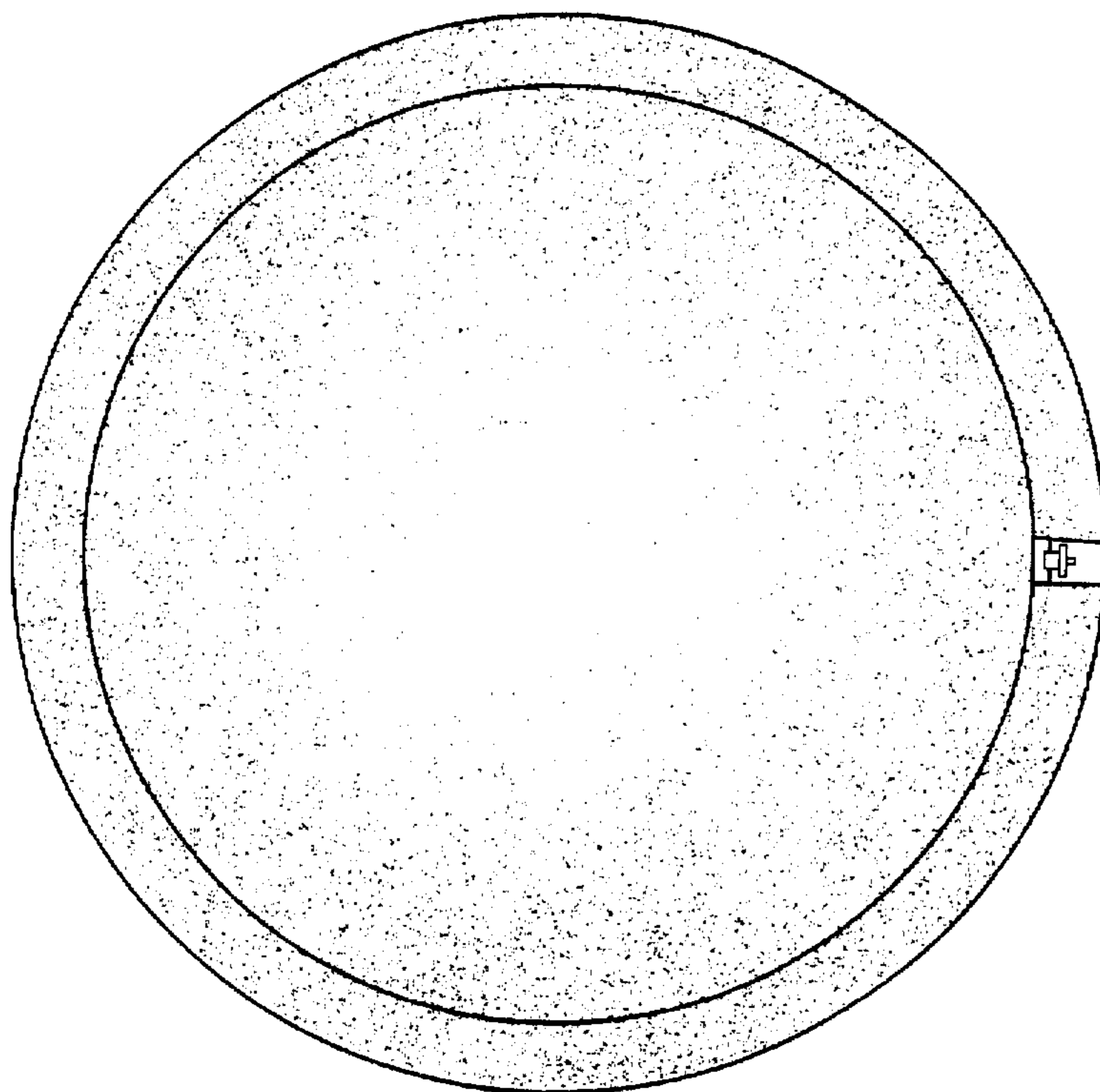
