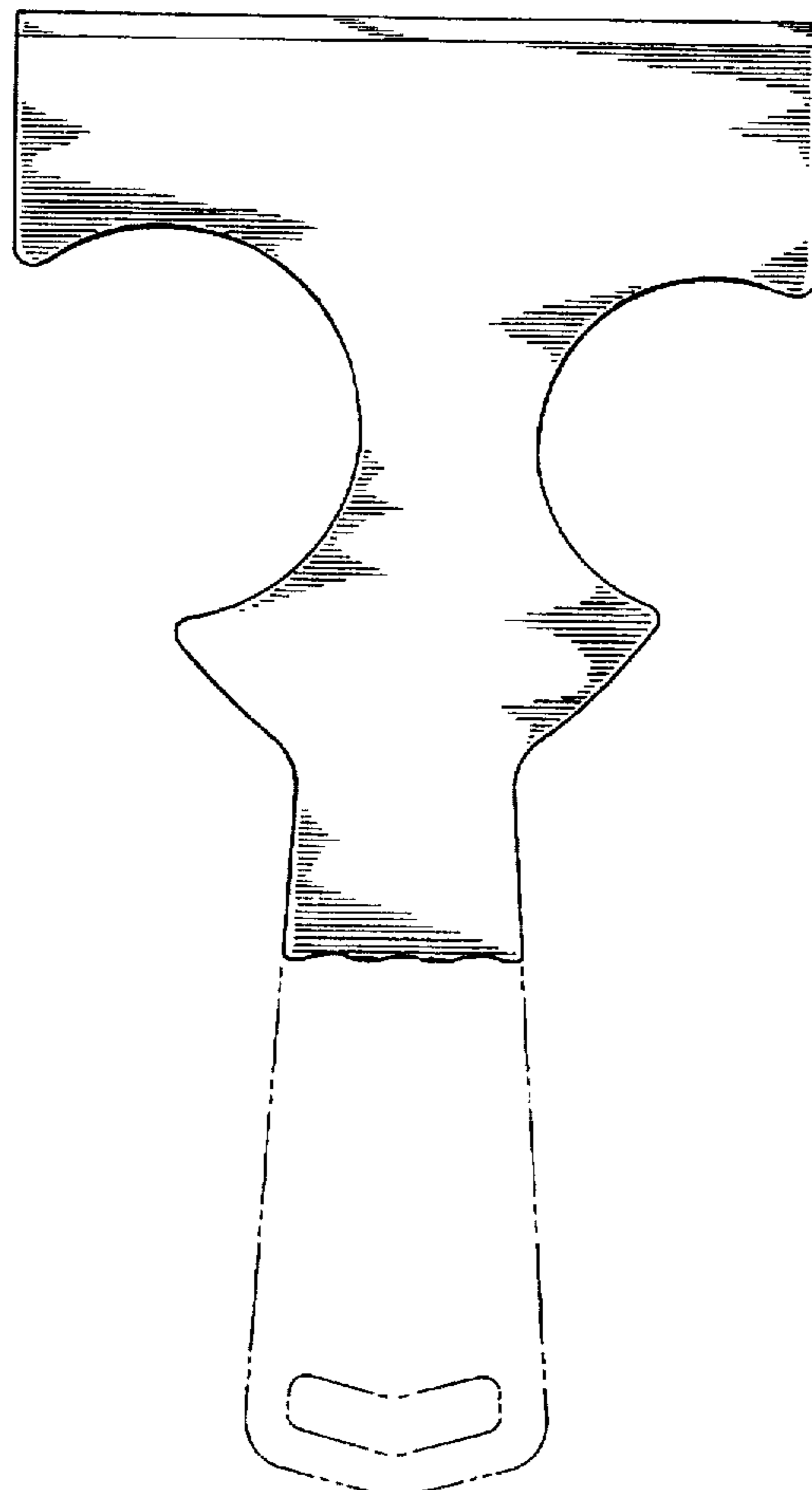
[57] **CLAIM**

The ornamental design for a paint brush and roller cleaning tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a paint brush and roller cleaning tool showing my new design;

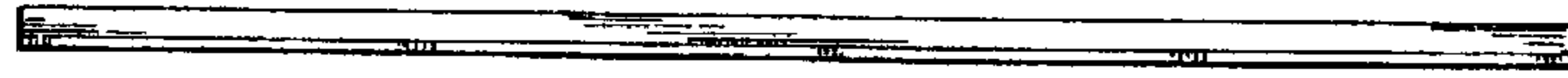

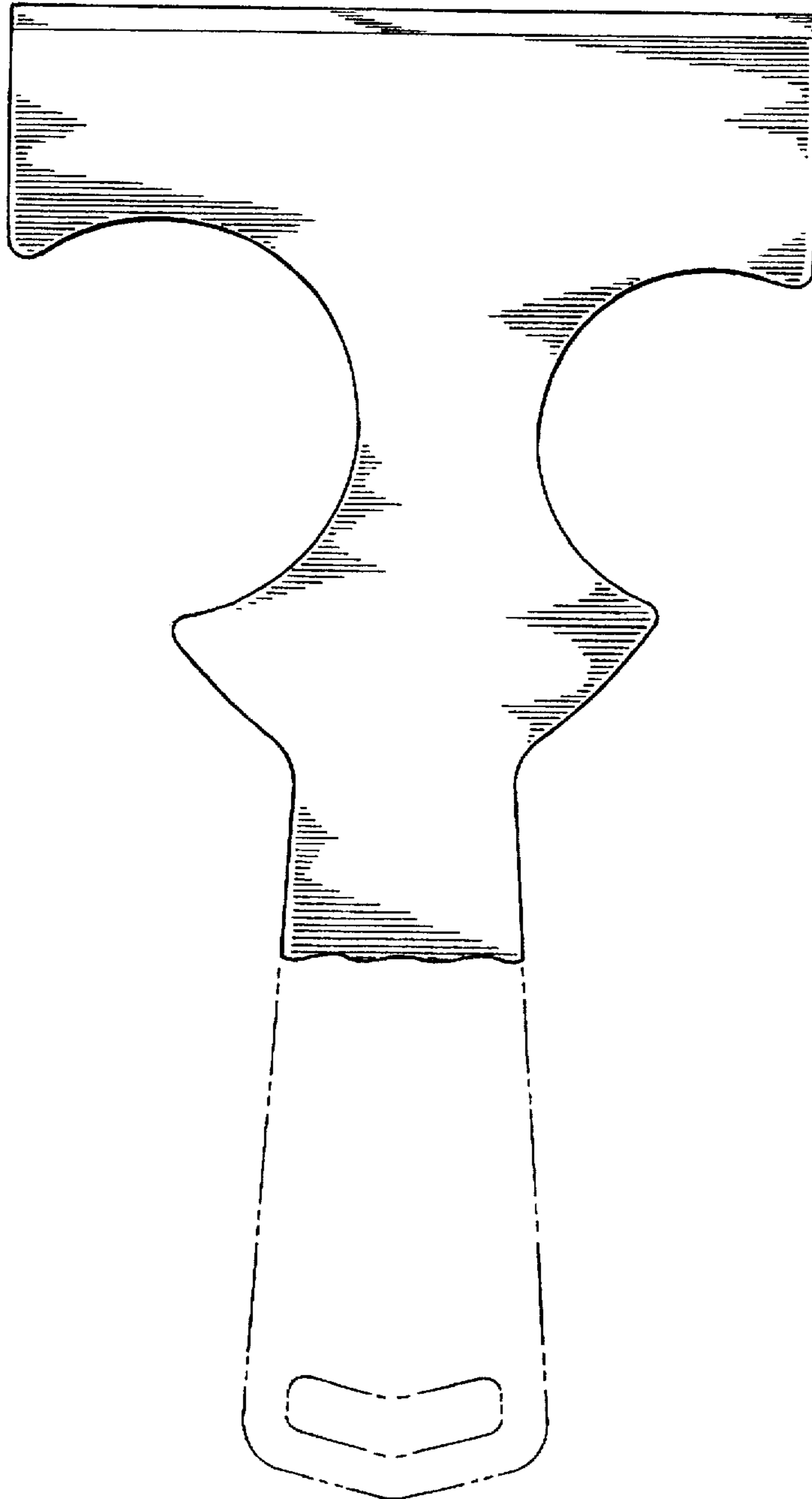
