[57] **CLAIM**

The ornamental design for an automated teller machine, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an automated teller machine showing our new design;  
FIG. 2 is a front view of the automated teller machine of FIG. 1;

FIG. 3 is a rear view of the automated teller machine of FIG. 1;

FIG. 4 is a right side view of the automated teller machine of FIG. 1;

FIG. 5 is a left side view of the automated teller machine of FIG. 1;

FIG. 6 is a top view of the automated teller machine of FIG. 1;

FIG. 7 is a bottom view of the automated teller machine of FIG. 1;

FIG. 8 is a front perspective view of a second embodiment showing our new design;

FIG. 9 is a front view of the automated teller machine shown in FIG. 8;

FIG. 10 is a rear view of the automated teller machine shown in FIG. 8;

FIG. 11 is a right side view of the automated teller machine shown in FIG. 8;

FIG. 12 is a left side view of the automated teller machine shown in FIG. 8;

FIG. 20 is a bottom view of the automated teller machine shown in FIG. 15;

FIG. 21 is a front perspective view of a fourth embodiment showing our new design;

FIG. 22 is a front view of the automated teller machine shown in FIG. 21;

FIG. 23 is a rear view of the automated teller machine shown in FIG. 21;

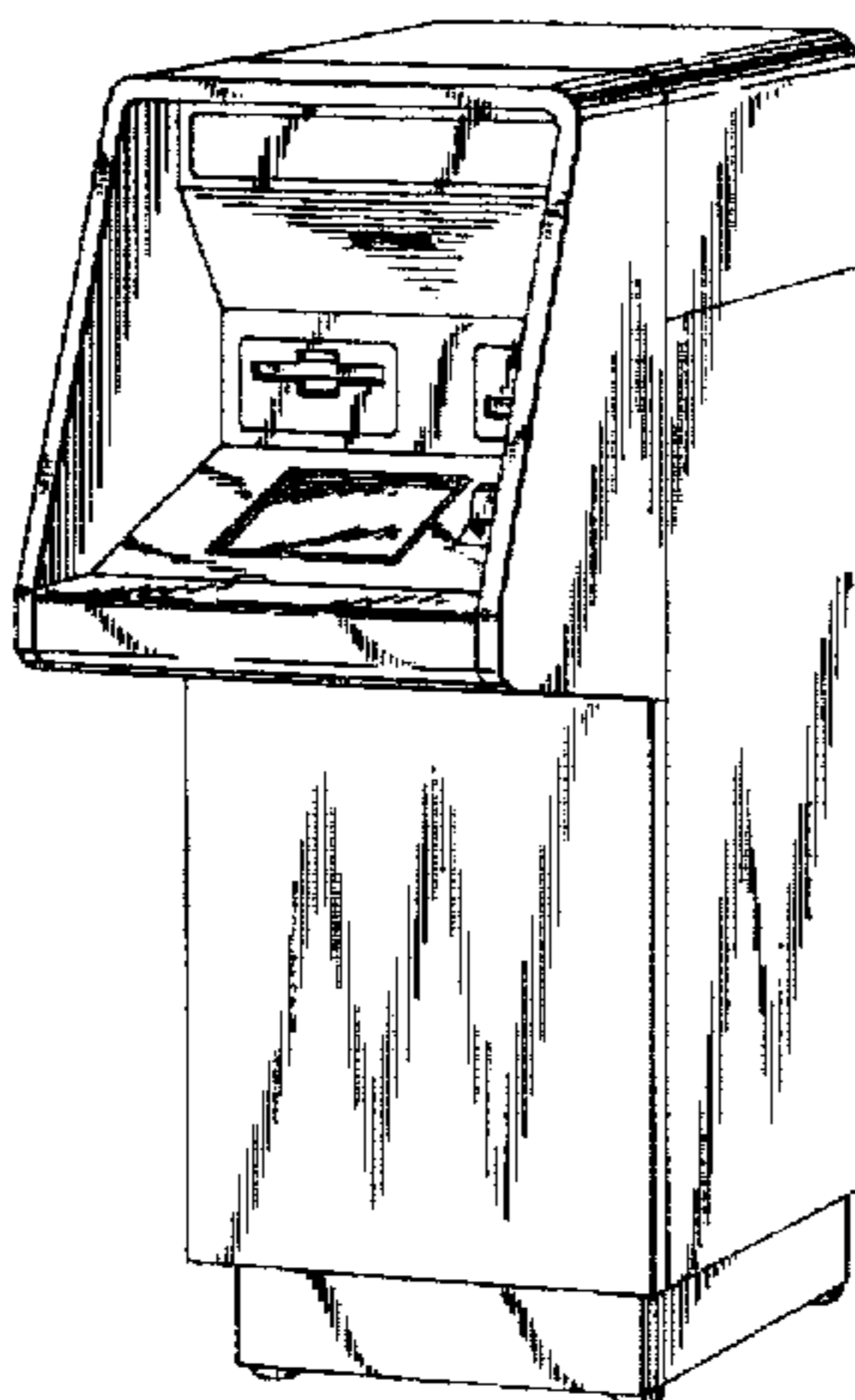

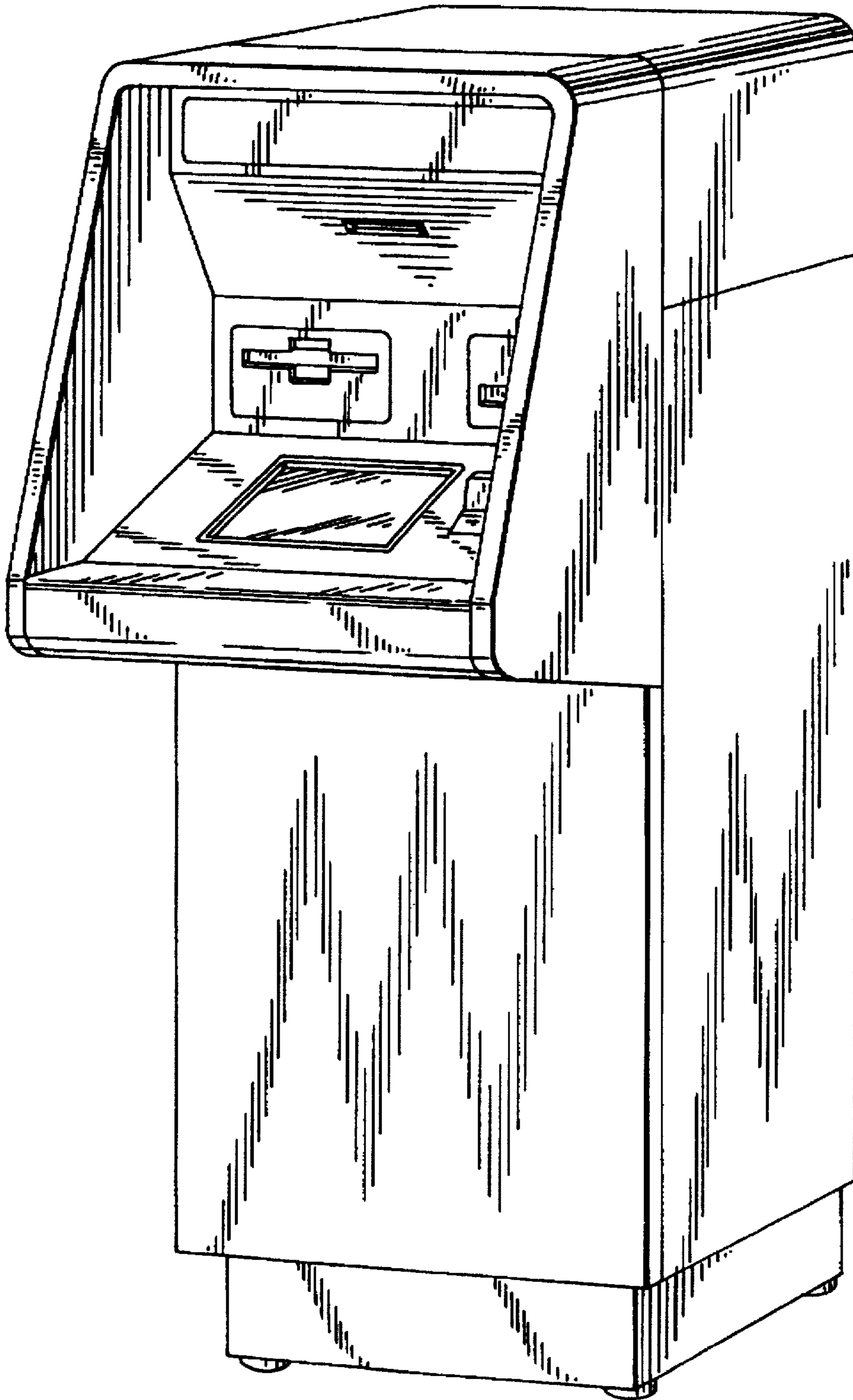

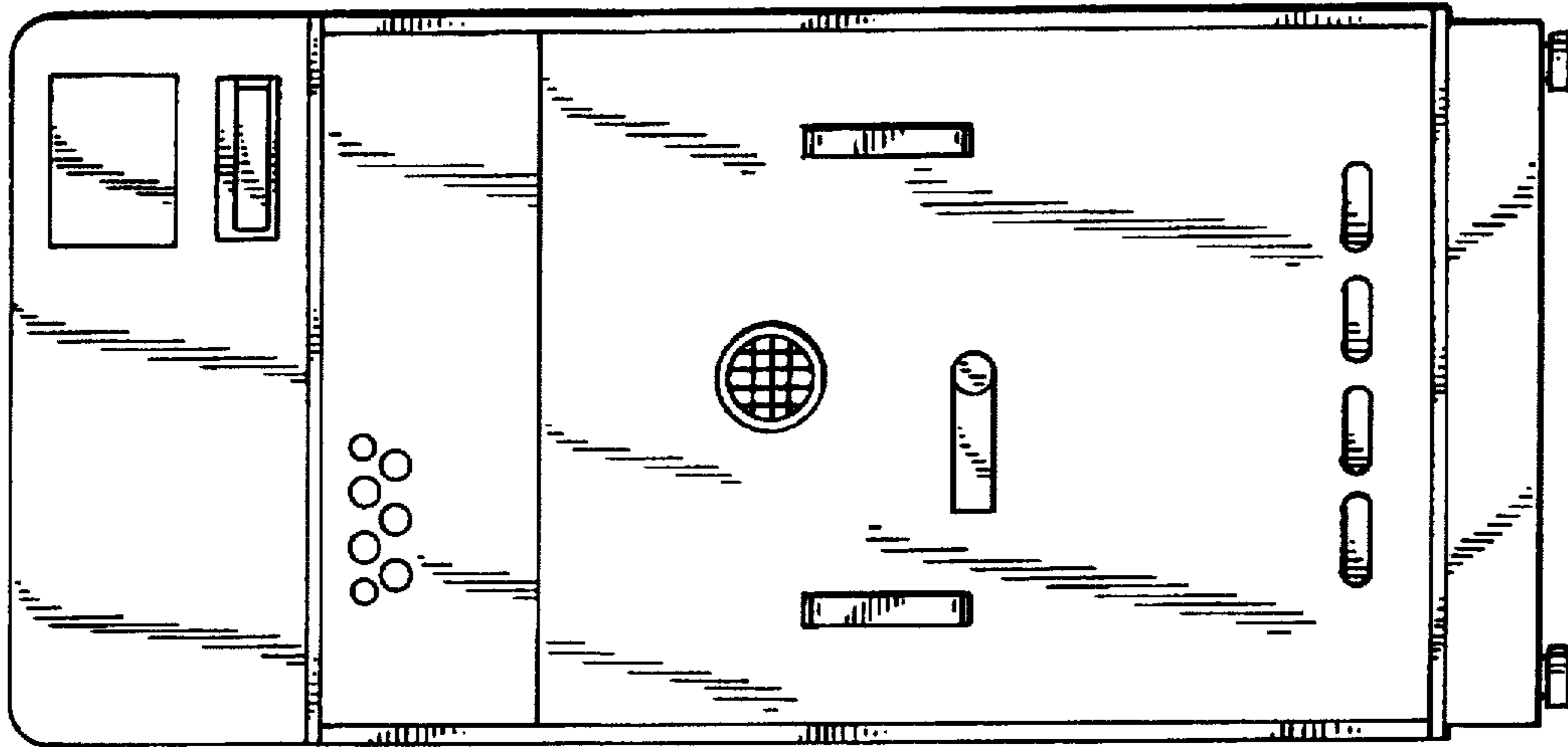

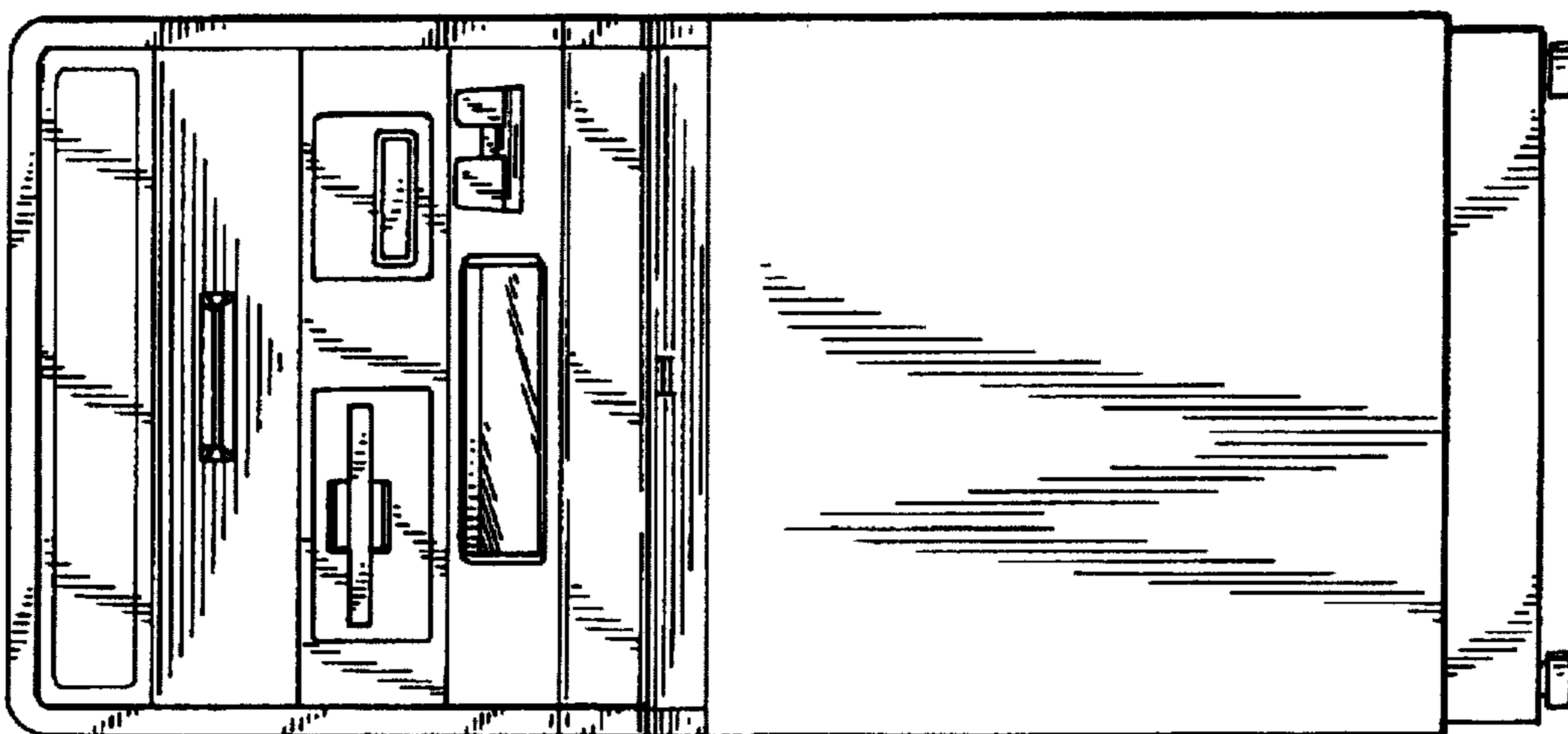

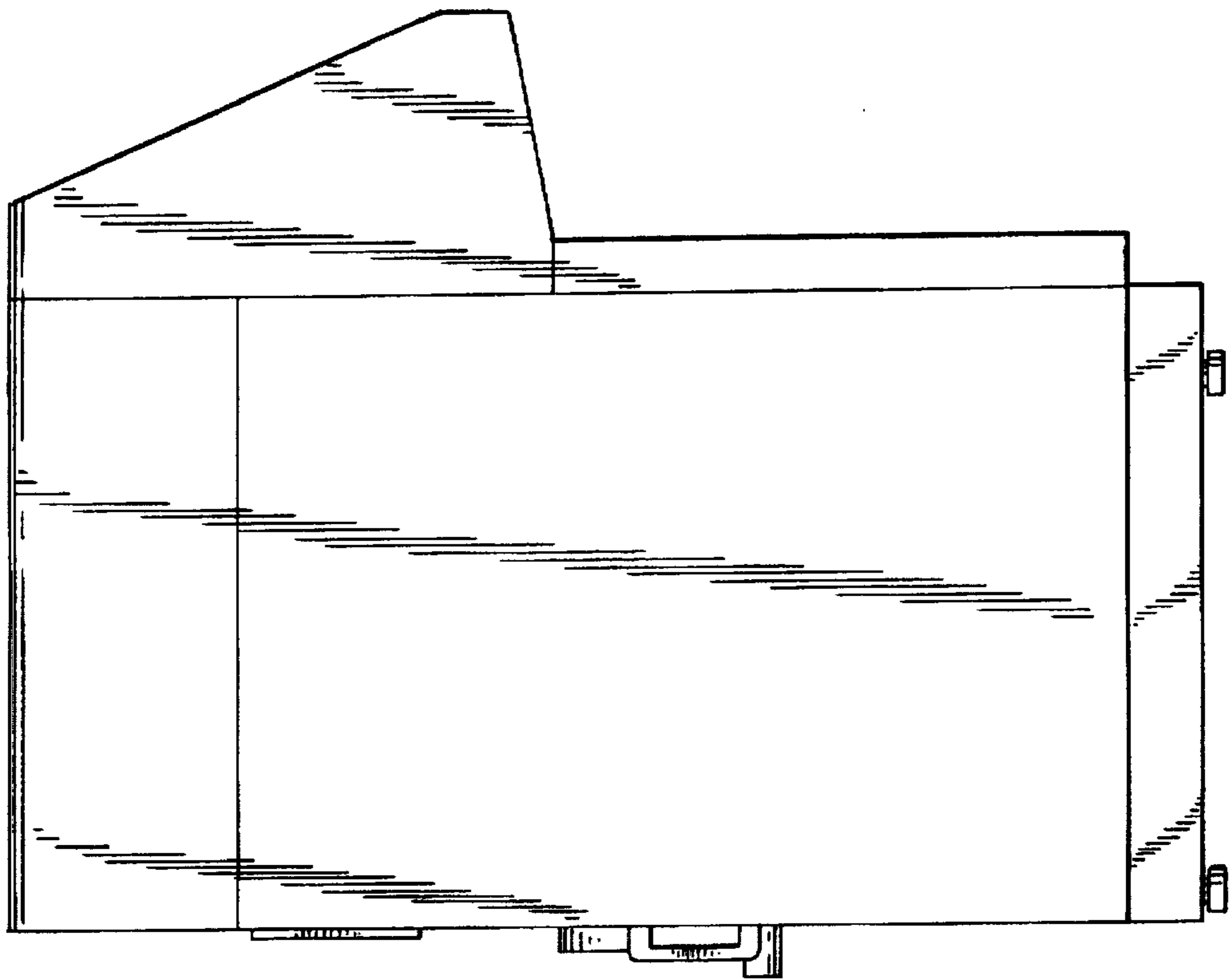

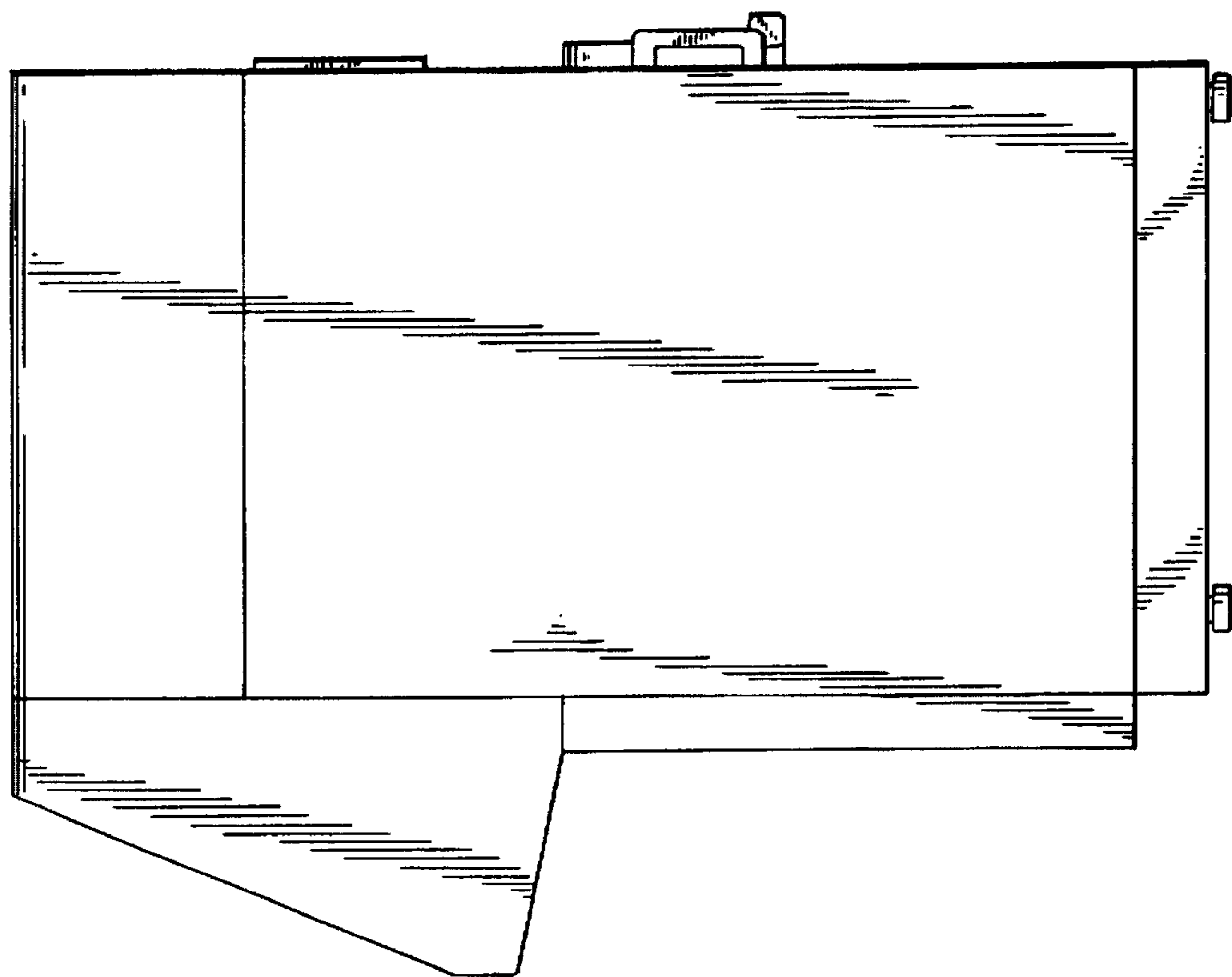

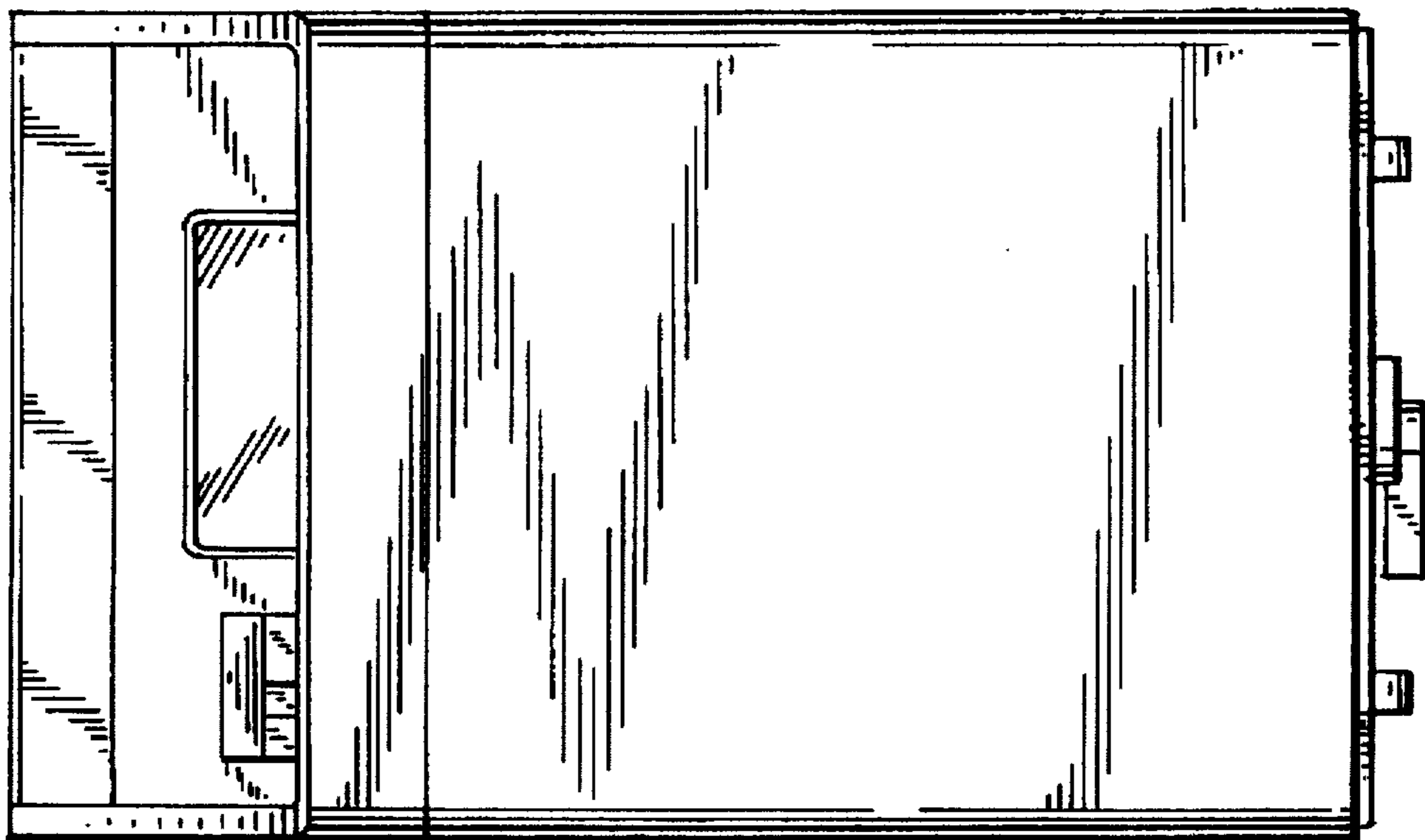

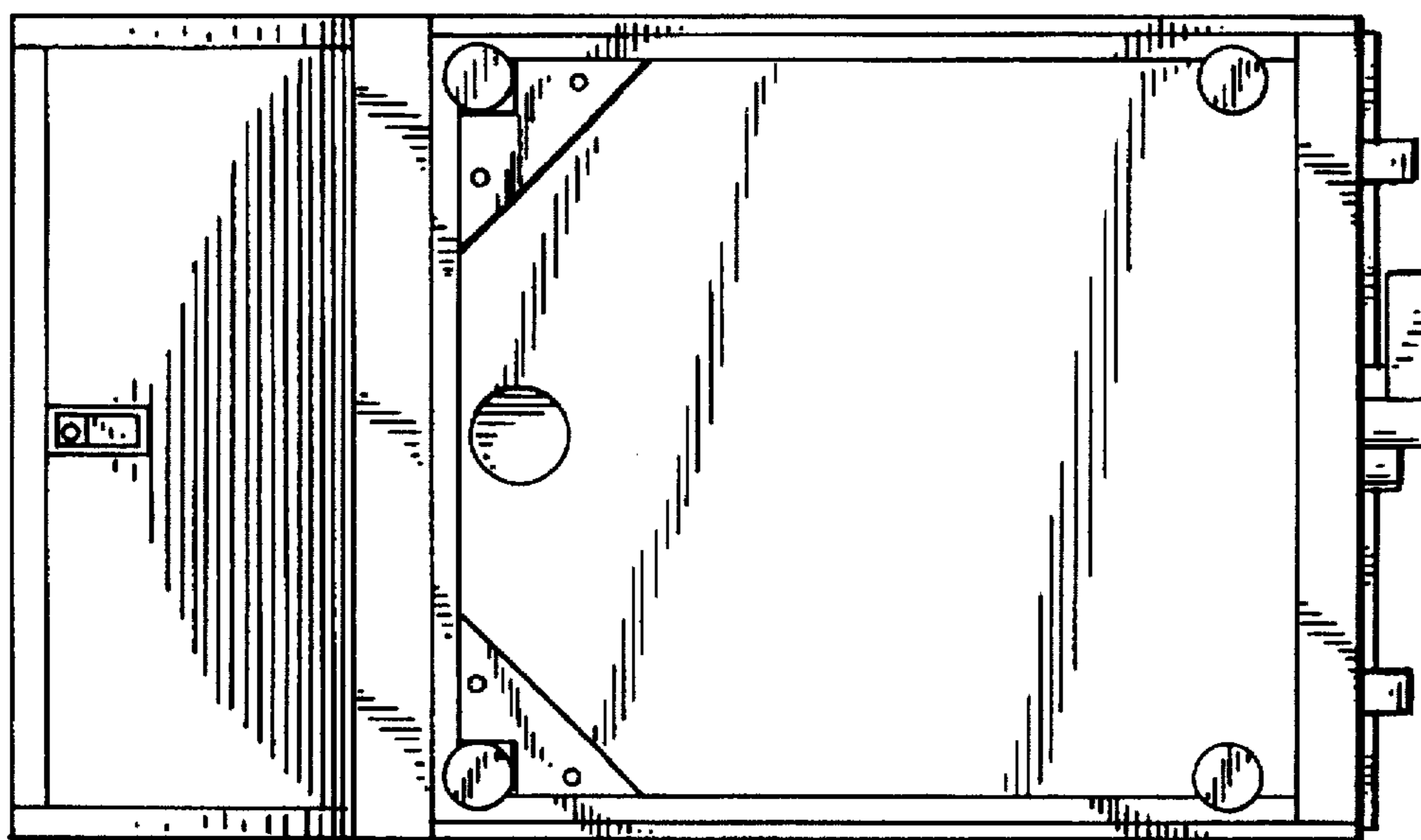

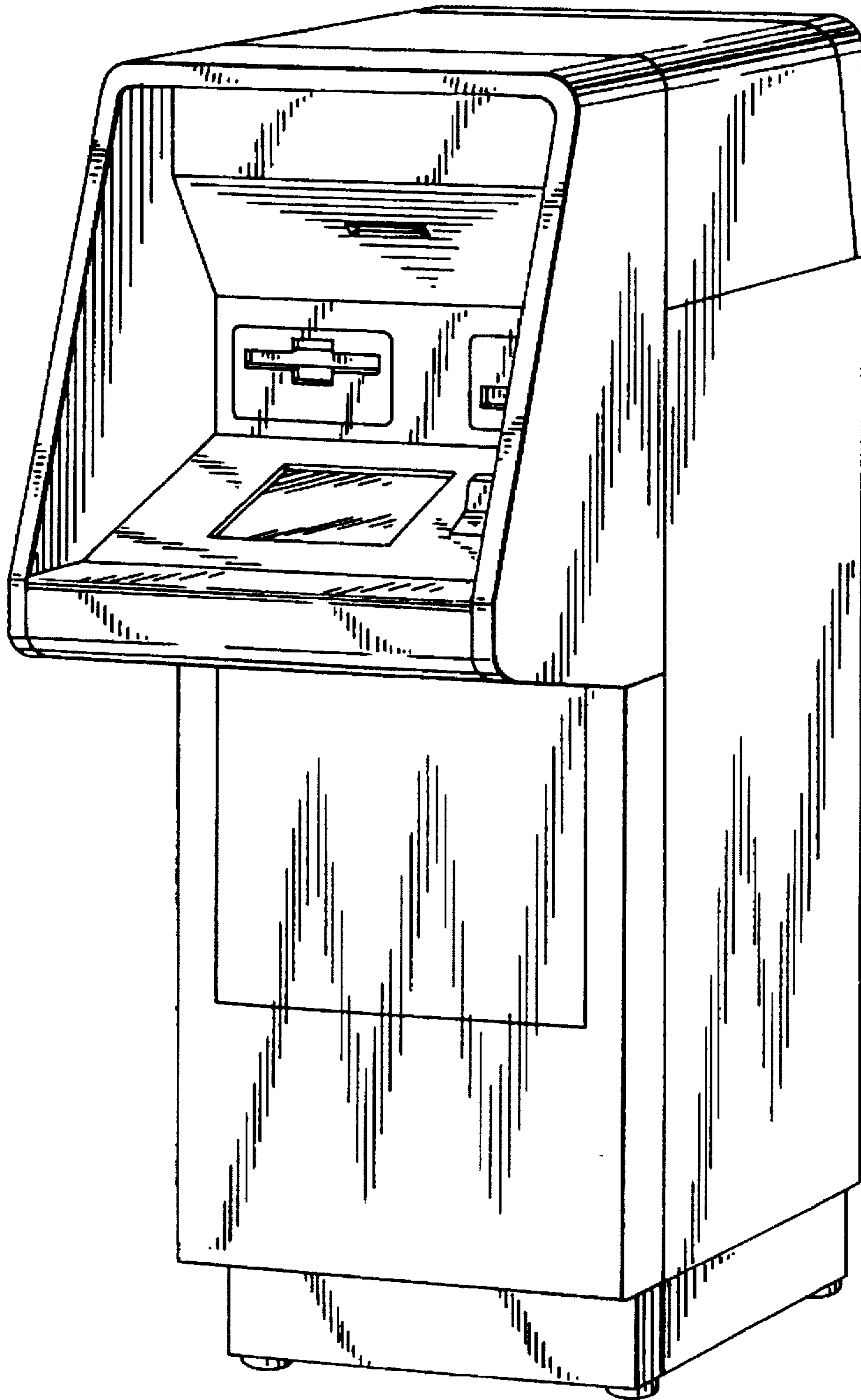

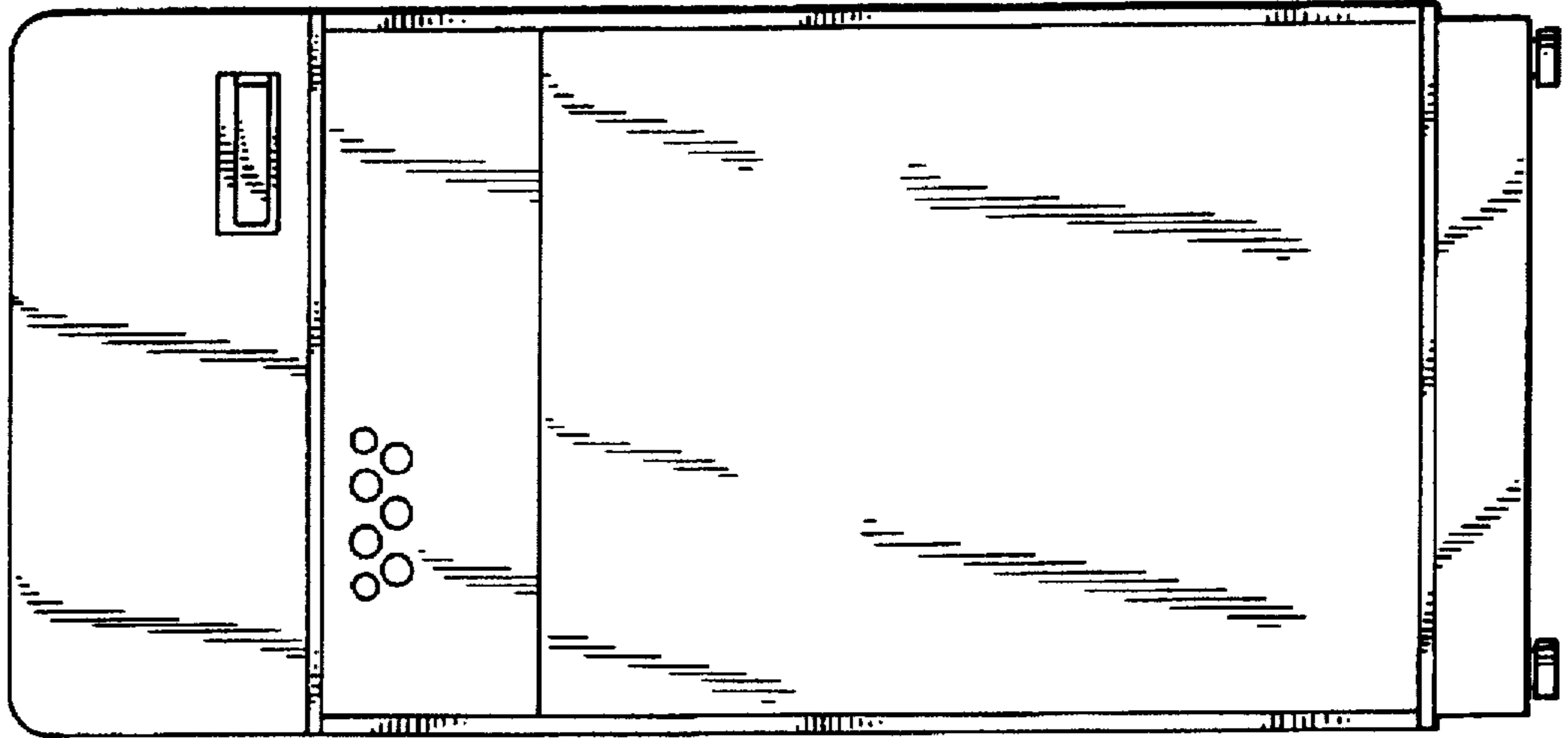

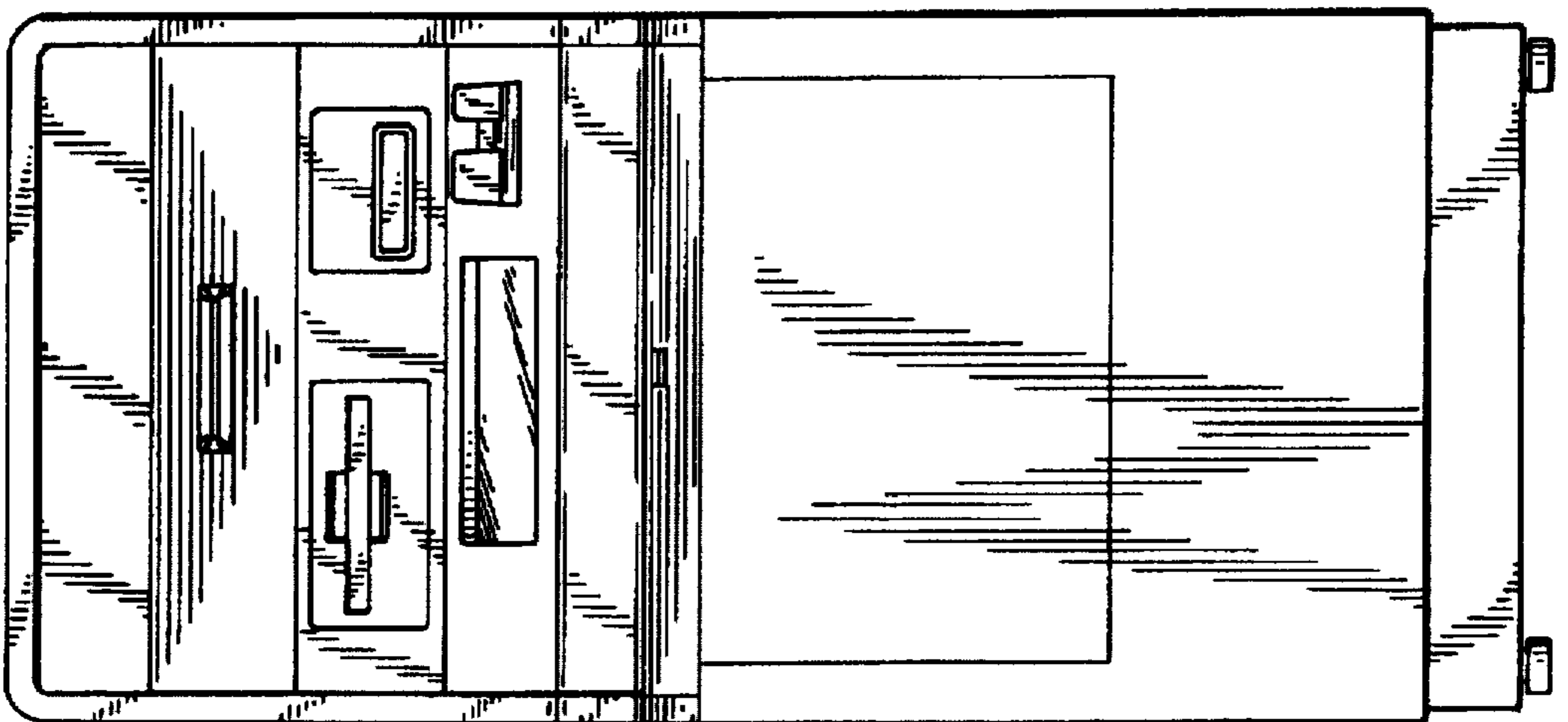

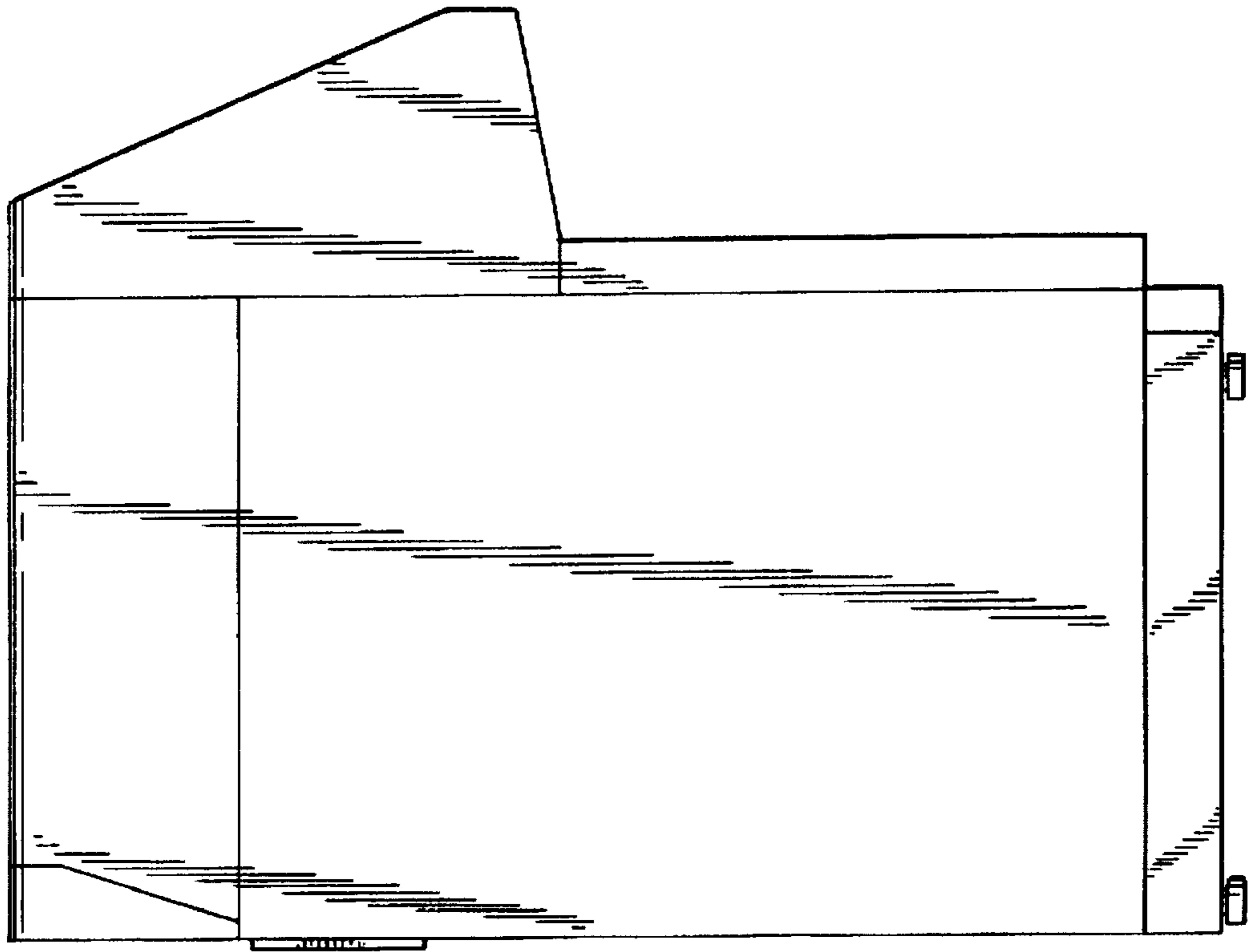

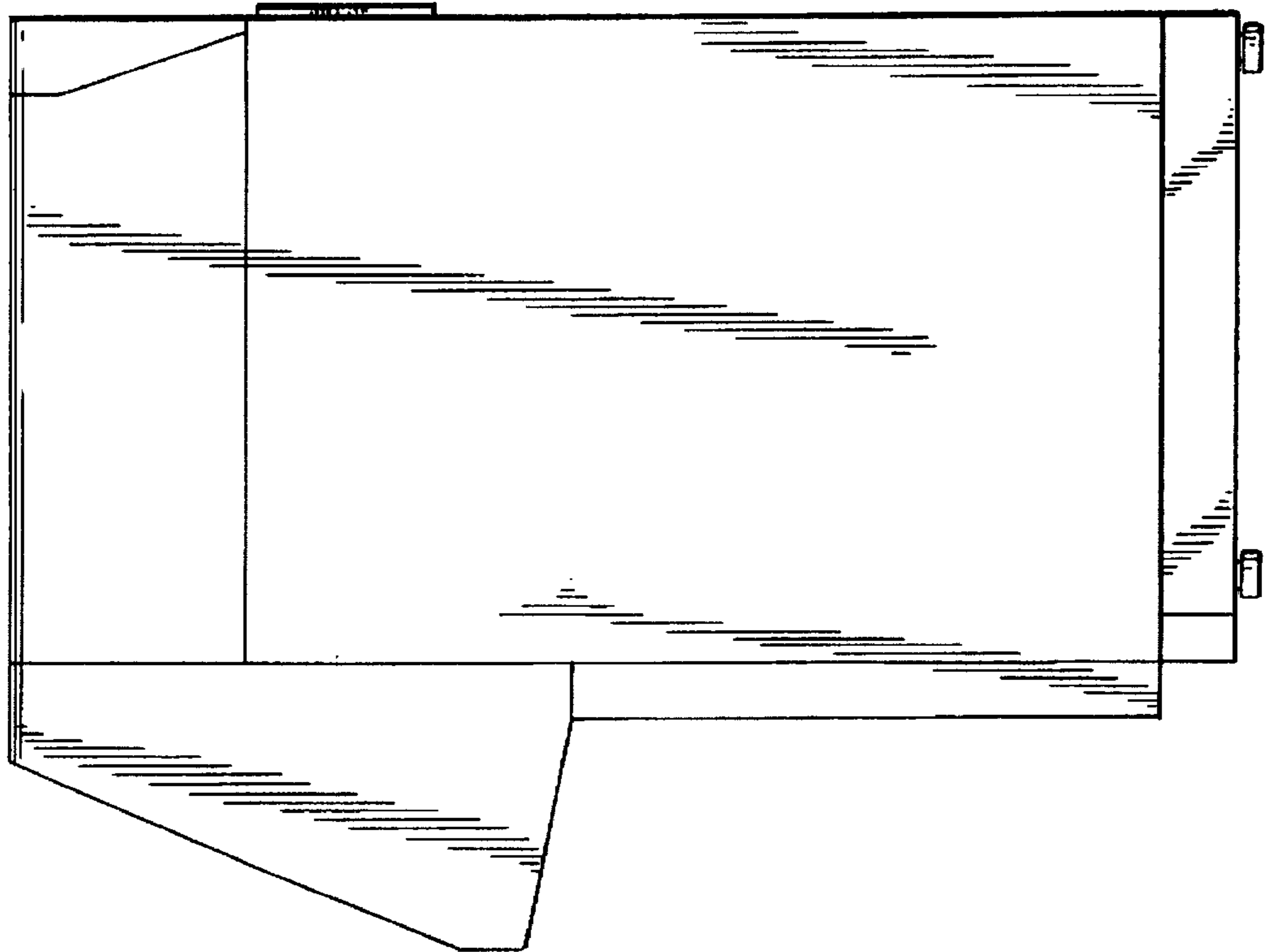

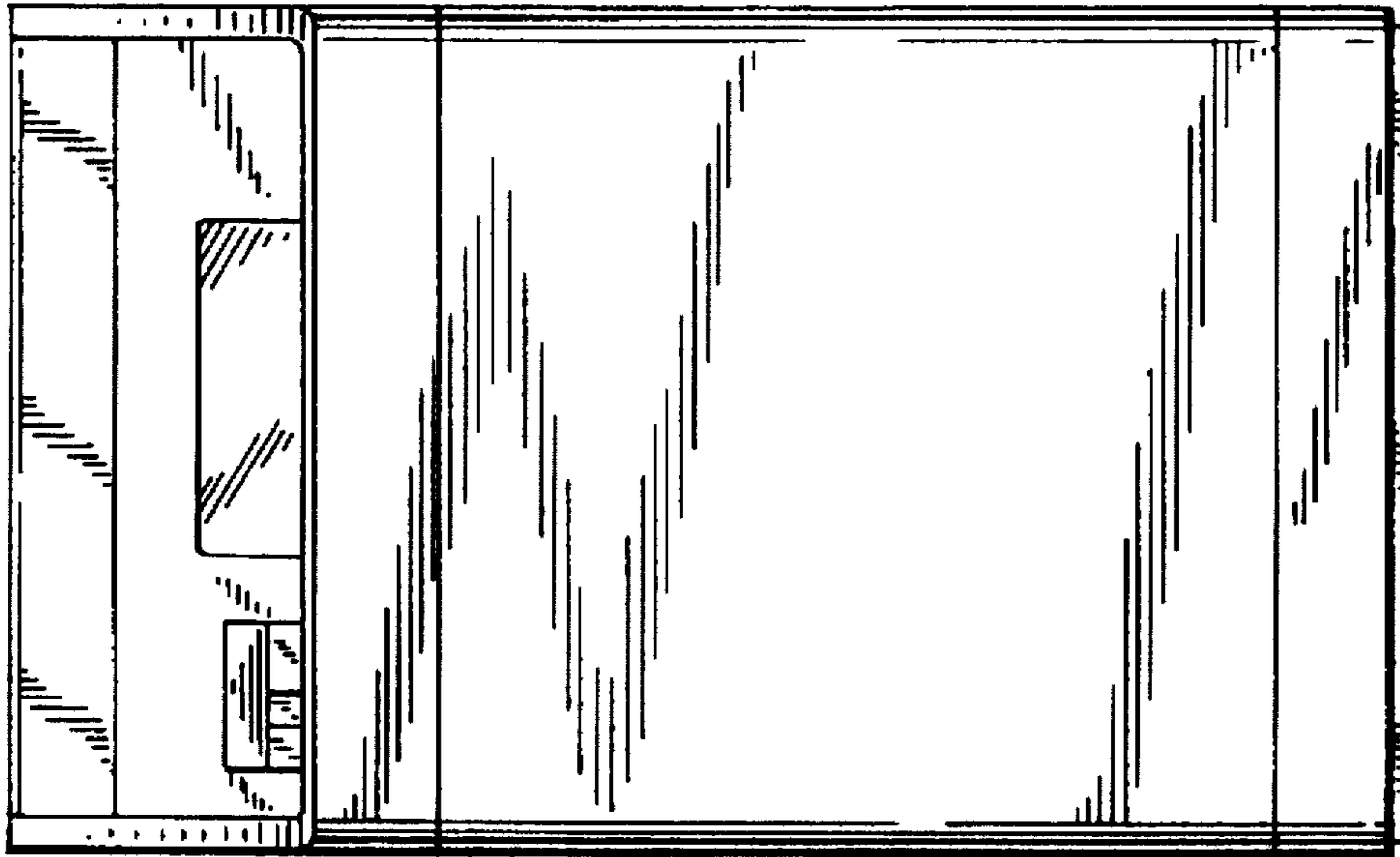

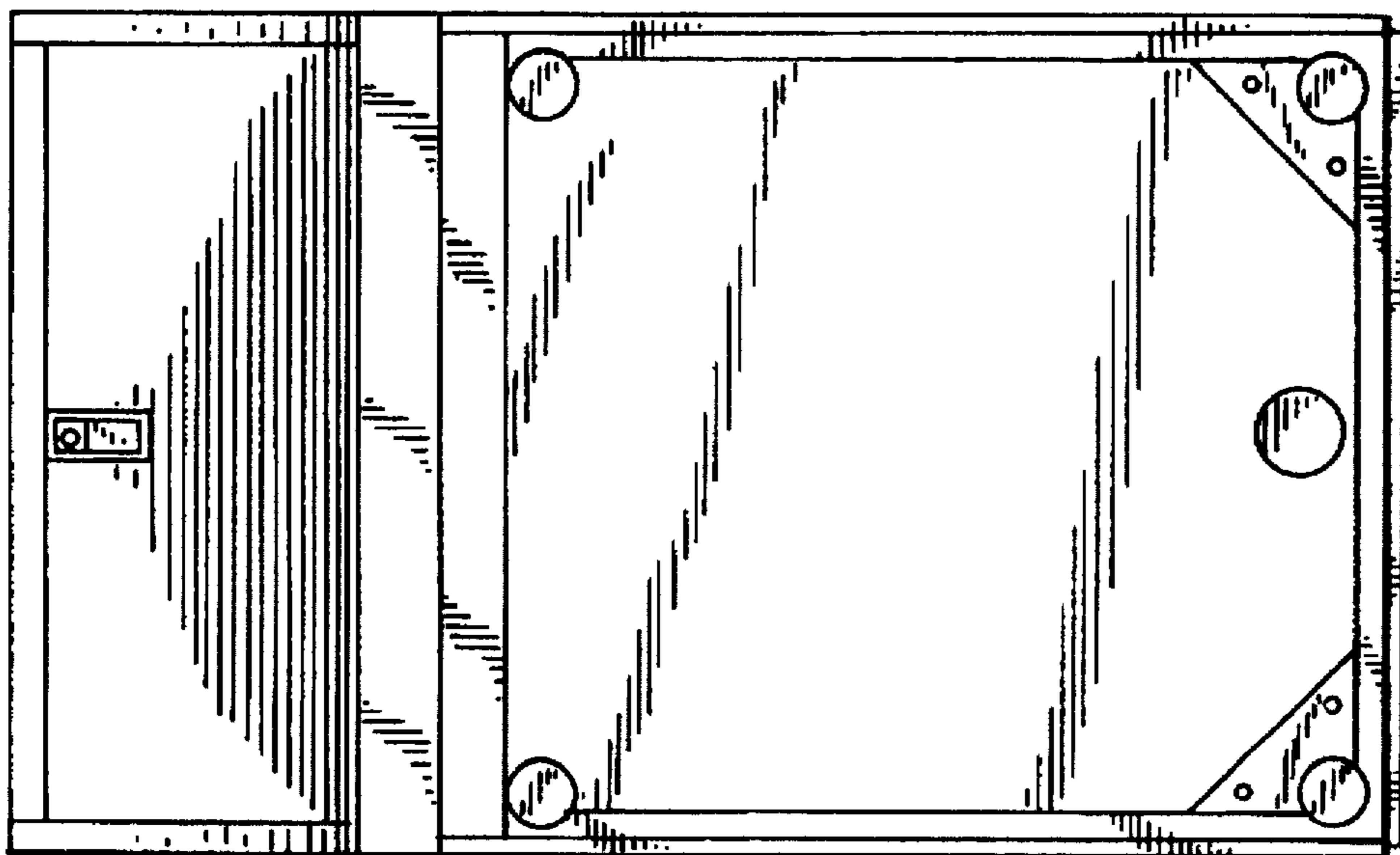

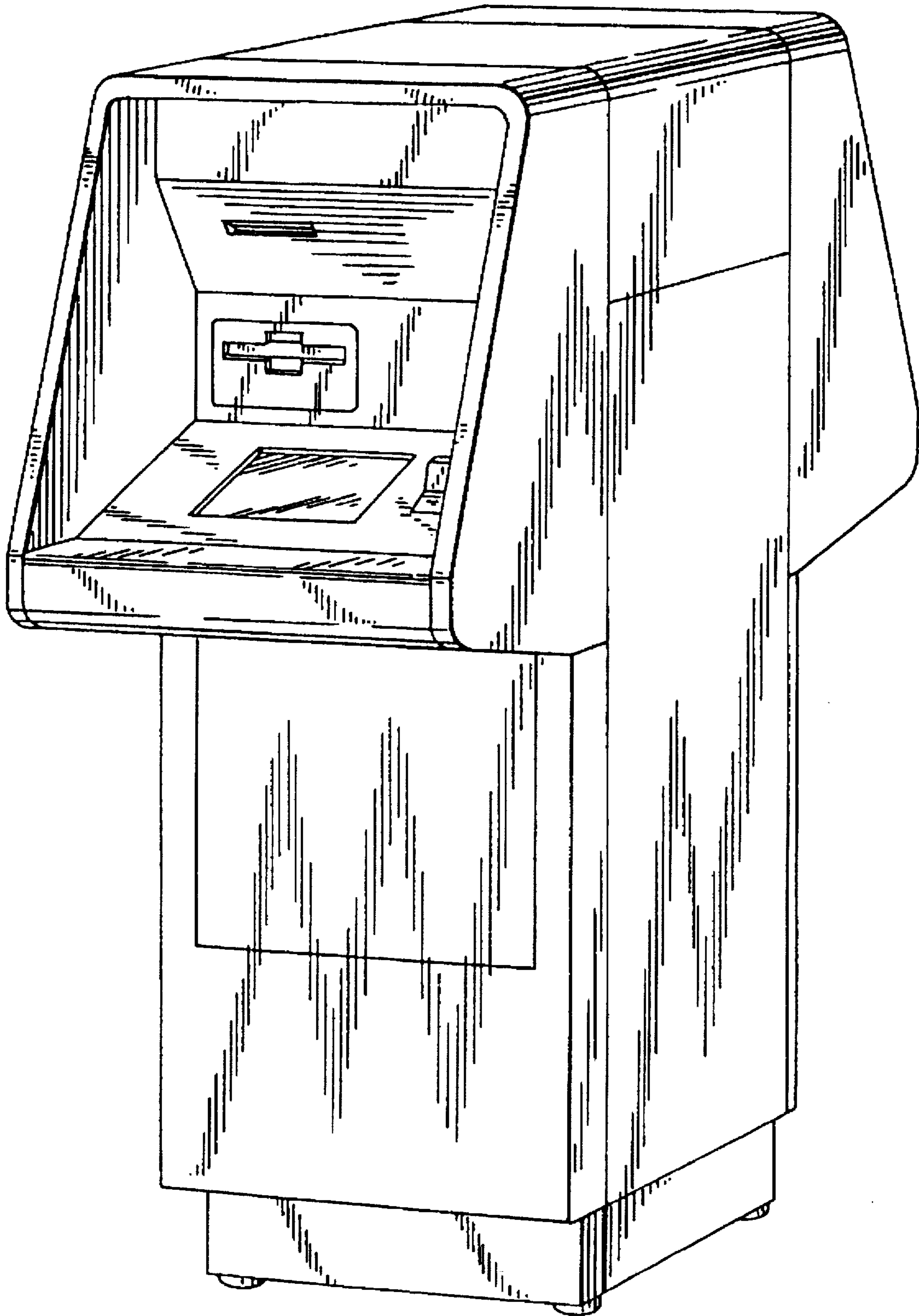

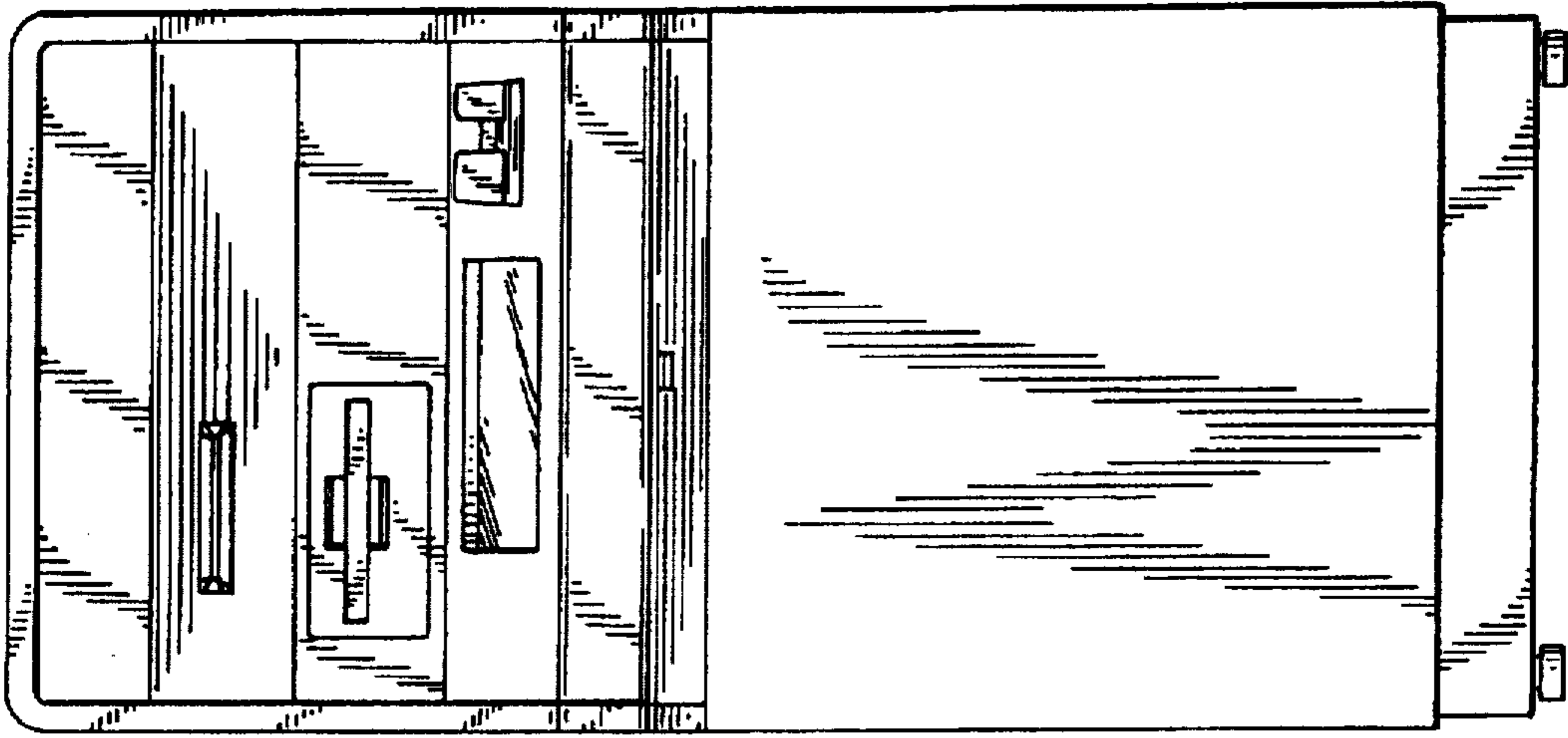

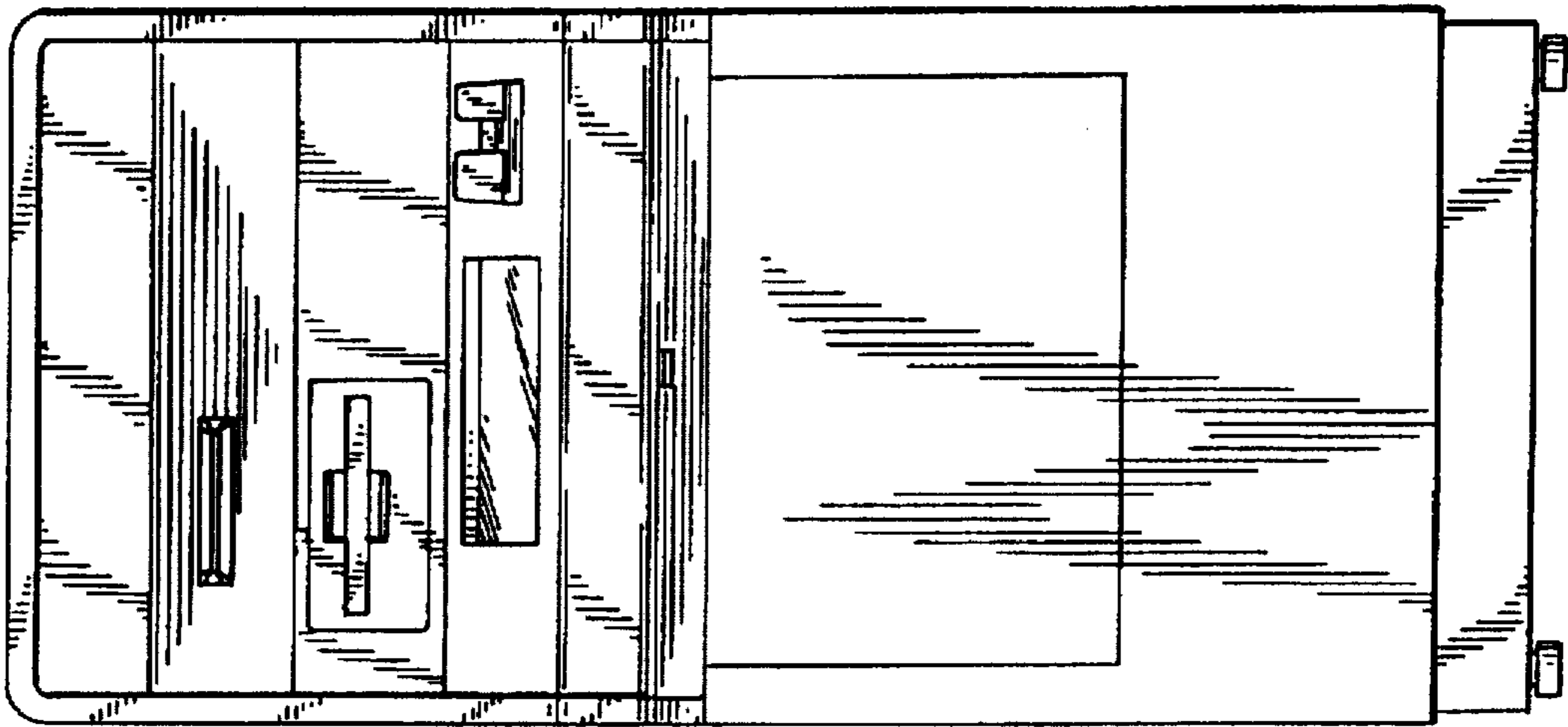

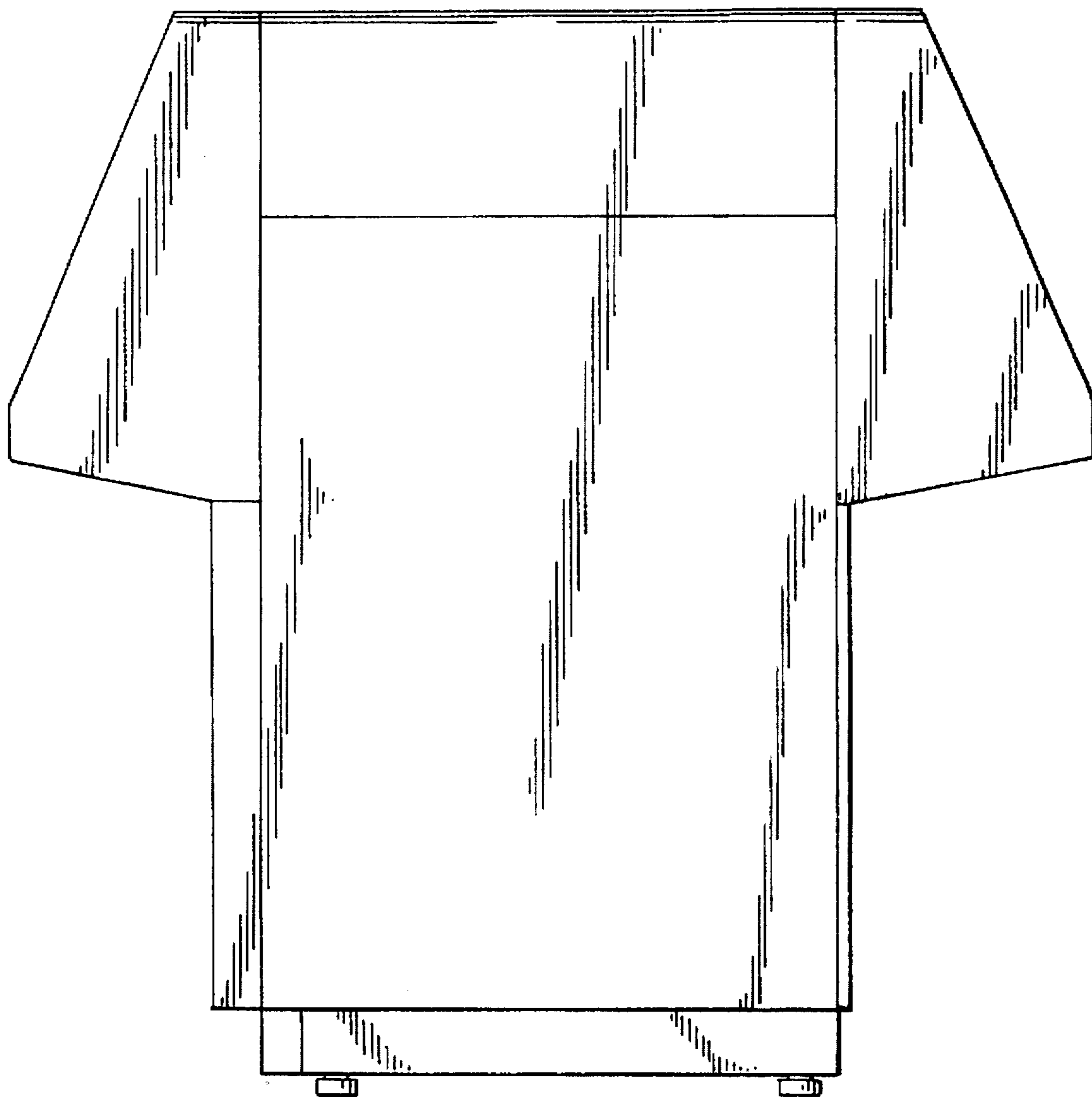

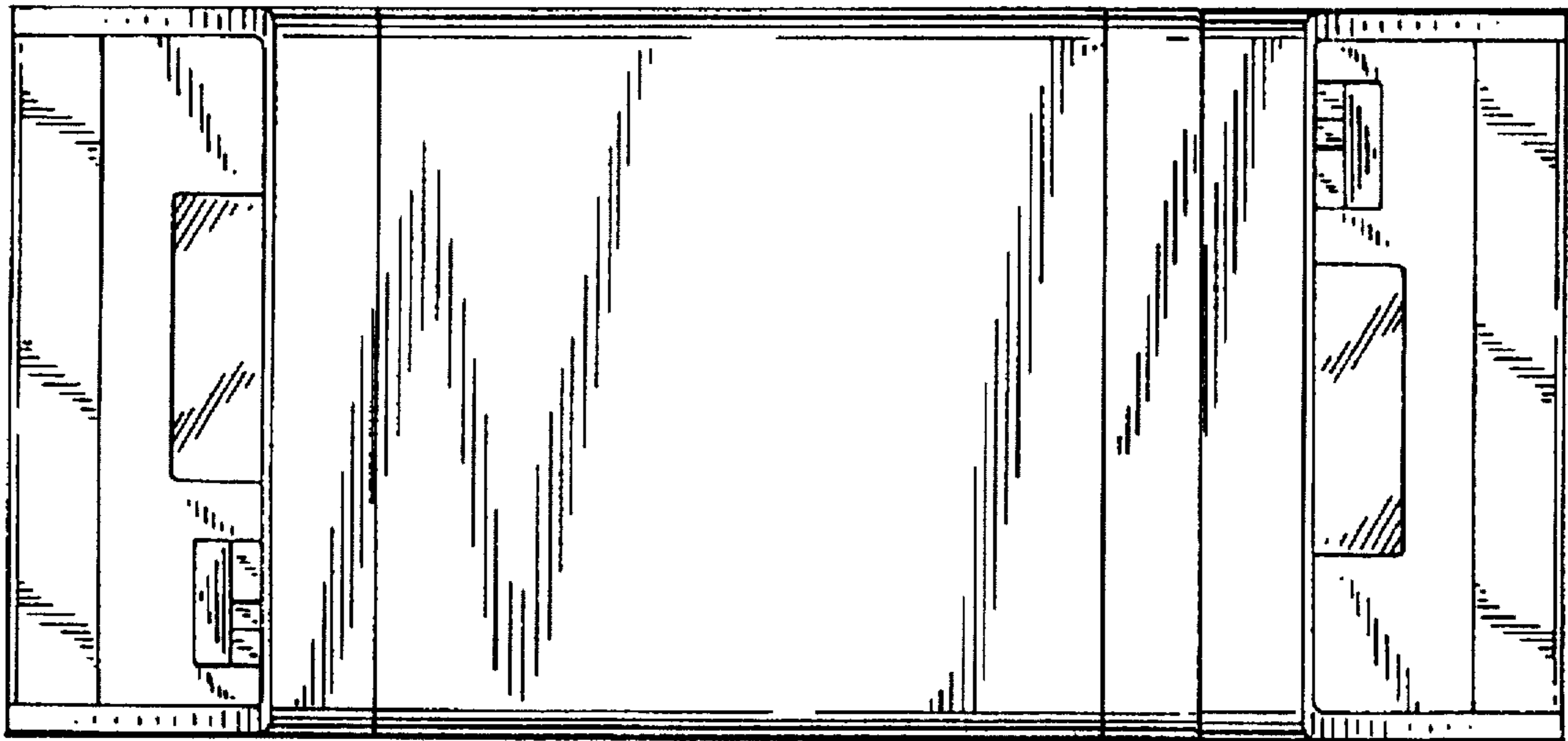

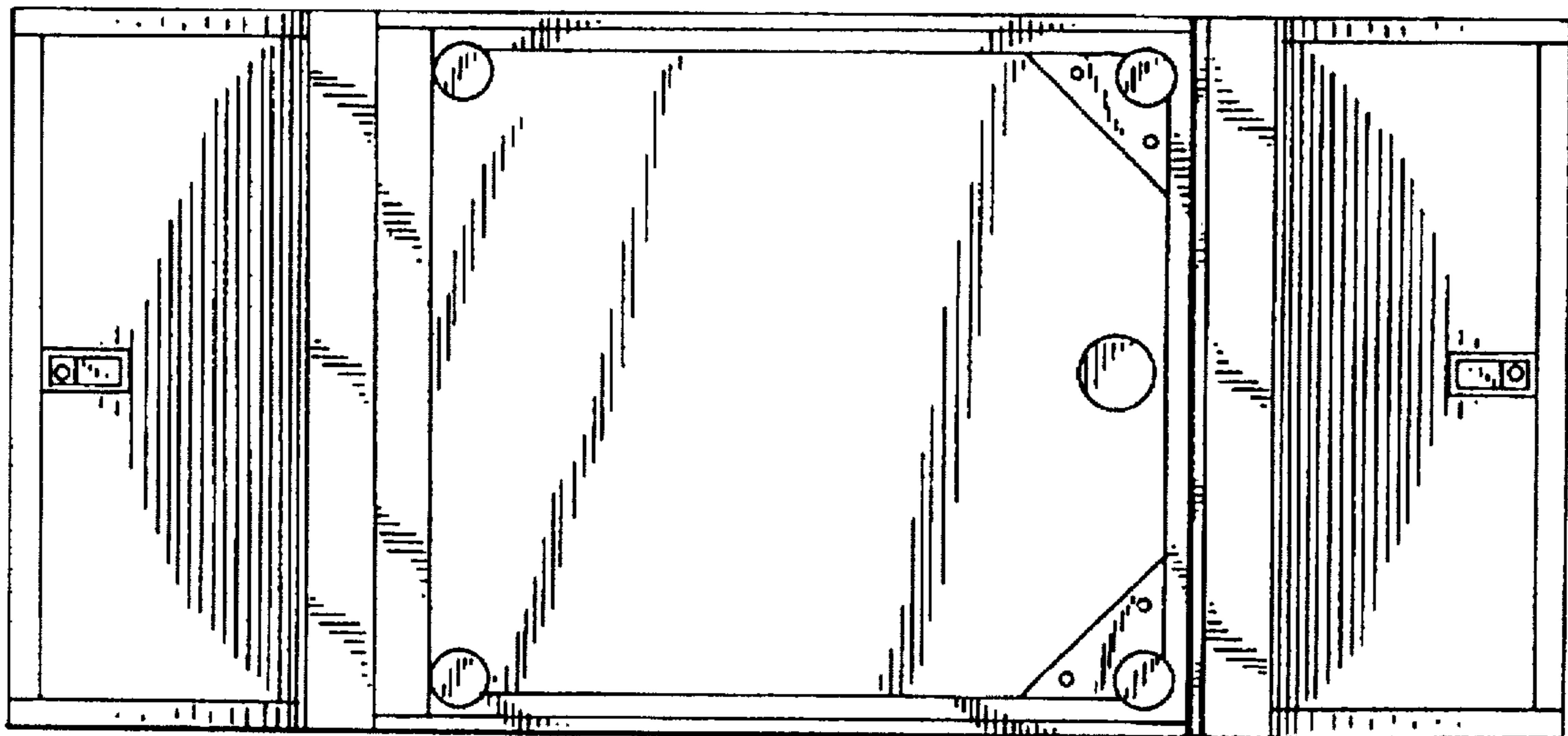

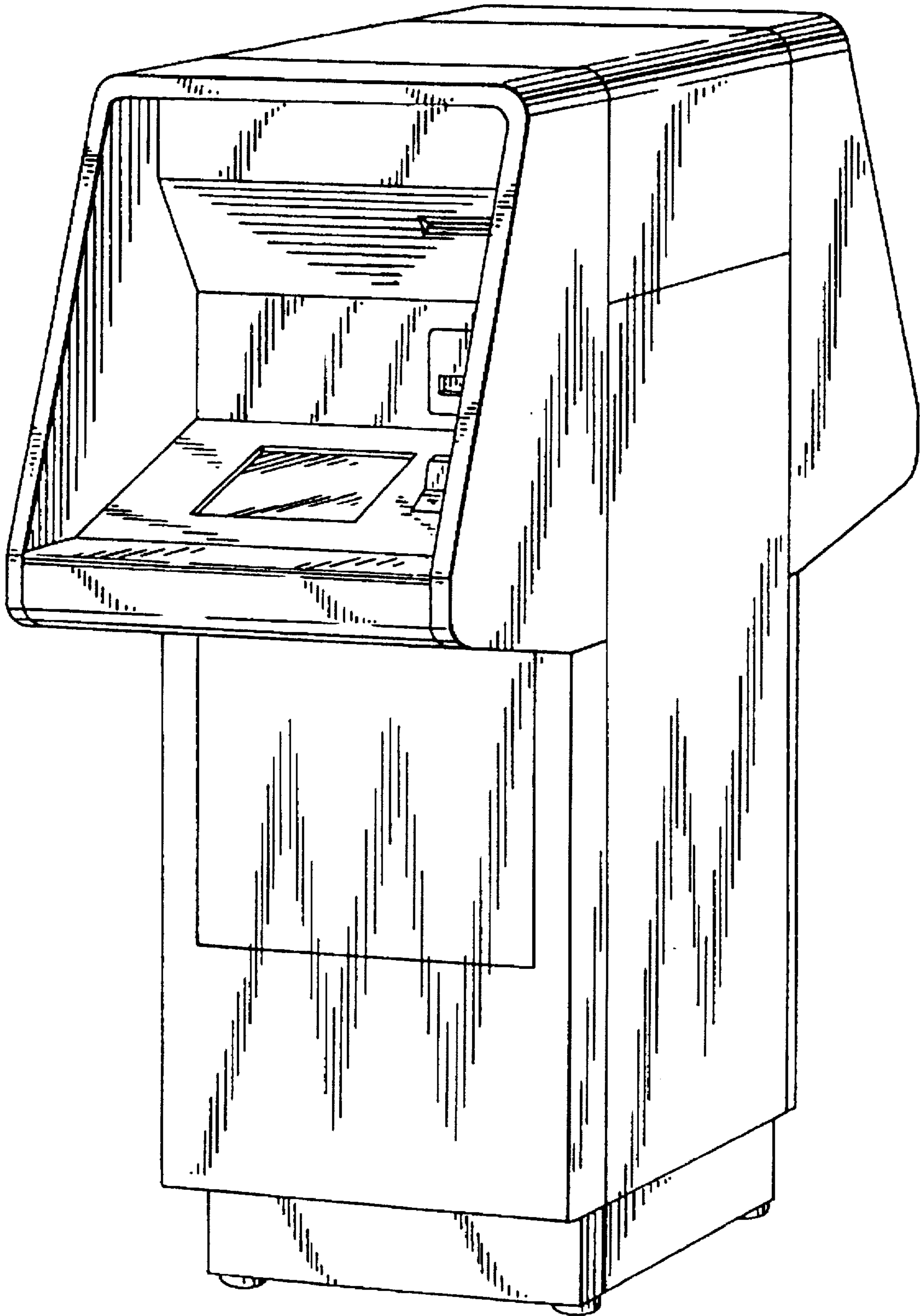

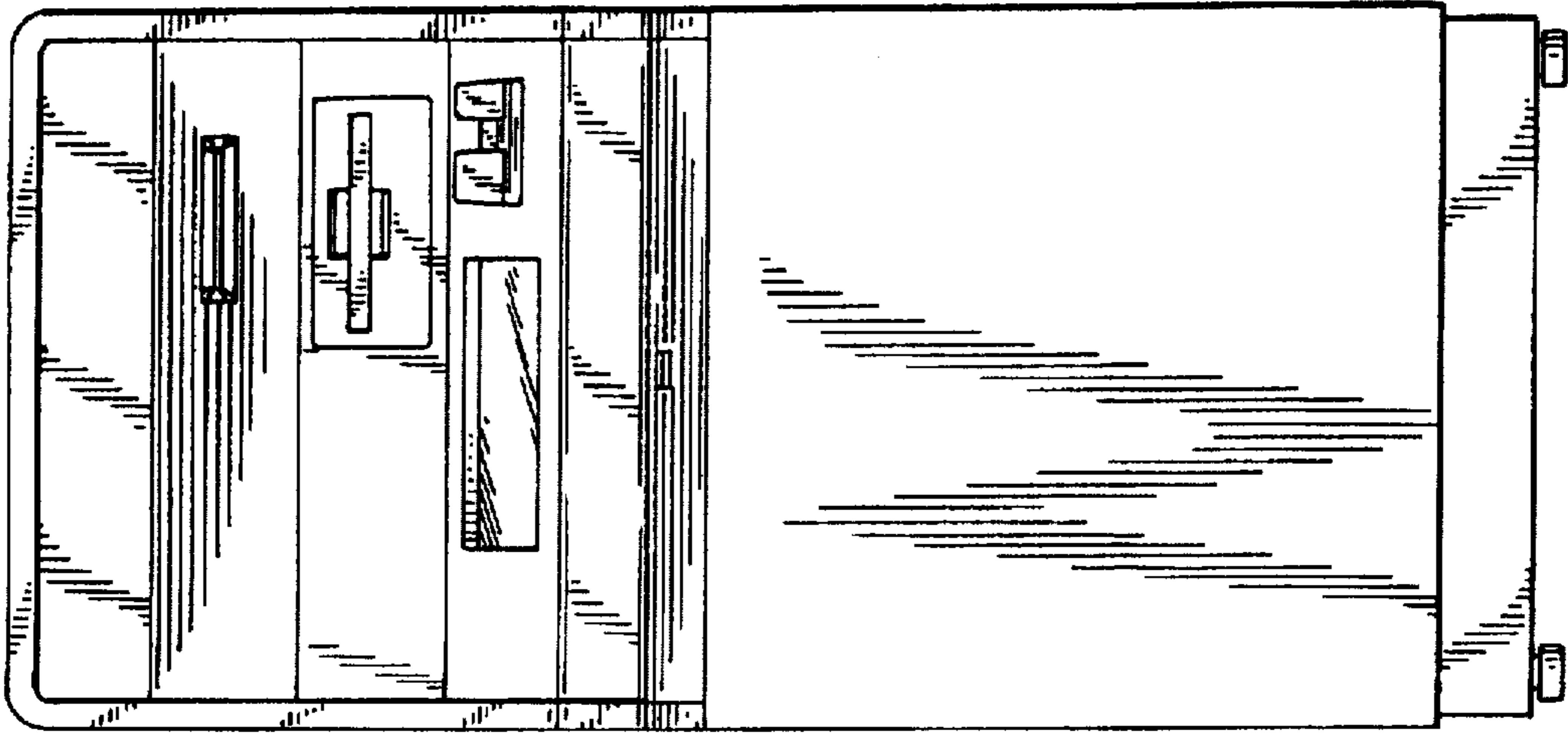

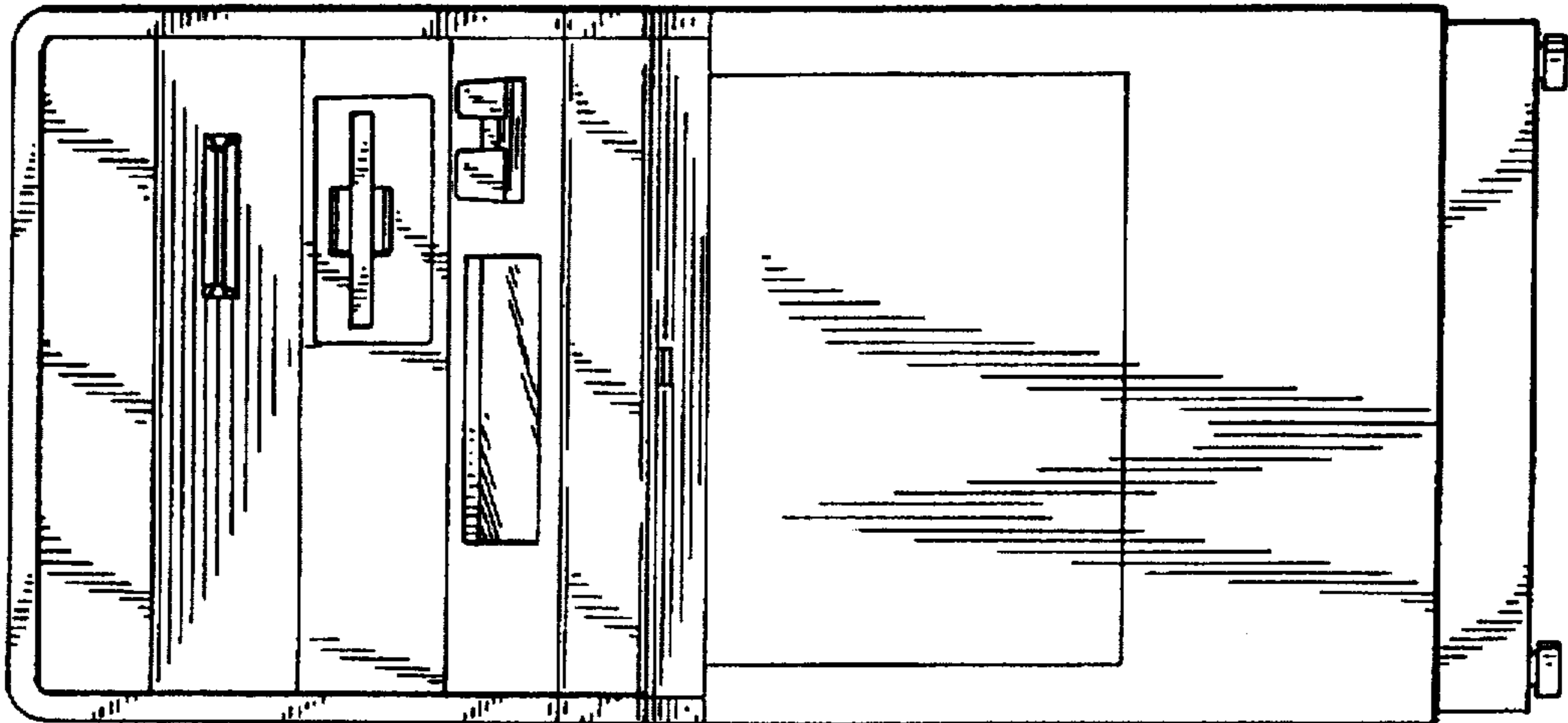

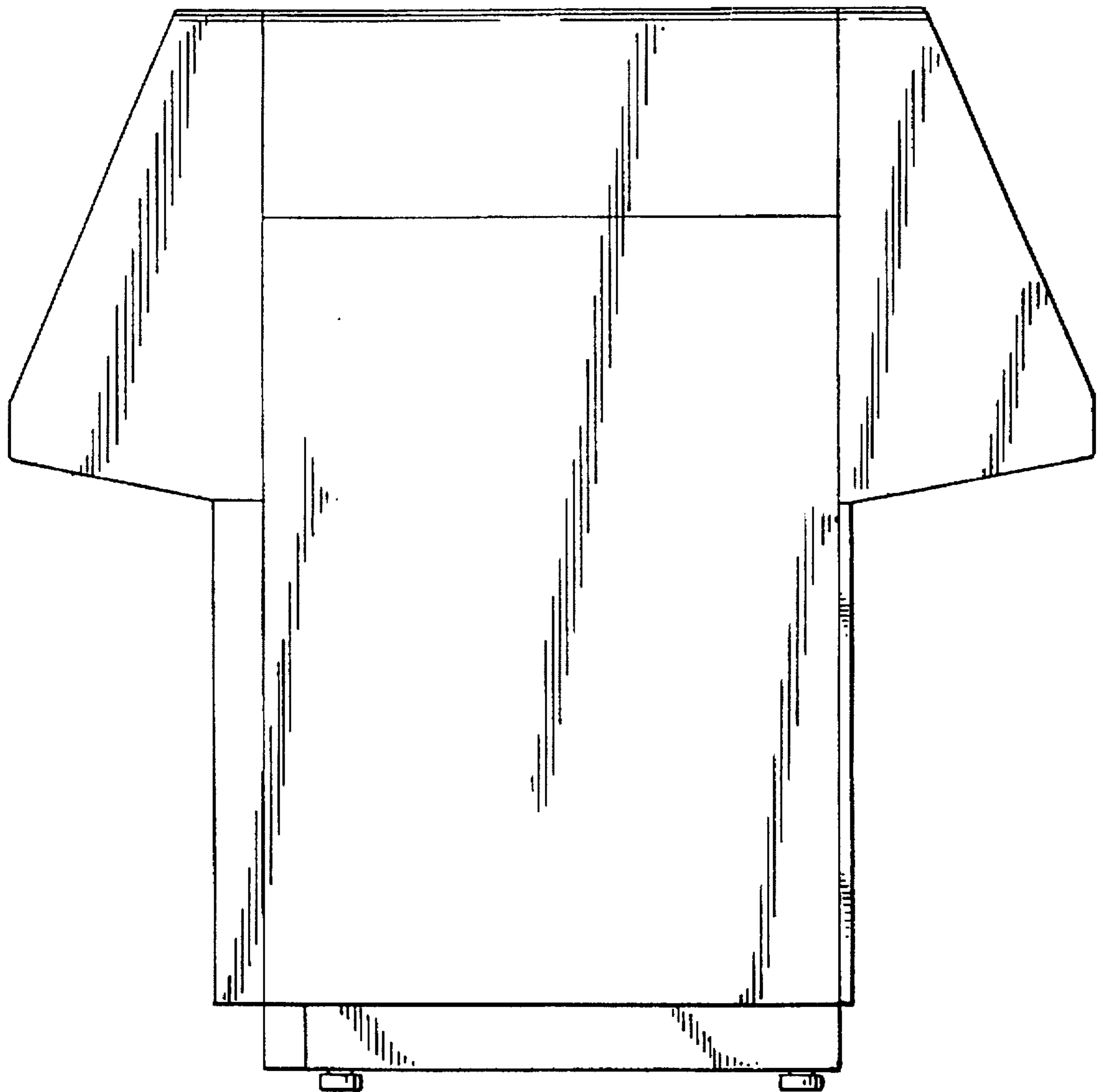

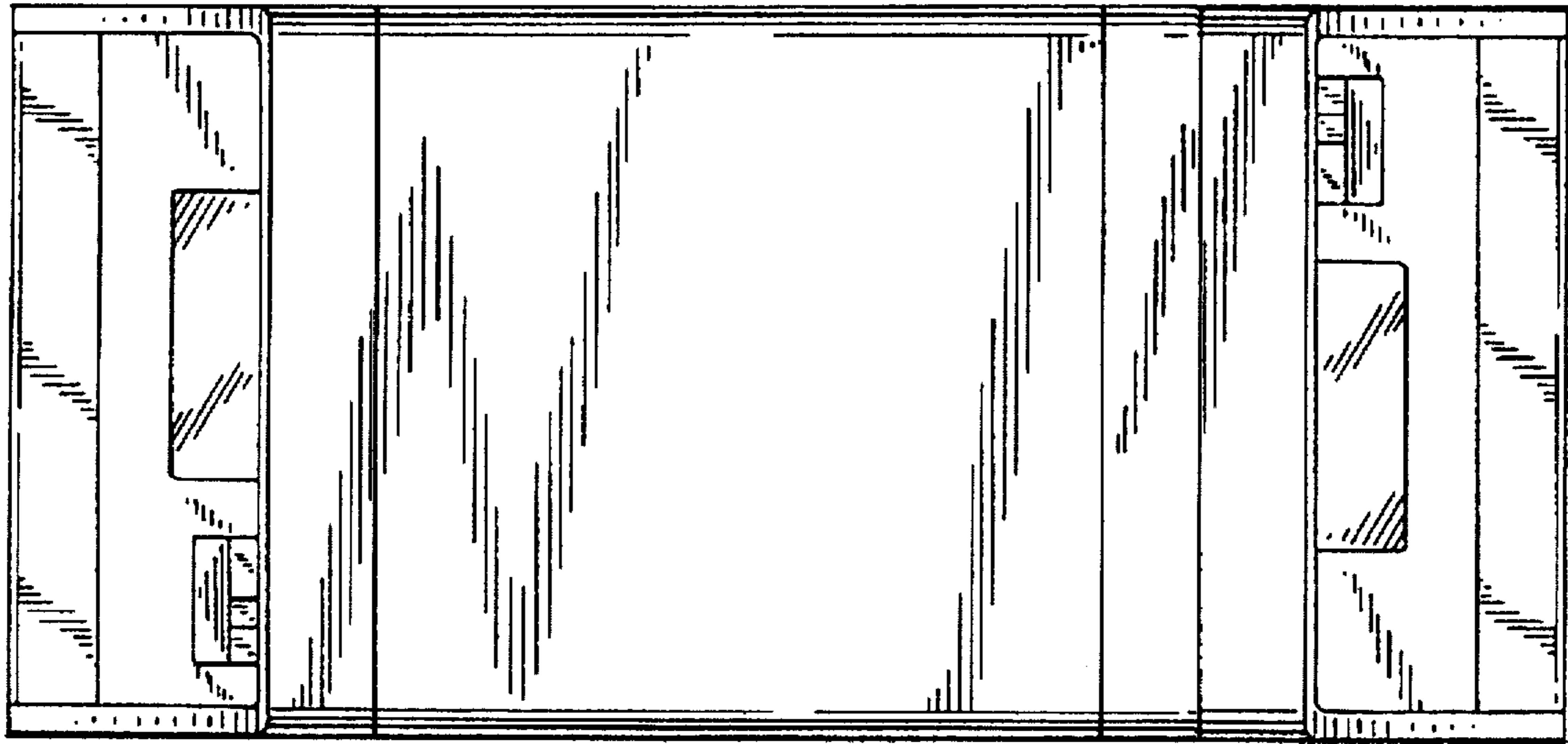
