The ornamental design for an element of a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of an element of a shoe showing my new design;

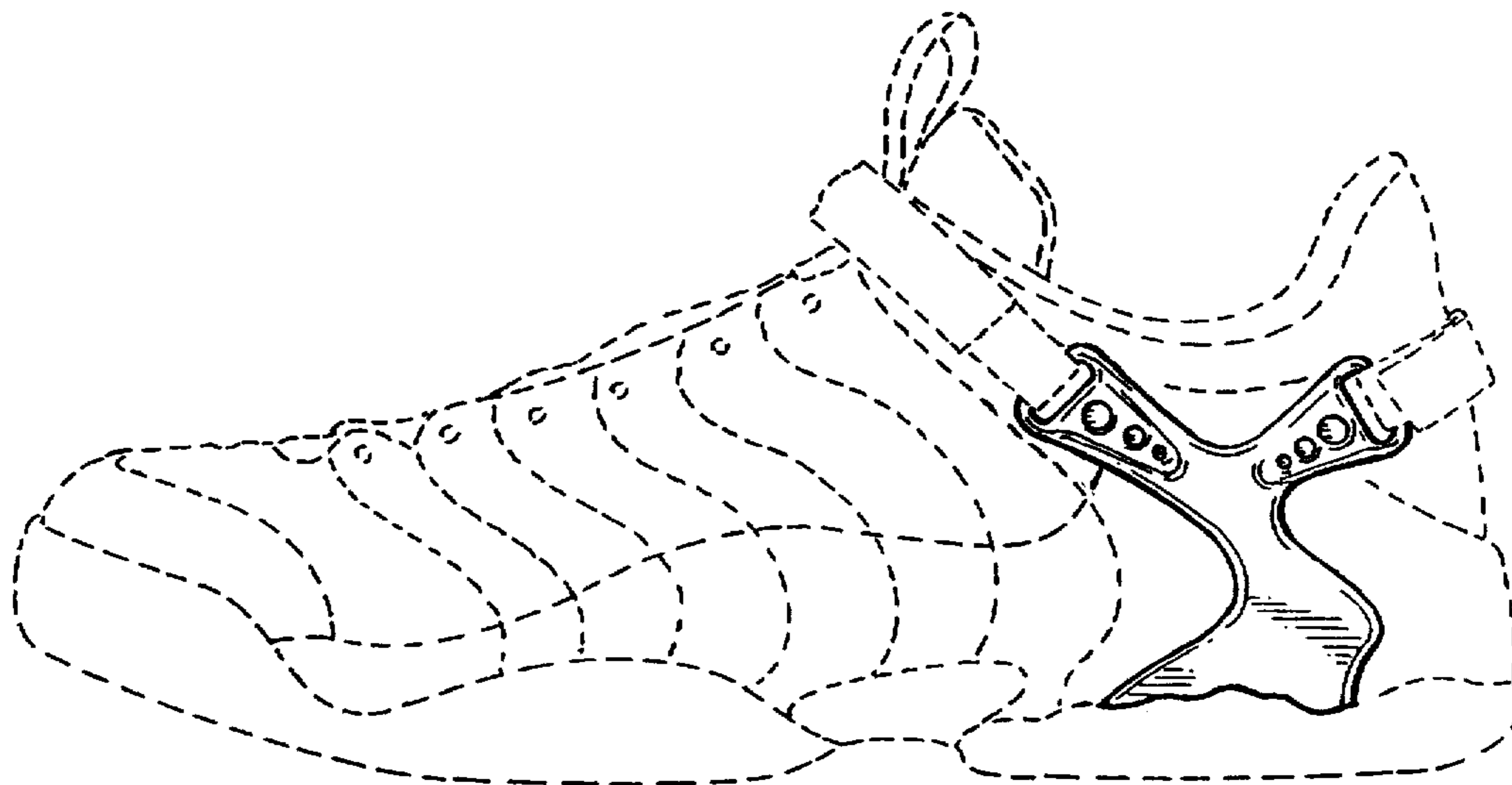
FIG. 2 is a front elevational view thereof;

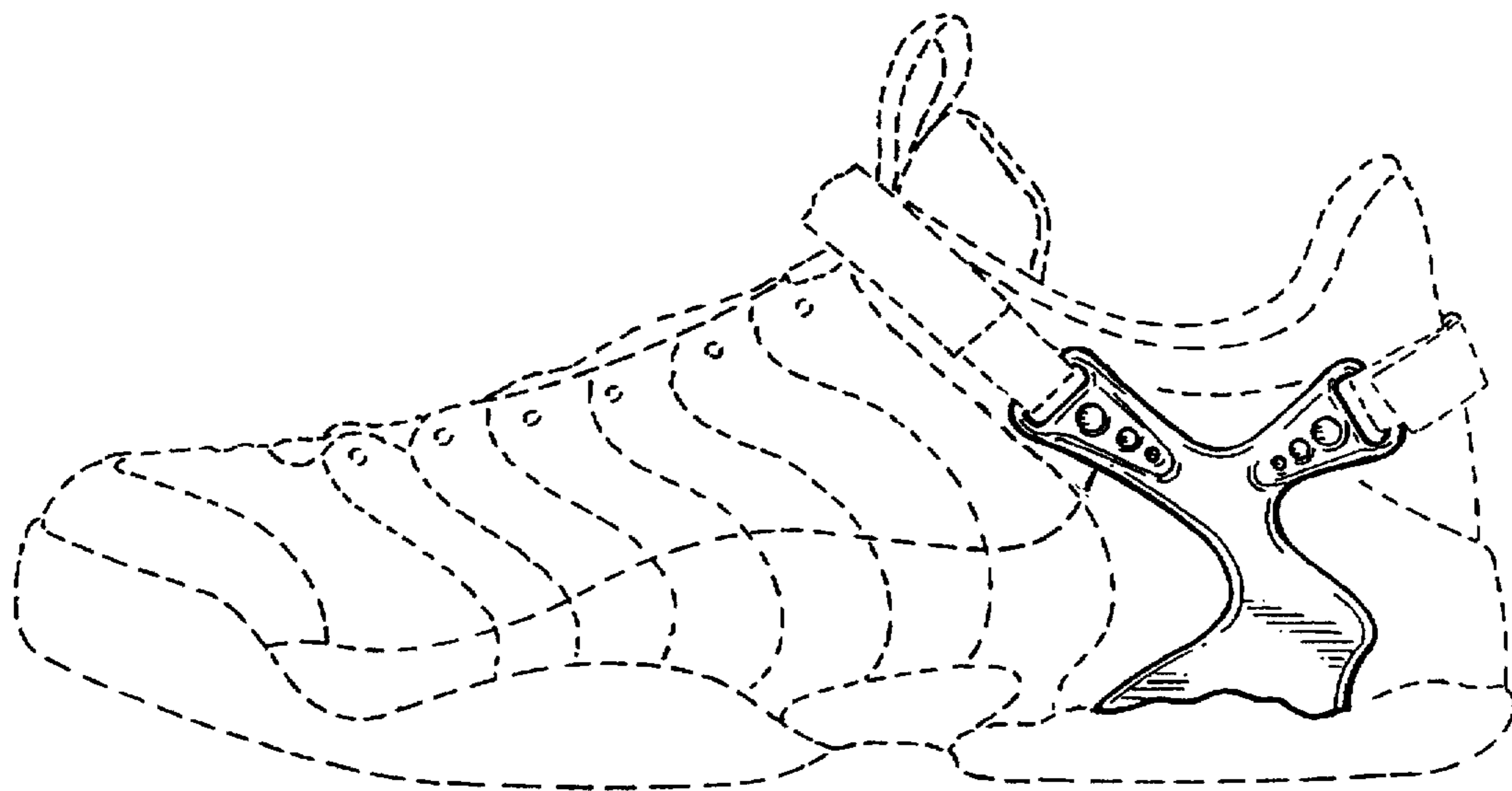

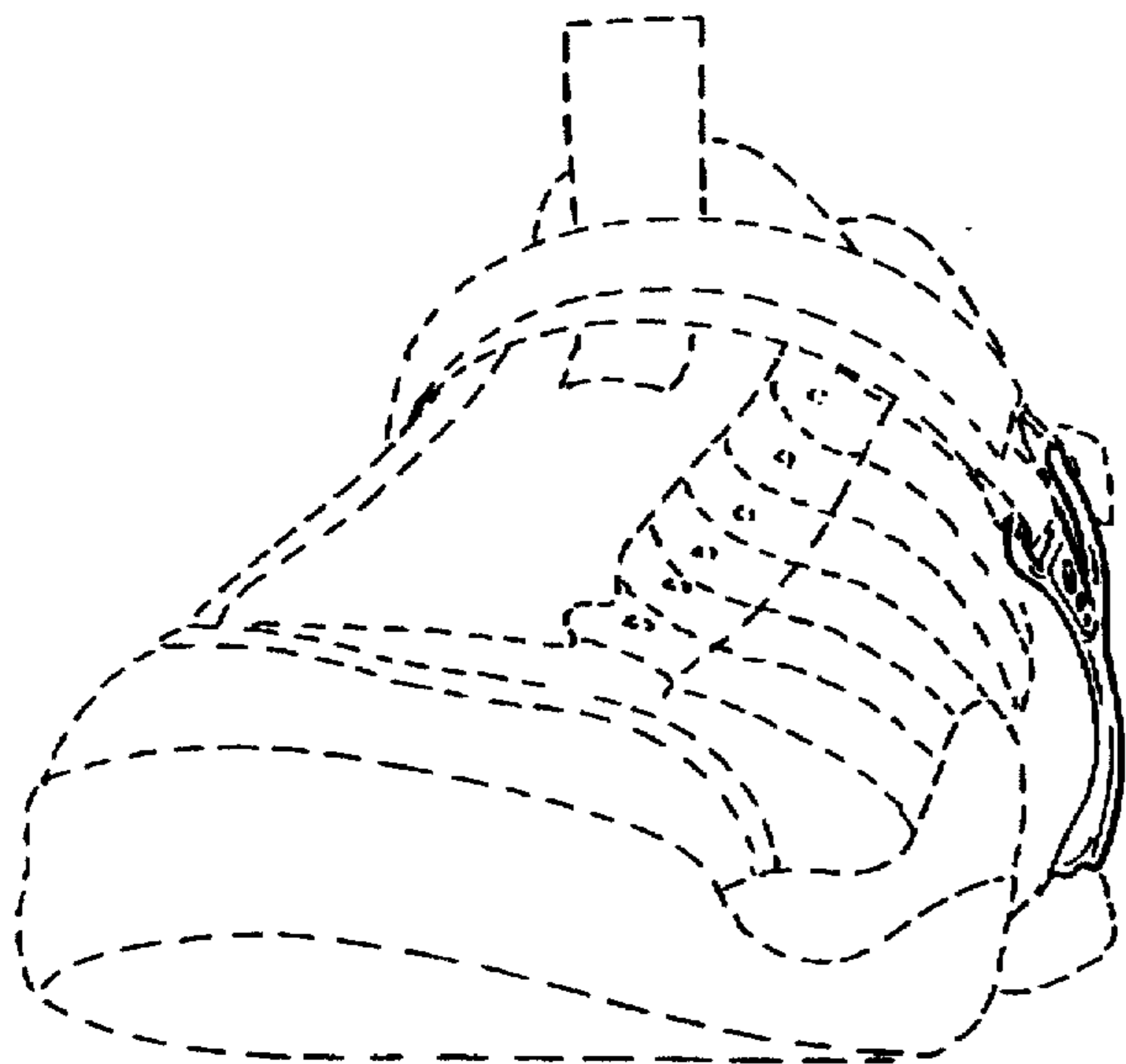

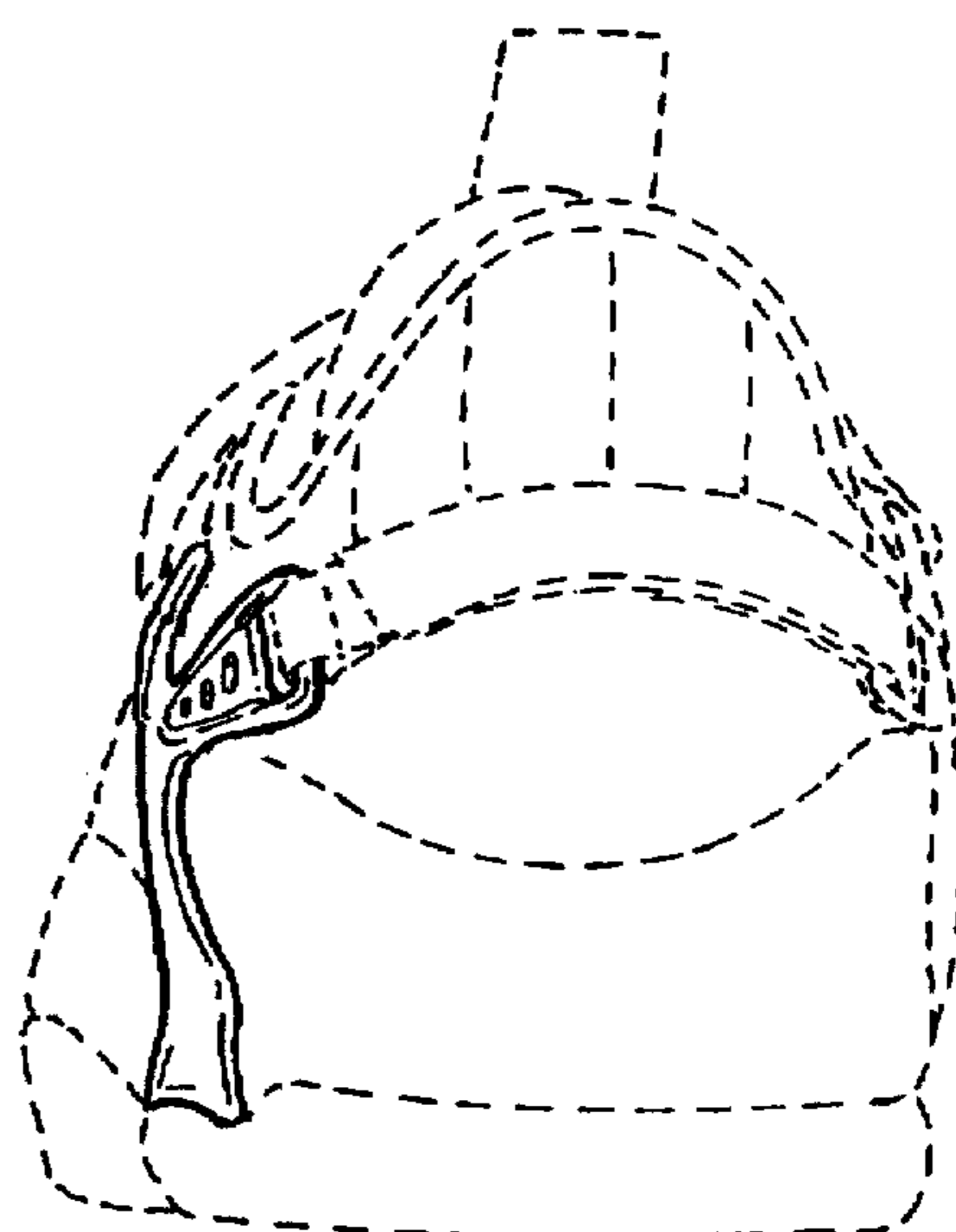

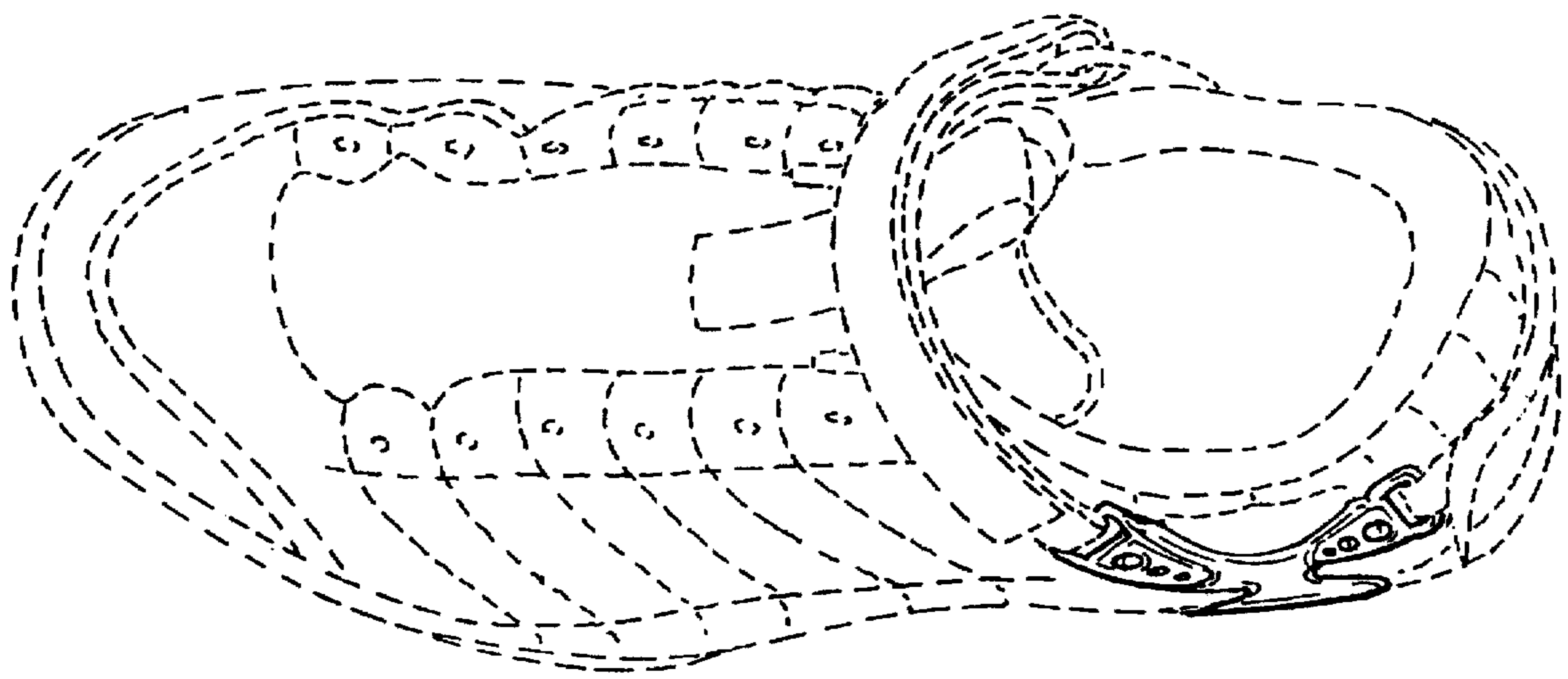
