The ornamental design for a door pull with tapered flange,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a door pull with tapered  
flange showing my new design;  
FIG. 2 is a front elevational view thereof, with the rear  
elevational view being a mirror image thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side elevational view, with the right side  
elevational view being a mirror image thereof; and,  
FIG. 6 is a bottom plan view thereof.

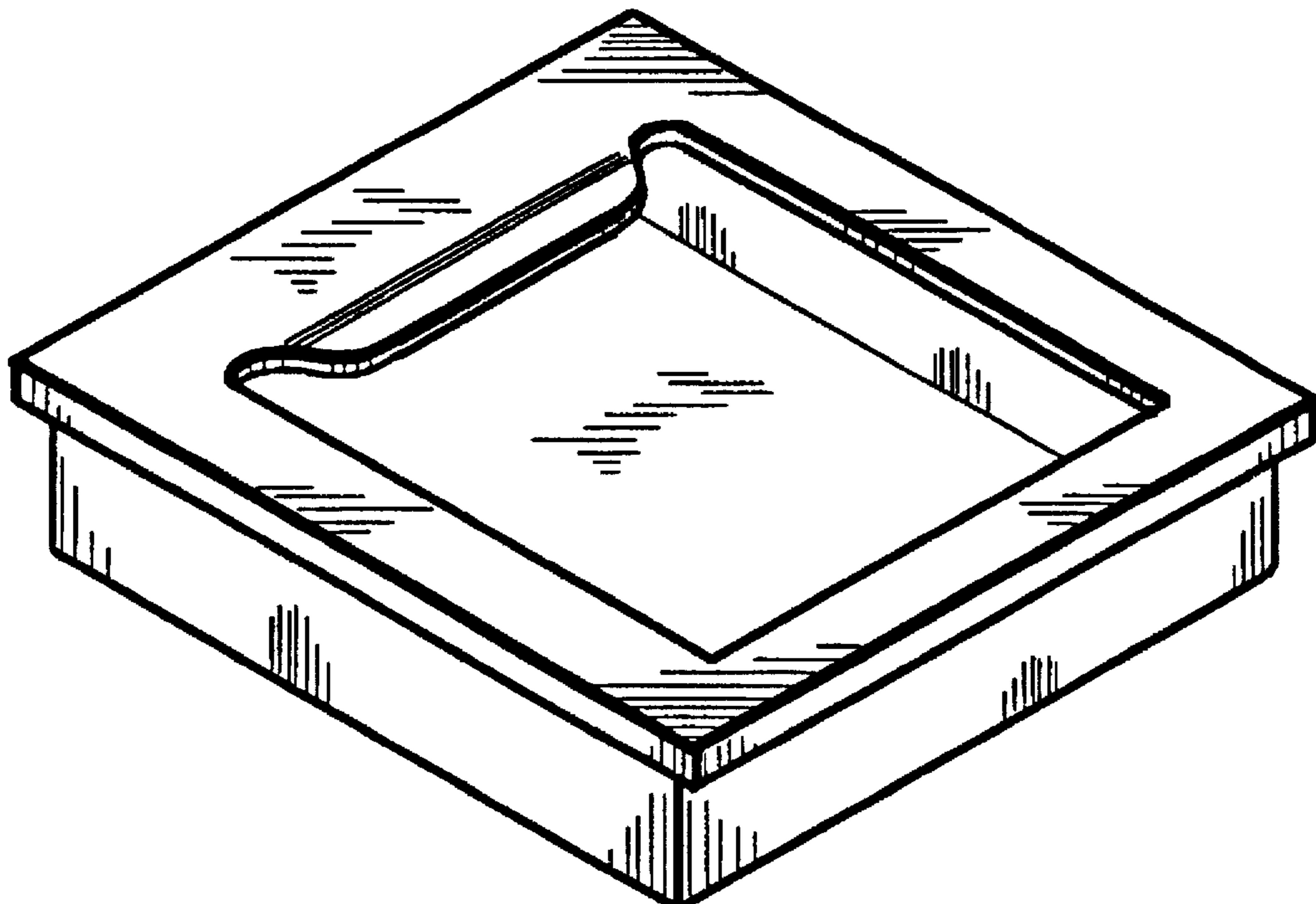

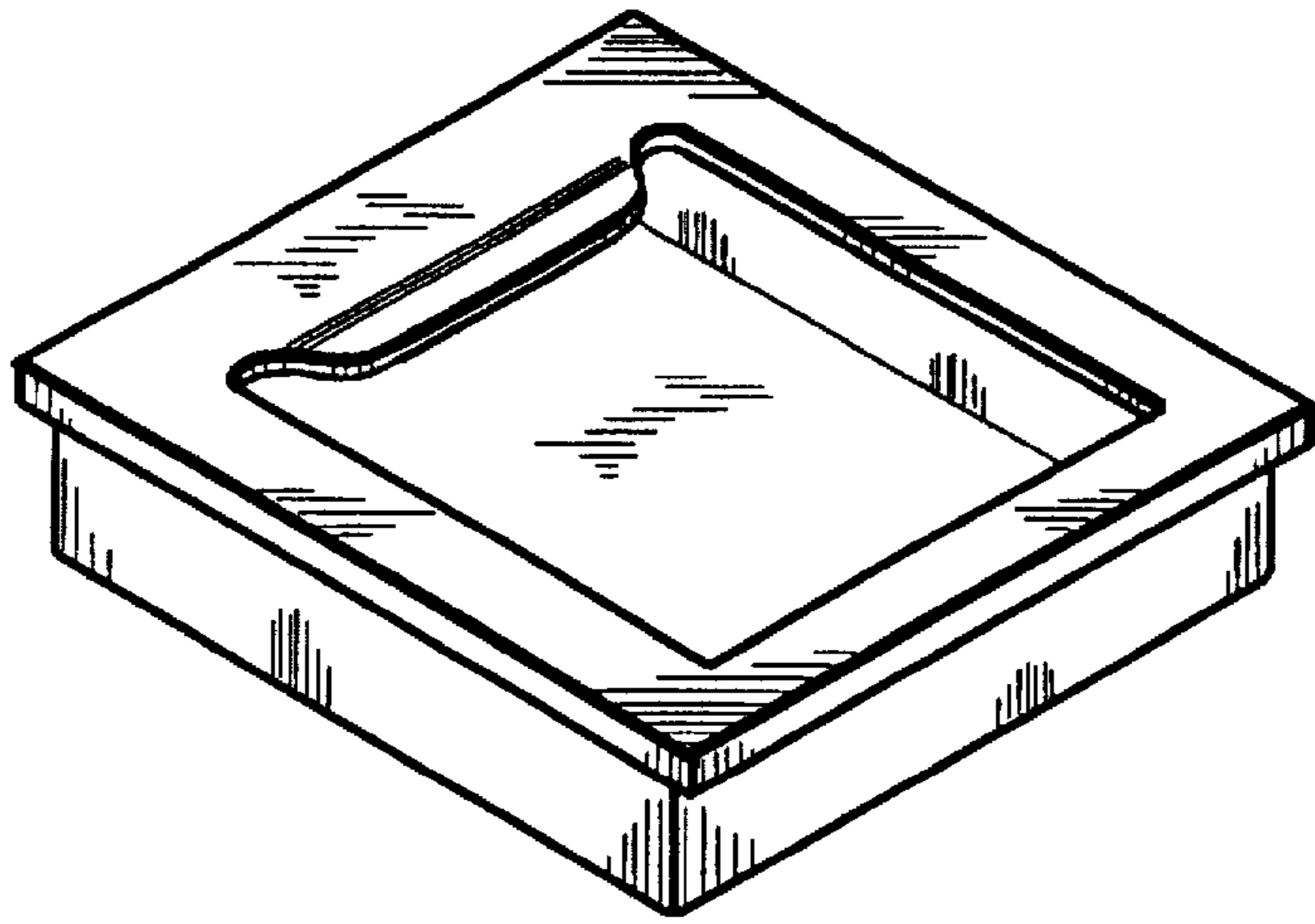

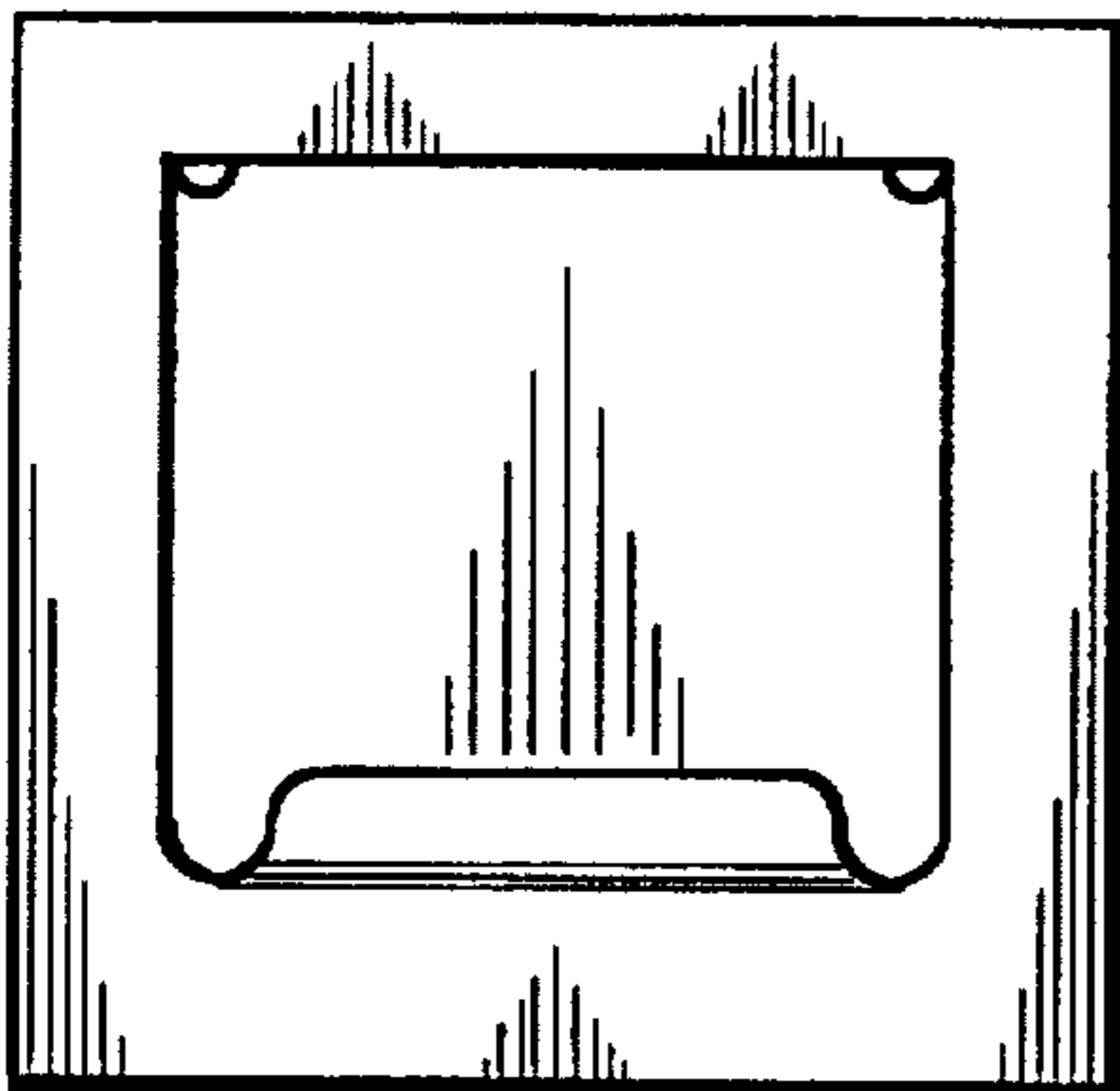

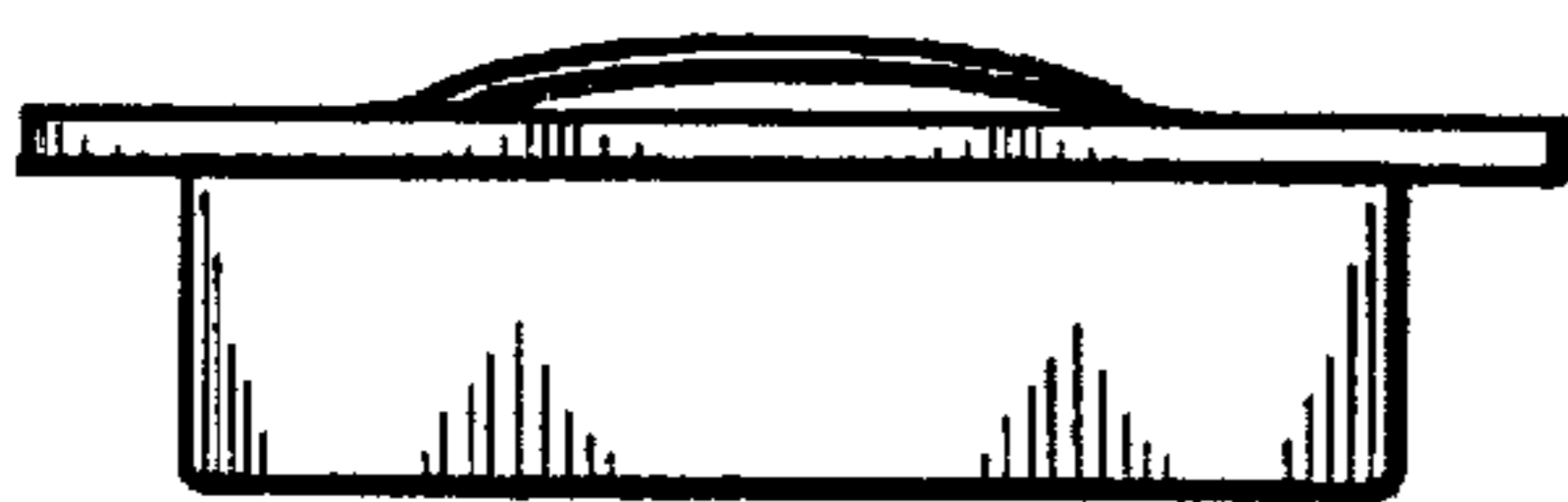

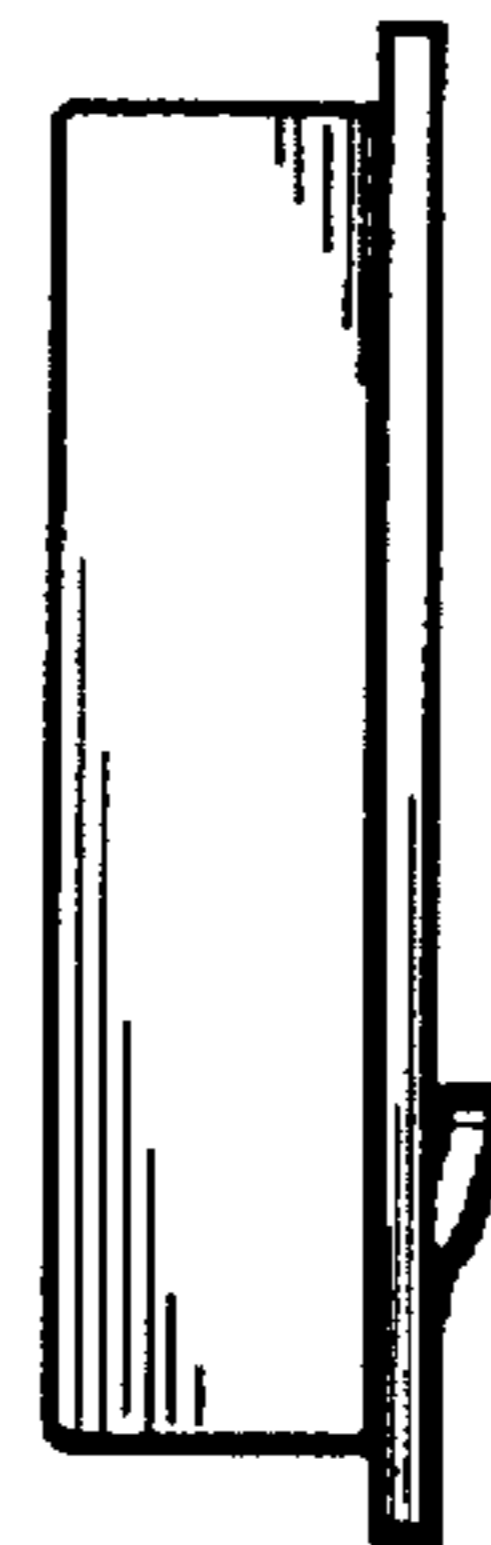
