[57] CLAIM

The ornamental design for a portion of a screen of a programmed computer system or programmed facsimile machine, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a portion of a screen of a programmed computer system or a programmed facsimile machine showing a first embodiment of our new design;

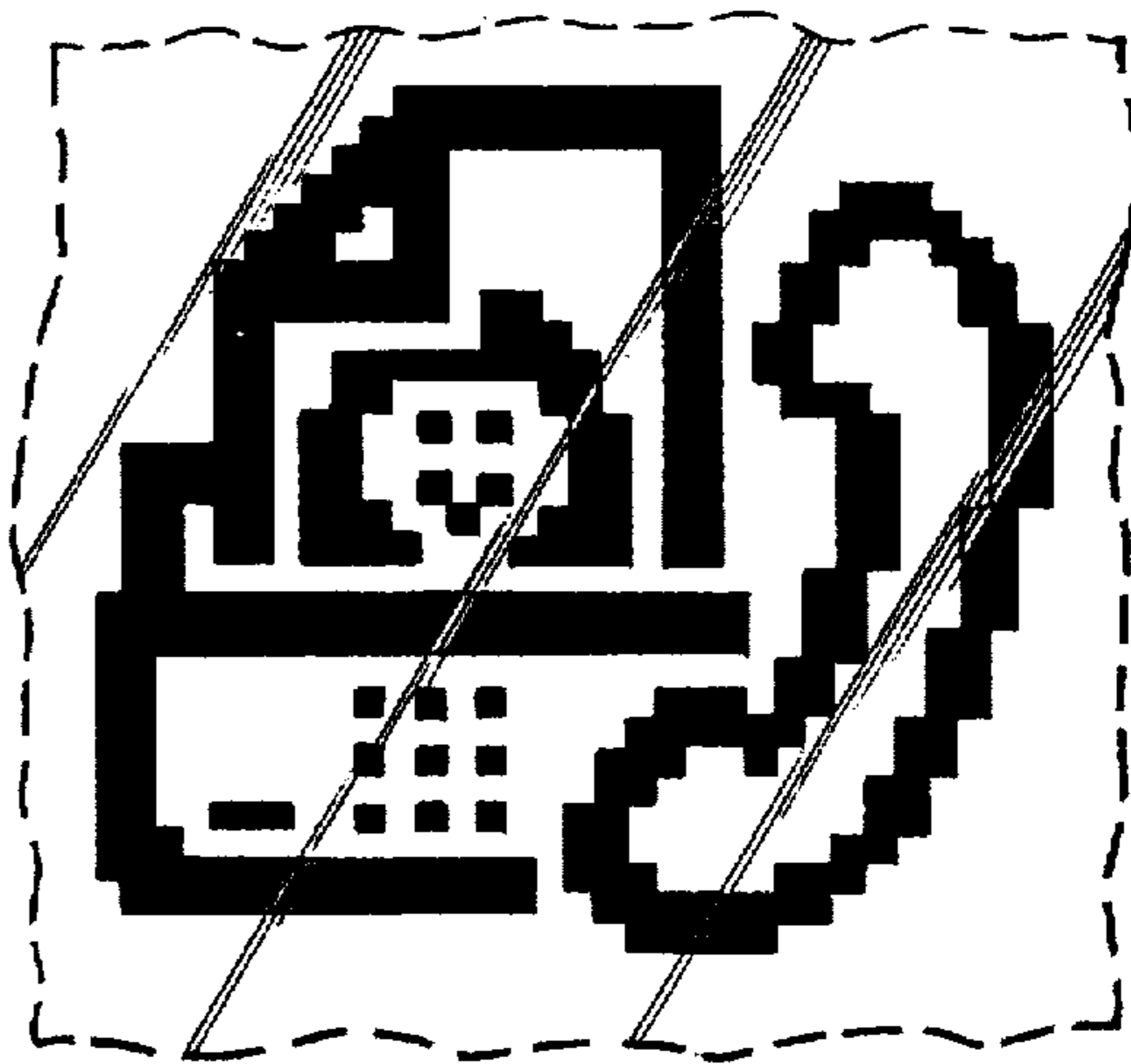
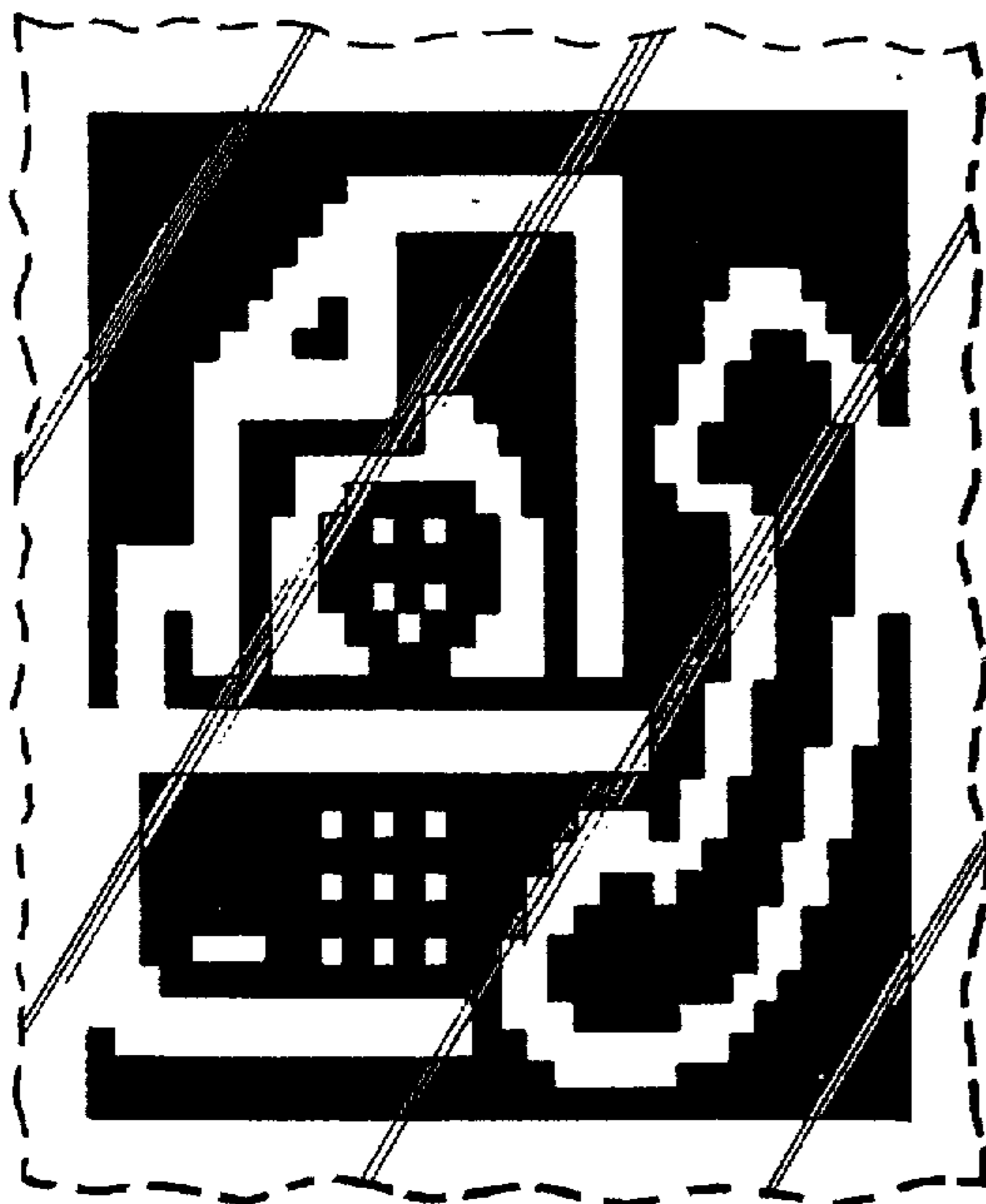
FIG. 2 is a front elevational view of a second embodiment thereof;

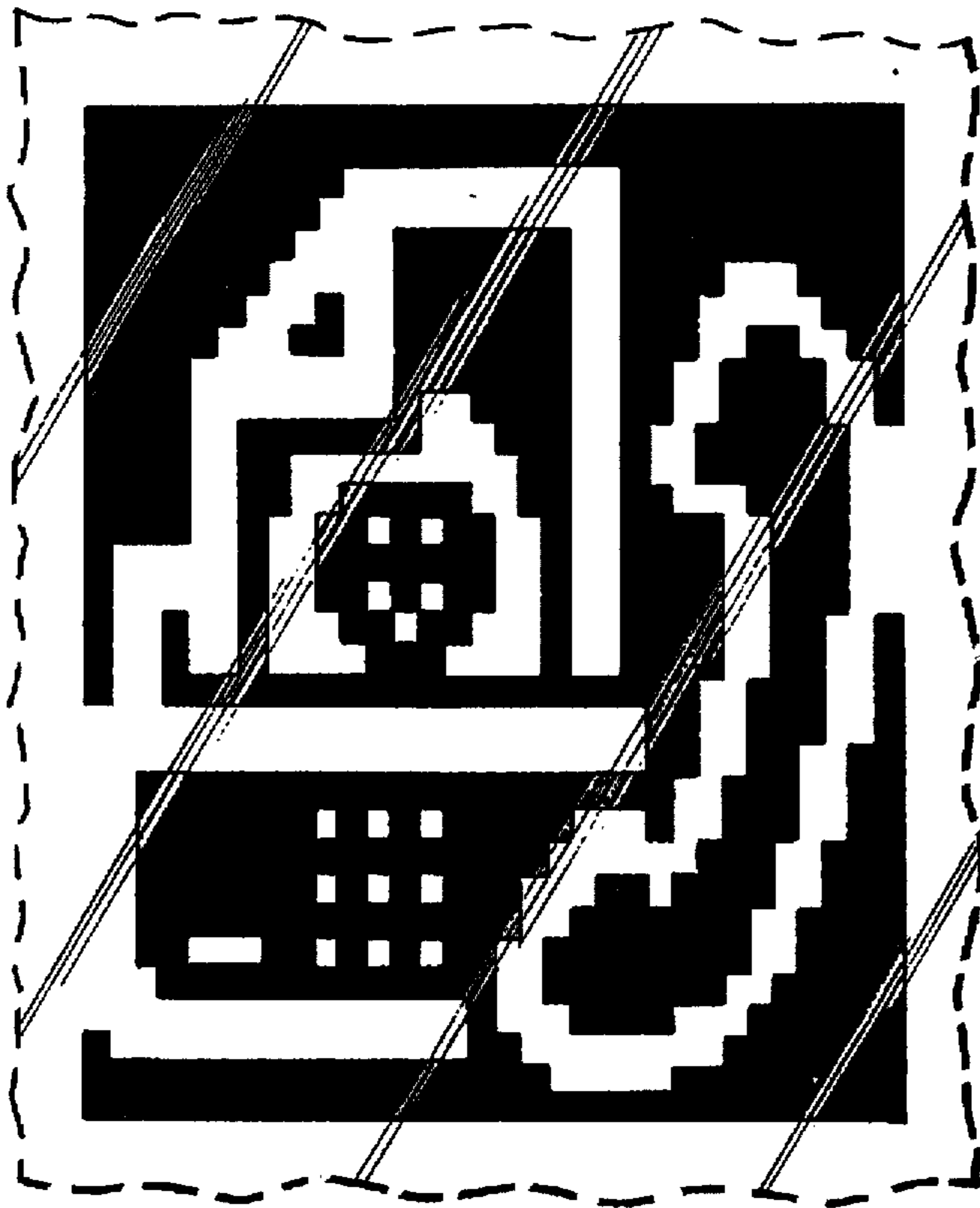

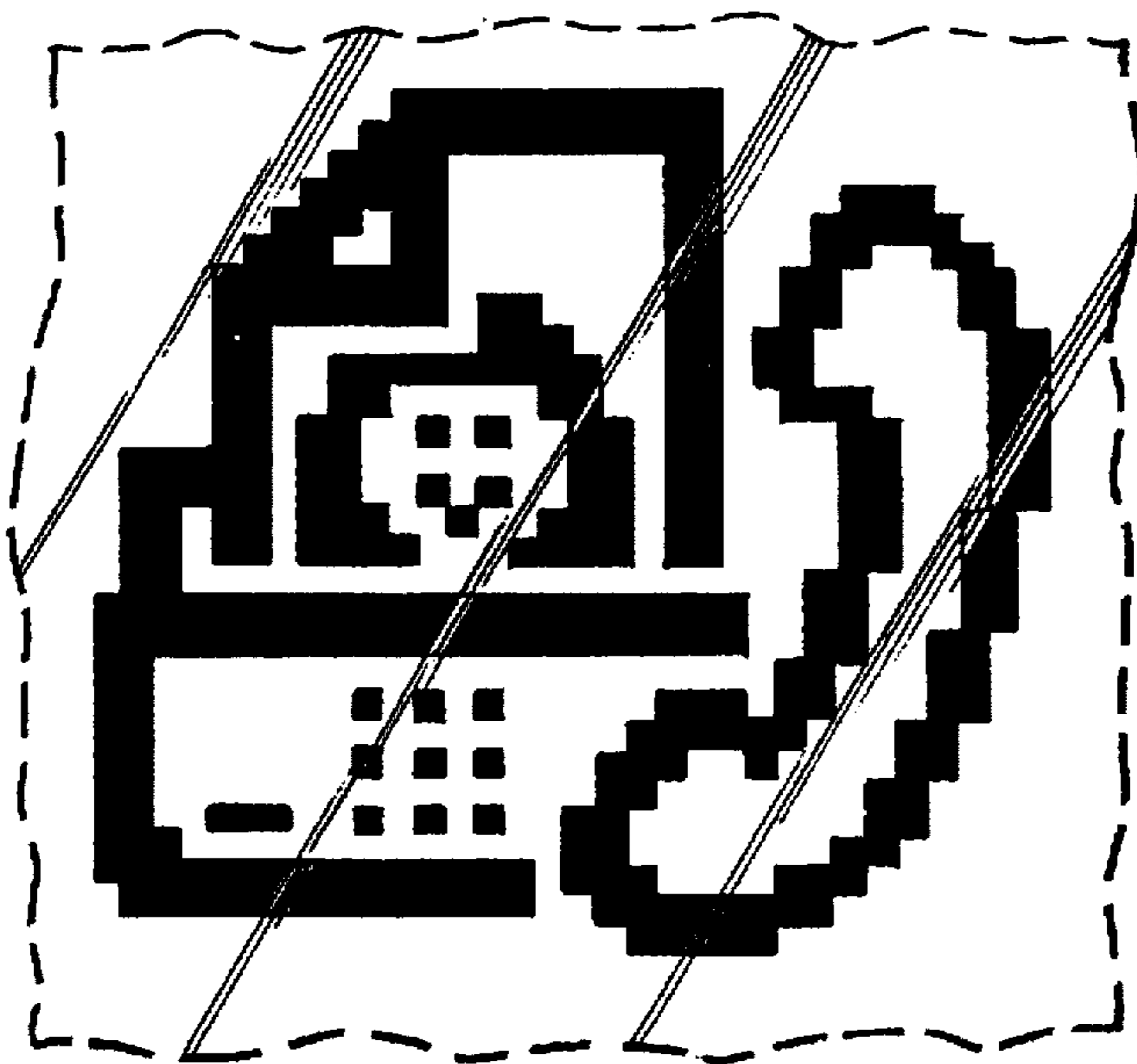

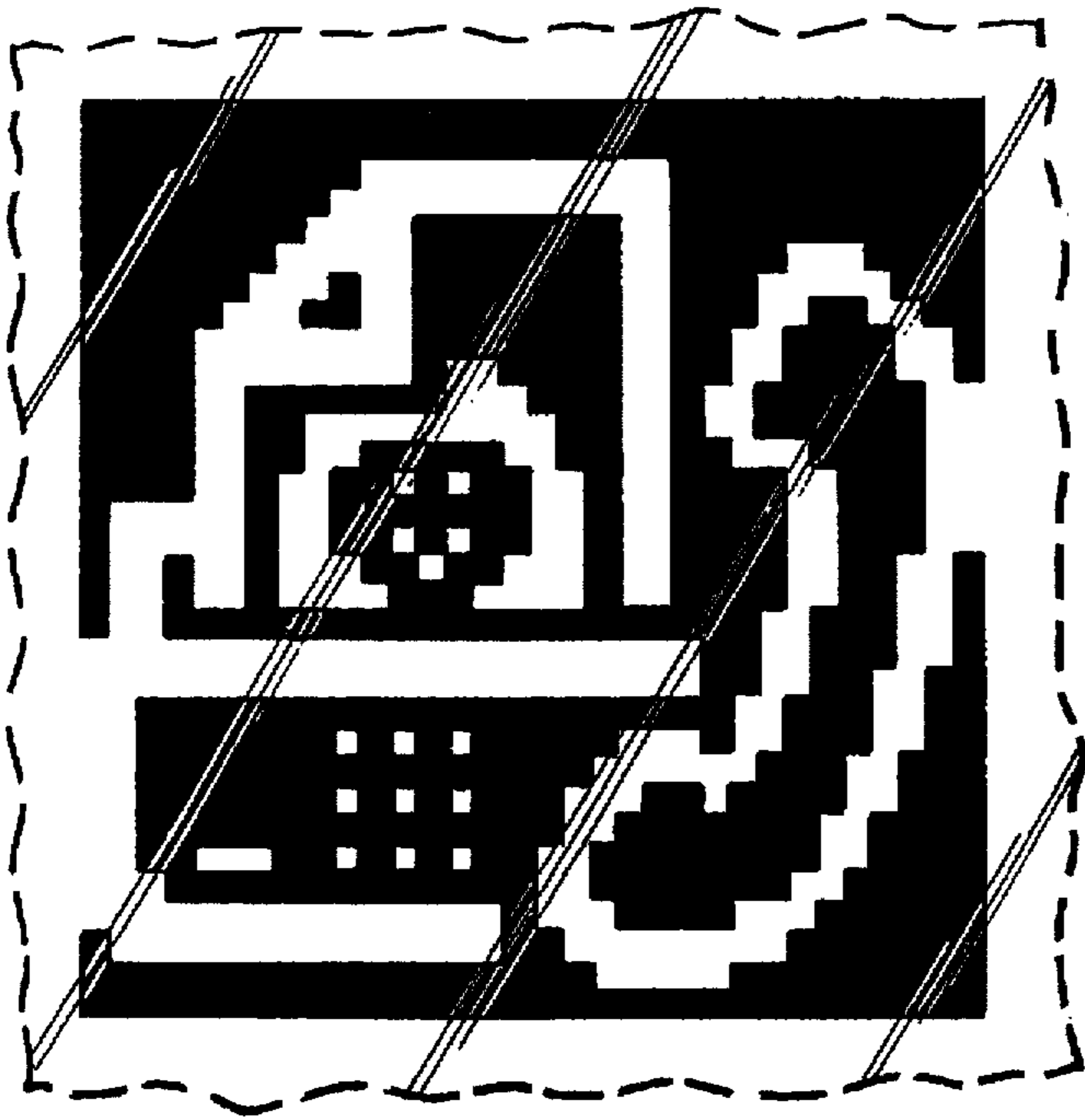

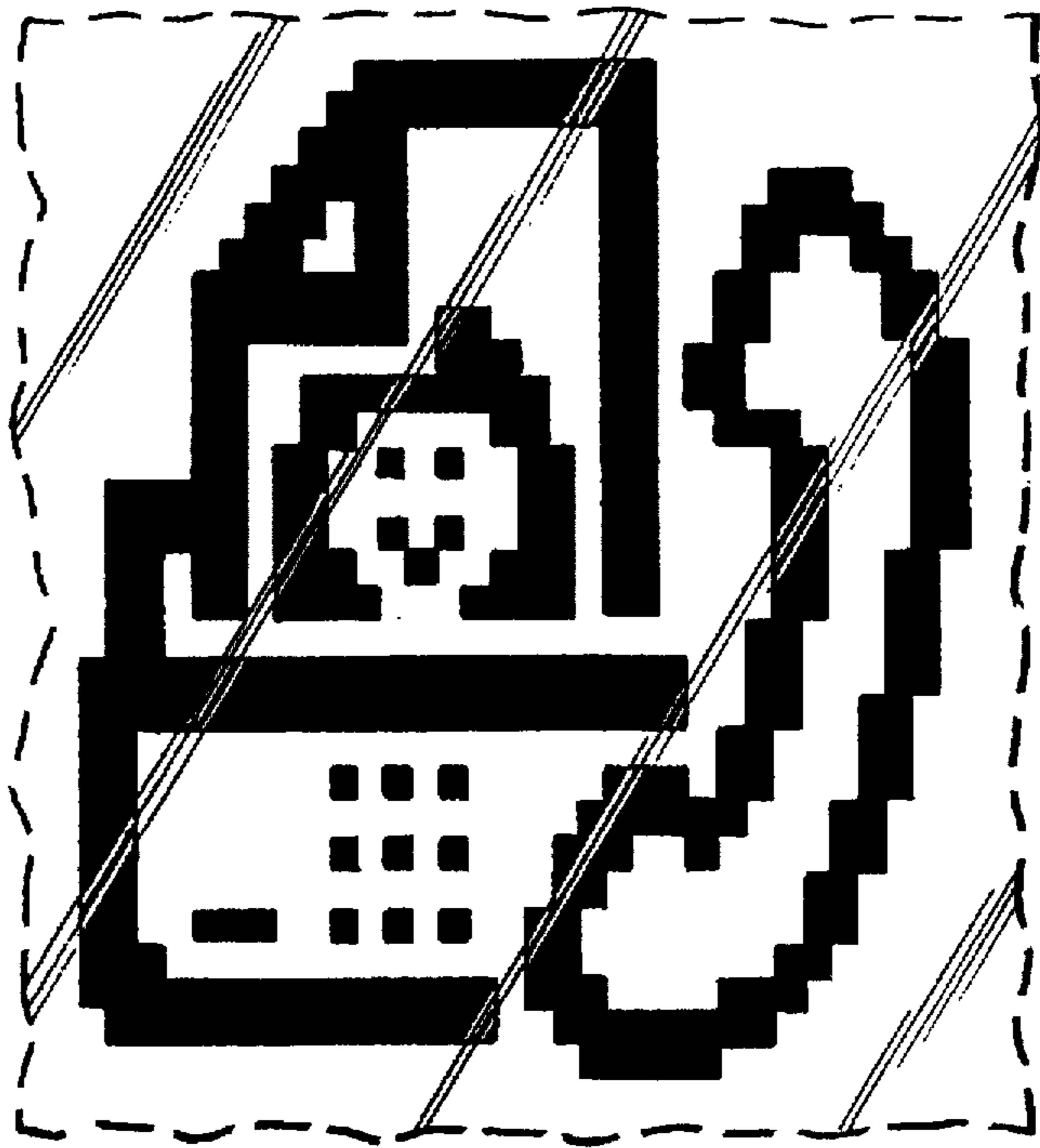
