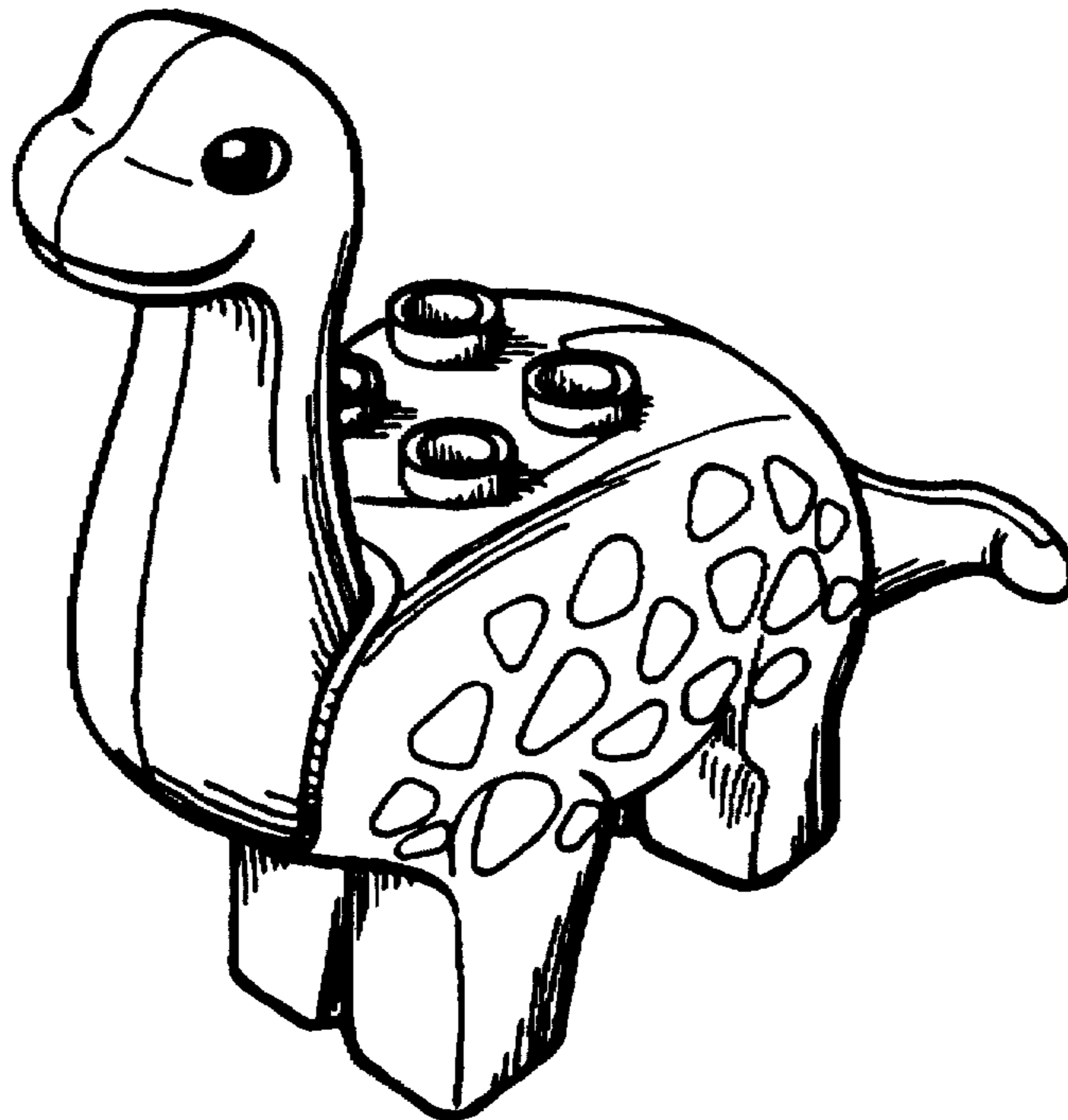
[57] **CLAIM**

The ornamental design for a toy animal, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of the toy animal in one position; FIG. 2 is a top perspective view of the toy animal in another position; FIG. 3 is a bottom perspective view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a rear elevational view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is a top plan view thereof.

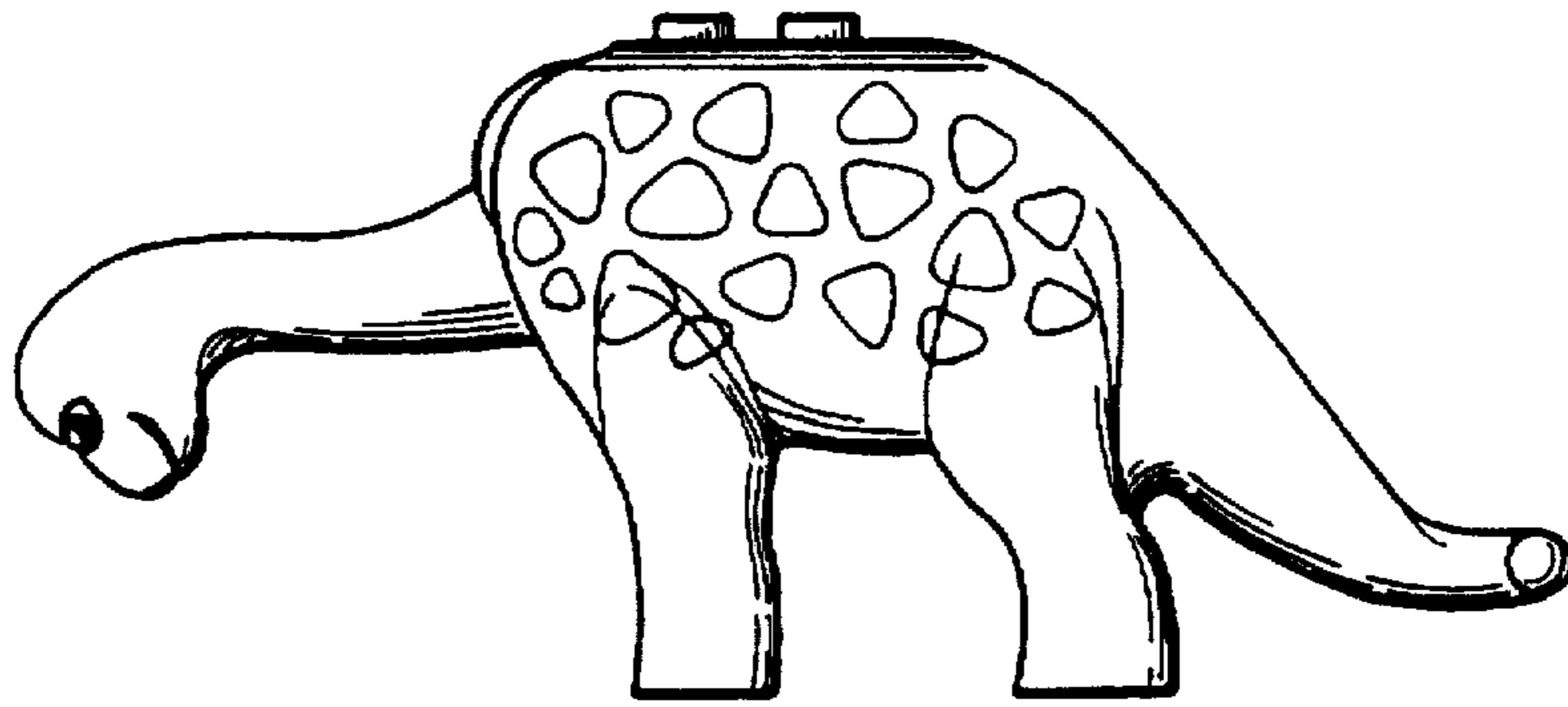

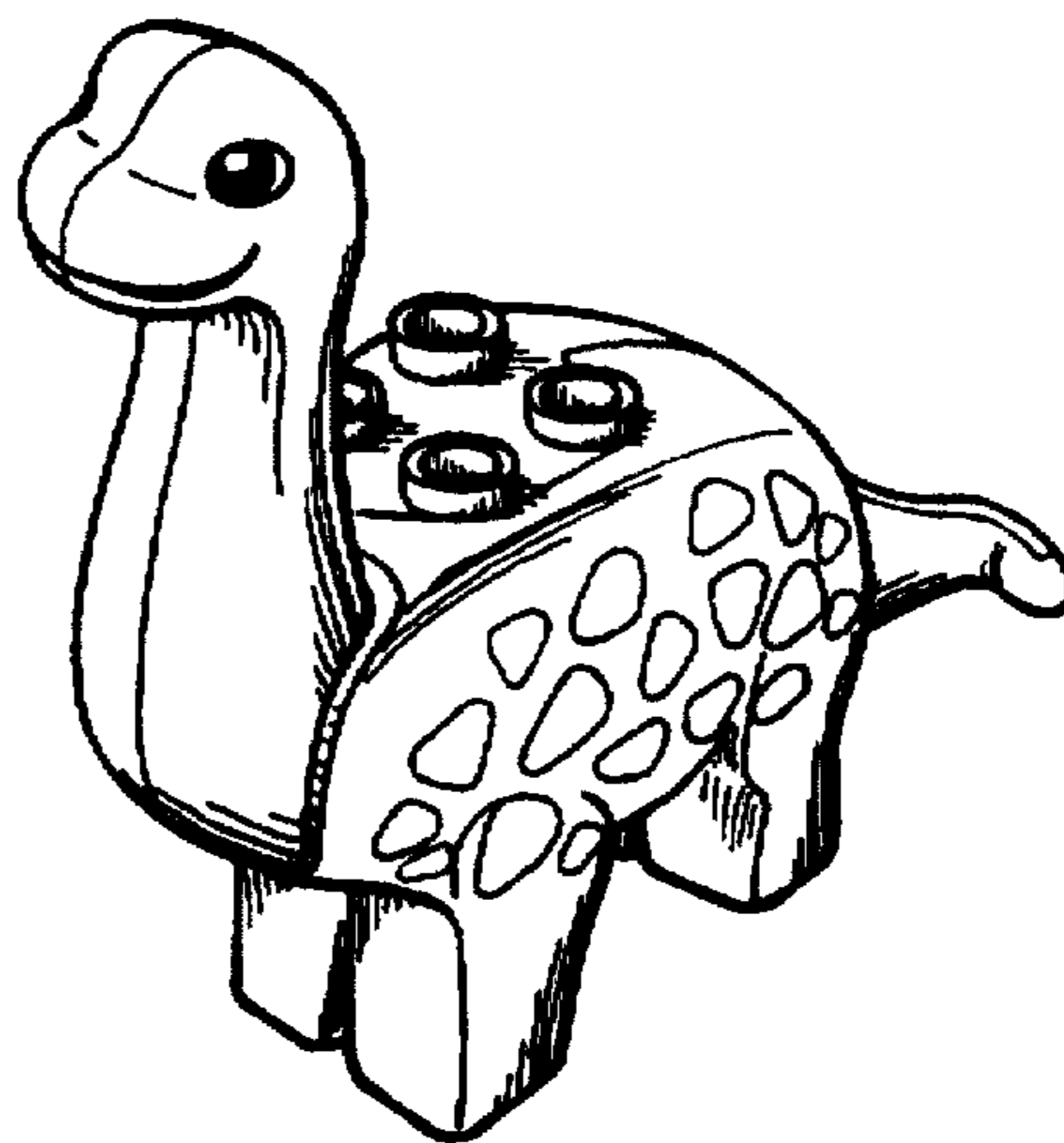

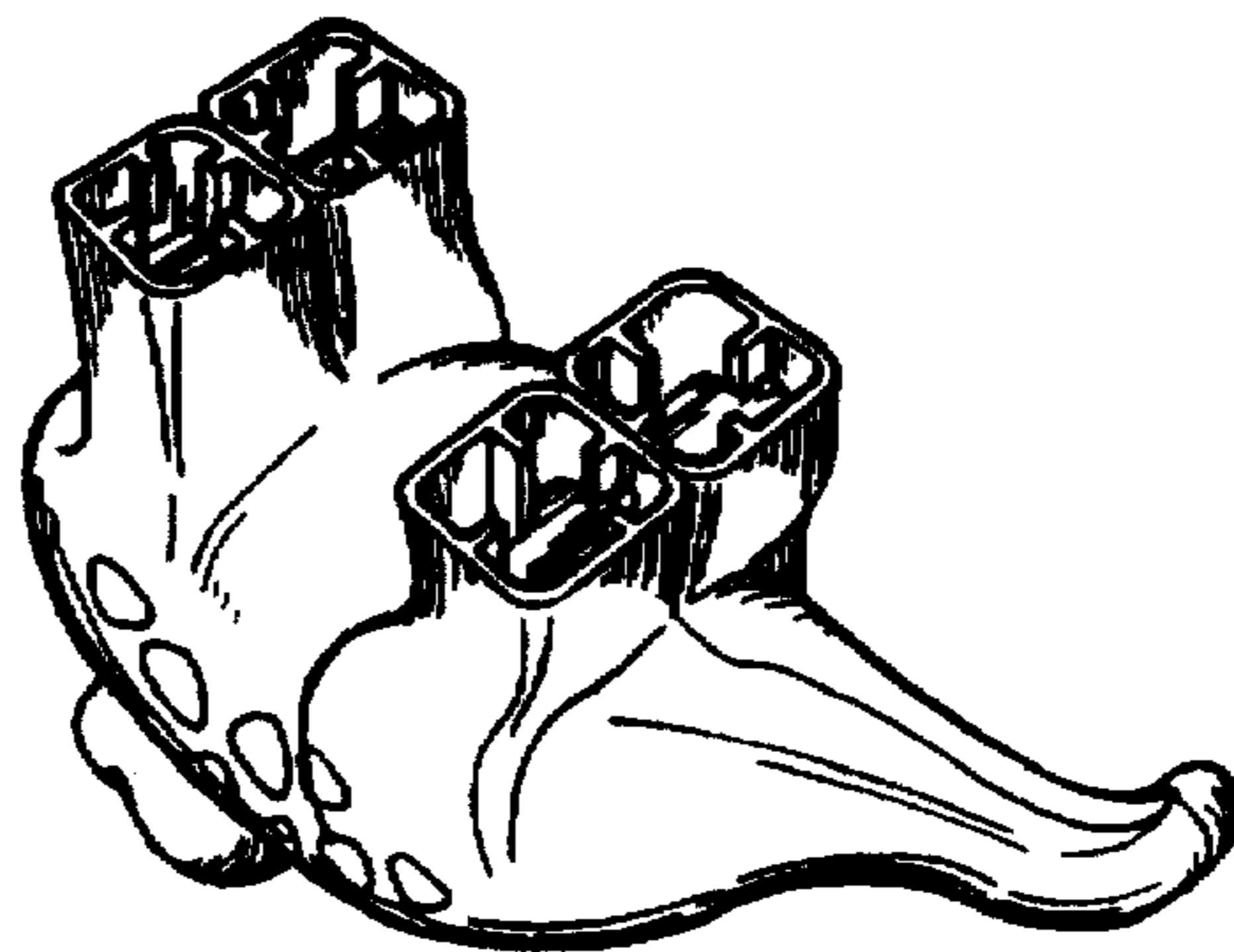

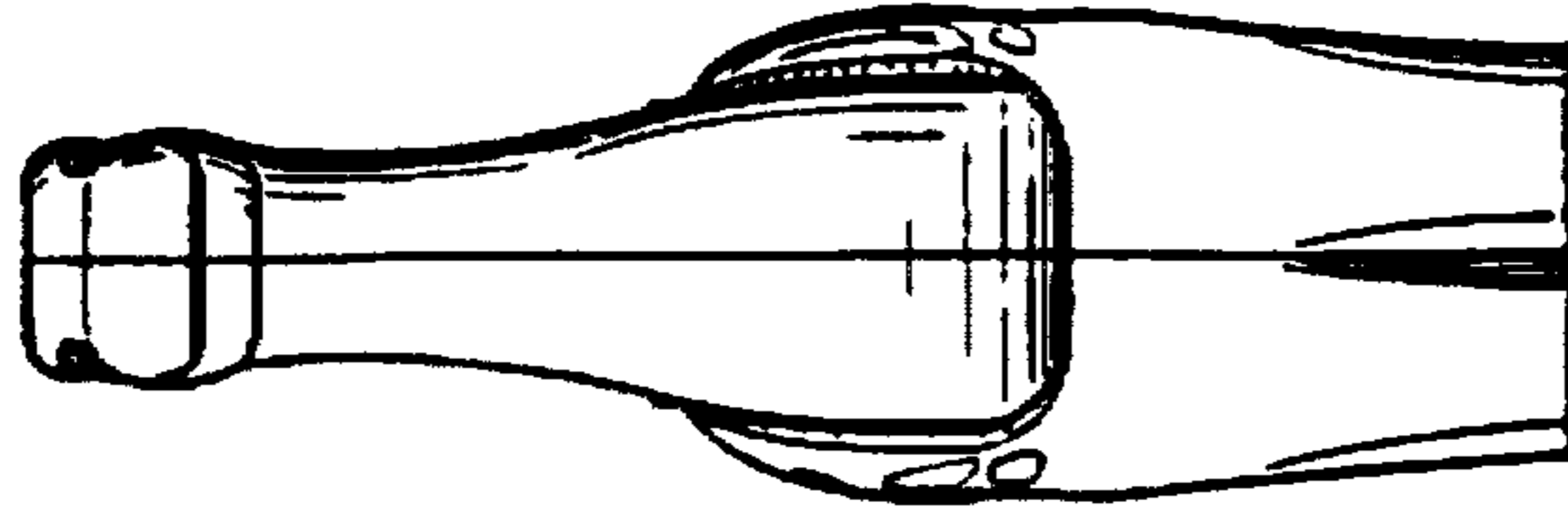

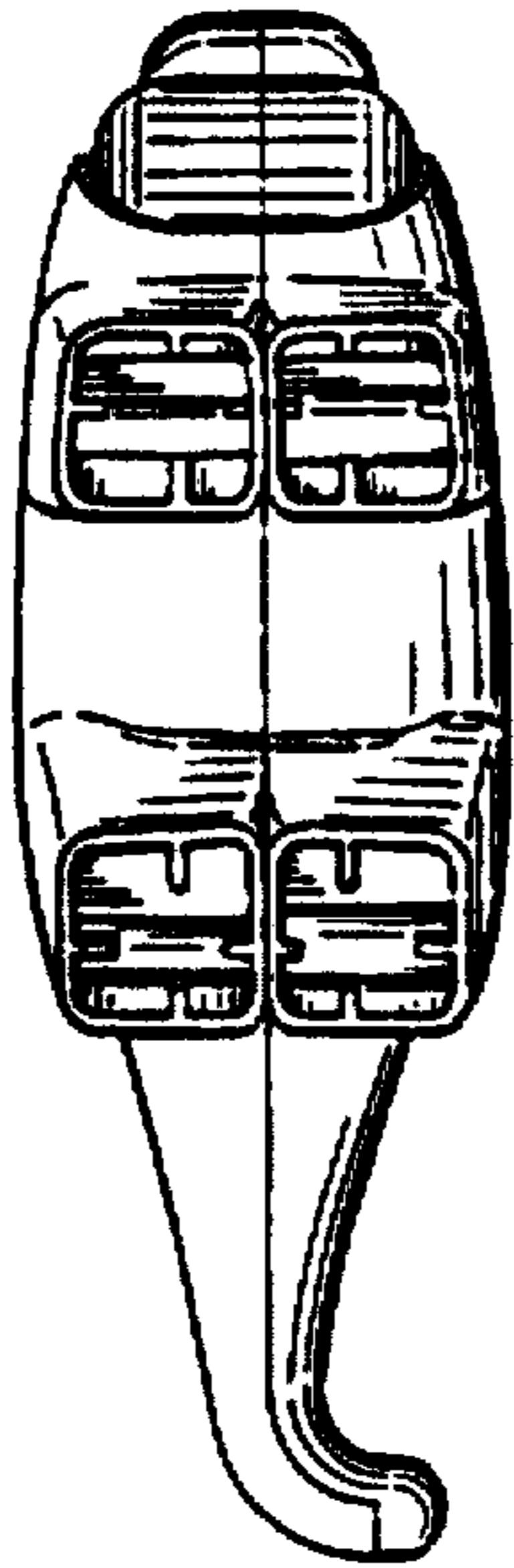

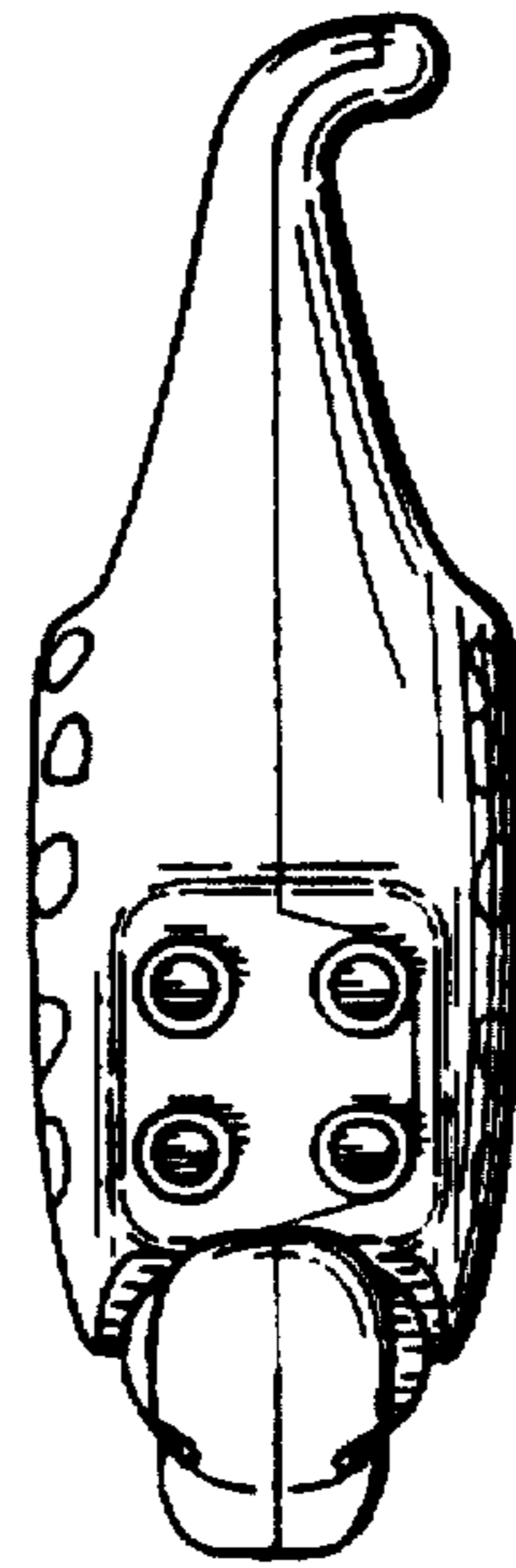

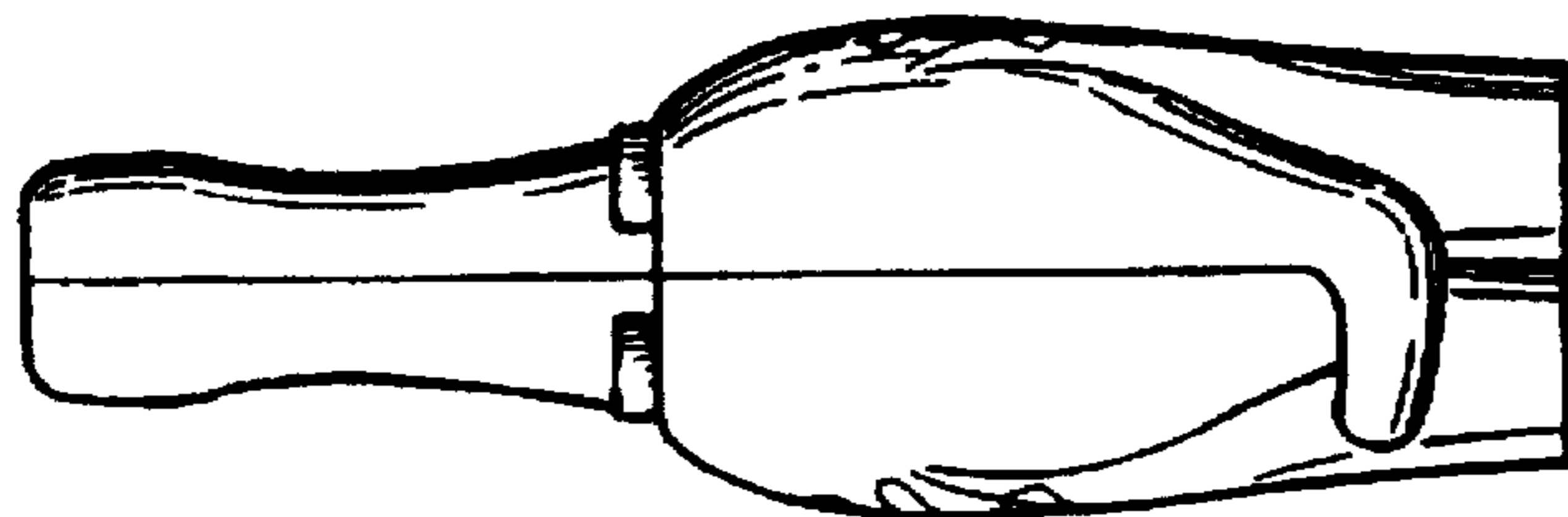

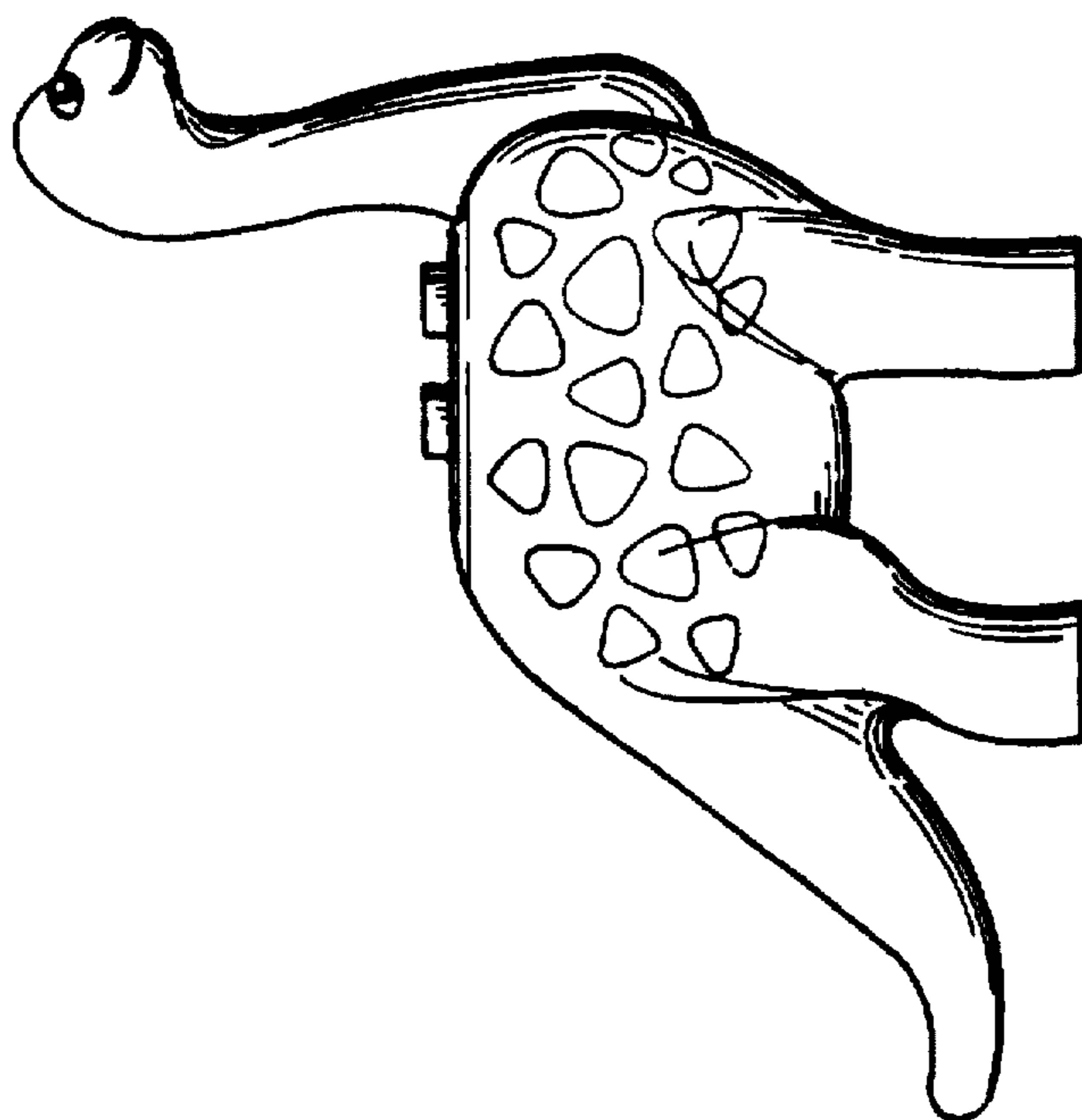

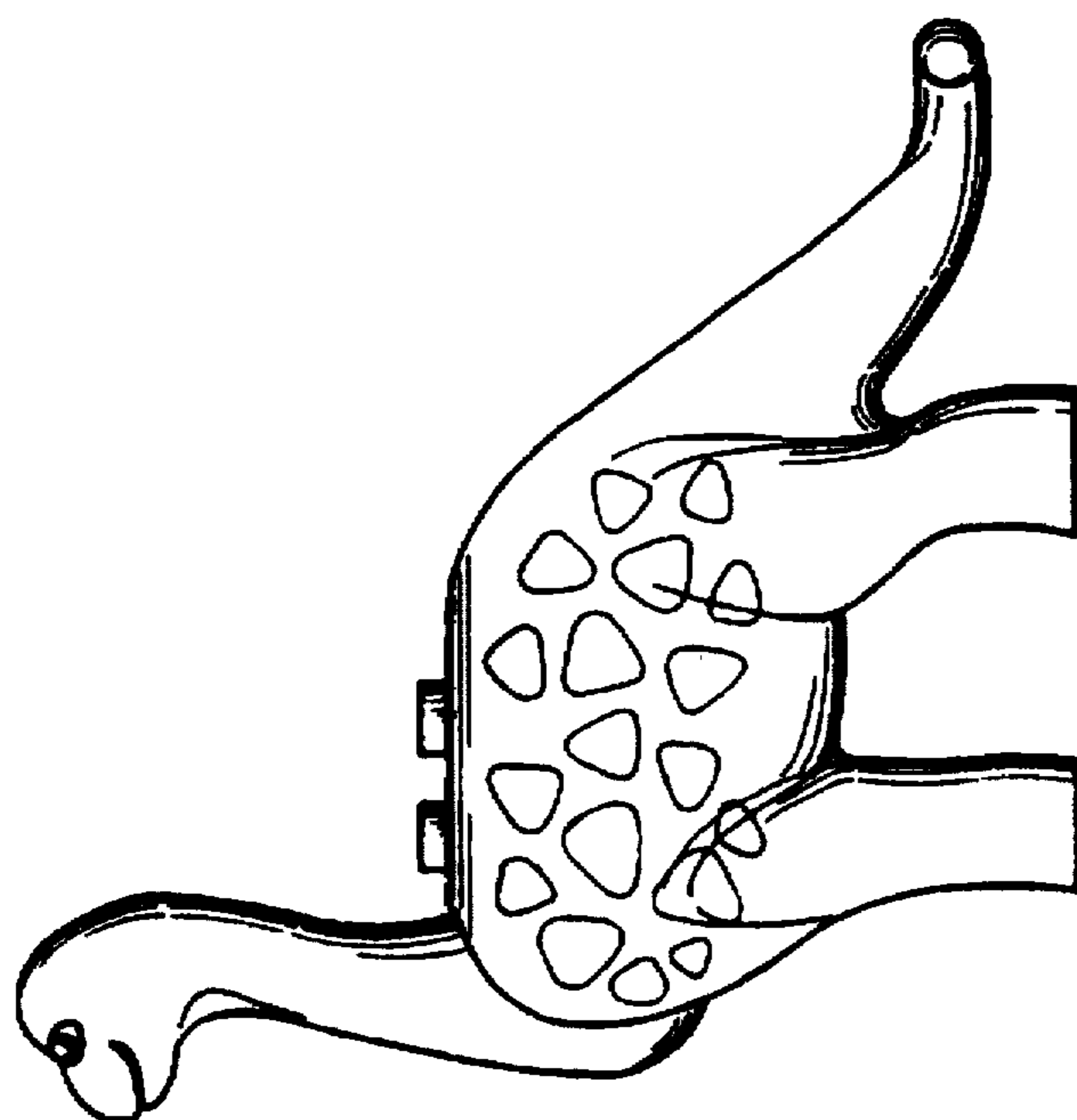
