The ornamental design for a stylized miniature helmet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of the stylized miniature helmet;

FIG. 17 is a front elevation view of the stylized miniature helmet seen in FIG. 15;




FIG. 18 is a left elevation view of the stylized miniature helmet seen in FIG. 15;










































