### [57] CLAIM

The ornamental design for a sanitary napkin, as shown and described.

### DESCRIPTION

FIG. 1 is a top plan view of a sanitary napkin embodying our design;  
FIG. 2 is a right side view thereof, the left side view being a mirror image in appearance;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a front view thereof; and,  
FIG. 5 is a back view thereof.

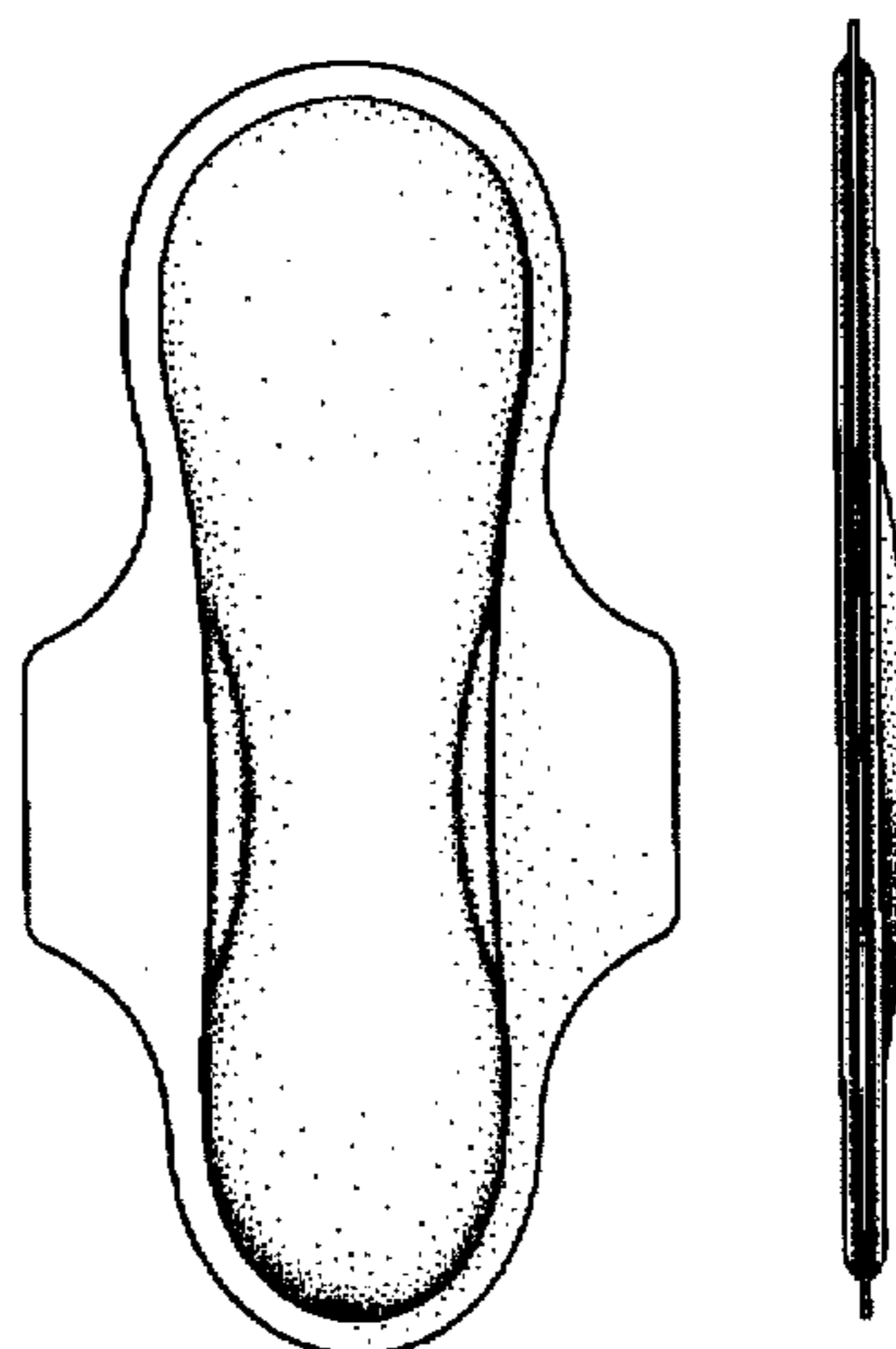

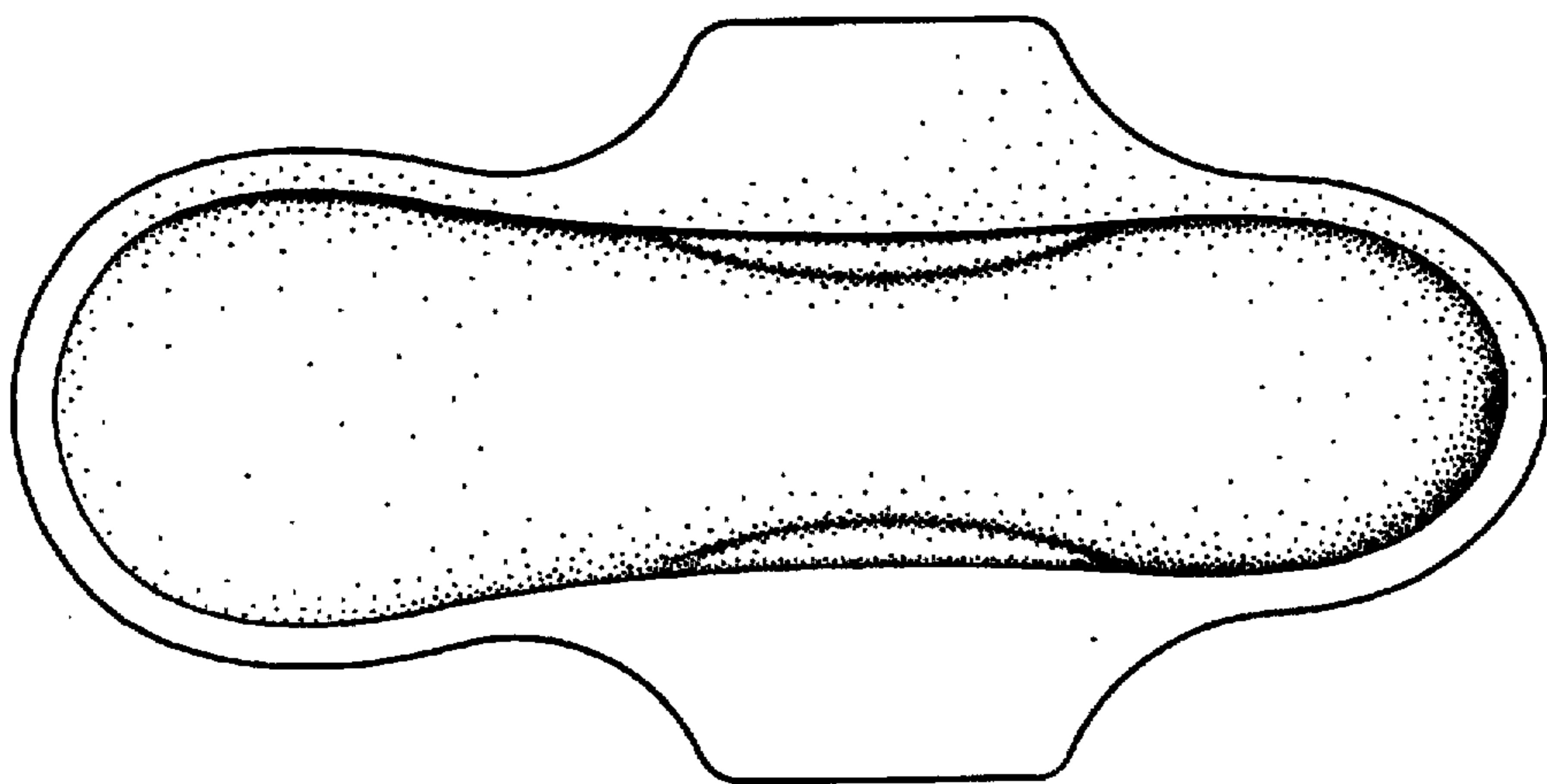

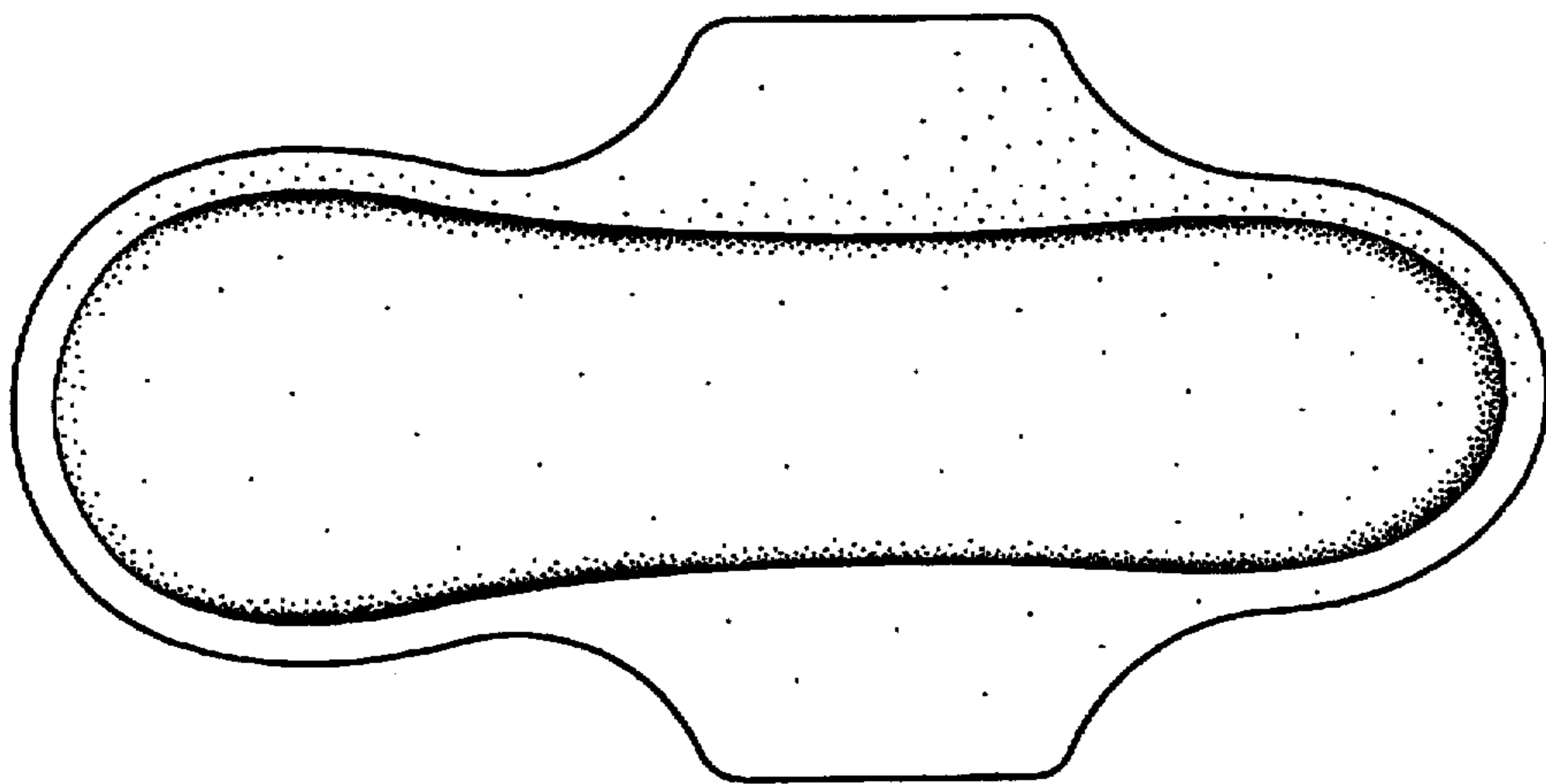
