The ornamental design for a hand bag, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and side perspective view of a hand bag, showing my new design;
FIG. 2 is a top view thereof;

FIG. 4 is a rear elevational view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a side elevational view thereof, with the opposite side being a mirror image thereof;

FIG. 8 is a top view thereof;
FIG. 9 is a front elevational view thereof;
FIG. 10 is a rear elevational view thereof;
FIG. 11 is a bottom view thereof;
FIG. 12 is a side elevational view thereof, with the opposite side being a mirror image thereof;
FIG. 13 is a top, front and side perspective view of a second variation of the hand bag of FIG. 1;
FIG. 14 is a top view thereof;

FIG. 16 is a rear elevational view thereof;

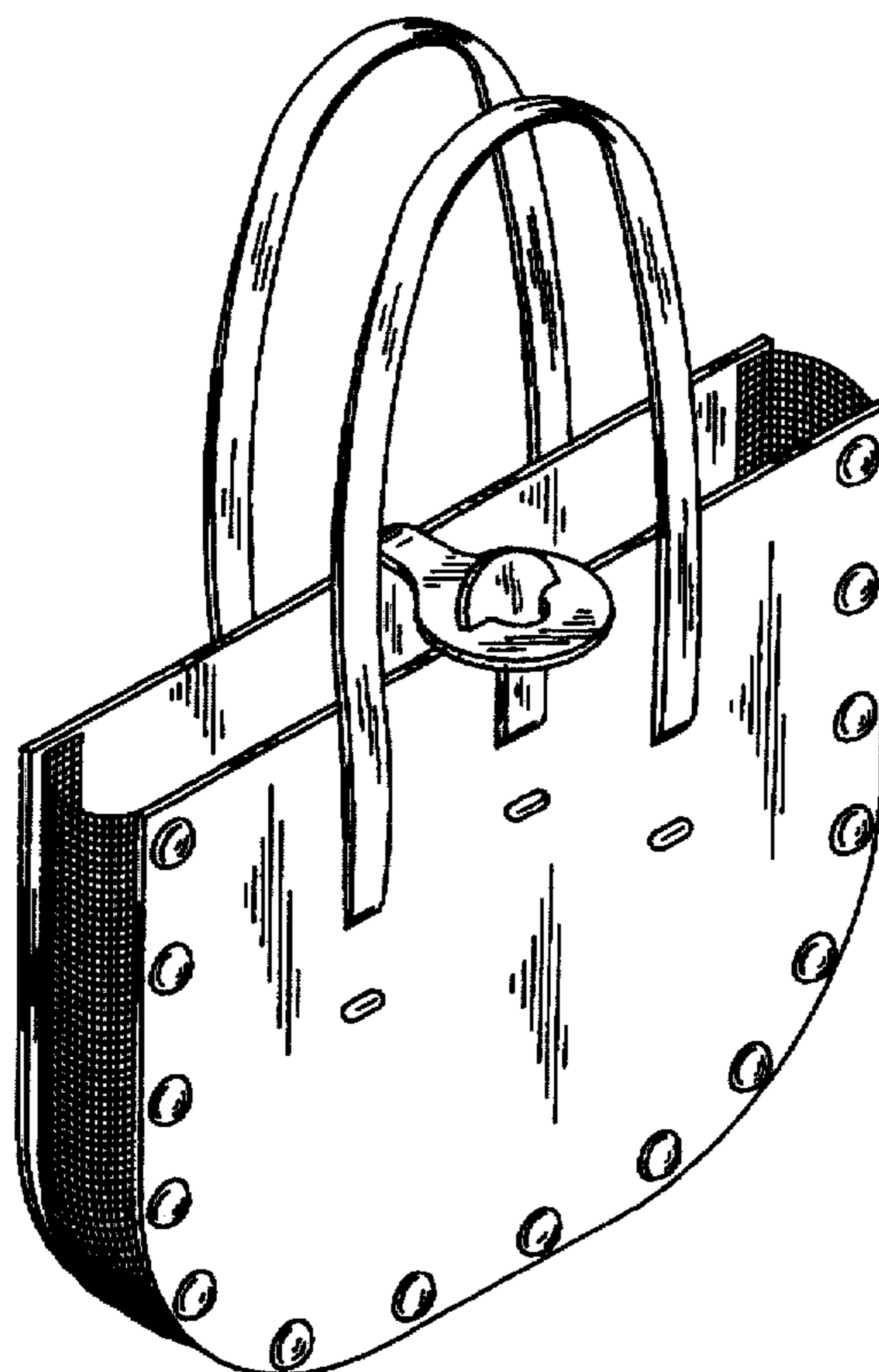

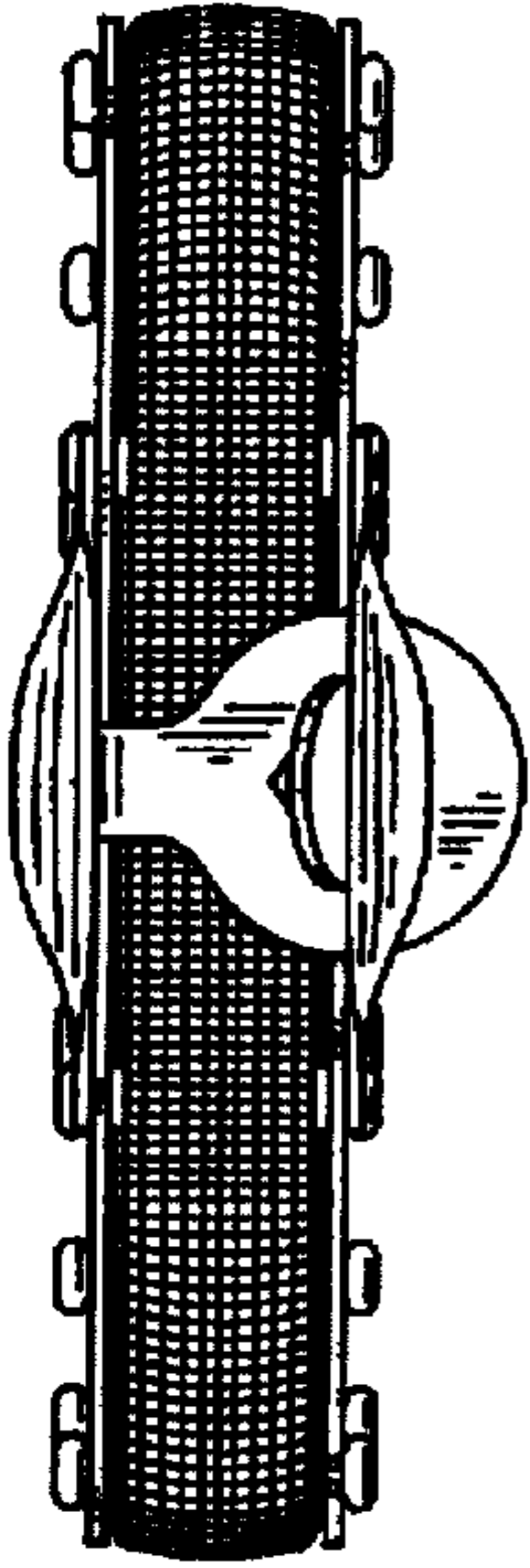

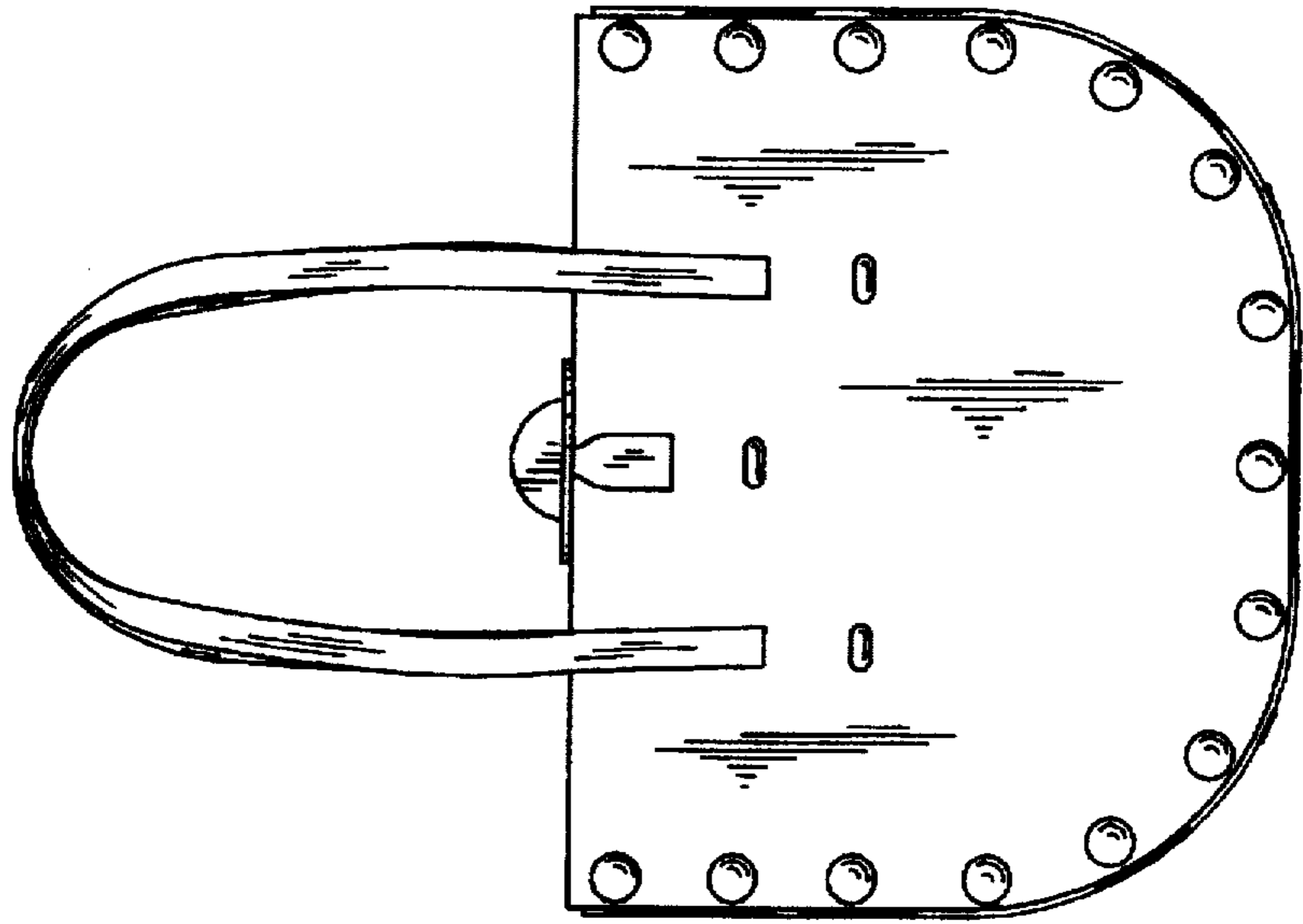

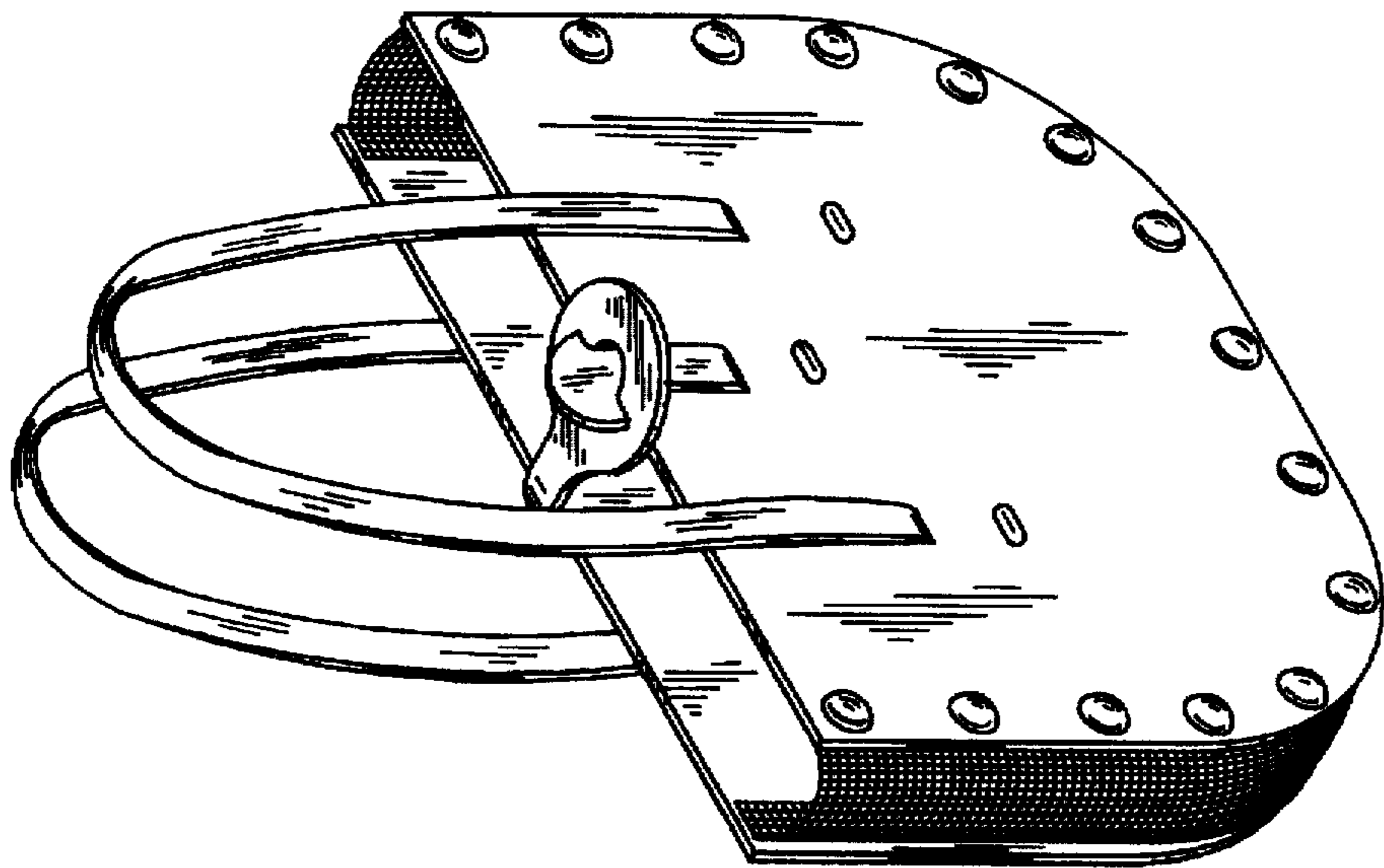

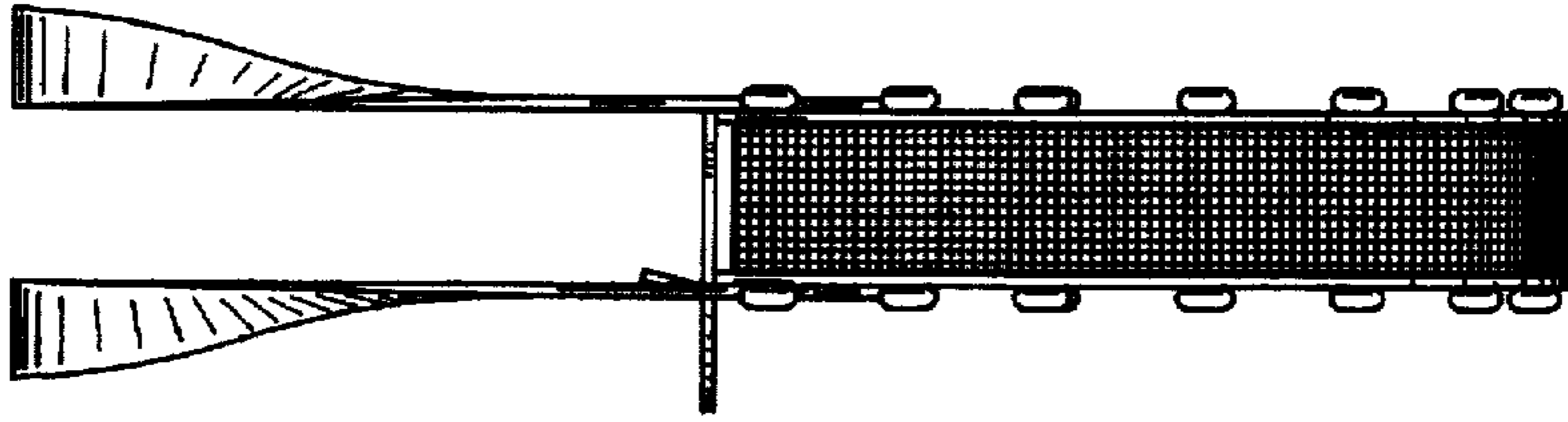

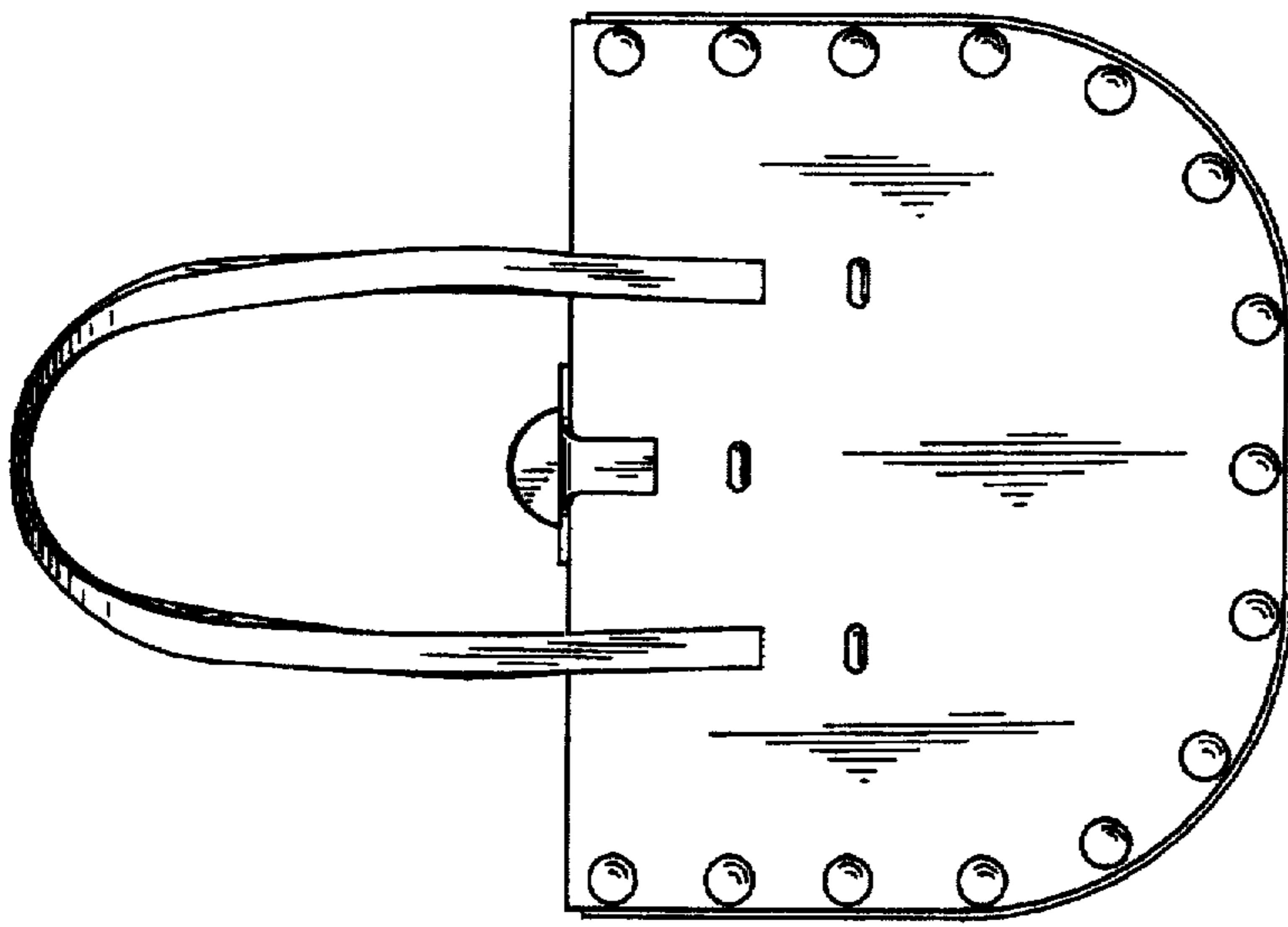

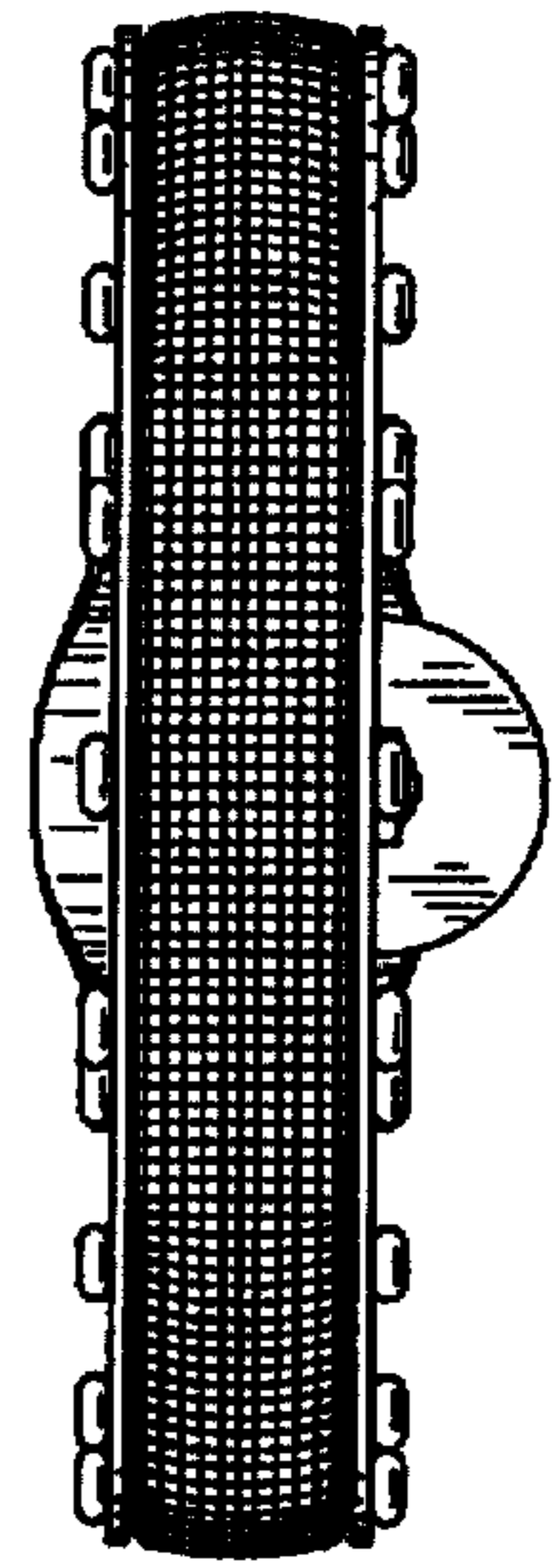

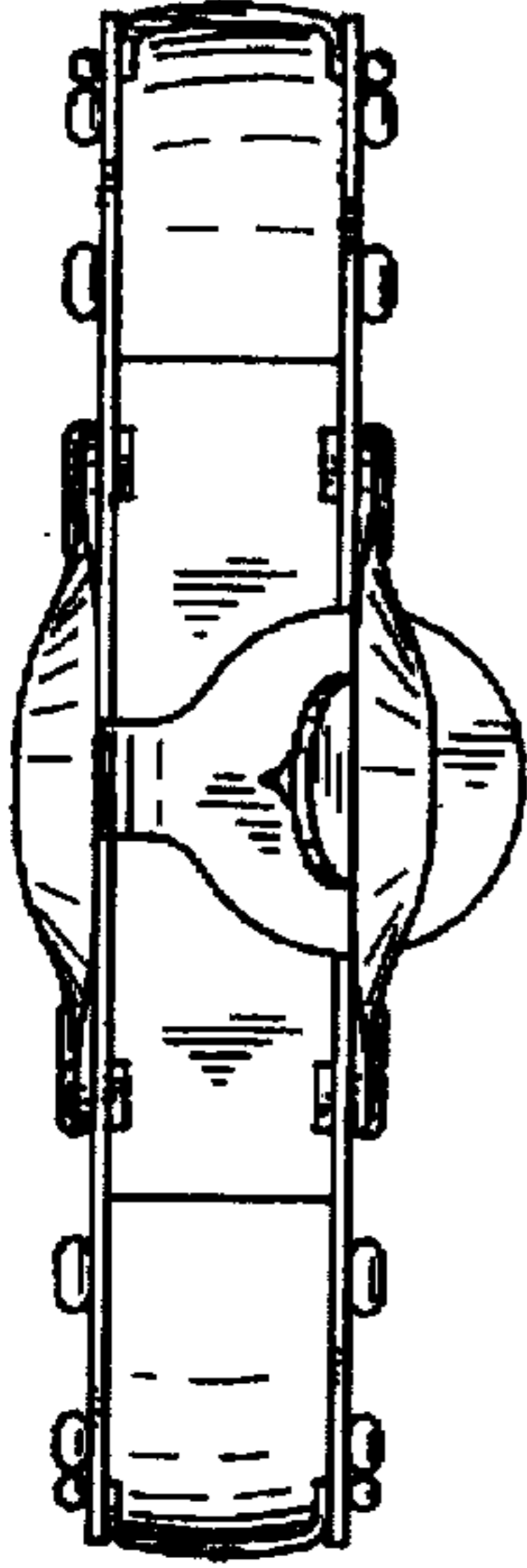

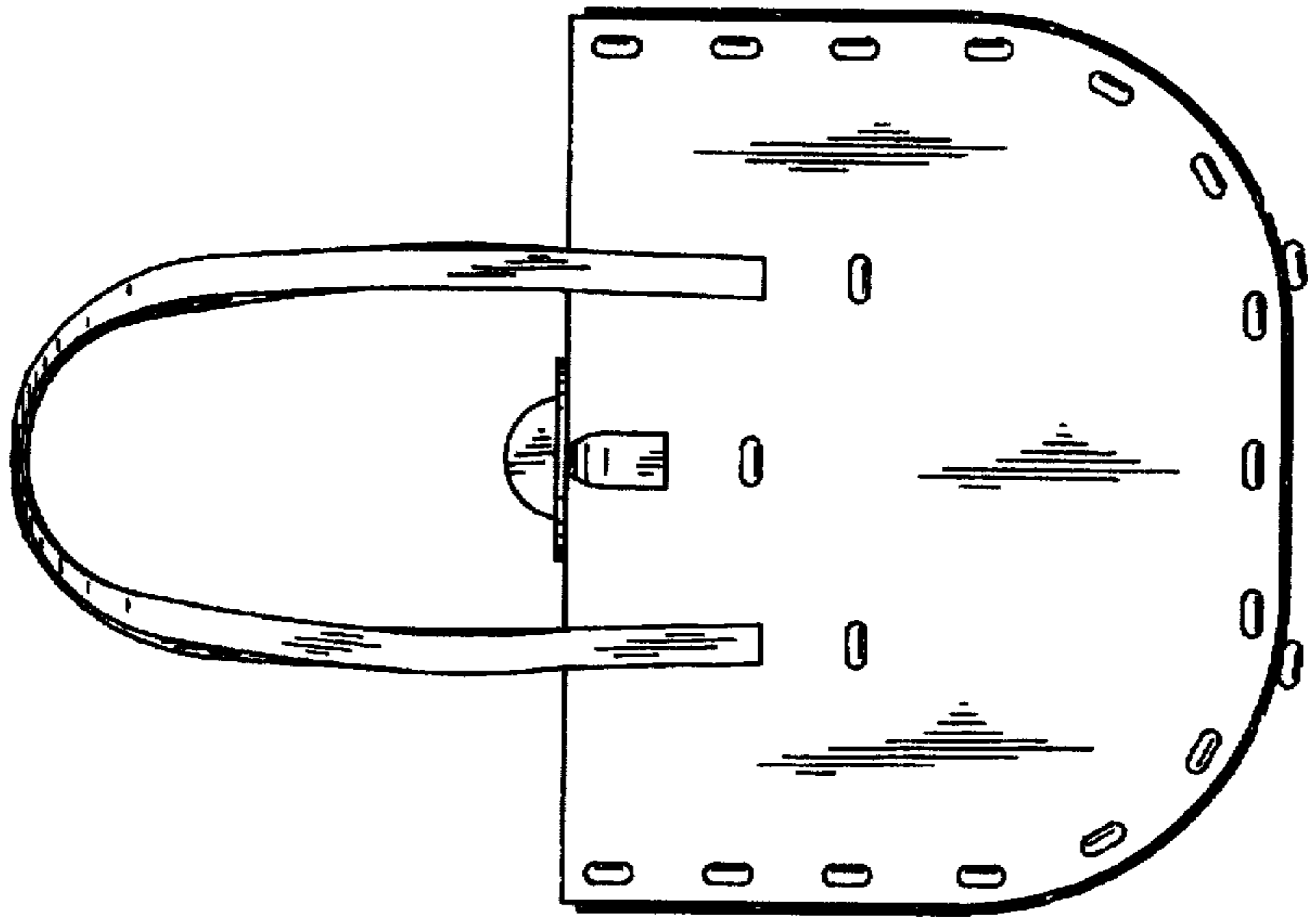

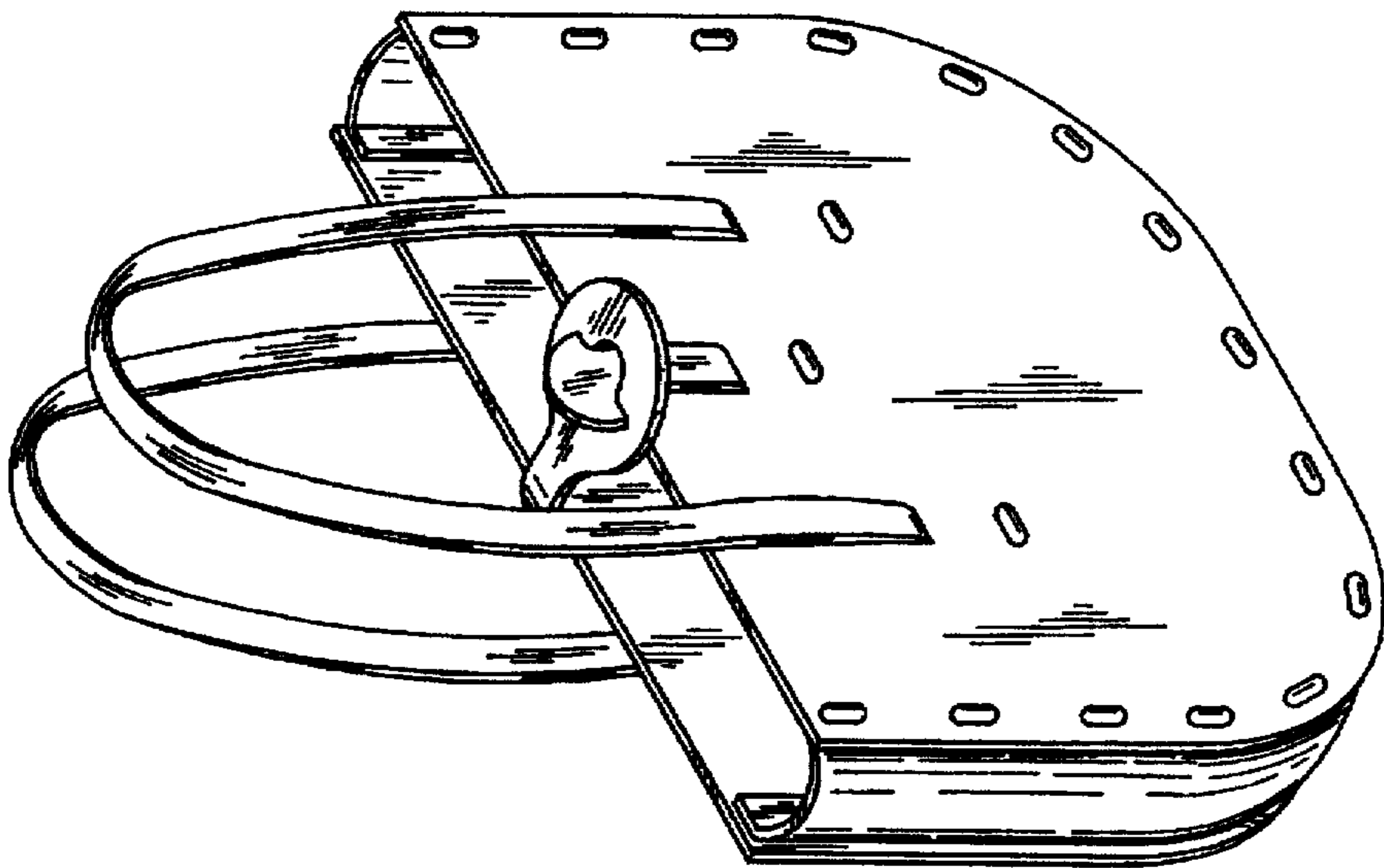

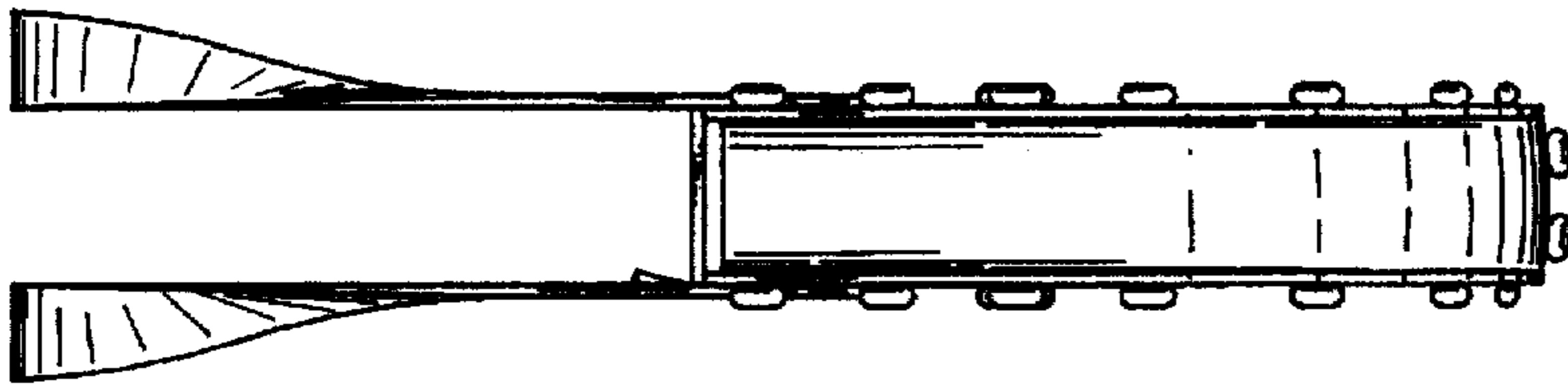

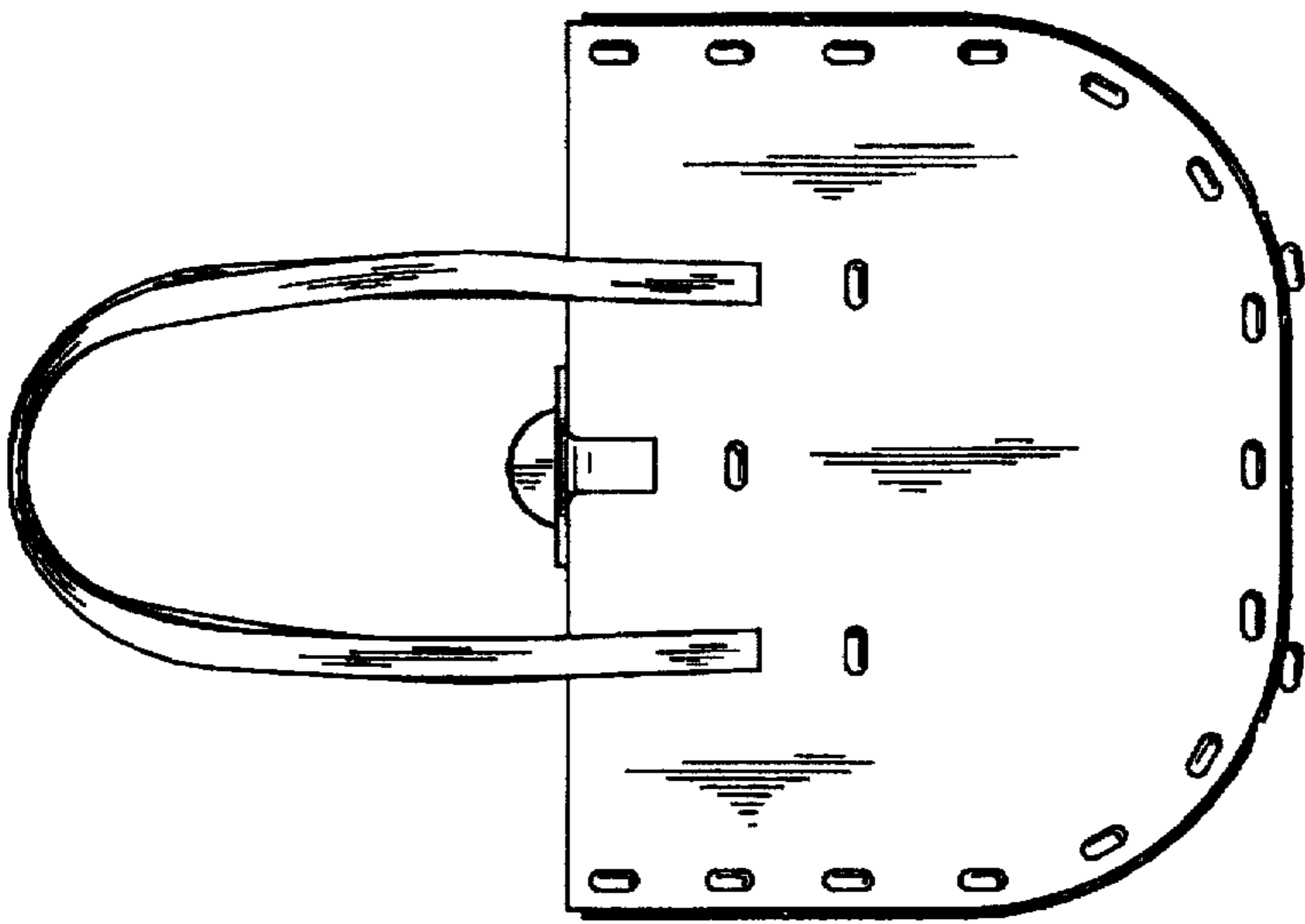

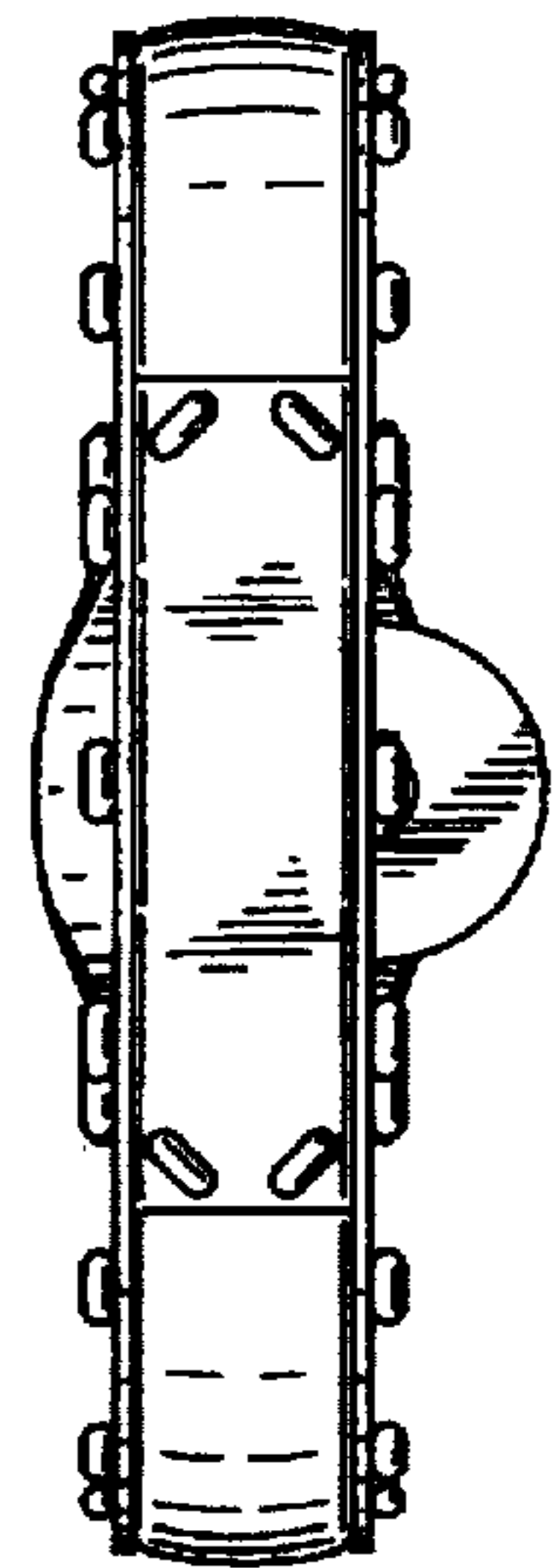

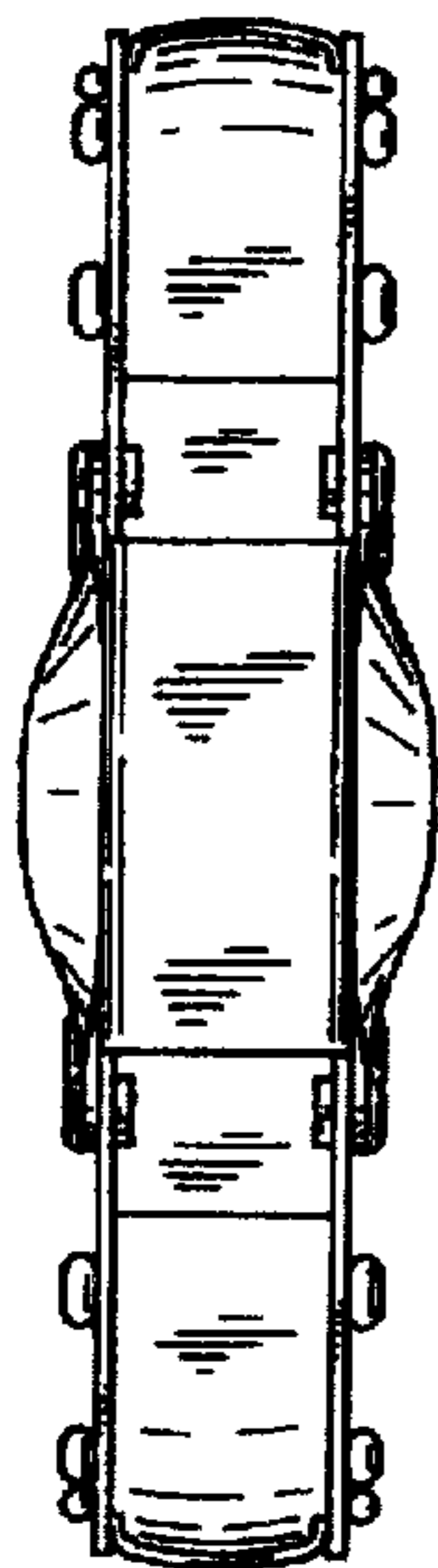

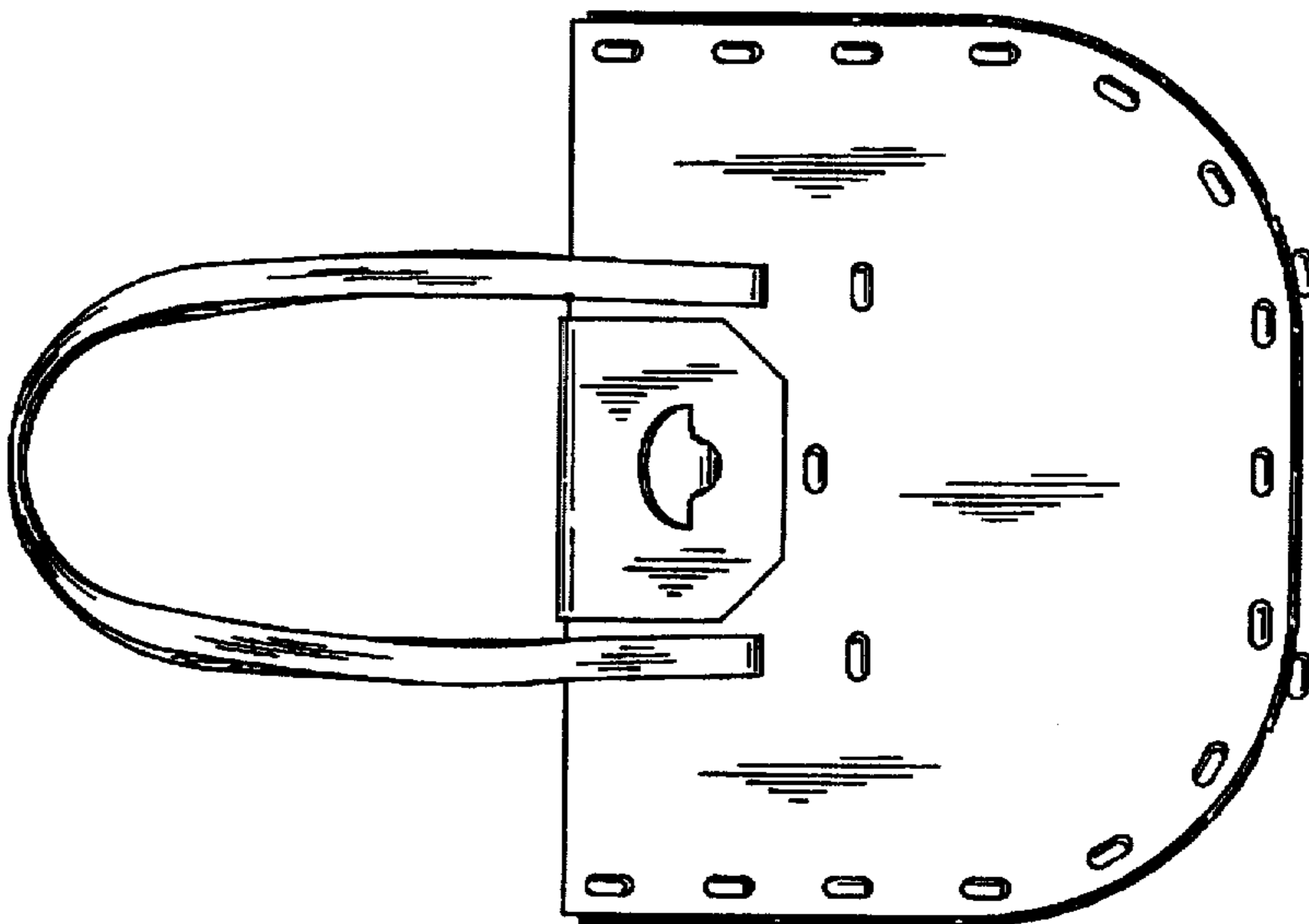

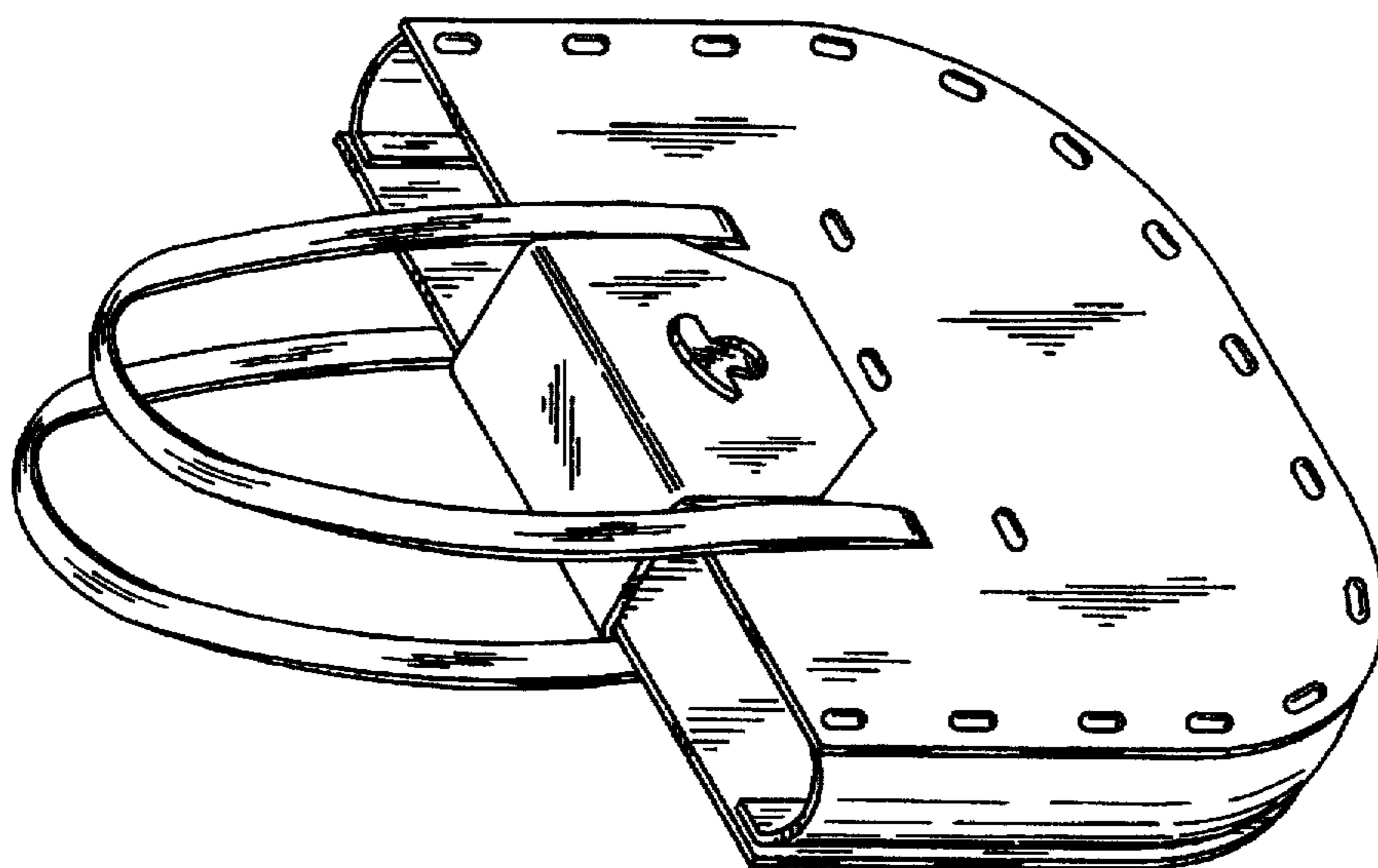

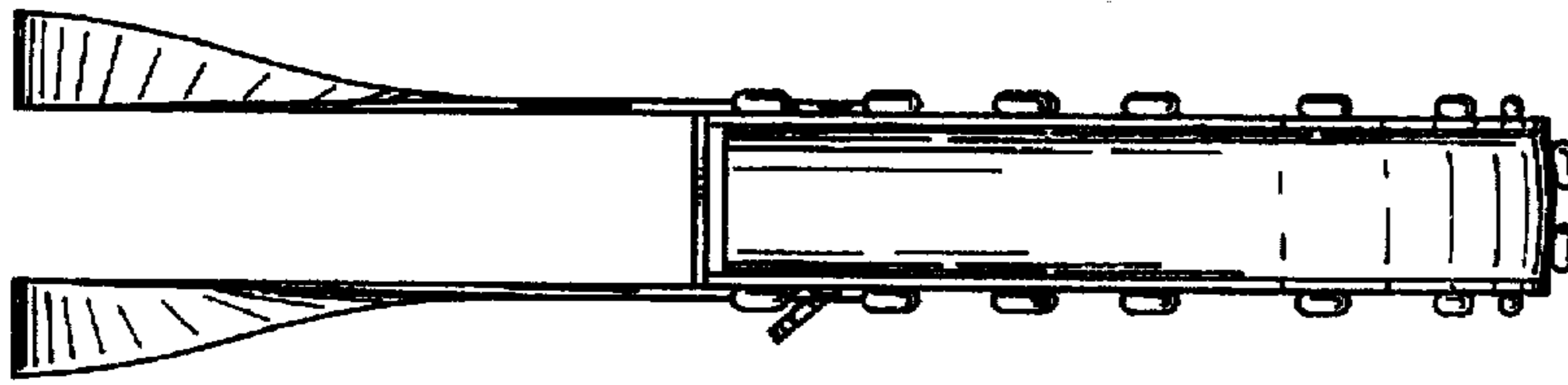

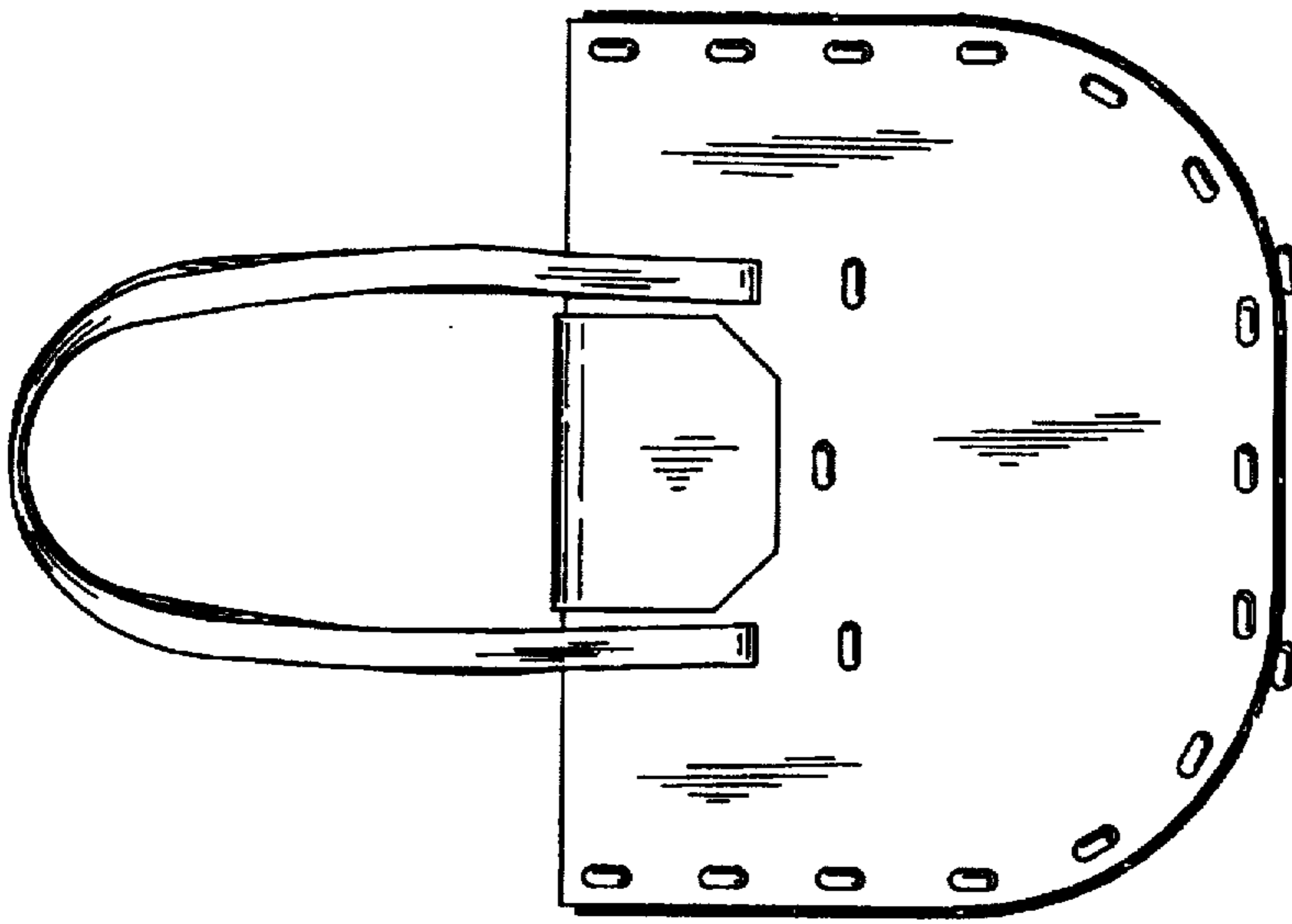

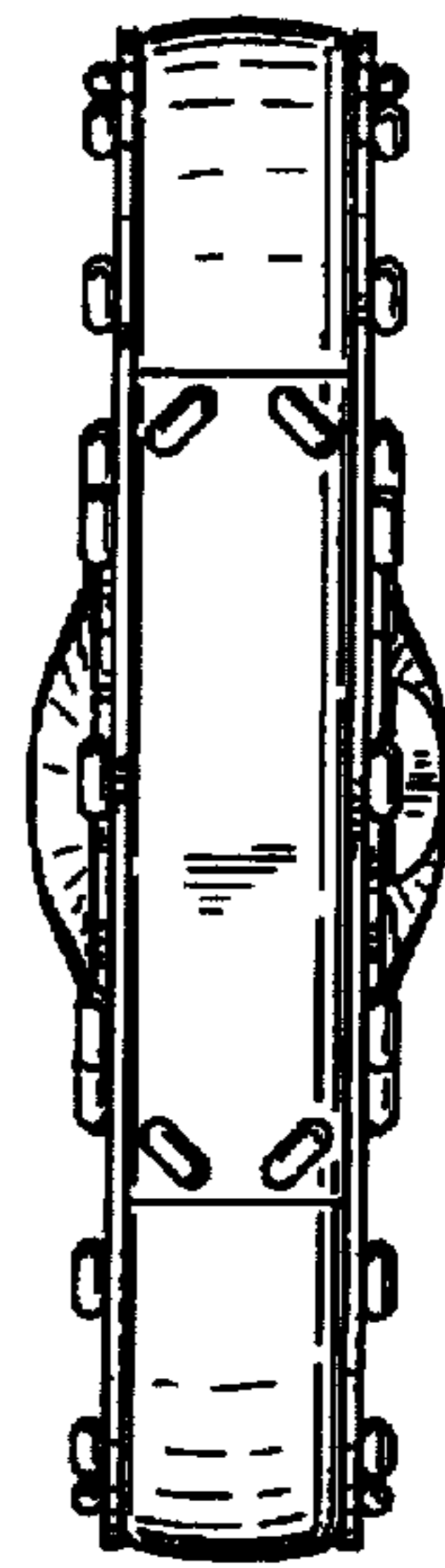
