DESCRIPTION

FIG. 1 is a perspective view of the invention;

FIG. 10 is a right side elevational view of the embodiment shown in FIG. 6;

FIG. 11 is a perspective view of the third embodiment of the invention;

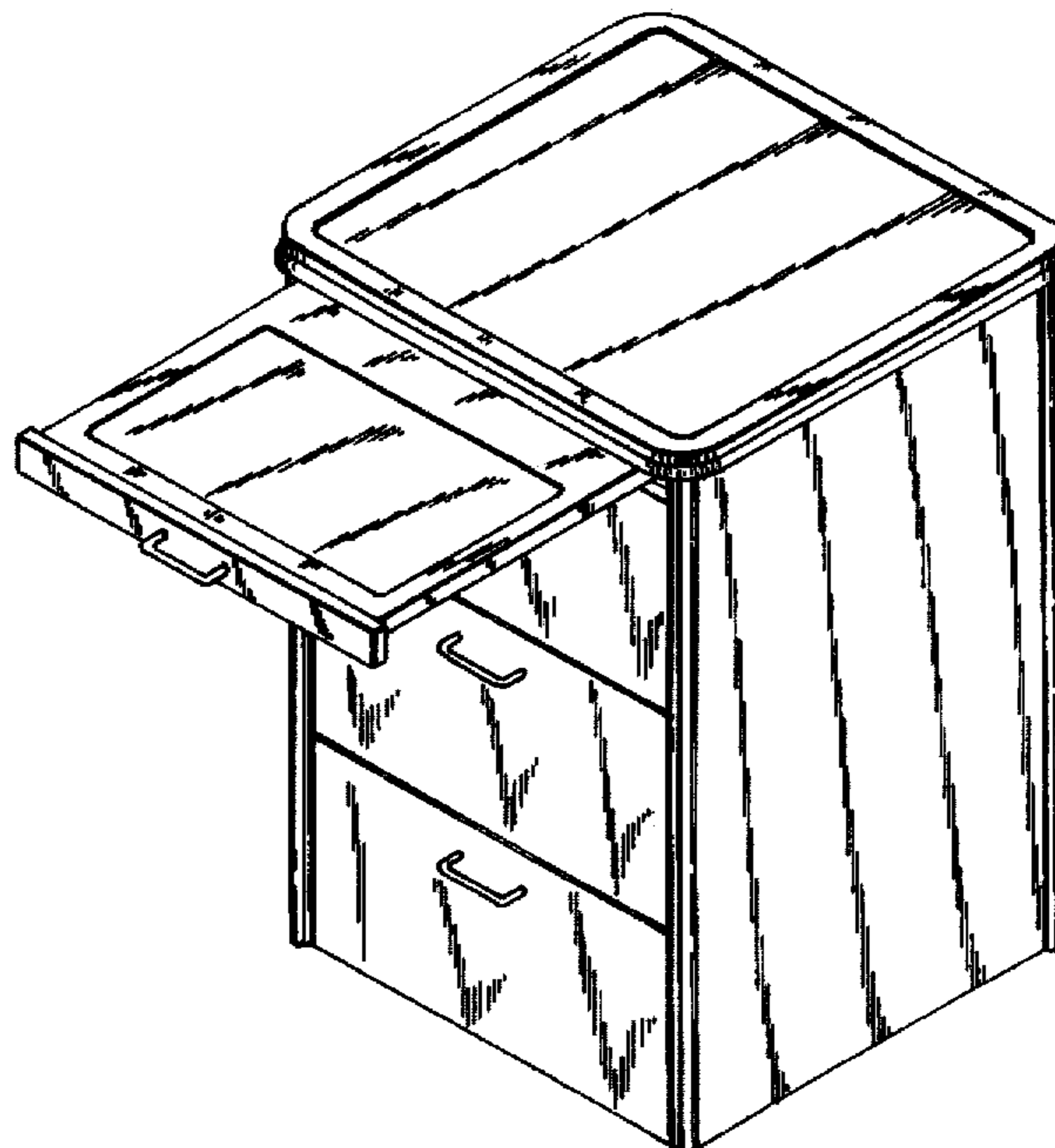
FIG. 12 is a rear elevational view of the embodiment shown in FIG. 11;

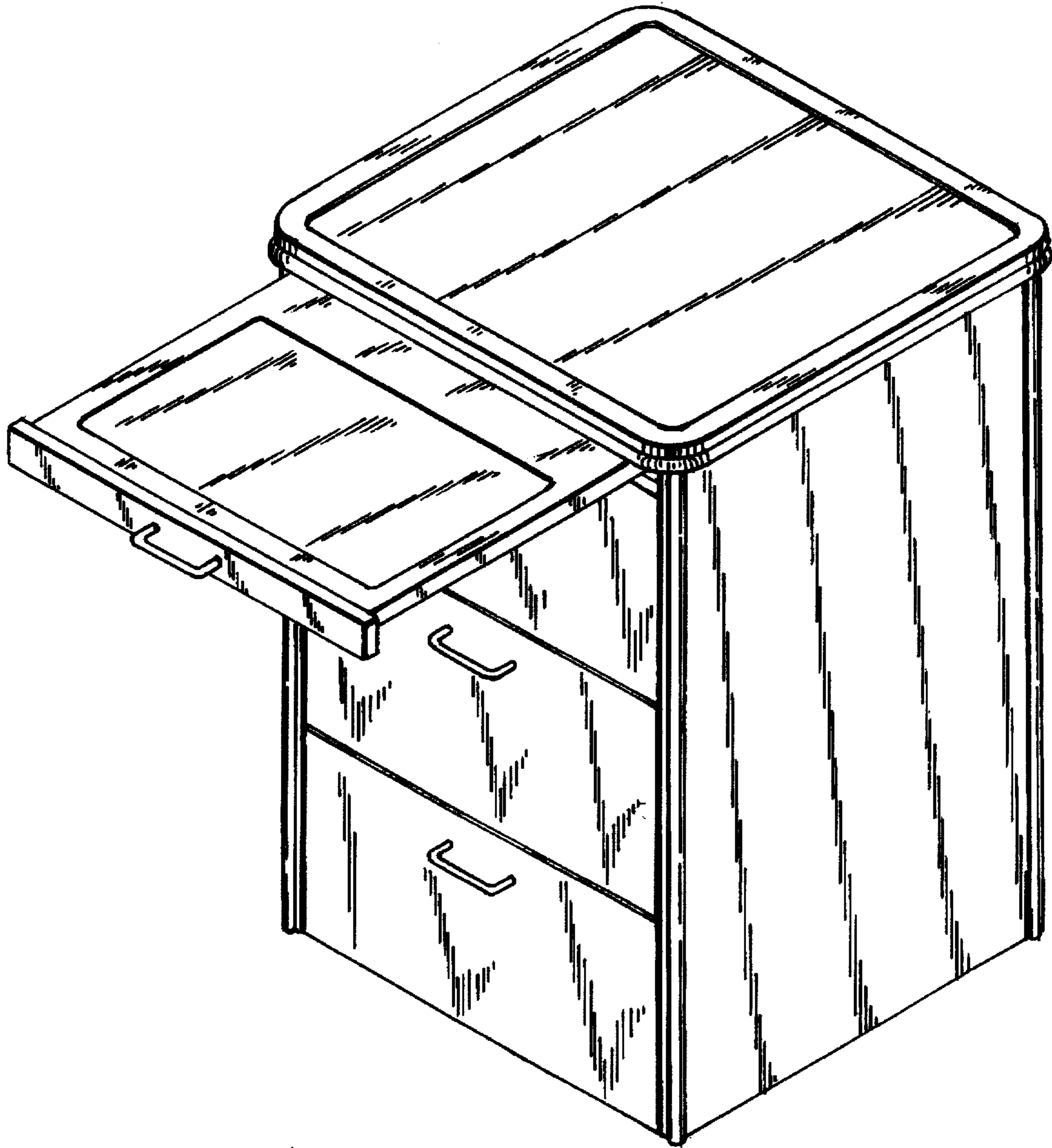

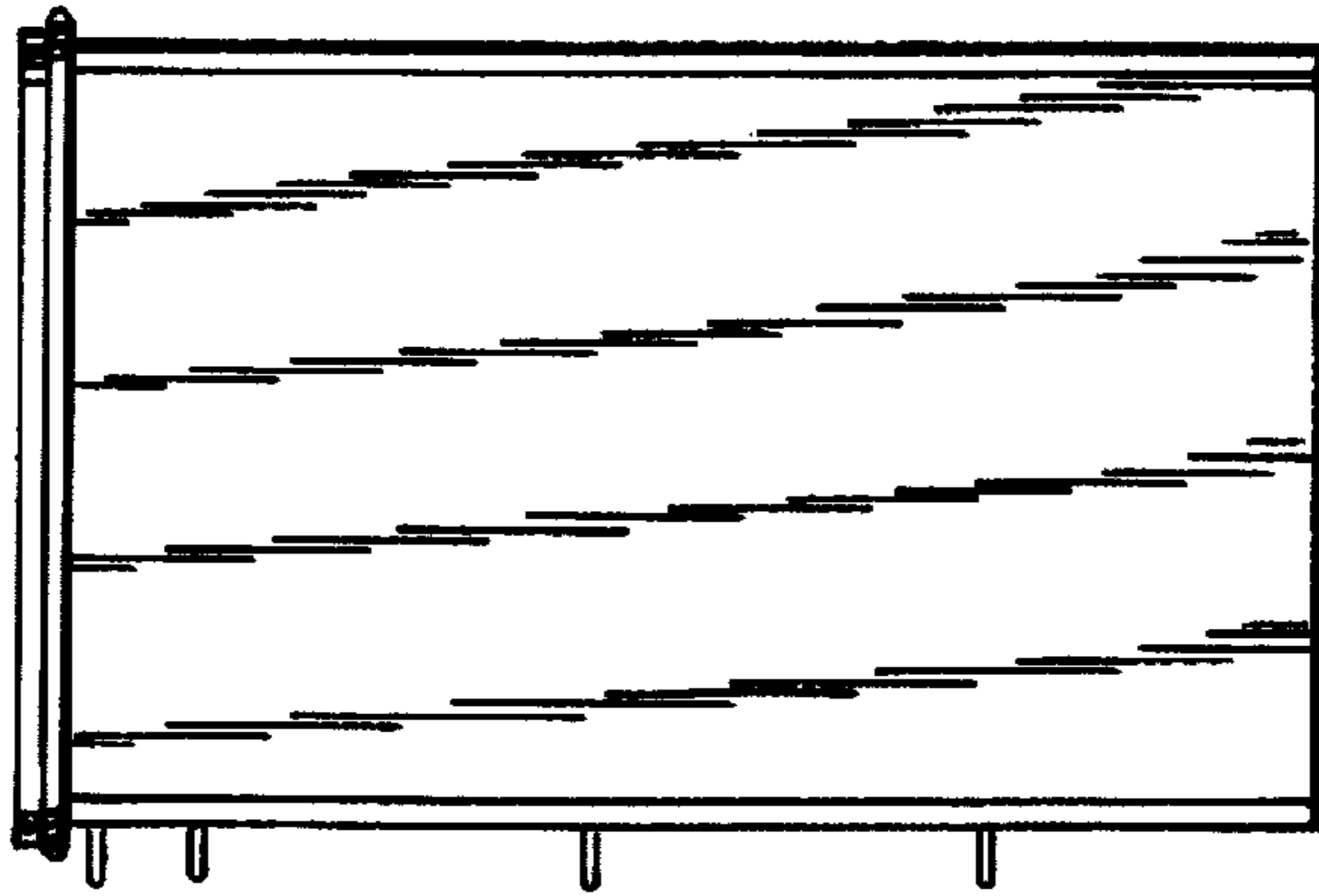

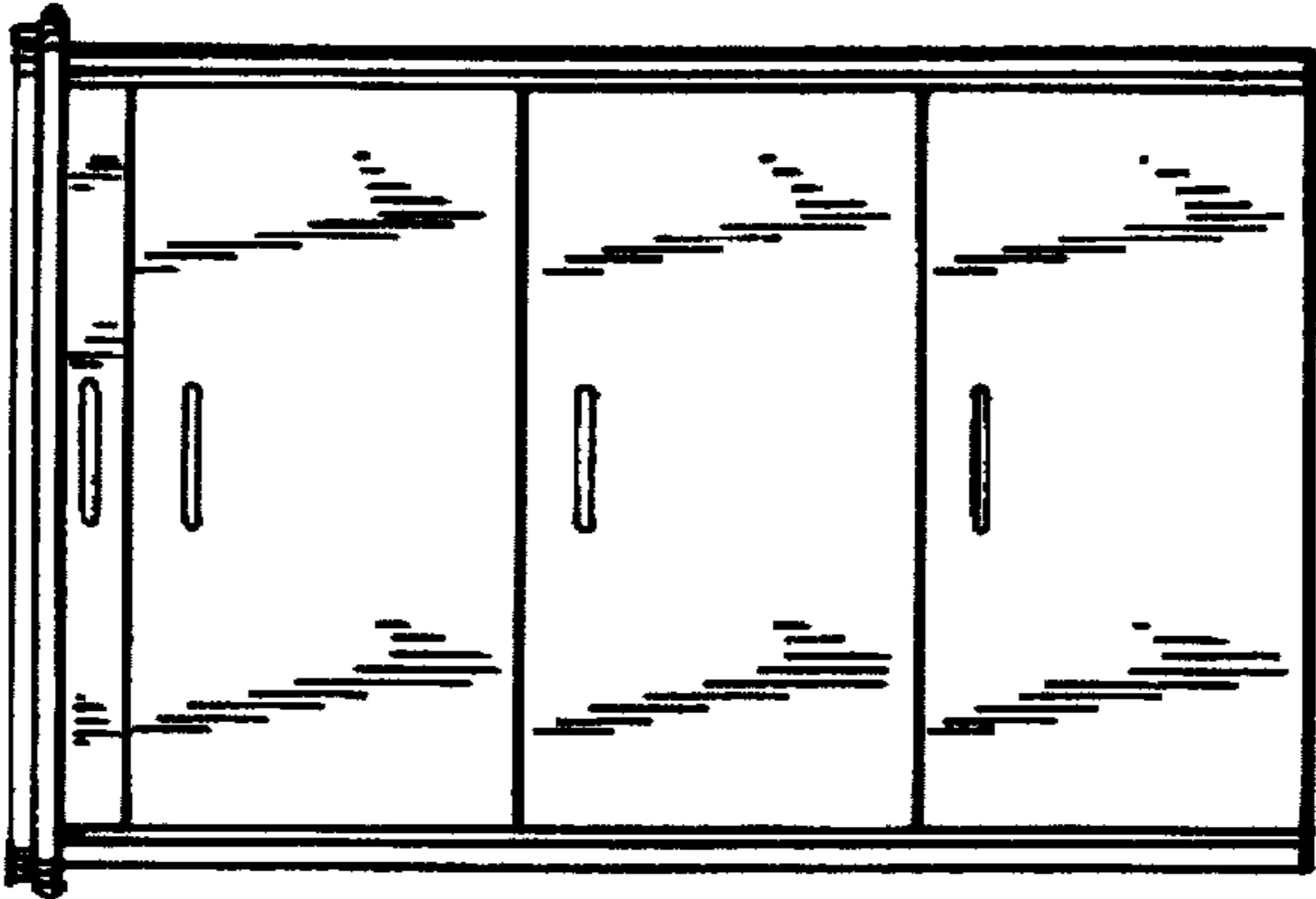

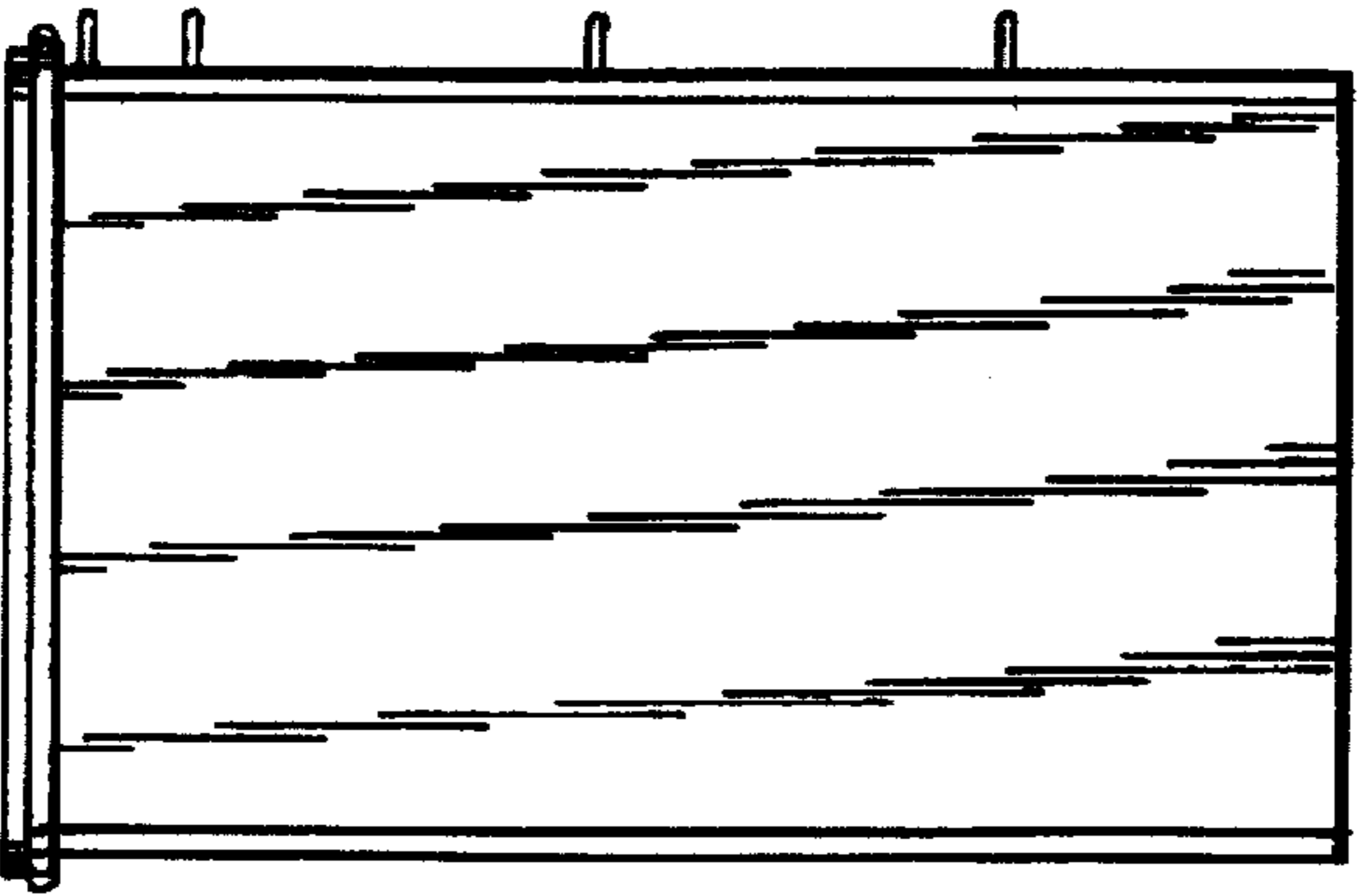

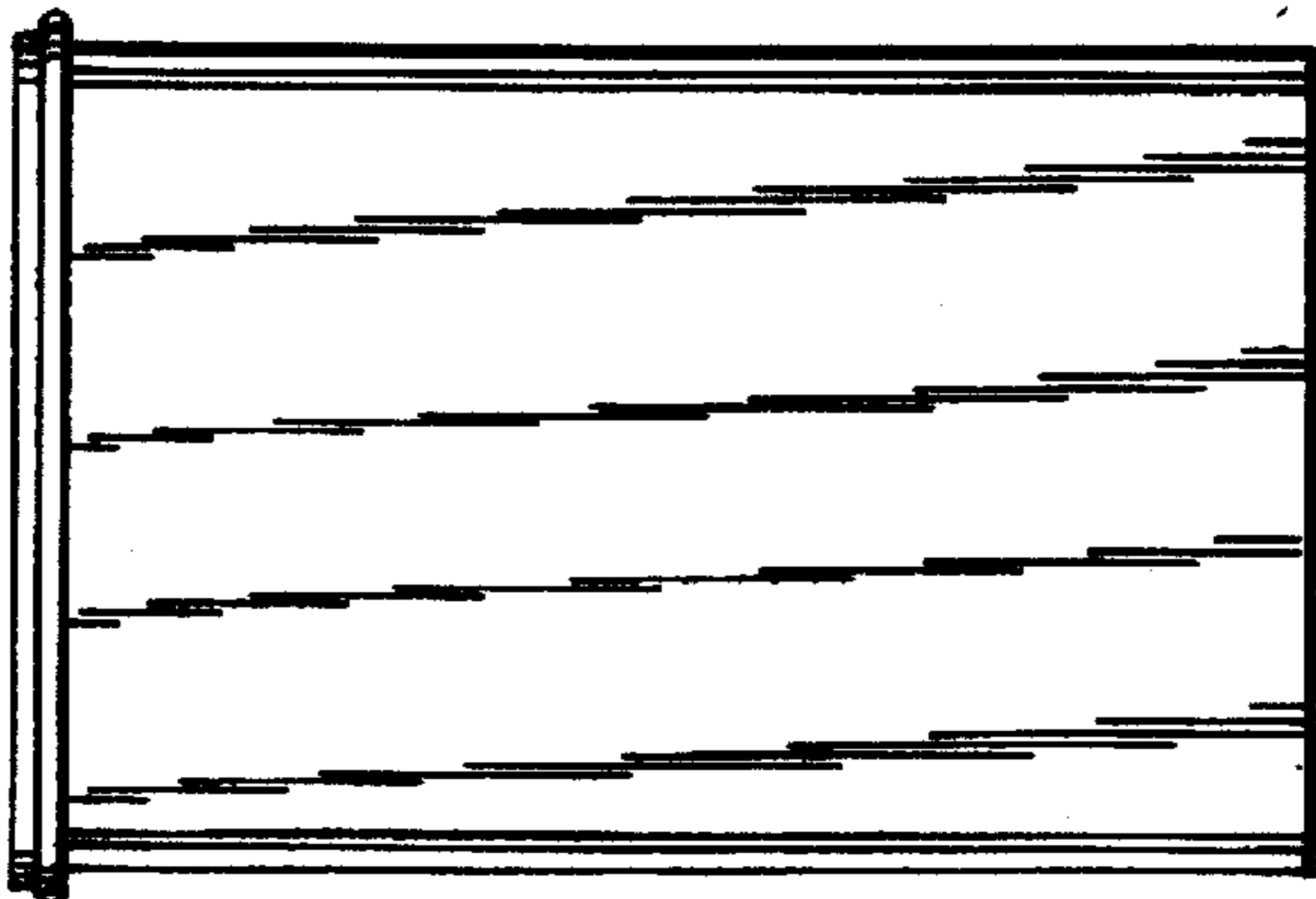

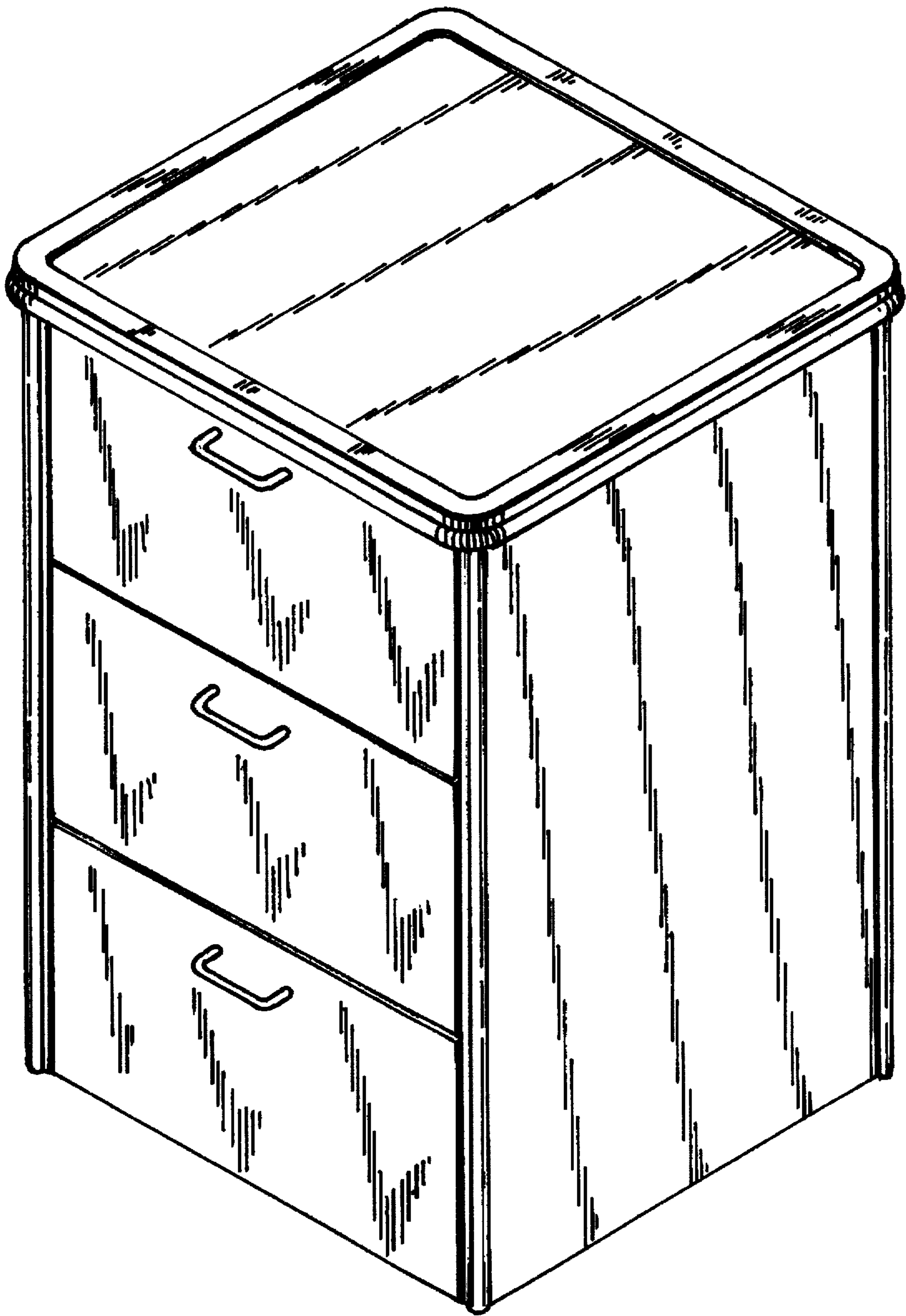

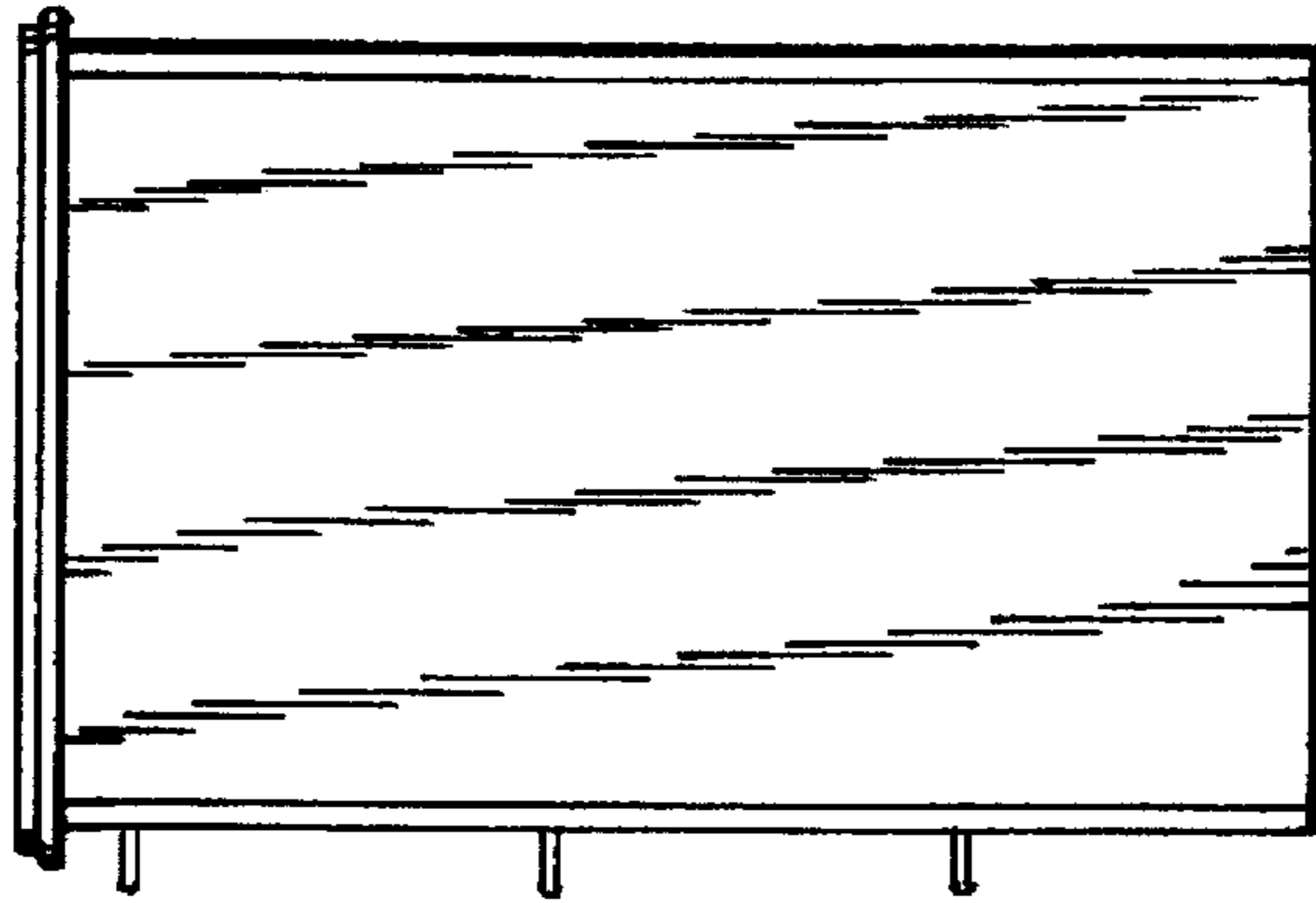

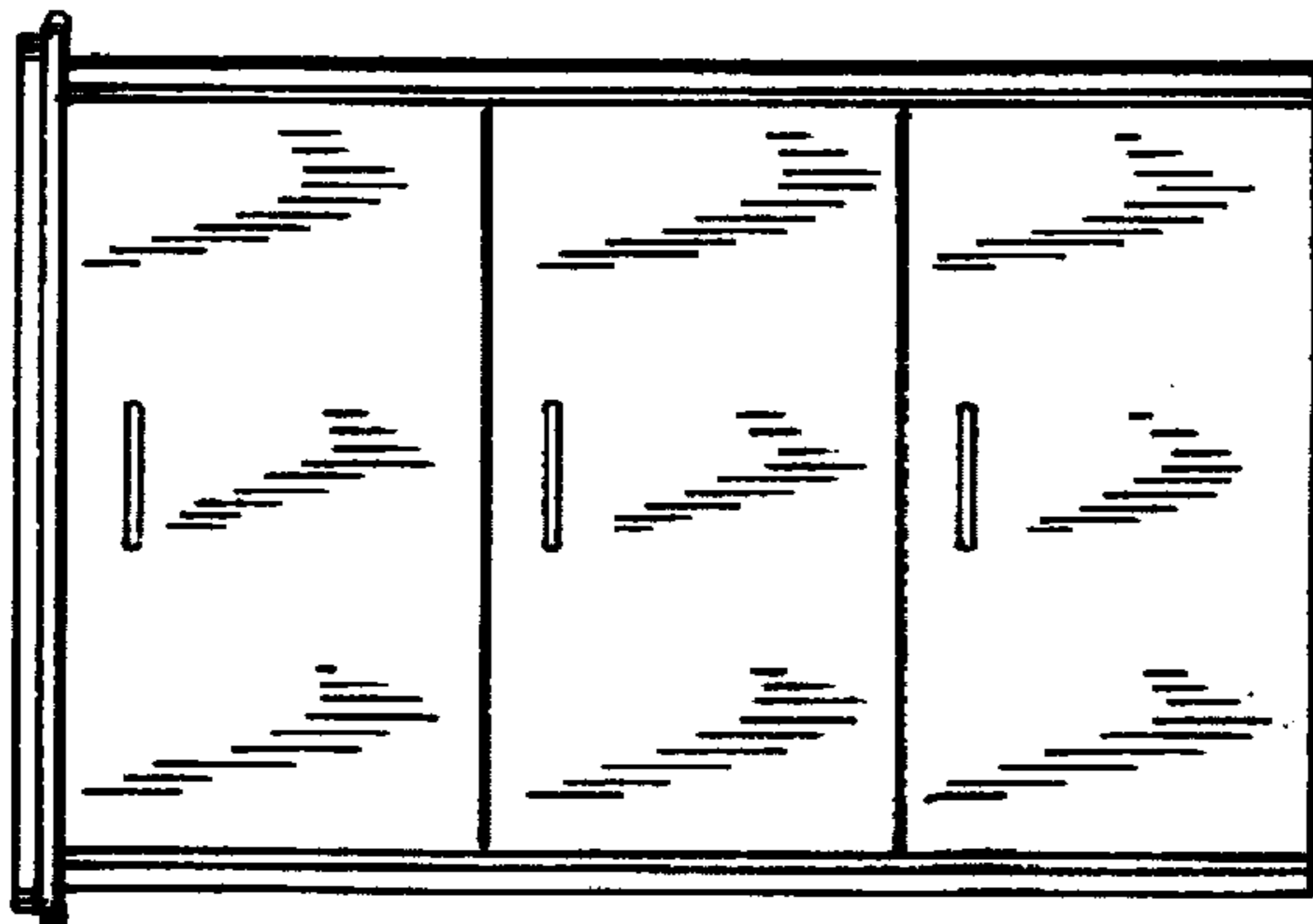

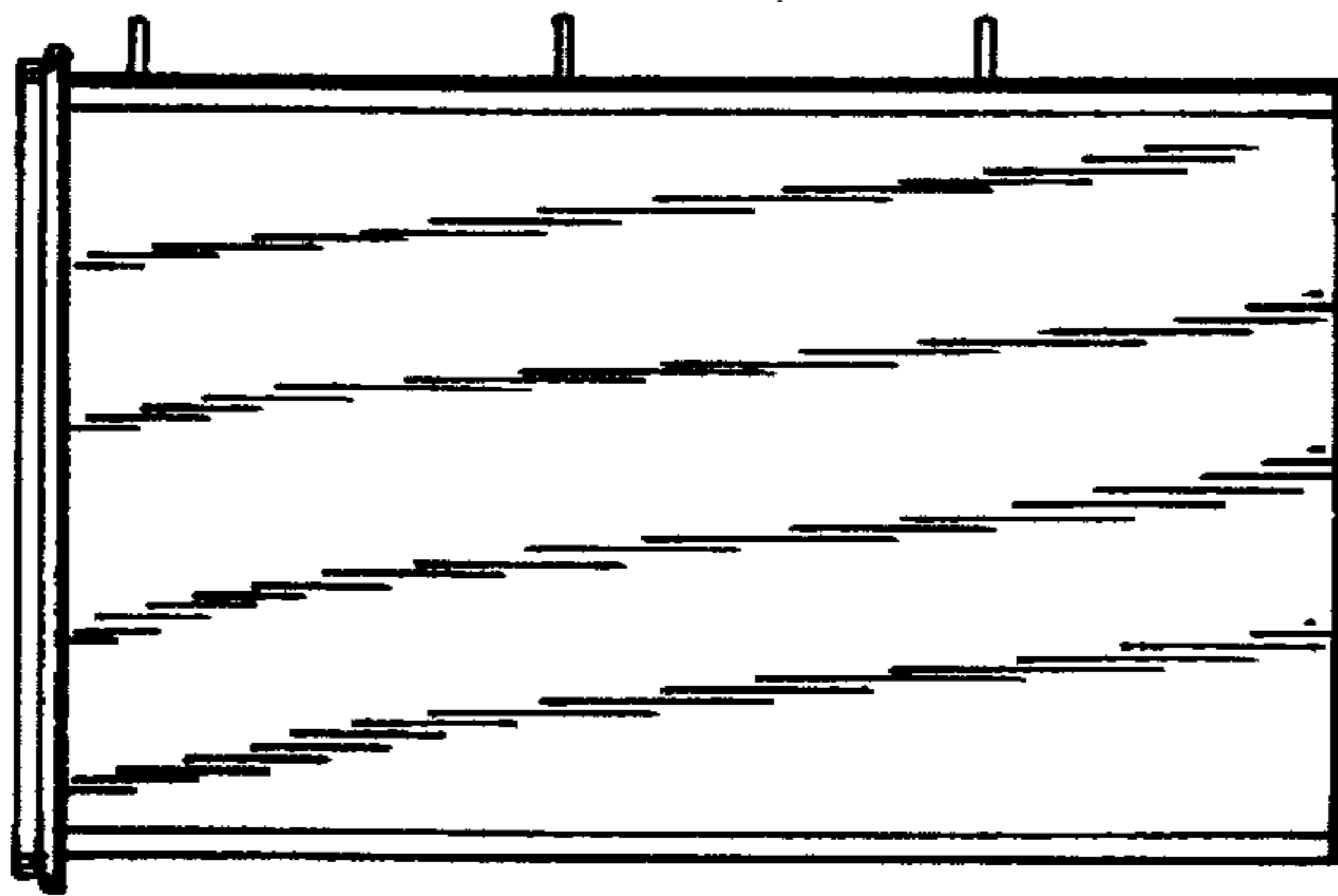

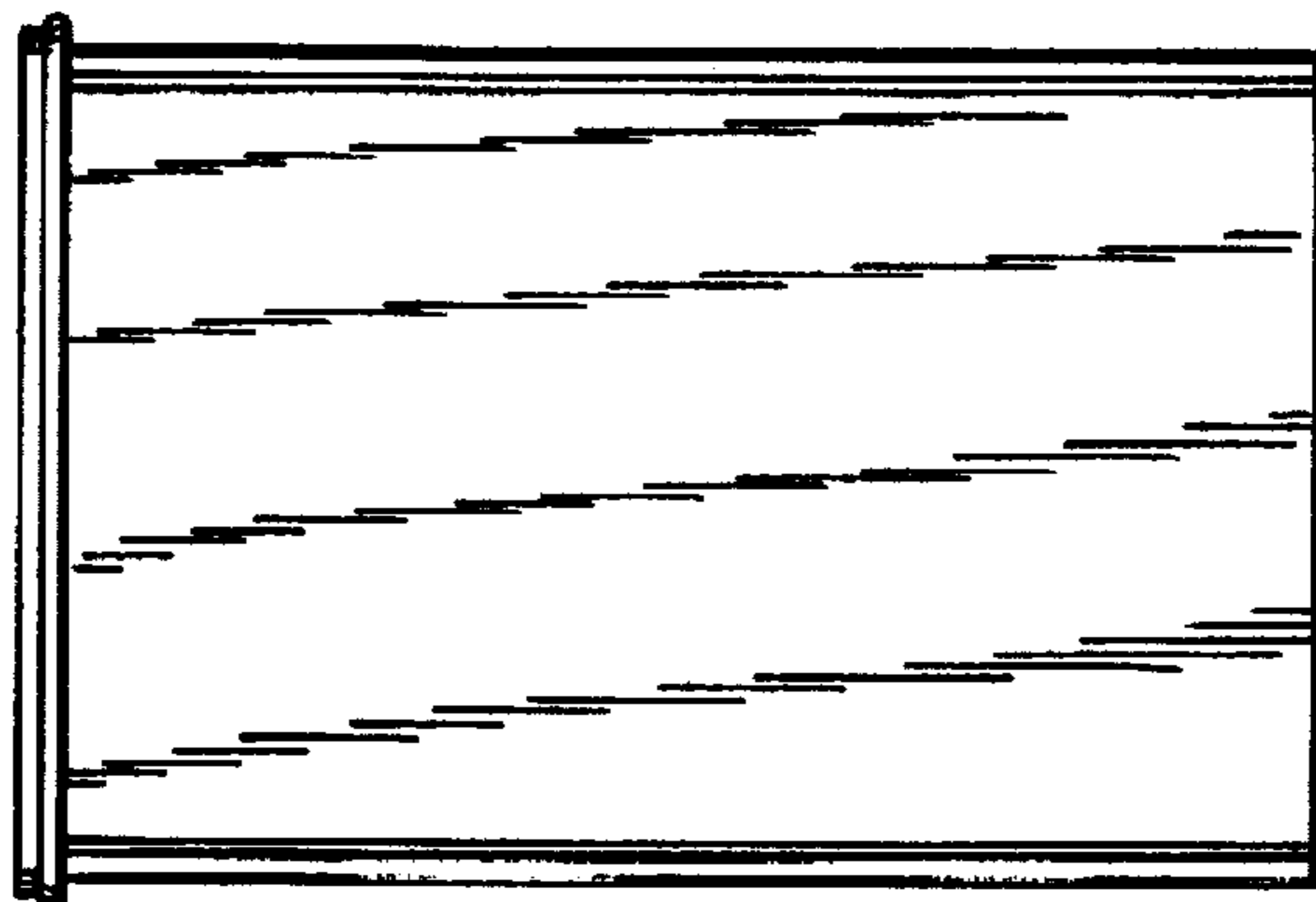

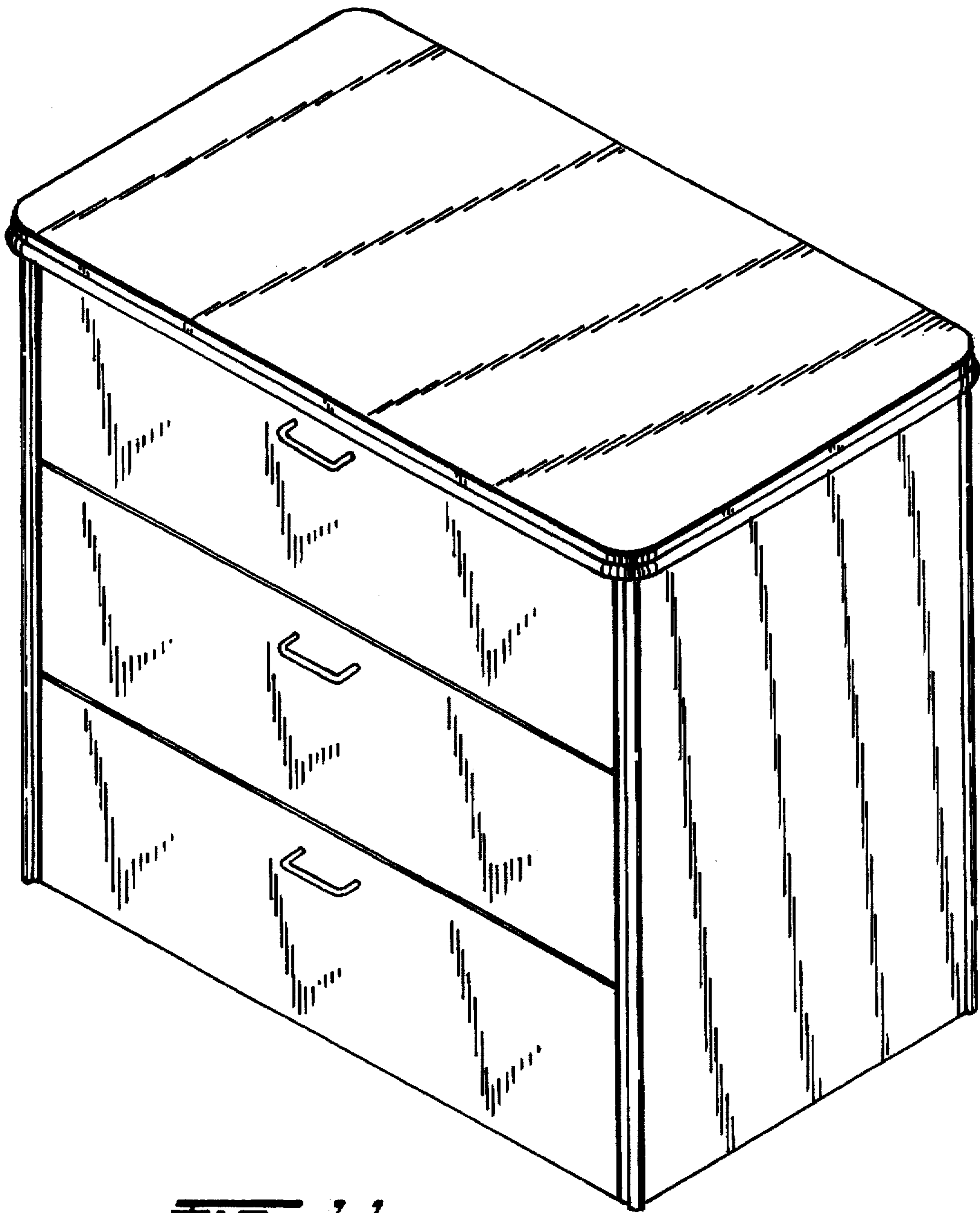

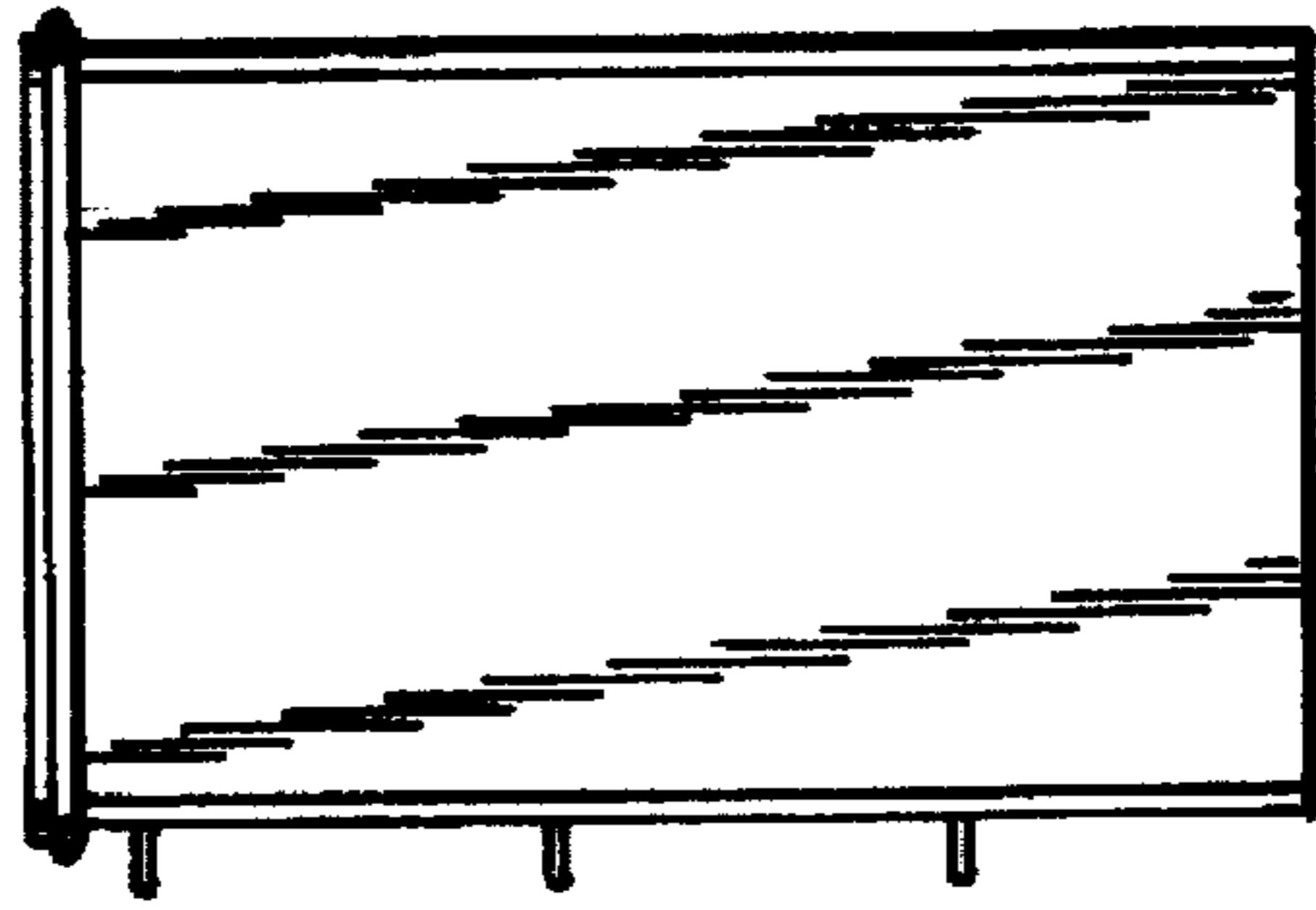

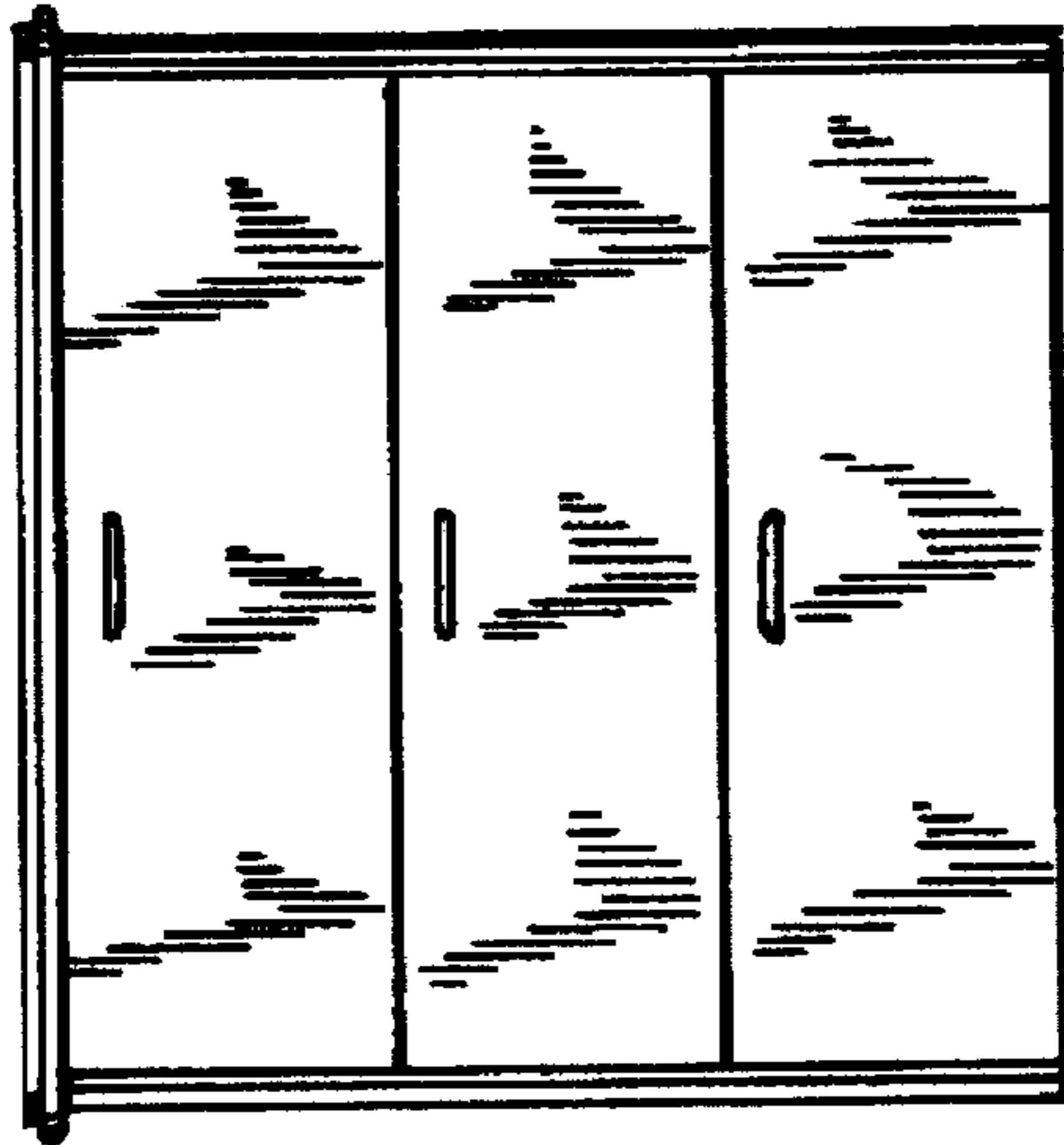

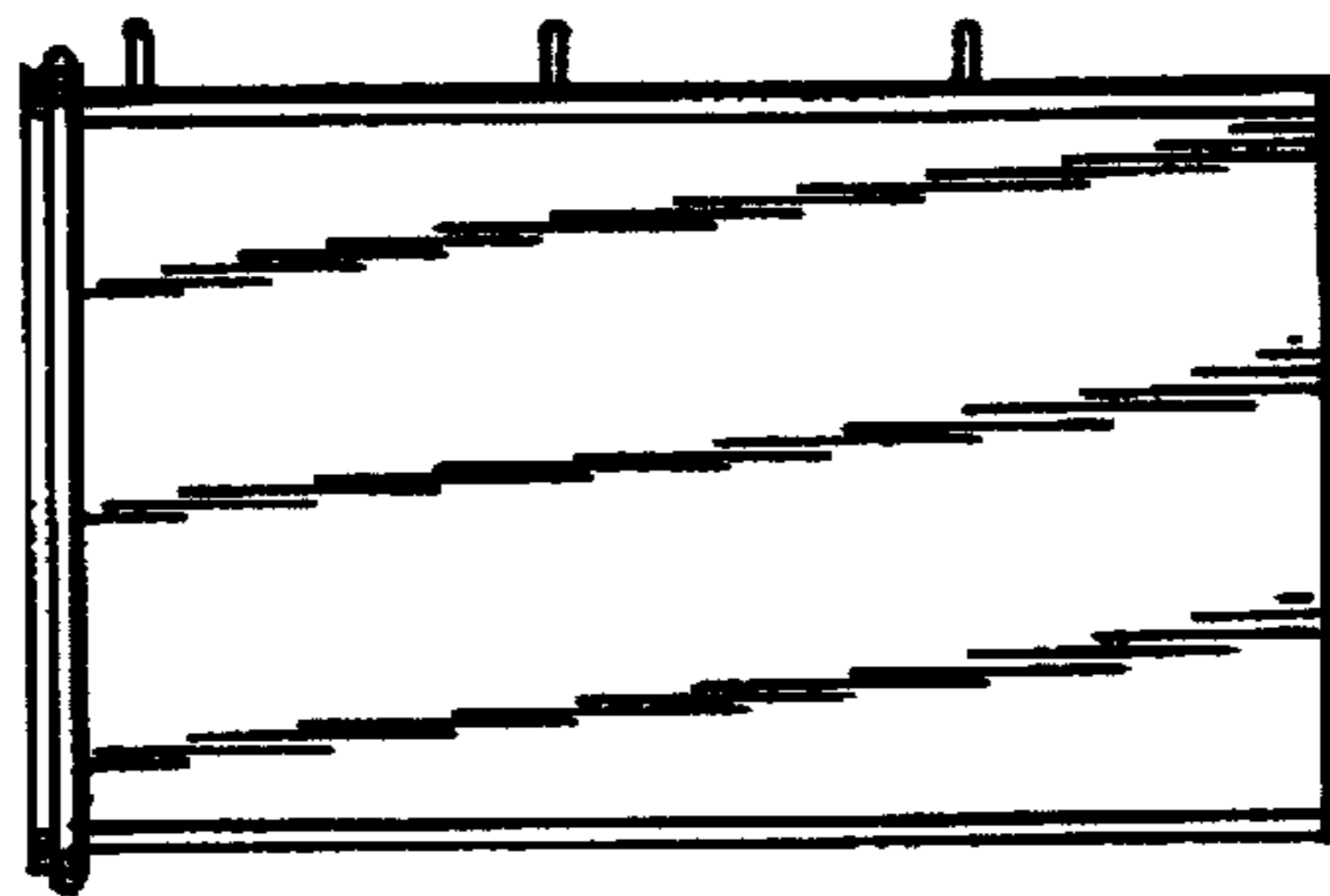

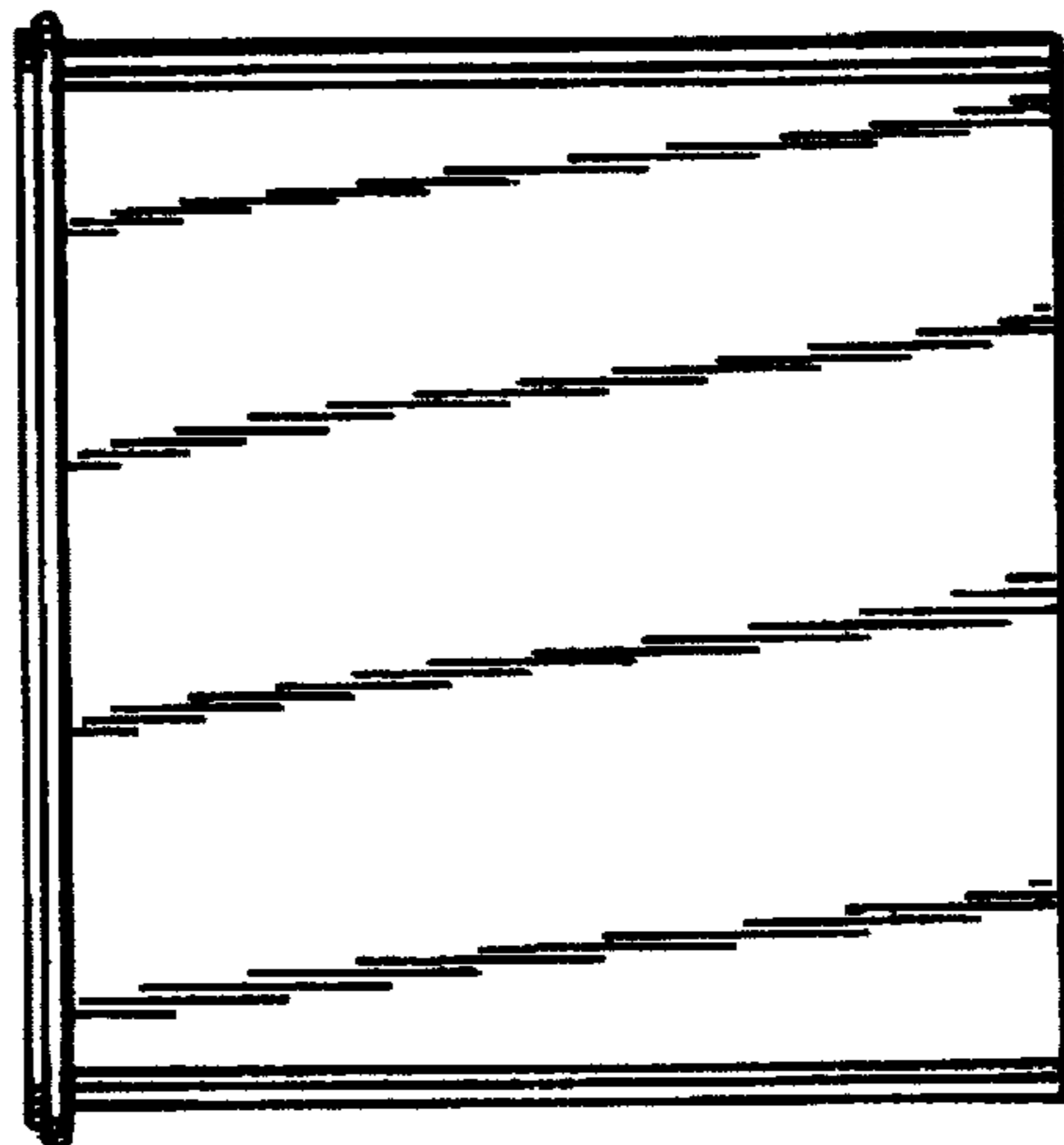
