The ornamental design for a landscape timber connecting system member, as shown and described.

DESCRIPTION

FIG. 1 is a front, right and top perspective view of a landscape timber connecting system member embodying our new design, the broken line showing of a second member is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a perspective view thereof;

FIG. 3 is an exploded perspective view thereof;

FIG. 4 is an exploded perspective view thereof, taken from below and to the right;

FIG. 5 is a top plan view thereof;

FIG. 6 is a right side elevational view thereof, the left side elevational view being a mirror image;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front elevational view thereof; and,

FIG. 9 is a rear elevational view thereof.

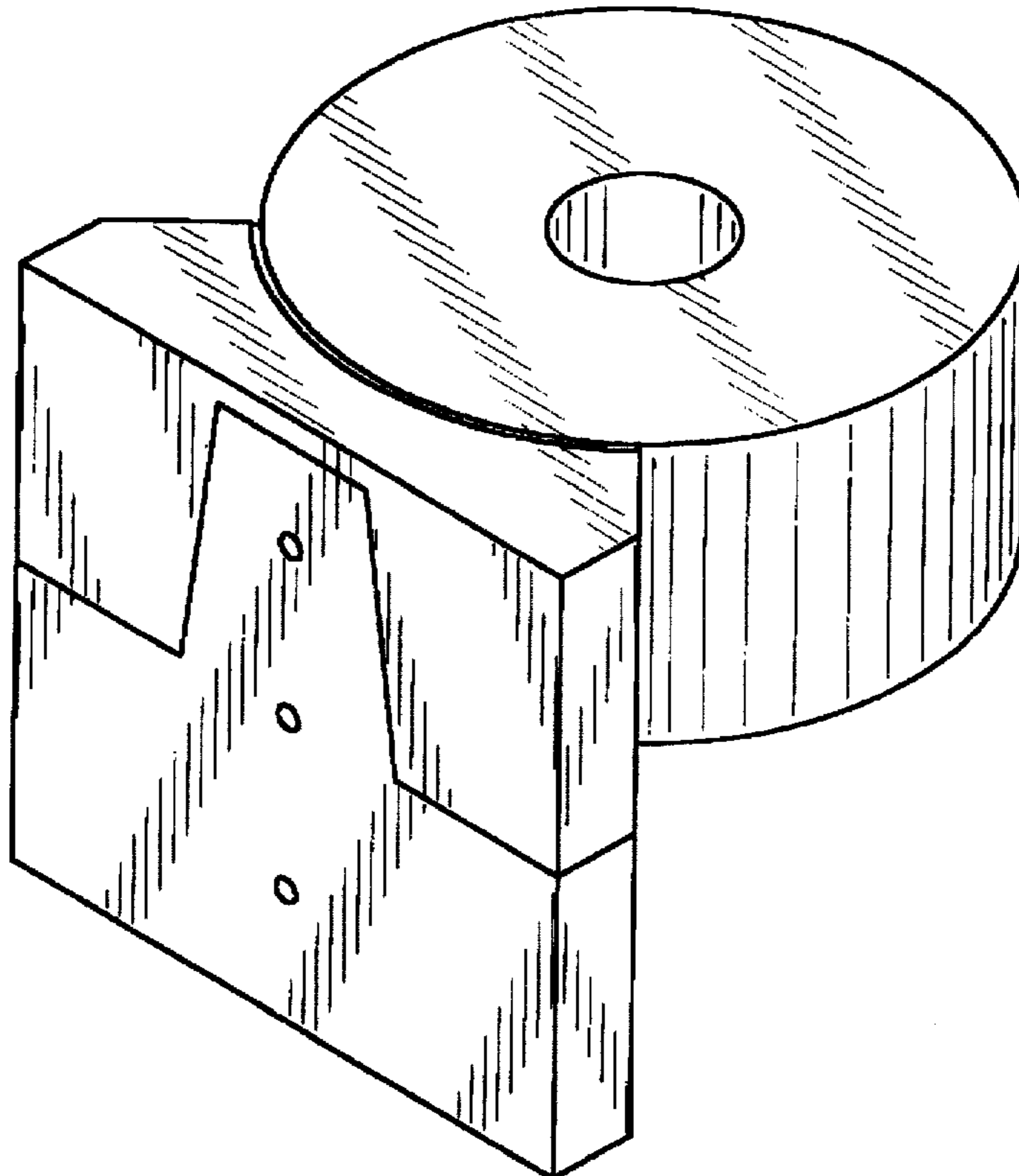

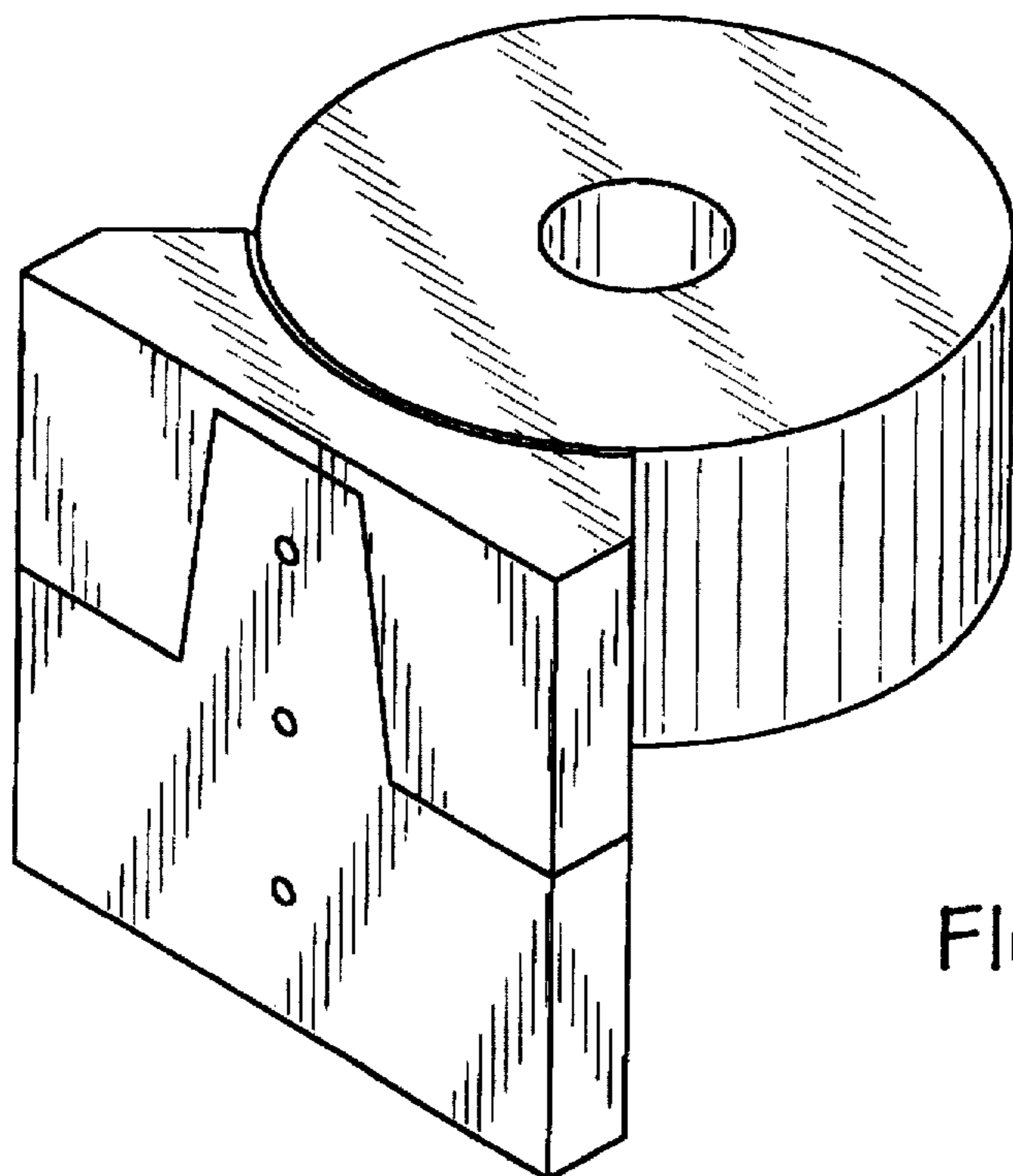
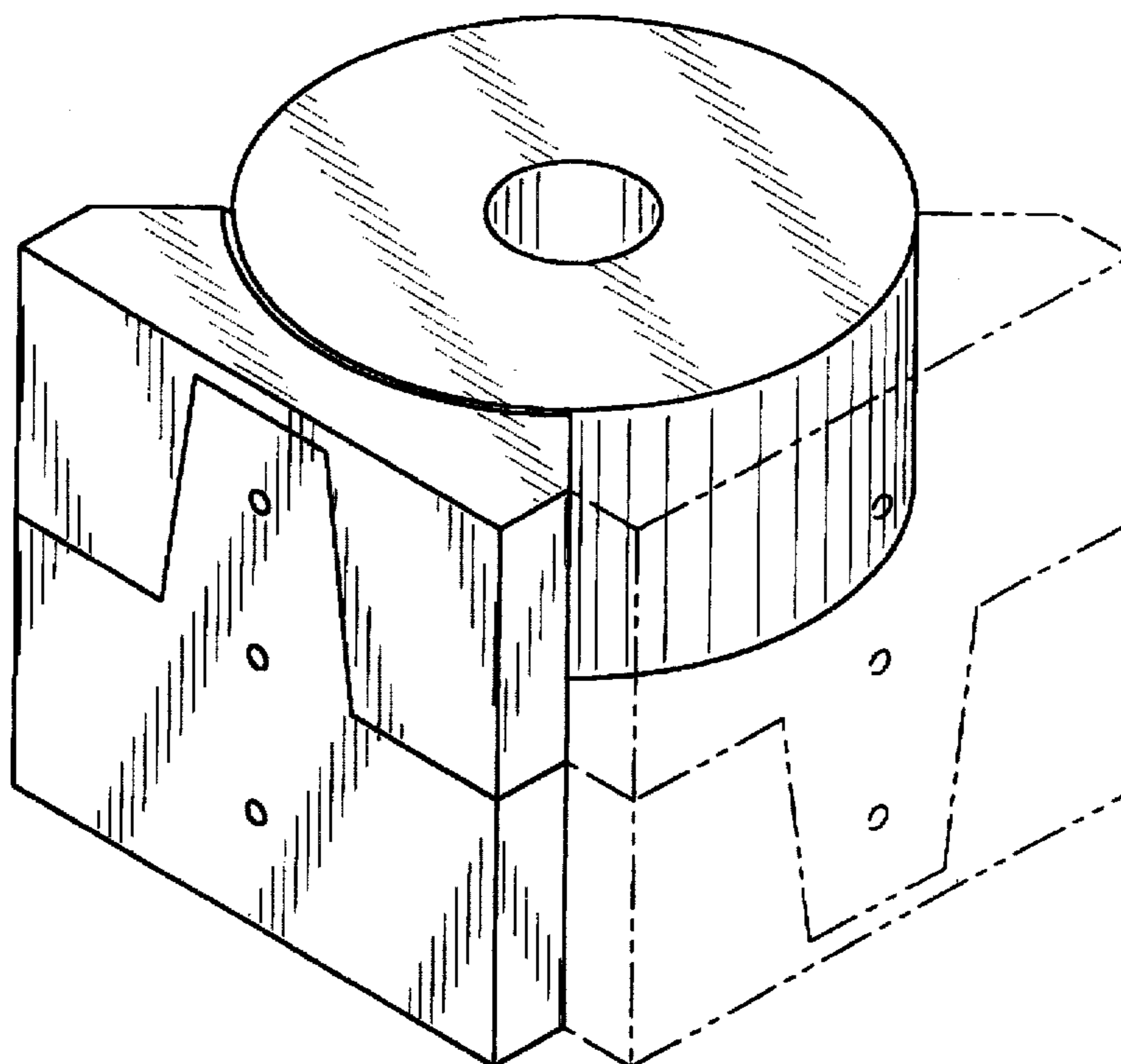

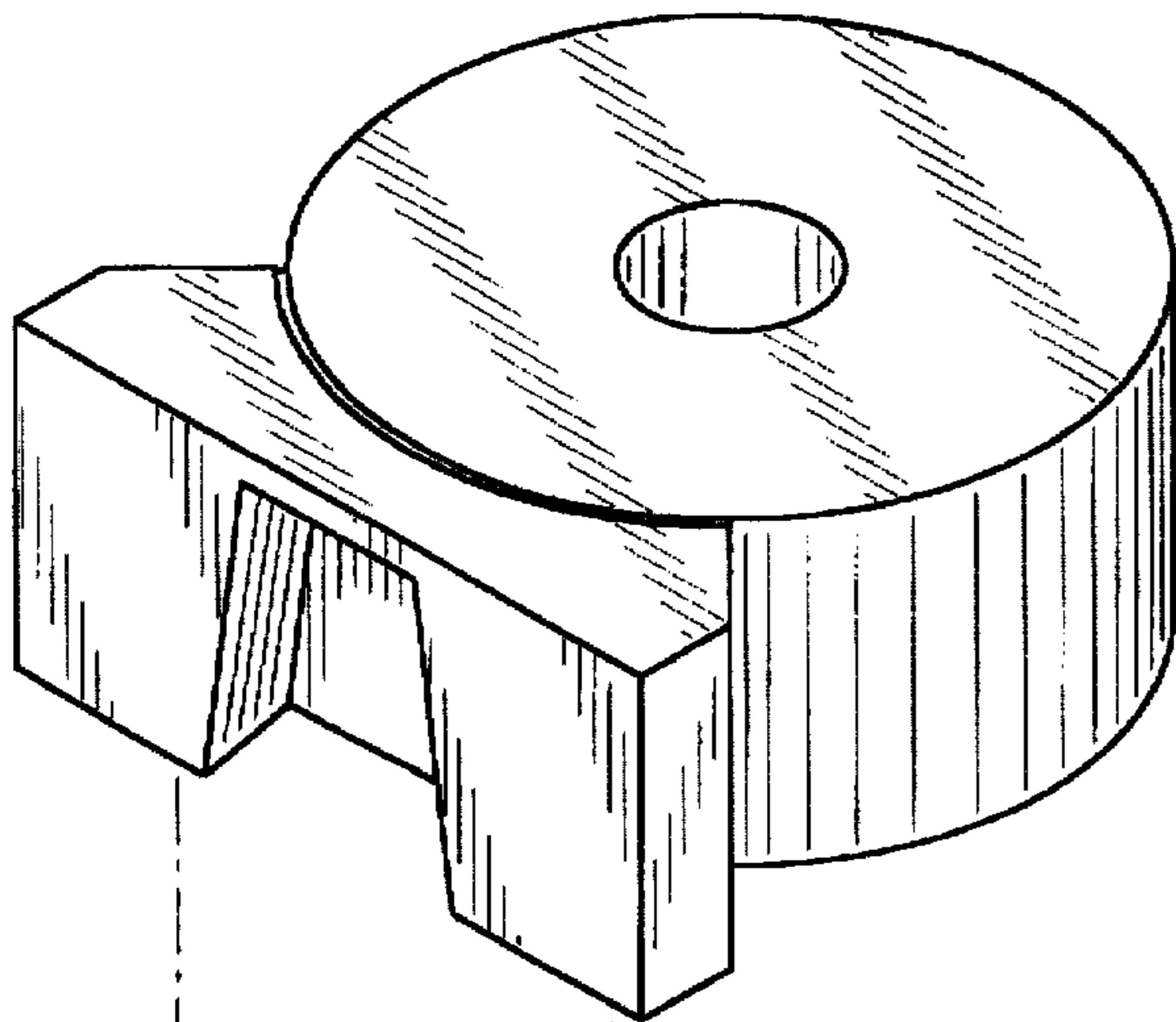

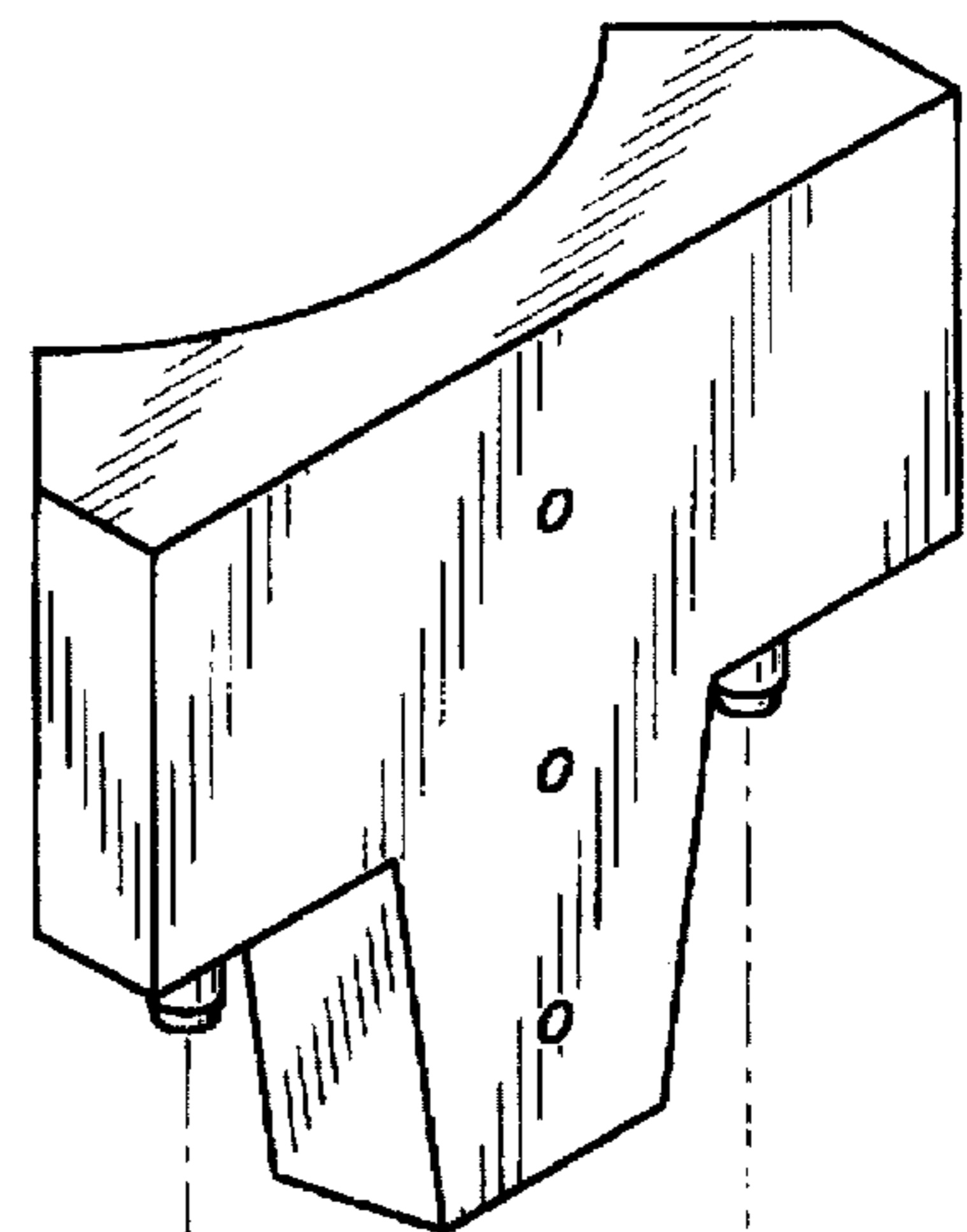
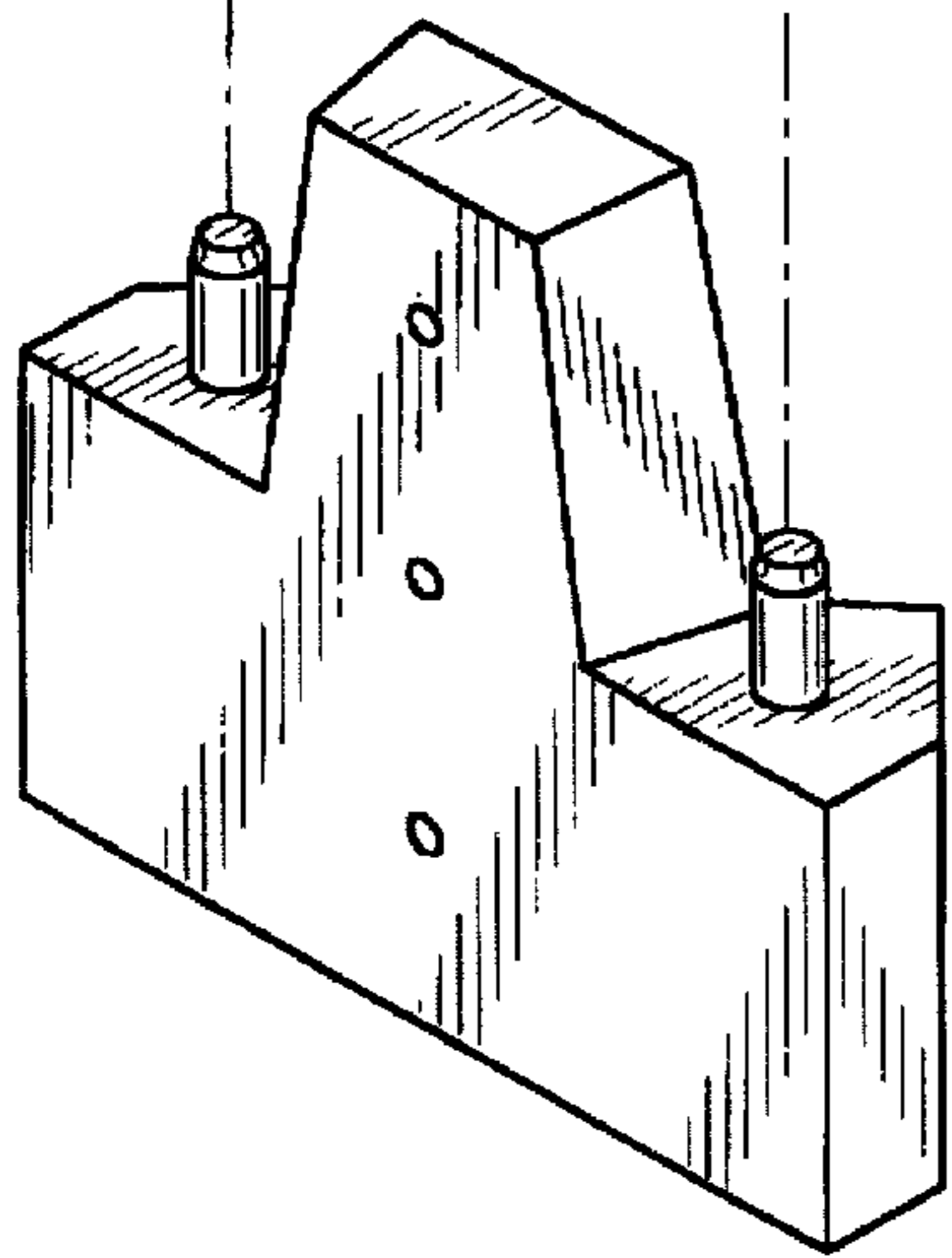
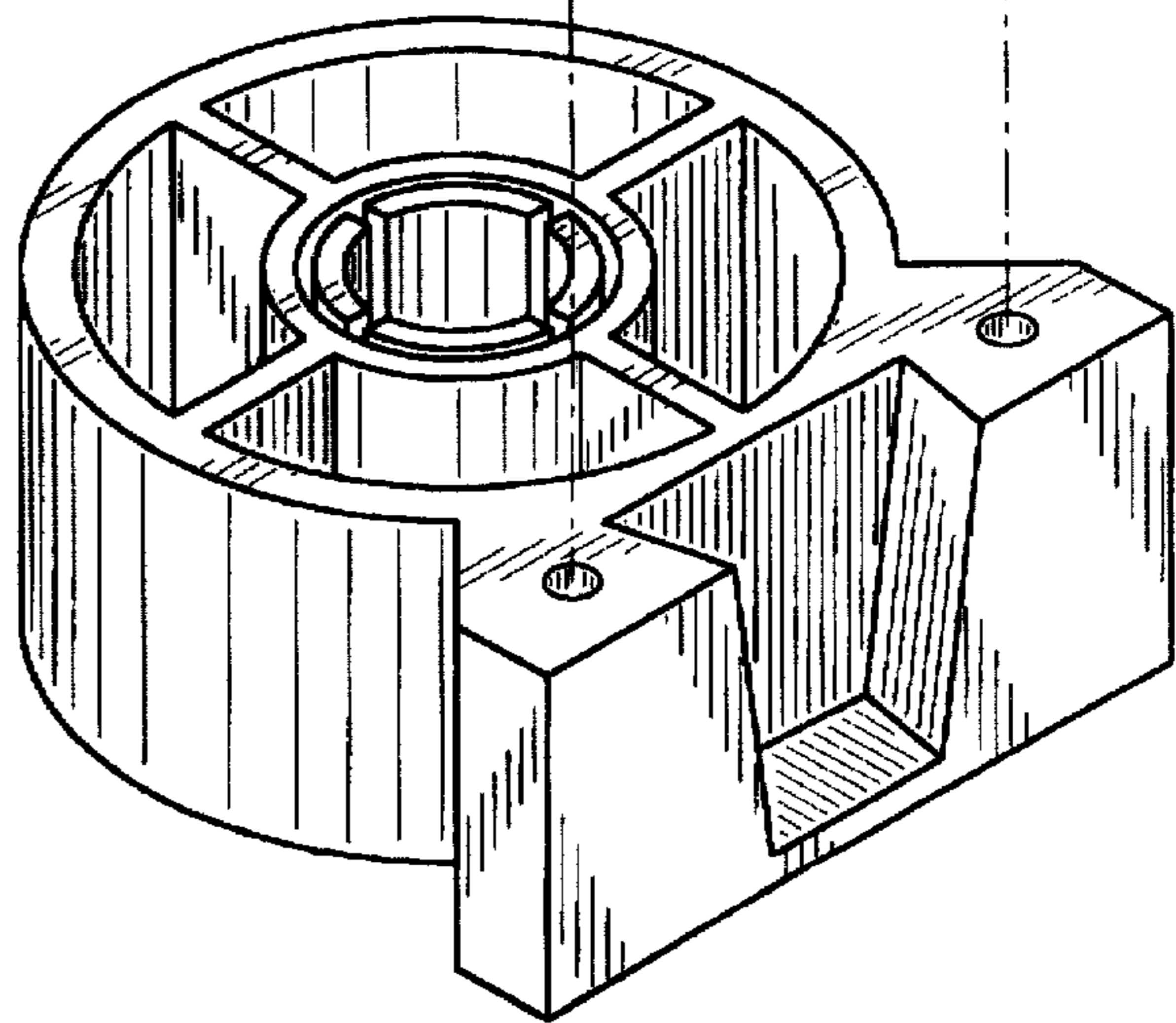

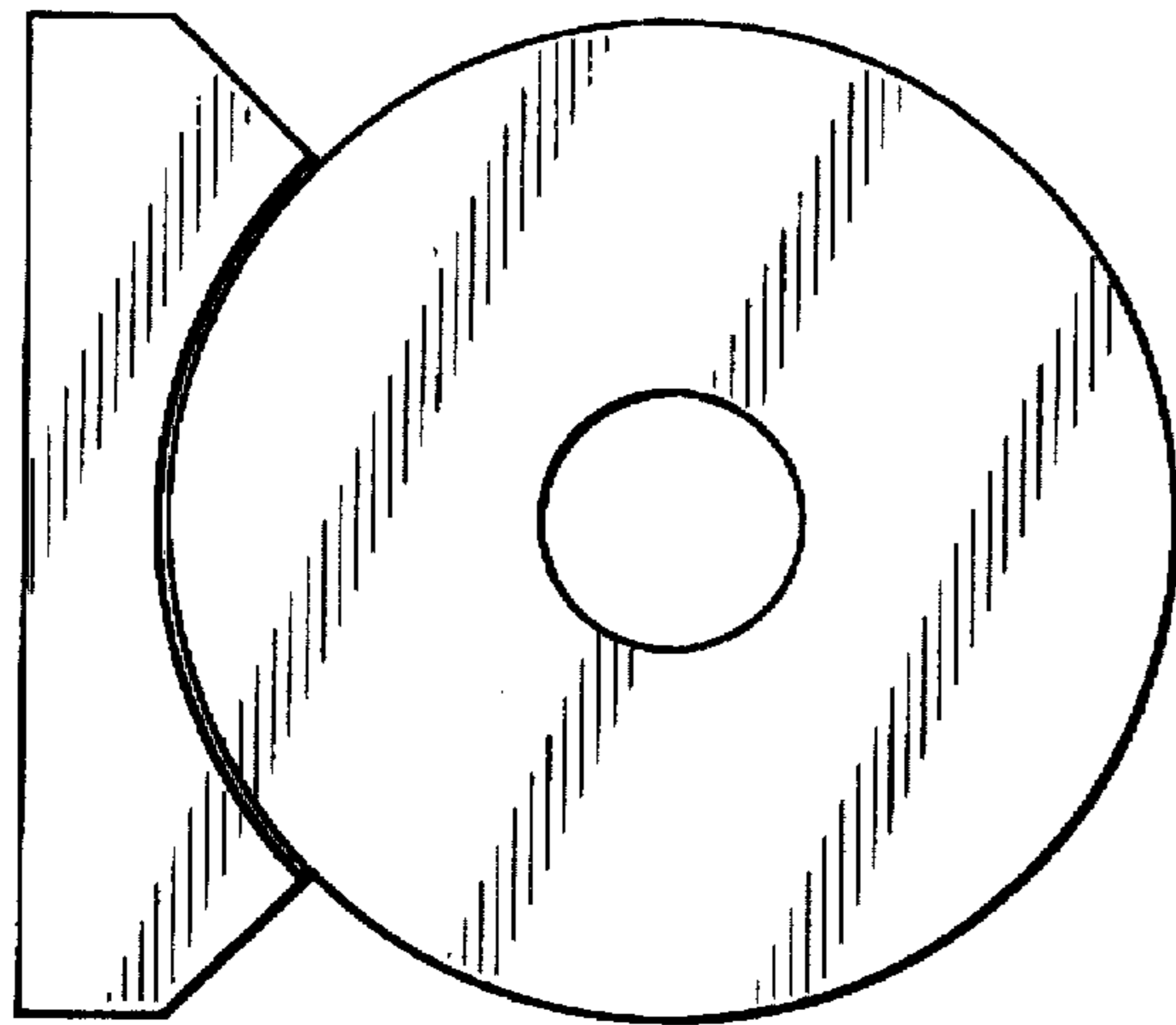

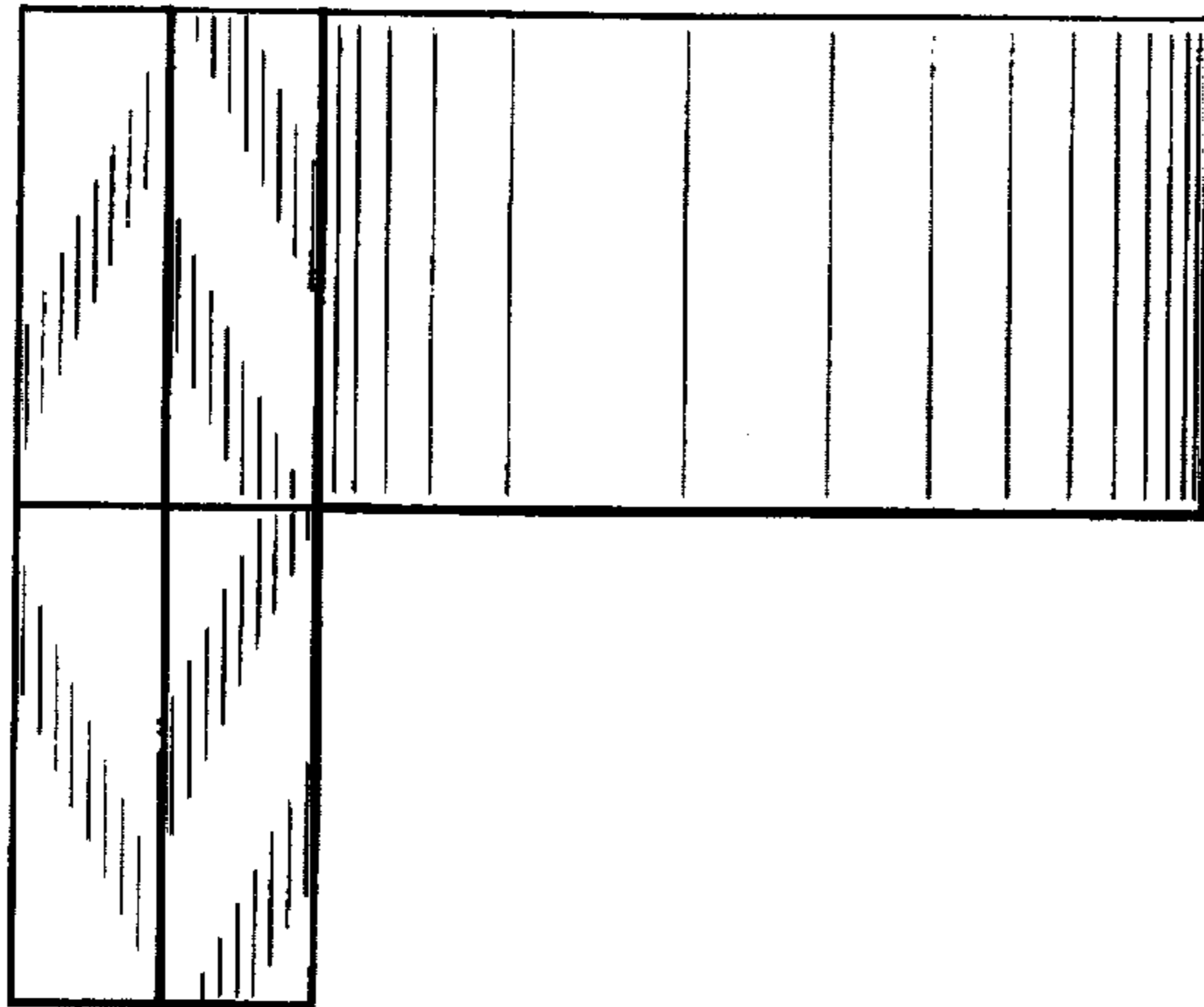

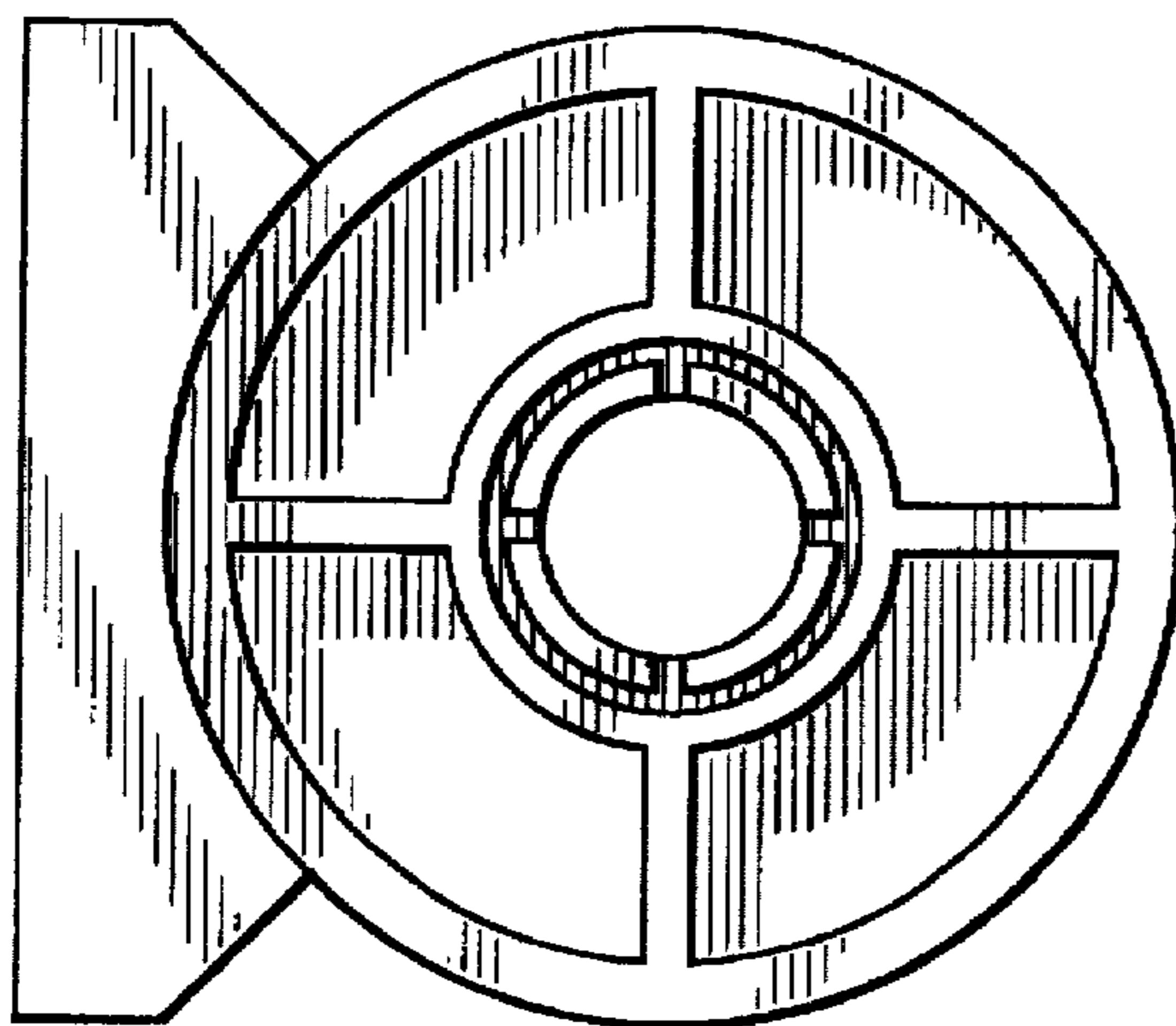

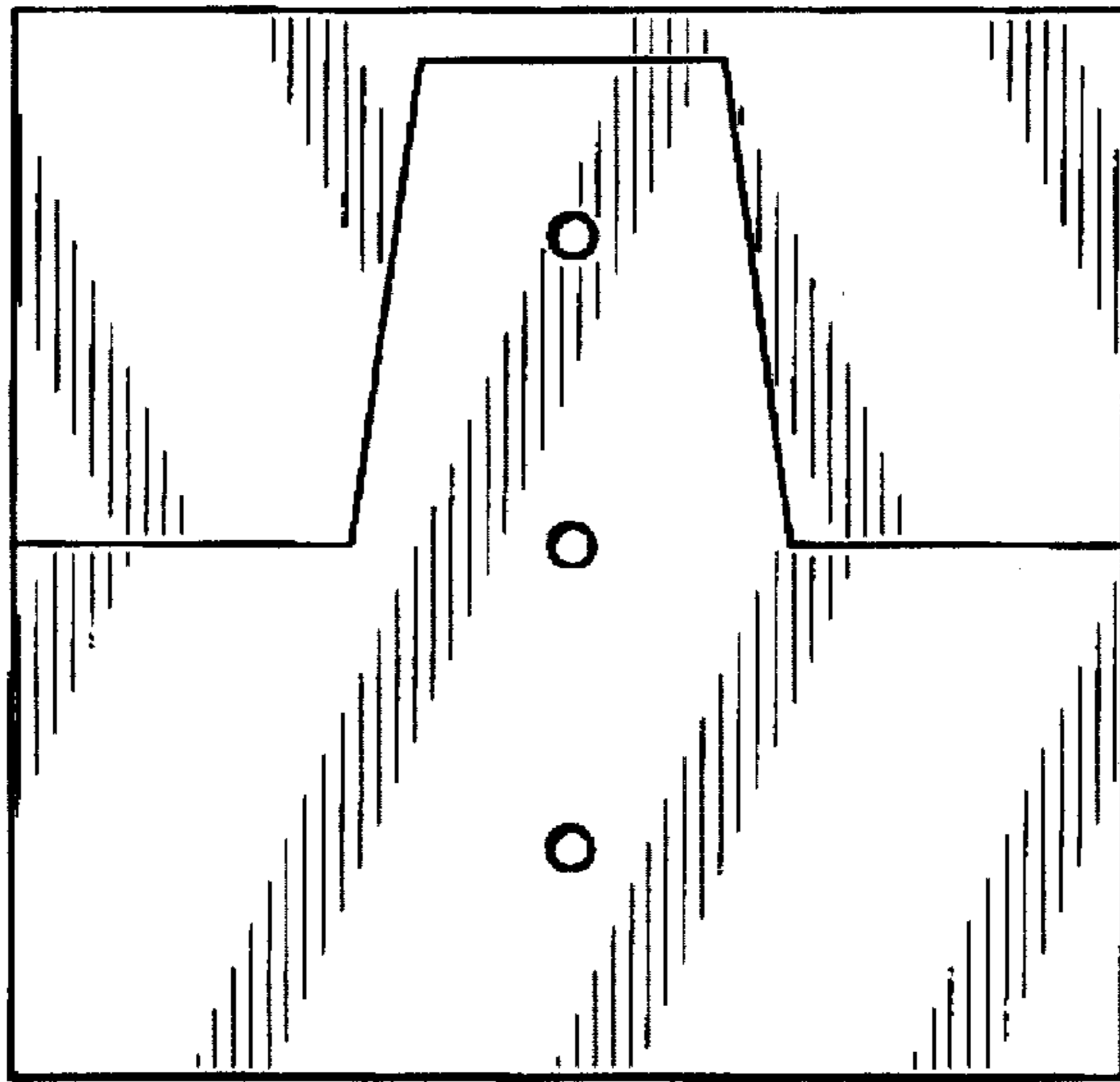

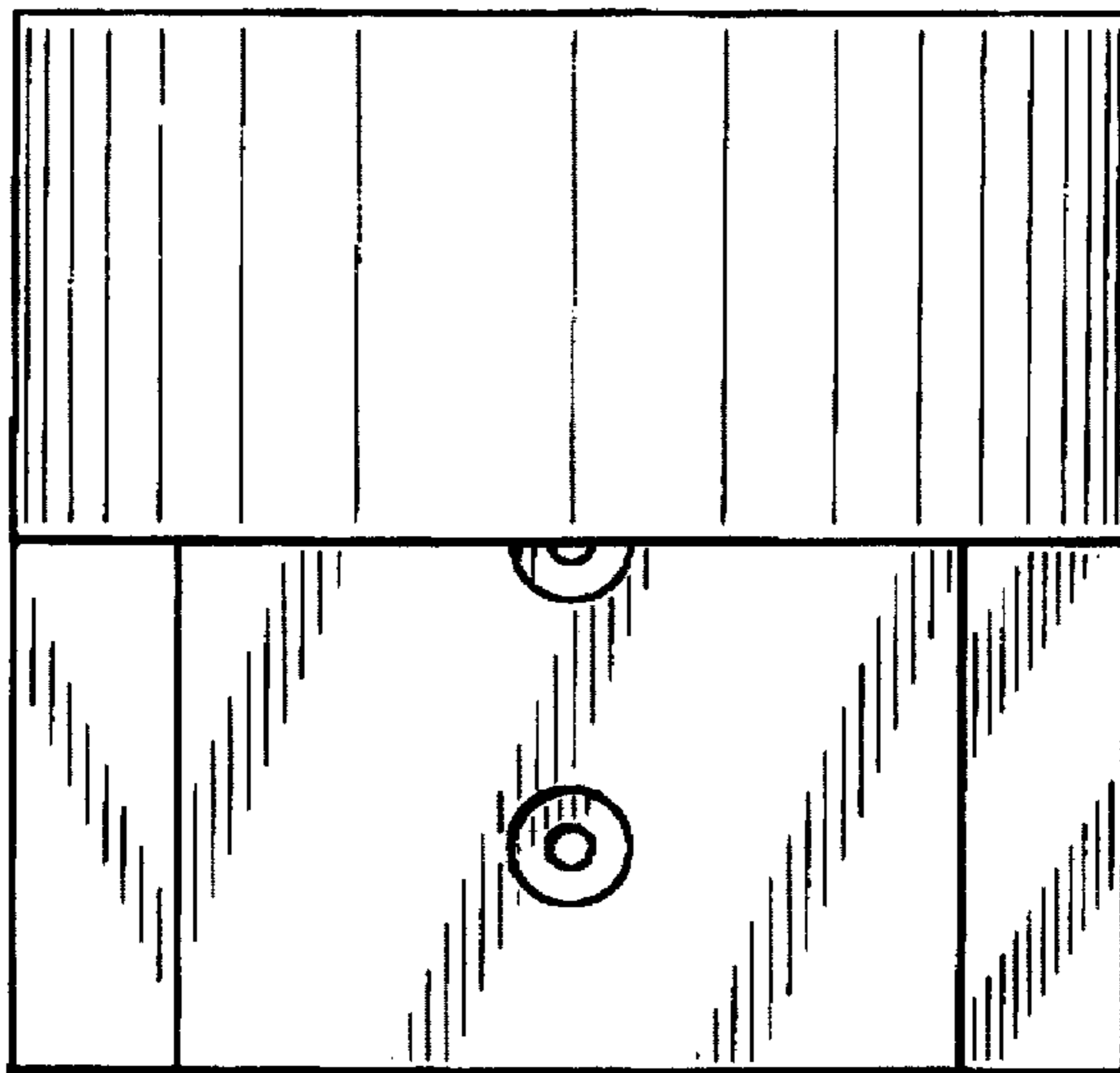
