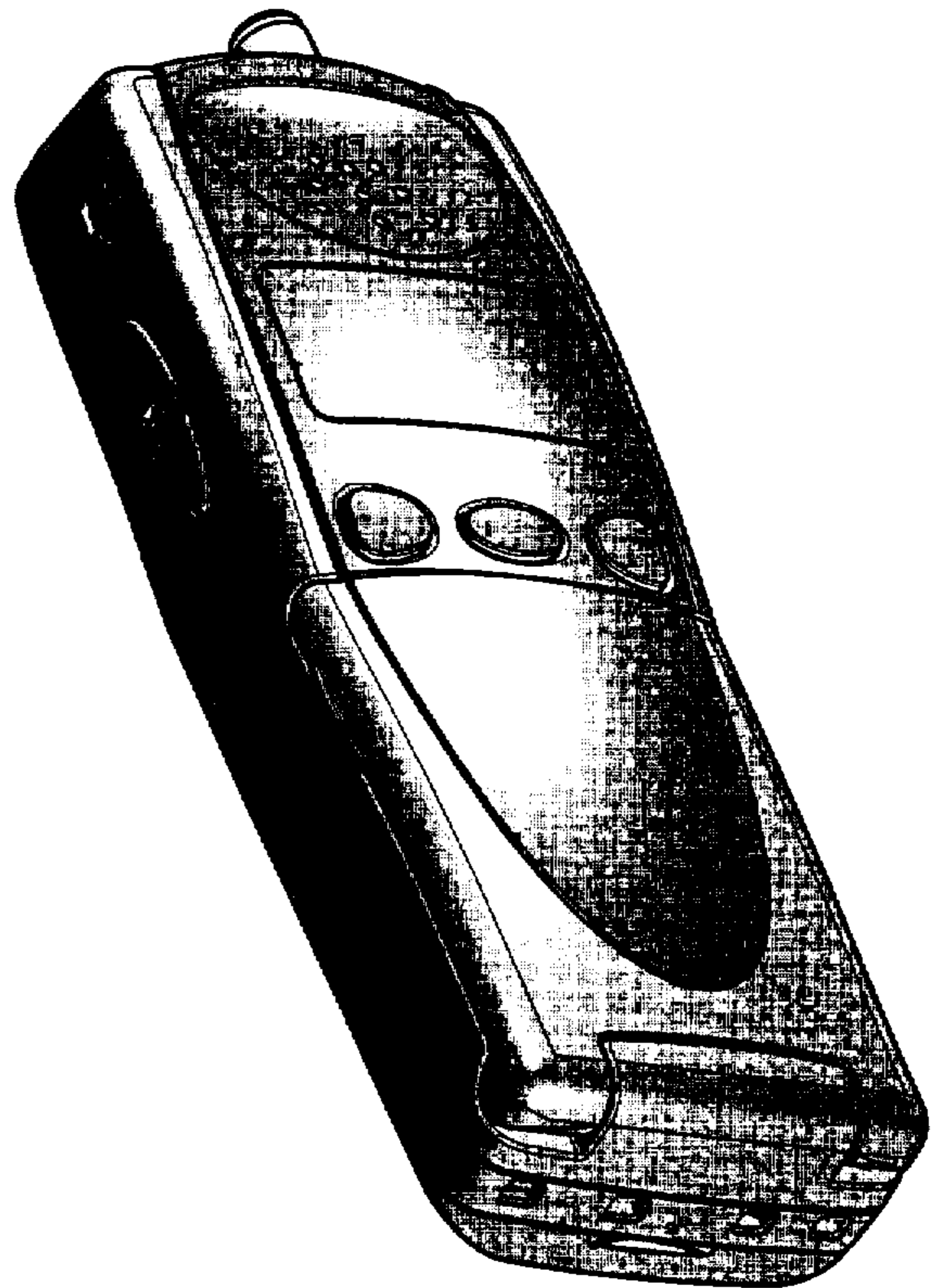
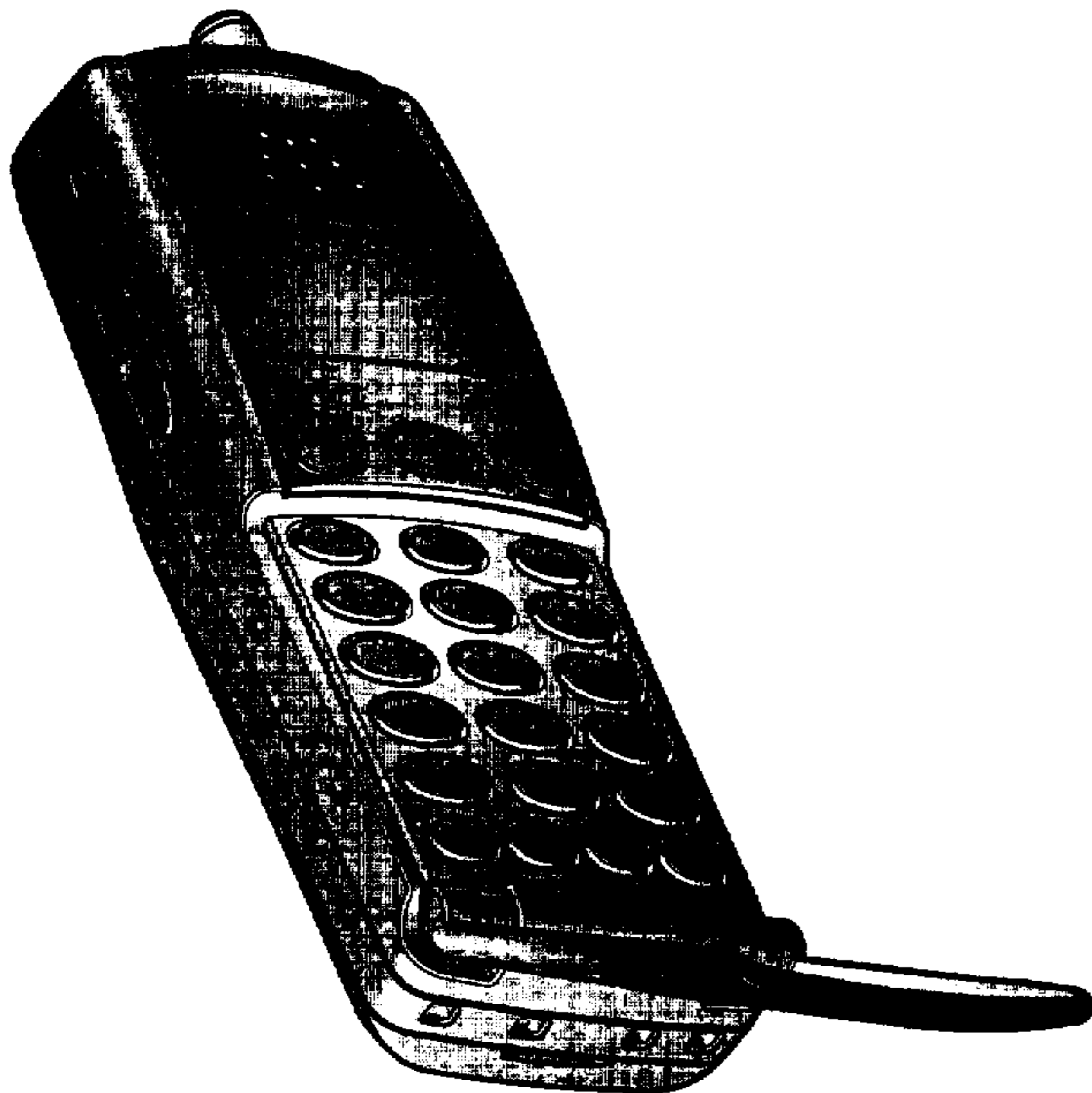
[57] **CLAIM**

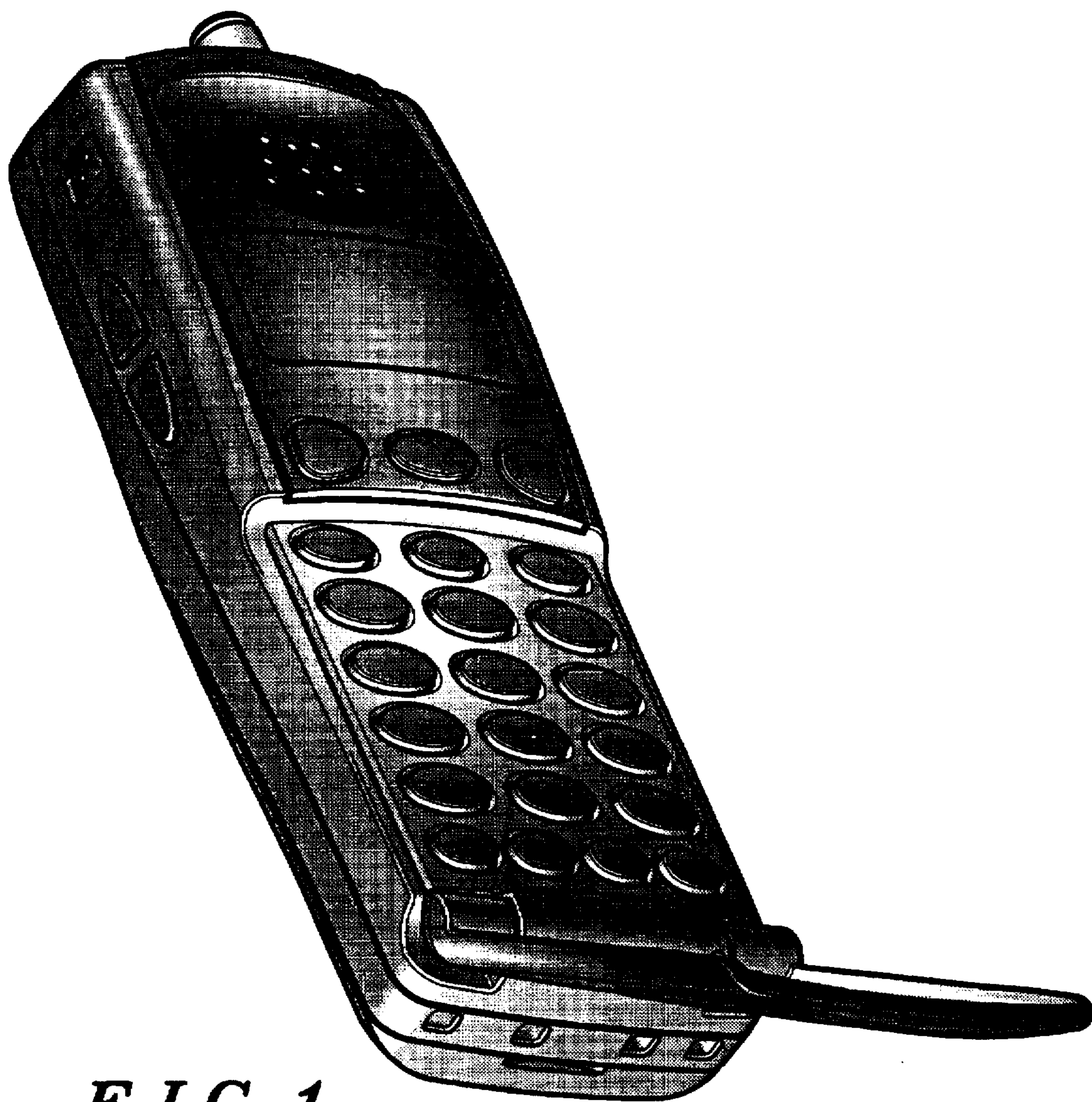
The ornamental design for a portable telephone handset with removable escutcheon elements, as shown and described.

**DESCRIPTION**

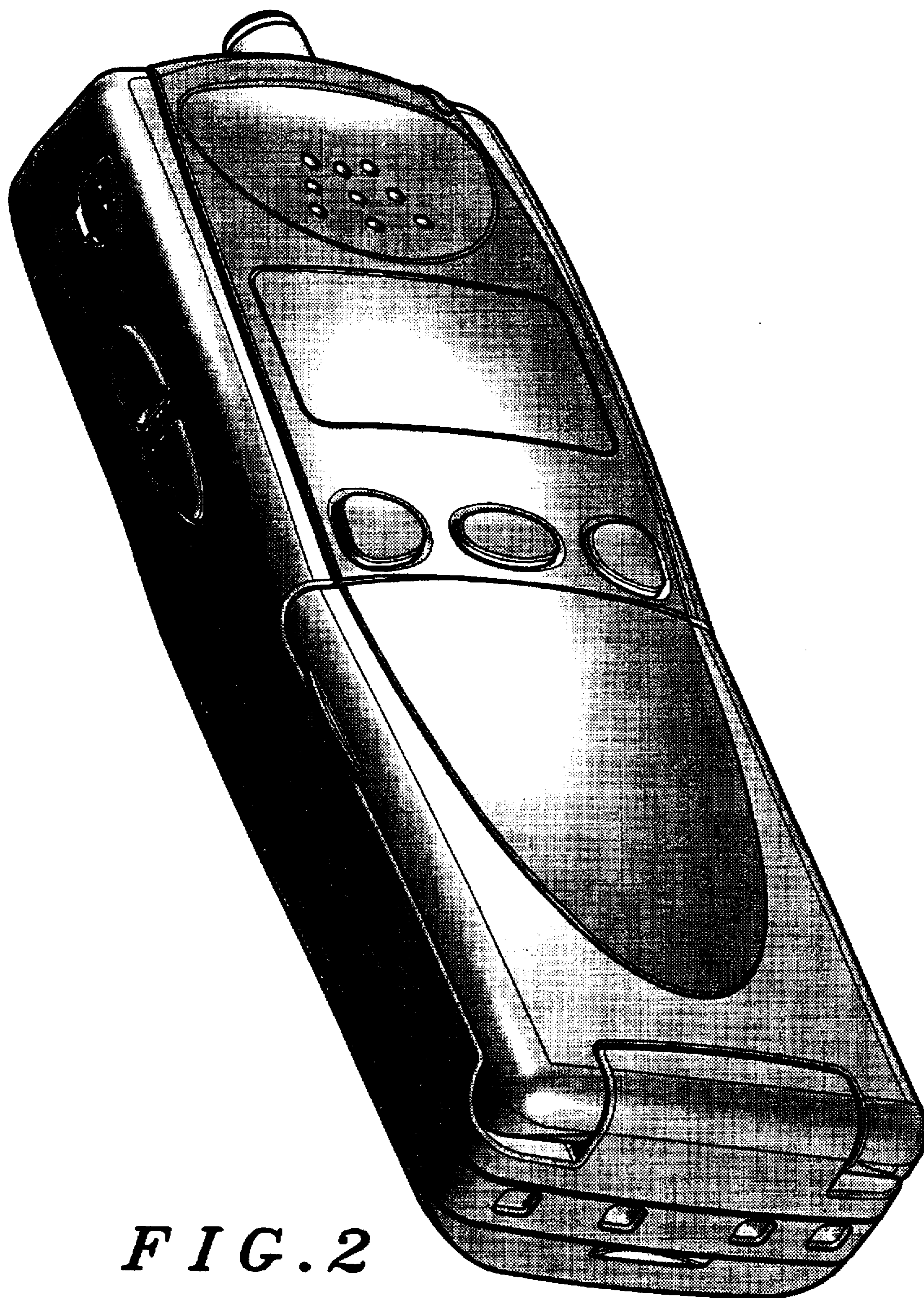
FIG. 1 is a left, front, bottom view of a portable telephone handset with removable escutcheon elements showing our new design, with a keypad cover in an open position; FIG. 2 is a left, front, bottom, view thereof, with the keypad cover in a closed position; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; and, FIG. 5 is a top plan view thereof.

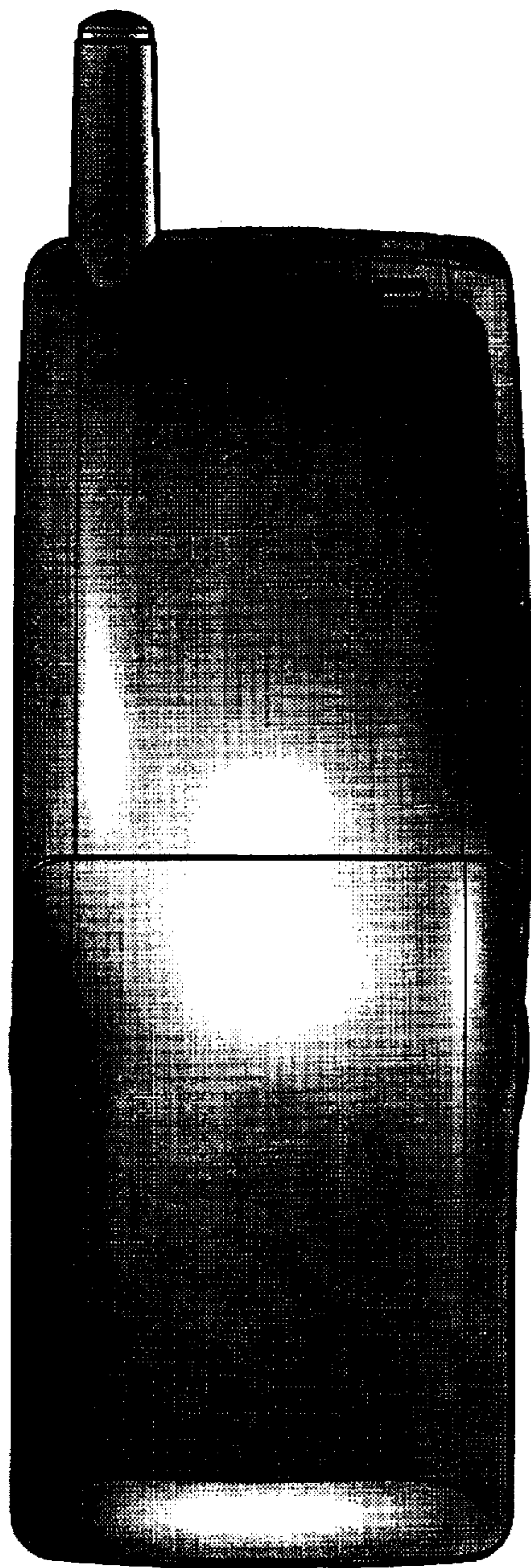




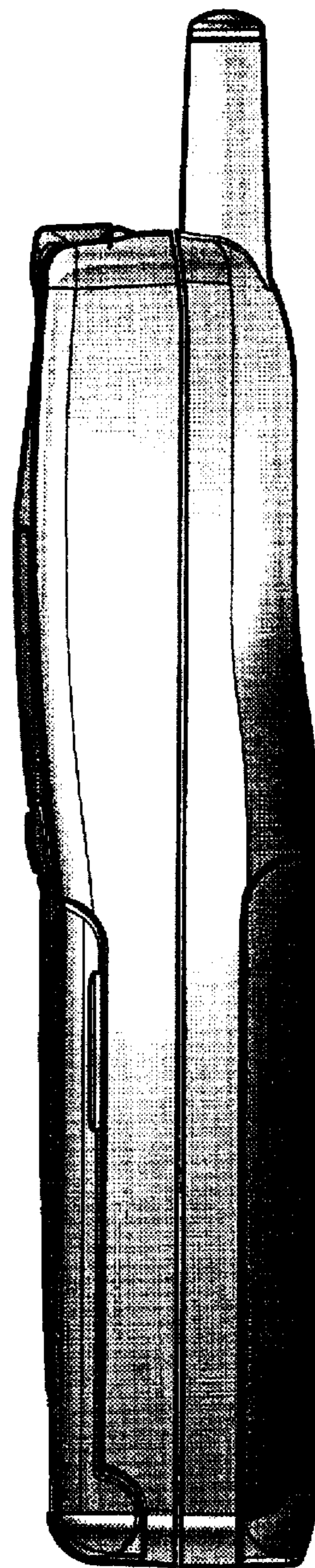

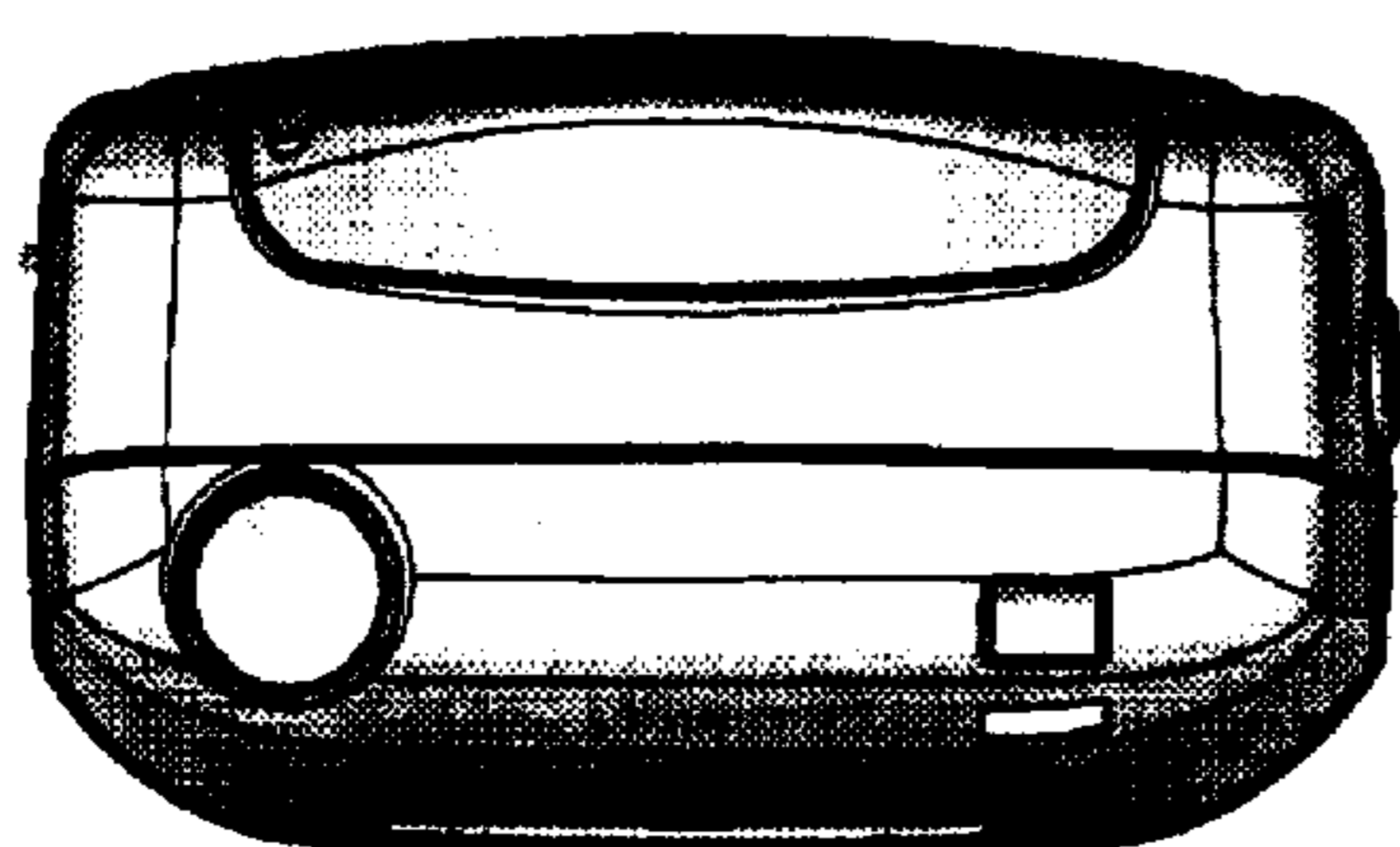
