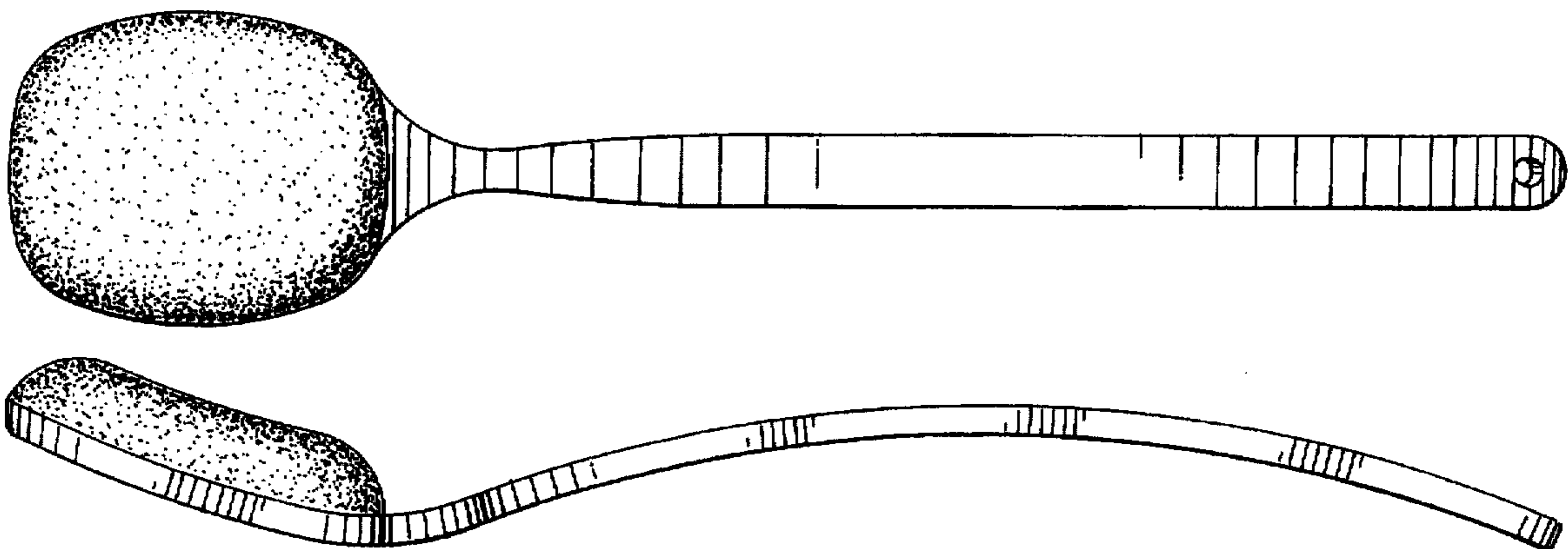
[57] **CLAIM**

An ornamental design for a lotion applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a lotion applicator showing my new design;  
FIG. 2 is a side elevation view of the lotion applicator of FIG. 1;  
FIG. 3 is a left end view of the lotion applicator of FIG. 1;  
FIG. 4 is a right end view of the lotion applicator of FIG. 1; and,  
FIG. 5 is a bottom plan view of the lotion applicator of FIG. 1.

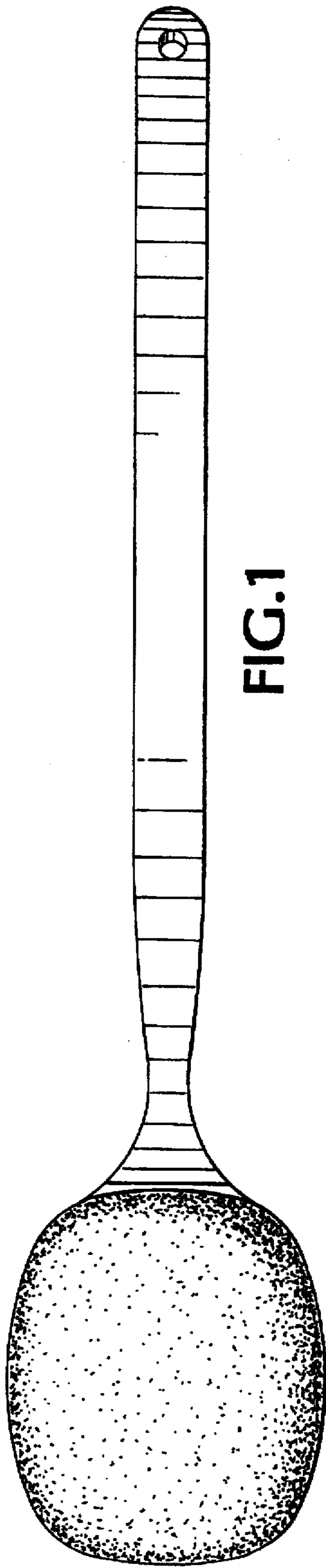

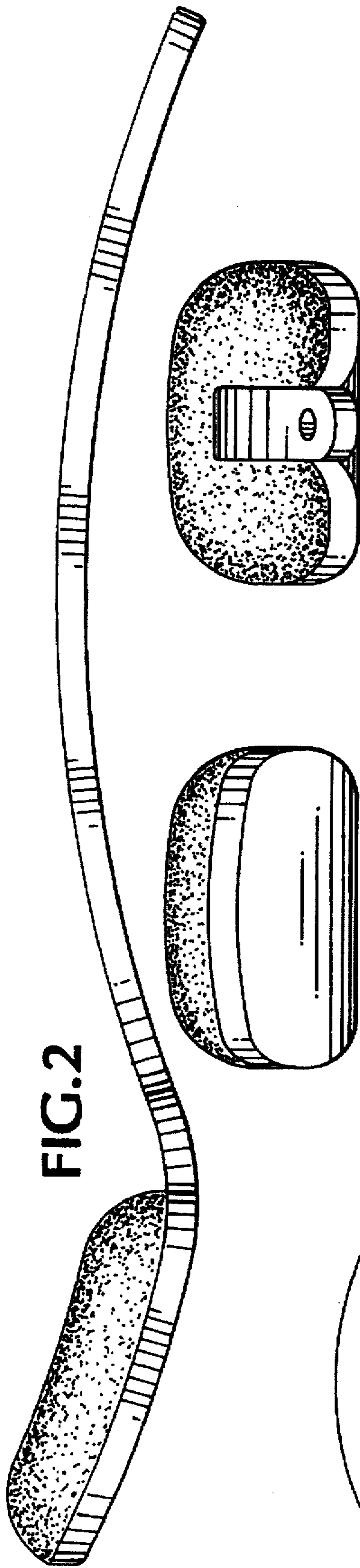

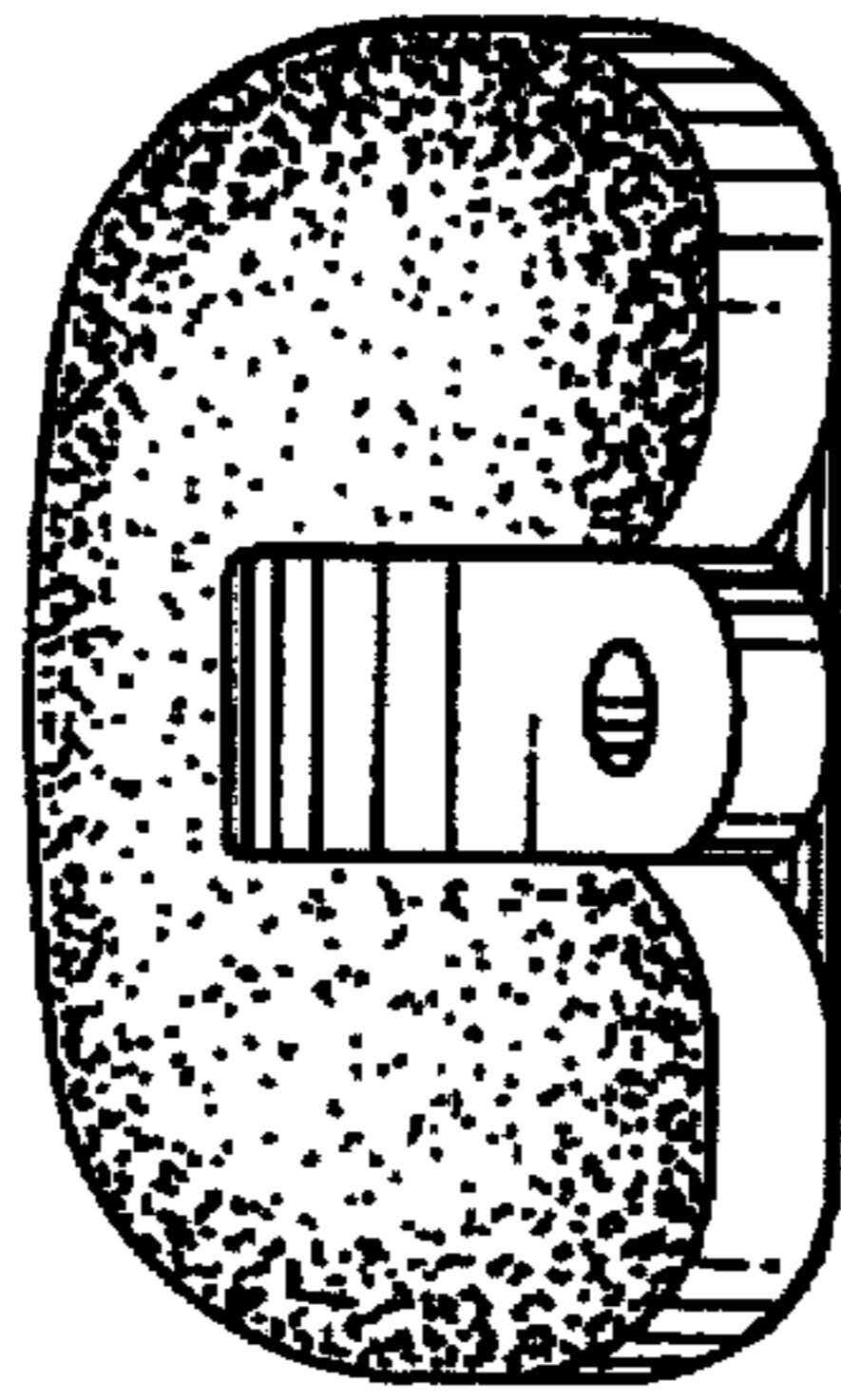

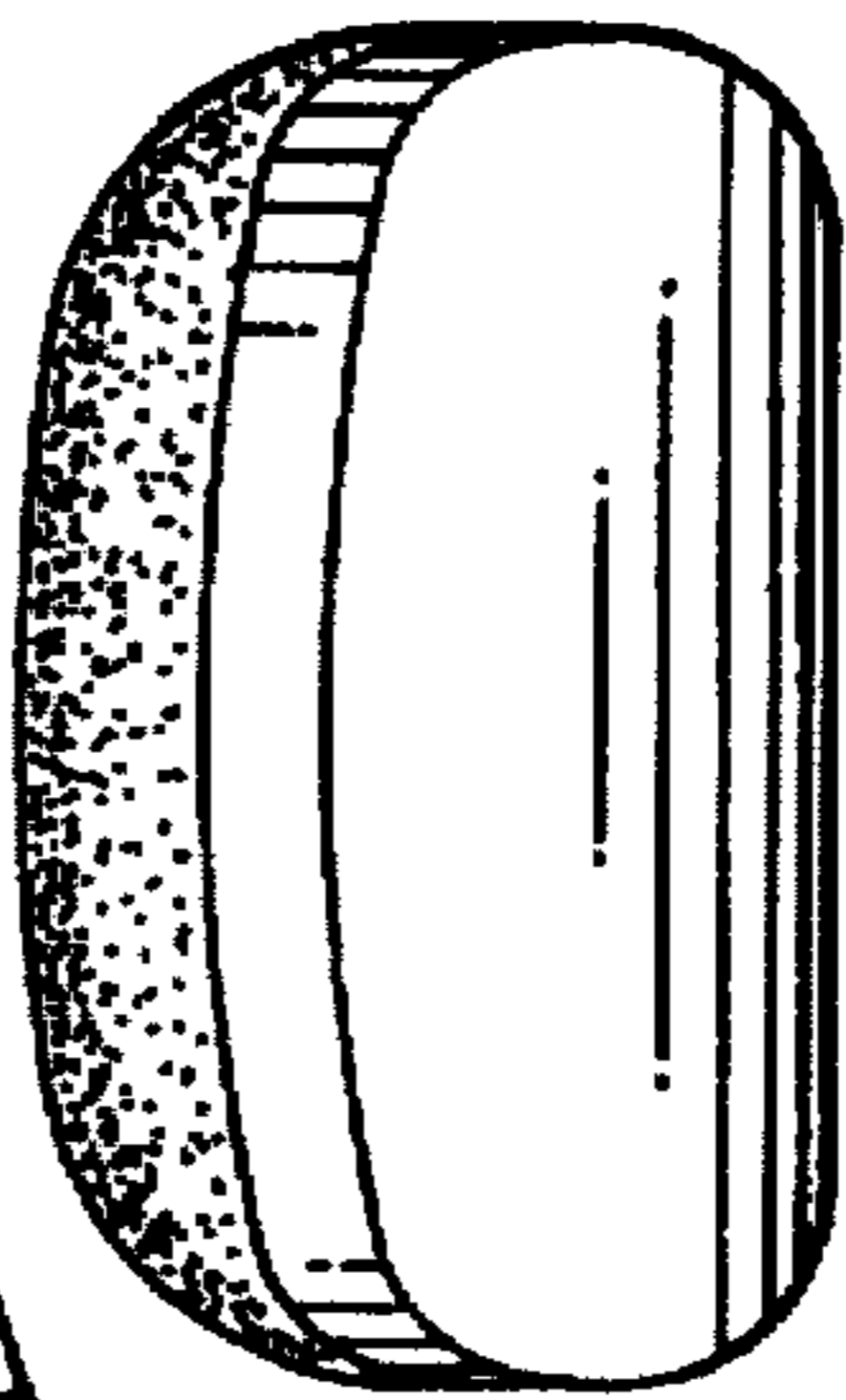

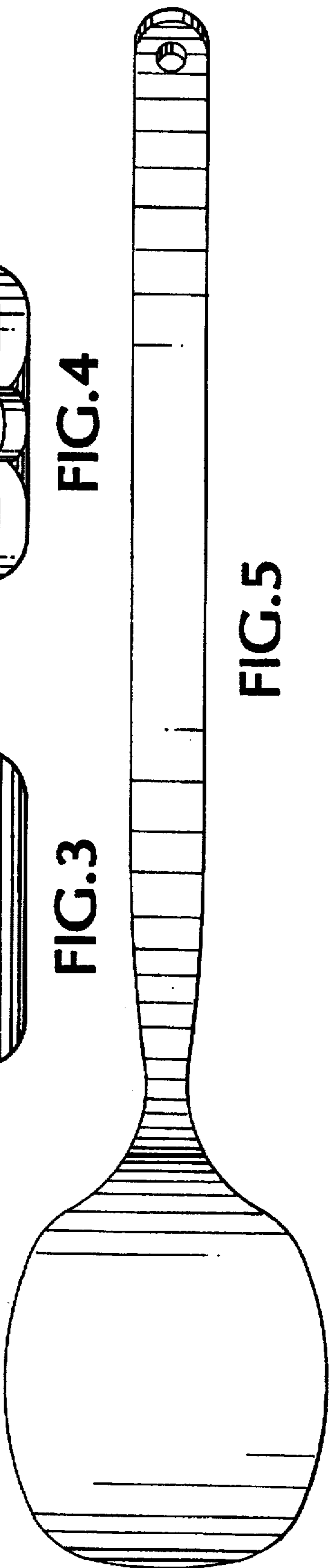
