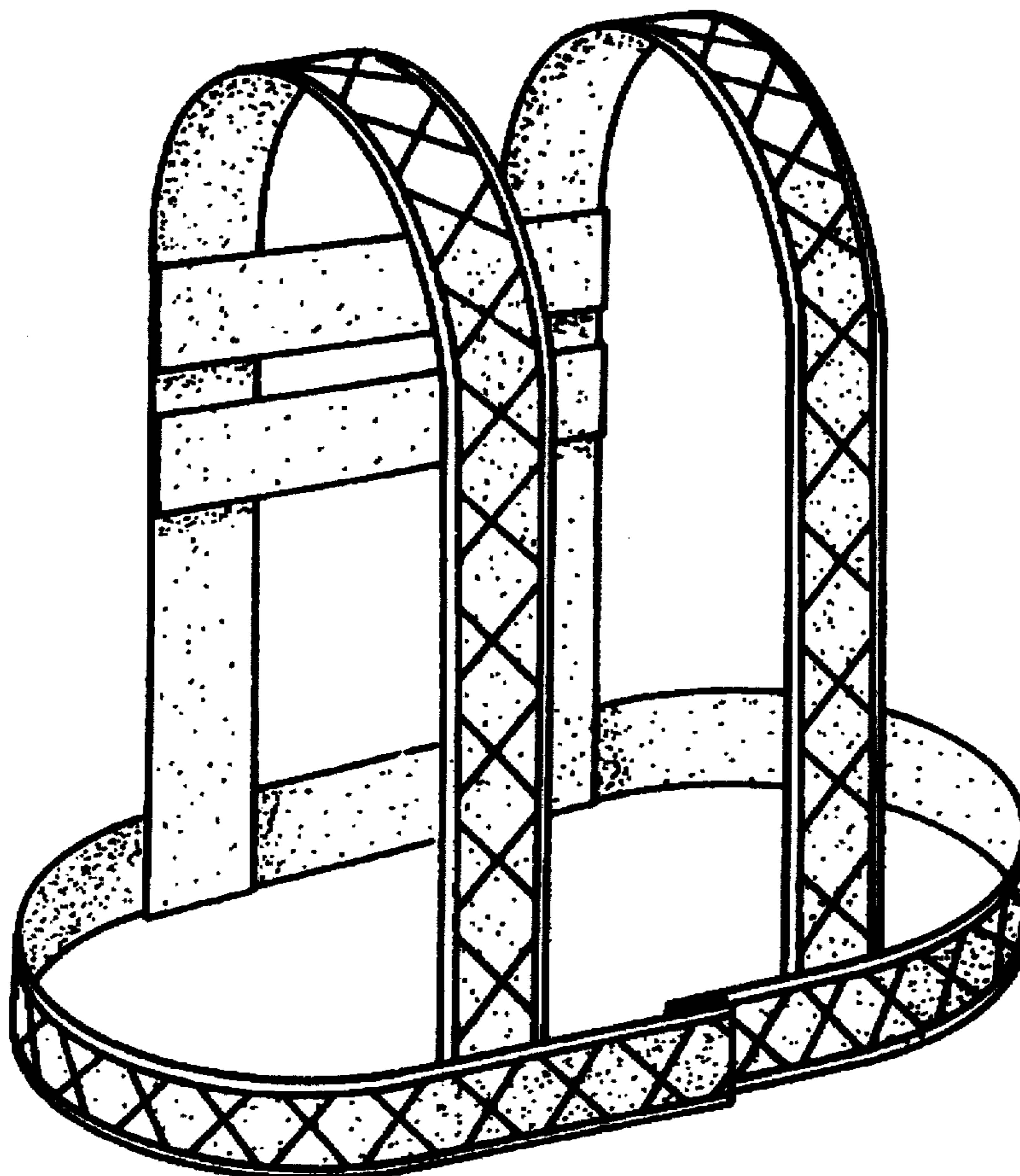
### [57] CLAIM

### DESCRIPTION

FIG. 1 is a front perspective view of the reflective harness showing my new design;  
FIG. 2 is a rear elevational view thereof;

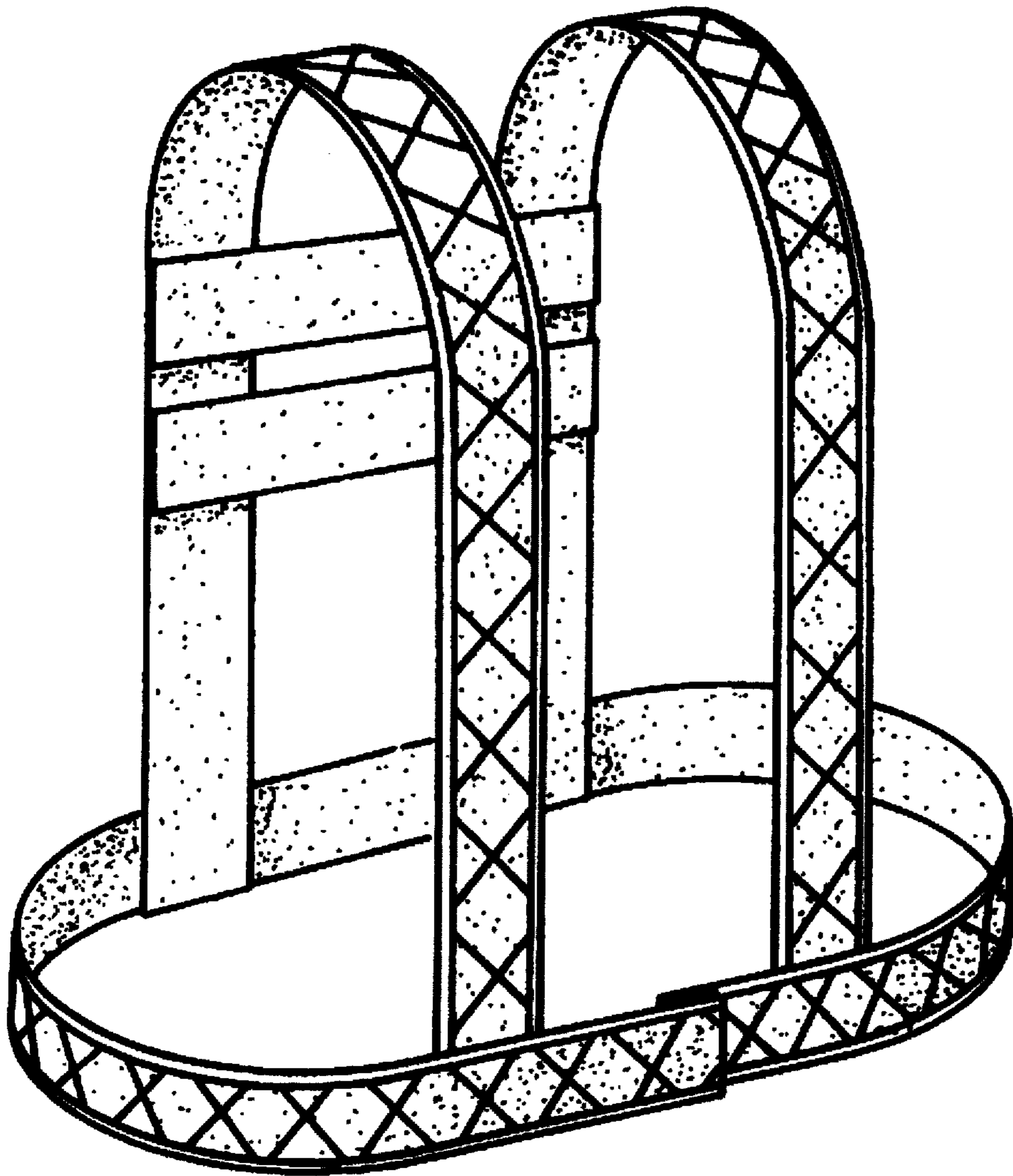

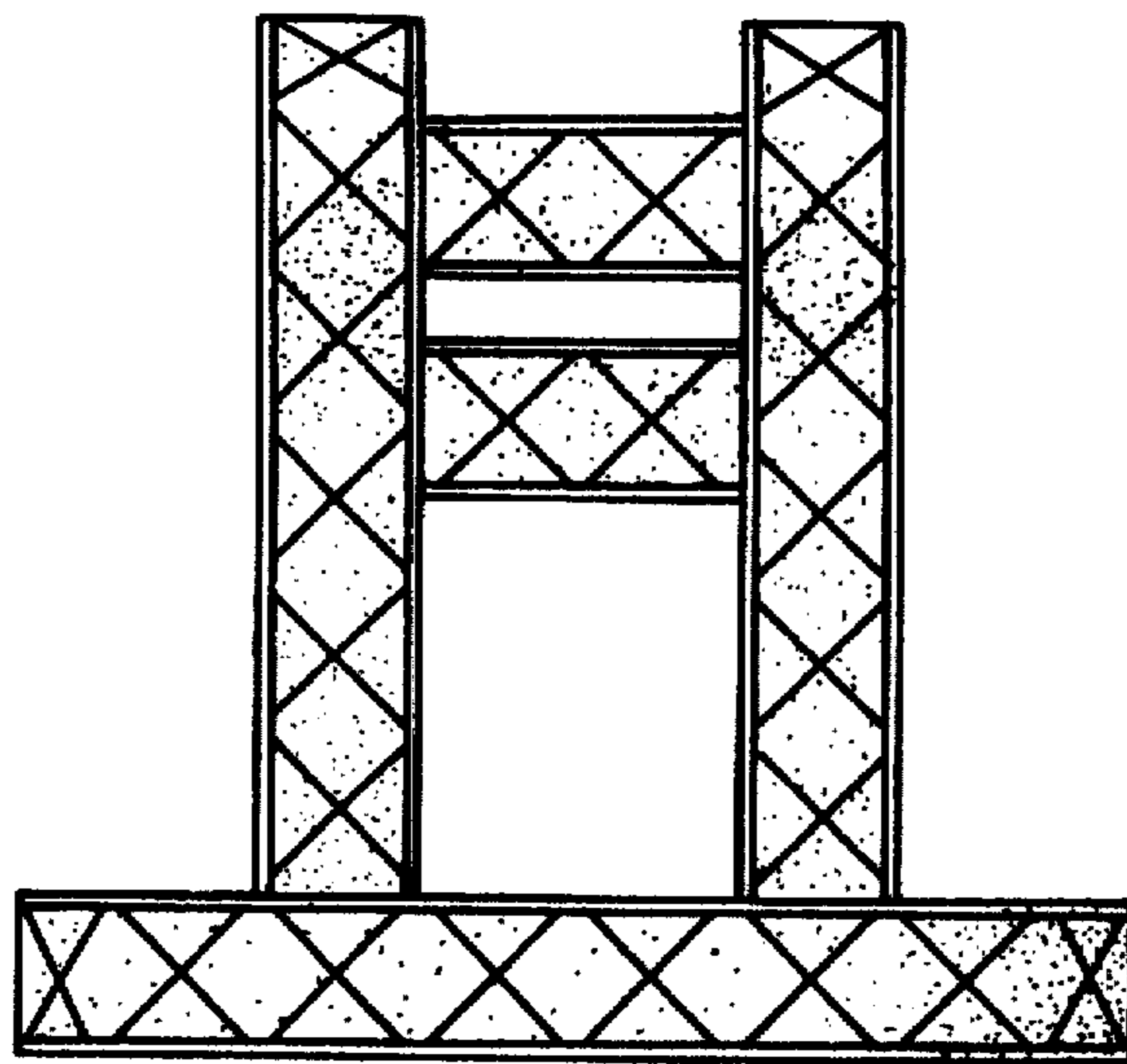

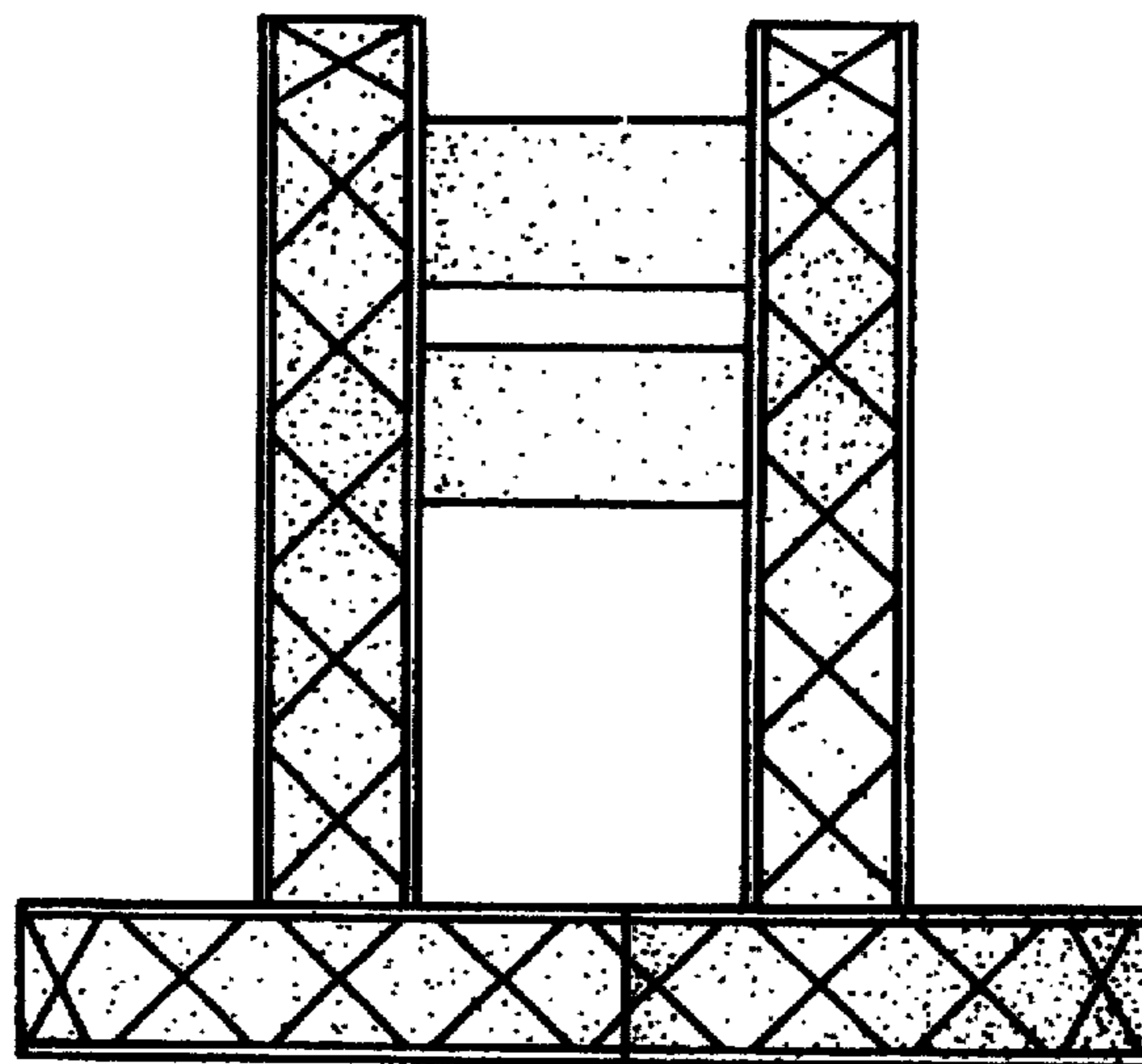

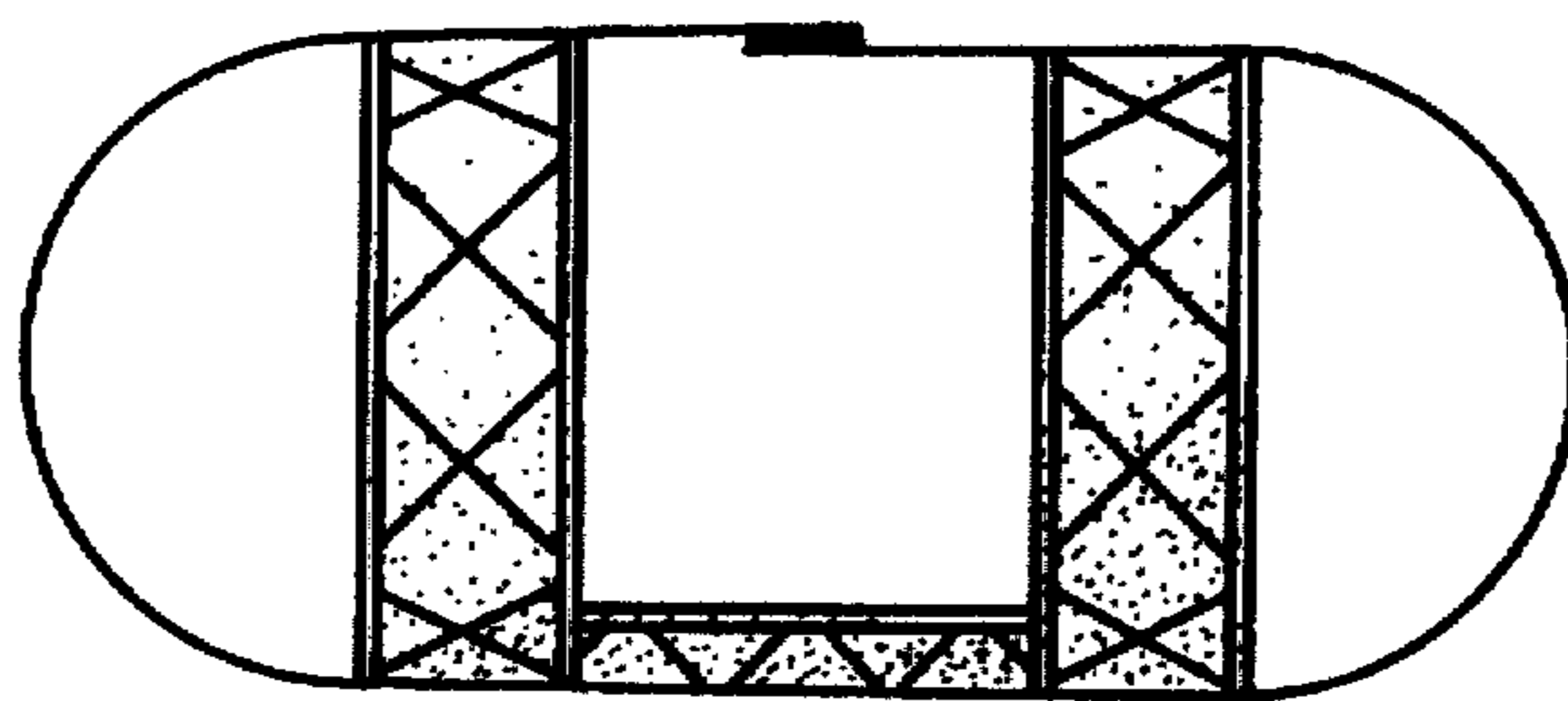

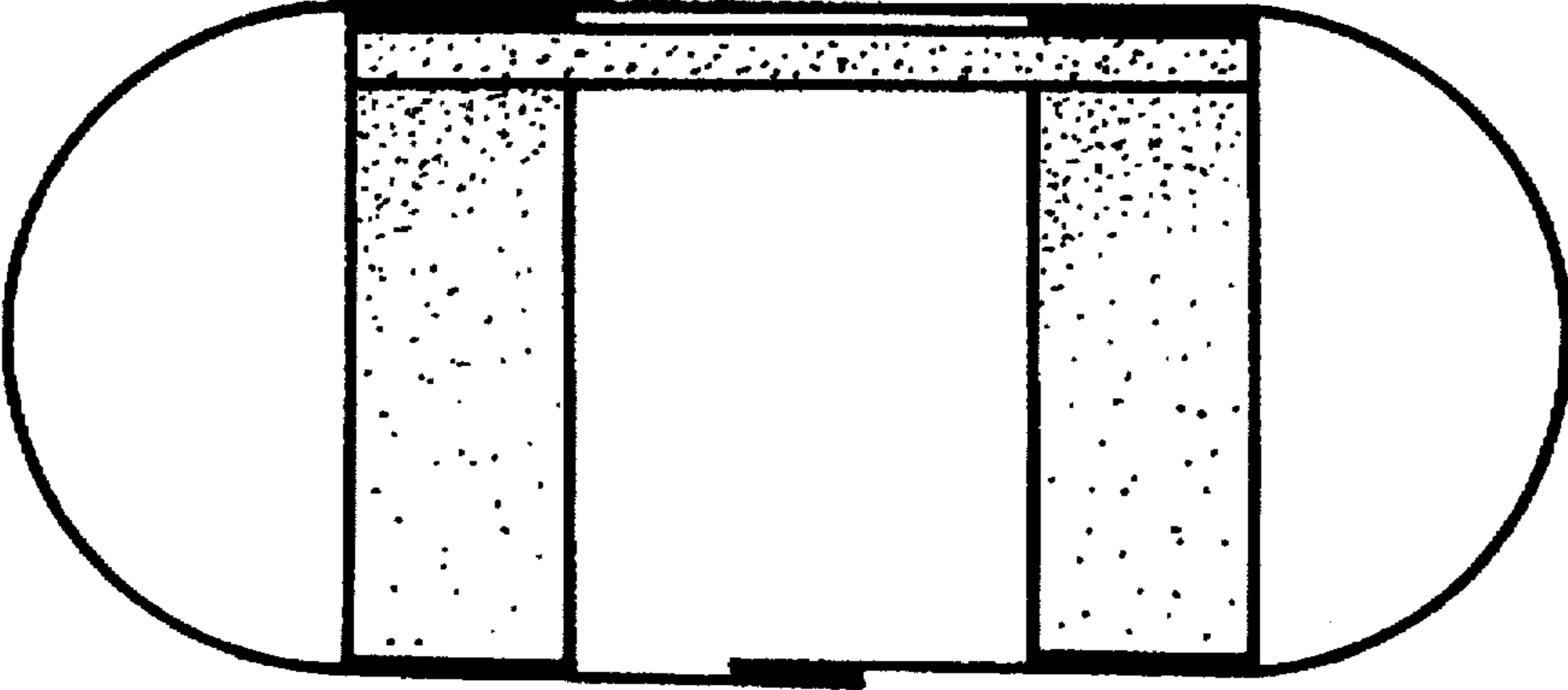

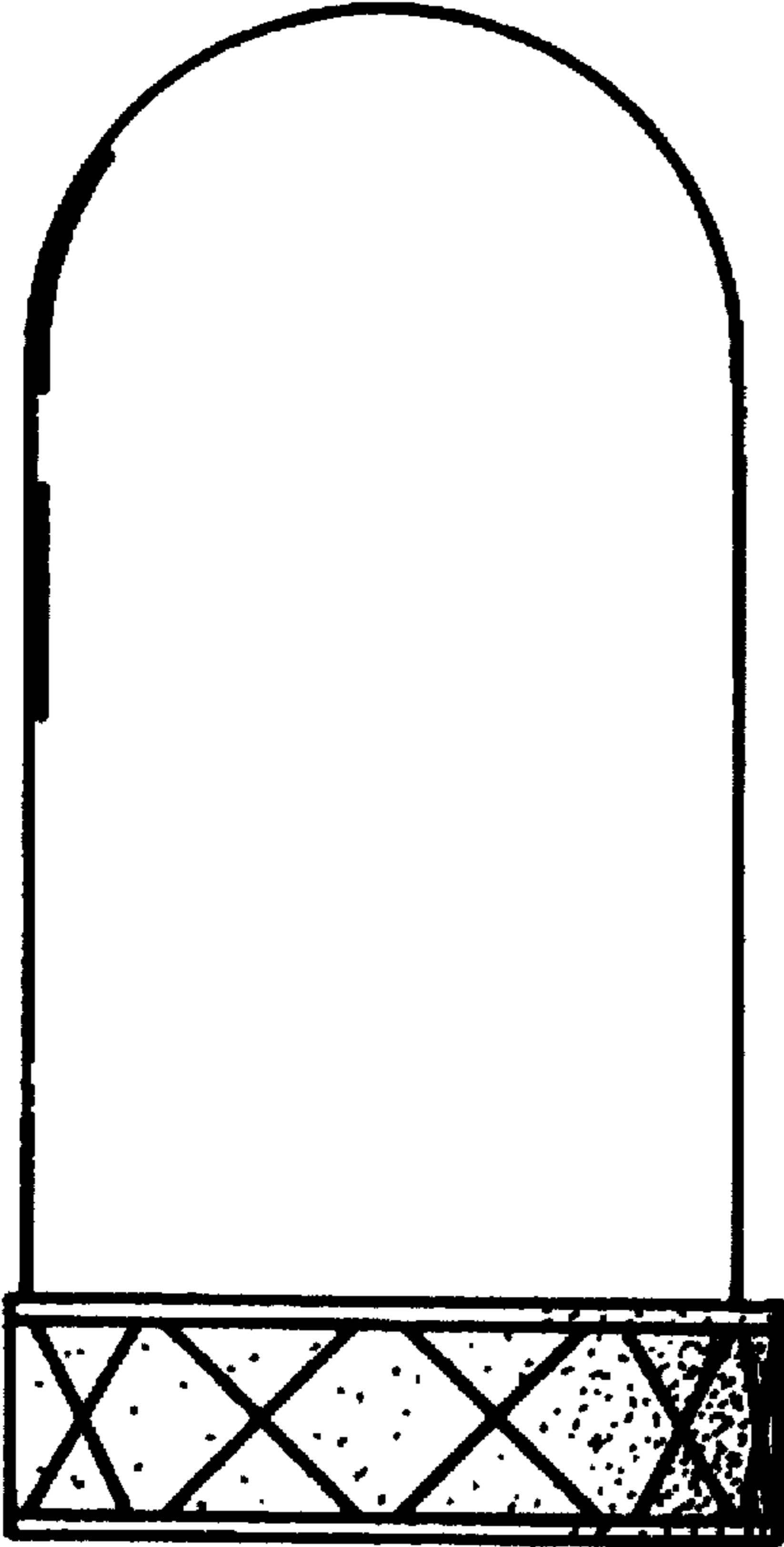

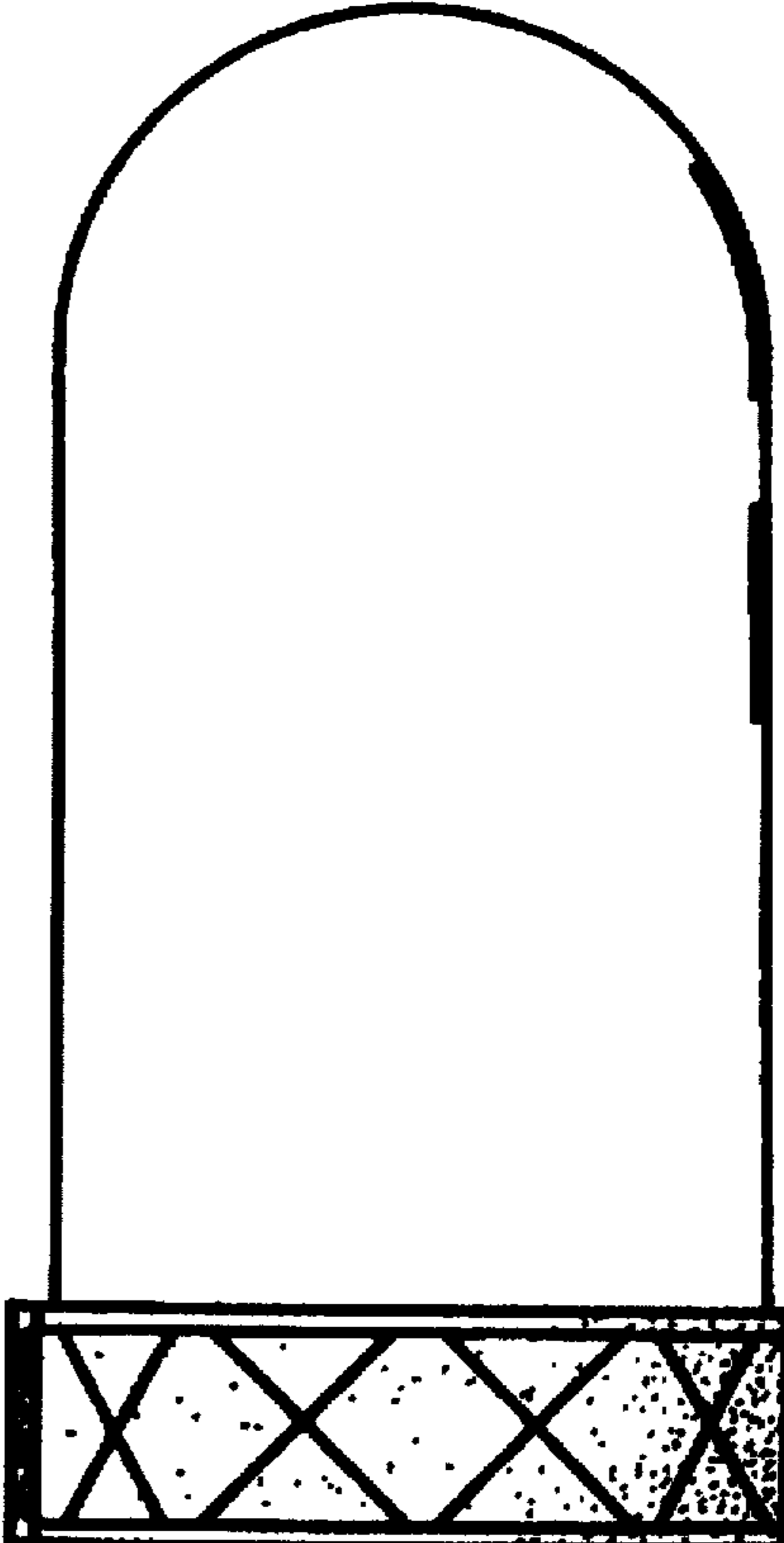
