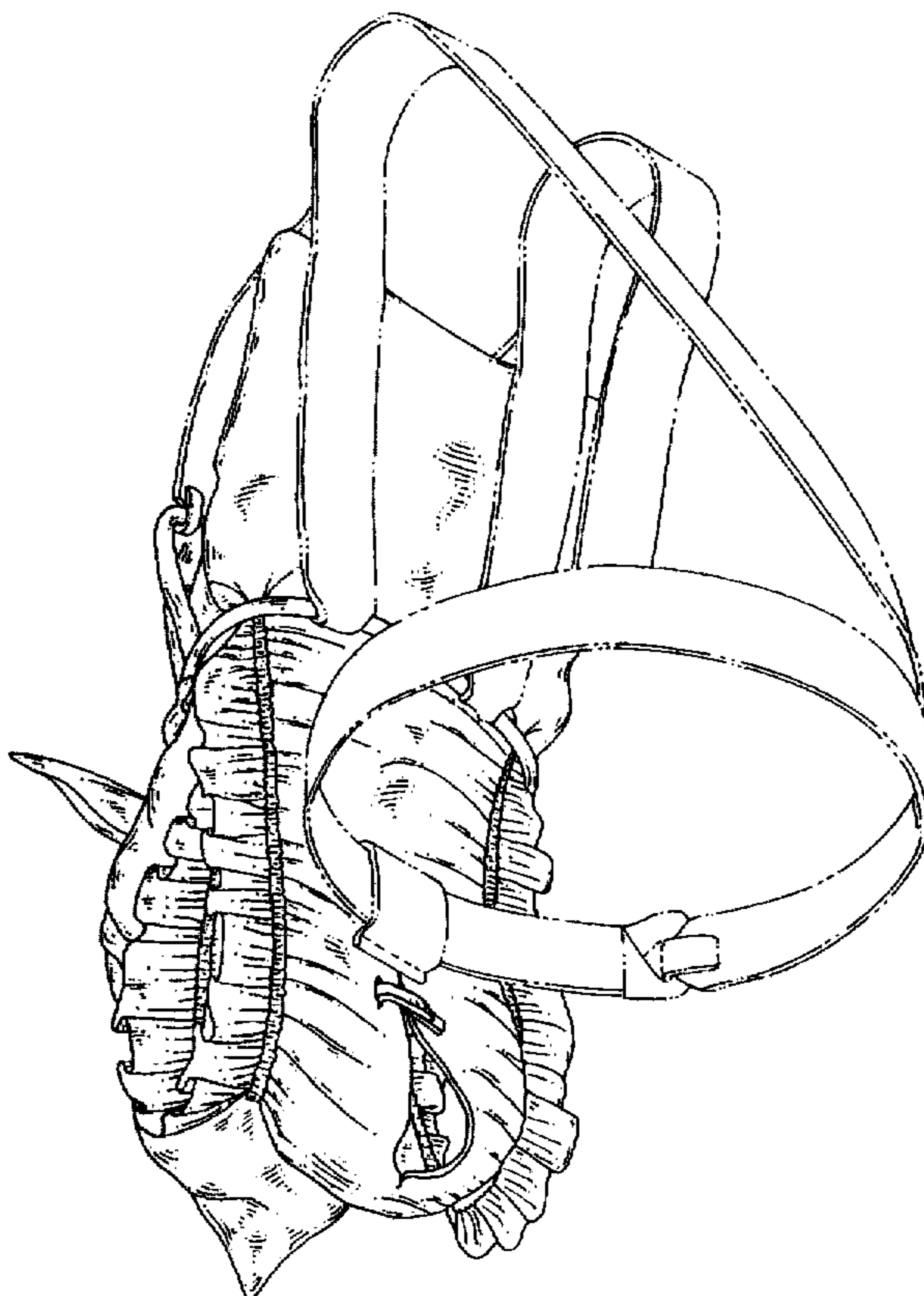
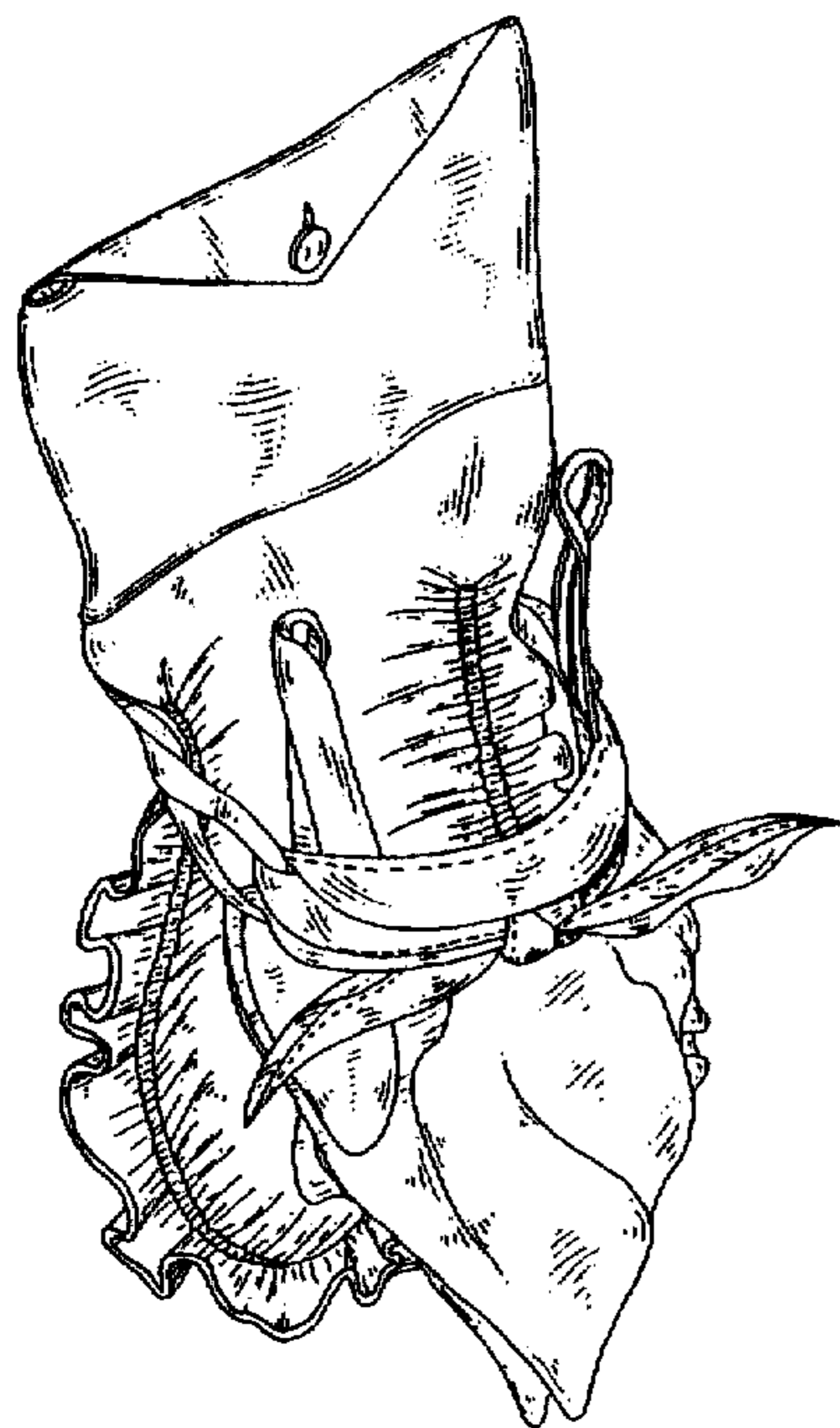

FIG. 1 is a perspective front view of the pet carrier;  
 FIG. 2 is a perspective rear view of the pet carrier;  
 FIG. 3 is a side view of the pet carrier;  
 FIG. 4 is a top view of the pet carrier;  
 FIG. 5 is a side view which is substantially a mirror image of the side view of FIG. 3;  
 FIG. 6 is a perspective front view of the pet carrier;  
 FIG. 7 is a perspective rear view of the pet carrier;  
 FIG. 8 is a side view of the pet carrier; and,  
 FIG. 9 is a top view of the pet carrier.  
 The broken line showing of the harness in FIGS. 6-9 is for illustrative purposes only and forms no part of the claimed design.

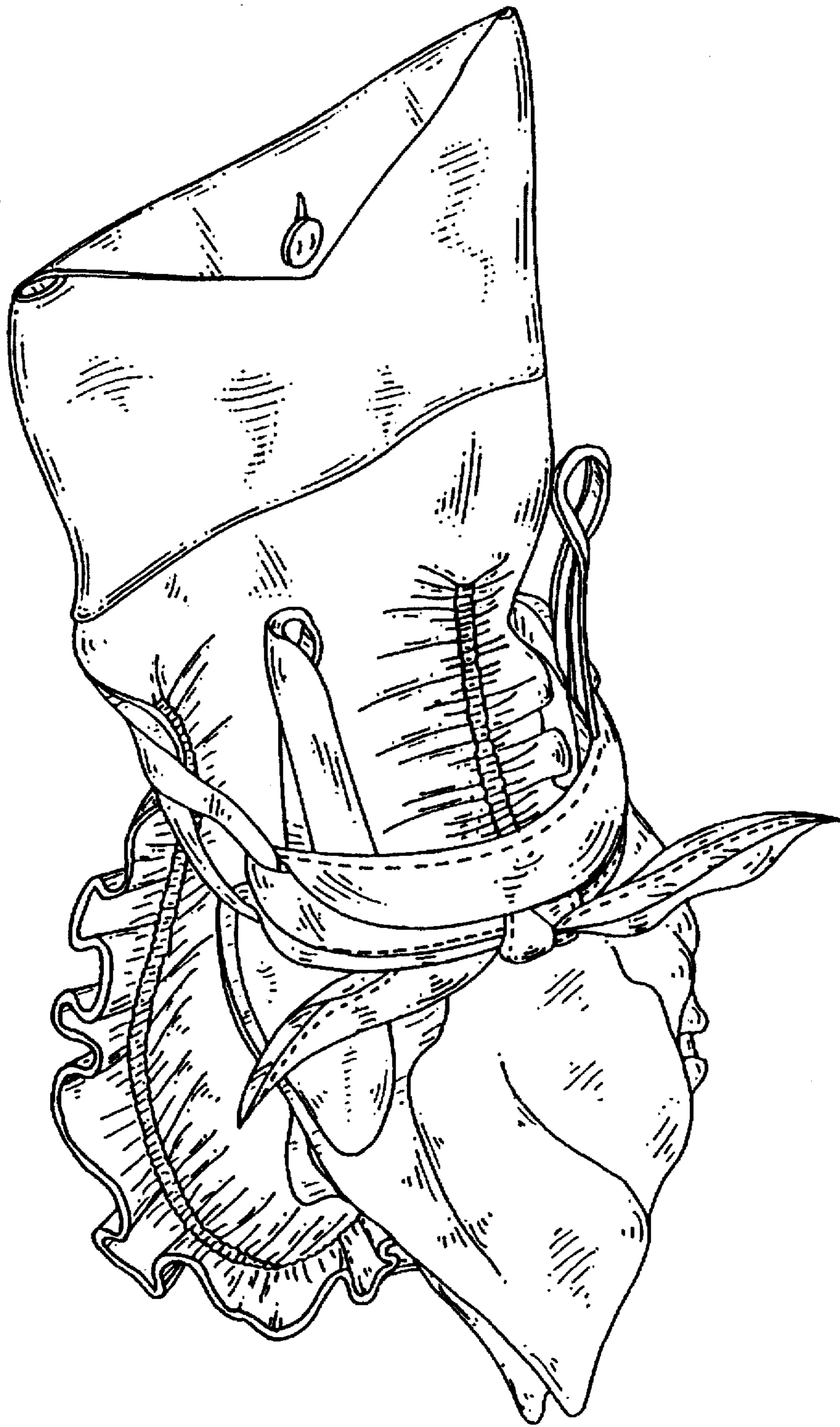

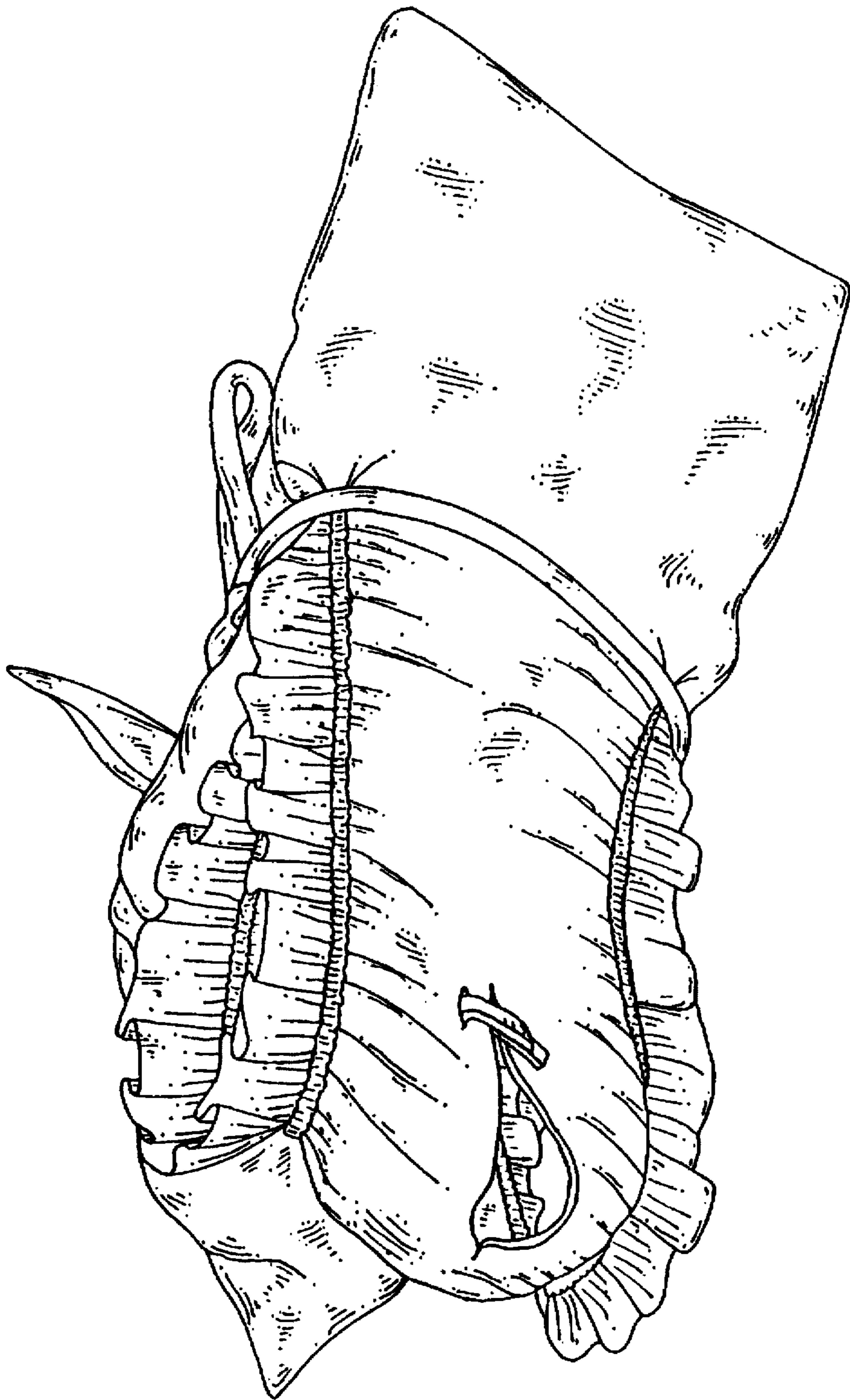

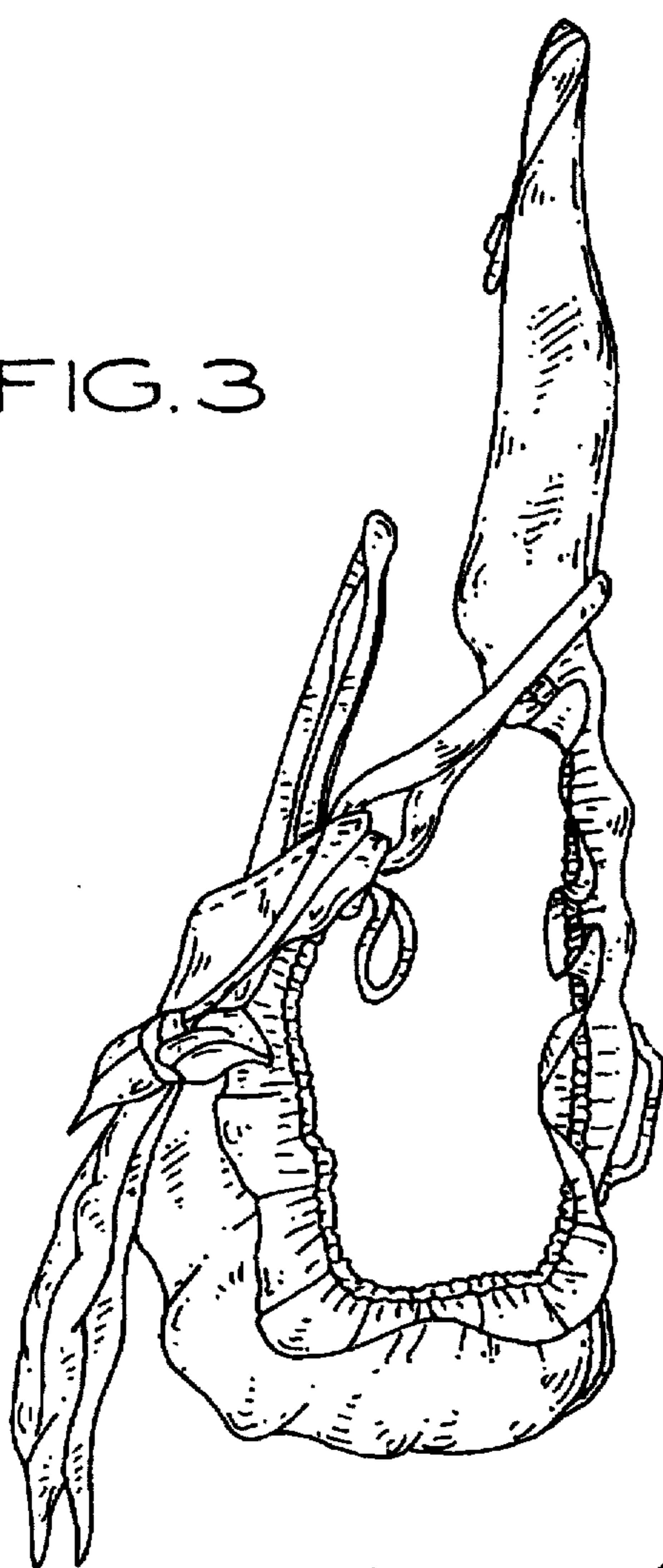

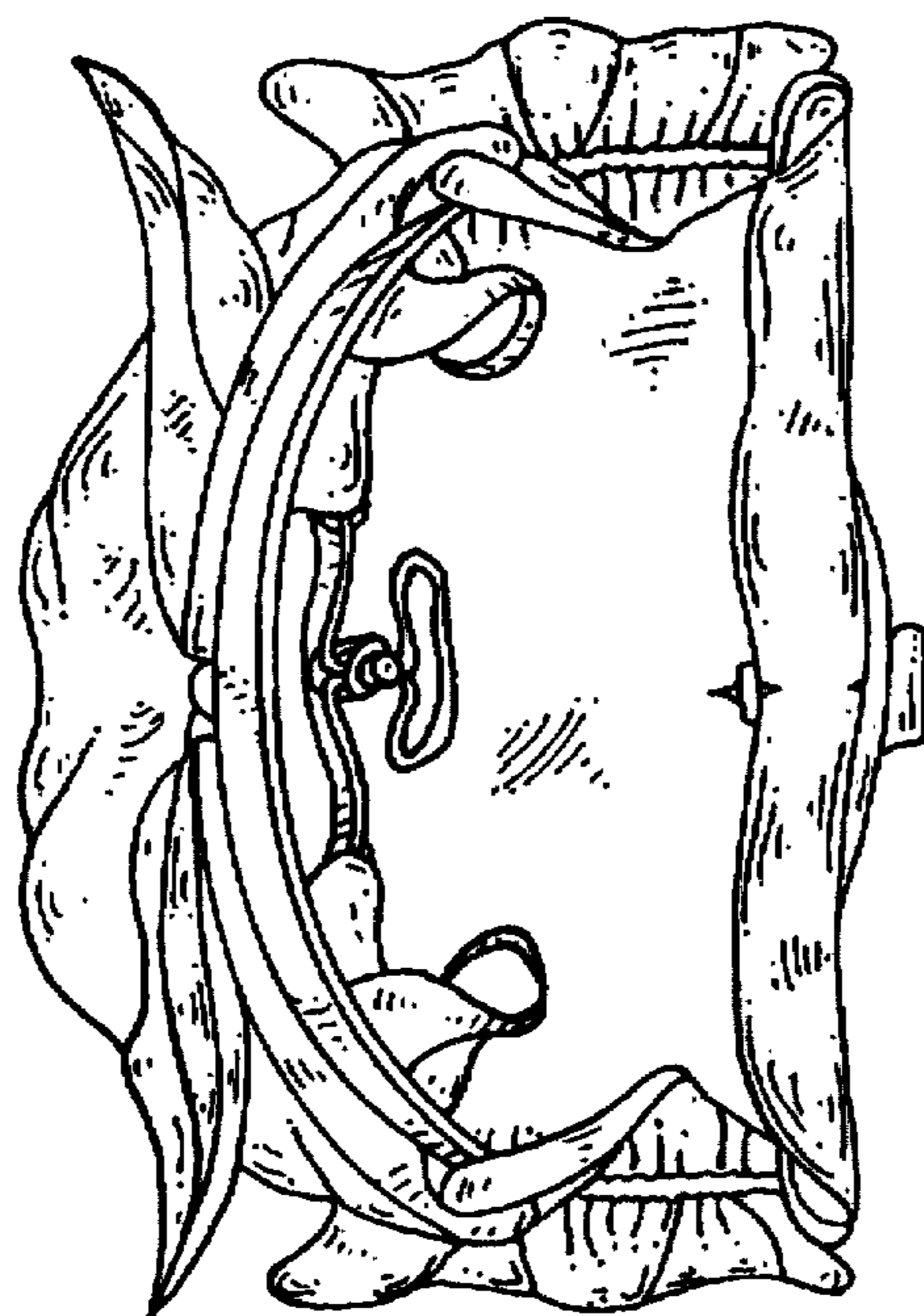
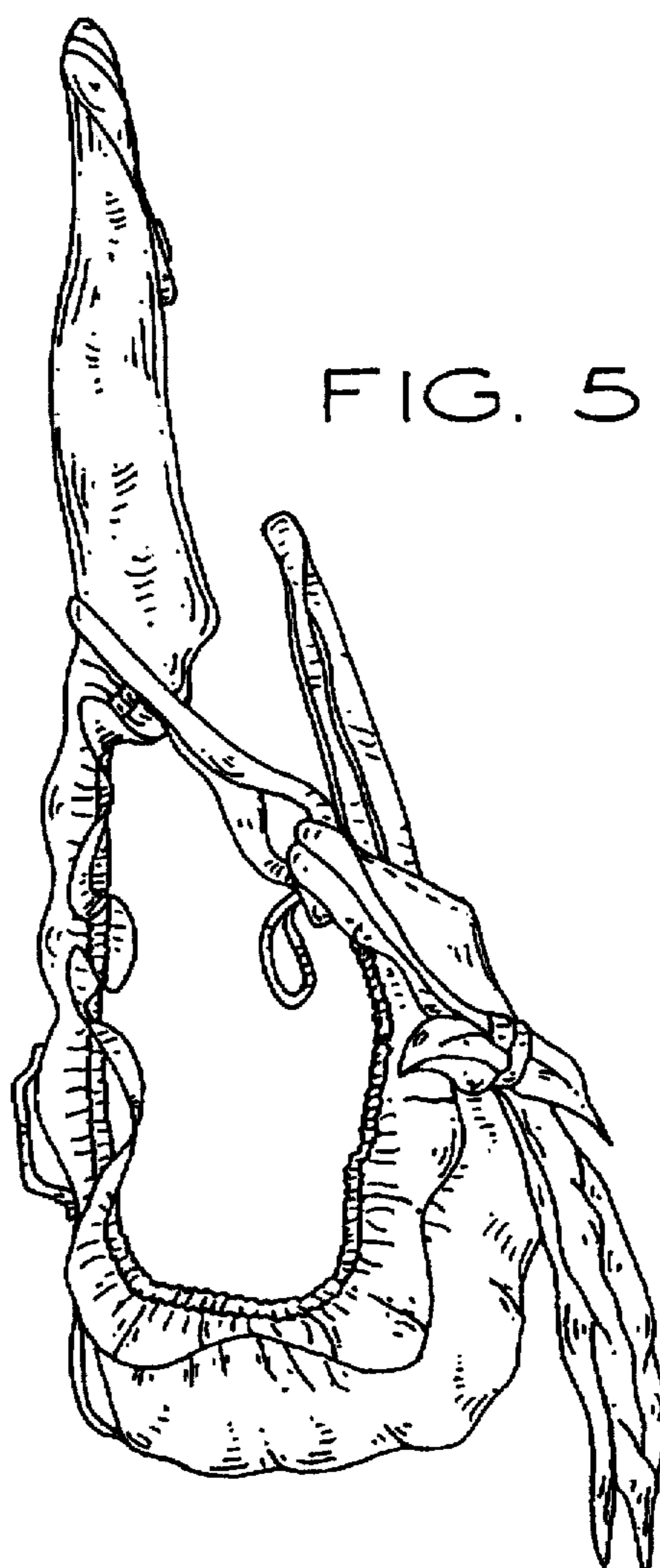

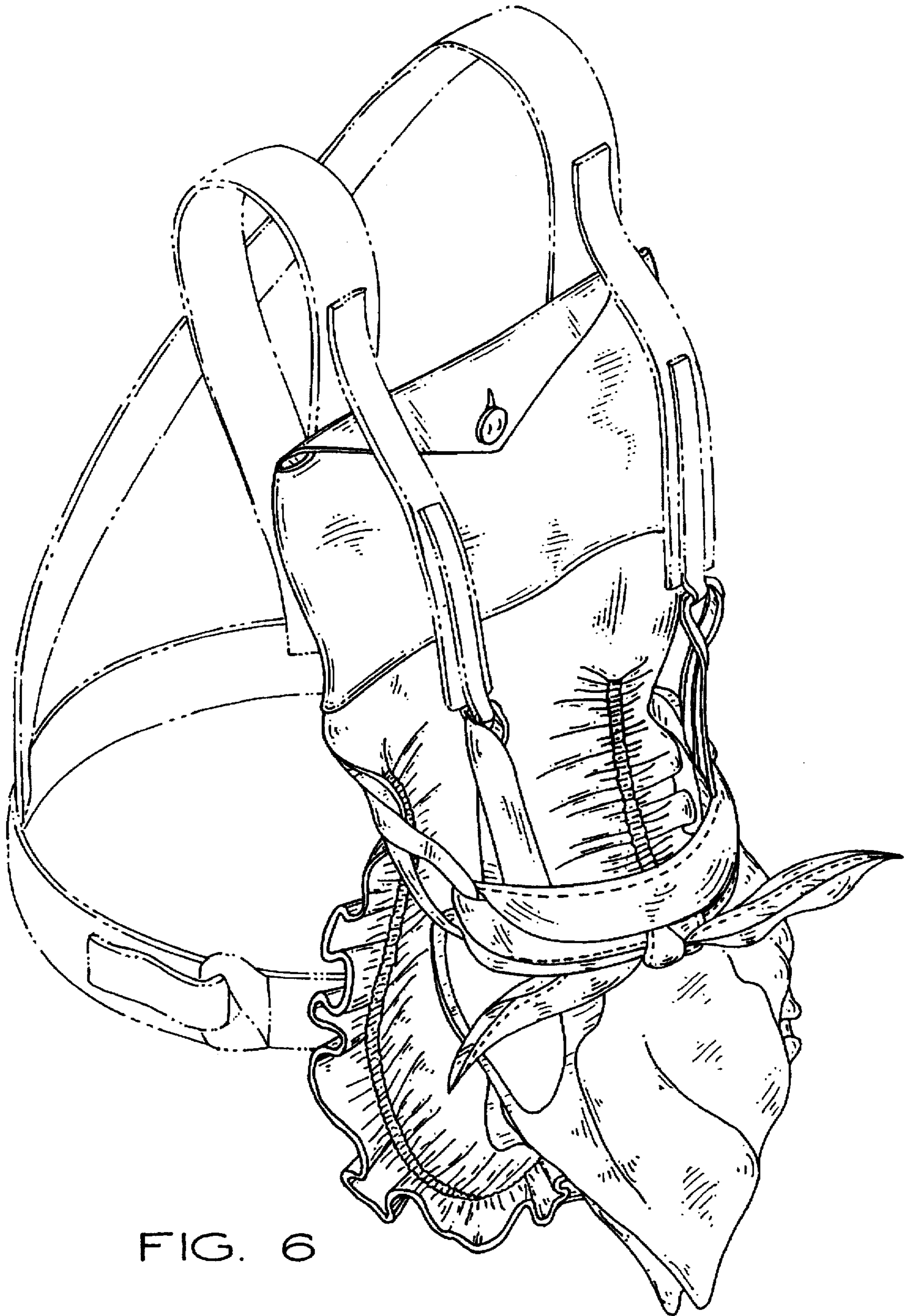

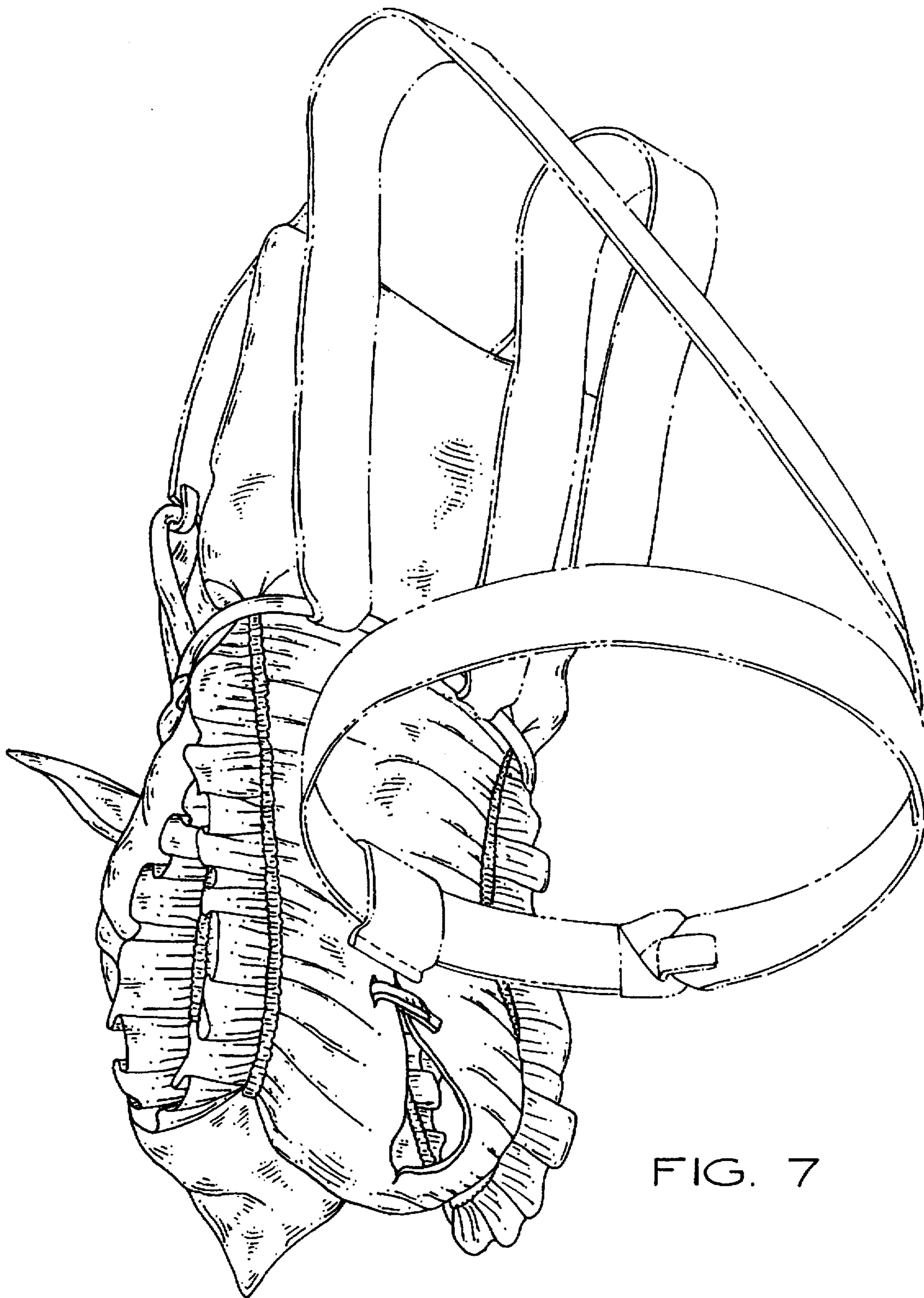

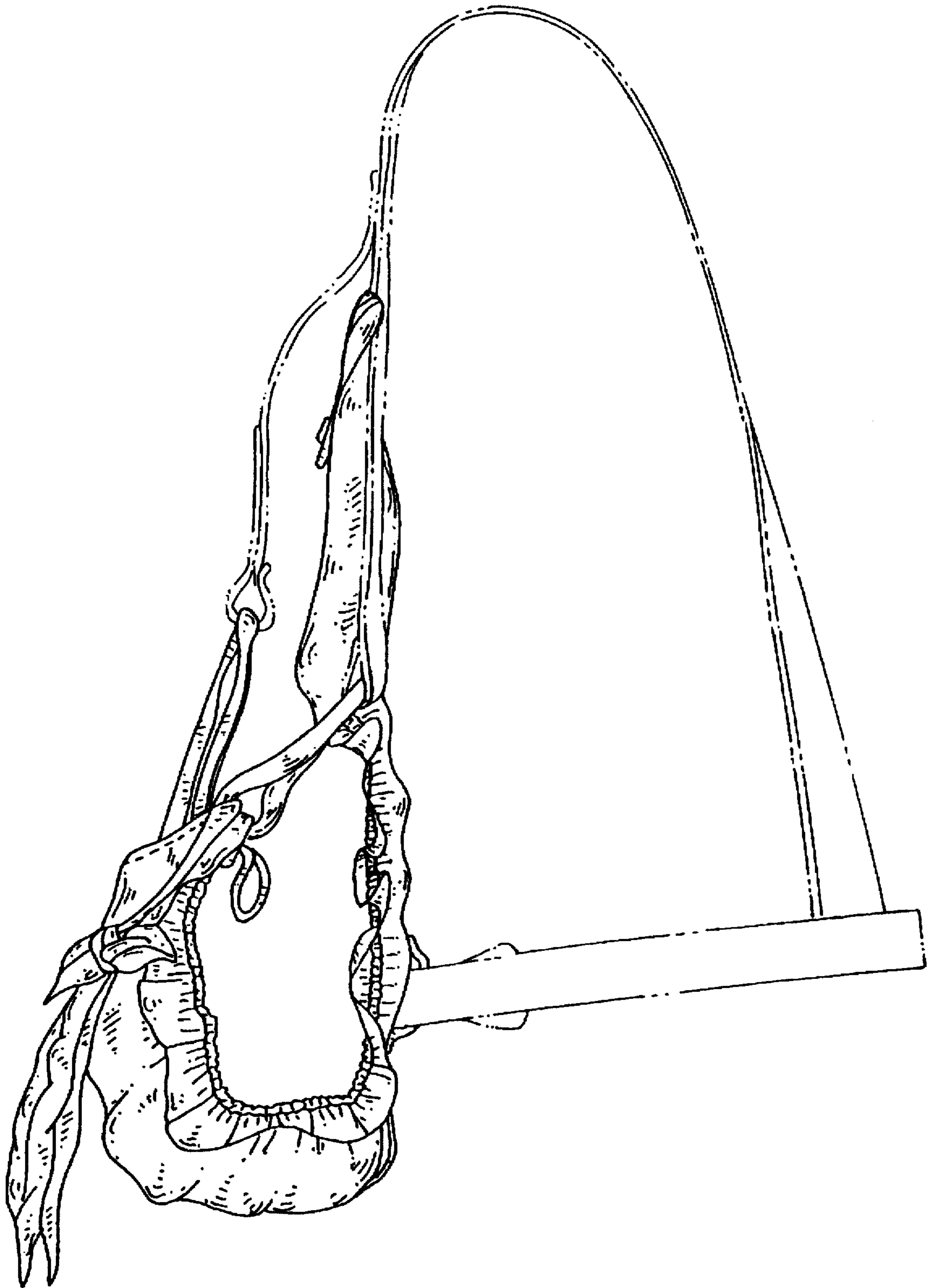

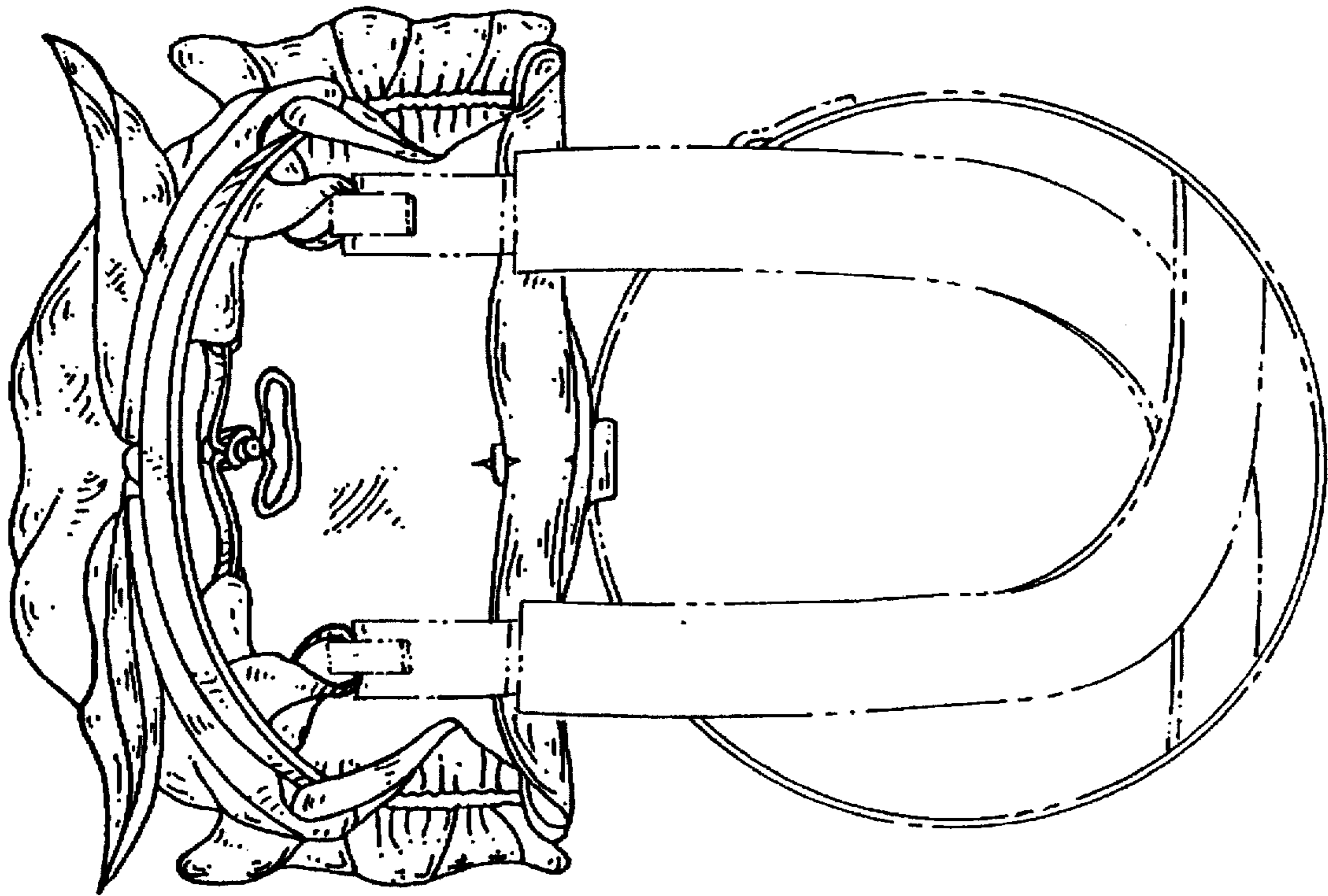
