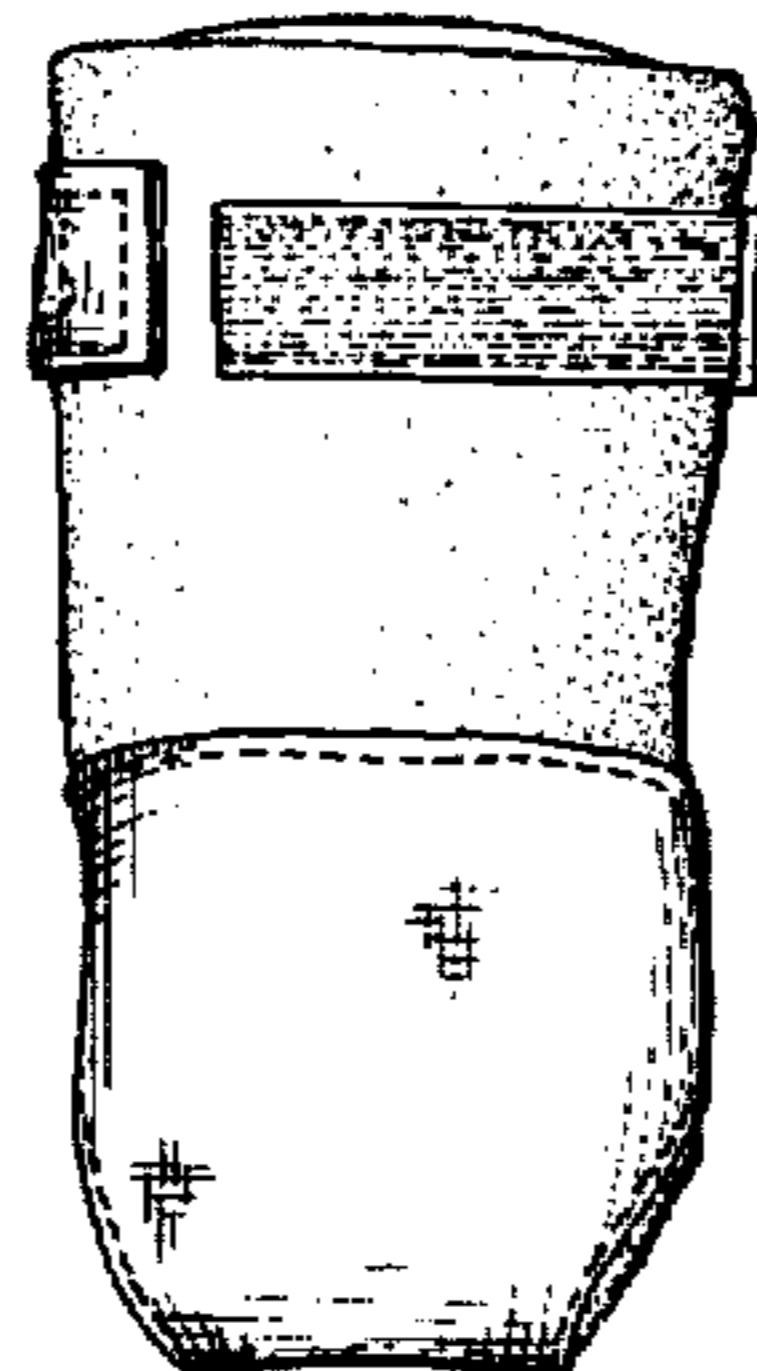
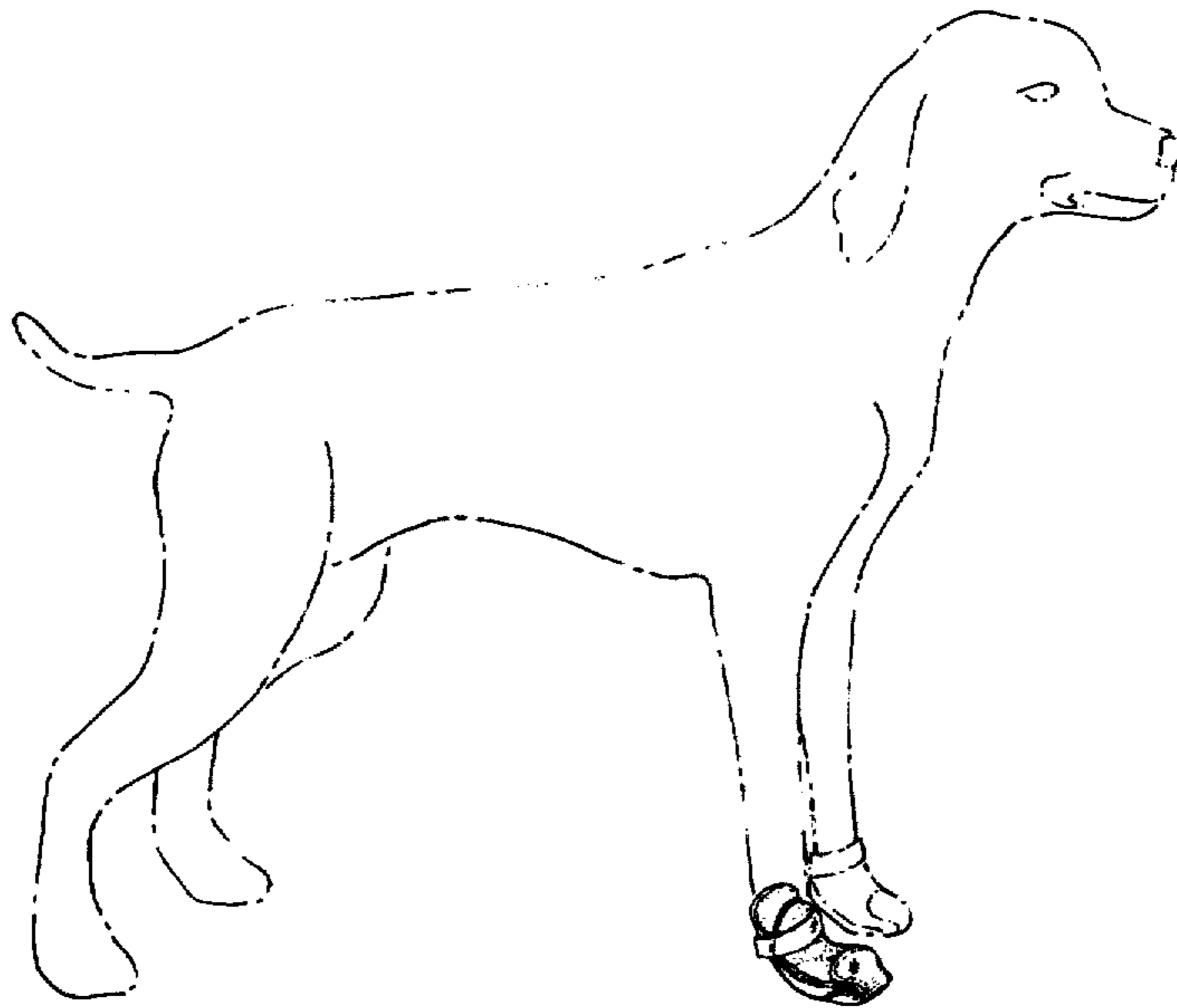
**DESCRIPTION**

The broken line showing of a dog and the second bootie is for illustrative purposes only and forms no part of the claimed design.

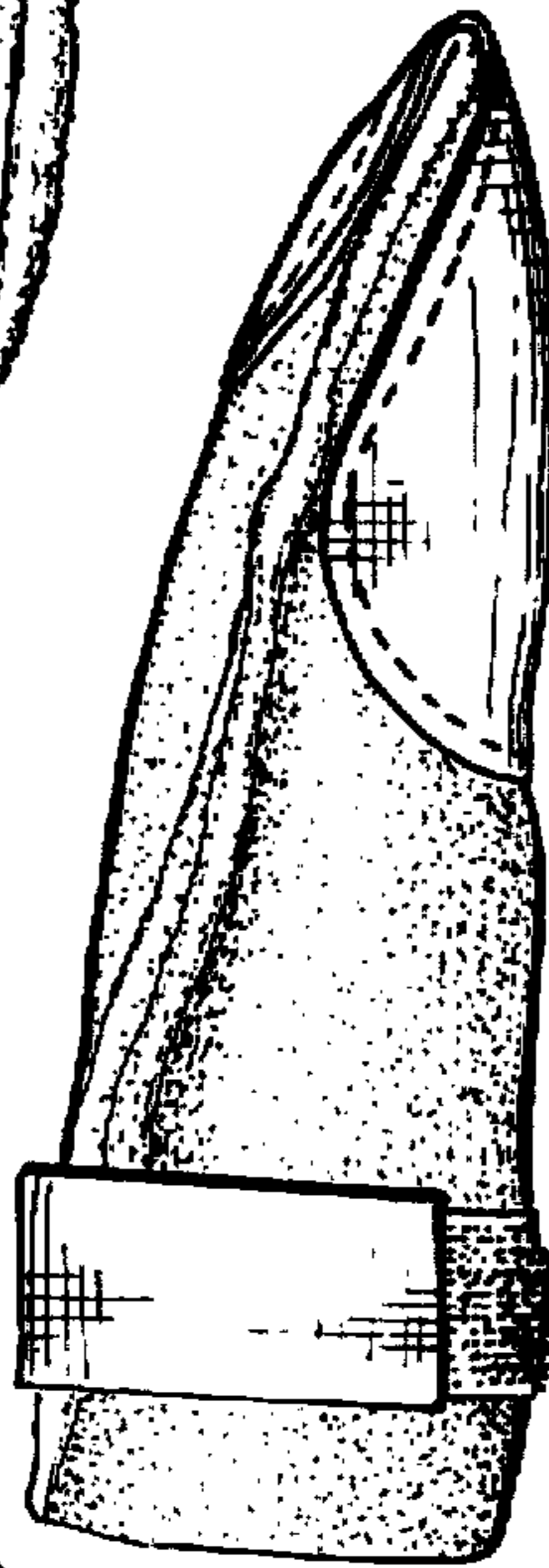
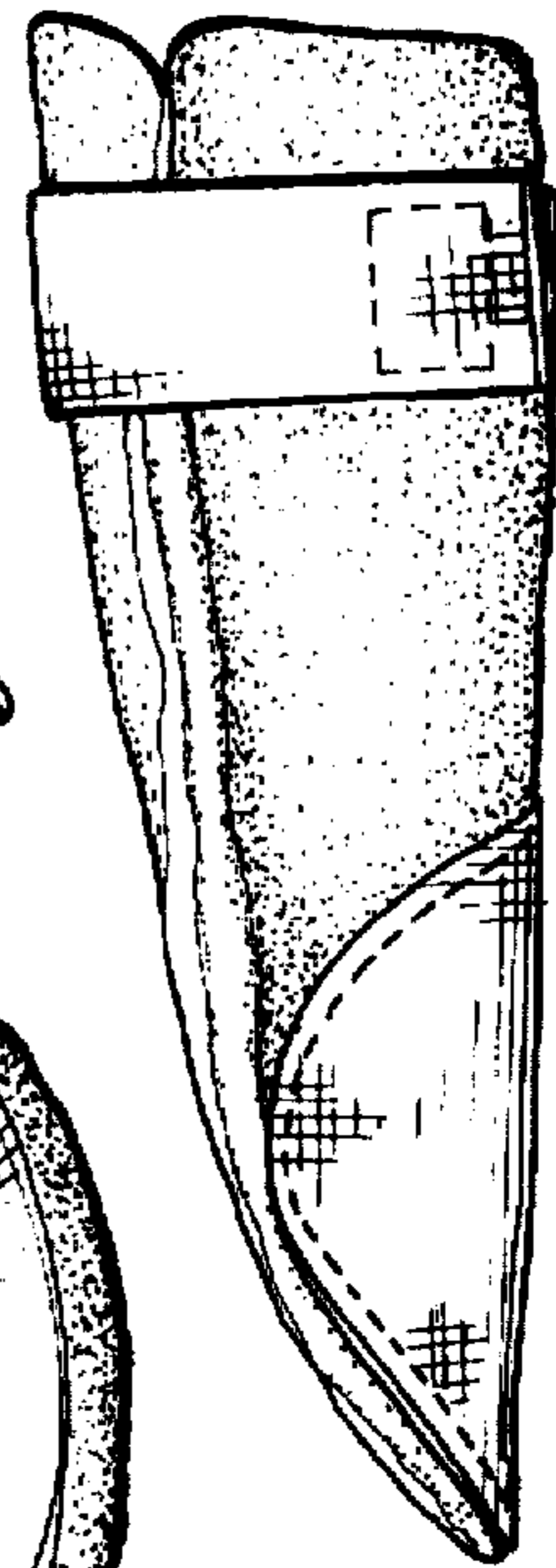
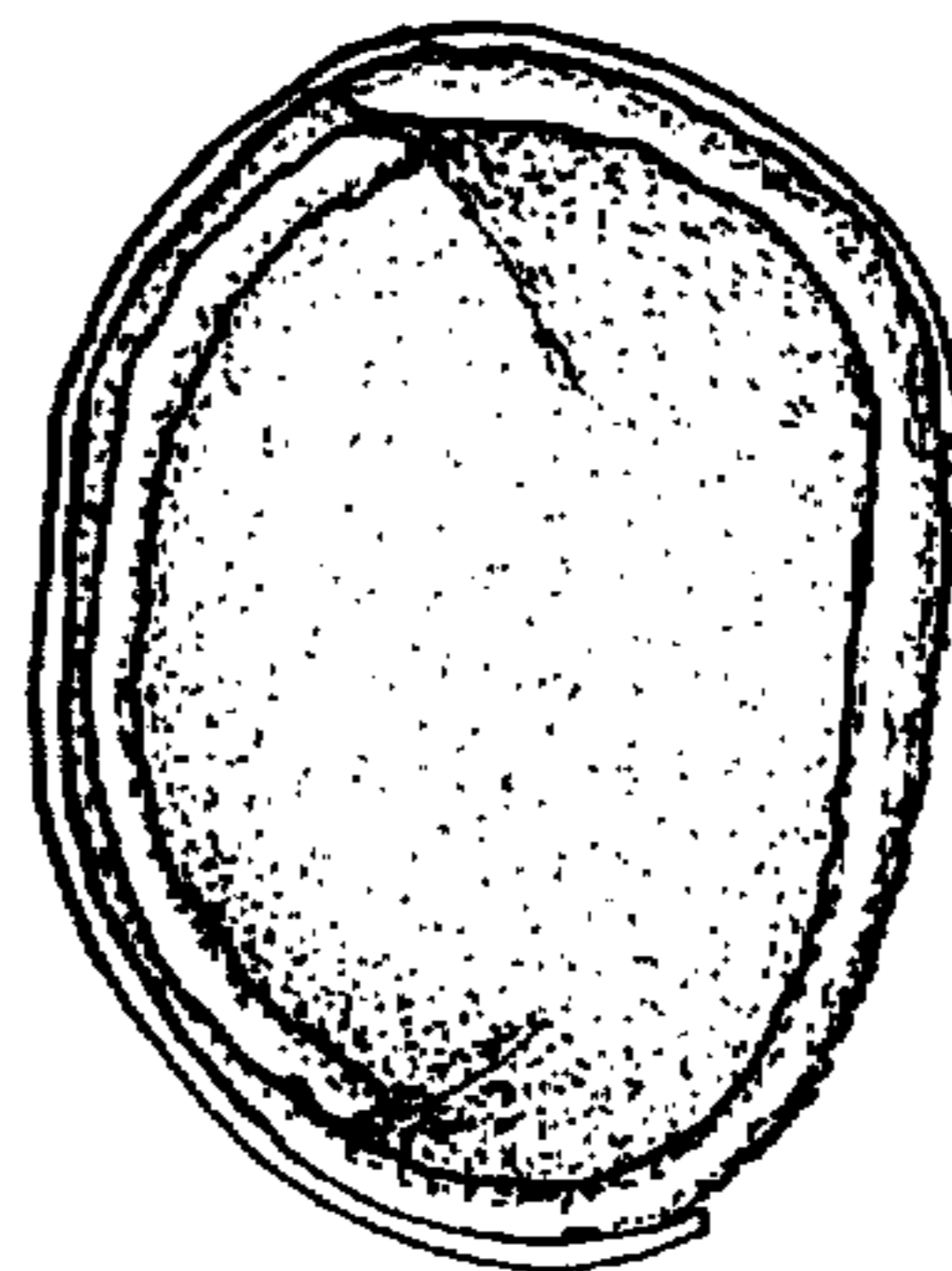
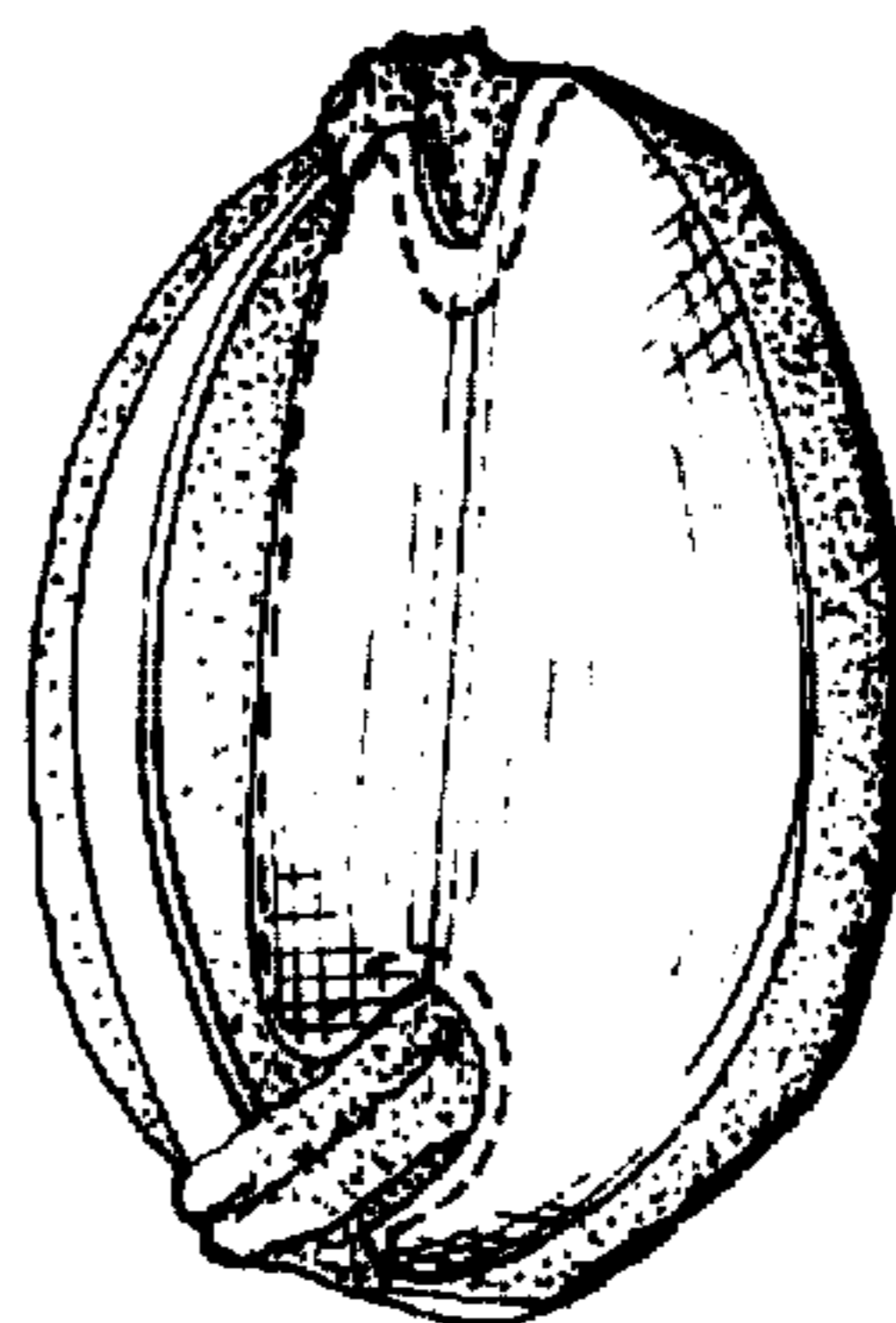
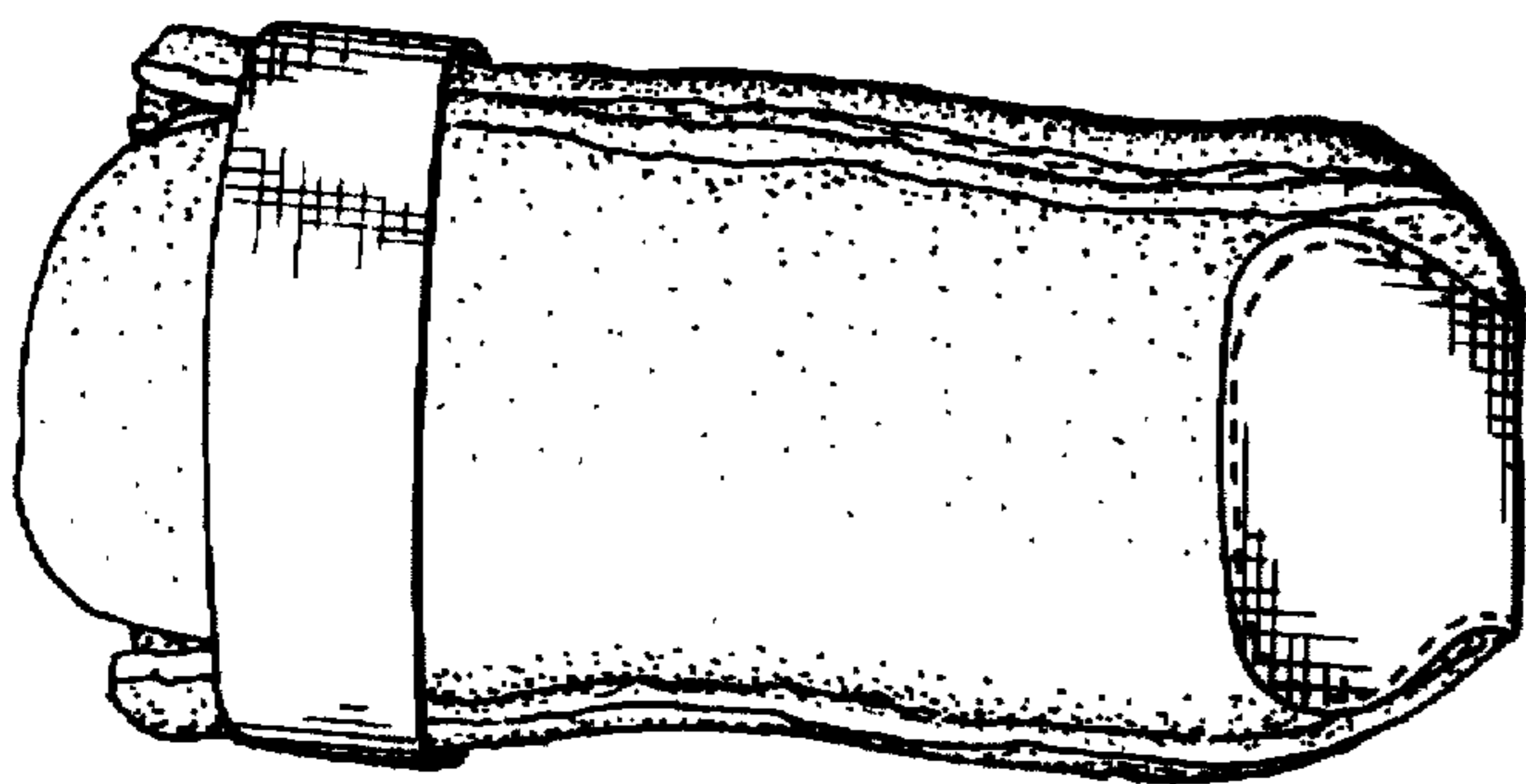
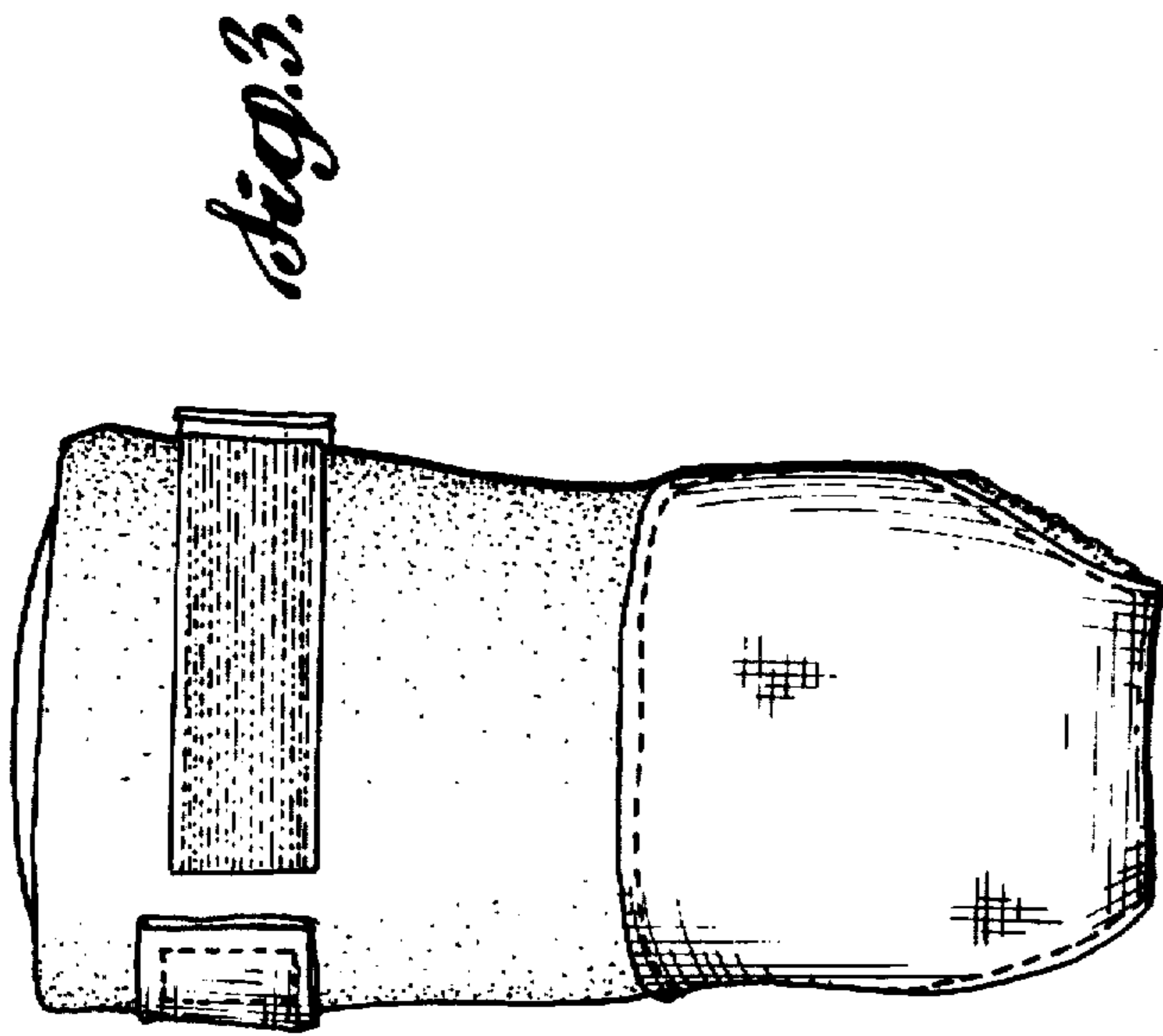
